A Saturday for Scouts and Seniors

agreed to come on full time last year and anxious to get her into sales. I couldn't be more proud of her accomplishments and the personal growth I have witnessed in her over the last several years" said

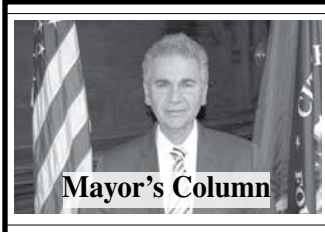

List of Top High Schools

Dear Parents,

I have been contacted by some individuals who have expressed concern that North Shore High School did not appear on the list of top high schools published by the Washington Post or US News and World Reports. Upon further investigation, we have determined that our data was not received by the organization that does the rankings and thus we were not included on either of these lists (please see the note from Jay Mathews below.) Had our data been received, we would have been listed among the top High Schools in New York State and the Nation. These lists take into account the proficiency rate in English, (North Shore scored 100%), the proficiency rate in Math (North Shore scored 97%) and a ranking based upon the number of students who take Advanced Placement or International Baccalaureate Exams. We will make sure that our data is received in future years to avoid this error from occurring again.

I am pleased that North Shore's data compares very favorably with the top High Schools on these lists, however, it is important to understand that this is one, narrow method of gauging the quality of education. 98%-100% of our graduates attend college. In fact in just the past two years an average of 18% of our graduating seniors have been accepted to one or more of the most competitive colleges in the Nation. Our comprehensive offering of arts, athletics, extracurricular activities and community service provide our young people with many opportunities to develop as well-rounded citizens. Returning North Shore graduates report that our special and unique senior programs and our rigorous course of studies serve to prepare them well for the college experience.

Scores matter more to some than to others for a variety of reasons. Although we cannot ignore this type of data, we must also continue to look within and gauge whether or not our students are passionately engaged, enjoy the process of learning, and are sufficiently challenged as they learn to analyze, synthesize, question, communicate, innovate and solve problems. Your Board

of Education Trustees, Administrators and Teachers are committed to remaining engaged in a process of continuous growth and improvement for the further benefit of our schools and community. PLEASE TAKE NOTICE THAT the Glen Cove City Council adopted the following Local Law 01-2014, at the City Council Meeting of May 13, 2014:

Local Law 01-2014

BE IT RESOLVED that Chapter 257 of the Glen Cove City Code is amended, as follows:

Title: Tobacco and Nicotine Products
§ 257-1 Definitions

For the purposes of this chapter, the following terms shall be defined as follows:

CHILD DAY-CARE CENTER Any child-care arrangement, public, private or parochial child-care center, school-age child-care program, day nursery school, kindergarten, play school or other similar school or service operating pursuant to authorization, license or permit of the State of New York, County of Nassau or City of Glen Cove; any facility that provides child-care services as defined in § 410-p of the New York State Social Services Law; or any child day-care center as defined in § 390 of the New York State Social Services Law. The definition of child day-care center applies whether or not care is given for compensation, but does not include child day-care centers located in private dwellings and multiple-dwelling units.

CIGARETTE Any product which consists of:

A. Any roll of tobacco wrapped in paper or in any substance not containing tobacco; or

B. Any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of tobacco used in the filter or its packaging and labeling, is offered for use or purchase by consumers as a cigarette described in Subsection A of this definition.

CIGARETTE TOBACCO Any product that consists of loose tobacco and is intended for use by consumers in a cigarette.

MULTIPLE DWELLING Any building or structure that may lawfully be occupied as the residence or home of three or more families living independently of each other.

NICOTINE PRODUCT Any product containing the chemical substance

named 3-(1-Methyl-2-pyrrolidinyl) pyridine or C[10]H[14]N[2], including any salt or complex of nicotine, including, but not limited to, the product marketed as "electronic cigarette" or "e-cigarette". For purposes of this Chapter only, the term "nicotine product" shall not include nicotine patches or gum that are sold with or without a prescription for the purpose of eliminating a dependence upon or addiction to nicotine.

PERSON Any natural person, partnership, copartnership, firm, company, corporation, limited liability corporation, agency, association, joint-stock association or other legal entity.

PLAYGROUND Any outdoor premises or grounds owned or lawfully operated by or on behalf of the City, the City school district or any public, private or parochial school, any child day-care center or any youth center, which contains any device, structure or implement, fixed or portable, used or intended to be used by persons under the age of 18 for recreational or athletic purposes, including, but not limited to, play equipment such as a sliding board, swing, jungle gym, sandbox, climbing bar, wading pool, obstacle course, swimming pool, seesaw, baseball diamond, athletic field, ice skating rink or basketball court.

PRIVATE DWELLING Any building or structure or portion thereof that may lawfully be occupied for residential purposes by not more than two families, including the grounds of such building or structure.

SCHOOL BUILDING Any building or structure, or any portion thereof, owned, occupied by or under the custody or control of any public, private or parochial institution and lawfully used for the primary purpose of providing educational instruction to students at or below the twelfth-grade level.

SMOKELESS TOBACCO Any product that consists of cut, ground, powdered or leaf tobacco that is intended to be placed by the consumer in an oral cavity.

TOBACCO PRODUCT A cigarette, cigar, smokeless tobacco or cigarette tobacco.

TOBACCO PRODUCT ADVERTISEMENT Any written word, picture, logo, symbol, motto, selling message, poster, placard, sign, photograph, device, graphic display or visual image of any kind, recognizable color or pattern of colors, or any other indicia of product identification identical or similar to or identifiable with those used for any brand of tobacco product, or any combination thereof, the purpose or effect of which is to promote the use or sale of a tobacco product through such means as, but not limited to, the identification of a brand of a tobacco product, a trademark of a tobacco product or a trade name associated exclusively with a tobacco product.

TOBACCO PRODUCT PROMOTION Any item or service marketed, licensed, sold or distributed, whether indoors or outdoors, which is not a tobacco product but which bears the brand of a tobacco product, a trademark of a tobacco product or a trade name associated exclusively with a tobacco product, alone or in conjunction with any written word, picture, logo, symbol, motto, selling message, poster, placard, sign, photograph, device, graphic display or visual image of any kind, recognizable color or pattern of colors, or any other indicia or product identification identical or similar to, or identifiable with, those used for any brand of tobacco product; or any gift or item, other than a tobacco product, offered or caused to be offered to any person purchasing a tobacco product in consideration of the purchase thereof, or

to any person in consideration of furnishing evidence, such as credits, proofs-of-purchase or coupons, of such purchase; provided, however, that a tobacco product promotion shall not include any gift or item provided through the exchange or redemption through the mail of any such credits, proofs-of-purchase, coupons or other evidence of the purchase of a tobacco product.

YOUTH CENTER Any building or structure or portion thereof lawfully occupied by any person for the primary purpose of operating an indoor recreational center (including recreational, cultural, physical fitness or sports programs) for persons under the age of 18 years and which has been certified as such by the City of Glen Cove, County of Nassau or State of New York.

§ 257-2 Tobacco product and nicotine product advertisement restriction.

A. It shall be unlawful for any person to place, cause to be placed, to maintain or cause to be maintained, an advertisement of any tobacco product or nicotine product within 1,000 feet, in any direction, of any school building, playground, child day-care center or youth center, in any outdoor area, including, but not limited to, billboards, roofs and sides of buildings, rolling shutters or gates, any enclosures into which rolling shutters or gates retract, water tanks and towers and free-standing signboards; provided, however, that any tobacco product advertisement on an awning projecting from the outside of a premises where tobacco products are sold or offered for sale may be retained until six months from the effective date of this chapter.

B. It shall be unlawful for any person to place, cause to be placed, to maintain or cause to be maintained, an advertisement of any tobacco product or nicotine product in the interior of a building or structure which is within 1,000 feet, in any direction, of any school building, playground, child day-care center or youth center, when such advertisement is within five feet of any exterior window or any door which is used for entry or egress by the public to the building or structure; provided, however, that tobacco product advertisements may be placed or maintained in the interior of any such premises where such advertisements are parallel to the street and face inward or affixed to a wall panel or similar fixture that is perpendicular to the street, regardless of whether such advertisements are illuminated or not illuminated.

C. Nothing in this chapter shall prevent a person from placing, causing to be placed, maintaining, or causing to be maintained, a single sign, poster, placard or label no larger than six square feet and containing only black text, in any language, not exceeding eight inches in height on a white background stating "TOBACCO PRODUCTS SOLD HERE" or "E-CIGARETTES SOLD HERE" or such words translated into any language, within 10 feet of an entrance to the premises where tobacco products are sold or offered for sale.

D. Nothing in this chapter shall prevent a tobacco product or nicotine product manufacturer, distributor or retailer from placing, causing to be placed, maintaining or causing to be maintained, its corporate or other business name on a building or structure, in any location, where such building or structure or portion thereof is owned, operated or leased by such manufacturer, distributor or retailer and that building or structure is the principal place of business of such manufac-

turer, distributor or retailer in the City; provided, however, that the corporate or other business name of such manufacturer, distributor or retailer is registered or filed in the United States or such manufacturer, distributor or retailer is authorized to do business in any state, and the corporate or business name of such manufacturer, distributor or retailer does not include any brand name or trademark of a tobacco product or nicotine product, alone or in conjunction with any written word, picture, logo, symbol, motto, selling message, poster, placard, sign, photograph, device, graphic display or visual image of any kind, recognizable color or pattern of colors, or any other indicia of product identification identical or similar to, or identifiable with, those used for any brand of a tobacco product or nicotine product.

E. Nothing in this section shall be construed to authorize the placement of a tobacco product advertisement or nicotine product advertisement in a location where such placement is otherwise prohibited by the rules, ordinances or laws of the City of Glen Cove, County of Nassau or State of New York.

§ 257-3 Noncompliant advertisements to be removed.

The person, owner, operator or lessee of any location or premises where a tobacco product advertisement and nicotine

product advertisement is prohibited or restricted pursuant to the requirement of this chapter shall have 30 days from the effective date of this chapter, as amended, to remove any noncompliant tobacco product advertisements and nicotine product advertisements, except as set forth in § 257-2A hereof.

§ 257-4 Tobacco product sale and promotion restriction.

A. It shall be unlawful for an owner, lessee, manager or employee of an establishment where tobacco products or nicotine products are sold or given away to sell provide, supply or give such tobacco products and/or nicotine products to a person younger than 19 years of age or for any person to offer or cause to be offered a tobacco product promotion or nicotine product promotion, as defined in § 257-1 of this Code, to any person younger than 19 years of age.

B. It shall be unlawful for a person 19 years of age or older to sell, provide, supply or give a tobacco product or nicotine product to a person younger than 19 years of age.

C. Any person selling, providing, supplying, offering or causing to be offered a tobacco product or a tobacco product promotion or a nicotine product or nicotine product promotion shall verify, through a driver's license or other photographic identification card issued by a government entity or educational institution, that a person to whom a tobacco product or a tobacco product promotion or nicotine product or nicotine product promotion has been offered is at least 19 years of age. Such identification need not be required of any individual who reasonably appears to be at least 25 years of age; provided, however, that such appearance shall not constitute a defense in any proceeding alleging the offering of a tobacco product or a tobacco product promotion to an individual under 19 years of age.

§ 257-5 Sponsorship of and at events.

Nothing in this chapter shall prevent a tobacco product or nicotine product manufacturer, distributor or retailer who sponsors, in whole or in part, any athletic, musical, artistic or cultural event, or team or entry in a competition or exhibition in any location, from displaying or causing to be displayed the corporate or other business name of such sponsor; provided, however, that the corporate or other business name of such sponsor is registered or filed in the United States or such sponsor is authorized to do business in any state, and the corporate or other business name of such sponsor does not include any brand name or trademark of a tobacco product or nicotine product, alone or in conjunction with any written word, picture, logo, symbol, motto, selling message, poster, placard, sign, photograph, device, graphic display or visual image of any kind, recognizable color or pattern of colors, or any other indicia or product identification identical or similar to, or identifiable with, those used for any brand of a tobacco product or nicotine product.

§ 257-6 Enforcement.

The requirements established by this chapter shall be administered and enforced jointly by the Police Department, Building Department and such other employees and/or officials authorized by the City Council from time to time. Violation of any provision of this chapter shall be cause for a ticket/information to be issued.

§ 257-7 Penalties for offenses.

Any person who violates any provision of this chapter shall be deemed guilty of a violation and, upon conviction thereof, shall be subject to penalties in the following manner:

A. Upon a first conviction, by a fine not less than \$100 and not more than \$250 or by imprisonment for a period not to exceed seven days, or by both such fine and imprisonment.

B. Upon a second conviction, by a fine not less than \$250 and not more than \$1,000 or by imprisonment for a period not to exceed 10 days, or by both such fine and imprisonment.

C. Upon a third conviction, by a fine not less than \$500 and not more than \$3,000 or by imprisonment for a period not to exceed 15 days, or by both such fine and imprisonment.

D. If the violation is of a continuing nature, each day during which it occurs shall constitute an additional, separate and distinct offense.

The objects or purposes for which the bonds are authorized is to finance various capital improvements in and for the City of Glen Cove, as further described in the City's 2014 Capital Improvement Plan, at the estimated total cost of \$7,029,766.

To The Editor,

It's that time of year again - the budget vote and the election of trustees to the North Shore Board of Education is upon us. Last year, the North Shore District Reform Group ("NSDRG") successfully supported two candidates, Marianne Manning Russo and Michael Nightingale, in their bids for election. We would like to highlight some of the changes that have occurred since their election.

The Board of Education has implemented the following changes:

1. Posting of the five year expenditure report on the District website;
2. Earlier start time for BOE meetings;
3. Videotaping of BOE meetings available for free on the District website;
4. Agenda modification to allow for earlier public comments, so that people do not have to stay until very late in the evening to have their voices heard;
5. Review and modification of legal bills;
6. Issuance of a request for proposal for district counsel;
7. BOE votes are no longer unanimous 7-0. The Board discusses and debates in public, numerous and varied issues; and
8. Independent review of the athletic department scheduled for next year.

While the Board of Education has to vote and agree to any modifications in policies, many, if not all, of these changes were made at the request of Marianne and Michael. We would also like to acknowledge and thank Dr. Herman

Berliner, the President of the Board of Education, who has been open-minded and receptive to the suggestions of the new members and has endeavored to make transparency and community engagement a Board priority. It is readily apparent that the change in the composition of the Board and its leadership has started to effect positive change. However there is still more to do.

It is in this vein that NSDRG is supporting Robert Mazzella for the position of Trustee on the North Shore Board of Education. The primary role of the Board of Education is fiscal oversight of the District, not the implementation of academic programs, which falls within the purview of the District's Administration. on Monday, May 12th, in Zurich, as a result from injuries suffered in a fall.

Last week's celebrity was Lee Grant. She was married twice. Her first husband, the father of her daughter and actress Dinah, and her son Tom, was playwright Arnold Manoff. Grant was called before the House Committee of Un-American Activities to testify against her husband, but refused to testify. She was blacklisted for twelve years, after which she resumed work in theater and film. Her first major achievement after that period was in the 1960s TV series "Peyton Place", as "Stella Chernak", for which she won an Emmy. Grant is the only Hollywood actress of her generation (after Ida Lupino in the 1950s) to successfully move into directing. She directed the stage play, "The Stronger" in 1976, written by August Strindberg. In 1980, she directed her first film, "Tell Me a Riddle", a story about an aging Jewish couple starring Melvyn Douglas. She also directed several documentary films including "Down and Out in America" (1986), which won the Academy Award for Documentary Feature. She enjoyed a guest appearance on the TV sitcom "Empty Nest" co-starring her daughter, Dinah. She may be remembered for her roles of "Ann Thorn" in "Damien: Omen II" (1978), as "Miriam" in Jacqueline Susann's "Valley of the Dolls" (1967) and as "Mrs. Leslie Colbert", widow of the murdered industrialist, in the original film version on "In the Heat of the Night" (1967) with Rod Steiger and Sidney Poitier. She received a Golden Globe Award for Best Supporting Actress for that role. In 2013, she returned to the stage after a 30-year-absence to star in "The Gin Game". Grant played "Forsia Dorsey" opposite Frank Buxton and her daughter, Dinah, directed the production.

He worked his way from local Australian amateur dramatic companies to the London stage in 1906 in such shows as "The Lemonade Boy" and "Stingeree". He played "Sherlock Holmes" in the stage presentation of "The Speckled Bird", a portrayal much admired by the character's author, Sir Arthur Conan Doyle. He worked his way to Broadway and by 1927, he was seen by Norma Shearer and her husband, producer Irving Thalberg, in the Players Club revival of "Trelawny of the Wells." The pair persuaded our celebrity to move to Hollywood where he made his first appearance in the silent film, "The Actress" (1928), starring Shearer and based on the stage show. The film is now considered a lost film. His later film appearances include playing King Louis XI of France in "The Vagabond King" (1930) with Jeanette MacDonald and as Anne Shirley's adoptive father in "Anne of Green Gables" (1934). He also played "Inspector Nayland Smith" in "The Mysterious Dr. Fu Manchu" (1929) with Jean Arthur Warner Oland and Neil Hamilton, who later played "Commissioner Gordon" on the 1960s TV series "Batman" with Adam West.

P.S. For all you sci-fi aficionados, a farewell salute to Swiss surrealist artist, H.R Giger, who designed the creature in Ridley Scott's horror classic "Alien" with Sigourney Weaver. He received a 1979 Academy Award for Best Visual Effects for that design. Mr. Giger passed away

 What a beautiful weekend we just had! There were Mother's Day celebrations throughout Sea Cliff- in its homes, restaurants, parks with blossoming trees and flowers everywhere. While at a lovely porch party, I overheard a conversation about a new novel recently reviewed on the front page of the New York Times Book Review about an Indian American family. The review was very positive. Have you read it and, if so, would you recommend it?

Dear SCS Sojourner,
 I spent part of this lovely weekend reading FAMILY LIFE by Akhil Sharma. While a quick read (only 220 pages long), this semi-autobiographical novel was deeply moving. It is 1979 and Ajay (our narrator), his older brother Birju, and their mother are preparing to leave India to join the boys' father in America. The excitement of this move is vividly captured as is young Ajay's realization that everything- good and bad- is about to change. The small apartment in Queens,

the unaccustomed luxuries of libraries and the unending supply of hot water, the pain of playground bullying, new foods- all are described in exquisite detail. Shortly into the book, fourteen year-old Birju is accepted into the prestigious Bronx High School of Science, and the family feels their future is secured, their highest hopes realized. Within weeks their dreams and lives are shattered. Birju suffers a terrible accident that leaves him in a permanent vegetative state. The rest of the book describes the anger, pain, remorse, and, yes, guilt each family member feels. The Indian community is presented as yet another character as it struggles to deal with this tragedy in its midst. An extraordinary book - highly recommended!



All Saints Pre-K Knows, "Reptiles Are Remarkable!"

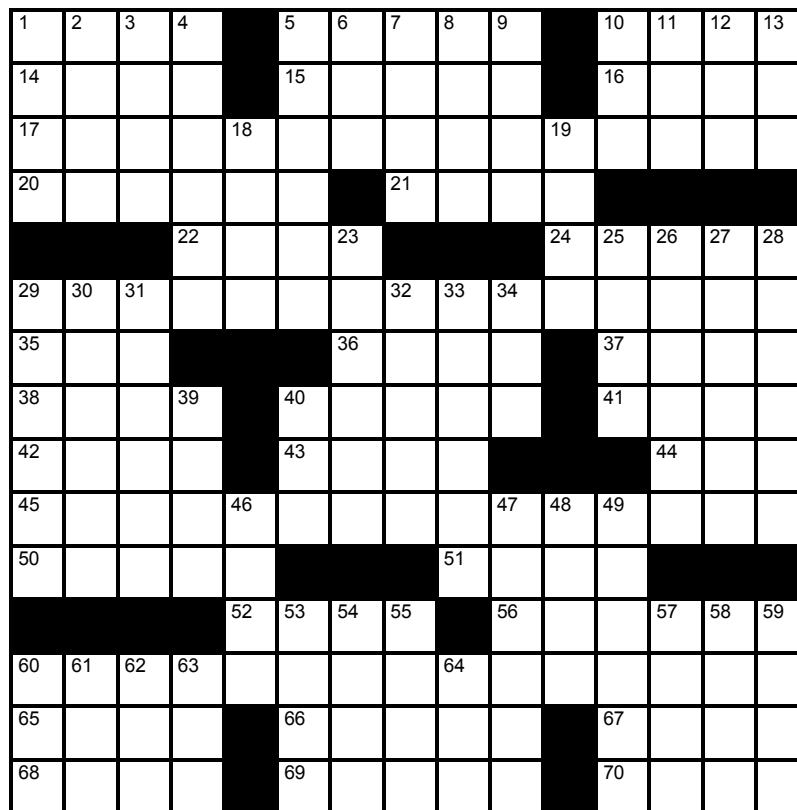
