## Police Seek Help In Finding Home Invasion Suspect

The Glen Cove Police is requesting the public's assistance in locating Kahlan Ambles. Kahlan Ambles is wanted in connection with a home invasion that took place on Coles Street on May 26th. Kahlan Ambles, is also known by the street name of "Prada." Ambles previously lived on Carpenter Street in Glen Cove. He is six foot two with a skinny build. ## Residents Warned Of PSE&G Scam

The Glen Cove Police department would like to warn Glen Cove residents of telephone scams in which callers posing as utility company representatives threaten to shut off electric or gas service if payment is not made to them that day. The scam has been reported across the country and involves payments using money cards like Green Dot Money Paks. The scammer will call and demand immediate payment for gas/electric service under the threat of disconnection. Victims are told to purchase a money card at a local pharmacy or convenience store and are instructed to put cash on the card. The scammer then requests the victim to furnish them the pin number on the card. The scammer then uses that number and removes the cash that the victim placed on the card. The phone numbers that they

use are not traceable and the scammer walks away with your money. If the Electric/Gas company calls you, that company representative should have additional information regarding your account such as your name, address, and balance owed. PSE&G will never ask a customer to pay a bill using a specific method of payment and they do not accept any of the pre-paid type money cards. According to Lieutenant John Nagle of the Glen Cove police, "We are getting at least two of these scams reported to us a week, sometimes victims are being scammed out of thousands of dollars". If you think you are being scammed simply hang up the phone and call PSE&G or your utility service directly. Victims of these scams should report them to the Glen Cove Police Department. -KCH

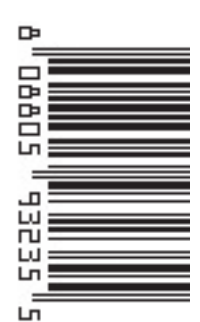

## Glen Head Principal & Students Participate in the Stuck for a Buck Fundraiser

Principal Lori Nimmo found herself happily in a sticky situation as all of her students had the opportunity to tape her to the wall of Glen Head School, as part of the Stuck for a Buck fundraiser.

This exciting event originated when over twenty students in the Patients for Pennies Committee wanted to “meet and beat” their fundraising efforts from last year totaling \$1,400 for the Leukemia and Lymphoma Society (LLS). Under the leadership of teachers, Janet Goldberg and Sharon Kern, the committee members eagerly spoke to a representative from LLS who told them that Stuck for a Buck was a popular event at other schools. She communicated that each student could donate \$1 dollar for a piece of tape that would be utilized to adhere a volunteer to the wall of their school!

For weeks, the Glen Head “mystery” volunteer was not disclosed raising suspense among the students and faculty of Glen Head. Principal Lori Nimmo surprised her students and made a school-wide announcement that she was going to be the volunteer for the Stuck for a Buck fundraiser! Mrs. Goldberg said, “You could hear the joyful cheers throughout the school from our students!”

The day of the event, under the supervision of their teachers, the students in each class excitedly lined up to donate a dollar and grab a piece of tape to stick to their principal who was already positioned outside on the wall! One by one, Principal Nimmo was being covered in colorful tape for this worthy cause. After all of the children had their turn, everyone counted down as the bench Principal Nimmo was standing on was removed beneath her feet! To everyone’s amazement and thunderous applause, Principal Nimmo was really stuck to the school!

Glen Head School raised approximately \$667 which was doubled by a generous pledge from a Glen Head family. Mrs. Goldberg said, “The Pennies for Patients donations are still being counted... this means ultimately, over \$2,500 will be collected for the Leukemia and Lymphoma Society thanks to our school and community! She concluded by saying, “My students were amazed at how much money can be raised in one day when everybody works together as a community.” Over 60 students participate in the Community Service Club at Glen Head School.

### Dead and Living in Glen Cove II

To The Editor,

Memorial Day just past. It was a wonderful holiday weekend getting together with family and friends to honor those men and women who have given their lives for our country as well as for all of us.

And it got me thinking, why can't my own fellow neighbors, men and women living in the City of Glen Cove, why can't we give our time and come together in support?

I recently attended the Planning Board meeting on May 20, 2014 to discuss the proposed six building multi-complex, 194 units, going up along the Glen Cove Avenue corridor. I counted 30 residents from Glen Cove at the meeting. Thirty residents attended meanwhile the population for Glen Cove is 27,000 residents. The other 8-10 individuals present at the meeting were with the developer, Daniel Livingston. It was a chance for Daniel Livingston and his entourage of characters to present their plan. A plan that he swears has already been approved by the Master Plan, (not true).

What Daniel Livingston fails to give any thought to is this; the Master Plans are just that, a PLAN, an idea and only after researched, analyzed, studied and proven to be good business sense, only then will the PLAN go into action. Not before then. After all, I had a plan to enjoy the tree scape behind my property never thinking I would be looking at anything but, the sunset and water view in my backyard each night. It never oc-

curred to me that my City of birth, Glen Cove, would allow the land behind my house, the Boys and Girls Club, which was zoned for recreation to be sold to a developer, and re-zoned so residential property, could be developed.

In three weeks my fellow City of Glen Cove Men and Women, you will have an opportunity to discuss whether you think this is a good PLAN. And if you choose not to attend the Planning Board meeting then please, don't complain later about the traffic on Glen Cove Avenue and the down town area. Don't complain about the six building complex structures that don't fit in to the landscape. Don't complain that we are over developing housing while businesses are suffering. Don't complain.

Once again, what is the Master Plan? The Master Plan's goals and objectives: "Protect and enhance Glen Cove's established residential neighborhoods, while providing a variety of housing options to meet the needs of current and future residents. Protect the scale, density and character of Glen Cove's stable and well-maintained neighborhoods. Promote livable, economically sustainable and environmentally responsible growth."

And what is Daniel Livingston's Master Plan? Daniel Livingston's Master Plan is to line his pocket with \$28-\$35 million in over-development for the City of Glen Cove. And it's not that we don't welcome growth and development, we resent the arrogance and the scale of the development. And it is that which we do not welcome.

# Glen Cove IAC Holds Monthly Meeting at Library

The Glen Cove Interagency Council (IAC) recently held its monthly meeting at the Glen Cove Library. Library Director Kathie Flynn and her staff gave an overview of the many services available at the library.

The Glen Cove Library has an extensive collection of historical documents and photos. The collection began with a donation from Robert Coles, after whom the library's history room is dedicated. Staff is currently augmenting the collection by conducting oral histories of Glen Cove. The collection, which includes interviews with former mayors, is called "Voices of Glen Cove".

The library also has an active teen program. Approximately 20-30 teens meet monthly. They perform community service, work with younger readers, and enjoy teen-related programs and lectures. The teens also participate in the "Any Soldier" program, packing and sending donated supplies to US troops in Afghanistan.

The library has been busy reaching out to the Spanish speaking community. A native speaker makes presentations to ESL students and their parents and participates in World Book Night, distributing books to students and signing them up for library cards. The library also conducts computer classes in Spanish



and offers a Spanish language story hour for younger children.

The library offers special programs

for all ages. Adults can enjoy book discussions, musical performances, educational lectures, computer classes, career assistance and more. The Children's Department offers programs for younger readers including story time four times a week, arts and crafts, music and movement, a Lego club and a summer reading club. Given the current emphasis on STEM-related programs, staff has been offering more activities related to science and technology.

Library staff also bring the library out into the community. Staff make presentations at local schools, have an ongoing outreach program at the Glen

Cove Day Care Center and share a historical slide show with residents at local assisted living facilities and nursing homes.

The Glen Cove IAC includes community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis. Betty (Vessichelli) Buoincontri, 88, a resident of Atria Glen Cove, recently received a POW medal for her late husband, Vito Vessichelli, who was a POW in WWII. Vito was captured and held prisoner in Switzerland and escaped twice. Since Switzerland was a neutral zone, these men were not recognized to receive the POW medal until recently. A bill was passed in congress to finally recognize 153 men who were held in these POW camps. Major Dwight Mears, whose grandfather was one of the men detained, researched why these men were not given the POW medal 70 years ago, as part of his thesis for his PhD. Through his 15 years of research, he was able to conclude that these men were truly heroes, who should have been recognized and the US Air Force agreed.

Mrs. Buoincontri's grandson, Ryan Vessichelli, who is a pilot in the US Navy, presented his grandmother her late husband's medal. She also attended the awards ceremony and reception at The Pentagon, in Washington DC, on April 30th with her daughter Liz and son-in-law Michael.

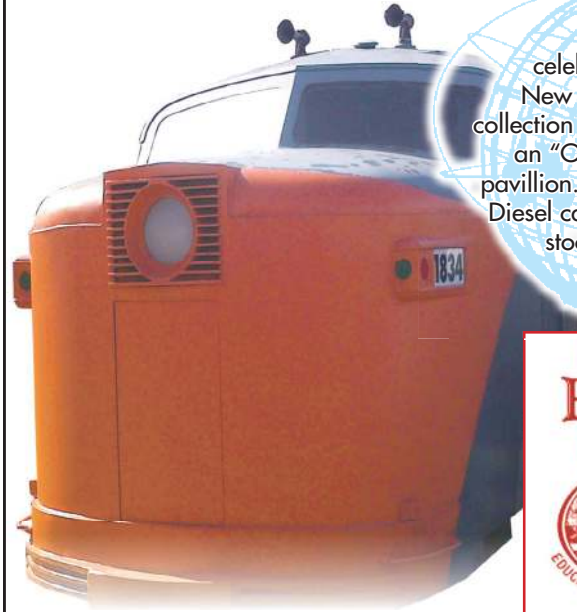
# Community Gardeners Celebrate Fruitful Planting

# GWL First Graders Learn Lessons on “School Long Ago”

First graders recently completed an integrated social studies unit “School Long Ago” as an extension of the first grade Social Studies Curriculum. Time appeared to stand still as Glenwood Landing (GWL) teachers and students came to school fully dressed as “School Masters and Students” from “School Long Ago” with lunches in baskets, wood for the “fire” and old scraps of cloth to serve as slate erasers.

This meaningful day was organized by the Glenwood Landing Collaboration Team in conjunction with GWL first grade teachers including Mrs. Cano, Mrs. Curiale, Mrs. Ebert, Mrs. Neilly, Mrs. Robertson, Mrs. Stevens, and Ms. Wolin. The GWL Collaboration Team included Kevin Carpenter, LiJu Cheung, Audra Marcantonio, Lauren Moran, Stephanie Smith, Stephanie DeBonis and Kevin Carpenter. In addition, the Culmination Day was based on understandings put forth by Jeffrey Golubchick, Elementary Humanities Director, which spiral systematically K-5.

GWL School-Wide Enrichment Services teacher Audra Marcantonio said, “This special day revolves around interdisciplinary workshops that deepen learning and connect to overarching understandings.” These hands-on, educational experiences enabled the first graders to duplicate lessons from many years ago utilizing similar tools and teaching methods.

In Art Class, students sewed books out of scraps demonstrating resourcefulness. In Physical Education, kids participated in games that focused on hand-eye coordination essential to the time. Music Class offered an in-depth look at the music of the time and its importance to community. The students also examined authentic GWL pictures/primary documents from the 1800s in Library Class including GWL’s own “One Room School House and its founding students. To practice penmanship, students were given a slate and a slate pencil. They were also encouraged to make authentic diaries! In addition, mathematical skills were practiced utilizing a math game called ‘Shut the Box,’ while students played with an old-fashioned ‘Cup and Ball’ held together by a string to practice hand-eye coordination. Each of the many other activities demonstrated the importance of how community members worked interdependently and focused on the purpose of each task discussed in great depth.

The unit concluded with children reflecting on their experiences and learning through a series of thought-provoking questions. Many thanks to all of the Glenwood Landing students and their teachers who participated in these authentic interdisciplinary lessons from “School Long Ago.” Please be sure to ask your children all about these incredible learning experiences.

The City continues its commitment to provide our residents with drinking water that meets or exceeds quality standards while taking the necessary steps to improve our water delivery system infrastructure.

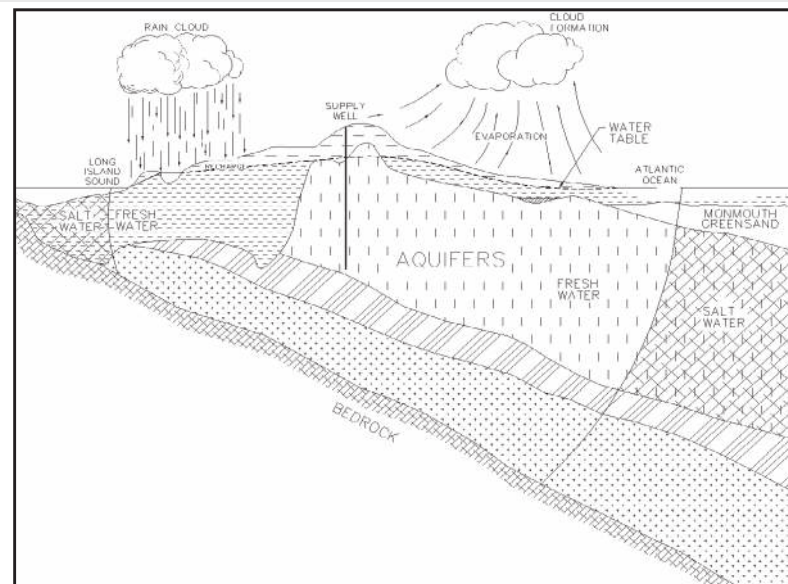
## SOURCE OF OUR WATER

The source of water for the City is groundwater pumped from four (4) wells located throughout the community that are drilled into the aquifers beneath Long Island, as shown on the adjacent figure. Generally, the water quality of the aquifers is good to excellent.

In order to ensure that our tap water is safe to drink, the State and the EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

The population served by the City of Glen Cove during 2013 was 26,000. The total amount of water pumped by the City in 2013 was 1.4 billion gallons, of which approximately 90 percent was billed directly to consumers.

The remaining un-metered water is from uses such as municipal and public school facilities, fire fighting, hydrant flushing, main breaks and undetected service line and water main leaks.

## WATER TREATMENT

The Water Department treats the water supply before it enters the distribution system. A small amount of chlorine is added to assure the water maintains its bacteria-free quality. Our water is also treated with sodium hydroxide to increase its pH to reduce its corrosivity before it enters the distribution system. This treatment reduces the leaching of copper and lead from household plumbing. Source water from the Kelly Street well is treated by air stripping to remove various volatile organic chemicals. Source water from the two (2) Duck Pond Road wells are treated by granular activated carbon filters to remove various organic chemicals and pesticides. All treatment is approved by and in strict accordance with Nassau County Department of Health standards.

## WATER CONSERVATION MEASURES

The underground water system of Long Island has more than enough water for present water demands. However, saving water will ensure that our future generations will always have a safe and abundant water supply.

In 2013, the City of Glen Cove continued to implement a water conservation program in order to minimize any unnecessary water use. The pumpage for 2013 was approximately 0.1% less in 2012.

Water supply management has long been a practice in Glen Cove. Over the last 20 years, the city has initiated numerous programs geared to reducing water usage. Obviously, continued water conservation efforts will be required to maintain ample supplies.

Some of the major water conservation measures implemented by the City are:

Water Conservation Ordinances – local ordinances have long been in effect to restrict non-potable water use during periods of peak demand, such as Summer periods and fire emergencies. In 1987, the City, in an effort to promote conservation, amended its municipal ordinances and adopted stricter regulations related to:

- Water sprinkling (odd/even) hours are 5:00 a.m. to 9:00 a.m. and then again from 4:00 p.m. to midnight. There is NO watering permitted on the 31st of any month. Sprinkler systems must be equipped with a backflow device and rain sensor.
- Car washing – only self closing shut off valved hose permitted for use.
- Water saving plumbing fittings and fixtures are required on all new residential and commercial construction and in certain alterations and additions to existing construction.

## WATER QUALITY

In accordance with State regulations, the City of Glen Cove routinely monitors your drinking water for numerous parameters. We test your drinking water for coliform bacteria, turbidity, inorganic contaminants, lead and copper, nitrate, volatile organic contaminants, total trihalomethanes and synthetic organic contaminants. Over 135 separate parameters are tested for in each of our wells numerous times per year. Over 5,000 tests are taken each year from the distribution system and supply wells. The table presented on page 3 depicts which parameters or contaminants were detected in your drinking water. It should be noted that many of these parameters are naturally found in all Long Island drinking water and do not pose any adverse health affects.

### COST OF WATER

Our residential rate structure for each 3 month period is as follows: \$2.36 per 1,000 for the first 45,000 gallons, \$2.66 per 1,000 gallons for the next 45,000 gallons, and \$2.95 per 1,000 gallons for usage over 90,000 gallons.

## SOURCE WATER ASSESSMENT

The NYSDOH, with assistance from the local health department, has completed a source water assessment for this system, based on available information. Possible and actual threats to this drinking water source were evaluated. The source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how rapidly contaminants can move through the subsurface to the wells. The susceptibility of a water supply well to contamination is dependent upon both the presence of potential sources of contamination within the well's contributing area and the likelihood that the contaminant can travel through the environment to reach the well. The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become contaminated. See Section entitled "Water Quality" for a list of the contaminants that have been detected. The source water assessments provide resource managers with additional information for protecting source waters into the future.

Drinking water is derived from four (4) wells (Duck Pond (2), Nancy Court and Kelly Street). The source water assessment has rated all of the wells as having a low susceptibility to potential sources of contamination. However, due to the highly sensitive characteristics of the aquifer, continued vigilance in compliance with water quality protection and pollution prevention programs as well as continued monitoring and enforcement will help to continue to protect groundwater quality.

A copy of the assessment, including a map of the assessment area, can be obtained by contacting the City Water Dept.

The City of Glen Cove Water Department conducts over 5,000 water quality tests throughout the year, testing for over 130 different contaminants which have been undetected in our water supply including:

### Definitions:

**Maximum Contaminant Level (MCL)** - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.

**Maximum Contaminant Level Goal (MCLG)** - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Action Level (AL)** - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**Milligrams per liter (mg/l)** - Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).

**Micrograms per liter (ug/l)** - Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).

**Non-Detects (ND)** - Laboratory analysis indicates that the constituent is not present.

**pCi/L** - pico Curies per Liter is a measure of radioactivity in water.

<sup>(1)</sup> - During 2011, we collected and analyzed 30 samples for lead and copper. The 90% percentile level is presented in the table. The action levels for both lead and copper were not exceeded at any site tested. Resampling is scheduled for 2014.

<sup>(2)</sup> - The Food and Nutrition Board of the National Research Council determined an estimated safe and adequate daily dietary intake of manganese to be 2,000-5,000 micrograms for adults. However, many peoples diets lead them to consume even higher amounts of manganese, especially those who consume high amounts of vegetables or are vegetarians. The infant population is of the greatest concern. It would be better if the drinking water were not used to make infant formula since it already contains iron and manganese. Excess manganese produces a brownish color in laundered goods and impairs the taste of tea, coffee and other beverages. Concentrations may cause a dark brown or black stain on porcelain plumbing fixtures. As with iron, manganese may form a coating on distribution pipes. These may slough off, causing brown blotches on laundered clothing or black particles in the water.

<sup>(3)</sup> - No MCL has been established for sodium. However, 20 mg/l is a recommended guideline for people on high restricted sodium diets and 270 mg/l for those on moderate sodium diets.

<sup>(4)</sup> - Perchlorate is an unregulated contaminant. However, the State Health Dept. has established an action level of 18 ug/l.

<sup>(5)</sup> - MCL is for combined Radium 226 and Radium 228.

All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk. Some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. ## WATER SYSTEM IMPROVEMENTS

The City of Glen Cove is committed to providing Glen Cove residents with the highest quality and best tasting water and to improve the overall efficiency of the system. With this in mind, the Department of Public Works had undertaken an internal audit of all water department facilities, mechanical systems and delivery infrastructure. Immediate needs for operational and mechanical improvements have been determined and the City will be performing major improvement projects for the 2014 period. Improvement projects will include upgrading the City's transmission main to provide service to the waterfront redevelopment project area.

During 2013, the City rehabilitated the Kelly Street well and Well No. 30 to restore capacity and improve operating reliability.

## Glen Cove HS to Host US Marines Inaugural Daly Cup LAX All-Star Game

Glen Cove High School will host the first-ever Dan Daly Cup Lacrosse All-Star game on Saturday, June 21 at 12 p.m.

Sponsored by the U.S. Marine Corps, in partnership with the Nassau County Lacrosse Coaches Association, the New York Lizards professional lacrosse team, the City of Glen Cove and the Glen Cove School District, the game will feature the top high school junior lacrosse players from Long Island, recognizing their superior achievement and building awareness of the legacy of U.S. Marine Sgt. Maj. Dan Daly.

Daly, who grew up in Glen Cove, was a two-time Medal of Honor recipient and one of the Marine Corps' most admired and decorated heroes. Glen Cove Mayor Reginald Spinello will conduct a rededication of the Dan Daly Memorial at Glen Cove Monument Park on the morning of the cup game. Following the ceremony, there will be a parade down Dosoris Lane led by the 30-member Quantico Marine Corps Band and 300 Marines culminating at Glen Cove High School's Maiden Field, where the game will be played. Spinello will also execute the official coin toss at the start of the game. Nassau and Suffolk County lacrosse coaches, in conjunction with New York Lizards players, will serve as coaches for the game, and the Lizards organization will honor the Daly Cup winning team at their July 3rd home game.

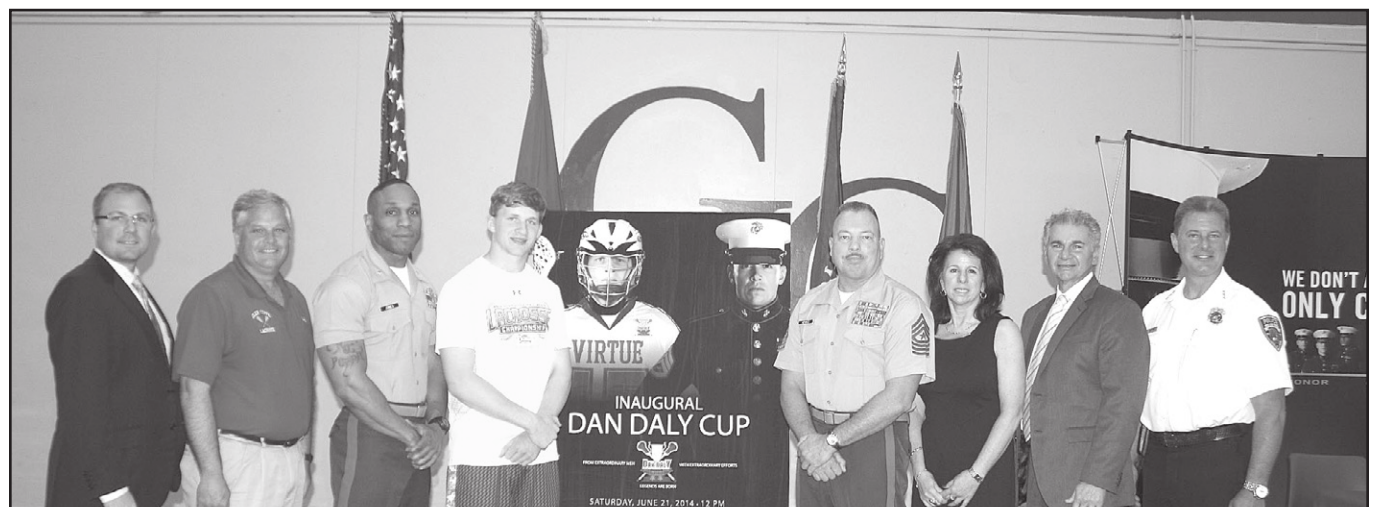

# Name the Celebrity



This week's celebrity was born in Rock Island, Illinois on June 10, 1926. At age 10, she began performing for Rudy Vallee. At age 8, she won a film test by imitating famous actresses including Greta Garbo, Katharine Hepburn and Helen Hayes. However, her mother, an actress in her own right, prohibited her daughter from becoming a child film actress, feeling she was too young. Yet, by her teens, she was a regular band singer with a variety of orchestras and also became a well-known child star on the radio. In the summer of 1942, she moved to Hollywood, where she finished high school and was discovered by a 20th Century-Fox film scout. In 1943, she signed a \$3,500/wk. contract with the studio and made her film debut playing an uncredited role as a hat-check girl in "The Gang's All Here" with Alice Faye and Carmen Miranda. The studio had plans to mold her as a glamour girl stand-in for the studio's two biggest stars, Betty Grable and Alice Faye. She was known as "Pocket Grable". Her credited debut on screen was in a supporting role as "Cri-Cri" in "Home in Indiana" (1944) with Walter Brennan, Jeanne Crain and Charlotte Greenwood. Even before "Home in Indiana" was released, she was assigned

to replace Alice Faye in the Technicolor-musical, "Irish Eyes are Smiling." Later that year, she co-starred with her future husband, Fred MacMurray, in "Where do We Go From Here?", which was the only time the pair appeared together in a film. In 1945, she co-starred with Grable in "The Dolly Sisters", a film for which she had to put on weight. While filming, there was a lot of rumors about a possible clash between the two actresses, mostly because of their frequent comparison. However, our celebrity refuted this. When she married MacMurray, eight years her senior, they adopted twin daughters. She stepped away from performing to raise her family. Believe it or not, it wasn't until the age of 79 and at the urging of friends, dancer/actress Ann Miller and actress Ann Rutherford, did our celebrity finally join the Academy of Motion Picture Arts and Sciences.

### Last Week's Celebrity

Last week's celebrity was born Margaret De Wolfe and was professionally known as Margaret Wycherly. In 1941, twelve years after she performed in her first "talkie" film, "The Thirteenth Chair", she appeared in Howard Hawks' "Sergeant York" with Gary Cooper, Joan Leslie, Walter Brennan and Dickie Moore. She played Sgt. York's common-sense, patient mother. She was nominated for the Academy Award for Best Supporting Actress as "Mother York". For as good as she was in that film, she may be best remembered for her screen role as "Ma Jarrett", the mother of the psychopathic gangster, "Cody Jarrett", in "White Heat" (1949), which famously starred James Cagney. She died on June 6, 1956, at the age of 74, at NYC's St. Clare's Hospital, of a stroke.

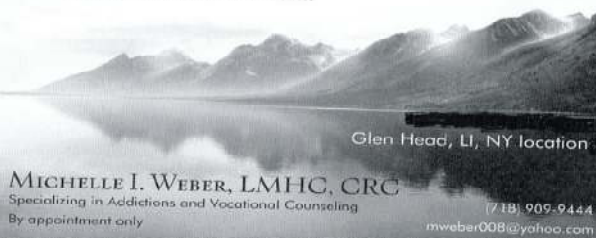
