## Sea Cliff Mayor Bumped By Republican Party?

At his Monday night campaign kick-off; Sea Cliff Mayor Bruce Kennedy had a surprise for his supporters. Despite being nominated as the Republican Party candidate for the NYS Assembly in the 13th District, his designation was yanked unexpectedly last Tuesday and he will be facing a primary election.

According to an article that appeared in Newsday Tuesday, Kennedy was deemed an unacceptable candidate by the Nassau County Conservative Party because he had performed at least one same sex marriage in his tenure as mayor. The Nassau County Republican Party, in an effort to maintain their alliance with the conservatives, decided to switch candidates to one that was agreeable to both parties.

At his kick-off, Kennedy stated, "the Marriage Equality Act was passed in 2011 and I took an oath of office to uphold the laws of the State of New York. As the result of abiding to the law, the Conservative Party chose to not endorse my candidacy." He continued that he is "disillusioned that my own party would abandon any member simply because they followed the law."

When asked about his feeling on the marriage equality law, Kennedy stated that he believed in the 14th Amendment to the Constitution which calls for equal protection of all citizens under the laws. He explained that when asked to officiate a marriage that he does so without prejudice as to ethnicity, color, creed, or who a person loves.

The Nassau Conservative and Republican committees plan to support attorney Louis Imbroto, who lost a bid last year for the county legislature and lost a bid to unseat Lavine in 2012.

Mayor Reginald Spinello is proud to announce an historic celebration of Glen Cove hometown hero, one of the United States Marine Corps' legends, Sergeant Major Dan Daly. "We are truly honored that Sgt. Maj. Daly's great, grandniece, Barbara Ransweiler Harcourt of Holbrook, his only living descendant, will be with us on June 21. Our tribute begins at 9 a.m. in Monument Park with the rededication of the plaque that bears his

name. From there, the US Marine Corps Band from Quantico will lead a parade of 200 Marines up Dosoris Lane to Glen Cove High School. At the high school, the first-ever Dan Daly Cup all-star lacrosse game will be held between high school junior boys' lacrosse team members from Nassau County (team Virtue) and from Suffolk County (team Valor). In preparation for the game, the NY Lizards professional lacrosse organization provided their coaches to share their expertise with each team member. Everyone is invited to join us for this wonderful event." said Mayor Spinello.

Sgt. Maj. Dan Daly was born in Glen Cove on November 11, 1873. He

received the Medal of Honor twice; the first for his actions during the Battle of Peking in 1900 and the second in 1915 for his heroism during combat in Haiti. His uncommon valor continued during World War I in the battle of Belleau Wood. Sgt. Maj. Daly was awarded the Navy Cross, the Army Distinguished Service Cross, and the French Croix de Guerre with Palm. Sgt. Major Daly's heroism prompted Major General John A. Lejeune, former Commander of the Marine Corps, to say that Sgt. Maj. Daly was an "outstanding Marine of all time."

Sgt. Major died in 1937 in Glendale, Queens and is buried in Cypress Hills National Cemetery.

## Ask The Elder Law and Estate Planning Attorney

### Estate Planning Isn't Just For Millionaires

**The Question:** I heard that New York State just doubled its estate tax exemption. My assets are below the new exemption. Do I still need estate planning?

**The Rules:** Effective April 1, 2014, the New York State estate tax exemption increased from \$1 million to \$2,062,500 per person. In addition, the exemption will increase each year until 2019 when it will equal the Federal estate tax exemption (projected to be \$5.9 million per person at that time).



**The Situation:** The increase in the exemption is good news for upper-middle class families. However, the new law doesn't provide relief to the wealthy and actually puts them in a worse position. The new estate tax law provides that all taxable gifts made within three years of death will be brought back into a person's taxable estate and that if a deceased person's taxable estate exceeds the exemption by as little as five percent, the entire estate becomes subject

to estate tax. Some persons wrongly believe that if they do not have a taxable estate, they do not need estate planning. They fail to recognize that estate tax planning is just one aspect of estate planning. Many reasons to engage in estate planning still exist despite the increase in the estate tax exemption. These reasons address important issues that have nothing to do with estate taxes.

**The Strategy:** Everyone over the age of eighteen should have an estate plan regardless of their level of assets. Every person should have at least a health care proxy, living will, durable power of attorney and a last will and testament with proper provisions.

**Non-Tax Considerations:** If you wish to choose who will benefit from your estate upon your death rather than defaulting to the government's plan to distribute your assets, a good estate plan includes a last will and testament. If you do not want your family to have to file a court proceeding to become your guardian and you do not want your family potentially fighting in court over who should be your guardian, a good estate plan will address appointing agents to make medical and financial decisions for you if you are no longer able to do so yourself. If you are concerned about losing your assets to the costs of a nursing home or other long-term care in the future, a good estate plan implements a plan (e.g., long-term care insurance or Medicaid planning) to protect your assets from the substantial risk that such expensive care may become necessary.

If you are concerned that your beneficiaries may go through a divorce or be sued, a good estate plan includes provisions so their inheritance is best protected from a divorce, other lawsuits, and falling outside you bloodline. If you have minor children, you should designate standby and permanent guardians.

**The Result:** A proper estate plan - which addresses tax as well as non-tax considerations - allows you to remain in control of your life's important decisions and legacy decisions while also protecting the interests of your family members.

Victoria Crosby recently gave a power point presentation on historic mansions of England, including two where she had stayed as a child growing up, and those she visited in North America. These included the mansions she had written about as features writer for 25A magazine. The June edition features her

updated article on Inisfada, the former St. Ignatius Retreat in Manhasset which was sold to developers and demolished last year.

Elizabeth Hogan, Reference Librarian at the Glen Cove Library, introduced Ms Crosby, a journalist for the Leader weekly newspaper as well as features

writer at 25A Magazine, and Glen Cove's poet laureate since 1994. The presentation included several poems about historic mansions and castles. Copies of 25A Magazine were distributed to people attending the lecture.



## SAFE Inc., continue to map out a winning strategy for Glen Cove youth

Members of SAFE's PRIDE Project Coalition met recently at a sustainability planning meeting to review their individual committee's accomplishments in the past year as well as forecast a plan of action for the upcoming year.

SAFE Board Chair and Strategic Planner Georgie Connett stated that the Coalition is in its last year of Federal funding through a Drug Free Communities Support Program grant. She thanked the Coalition for all of their hard work and accomplishments.

SAFE also receives NYS OASAS funding. OASAS has partnered with the NYS National Guard Counterdrug Task Force to improve the health and well-being of NY communities by addressing alcohol and substance abuse through Coalition development.

National Guardsmen Staff Sgt. David You and Sergeant First Class Jim Aquino came to this year's sustainability meeting where they introduced the Guard's Coalition Assessment tool, the KAIZEN, which Coalition members used to answer a series of questions that will determine the Coalition's overall effectiveness and areas of concentration. As a group, the Coalition will develop strategies and milestones for improvement based on the results of the KAIZEN.

After completing the KAIZEN, Coalition Committee Chairs addressed the membership regarding future Action Steps for their respective committees that incorporate the recent Bach Harrison Prevention Needs Assessment results.

Glen Cove Councilman Tony, Gallo, the new chair of the Community Committee, discussed plans to create a phone app for the SAFE Rides Program. The Bach Harrison Prevention Needs Assessment study for 2014 indicates that 11.3 percent of sixth graders are riding in cars with someone under the influence, said Gallo.

"The motivation of SAFE Rides is to incorporate technology using an app on cell phones instead of calling a cab," he explained. "When youth activate the app it will go directly to a taxi company who will provide a ride."

The Community Committee will also work to develop data from the Social Host Hotline and continue to work

with the Glen Cove Police Department in their commitment to increase DWI sweeps to capture underage drinkers that are drivers and passengers. Additionally, the committee will continue their collaboration with the Glen Cove Business Improvement District, and Chamber of Commerce to implement the SAFE initiative to address the recent data that concerns area merchants' non-compliance to



reduce the sale of alcohol to minors.

"Part of our efforts at the police department includes stings at the local liquor store and convenience stores," said Glen Cove Police Sgt. Chris Ortiz. "This past year we've got 100 percent compliance. We find they are asking for proper identification."

Ortiz added that the Glen Cove Police Department was awarded two grants for DWI enforcement this year.

One initiative SAFE is working on is the implementation of zoning and regulations for new retail establishments throughout Glen Cove to decrease city-wide availability of tobacco paraphernalia. "There needs to be more leadership from the top to get this zoning in place," said Gallo.

Ortiz recommended that it be a law that tobacco paraphernalia not be permitted a certain number of feet from a place that sells alcohol.

"We are anti tobacco," said Georgie Connett, Safe Board Chair, adding that SAFE does not support the expansion of a hookah retailer that is being discussed

in town.

The Parent Committee, led by Laurent Caballero, will continue to work on incorporating the new results from the Bach Harrison Survey. The committee acts as a bi-lingual parent resource for prevention, education, intervention and research on alcohol and drug abuse and serve as a liaison with the PTA. They will continue their efforts to recruit new

"We've Seen Enough Campaign," that SAFE has brought to the school district for the past two years.

An afterschool program, the Life Skills Evidence-Based program, will address the results from the Bach Harrison survey targeting the middle school student data.

"I want to invite people from SAFE to speak about the results of Bach to our health teachers and physical education teachers," said Kiernan. "They need to hear this so they can understand what is going on with our children."

The Youth Committee, led by Arlene O'Dell, Executive Director of the Glen Cove Youth Bureau and Melissa Rhodes, Executive Director of the Glen Cove Boys and Girls Club is committed to developing, promoting and implementing the prevention programs for youth. The committee will continue their collaboration with the School Committee's Teens as Teachers regarding the implementation of prevention education and strategies.

"We are constantly trying to involve kids to do something better," said O'Dell. "All of our programs continue to be involved in community service classes. This year for the first time the kids were involved in the community service project Relay for Life."

Some of the programs the committee will be presenting to decrease idle time among youth and to showcase them are the Family Awareness Day, Kiwanis Pizza Night, National Night Out and the annual Boys & Girls Club SMART Moves Evidence Based Summer Programs.

## Clean Water Initiatives

### To The Editor, Sewering Crescent Beach and Sea Cliff Avenue

One of my foundational priorities since taking office has been protecting our health and environment. When it comes to clean water initiatives, the first on the list has been fighting for sewers in our area. This would protect our drinking water and our bodies of water.

As I have shared before, last year, I had a team research and write a proposal to expand Nassau County's Sewer system to incorporate the Crescent Beach area as well as the existing plans that Mayor Bruce Kennedy has created for Sea Cliff Avenue. The Sea Cliff mayor and I met with Congressman Steve Israel on this and the congressman helped start the process of searching for funding. Part of this involved the City of Glen Cove working with me to apply for a grant to study the project. We are all continuing at the federal, state, county, city and village level to find the study money to get the ball rolling. I am confident we will get there.

### Clean Water Initiative and Shoreline Trail for Port and Roslyn

As the "waterfront district" legislator, I am very pleased to announce that I have been pushing for clean water projects to benefit Port Washington and Roslyn, and they have recently been approved at the Nassau County Legislature.

Through a Nassau County Environmental Bond Act, Nassau is supporting some really great improvements through the Town of North Hempstead aimed at stopping pollution and revitalizing our Hempstead Harbor and Manhasset Bay shoreline.

First, good news for Port and Roslyn residents who love running, biking or walking along the water on West Shore Road, we are supporting a project to continue a shoreline trail. This is a prime location for recreation, defining what

makes living on Long Island so special. So, I am glad to see that area turning around so much. What many remember as the dump area, is now completely revitalized in a manner befitting the location and our local character. The golf course and residences, a newly repaired and paved county road, and now the addition of more trails are all great developments in my mind. I look forward to more revitalization of this wonderful stretch of waterfront that shows we appreciate our natural gifts and take advantage of them correctly.

Next, in Roslyn, we are teaming with the Town of North Hempstead to do wetland planting and install stormwater controls at Roslyn Pond.

Similarly, in Port, we are installing several types of stormwater control improvements and doing planting at Mill Pond as well as North Sheets Creek in Manorhaven.

The storm drain "inserts" and the plantings are meant to eliminate a broad range of pollutants from heavy metals, oils and hydrocarbons, to bacteria and organic contaminants. It is crucial to not let stormwater go through the streets, picking up all of these things and then bring them straight into the waterways.

My esteemed colleague and Legislative predecessor Wayne Wink, our current Town Clerk, helped push for this while he was at the County. He pointed out that not only is this type of project important for the environment, but it is a great example of different levels of government working together on common goals that truly benefit the public. I thank Wayne, our Town Supervisor Judi Bosworth, our county officials and the environmental advisors who all made this possible. I am proud to be a part of what they started and am so glad I was able to advocate for this to finally pass through the Legislature.

### X-Men: Days of Future Past

A movie review by Katherine Kranz 2014

Runtime: 131 min

Rated PG-13 (Intense sci-fi action and language)

Stars: Hugh Jackman, James McAvoy, Michael Fassbender

One of the most reliable franchises took a bit of a stumble with its previous installment, "The Wolverine" of last year. Screenwriters and a director who mis-handled the material made the whole affair overlong and somber, a stark contrast to the rest of the X-Men series. Especially disappointing was that it followed 2011's "First Class," not only one of the most finely crafted movies in this particular set but of the entire comic book-to-screen subgenre. With much relief, "Days of Future Past" has righted the course in the ever expanding tale of unordinary men, women and children seeking equality in our beligerently judgmental world.

Audience members who stayed for the post credits scene of "The Wolverine" know that Professor Charles Xavier (Patrick Stewart), head of the School for Gifted Youngsters, has in fact survived. How exactly, is left up to imagination. The seventh entry begins with a spectacular battle between mutants, both new and familiar, and Sentinels, robots designed to wipe out their kind. The world has been left in ruin by this ongoing war. Rivals now forced to cooperate, Professor X and Magneto (Ian McKellen) believe the only way to prevent such a dystopia is to use the time traveling capabilities of Kitty Pryde (Ellen Page). When she acquired this power is uncertain, as when she was last seen her phasing ability was used primarily for walking through walls. If they can prevent the Sentinels from existing, countless lives would be saved.

Initially, it is Professor X who volunteers to transport his consciousness to the 1970s, when the Sentinels were first created. Logan/ Wolverine (Hugh Jackman) reminds them that he himself is the only one who can survive such a trip, being able to heal himself as the forces of time tear his mind apart.

Suddenly finding himself in 1973, Wolverine tracks down Professor X's younger self, once again played with brilliance by James McAvoy. Tormented by the events of the past and frustrated with his telepathic abilities, he lives isolated in his shut down school for mutants. Xavier's only companion is Hank/ Beast (Nicholas Hoult) who provides him with suppressing medication. Gaining their trust was difficult enough for Wolverine. Now he must find the man whom Xavier once called a friend,

Erik/ Magneto (Michael Fassbender). Accused of one of the most shocking crimes of the time period, Magneto is locked in a highly secure prison. Providing assistance is a spirited young man called Quicksilver (Evan Peters).

As the team reunites, Dr. Bolivar Trask (Peter Dinklage) is leading research into the weapons that would rid the world of the so-called mutant problem. Wolverine and company know they must find the one mutant who would play a pivotal role in Trask's plans, Mystique (Jennifer Lawrence).

Based on the plot of the 1981 publication "Uncanny X-Men" and written by

Simon Kinberg, "Days of Future Past" acts as a sequel to both "The Wolverine" and "First Class." Kinberg is no stranger to the X-Men Marvel universe, and director Brian Singer continues to show he is one of the most skilled men for the job. Action sequences have been meticulously choreographed and often filmed in long, full body takes. The 70s era is recreated with stunning richness accompanied by a thrilling score. At this



point in the story's timeline, it is a difficult task to build upon such a large amount of characters without compromising what has already been established in past entries. There are even multiple amusing references to the comic book source material for diehard fans that fit in seamlessly.

Bringing the film together is the ensemble cast of highly talented actors who dedicate themselves unwaveringly to their fantastical roles. Fassbender and McAvoy, both phenomenal performers in their own right, have such remarkable chemistry together as both friends and nemeses. Evan Peters stands out with enthusiastic confidence, stealing every scene he is in. Lawrence perfectly displays the conflict and mesmerizing beauty of Mystique. Jackman continues to give a flawless performance of the physically imposing Wolverine. Of course, anytime Patrick Stewart and Ian McKellen are together is a joyous experience.

With just the right amount of seriousness and humor, the series is back to conveying the message that is at its core. It is a means of strength for the outsiders and the unique to combat the oppression of the ignorant. Yes, the explosive action is magnificent to behold, but it would only be superficial were it not for the strong air of humanity. "Days of Future Past" is that kind of top quality storytelling. Stay for the after credits scene where you can glimpse what will hopefully continue this trend of excellence, "X-Men: Apocalypse."

## North Shore Ninth Graders Study Historic Volcanoes

Student Oliva Mevorach said, "Volcanoes are spontaneous and frightening. Volcanoes can kill you in many ways

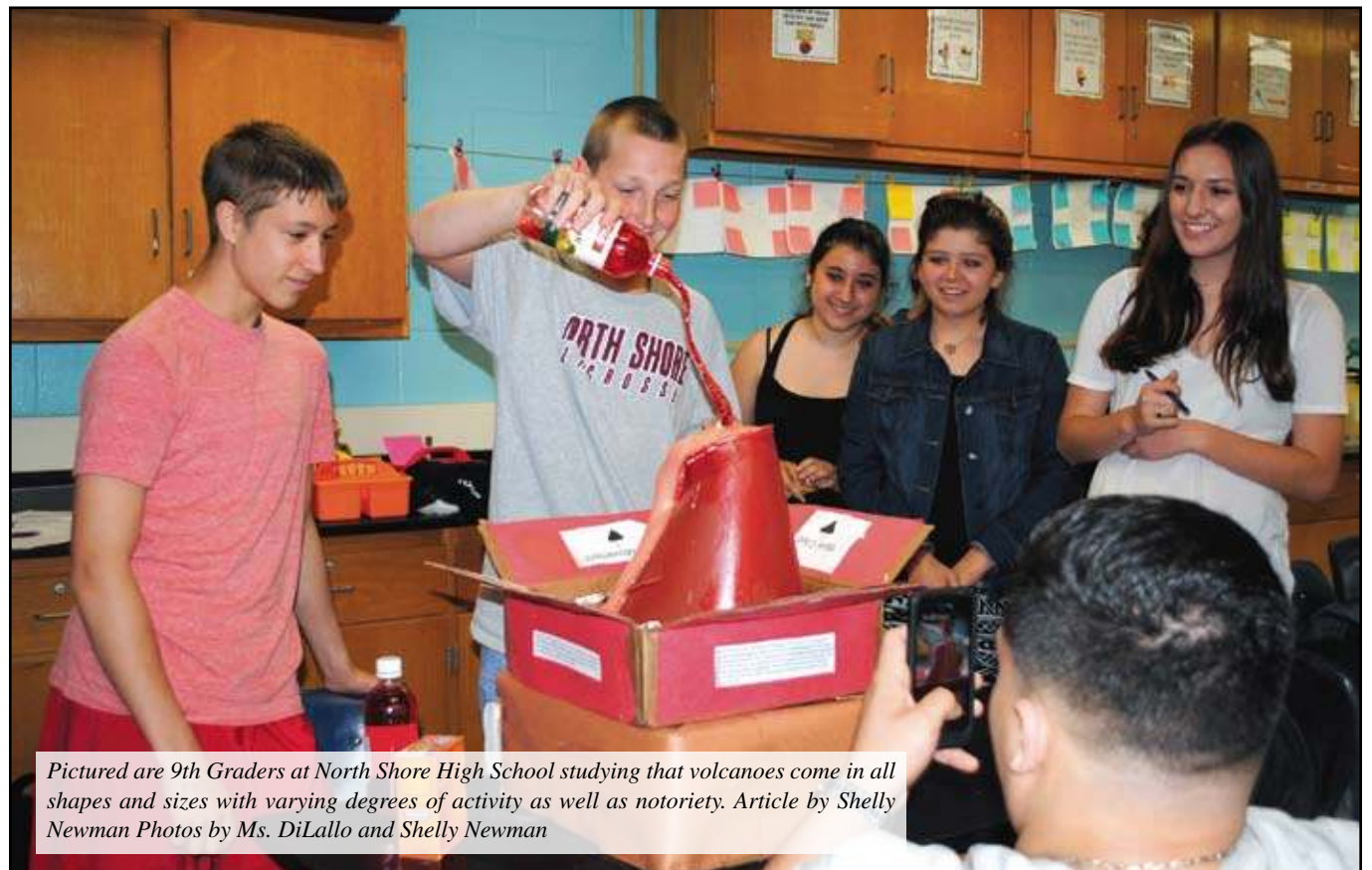

### Last Week's Celebrity

Last week's celebrity was Fred E. Scott. After Dumont Television Network faded out in 1956, Fred remained an announcer for Channel 5 television in NY (later WNEW, WNYW and FOX 5) hosting a television cartoon show as "Uncle Fred". He became the fourth and the last host/performer of "Bugs Bunny Presents" seen weekday evenings. The show's title changed to "Nuts & Bugs" because the series aired reruns of old movie comedies that featured Charlie Chase, Edger Kennedy, Leon Errol and Ben Turpin, along with the "Bugs Bunny" movie cartoons. Fred succeeded Sonny Fox as the second and last host of WNEW TV Ch.5 NY Saturday morning game show "Just for Fun". He may also be remembered by baby-boomers, as the guest fill-in host for Soupy Sales for one week on his WNEW-TV show Jan. 1965, during Soupy's suspension. This was a result of Sopy's infamous New Year's Day blunder. Soupy had told his young TV audience to go their parents' handbags and wallets and send him the green paper! A joke, but a definite FCC no-no! Uncle Fred died Nov. 16, 2008 in Ridge, NY. He had spent most of his life in Muttontown and later in Syosset. He was 88 years old.

### Correct Callers

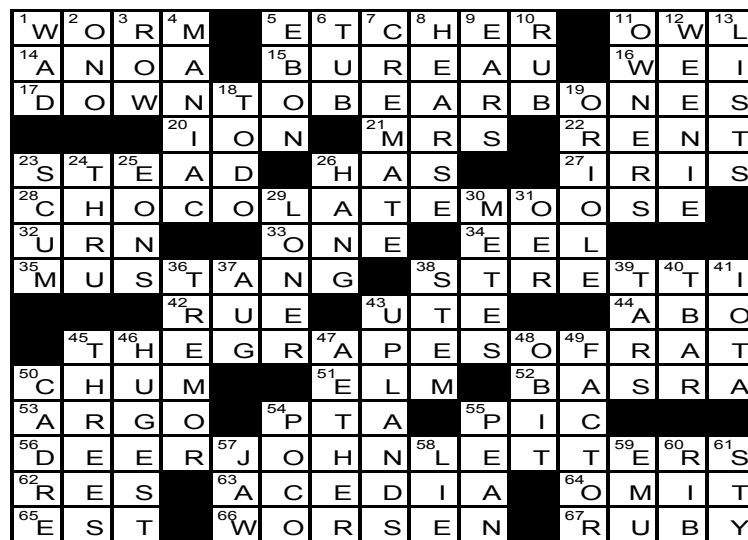
Callers who know our celebrity were: Don Adams, Will and Babs Hutchins, Roberta Pezza and Mario Moccia.

This week's celebrity was an American actor who appeared on film, radio and television. He was born on Dec. 5, 1909, in the Bronx, to Jewish immigrants from Imperial Russia who had arrived in the U.S. as infants. His father was the manager of an optical firm. Our celebrity entered NYU in the Fall of 1925 at age sixteen. After graduating from NYU in 1929, he attended Columbia University for a short time, reportedly in the School of Law, but dropped out after getting his first acting job in 1930. On Sept. 22, 1930, our celebrity changed his name to a more Anglo-sounding stage (and later legal) name for his first acting role on Broadway, "A Farewell to Arms".

His choice to change his name was rather ironic in that nearly all his acting roles would be ethnic caricatures of various types. He spoke several languages. He would have several small parts in three Broadway productions in the next two years before landing roles in some Warner Bros. films shot in NYC. His face was scarred in an amateur fencing match, adding to his signature character image as heavies. He made his film debut in "Central Park", a 1932 U.S. Pre-Code feature length crime drama film produced by First National Pictures, distributed by their parent, Warner Bros..

This rarely seen film, starring Joan Blondell, Wallace Ford and Guy Kibbee, exists in a nitrate print at the Library of Congress. It has recently had a DVD release. His role as "Nick Sarro" in that film, was followed quickly by a bit part in "20,000 Years in Sing-Sing" with Spencer Tracy and Bette Davis. A little remembered fact was that this film was adapted from the non-fiction book written by Lewis E. Lawes, the warden of Sing-Sing from 1920 to 1941. Our celebrity appeared in nearly 100 films in the 1930s and 1940s. Once viewing our celebrity in "Mary Stevens M.D." (1933) as "Nick", the highly agitated father-to-be, who threatens to kill "Dr. Stevens" played by Kay Francis, simply because she is a female doctor, is not easily forgotten. Hard to believe such days actually existed! Another early noteworthy role was as the stool -pigeon "Nun-

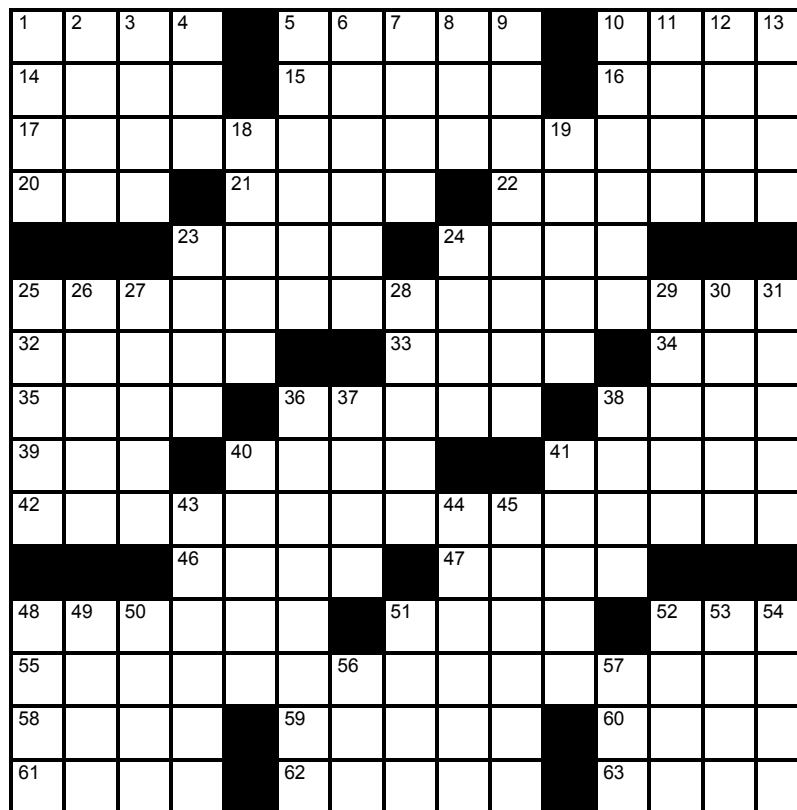

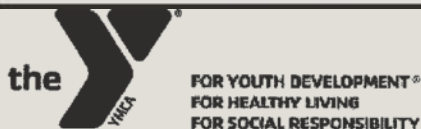
