## New Appointments, Resolutions, and Strong Public Response at City Council Meeting

Tuesday night's city council meeting was met with public concern after Joseph Capobianco was appointed to the position of Council Member. Joseph Capobianco was selected for the position after the untimely passing of Nicholas Dileo in April left a vacant seat on the city council.

Joseph Capobianco would fill the position on the city council board until the next general election in November.

Differences of opinion were made known at the meeting based on whether or not the decision was justifiable. Some argued that the decision was reached without full consent of the Council; others argued that it should have been a more transparent decision.

The council members themselves debated over the validity of the decision based on lack of information shared within the council. Efraim Spagnoletti voiced his concern to mayor Spinello on being kept

out of the loop in terms of the decision being reached. Joseph Capobianco spoke briefly on the allegations but maintained his position on his ability to serve as a council member until the next election. The resolution was ultimately tabled for further discussion by the city council and the decision will be reviewed.

New appointments also included summer camp councilors and youth board members in various positions.

Other resolutions addressed at the meeting included new and finalized regulations to the sewage and wastewater disposal in the city. Another resolution prompted the council to enter into agreement with Digital Age Group Inc. to provide live streaming of City Council meetings online.

Minutes approved for the next council meeting were approved for July 22nd, 2014.

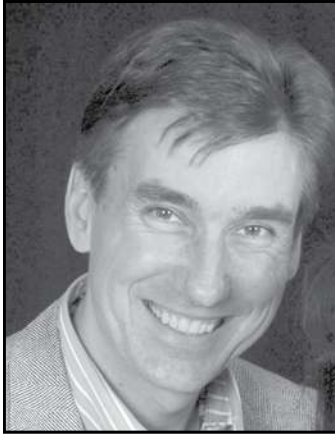

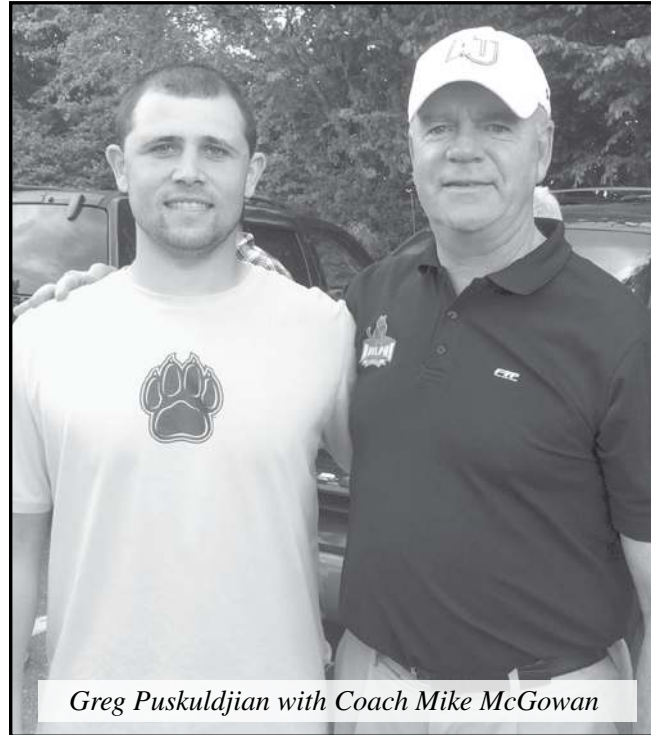
Boston University awarded academic degrees to 6,321 students in May 2014.

pletely transformed his game. He shed weight while training for a marathon and went out to the practice field every day to work on faceoffs. He recorded several 'down-set-whistle' cadences into his iPhone and would put it on a loop as he trained by himself. He would do a hundred face-offs a day.

He wanted a starting position and he got that chance as a 2011. In that game he won 19 of 22 faceoffs and never looked back. In his sophomore and junior seasons Greg had the best Face Off winning percentage in the county, averaging a 70 percent win percentage.

Gregory Puskuldjian completed his four years at Adelphi University and graduated this spring with a Degree in Business and an incredible Lacrosse career as a Faceoff Man playing for the Adelphi Panthers.

Greg joined Adelphi after graduation from North Shore High School, looking for an opportunity for a good education but to also to play Lacrosse. Greg dabbled in many sports while he was younger and many remember him as a hockey and soccer player, but he always loved lacrosse.

In 2010 Greg joined the Adelphi Panthers as a walk on. As a freshman Greg really did not play much. He was the number 5 faceoff man and did all of four faceoffs his first year. Adelphi's coach Gordon Purdie said of Greg "as a freshman, his stick skills were incredibly poor. After his first year he was our No. 5 faceoff guy and going into his second year, he was our No. 4 faceoff guy, which was low guy on the totem pole. He was that guy where everybody looked at him and said, 'C'mon Greg,' because—and I hate to say this — he was a bit of a drill-buster."

Between the 2011 fall ball and 2012 season, his sophomore year, Greg com-

ing a 70 percent win percentage.

Greg credits much of his success to his coach's Gordon Purdie and Joe Catalanotti who encouraged him to work hard. But also credits much of his success to Coach Mike McGowan the Chief of Police for the Hempstead Police Department. Mike is a volunteer coach on the Adelphi coaching staff who worked with Greg at every practice. Mike meticulously watched Greg and offered encouragement and pointers on how he could improve. Greg and Mike became the most unlikely of partners with Mike saying "I just love being around Greg, he works so hard".

Greg's lacrosse accomplishments are astonishing. Greg is a three time All American, three year All Conference Northeast 10 selection, Adelphi Sophomore Athlete of The Year, Adelphi Junior Athlete of the Year, Division II 2014 Specialty Player of the Year, 2012 and 2013 Division II Face Off champion.

Greg capped the 2014 season off by breaking the single season ground ball record as well as the all time ground ball record at Adelphi and was selected as Adelphi's 2014 Athlete of the Year!

## Water Use Restrictions: Reminder to Residents

Houses and buildings that are not numbered are considered to be even numbered. Watering is not permitted on the 31st of any month.

All sprinkler systems must be equipped with a backflow device and

rain sensor. The Mayor and/or the Director of Public Works have the right to declare a public emergency when conditions warrant. All watering/sprinkling/car washing is prohibited during a public emergency

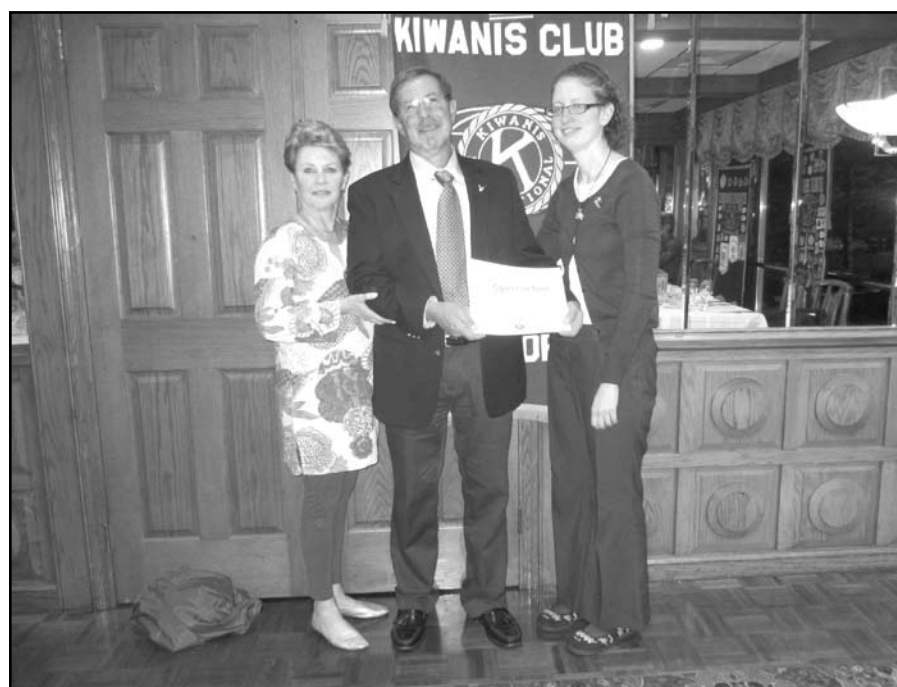
## NS Kiwanis Supports Kamp Kiwanis For Children In Need

PLEASE TAKE NOTICE THAT the Glen Cove City Council adopted the following Local Law 02-2014, at the City Council Meeting of June 24, 2014:

BE IT RESOLVED, that Section 235-13, Solid Waste, (Penalties for Offenses) of the Glen Cove City Code of Ordinances is hereby amended, as follows:

Section 235-13, Solid Waste, (Penalties for Offenses) of the Glen Cove City Code of Ordinances:

(A) Any person or corporation or officer thereof who shall violate any of the provisions of this article, or who fails to comply therewith or who shall fail to comply with any written notice of violation or order issued by the Building Department Administrator, shall be guilty of a violation within the meaning of the New York Penal Law and, upon conviction, shall be liable to a fine of not less than \$1,000 nor more than \$2,000 or to imprisonment for a period not to exceed 15 days, or both; and, upon a second conviction for the same offense committed within five years of the date of the first offense, shall be liable to a fine of not less than \$2,000 nor more than \$3,500 or to imprisonment for a period not to exceed 15 days, or both; and, upon a third conviction for the same offense committed within five years of the date of the second offense, shall be liable to a fine of not less than \$3,500 nor more than \$5,000 or to imprisonment for a period not to exceed 15 days, or both. Each week that any such violation continues shall constitute a separate and distinct violation. The owner or owners of any building or premises or part thereof where a violation of any of the provisions of this article shall exist or any lessee, tenant, builder, contractor, subcontractor, agent, person or corporation employed in connection therewith and any person who assisted in the commission of any such violation shall each be guilty of a separate offense and, upon conviction thereof, shall be punishable as herein provided.

(B) Notwithstanding subsection A above, or any other provision of law to the contrary, any person violating any

Section 3(A) of this chapter shall be liable to a penalty set in accordance with Chapter 1, General Provisions, Article II, General Penalty.

Local Law 02-2014 shall take effect immediately upon its filing in the Office of the Secretary of State.

PLEASE TAKE NOTICE THAT the Glen Cove City Council adopted the following Local Law 02-2014, at the City Council Meeting of June 24, 2014:

Local Law 03-2014

BE IT RESOLVED, that the City Council hereby amends Chapter 225, Part 1 - Sewer Use, Article IV Private Wastewater Disposal.

Chapter 225.

Part 1- Sewer Use

Article IV- Private Wastewater Disposal (225-17 - 225-26)

225-17- Connection to private system required when public sewer unavailable

A. Where a public sewer is not available, under the provisions of 304 of the Act, a building lateral shall be connected to a private wastewater treatment system complying with the rules and regulations of the NYSDOH, to be enforced by the Director of Buildings and/or the Nassau County Department of Health.

B. No statement in this article shall be construed to interfere with any additional requirements that may be imposed by the Nassau County Department of Health, the New York State Department of Environmental Conservation and/or the United States Environmental Protection Agency.

C. In the event that any section, paragraph, sentence, clause or phrase of this Article shall be declared unconstitutional or invalid for any reason, the remainder of said Article shall remain in full force and effect.

225-18- Private wastewater disposal prohibited

Except as hereinafter provided, it shall be unlawful to construct or connect to any privy, privy vault, cesspool, septic tank or other facility intended or used for disposal of wastewater without certification that the existing system can handle such additional capacity.

225-19- No new connection to existing private wastewater disposal system

No new connection to any existing septic tank, cesspool, privy vault, tile absorption field or other similar type means of private wastewater disposal shall be allowed without certification that the existing system can handle the additional capacity.

225-20- Permit required

A. Before commencing construction of any private wastewater disposal system the owner(s) shall first obtain a private wastewater disposal system permit signed by the Director. The permit application form shall be furnished by the Director of Buildings. The applicant shall supplement the application with any plans, specifications or other information deemed necessary by the Director. A permit and inspection fee in the amount stated on the application form shall be paid to the city at the time the application is filed with the Building Department.

B. The type, capacity, location and layout of any private wastewater disposal system shall comply with the regulations of any other agency having jurisdiction. No septic tank or cesspool shall be permitted to discharge to any natural or man-made water conveyance.

225-21- Construction permit

A. A construction permit shall be obtained from the Director before commencing construction. The Director, or his or her designated representative, shall be permitted to inspect the construction at any stage without prior notice.

B. A permit for a private wastewater disposal system shall not become effective until the installation is completed to the satisfaction of the Director. The Director shall be allowed to inspect the work at any stage of construction, and the applicant shall notify the Director when the work is ready for final inspection and before any underground portions are covered. The inspection shall be made within five business days of the receipt of notice by the Director.

225-22- Private nuisances

A. When liquid or liquid borne effluent from a private wastewater disposal system enters any watercourse, water conveyance, ditch, storm sewer or water supply system located in the City of Glen Cove in such a manner, volume or concentration so as to create a hazardous, offensive or objectionable condition, in the opinion of the Director, the owner of the premises upon which such wastewater disposal system is located, upon receiving written notice from the Director to do so shall, within the time limit prescribed in the notice, abate such nuisance, and within 90 days after receipt of such notice, repair, rebuild or relocate such wastewater disposal system for the purpose of eliminating such hazardous, offensive or objectionable conditions. The repair, rebuilding or relocation of the system shall be accomplished at the owner's expense in accordance with the rules and regulations of the NYSDOH and/or the Nassau County Department of Health.

B. At the request of the BDA, the City Attorney is authorized to make application to Glen Cove City Court or any other court of competent jurisdiction for the issuance of a search warrant, to be executed by a police officer, in order to conduct an inspection of any premises believed to be discharging any liquid or liquid-borne effluent from a private wastewater disposal system that enters any watercourse, water conveyance, ditch, storm sewer or water supply system located in the City of Glen Cove in such a manner, volume, and concentration so as to create a hazardous, offensive, or objectionable condition. The BDA may seek a search warrant when the owner or occupant fails to allow inspection of any dwelling unit where there is a reasonable cause to believe that a violation of this Article, the Building Code, the rules and regulations of the NYSDOH and/or the Nassau County Department of Health has occurred after due notice has been sent by ordinary United States mail. The application for a search warrant shall in all respects comply with applicable laws of the State of New York.

225-23- Private Waste Inspection Requirement

A. Qualifications

The minimum qualifications for an inspector shall be in addition to completing the required course and passing the test to insure knowledge of wastewater regulations and inspection procedures:

1. Professional Engineer, Registered Architects or Licensed Land Surveyor with certificate for minor engineering all of whom are licensed by New York State to design septic tank systems.

2. Glen Cove City Code Enforcement Officers, water supply operators or sewage treatment plant operators.

3. A person who has been in the business and supervising the installation and repair of septic tank systems on a regular basis in the City of Glen Cove for five years.

B. The owner shall operate and maintain each private wastewater treatment system in a satisfactory manner at all times and said systems shall be inspected bi-

annually. The inspection report shall be filed with the Building Department in a format provided by the Director of Buildings that shall contain each of the following:

1. The location of the wastewater treatment system, including the street address and tax map, block, and lot numbers of the parcel of property and the location of the system therein with latitude and longitude coordinates;

2. A general description of the wastewater treatment system, including sizes, dimensions, and sketch of the system;

3. The date(s) of system construction and subsequent repairs, modifications, or alteration, if available;

4. A listing of the wastewater generating fixtures, which are verified by dye testing their discharge into the system;

5. A description of the occupancy and annual use of the system, including periods of maximum use;

6. A listing of the distances separating the applicants seepage pits, treatment fields, and leaching facilities from adjacent wells, watercourse, or property lines, if known;

7. A certification that the integrity of system is not structurally impaired in any way and is not discharging sewage or wastewater onto to the surface of the ground or into a watercourse without a permit from the New York State Department of Environmental Conservation.

C. Prior to any property transfer, all private wastewater treatment systems shall be:

1. Pumped out by a New York State Department of Environmental Conservation licensed waste hauler, and a report filed with the Glen Cove Department of Buildings and made available to the proposed new owner, unless documentation can be furnished that the tank has been pumped out by a licensed hauler within the last twelve months.

2. Prior to, or at the time of property transfer, all wastewater treatment systems shall be inspected in accordance with 225-23(B) and a report filed with the Glen Cove Department of Buildings and made available to the proposed new owner.

D. Notwithstanding any other provision of this article or any permit issued thereto, no person shall discharge, cause, or allow to be discharged, sewage or wastewater onto the surface of the ground, or into a watercourse without a permit from the New York State Department of Environmental Conservation.

225-24- Septage removal

Where a private wastewater disposal system utilizes a cesspool or a septic tank, septage shall be removed from the cesspool or septic tank by a licensed hauler every three years and a report thereof shall be filed with the Director of Buildings.

225-25- Direct connection to new public sewers required

A. When a connection for an existing building is made to any public sewer, the connection to a private wastewater disposal facility shall be cut and both ends of the cut shall be plugged as appropriate.

B. Any cesspool, septic tank or similar wastewater disposal facilities shall be cleaned of septage by a licensed septage hauler, and either:

(1) Filled with clean sand, bank-run gravel or dirt; or

(2) Be removed and properly disposed of.

225-26- Penalties for offenses

Any person or entity that shall violate any of the provisions of this article or who fails to comply with any of the requirements thereof shall be guilty of a violation, punishable by:

A. A fine not less than \$1,000 and not exceeding \$2,000 or by imprisonment

# Name the Celebrity



Born Hattie Helen Gould Beck, on April 3, 1904, in the village of Elkton, Hickory county, Missouri, this week's celebrity was a dancer and actress. Her father, William Beck, was a West Point graduate and a retired U.S. Army Colonel. Her mother, Nettie Grove Beck, was a school teacher and part-time newspaper correspondent. Before using her professional name, Helen got her start on the stage quite early, working as a chorus girl at Kansas City's Empress Theater when she was only 13. An early supporter of her talent was Goodman Ace, a drama critic for the Kansas City Journal, who saw her performing in a Kansas City nightclub and wrote glowing reviews.

After studying ballet and drama in Kansas City, the teenage Helen decided her future lay in Hollywood. For a short time, as she worked her way to the west coast, she was employed as an acrobat in the Ringling Brothers Circus. She also performed in a summer stock and traveling theater. In 1935, this included work with a then-unknown Humphrey Bogart, in a stint as "Sadie Thompson" in "Rain", later played by Joan Crawford and Walter Huston on film. Films came her way as she was able to score work, due to her agile background in the circus, from Mack Sennet and Hal Roach, in a few of their daredevil slapstick shorts. A Wampas Baby of 1927, she joined mentor Cecil B. DeMille's stock company and entered feature films with a new name that DeMille gave her. She appeared in DeMille's "The Sign of the Cross", a pre-Code epic film released by Paramount Pictures. The film stars Frederic March, Elissa Landi, Claudette

Colbert and Charles Laughton. The film was the third and last in DeMille's biblical trilogy with "The Ten Commandments" (1923) and "The Kings of Kings" (1927).

It was the content in "The Sign of the Cross" and "Ann Vickers" (1933) starring Irene Dunne and Walter Huston that caused a reaction in the Catholic Church in the U.S. which led to the 1934 formation of the Catholic Legion of Decency, an organization dedicated to identifying and combating objectionable content from the point of view of the Church, in motion pictures.

## Last Week's Celebrity

Last week's celebrity was Harold Huber. He played many roles requiring him to assume different accents, such as, in the role of "Ito Nakamura", a Japanese-American in the 1942 film "Little Tokyo U.S.A.". Among his many roles were appearances as a police officer in various "Charlie Chan" films including an American in "Charlie Chan on Broadway" (1937), a French officer in "Charlie Chan at Monte Carlo" (1937) and "Charlie Chan in City of Darkness" (1939), as a Brazilian in "Charlie Chan in Rio" (1941). In Feb 1945, via shortwave radio, author Agatha Christie introduced the initial broadcast of the weekly, half-hour series, "The Adventures of M. Hercule Poirot", starring Huber as "Poirot". He also played "Toctai" in "The Adventures of Marco Polo" (1938) with Gary Cooper and "Babe" in "San Francisco" (1936) with Clark Gable, Spencer Tracy and Jeanette MacDonald.

In Sept. 1958, he co-starred with Eva Gabor in a short-lived off Broadway revival of Frank Wedekind's "Lulu", his last professional credit. On Sept. 29, 1959, at the age of 49, Huber died during surgery at Jewish Memorial Hospital in NYC, which was located at 196th & Broadway and built in commemoration of Jewish veterans of WWI. As part of the down-sizing of hospitals in NYC, it was later closed and eventually torn down and Intermediate School #218 was built in its place. Huber was buried at Mount Hebron Cemetery, off College Pt. Blvd. in Queens, New York.

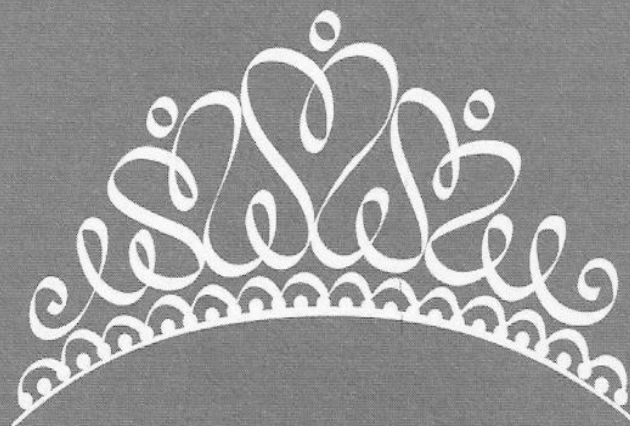

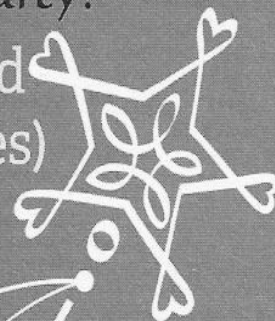

Dear Summer Goal Setter,  
I just finished a first time novel HOME LEAVE by Brittani Sonnenberg that I think you might enjoy. Relatively short (257 pages), this book offers an interesting study of home- what does home mean when you and your family are “expats” Americans living and working abroad. The Kriegsteins—Chris and Elise and their two daughters Sophia and Leah- have lived in Germany, China, Singapore, England, Thailand, Mississippi, Indiana, Georgia and Wisconsin all because of Chris’s business ventures. The story begins rather oddly but inter-

estingly with the family home as the narrator but only for the first chapter. Later we hear from each of the family members as they describe their feelings of alienation, reinvention, and excitement as they move from place to place as a family. In the opening chapter we learn of the tragedy that leaves each of the family in a permanent state of grief exacerbated by their “homelessness.” The colorful descriptions of the schools, homes, food, friends they encounter abroad and at “home” add to the richness of this novel. ## Glen Cove Boys & Girls Club

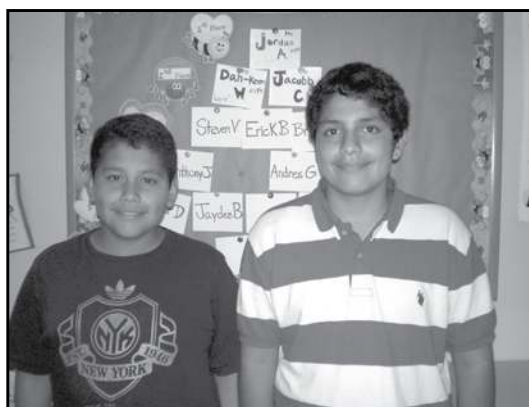

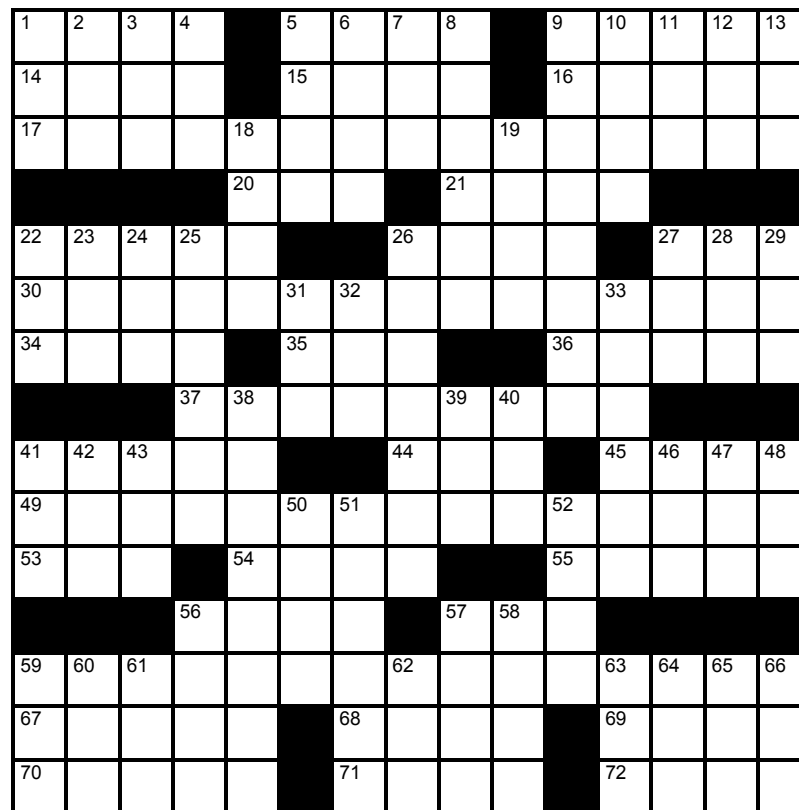
