Glen Cove on the Move and Rising:

Demolition Signals Construction of Paners and and Piazza

The demolition of a former restaurant, considered for many years to be an eyesore in Glen Cove's downtown business district, signaled the first phase in the construction of the Glen Cove Piazza. On June 19, 2014, Mayor Reginald Spinello joined Jobco Realty and Construction President Michael Puntillo for the first "crack" that will bring down the eyesore and launch the building of a free-standing Panera Bread eatery. Panera Bread will have a drive-through component. This October is the anticipated completion date.

Mayor Reginald Spinello said, "Glen Cove is on the move and rising. This is the first phase of a smart growth development project in our downtown that will bring residents and shoppers to our City's traditional business district. The entry of a franchise such as Panera Bread sends a positive signal to the retail community that Glen Cove is moving forward with its plans to make Glen Cove a destination location. The project also includes an enhanced village square for public events such as outdoor con-





# Mayor's Column

From the Desk of Mayor Reginald Spinello

## Congratulations Glen Cove High School Class of 2014!

Operation Neighborhood Pride In conjunction with our Police Department, we have launched "Operation Neighborhood Pride," a listening tour of our City. After mapping out a plan of action with Chief Whitton, Deputy Chief MacDonald, and Lieutenant Ortiz, we outlined a plan and started this project two weeks ago. We intend to visit every neighborhood in Glen Cove because there is no better way to get information about what's going on in an area than to ask the people who live there. We chose the Landing as our starting point because of recent events and we are looking forward to hearing from all our residents regarding quality of life concerns that may exist in their area.

Voluntary Separation Incentive Payment (VSIP): We realized a significant benefit to the operating budget when we implemented the Voluntary Separation Incentive Payment program this past January. Based on this success, and at the request of several City employees, we are reinstituting the incentive package. The VSIP allows the City to reward employees for their years of service while simultaneously creating new opportunities for current employees to move up. The plan creates savings in payroll and benefits costs since by replacing employees with new ones it is at a lesser rate of pay and at a lower cost in benefits and pensions. The first round of VSIP is estimated to have saved Glen Cove taxpayers \$300,000.

Crescent Beach: On June 24, 2014, the City Council voted to approve an amendment to a local law that will assist us in identifying septic systems that may be compromised and to rectify any violations of the City's sanitary code. The amended legislation will help us with the opening of Crescent Beach and

to improve the overall water quality of Long Island Sound. It will also help us to locate any septic system which the City does not have a record of so that it can be properly maintained. The law requires residents have their septic systems pumped out regularly, and to provide proof of the procedure to our Building Department. Homeowners must have their systems inspected every two years, and file the inspection report with the building department. The law takes effect January 1, 2015.

Fourth of July: Our City's Fourth of July events begin with the children's bicycle parade at 10 a.m. from the Finley Middle School horseshoe to Village Square. Children are urged to decorate their "wheels" in a patriotic theme. All children must have adult supervision and all bicyclists must wear a helmet. At Village Square our children will be offered cookies and refreshments by the Glen Cove Youth Bureau. At 7:30 p.m. there will be a concert in Morgan Memorial Park by the Northwinds Symphonic Band for all to enjoy and it will be followed by fireworks under the direction of Grucci, Inc. Let's celebrate our nation's 238th birthday together. Have fun and be safe everyone.

## Name the Celebrity



This week's celebrity was born Anita Sokol on Aug. 8, 1930 in New York City. She began her acting career appearing as a model in the 1949 film "It's a Great Feeling" with Dennis Morgan, Doris Day and Jack Carson. She was afforded a wealth of varied screen roles as "slickchicks" from "Who's Got the Action" (1962), as "Saturday Knight", with Dean Martin, Lana Turner and Walter Matthau, as the love-starved switchboard operator in "A Very Special Favor" (1965) with Rock Hudson, Leslie Caron and Charles Boyer to the brassy "Madame Esther" in "Buck and the Preacher" (1972) with Sidney Poitier, Harry Belafonte, Ruby Dee and Cameron Mitchell.

In 1971, our celebrity was cast in the pilot episode of the CBS sitcom "Funny Face" starring actress-comedienne Sandy Duncan. The original premise of the show had Duncan playing "Sandy Stockton", a young UCLA student from Illinois majoring in education and making ends meet by working part-time as an actress in TV commercials for the Prescott Advertising Agency. Our celebrity played Sandy's agent "Maggie Prescott". Shortly after filming the pilot, CBS picked up the program for the fall of 1971, but slightly revised the format. As a result, our celebrity was dropped from the cast.

Her most recent role was in 1997, when she voiced over the character "Anastasia Hardy", the businesswoman mother of "Felecia Hardy", "The Black Cat", in the animated series "Spider-Man."

#### Last Week's Celebrity

Last week's celebrity was Sally Rand. Cecil B. DeMille gave her the name Sally Rand, inspired by a Rand-McNally atlas. Inspired by the legendary ballerina, Anna Pavlova and after the introduction of sound film, she became a dancer, known for the ostrich feathers fan dance, which she popularized. She started at the Paramount Club at 15 E. Huron, in Chicago. Her most famous appearance was at the 1933 Chicago's World's Fair entitled Century of Progress. She was arrested four times in a single day during the fair due to the perceived indecent exposure after a fan dance performance and while riding a white horse down the streets of Chicago, where nudity was only an illusion. She was arrested again after being body-painted by Max Factor, Sr., with his new make-up formulated for Hollywood films. She also conceived and developed the bubble dance, in part to cope with the wind while performing outdoors. In 1934, she performed in the film "Bolero", with Carole Lombard and George Raft. The risqué part of this movie was that both Lombard's and Rand's roles were as exotic dancers. However, while Rand did her performance "in the raw", Lombard insisted on a standin double. In later years, including the 1970s, Rand continued on the road with stage shows, performing her fan dance. She died Aug. 31, 1979, at the age of 75, from congestive heart failure. She was deeply in debt, according to her adopted son. He told an interviewer that Sammy Davis Jr. stepped in and wrote a \$10,000 check to cover her expenses.






