Sea Cliff Celebrates 4th of July in Grand Style

In addition to Sea Cliff's annual 4th of July celebration at Village Green with the annual reading of the Declaration of Independence, they also celebrated the opening of a new sitting area at Sea Cliff and Roslyn Avenues dedicated to the memory of Abraham Lincoln with new signs on Lincoln quotes, new benches and a planting area.

In front of Village Hall the Mayor Bruce Kennedy began the gathering by the ringing of the Village Bell followed by a Presentation of Colors and the Pledge of Allegiance led by Ruben Shonik, Sara Garry and Boy Scout Troop #43. Lesley Pryde Haley sang the National Anthem while Ann DiPietro, President of the Sea Cliff Civic Association welcomed everyone present.

Next the Declaration of Independence was read by a cast of Sea Cliff Villagers and John Canning with everybody joining in to read the last paragraph. After the reading all were invited to join the procession to the dedication ceremony of the new Lincoln Plaza.

The 4th of July Committee from the Sea Cliff Civic Association included Christine Abbenda, Diane Biolsi, Karen Kessler, Jen O'Hare, Carol Pohrille and Carol Vogt.

After arriving at Lincoln Plaza, Village Trustee Ed Lieberman spoke welcoming everyone to the dedication of Lincoln Plaza, "a place of community spirit, social gathering and civic pride."

"Abraham Lincoln was proud of our nation's birth of freedom and its ideal of equality for all. Our village fathers-and-mothers- held these principles as well-today we join together at this spot to uphold them for ourselves and our village's future generations... and to honor words of community spirit and civic pride."

"A century later, the Hendrickson family, owners of this site, beautified this particular spot with the planting of three red maple trees-only one of which still stands--the placement of a community sitting area for residents to gather. Also, on the wall a plaque. It invokes civic pride and community spirit containing a partial quotation of Abraham Lincoln invoking civic pride and community

spirit, which has been presented by the Sea Cliff Beautification Committee. The quote reads as follows: "I like to see a man proud of the community in which he lives." This site was affectionately known as "Mini Plaza."

Over time this spot took on a vacant look. But the spirit of the community pride was reborn when Susan Campagna took upon herself to beautify this venue by planting flowers, first in a tree stump and then in a wooden planter built by another resident Brian Griffin. "The seed of beautification had been planted, once again."

What started with a personal desire to refurbish the aged Lincoln quotation-plaque, developed into the vision that is today's Lincoln Plaza.

Lieberman personally thanked Mayor Bruce Kennedy and the property's owner Ann Karonick Henrickson, John Hendrickson's daughter on behalf of our



Village.

After thanking many others who were responsible for the recreation of this plaza, Lieberman turned the microphone over to Mayor Bruce Kennedy, who reiterated on the community spirit

in Sea Cliff, later introducing Donald Mullen a Lincoln look alike who grew up in Sea Cliff. He read some Lincoln history to the audience then thoroughly enjoyed posing with the residents for photos while he was present.

GCAC and GCBGC Visit NCMA

The Glen Cove Arts Council treated youth from the Glen Cove Boys and Girls Club to a visit to the Nassau County Museum of Art for the Garden Party exhibit, which features works with a floral theme by many artists.

and lamps.

Children from local Boys and Girls Clubs, Youth Bureau and Schools have been given scholarships in classes in the arts at LI-AFA, as well as visits to museums and to Tilles Center for the ballet, opera and theater, and museums.

Grand Opening of Living Water for Women, A Haven of Hope for Formerly Incarcerated and Substance Addicted Women

One of Glen Cove's newest non-profits, Living Water for Women, Inc., a community-based organization whose mission is to bring freedom from addiction and renewed life to women who were formerly incarcerated, opened its doors on June 7, 2014. Located on the site of two former boarding houses, founder Lisa Cohn, with the assistance of local businesses and contractors renovated and revitalized the once blighted buildings into a haven of hope. Typically women released from jail return to the same environment that often fosters their addiction and incarceration, perpetuating the syndrome. Now they have a safe structured home environment that serves as a place of transformation, restoring the life that addiction attempted to destroy. Every woman that Living Water for Women serves is valued, respected and supported. The structured program provides clients with clothing, individual counseling by a licensed psychotherapist, workshops on coping, job and life skills, including nutrition classes in a full on gourmet kitchen with a plethora of healthy options in the well-stocked pantry and freezer.

The well attended Grand Opening included local dignitaries: Assemblymen Charles D. Lavine, Glen Cove Mayor Reggie Spinello, Glen Cove Deputy Mayor Barbara Peebles, Sea Cliff Mayor

Bruce Kennedy, Glen Cove City Councilmen Anthony Gallo, Jr. and Anthony Jimenez, Nassau County Legislator Delia DeRiggi-Whitton, and Judy Piazza, Community Sales Director at Atria Senior Living in Glen Cove. The support of the Glen Cove and Sea Cliff business community was phenomenal. Individual supporters from all over Long Island and as far as Toms River, NJ attended this worthy event. It has been said that "it takes a village to raise a child," but it takes no less to restore the life of an adult that has experienced the shame of incarceration and ravages of addiction.

Living Water for Women is only one part of that village. Restoring these lives requires partnership, teamwork, and collaboration that only our entire community can provide.

At Family Awareness, people not only have fun, but they are exposed to literature that lets them know all that's available in the Glen Cove community to assist them."

Even the professional mountain bike rider, Chris Clark, delivered a message on the importance of healthy living. After doing several stunts he stopped to tell children that having a hobby can be a way to ensure that you continue to make the right choices.

"I got good at riding my bike and everyone knew I loved it, he said. "When I got older and my friends were doing things I didn't want to participate in I

told them I couldn't come along because I was riding my bike. Find something you love, make smart decisions and use what you love as an excuse not to do the things you shouldn't do."

Members of the Glen Cove Fire Department and EMS helped children to learn about firefighting. Several children went into the EMS truck to see firsthand how victims are assisted in when there is

an emergency.

SAFE's Family Awareness Day was true to it's name – people left more aware of how to live a healthy lifestyle, children learned the importance of making the right decisions and everyone left remembering that SAFE remains committed to helping the Glen Cove community.

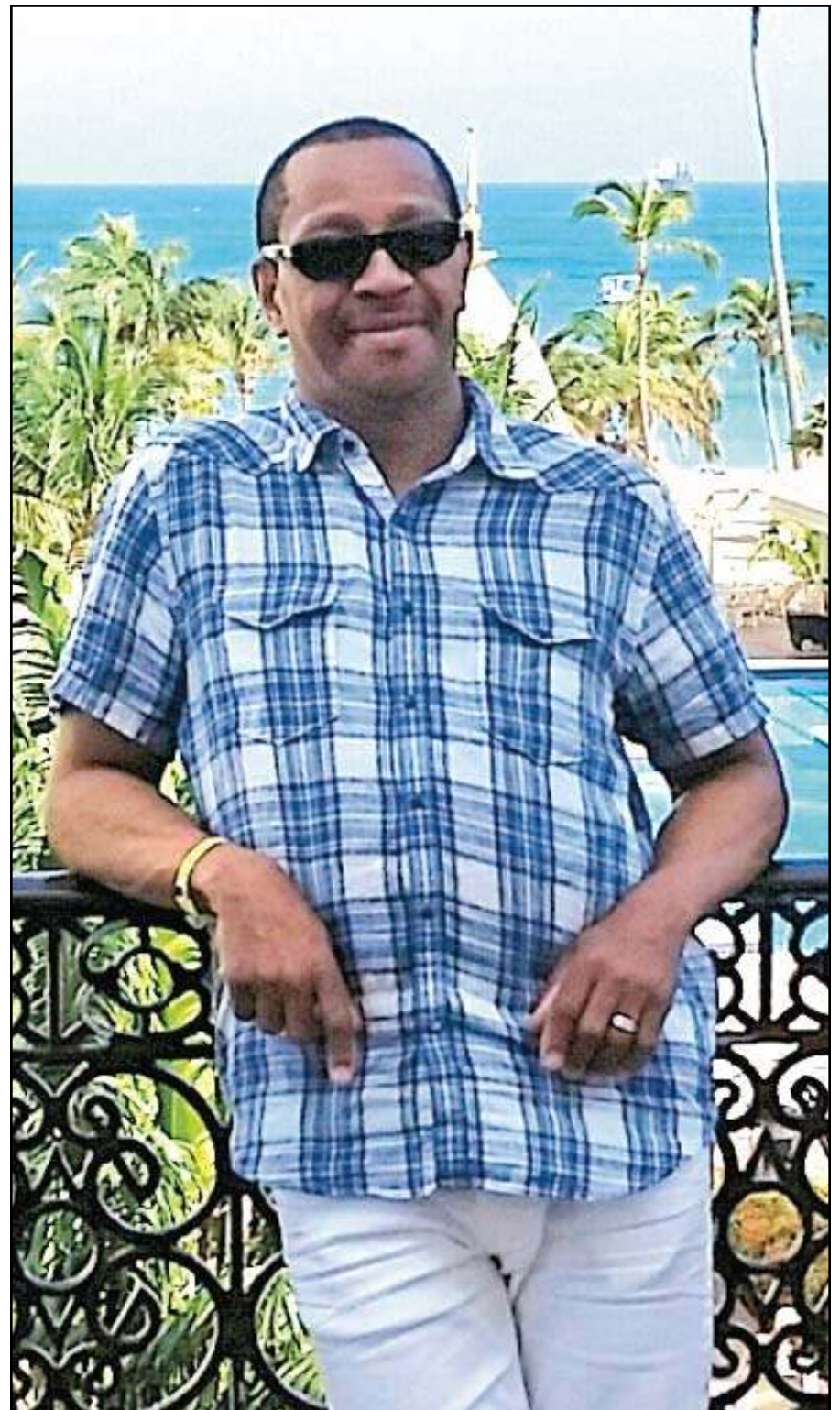

Last week's celebrity was Nita Talbot. The first decade of her career was spent playing "slick-chicks" and sharp-witted career girls. Besides her films mentioned last week, she had roles in many TV shows such as "Perry Mason", "The Jim Backus Show", "Bourbon Street Beat", "The F.B.I.", "The Secret Storm", "Supertrain", "Search for Tomorrow", and "General Hospital". Our celebrity was born in Richmond, Surrey, England on Nov. 20, 1891. After continuing his stage career in America his film career started in 1915 with the old World Film Company and he made films both in the U.S. and Britain until the 1960s. He came from a theatrical family which went to the U.S. in 1912 to appear in the stage production of "Quaker Girl." Our celebrity appeared in John Barrymore's 1920 production of "Richard III" and the two became life-long friends. He became well-known in silent films and with the advent of "talkies" he became a character actor.
