# Spinello Swears in Glen Cove Harbor Patrol

The council met at the Glen Cove City Hall on Tuesday, July 22. Before proceeding to the agenda, Mayor Reginald Spinello swore in the Harbor Patrol, a law enforcement body that regulates activities on and around Hempstead Harbor, including boating and weather-related obstacles. Lieutenant Chris Ortiz of the Glen Cove Police said that the Harbor Patrol has been reorganized to become more efficient and more "professional".

Spinello proposed a resolution regarding bicycle use in downtown Glen Cove during the public hearing. At the present time, the penalty for riding a bicycle on the sidewalks downtown is \$15. In the past year, police have issued 19 tickets to violators. Spinello proposed that the fine be increased up to \$75.

"Riders are disregarding traffic in the downtown area," Spinello said. One resident protested that the streets are too narrow to ride alongside cars and thus many people are forced to resort to the sidewalks. "Downtown Glen Cove is not a bicycle friendly town," he said. Another resident suggested that bicycle lanes be added to the streets.

# Bruce Kennedy Switches Parties and Runs for NYS Senate

On July 17 Sea Cliff Mayor Bruce Kennedy made his official announcement at the Bistro Restaurant at the newly rededicated Lincoln Plaza in Sea Cliff to run as a Democrat for the New York State Senate. He said he promises to bring the same hard work to put a lid on taxes, to rebuild our downtowns and to empower our residents. Since being elected as Sea Cliff mayor in 2009, "I have worked to tirelessly on behalf of our residents to fulfill my promises and the results have been spectacular," Kennedy said.

"I am ready to bring the same dedication and energy to Albany. I have the drive and the willingness to positively effect change in our surrounding communities so I am officially announcing

my candidacy for the New York State Senate! Most of you know me. I am a family man, I am a businessman and I am a leader. I believe in focusing on solutions and I am driven by service to my fellow man.

Long Island families are struggling and they need someone that is willing to fight for them not against them. The answer to our issues is a shift in thinking. It is empowering our people and businesses to flourish. We need a fighter-an advocate-who will stand up for our working families, our senior citizens and our children...I am up to the fight."

Kennedy said originally he was going to be the Republican nominee for an Assembly seat to try to make Long Island a better place to live, to present real solutions for property tax relief, to help

build a strong and healthy economy, to help make our schools more functional and affordable, and reduce the costs of government.

"After going through the vetting and nomination process and being confirmed

as the party candidate at the convention in May; I was asked by the Republican Committee to attend a "routine" interview by the Nassau County Conservative Committee. At this interview I was

asked how many same sex marriages I had performed and I was shocked by the Committee's hostile reaction when I said two. I made it clear that the Marriage Equality Act passed in 2011 and I took the oath of office to uphold the laws of New York State. As a result of abiding to the law, the Conservative Party refused to endorse my candidacy. The Conservative Party then instructed me to go back to the Conservative Committee and say that I had made a mistake in performing those marriages, that I should promise to never do them again, state that I oppose same sex , marriage and vow to vote against it if given the chance.

Kennedy said, this is not something that I could ever do. I would never go back on my word or disavow my actions and beliefs that are grounded in basic principles of human rights and the responsibility of lawmakers to uphold the law."

As Mayor of the Village of Sea Cliff I have performed countless legal marriage ceremonies and have do so without prejudice as to ethnicity, color, creed, or who a person loves; and I have a long record of fairly representing ALL the people of my Village. It is hard to believe that in this day and age we are arguing what was settled in the 1868 when we adopted the 14th Amendment to the US Constitution--that all people deserve equal protection of the laws. Despite being bitterly contested, our forefathers led by Abraham Lincoln recognized the immortal declaration that all people are created equal. The American Dream is based upon the assumption of equality--the supposition of equal standing under the laws.

It is to be expected that people in the same political party can agree on certain issues and economic values, but also disagree on social issues. And while I can respect someone not agreeing with the merits of something, I cannot accept an "order" to violate my personal principles in order to advance my personnel principles in order to advance my political career.

Although Spinello agreed that something must be done to accommodate bike riders, Lieutenant Ortiz stated the reason for the sense of urgency that this issue has merited. "If you look in the papers every day, there is a bicycle struck," he said.

Spinello also spoke about the success of his newly initiated "Quality of Life" walks. Along with members of the police force, Spinello walks Glen Cove neighborhoods to monitor the condition of people's properties. After reminding 12 residents about certain code enforcement, nine have complied.

youth free of charge. Spinello noted that Frank Pena, President of GCBC, has been using his own personal vehicle to transport members to tournaments. "We try to make champions of those kids and try to take them away from drugs and alcohol," Pena said.

The City of Glen Cove Zoning Ordinance now prohibits hookah lounges. A member of the Tobacco Action Coalition of Long Island, an organization whose mission is to eliminate the view of smoking as a social norm, commended the council on this resolution. Glen Cove is the first municipality in Nassau County and the second on all of Long Island to ban hookah lounges and bars.

Glen Cove City Council will convene next on Aug. 19 for a pre-council meeting and on Aug. 26 for a council meeting.

The Glen Cove Youth Bureau, in cooperation with the Friends of the Glen Cove Youth Board is teaming up with local citizens, organizations and businesses to provide back to school supplies to disadvantaged youth in our community. ## The Glen Cove Library Welcomes New Trustee


The Glen Cove Public Library welcomes Antonia Petrash to the Library Board of Trustees. Mrs. Petrash was elected as a Trustee in April for a five-

## Strawberry Fields, Beatles Tribute Band, Performing Friday, July 25th

Strawberry Fields, a Beatles tribute band, will take the stage on Friday, July 25th, as part of the Friday night Downtown Sounds concert series, in Glen Cove on Long Island's historic North Shore Gold Coast. The series will run every Friday through August 29th.

Strawberry Fields is a look-alike, sound-alike Beatles tribute, dedicated to bringing the audience, as close to a real Beatles concert as you can get. The band features look-alike performers, (hand-picked from hundreds who auditioned), who speak in Liverpudlian accents and play on the vintage musical instruments that Beatles fans have come to recognize.

The band will take you on a Magical Mystery Tour beginning with 1964 - complete with mop top hair, black suits and thin ties - and through the Beatles first four albums. Next stop is 1967, featuring the psychedelic era of "Sergeant Pepper's Lonely Hearts Club Band" - with all of the costumes and jackets featured on the album cover. Last musical visit is to a place where hair got longer and music more politically involved, featuring songs from the "White Album," "Abbey Road," and "Let It Be."

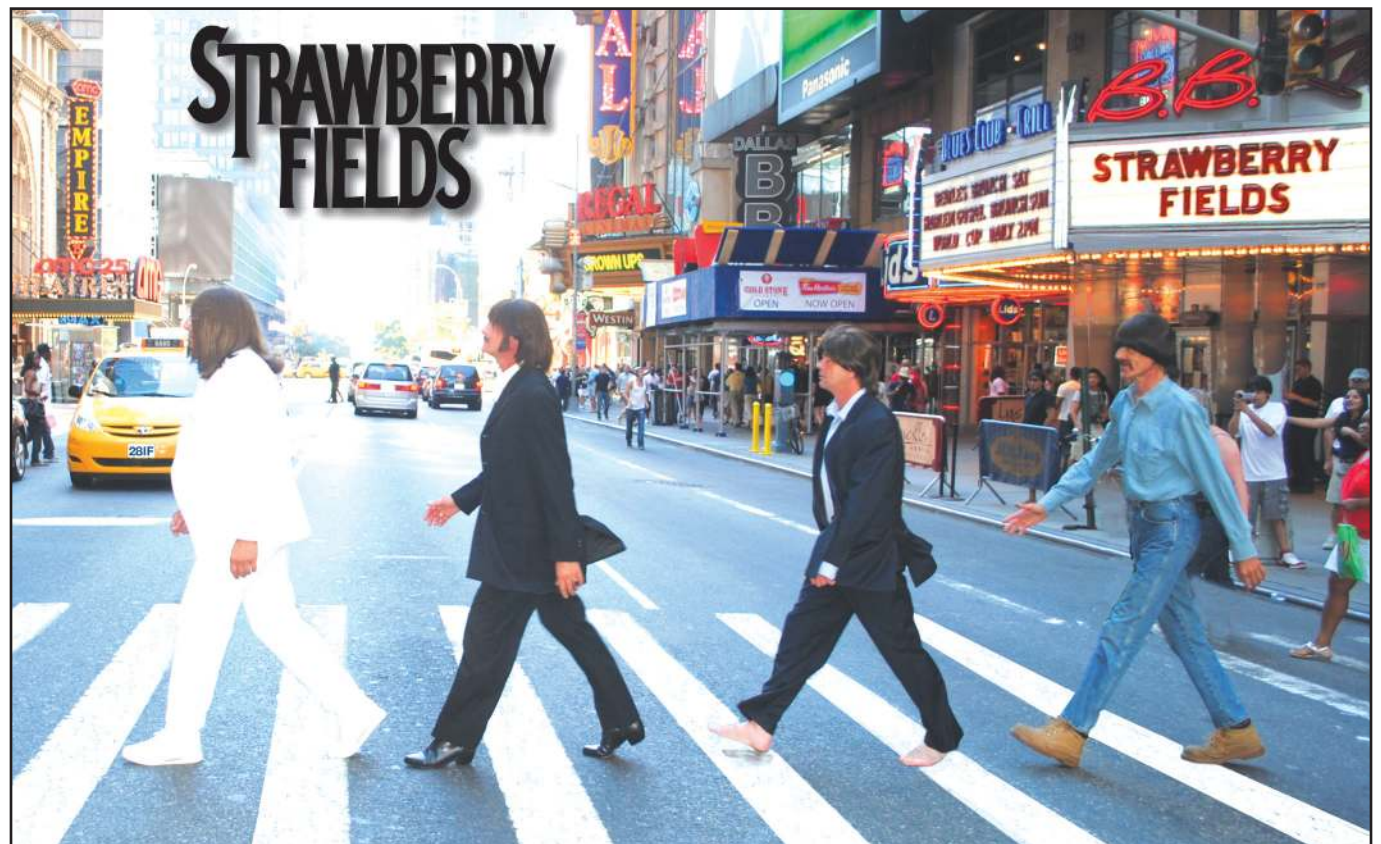
The free concerts are open air, at the Glen Cove Village Square, intersection of Glen and Bridge Streets. Shows begin at 7:30 and run until 9:30. There is ample free parking in the adjacent indoor and outdoor parking lots.

## Ask The Elder Law and Estate Planning Attorney

### Beware of Joint Accounts

**The Question:** I'm a 76-year-old widower who holds all my bank accounts jointly with my daughter, so she can pay my bills if need be. I also hope to avoid probate this way. Is this a good idea?

**The Strategy:** The practice of holding joint accounts can have unanticipated negative consequences and it is generally a poor option for estate planning. Explore other, safer alternatives to achieve the same results.



**How It Works:** When an adult child's name is added to a parent's account as a joint owner, the funds are exposed to any creditor claims that may exist against the child. The child also obtains full access to the funds so the funds could be withdrawn from the account and used for unintended purposes. For

Medicaid purposes, joint ownership does not provide any protection as a joint bank account is considered to belong 100% to the Medicaid applicant. For estate tax purposes, bank accounts held jointly by a parent and child are considered to be completely part of the taxable estate of the first to die, unless documentation can be provided showing that the survivor deposited funds into the account. That means the money could be included in the taxable estate of a child who dies before a parent. While joint accounts generally pass outside of probate, these accounts frequently cause family disputes. There may be an unequal passing of assets to the child whose name was on the joint account. The other children may argue that the parent wished to treat all the children equally. The child who jointly held the account often argues that the parent intended that he or she receive extra consideration because of the assistance that child provided.

**The Results:** Other techniques are usually preferable to the use of joint bank accounts for elder law and estate planning purposes. A properly drafted revocable trust or durable power of attorney can give your daughter legal authority to pay your bills while also protecting your assets from any creditor claims that may exist against her, for instance. You'll still need to protect your assets from the costs of a nursing home, however. Have an expert coordinate the planning you need to address all the concerns that apply to you.

# Name the Celebrity



This week's celebrity was born on Jan. 26, 1923 in Goldsboro, No. Carolina. She had entered the entertainment field at a young age since she had been trained in voice. Despite being an accomplished soprano, she decided, as a teenager, to sign with the John Robert Powers Agency as a junior model. Her plans for an operatic career were sidelined when she was cast in a staged music review "Fun for the Money". Her appearance in that revue led to her being cast in her first movie role, "I Married an Angel" (1942), starring Nelson Eddy and Jeanette MacDonald. She was under contract to both RKO and Republic Studios during the 1940s, including several appearances as "Tess Trueheart", in the "Dick Tracy" series and the 1944 Frank Sinatra musical, "Step Lively". She also appeared in the horror comedy "Zombies on Broadway" with Wally Brown and Alan Carney in 1945, starred in "Riffraff" with Pat O'Brien and was "Cheyenne", the girl in love with Randolph Scott in "Return of the Bad Men" (1948).

When her career faltered, she instead focused on a stage career playing lead roles on Broadway in productions such as the 1947 opera "Street Scene", in the 1948 Cole Porter musical "Kiss Me, Kate" (having replaced Patricia Morison) and the 1952 musical "Three Wishes for Jamie". With long term husband Robert Sterling, who was first married to Ann Sothern, she appeared in the CBS sitcom "Topper" (1953-55), also with Leo. G. Carroll and Lee Patrick. Our celebrity was billed as the "ghostiest with the mostest".

### Last Week's celebrity

Last week's celebrity was Bonita Gran-

ville. After several years as a child actress, she was once again cast as a young adult in supporting roles often in prestigious films such as "Now, Voyager" (1942) with Bette Davis, as well as two "Andy Hardy" films with Mickey Rooney, "Andy Hardy's Blonde Trouble" (1944) and "Love Laughs at Andy Hardy" (1946). She is also remembered for her starring role in the WWII anti-Nazi film "Hitler's Children" (1943). Her career began to fade by the mid-1940s. In 1947, she married Jack Wrather, who had produced some of her films. He formed the Wrather Corporation, and bought the rights to characters from "The Lone Ranger", "Lassie" and "Sgt. Preston of the Yukon". Perhaps this is the reason why Lassie and Clayton Moore, who played "The Lone Ranger", appeared several together in the mid-1950s at the old Madison Square Garden, much to the delight of all of us youngsters. Granville worked as a producer for several film and TV productions featuring these characters, including the 1954 TV series "Lassie" with Tommy Rettig. She appeared in the film version of "The Lone Ranger" in 1956, and made her final screen appearance in a cameo role in "The Legend of the Lone Ranger" (1981). It was in this film that the "Lone Ranger's" entire name, "John Reid", was ever revealed. The Granville-Wrather marriage lasted until his death in 1984, shortly after the release of the movie "The Magic of Lassie", which starred Wrather's pal, James Stewart. Granville herself died four years later of lung cancer at the age of 65.

An extra note, Wrather was approached by Walt Disney, back in the 1950s, to build the Disneyland Hotel near Disneyland when Walt ran out of money building his theme park in California. Wrather built it and years later refused Disney's request to purchase it. The Disney franchise finally succeeded in purchasing it when it acquired the Wrather Corporation in 1989, years after both men were dead. The 2013 film version of "The LR", starring Johnny Depp, was produced Walt Disney Prod. and Jerry Bruckheimer.

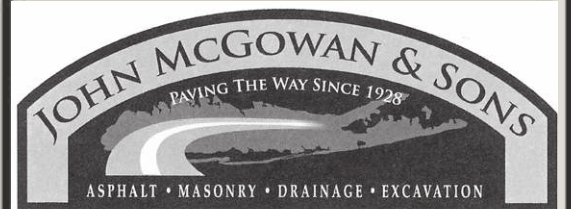
