Community Mourns Mayer Udell of London Jewelry

The Gold Coast community mourns the loss of Mayer Udell, who passed at the age of 96, on Tuesday, July 29th. Mr. Udell was well known in the community as an inspiring business man as well as a loyal family man. He came to the United States from Poland in 1939 and worked in his family's sweater factory business. He mastered that business and opened two of his own factories in Bay Shore and the Bronx which were great successes.

In 1946, he met Fran London and the two were married that year. Mr. Udell then sold the sweater factories and with Fran, took over the London Family jewelry business in Glen Cove.

Together they had two sons, Dr. Ira Udell in 1947 and Mark Udell in 1951.

Inspired by Charles London, Mayer and Fran expanded the business from a small clock and watch repair shop to a watch business that included fine jewelry.

Prominence and reputation allowed them to carry world-renowned brands in their store - eventually expanding the business to multiple stores.

Tremendous family values and traditions were instilled at an early age not only at home, but in the family business. Mayer's vision for his family was to not only excel in life and business, but also to enjoy it to its fullest. "Doing the right thing" and giving back to the community was at the forefront of his values.

Mr. Udell's sons followed in their father's footsteps with care to the community, as well as his values. Mark is now London's chief executive. Ira is chairman of the department of ophthalmology at North Shore University Hospital and Long Island Jewish Medical Center in Manhasset, and chairman of ophthalmology at the Hofstra-North Shore LIJ School of Medicine in Uniondale.

Both sons said their father never formally retired from London Jewelers, breakfasting every morning with Mark, counseling him on business decisions and doing some of the fine engraving and watch repairs.

"He was soft-spoken and mild-



mannered," Ira said, "but he was very clear and direct about how he felt about things. If he thought you were taking the wrong approach to something, in a nice way he would make sure you knew."

Serving his community and family was most important to Mr. Udell. He was a member of the Congregation Tifereth Israel, Glen Cove, where he held multiple positions: Ritual Chairman, House Chairman, President of Men's Club, President of Temple, Member of the Board of Trustees.

His philanthropic endeavors included: Israel Bonds, UJA and Temple Tifereth.

Mr Udell is survived by his beloved wife of 68 years, Fran Udell. Loving father to Ira Udell and daughter-in-law Allyn Udell and Mark Udell & daughter-in-law Candy Udell. Proud grandfather of Erin & Leigh Minsky, Randi & Scott Alper, Jared & Riki Udell, Scott & Jessica Udell and Zachary Udell.

Clammers Dispute ends in Arrest

On Saturday July 26th Chief John Testa and Lieutenant Graziose of the Glen Cove Harbor Patrol arrested John Mirabito while he was clamming in his boat in West Hempstead Harbor. According to Lieutenant Nagle, John Mirabito, age 60, of Shirley NY violated a Nassau County 1st District Order of Protection that two other clammers had against him. The two clammers (victims) were the same two people that the defendant John Mirabito allegedly pointed a rifle at after arguing with them last year in the Harbor.

The defendant apparently violated the stay away order on Saturday July 19th after he used his boat to approach

the victims boat while they were in East Hempstead Harbor off of Dosoris Pond. After the alleged violation of the Order, Detective Van Allen was assigned the case.

The Detective notified the Nassau County Marine Bureau and alerted the Glen Cove Harbor Patrol and furnished them with information regarding the defendant. On July 26th the Nassau Marine Bureau notified Detective Van Allen that they believed that the defendant had launched his boat from Tappens Beach Marina. Glen Cove Harbor Patrol Chief Testa and Lieutenant Graziose located the defendant in West Hempstead Harbor and arrested him without incident.

Senior Moments



This column features a life-altering event that has had a great impact on a senior citizen's life, molding that person into who he or she is today. The people interviewed are all members of the Glen Cove Senior Center.

It is noon on a Monday and the seniors have gathered in the dining room of the Glen Cove Senior Center as they do weekdays to enjoy a tasty and nutritious lunch. As is the practice, all rise to recite the Pledge of Allegiance and to sing, on this afternoon, "America the Beautiful." As they sing, one male voice stands out above all others. It is strong, melodious and as crystal clear as finely tuned carillons. This harmonious voice belongs to Charlie.

Charlie's parents were born in northern Italy near the French border. As with most immigrants, they settled near others from their home village or region. Charlie's parents had settled in the Bronx. It was there they met, fell in love and married. His father, although uneducated, was a skilled cement mason and one of the first members of the newly organized cement masons' union. Eventually his father saved enough money to purchase a 6-family apartment building in Astoria, Queens. His father was no longer a blue-collar laborer but was living the American dream as a property owner and landlord.

Charlie had one older sister and two younger sisters. None of the sisters had aspirations of achieving a college education. As daughters of a middle class working family, the girls were groomed for marriage and families of their own. Charlie, on the other hand, was a top student in elementary school. He dreamed of achieving a high school education as a prerequisite to a college degree. His zoned school was Bryant High School. As a matter of prestige, Charlie took and passed the entrance exam for Stuyvesant High School in Manhattan. Stuyvesant was one of four specialized high schools in New York City created by Mayor Fiorello H. LaGuardia in the 1930s. Stuyvesant, Bronx High School of Science and Brooklyn Tech stressed mathematics and science and the High School of Music & Art concentrated on fine arts and instrumental and vocal music. Charlie made the decision to attend Stuyvesant High School.

Attending Stuyvesant would change his life and destiny completely. The population of students and teachers at Stuyvesant shocked Charlie, to say the least. His neighborhood in Astoria was

primarily Italian with a smattering of other ethnic groups. Charlie knew two Jewish lads in Astoria. They were common thugs and Bugsy Siegel wannabes, who were proficient street fighters with a propensity for gambling. Growing up Charlie thought these lads were representative of young Jewish males. At Stuyvesant his perceptions would be turned upside down. In Stuyvesant the vast majority of students and teachers were Jewish. The Jewish students were not thugs or gamblers, they were scholars who were serious about achieving a quality education and they were in the majority. Charlie, who was one of the very brightest students in Astoria, found that he was merely an average student at Stuyvesant because the school attracted the very smartest students from all five boroughs.

Charlie's favorite subject was Biology. However, his teacher caught him cheating on an exam. Instead of chastising and berating Charlie, his teacher showed concern, a sense of disappointment and interest in Charlie's future. He told Charlie not to worry; the test would be discarded and would not be averaged into his final grade, much to Charlie's relief. Through his high school experiences, Charlie garnered a deep respect for Jews, an appreciation of scholarship and a unquenchable thirst for knowledge.

After graduating from high school, Charlie would be the first member of his family to attend college. He attended C.C.N.Y. for two semesters before transferring to Cortland State Teachers' College in upstate New York. He found the course of study at Cortland fairly easy and breezed through. Charlie would graduate with a major in English and receive his certification as a Teacher of English.

After graduation, he lived in Manhattan and worked at Stern's Brothers Department Store. It was there that he met his first wife. Soon after he obtained a position as an English teacher at Oceanside High School. He remained at Oceanside for 30 years until his retirement at age 55 in 1985. He moved to the idyllic Village of Sea Cliff in 1970 and married his second wife, Carolyn, in 1972. Prior to retiring he purchased Thompson's Bookstore on Sea Cliff Avenue. He was thoroughly happy and in his element surrounded by the books that he cherished, discussing literature with his regular clientele and suggesting reading material to others. He was still the consummate educator, motivating visitors to his establishment to embrace the written word and escape the here and now via passages painted by the words of noteworthy authors. It was a sad day for Charlie in 2006 when the building housing his book emporium was sold and Charlie's second vocation came to an end.

Once more he would have to reinvent himself. Today one can find Charlie at the YMCA practicing pilates or jogging near the grounds or signing in the Golden Voices Chorus at the Glen Cove Senior Center. He is still passionate about literature. Does he own a Nook or Kindle? No; he finds that physically turning pages in a bound book makes the reading experience more pleasurable and Charlie always has a book within easy reach.

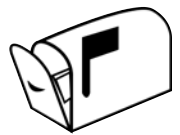

Name the Celebrity



Born in Homestead, Pennsylvania, on May 23, 1898, our celebrity came from a theatrical family. His parents ran a stock theatre company and as a young child he performed on stage. His brother Matt and sister, Kitty, performed an act with him by the time he was ten years old. However, the family quit the stage about 1930. Another brother, Ed, became a stage manager and agent in New York. He debuted on Broadway in the "Fall Guy" in 1925. Warner Bros.

hired him as a contract player in 1930. He played everything from lead actor to sidekick and would often provide comedy relief. He appeared in more than 150 films and TV productions and worked with almost every star at Warner Bros.. He was a very close friend of James Cagney and appeared in more Cagney movies than any other actor. He appeared with Cagney in eleven films between 1932 and 1953. Some of those films include, "The Crowd Roars" (1932), "Here Comes the Navy" (1934), "Devil Dogs in the Air" (1935), "A Midsummer's Night Dream" (1935), "The Roaring Twenties" (1937), and "The Fighting 69th" (1940). They remained close friends until their deaths.

Last Week's Celebrity

Born Annie Carmichael, last week's celebrity was Anne Jeffreys. Not only did she share the limelight with her husband, Robert Sterling, on the 1950s sitcom "Topper", they also appeared in 1957, on one of the first episodes of the long-running TV western, "Wagon Train" with Ward Bond and Robert Horton. They also appeared together in the 1960s on the TV sitcom, "Love, American Style". After a semi-retirement in the 1960s, she appeared on "L.A. Law", "Murder, She Wrote" and was nominated for a Golden Globe for her work in "The Delphi Bureau" (1972). From 1984 to 1985, she starred in the short-lived Aaron Spelling series "Finder of Lost Lives". She also appeared on "Baywatch" as David Hasselhoff's mother, and also had a recurring role in the 1980s night time soap-op "Falcon Crest", as "Amanda Croft" with Jane Wyman. In 1979, she guest starred as "Siress Blassie" in the "Battlestar Galactica" episode, "The Man With Nine Lives" as the love interest of "Chameleon", a part played by Fred Astaire. She was the last person to dance with Mr. Astaire on screen.

Her most recent career has been in daytime TV. Since 1984, she appeared in the soap-op "General Hospital" and that show's spin-off "Port Charles", as wealthy socialite "Amanda Barrington". That character last appeared on screen in 2004. Mrs. Sterling and her husband had three children and he passed away, at the age of 88, on May 30, 2006. Anne celebrated her 91st birthday on Jan. 26th.

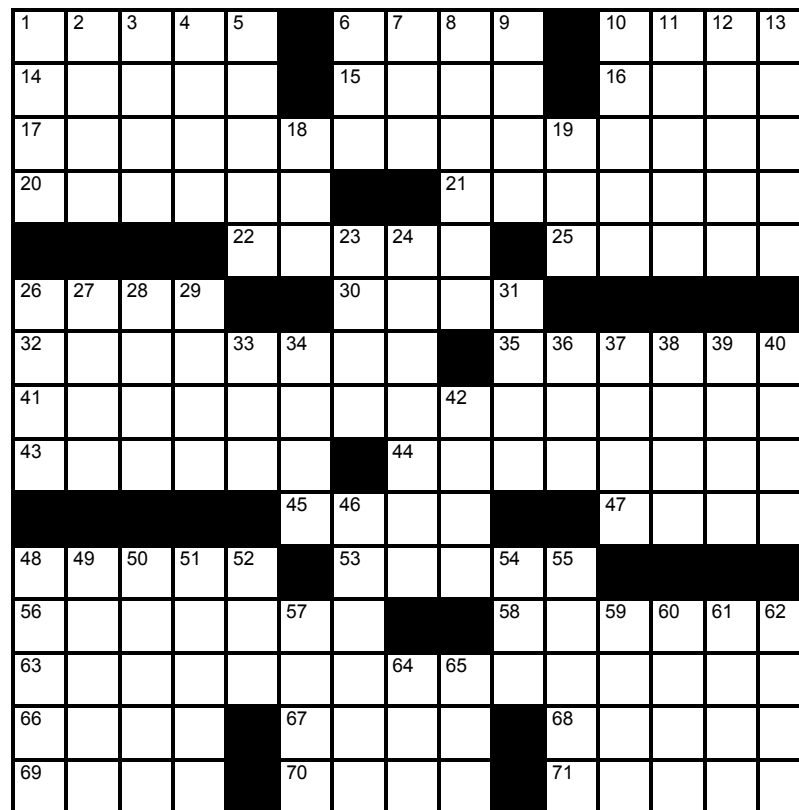
