Mayor Spinello Continues Initiative to Combat Illegal Housing Second Major Bust in Two Months

In continuing his initiative to combat illegal housing and overcrowding, Mayor Reginald A. Spinello announced that on the morning of August 5, the City Attorney's office obtained a search war-

rant which was executed by the City's code enforcement and Glen Cove Police at a house on Chestnut Street. The house, whose owner has a history of housing code violations with similar charges

pending since January, was found to be overcrowded with illegal occupancy.

Mayor Spinello said, "Our code enforcement team and the city attorney's office followed up on complaints from neighbors and launched an investigation. During today's search of the house, it was discovered that 13 people were living in a four-bedroom home; four of the people—including children—were sleeping in an uninhabitable attic. In addition, there was someone sleeping in a covered porch."

This administration has a steadfast commitment to address quality of life issues. Illegal housing and overcrowding is first on the list since it puts lives at risk while disparaging a neighborhood. "I urge residents to contact my office or code enforcement if illegal housing or overcrowding is suspected. This administration's message to any others participating in the illegal housing business is this: illegal housing and overcrowding will not be tolerated," said Mayor Spinello.

The Next Generation Prevails

On Tuesday evening, July 22nd, Mayor Spinello and the City Council successfully enacted protective legislation banning and prohibiting hookah parlors in all zoning districts in the city. This legislation comes on the heels of the city's recently passed legislation on May 13th establishing additional restrictions regarding tobacco in an effort to reduce youth initiation. SAFE and its community based SAFE PRIDE Project Coalition has been working with Carol Meschkow of the Tobacco Action Coalition on a state-wide initiative "Seen Enough" campaign to combat youth cigarette and tobacco product use by teaching students about the power of cigarette and tobacco marketing in local stores, and in advertising in general. The Coalition's School Committee Chaired by Denise Kiernan, Director of Athletics and Physical Education, works with student groups, SALT and Teens and Teachers to facilitate the campaign throughout the schools.

Members of the SAFE PRIDE Project Coalition are composed of SAFE Board of Directors and staff, city officials, school district representation, the Glen Cove Police Department, local not for profits, clergy, the business district and community volunteers are swiftly achieving their goal of changing societal norms about alcohol, tobacco and substance use in Glen Cove. The Coalition is committed to reducing youth's exposure to addictive substances and will continue to work with Carol Meschkow going

forward.

When addressing the Mayor and City Council Georgie Connett, SAFE Board Chair, said, "While every adult has a legal right to smoke, the City of Glen Cove has chosen not to condone it. Thank you to the Mayor and City Council for their wisdom to provide a healthy environment for our youth and all the people of Glen Cove."

"Protecting our youth from becoming the next generation of smokers is an important challenge, and I am so grateful for the partnership with SAFE's PRIDE Project Coalition, the School District and the efforts of the city," said Meschkow. "It is apparent Mayor Spinello and the City Council have been on a crusade with their recent sweeping legislation to reduce youth initiation and have emerged as tobacco champions by establishing a benchmark for the first municipality in Nassau County to ban hookah lounges. Per former Surgeon General Benjamin, youth exposure to the Big Tobacco's marketing efforts had risen to level that it has become a pediatric epidemic."

Re: Villa Project at Glen Cove - Adverse Impact to Glen Cove and Sea Cliff

To The Editor,

Just hours before the Glen Cove Planning Board Meeting on Tuesday, July 29, 2014, the board removed from its agenda the Adoption of the Findings for the Villa Project. This has been moved to the September 2014 Planning Board meeting.

We, the homeowners surrounding the proposed Villa Project hereby object to any further action on the Villa Project at this time. The legal processes giving rise to the RIO-GCA Overlay Zone and the Villa Project were erroneous and in contravention of the State Environmental Quality Review Act (SEQRA) and, accordingly, the RIO-GCA Overlay Zone is invalid.

There has been no notification to the homeowners within 500 feet of the subject property of the rezoning of this project with a Positive Declaration. There has been no mitigation of any adverse impacts flowing from the Positive Declaration in violation of the requirements of SEQRA and there has been no opportunity for those impacted by this project to be heard.

The numerous and extensive adverse impacts of the Villa Project have not been properly ascertained or mitigated. For example, the Applicant erroneously represented that all visual impacts have been mitigated. There has been no objective measure of visual impacts provided by this Applicant. No decision can be rendered on visual impacts until the Applicant is required to demonstrate the building heights of the proposed buildings through the floating of balloons or some other objective measure.

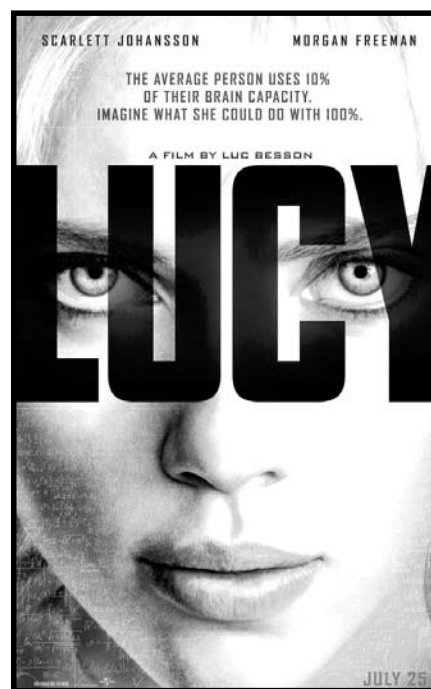
We hereby protest the City of Glen Cove taking any further action on the Villa Project until it is demonstrated that the RIO-GCA is a legally enforceable Overlay Zone. Further, due process under SEQRA requires that the public and those affected by the project have an opportunity to be heard prior to any determinations being made. SEQRA requires that the Applicant resolve all adverse impacts prior to being granted any permission to move forward with a Project. In addition, this Applicant owes real estate taxes in the amount of approximately \$257,000.00 to the City of Glen Cove and should not be granted any further review until this amount is satisfied.

Lucy

A movie review by Katherine Kranz

Runtime: 89 min

Rated PG-13 (Disturbing brutality and sexuality)

Stars: Scarlett Johansson, Morgan Freeman, Min-sik Choi

The laudable writer/director of Euroconfections Luc Besson, while contributing some of the most beloved titles in the action genre, is not exactly dependable when it comes to quality. The same man who is credited with "Léon: The Professional" and "The Fifth Element" also has his name on the scripts for "Transporter 3" and "Colombiana." Besson's iconic vivacious action sequences and colorful characters are what compose his best work. It is a great shame audiences would be pressed to find either of these attributes in "Lucy."

Professor Norman (Morgan Freeman) explains the theory on which the movie is centered on, that humans only use a small percentage of their brain's capabilities. To further prove his points, needlessly, the opening scenes are bombarded with stock footage of various parts of life. As he gives his lecture, an American student living in Taiwan, Lucy (Scarlett Johansson), is coerced by her boyfriend to deliver a briefcase with unknown contents to mob boss Mr. Jang (Min-sik Choi). At Mr. Jang's mercy, Lucy learns she has just brought him a

large amount of a synthetic drug called CPH4.

Jang decides to use Lucy as a mule and has the drug packets sewn into her abdomen, instructing her to transport them to Europe where they will be sold on the streets. At the hands of Jang's cohorts one of the men brutally beats Lucy, causing one of the bags to burst in her stomach and release the drug into her body. Her transformation is almost immediate. The enzymes increase her mental abilities and Lucy's powers gradually become unstoppable.

There is not much more to the story than this. It is a concept almost identical to that of 2011's "Limitless." Lucy seeks revenge on Jang and tracks down the rest of the drugs, which requires little effort. Inexplicably, as Lucy's mind strengthens her morality starts to fade. She frequently harms, and even goes as far as murdering innocent people without reason. Yet Besson seems to be trying to convince viewers that her actions are justifiable.

Besson's script is surprisingly light on action, with only the occasional burst of thrilling gunplay and pursuits. It is overflowing with scientific explanations and superficial conversations concerning what life would be like if people could access the full potential of their minds. The weight of such dialogue is hindered however, as the improbability of Lucy's powers reach ridiculous levels. She becomes so advanced that what little sense of conflict and suspense there was disappears. How could anyone possibly compete with a woman capable of telekinesis, physical manipulation, and instant body modification?

Most disappointing is the lack of a memorable character, the type Besson is so skilled at creating. Not one even remotely bears greatness the likes of Jason Statham's Frank Martin, or Gary Oldman's Stansfield. Morgan Freeman does his best to bring life to his one dimensional character, but the case remains that Professor Norman is simply not needed at all. He could have been eliminated entirely and the overall story would not have been affected in the least. Johansson, as beautiful as she is, does not have the presence or command required to carry a movie on her own.

While his talent is undeniable, Besson's inconsistency is glaring. What he has put forward is nothing aggressively dreadful, just lacking in notability. It seems ironic that a movie focused on utilizing the mind to its fullest comes off as half-hearted. After viewing "Lucy," one may want to revisit the better films of Besson's past and revel in the joyful outrageousness.

SAFE Inc. encourages parents to talk about underage drinking with children

SAFE, Inc. PRIDE Project Coalition encourages parents and caregivers to become actively involved in preventing underage drinking among youth by talking about the dangers. Not talking about this important issue sends the wrong message to children and teenagers.

“According to the Substance Abuse and Mental Health Services Administration (SAMHSA), children begin thinking alcohol may not be just for adults by age nine,” said Dr. Sharon Harris, Director of SAFE, Inc. “And the children who start drinking by age 15 are five times more likely to have alcohol problems as adults.”

SAMHSA's underage drinking prevention campaign provides parents and caregivers with the tools to start talking

to their children early. Their “Talk. They Hear You” campaign empowers parents and caregivers to talk with children early about the dangers of alcohol and offers answers to some of the tough questions parents face.

One question frequently asked by children is whether a parent engaged in underage drinking. Some parents may be uncomfortable with this question and avoid it. SAFE Inc. encourages parents to instead be honest. Then tell their children that it was risky for them to drink back then too but the dangers that we know now about underage drinking was not available. And a parent should not be afraid to admit any unfavorable outcomes that happened to them as a result of making the wrong choice.

Another question that parents may not be sure how to answer is when they are questioned as to why they drink. Explain to children that there is a big difference between an adult and a child drinking and then parents should share the reasons why they do drink. Perhaps the parent enjoys a glass of wine with dinner or to celebrate a special occasion. Parents should stress that it is often all right for an adult to drink in moderation, but also that some people should not drink at all. Most importantly, children should know it is o.k. to discuss drinking with their parents.

Children are asking their parents at an increasingly younger age if they can go to parties. It's never too early for a parent to ask if an adult will be present and if the child believes there will be drinking at the party. Additionally, they should remind their child that if they are at a party and there is drinking, even if they are not drinking, they can get into a great deal of trouble. Parents can use this moment as a time to reinforce their expectations for their child and remind them that they will pick them up if there is underage drinking going on at the party.

“Children may need help knowing how to say no to peer pressure,” said Aimee Abraham, PRIDE Project Coalition Coordinator. “Discuss options with them on how to say no to their

friends who are encouraging them to drink.”

SAFE Inc. reminds parents that it's important to be consistent when sending home the message that underage drinking is harmful and unacceptable — and to keep talking.

Last Week’s Celebrity

Last week’s celebrity was born Francis Curray McHugh, but known professionally as Frank McHugh. One of his most memorable roles was when he was cast as “Father Timothy O’Dowd” in the 1944 Bing Crosby film, “Going My Way”. He later played “William Jennings Depew” in the 1962 episode “Keep an Eye on Santa Claus” in the ABC TV series, “Going My Way”, starring Gene Kelly and loosely based on the earlier film. McHugh’s role in the TV series was re-cast with Dick York, later of “Bewitched”, as “Fr. Chuck’s” boy-hood friend, “Tom Cowell”, the director of a secular neighborhood youth center. Twice McHugh played the same character in two movie re-makes. He played a petty thief running from the Chinese authorities in “One Way Passage” (1932) and its re-make “ ‘Til We Meet Again” (1940). He played “Spud Connors” in the “The Crowd Roars” (1932) and its re-make “Indianapolis Speedway” (1939). In the 1960s, his career was beginning to wind down. From 1964 to 1965, McHugh played the role of “Willie Walters”, a live-in handy-man, on the ABC sitcom, “The Bing Crosby Show”, co-starring Beverly Garland and, of course, the ‘ole Bingle. He also played a handy-man on Andrew Duggan’s CBS western series, “Lancer”. Mr. McHugh died of natural causes on Sept. 11, 1981, at the age of 83, at his home in Greenwich, Connecticut.

Nevertheless, she continued to appear regularly on the Great White Way for the next twelve years, performing in comedies and musicals until 1929, when she was featured in “The New Moon”, a Sigmund Romberg musical, which was her final Broadway production. In 1930, she was still slender and beautiful when she changed her focus to making movies, appearing in a Vitaphone comedy short, “The Victim”. From that point until her retirement in 1952, she worked regularly. Known for her versatility and expressive face notable among her many roles were the gorgeous “Miss Prescott” in “Meet the Mayor” (1932) with Frank Fay and Nat Pendleton, “Miss Stillman” in “The Iron Master” (1933) and frowsy “Jessie Florian” in Raymond Chandler’s

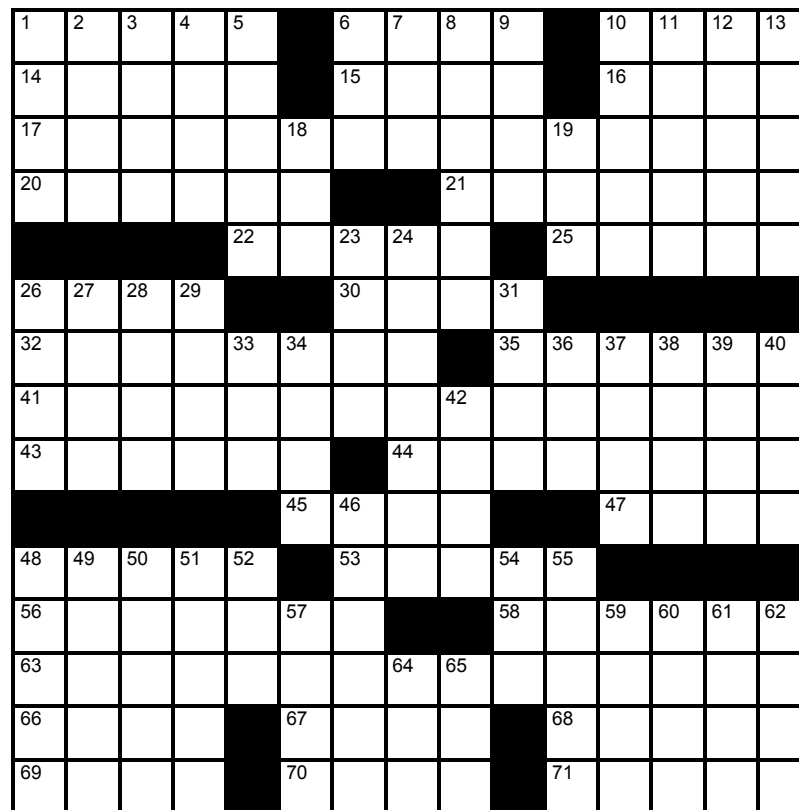
