War Veterans House Burglarized

An Afghanistan war veteran who had recently returned home in April purchased his dream home in Glen Cove on July 7th. After moving in with his wife their new home was burglarized on July 29th and then again on August 1st.

According to Det. Lt. John Nagle, Stolen from the home was various electronics, cash, and thousands of dollars' worth of jewelry. Glen Cove Detective Brian Glennon developed a possible suspect and then with the assistance of the Nassau County Asset Forfeiture and intelligence Unit he discovered that this suspect had sold some of the stolen items from the burglary in Freeport and in Greenvale. The Glen Cove Police responded to the locations in Freeport and Greenvale and recovered much of the stolen property. As a result of the investigation it was learned that the suspect was still in possession of some of the stolen items from the burglary. The Glen Cove Police then contacted the suspect and set up a planned buy and bust with him. "the suspect thought he was dealing with a jewelry buyer when he was speaking to a Glen Cove Officer," stated Detective Lieutenant Nagle. The suspect showed up at the meeting with



all the proceeds of the burglary that he had not yet sold.

The defendant, Michael Petikas age 31 of floral Park NY was arrested and charged with two counts of Burglary in the Second Degree and Criminal Possession of Stolen property in the fourth degree. As it turns out the defendant Michael Petikas had grown up in Glen Cove and lived in the actual house that he allegedly twice burglarized. The defendant will be arraigned in First District Court in Hempstead on today's date.

"A bone marrow transplant is potentially a life-saving treatment for someone with cancer and other blood disorders," explains Sea Cliff resident Lori Schneider, who founded the organiza-

tion with her husband Matthew Ruderman after their daughter Penelope was diagnosed with leukemia at age 3. "Matt and I were so lucky that Penelope had a match and part of our mission is to make sure all patients in need of a bone marrow transplant can have one." To get on the registry, interested volunteers can have their cheeks swabbed at the door.

Penelope's Odyssey will also be joined by the Matthew Fetzer Foundation, which collects new toys for children with cancer. Please bring a new toy to donate.

Petitions must bear the signatures of at least 50 qualified voters of the Gold Coast Public Library District. Petitions must be directed to the Chair of the Election Committee of the Gold Coast Public Library District at the Gold Coast Public Library and filed in the Office of the Chair of the Election Committee, located at the Circulation Desk, not later than 5 pm on Tuesday, August 26, 2014.

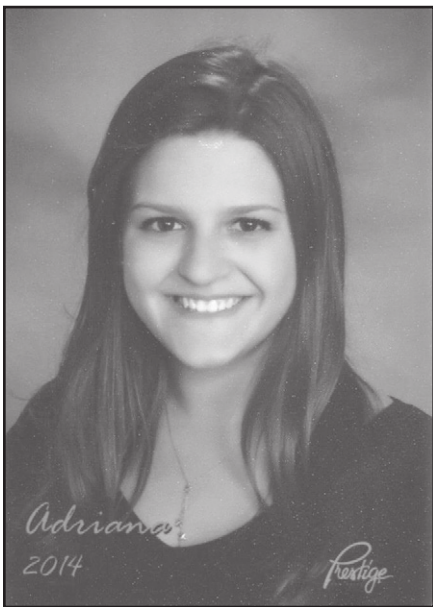

Name the Celebrity



This week's celebrity was born on Dec. 10, 1889 in Sacramento, California and was an actor in film, stage, radio and television. He started acting on stage at the age of 14. He was part of a stock company called Vancouver's Popular Players which enacted plays at the original Orpheum Theatre in Vancouver, British Columbia. Between the ages of 17 and 30, he was out of work as an actor for a total of five weeks. Otherwise, he worked continually in the field of entertainment for his entire life. In the mid-1930s, now an established stage and radio actor, he began an association with Orson Welles' Mercury Theatre that led to some of his most memorable roles. Having already worked on radio with Welles on "The Shadow" ("Who knows what evil alerks in the hearts of men?..."), as a regular in the role of "Commissioner Weston", and in Welles' serial adaptation of "Les Miserables" from 1937. He made his first notable screen appearance in "Citizen Kane" (1941) as "Kane's" ruthless political rival and incumbent NY State governor, "Jim G. Gettys". This was also Welles' first feature film and nominated

for Academy Awards in nine categories winning for Best Writing of an Original Screenplay by Herman Mankiewicz and Welles. He also played key roles in Welles' "The Magnificent Ambersons" (1942) and "Touch of Evil" (1958). He appeared in more than 90 films in all including "Leave Her To Heaven" (1945) with Gene Tierney and Vincent Price and "The Bachelor and the Bobby-Soxer" (1947) with Shirley Temple, Cary Grant and Myrna Loy.

Last week's celebrity was Esther Howard. From 1937, she was a regular player in shorts subjects produced at Columbia Pictures where she was frequently cast opposite comedian/actor, Andy Clyde. Beginning in the early 1940s, she was part of Preston Sturges' unofficial "stock company" of character actors, appearing in seven films written and directed by Sturges. Her performance in Sturges' films were among her best, especially the wife of the Wienie King in "The Palm Beach Story" (1944) with Claudette Colbert and Joel McCrea and a diner waitress "Holly" in the film noir classic "Detour" (1945). She presented a terrific portrayal of bawdy "Filthy Flora" in the dark and moody "Dick Tracy vs. Cueball" (1946), Kirk Douglas' mother in the multi-Oscar nominated film, "Champion" (1949) and the wealthy "Gloria Peabody" in "The Falcon's Alibi" (1946), a mystery film with Tom Conway. Her last performance was in a Columbia comedy short "Caught on the Bounce" (1952), in which she played Joe Besser's aunt. Esther died of a heart attack on March 8, 1965, at the age of 72.

Get there early and start reading a beautiful and disturbing classic ALL QUIET ON THE WESTERN FRONT by Erich Maria Remarque. With the 100th anniversary of the start of World War I, there have been many books and articles published this year about the so called Great War but this short novel (258 pages) written in 1929 by a young German soldier stands out as the most devastating account of the futility and brutality of war. The book follows six German soldiers fighting on the western front. The suffering- physical and emotional- that these young men endure and inflict is recounted in painstaking detail.

Told by eighteen year-old Paul Baumer, the novel depicts how the lives of all those who fought were changed forever. He questions over and over the morality of killing other young men who are not his enemy, but rather the declared enemy of statesmen and politicians who rule far from the dangers of battle. An astonishingly relevant book written over eighty years ago- highly recommended!

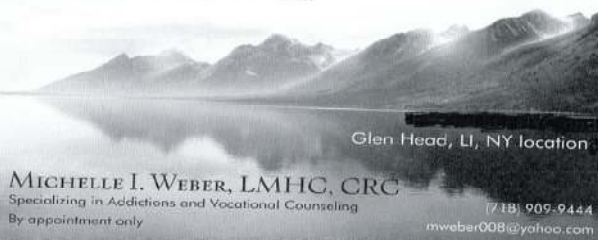
