The Navy Storms the Sea Cliff Beaches

Two sailing boats from the United States Naval Academy dropped anchor in Hempstead Harbor this Monday in preparation to sail in the 38th annual Around Long Island Regatta, hosted by the Sea Cliff Yacht Club. The Academy's sailing vessels, Dolphin and Ranger, will once again be competing in this year's 190 nautical mile race around Long Island.

Eighteen midshipmen and women and four coaches came ashore and have been hosted by families of the Sea Cliff Yacht Club. Tuesday evening the "Mid-dies" were treated to a special barbeque and pig roast on the beach of the Yacht Club. Thursday morning the boats left for Brooklyn for the start of the Regatta. The race runs from Thursday afternoon, July 31st to early Sunday, August 3rd.

Barbara is the youngest child in a large Italian-American family. As the baby of the family she had many advantages. Her sister Theresa was 13 years older and already working when Barbara was 7 years old. Theresa decided to pay for dance lessons for her baby sister. In the evening when Theresa returned home from work she would say, "O.K., Barbara, show me what you learned in dance class today." Barbara so enjoyed showing Theresa and the family the new dance steps she learned in class. And thus it was as Barbara grew up. Theresa's generosity would spark a passion in Barbara, a never-ending love of dance.

Barbara grew to womanhood, married Charlie and together they raised a family. Out of necessity, Barbara's priorities changed and dancing was put on the back burner. Now her responsibilities were with her family. Also of importance to Barbara and Charlie was service to their community. Charlie became a volunteer fireman and Barbara volunteered at the church the family attended. The years passed; the children married and had families of their own.

She has donated her time reading to elementary school children, assisting with the Rose Shop's sidewalk sales, giving freely of her time and resources wherever and whenever needed. When the Line Dancing teacher takes a vacation, Barbara teaches the class in his absence.

She has become a good will ambassador for the Senior Center. With her engaging smile, her happy disposition and outgoing personality she meets and greets many new members, making each feel welcome, and introducing each to the numerous activities at the center. One of her friends dubbed Barbara 'Miss Congeniality' because she has and continues to befriend so many seniors making each and every person feel special and important. She is always available to help anyone needing help or just needing a comforting word or a hug. Her compassion and understanding know no limits.

e-Waste disposal: September 20, from 9 a.m. until 4 p.m. at Progressive Waste Solutions on Morris Avenue. Please bring only computer monitors, hard drives, printers, keyboards, mice and cables, copiers, fax machines, cell phones, pagers, VCRs, stereos, televisions, and electronic games.

Shed the Meds: October 4, from 10 a.m. until 2 p.m. behind Glen Cove Police Headquarters. Glen Cove Police Department, EMS Corps, and the Substance Abuse Free Environment (SAFE)

agency will collect unwanted/expired medicine and have secured an environmentally responsible means of disposing them. Check your medicine cabinet for medicine no longer needed or no longer useful.

Stop Throwing Out Pollutants: Saturday, Oct. 25, from 9 a.m. until 4 p.m. at Progressive Waste Solutions on Morris Avenue. Bring only aerosol cans, air conditioning refrigerants, antifreeze, automobile batteries, household batteries, brake and transmission fluids, bug and rodent killers; enamel, lead and oil based paints; paint thinner, automobile tires, oven cleaner, polish and wood preservatives, unused flammable liquids, waste oil, insecticides, pesticides, fertilizers, rug and upholstery cleaners, pool chemicals and empty barbecue propane tanks.

SAFE believes parents can help their teen avoid smoking

The troubling combination of teens and tobacco has been an issue as far back as most people can remember. Many young people believe smoking is sexy, will help them lose weight, or make them more popular with their peers.

SAFE PRIDE Coalition recognizes the problem these misconceptions are causing among youth, but believe they can be squashed if parents and caregivers open up the lines of communication. SAFE encourages parents to speak to their children driving home the message that tobacco use is not a sign of maturity, and that most adults who started using tobacco as teens later regretted it.

Perhaps a few other pieces of valuable information will help them too. There are many short-term effects of choosing to become a smoker that parents can use to help stop their teen from smoking. They include: a higher likelihood of respiratory problems, shortness of breath (certainly a problem for a teen that wants to excel at sports), impaired lung growth and function, bad breath, yellow teeth and stained fingers.

If these short-term effects do not dissuade them, try discussing the long-term effects which include: addiction to nicotine and exposure to other dangerous chemicals, lung, mouth, throat, kidney, and stomach cancers, coronary heart disease, emphysema and other chronic diseases, and a shorter lifespan — up to 20 years shorter.

Some teens are not strong enough to know how to deal with peer pressure. SAFE encourages parents to help their teens prepare in advance for certain situations. To deal with peers, they can always say they are not allowed to smoke and that it is impossible to hide it from their parents because of the smell tobacco

leaves behind.

Parents should take advantage of teachable moments to discuss tobacco use. Commenting on an advertisement or TV show that shows someone smoking can be useful as well as acknowledging anti-smoking commercials. If a parent sees someone using tobacco, such as a relative at a family gathering or one of their own friends, they should ask their teen what they think about it. SAFE believes opening the doors of communication with teens is the way to go to stop tobacco use. Talk they will listen.

Over the last several years SAFE has partnered with the Tobacco Action Coalition of LI (TAC) and the city in many initiatives to de-normalize smoking for our impressionable youth. Carol Meschkow, the Nassau Project Coordinator for TAC says "leading by example is so important, and she is very proud of the fruits of this collaborative effort in changing the social norms in the city to prevent the next generation of smokers. Sadly, 9 out of 10 smokers start by the age of 18 and 99% by the age of 26. North Shore Schools, Glen Head, N.Y., August 11, 2014 – This summer, dedicated North Shore students and alumni participating in the LI Studies (LIS) Program under the direction of Technology teacher Bruce Fichtman worked very hard to put the finishing touches on the TV and Recording Studio. This beautiful Victorian structure located at the front entrance of the North Shore High School campus will provide an exciting interdisciplinary experience in multimedia for students now and in the future.

Mr. Fichtman said, "In class, we studied characteristics of Carpenter Gothic style Victorians, which have been passionately captured and replicated throughout the building by student builders over the last few years." He added, "With a looming deadline of a September opening of the Victorian Studio, my students worked diligently this summer putting in eight hour work days, five days a week. They took great pride in their work and their craftsmanship is quite evident in all the fine detail work that adorns the studio inside and out."

The students who worked on the Victorian Studio this summer included Eric Borchert, A.J. Cavaliere, Joe Dromm, Kevin Henneberger, John Hickey, Andrew Poddoubnyi, and Emmanuel Varveris. Along with Mr. Fichtman and local members of the community, they successfully completed the following tasks:

- Installation of all wainscoting with continuous wrap around sill and crown moldings
- Installation of all fluted window moldings and decorative rosette
- Installation of all baseboard molding and wall
- Construction of exterior staircase leading to the front door
- Installation of all final electrical recep-

tacles, switches and light fixtures

- Installation of bathroom fixtures, mop sink and water cooler
- Installation of maple hardwood flooring, floor tile
- Installation of alarm system sensors and control panel
- Construction of plastic laminate countertops

The tremendous undertaking of building the Victorian TV and Recording Studio began in 2008. It is a collaboration among volunteer community members and the students in the LI Studies (LIS) Program, just one of five interdisciplinary humanities courses offered to seniors at North Shore High School. This summer local electrician, John Wierzbicki, of JRW Electric assisted the students with the installation of all final electrical fixtures. Glenn Bunce and his sons John and Brian (North Shore graduates and former Long Island Studies Students) assisted with the installation of all plumbing fixtures. Additionally, Gaspare Saracino of Saracino Construction donated the cement walkways leading to the exterior entrances of the Victorian Studio. Mr. Fichtman stated, "My students and I were so lucky and thankful to have the opportunity to work alongside local community members who are masters of their trade. They acted as both mentors and teachers and provided each of my students with unique learning experiences that cannot be found in any standard textbook."

The Victorian Studio is the first building at the North Shore School District that will be heated and cooled using geothermal energy. In addition, several other school districts have visited North Shore to observe our senior programs which have been recognized as Programs of Excellence by the New York State Council of Teachers of English.

Mr. Fichtman concluded by saying,

"I cannot thank the members of the Viking Foundation enough for providing the vision, funding, and opportunity for North Shore students over the past seven years to construct the Victorian Communications Studio. All aspects of this project ranging from the initial design and planning to the installation of the final piece of molding have provided hundreds of students with a valuable learning experience that will stay with them for the rest of their lives."

On September 18, 2014, the Viking Foundation along with the Board of Education, administrators, faculty, students, and community members of the North Shore Schools will celebrate the opening of the Victorian TV and Recording Studio from 6.30 PM – 8:30 PM.

Kids Rock Summer Strings

Young musicians share highlights from SummerStrings! Junior Orchestra Matthew Schneider motioned for fellow musician Frank Ferrara to begin playing the electric guitar. Then Schneider signaled drummer James Guarnieri and the 26 elementary school kids enrolled in his SummerStrings! Junior Orchestra to begin their piano, bass, cello, viola and violin parts, too. Together, the ensemble played Survivor's "Eye of the Tiger" to open their concert on August 6 at St. Luke's Episcopal Church in Sea Cliff and captured the attention of all.

"Finally, it's rock music, not classical," says Mark, a 9-year-old bassist. Most of the other young strings players agree that the song is their favorite of the three selections Schneider had taught them during the six-week summer program.

For the second selection "Eleanor Rigby," students used long, full bow strokes to create the song's somber sound. Schneider had chosen to include a Beatles' song to commemorate the 50th anniversary of the group's arrival in the United States.

To close the concert, the students played a country song called "Fiddles on Fire," during which they improvised

solos. Emily, a 9-year-old violinist, likes this song best "because it sounds good together." Will, 9, knew that concertgoers would enjoy the song's solo section and the bluegrass beat that he and the other bassists created by slapping their strings. "The solos are really cool because you hear all of these different rhythms created by different instruments and people," he explains. "And the slapping is just plain cool!"

The music, says Schneider, was not easy to learn. "The kids truly rose to the challenge and made music in a way that they had never done before," he says. "I am extremely proud of each of them!"

The kids liked the challenge, music and also working with kids of different ages and from surrounding towns. Many of the kids, including 8-year-old cellist Aaron, take private lessons with Schneider during the school year, but others were studying with him for the first time. Glen Cove City Council adopted the following Ordinance at the City Council Meeting of August 12, 2014:

BE IT RESOLVED, that the City Council hereby amends Chapter 200 - Outdoor and Sidewalk Cafes, Section 5 -Music; alcoholic beverages; operating hours.

Chapter 200

200-5- Music; alcoholic beverages; operating hours

Section 200-5 of the Glen Cove City Code of Ordinances is hereby amended to read as follows:

A. No sidewalk cafe or outdoor cafe shall provide amplified music, recordings or any musical sound by electronic means through loudspeakers or similar devices, except by permit. Permits shall be available annually from Memorial Day through September 30th for the following days and times only: Friday and Saturday until 10:30 p.m. and Sunday until 8 p.m. Permits shall be applied for as prescribed in subsection D below. Musical instruments and singing without amplification shall be permitted so long as the same does not disturb the peace of any nearby residentially zoned neighborhood.

B. Alcoholic beverages may not be served at any sidewalk cafe or outdoor cafe unless expressly authorized by the New York State Liquor Authority.

C. No sidewalk cafe or outdoor cafe shall operate before the start of business of the restaurant to which it is accessory or after the close of business of such restaurant.

D. Permits for the use of amplified music, recordings, or any musical sound by electronic means through loudspeakers or similar devices may be issued to sidewalk cafes or outdoor cafes upon application to the Building Department Administrator upon forms designed and provided by the BDA. Permits shall be granted at the discretion of the Building Department Administrator in consultation with the Chief of Police, and may be revoked at any time for cause at the discretion of the Mayor. There shall be a permit application fee of \$50.00. Only one permit is required per applicant per season, but applicants and permit holders are required to notify the Building Department of each date the applicant intends to utilize the permit to provide amplified music for its patrons. This notice shall be provided to and on the form or forms designated by the Building Department Administrator, and must be provided forty-eight hours in advance of the desired date. Each date is subject to approval or denial, notwithstanding the prior issuance of a permit.

This Ordinance shall take effect immediately.

Name the Celebrity



This week's celebrity was an Australian actress, born on January 15, 1896 and made her first appearance in the pre-World War I years. That was at the suggestion of one of her two actress sisters, Enid, who was a silent film star. She wasn't yet under the spell of the acting bug, so she abandoned performing for several years, re-emerging as a stage rather than screen actress. She returned to films in the late 1940s as a character player notably in two Charlie Chaplin films, "Monsieur Verdoux" (1947) and as the landlady in "Limelight" (1952). A prolific film and TV performer of the 1950s and '60s, our celebrity was usually cast as huffy society matrons and haughty domestics. Her massive bulk and easily outraged demeanor made her the perfect straight woman for such iconoclastic comedians as Red Skelton and the Three Stooges. The baby-boomers will fondly remember her in "Mary Poppins" (1964) with Julie Andrews and hear her voice, along with Mary Wickes, Rod Taylor and J. Pat O'Malley, in the Walt Disney's animated "101 Dalmatians" (1961). For those cult movie enthusiasts, she played "Dehlia Flagg", the mother of Victor Buono's character, "Edwin Flagg", in the 1962 film "Whatever Happened to Baby Jane?", with Bette Davis and Joan Crawford.

Last week's celebrity was Ray Bidwell Collins. He became a regular with Orson Welles' The Mercury Theatre on the Air and its sponsored continuation, The Campbell Playhouse. Through the run of the series, he played many liter-

ary adaptations from "Squire Livesey" in "Treasure Island", to "Dr. Watson", in "Sherlock Holmes", to "Mr. Pickwick" in "Pickwick Papers." Collins' best known (albeit uncredited) work on the series, however, was in the infamous 1938 Halloween night radio broadcast, "The War of the Worlds" in which he played three roles, including "Mr. Wil-muth", on whose farm the Martian craft lands) and the newscaster, who describes the destruction of New York. The first two-thirds of the 60 minute broadcast was presented as a news bulletin. The performances of the Orson Welles ensemble of Mercury Theatre Players were so authentic, that it led to widespread outrage and panic by certain listeners who had believed the events described in the program were real!

Some of the other 90 films were "The Best Years of Our Lives" (1946), "A Double Life" (1947) and two entries in "The Ma & Pa Kettle" series with Mar-jorie Main and Percy Kilbride. Perhaps however, in the 1950s and '60s, his most memorable role was that of "Lt. Arthur Tragg" on the Sunday night CBS TV mystery series "Perry Mason" with Raymond Burr, William Hopper and Barbara Hale. By 1960, while immersed in the series, Collins found his physical health declining and his memory waning, problems which in the next few years brought an end to his career. He made his last appearance in the Jan. 16, 1964 episode. He commented, "Years ago, when I was in the Broadway stage, I could memorize 80 pages in eight hours. I had a photographic memory. When I got on stage, I could actually--in my mind--see the lines written on top of the page, the middle of the page or on the bottom. But then radio came along, and we read most of our lines, and I got out of the habit of memorizing. I lost my natural gift. Today, it's hard for me. My wife works as hard as I do, cueing me at home." On July 11, 1965, Collins died of emphysema at the age of 75.

It belonged to her adored elder sister Sukey who has been missing all these years. The sweet, exquisite details Maud remembers of her early years in postwar England and the sadness that

permeated the years after Sukey's disappearance make for a good book, but it is Maud's faulty memory- whether from Alzheimer's or old-age dementia- that makes this book so unusual. We are not sure if she has forgotten important clues or is she being purposely misled by those around her. The two missing persons in her life- her sister and her friend Elizabeth- come together in her mind and ours as we try to understand what really happened long ago. An unreliable narrator but a very rewarding read- highly recommended!
