Beware of Scam

Glen Cove is currently experiencing a rash of PSE&G phone scams. The scammer calls a PSE&G customer and states that he/she represents PSE&G and demands immediate payment using a Green Dot Money Pak, which is a type of pre-paid card available at pharmacies and convenience stores. PSE&G does not accept these pre-paid Green Dot cards, Furthermore PSE&G customers who are scheduled for disconnection due to nonpayment receive written notice on their bill at least 10 days in advance.

If you believe you are being scammed simply hang up the phone and contact PSE&G directly at 1-800-436-7734. If you believe you are a victim of this type of phone scam contact your local police department.

Mobil Speed Cameras to be placed by High School on Dosoris Lane

A message from Mayor Reginald Spinello

I have contacted the County Executive's office regarding Speed Cameras being placed near Glen Cove Schools. Their plan calls for a mobile unit to be stationed near the High School on Dosoris Lane beginning the week of September 8. This is a temporary post and, although I could not get a definitive answer regarding the amount of time the unit would be in place, estimates range from 1-3 weeks.

The cameras will be in use one hour before school starts until one hour after school ends. The hours may vary, but the cameras can be used from 7am until 6 pm.

The speed limit in the school zone is 10 miles per hour LESS than the posted speed limit in the area of 30 MPH. The school zone speed limit is 20 MPH.

Actual State statute does not mandate that signage be placed in the area notifying drivers of the cameras. I have asked the County to supply signage and they are working on it. The fine for speeding through a school zone is \$80.

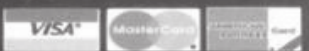

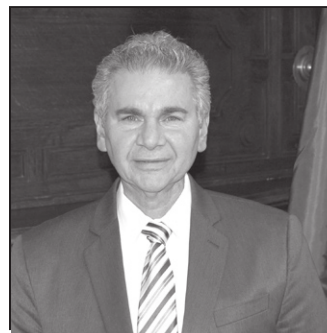

Mayor's Column

Drive Safely Schools Are Open: Glen Cove students have begun their school year. Please obey the law and drive safely. When a stopped school bus flashes its red light(s), all traffic approaching from either direction must stop. Drivers can't proceed until the red lights stop flashing. Don't text or talk on a cell phone while driving—this law applies to drivers of all ages.

Speeders Beware: Drivers speeding through our streets, you are now forewarned. The Police Department's ongoing initiative to monitor speed conditions in various locations throughout our city is coming to a neighborhood near you.

Glen Cove is Open for Business

Panera Bread: Great news! Construction permits have been issued and work will begin shortly.

New Construction started: After many years of delay, the Landing Cove Condominium 55 Senior Development has begun.

Coming soon : Garvies Point Brewing Company has applied for a special use permit for the manufacture, packaging, sale and distribution of beer.

Voluntary Separation Incentive Packages:

Fifteen City employees have opted for the early retirement incentive package which I introduced earlier this year. Eligible employees receive 1% of their current base pay for each year of service up to 20 years. This plan has created a win-win for our city. Those employees who have served our city well are rewarded for their service, and new people are hired to fill their positions at substantial saving to payroll and pension costs. Additionally, opportunities for advancement and growth are provided to employees currently working. Estimated savings are \$250,000.

Aggressive Approach to Remedy Quality of Life and Illegal Housing Continues: My administration's message of zero tolerance for anyone participating in the illegal housing business has resonated in Glen Cove. Illegal housing puts lives at risk, disparages a neighborhood and impacts our city's infrastructure. During Operation Neighborhood Pride, the police department and I have walked the Landing, Elm Avenue, and Valentine Avenue areas to name a few. We will continue this initiative with more walks planned for September and October. Our code enforcement department continues to respond to complaints from residents reporting overcrowding and questionable housing conditions. Residents, "If you see something, say something." Please call my office with your concerns at 676-2004. Your confidentiality will be respected. Through the first seven months of 2014, we have collected more in fines than was budgeted for the entire year.

Coles School: We are continuing the exploratory phase for the potential reuse of the Coles School and it surrounding property. Glen Cove will be inviting proposals, known

as Expressions of Interest (EOI), for the re-development of the site, keeping in mind the City wants to preserve the architectural integrity of the school building through adaptive reuse. In addition, the City would like to bring the long vacant, surrounding property to active use. We will consider proposals that involve the sale of the property as well as leasing options under the right circumstances. A response to this EOI does not bind or obligate the City or the entity making the proposal in any way. Once we receive ideas through the EOI process, we will invite all residents to offer their ideas. The entire process will include everyone. Only then will we be able to make an educated decision.

Youth Initiatives: I have been working closely with members of our Recreation and Youth Departments to bring new opportunities for expansion and growth of our facilities and sports programs. More to follow on this in the near future.

Verizon FIOS Knocking on Your Door, if they haven't already. Verizon FIOS sales representatives have obtained the required solicitors' permits from our police department and will be going around marketing their cable television service. Verizon has agreed with the Public Service Commission's condition and will be increasing their annual payments to Glen Cove for PEG (Public Education Government) grant by \$4,750 per year for 12 years. The total payout to the City over the term of the contract is \$99,000. Many residents are already enjoying this new service.

Job Well Done: Public Works and our First Responders: I am proud to say that many residents and non-residents have expressed to me their gratitude for the exemplary work being performed by our many departments. A well-deserved thank you to all of our city workers.

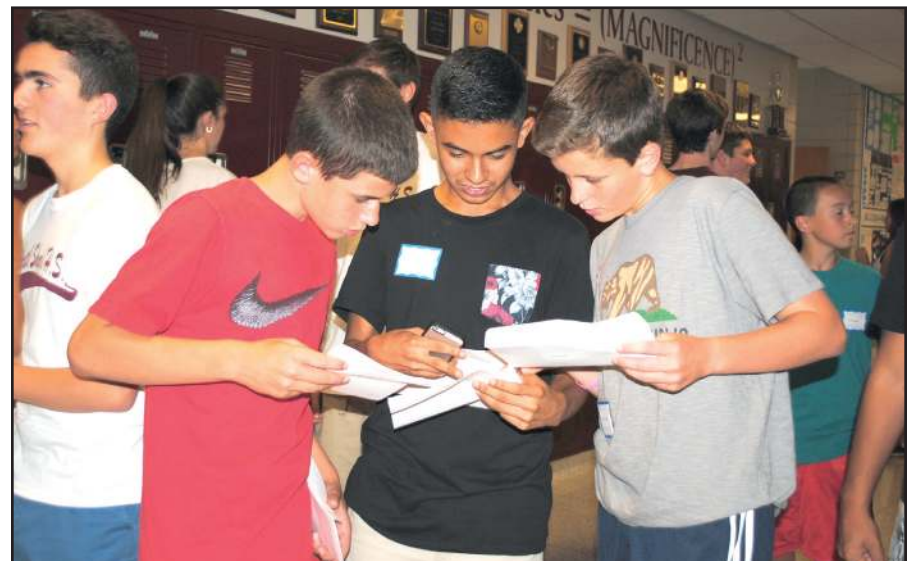
dle school and enjoy a class BBQ!

Last Week's Celebrity

Last week's 6'4" celebrity was Henry Stephenson Garroway. He professionally dropped Garroway. After transferring a successful Broadway role to film with "Cynara" (1932) with Ronald Coleman and Kay Francis, Stephenson settled in Hollywood, where he distinguished himself in a variety of pictures for RKO, MGM, and Warner Bros., among others. He appeared quite frequently in a royal support for Warner's top star at the time, Errol Flynn, including "Captain Blood" (1935) as "Lord Willoughby", "The Charge of the Light Brigade" (1936) as "Sir Charles Macefield", "The Prince and the Pauper" (1937) as the "Duke of Norfolk" and "The Private Lives of Elizabeth and Essex" (1939) as "Lord Burghley". He played "Mr. Brownlow" in Charles Dickens' "Oliver Twist" (1949) with Alec Guinness as "Fagin" and Anthony Newley as "Artful Dodger". In 1999, the British Film Institute placed this film at 46th in its list of top 100 British films. In Edgar Rice Burroughs' novel based films, he portrayed "Sir Thomas Lancing" in "Tarzan Finds a Son" and played an entirely different role as "Sir Guy Henderson" in "Tarzan and the Amazon" (1949). This week's celebrity was born Norma Deloris Egstrom, on May 26, 1920, in Jamestown, North Dakota. She was a jazz and popular music singer, songwriter, composer and actress, in a career spanning six decades. She was seventh of eight children. Her mother died when she was four years old. Her alcoholic father re-married to a woman who treated her with great cruelty and he did little to stop it. Later, she developed her musical talent and took several part-time jobs so that she could be away from home. She first sang professionally over KOVC Radio in North Dakota. She later had her own series on a radio show sponsored by a local restaurant that paid her salary in food. Radio personality, Ken Kennedy, of WDAY in Fargo, North Dakota, the most widely heard station in that state, changed her name from Norma to what she is known as today and added a "Miss" in front of it. After that she left for Los Angeles at the age of 17. She was noticed by hotel owner Frank Beringin while working at the Doll House in Palm Springs. It was here that she developed her trademark sultry-purr, having to compete with the noisy crowd with subtlety rather than volume. Beringin offered her a gig at The Buttery Room, a

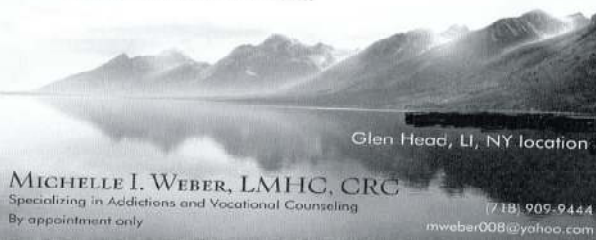

Glen Cove Seniors Cruise the Harbor

Wednesday, August 27th was a picture perfect day. The sun was shining and nary a cloud in the sky. Twenty-four seniors and Program Director Jenny boarded the Glen Cove Senior Center bus. Tilman, our driver, pulled the bus away from the curb and headed to the marina at Port Washington. Matt and Carlene stood at the dock to greet each senior embarking the Port Water Taxi, an open-air vessel with a red and white canvas awning. Matt would be our guide, sharing steering duty with Carlene.

As we headed away from the pier, Matt pointed to Manorhaven, the "Riviera" of Port Washington. Jackie Gleason, Johnny Carson and Jennifer Lopez docked their boats here. In the 50's and 60's one could dine and dance to the music of Bernie Mann and the All-American Band at the Riviera's restaurant. Governor W. Averell Harriman kept his seaplane at the hangar there.

When the area was inhabited by the British, Cornwall built his house overlooking the harbor. The Cornwall Cemetery stands as a testament to this era. Later the Dutch inhabited the land. It is said that the Dutch, dressed as Indians, tried to burn down Cornwall House. One can see a prominent mansion with a red roof that was once owned by John Philip Sousa. During the heyday of Gold Coast mansions, Hearst built an extravagant

estate on the promontory of Sandpoint. All that remains of his opulent estate is the gatehouse. The executive of Arizona Ice Tea owns an impressive mansion along the shore.

Across the harbor stands Great Neck. When F. Scott Fitzgerald lived in Great Neck he penned his classic novel, *The Great Gatsby*. In the novel, Fitzgerald refers to Great Neck as West Egg and Port Washington as East Egg. The Marx

Brothers and Sid Caesar were residents of Great Neck.

The water taxi gently made its way to Execution Rock, with its Cormorants and Seagulls, and to the 1867 Port Lighthouse. Today the lighthouse is privately owned but the Coast Guard is charged with maintaining the facilities. From our boat, we could see the Throgs Neck and Whitestone Bridges, The Bronx, New Rochelle and, in the distance, the New

York City Skyline. After circumnavigating the lighthouse and Execution Rock, we slowly returned to the marina where Tilman was waiting to drive us back to the Senior Center.

It was a magical cruise, a wonderful way of saying adieu to summer. Thank you, Jenny for organizing this enjoyable outing and the tasty boxed lunch for us. We look forward to future excursions arranged by the Glen Cove Senior Center.
