Friends Academy welcomes 780 students for the 2014-15 school year

120 new students from 60 school districts join the FA community

Friends Academy faculty and staff were on hand to welcome students, new and returning, to the 2014-15 school year on Tuesday, Sept. 2. As faculty shook hands and helped younger students off of buses, the community was a whirlwind of excitement and emotion.

"The first day of school is usually always stressful, from 1st graders to seniors. But my job today is to use my 14 years of experience to let you know that everything will be okay," calmly stated senior Elijah Rechler, who was chosen by his class to address the student and faculty body at the 139th Convocation, including a record 780 student body.

Rechler outlined his five go-to steps for making the most out of school, including surrounding oneself with a diverse group (including someone extremely funny), finding passion in what you're learning, making connections with teachers, napping when time allows (except for classes) and most importantly getting involved in the community.

"Our theme for the year, 'Growing our community by strengthening character,' is a two-way street," said Rechler. "The stronger our individual character is, the stronger our community is. And the stronger our community, the stronger the individual."

"It's a reciprocal relationship of give and take," added Head of School Bill Morris. "Developing an attitude of appreciation and gratitude is what will lay the way for moral courage," added Morris.

Earlier in the day, each division explored sub-themes with their principals: Upper School - integrity, Middle School - Teamwork and Lower School - Staying true to your beliefs.

Following the apparent first-ever FA wave during Convocation, Morris asked the newest members of the FA community to stand and each grade of new students was greeted with enthusiastic applause. "Let's invite them into our circle of friends," urged Morris. "Include them; have lunch with our new friends."

The most senior of the Friends community was also acknowledged as Morris thanked eight faculty members for their service of 30+ years: Rick Sullivan (US), Alan Quackenbush (Athletics), Lynn DeNatale (LS), Lillian Schulman (LS), Herb Lape (US), Marshall Lindner (US) and Judi Upright (US). Middle School's Ken Austin is celebrating his 40th year at FA.

Service to our community started on the first day at Friends. As part of a new family-style dining in the cafeteria

for Lower School, fifth graders were on hand to help serve drinks to younger schoolmates.

New students couldn't help but feel at home. "It's very welcoming and the teachers are so nice," said fifth grader Erica Schultz, who had just completed a group activity with her peers. Students were each given a single letter and then asked to collaboratively determine what the letters spelled out.

The prospect of learning new and different ideas were appealing to both young and veteran students. "I'm excited to learn about South America," said 2nd grader T.J. Groves. Seventh grader Yusra Azaz is looking forward to delving into history. "It's fun to find out what people did before."

The new Digital Media Arts department headed up by Jess Levey launches this year for both Middle and Upper School students. Stocked with 20 iMacs, still and video cameras and a studio set-up, Levey will be offering Upper School classes in documentary and narrative video, graphic design and more. Sixth and eighth graders will learn video and stop-motion animation on a rotational basis in their Arts blocks.

"We are excited to provide students with the knowledge and means to create

works of art with this ubiquitous medium," said Levey.

“Growing Up in Sea Cliff” Opens at Sea Cliff Village Museum on September 28

On September 28 at 2pm in room C in Village Hall, The Sea Cliff Village Museum presents Growing Up in Sea Cliff, an exhibit that displays the countless donations over the past 35 years documenting the life of children in the village.

This year for the first time, thanks to generous donations of time and equipment by Bob Lafferty, the Museum’s oral history collection will be available to the public. Listen to actual recordings of our Village “elders”, Harry Korten, Charles Ransom, Henry Hollman, Sam Raff, John Burns, Ward Bell, Joseph Martin and others. These recorded interviews give a unique glimpse of the past as the intimate history of the village is revealed.

At the exhibit, articles of clothing and shoes worn by children and babies from a century ago will be featured. An extensive collection of toys, dolls and children’s furniture will illustrate the kind of lives children lead in the village in past centuries.

Many of the items from the Sea Cliff School have never been exhibited. The books and lessons, diplomas, report cards, yearbooks and brochures from special events will make their appearance in the coming exhibit. A report card from March 1899 from a student in grade 6 at the Union Free School in Sea Cliff, New York shows 136 “Perfect Lessons” with 2 “Failures”. Charles H. Smith was the Principal at the time.

An old school autograph book with rhymes dated “August 9, 1881” and “June 6, 1882” reveal a similarity to autograph books of the present.

The exhibit has some early penmanship notebooks and medals presented to students who mastered the Palmer Method of Penmanship, which was developed in the 1870s. An Italic Cursive with much of the ornamentation of the 18th

and 19th centuries, the Palmer Method was practiced frequently as evidenced by the notebooks filled with flowing letters.

A Copy of Rip Van Winkle with illustrations by Arthur Rackham is also on display. Arthur Rackham, born in 1867 became an important illustrator who influenced many in his generation and beyond. Please take a look at his beautiful and fanciful illustrations in the Museum’s copy of this famous book.

In 1895, a group of wealthy women

established the Country Home for Convalescent Babies in upstate New York. Two years later a new home was built in Sea Cliff on 14 acres and admitted “sick and suffering small children, whom hardly anyone else can take”.

Among the many notable names donating to this effort were Mrs. Andrew Carnegie, Daniel Guggenheim, Mrs. Otto Kahn, John Pierpont Morgan and Mrs. Cornelius Vanderbilt.

Our opening reception on Sunday,

September 28 will include readings from Jean Davis, Priscilla Waltz, D. Jen Dawson and others who will give a first hand account of what it was like to grow up in Sea Cliff.

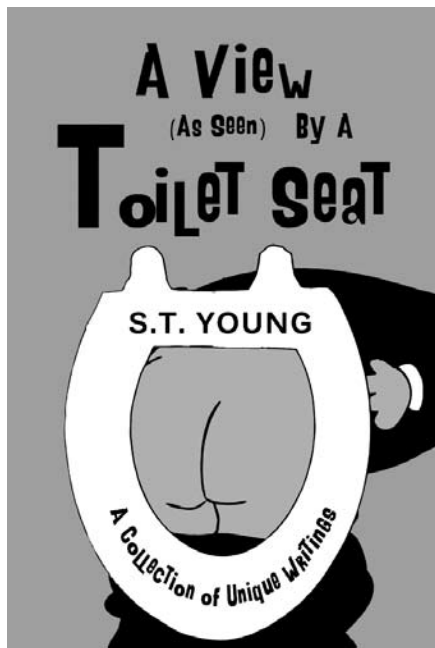
Local Sea Cliff Author Launches Unique Poem Book Displaying Superb Use Of Personification

Transferring Title of Your Home

The Question: Should I transfer title to my home to a trust or to my children?

The Situation: Many individuals want to know whether they should transfer title to their homes to a trust or to their children. The short answer is “it depends” upon your objectives and comfort level, among other potential factors. For many individuals, such a transfer may be a good idea provided it is properly structured. There are several valid reasons why a person may wish to transfer title to their home.



Possible Reasons For Transferring Title:

The possible reasons for transferring title to your home include probate avoidance, estate tax planning, Medicaid planning (i.e., nursing home protection), and ongoing management of the asset in the event of incapacity. Probate avoidance means that your estate will not pass through the courts. This typically means that there could be a savings, upon your death, in court costs and attorney’s fees. An estate that avoids probate typically passes quicker to the decedent’s heirs and the settlement of the estate is private as opposed to

a matter of public record. Avoiding probate is also a good idea if you anticipate your Last Will and Testament will be contested or if you own real property in more than one state.

Estate tax planning is another reason why some persons transfer title to their home. By transferring title to the home, you may save substantial estate taxes by removing the home and its future appreciation in value from your estate.

Medicaid planning (i.e., nursing home protection) is another reason why many people transfer title to their home to a trust or another person. Medicaid planning involves changing title to your home so it does not count as a resource or have a lien or estate recovery claim filed against it if Medicaid is sought to pay for long-term care at home, in assisted living or in a nursing home.

Ongoing asset management is another reason a person may put his or her home (or other assets) into a trust. Under this scenario, the person is typically the trustee of his or her own trust as long as the person has the mental capacity to serve. The trust language typically provides that if the original trustee loses capacity, another person or entity named as a successor trustee assumes control of the trust.

How It’s Done: There are different methods used to transfer title to a home. For example, a deed may be transferred to a revocable trust, irrevocable trust, or to a family member or other person outright or subject to a life estate. The best method to make the transfer can be determined after consultation with a qualified attorney. The wrong method can lead to the loss of the right to live in the home, and the loss of property tax exemptions, the capital gains tax exclusion, and the step-up in basis.

The Result: As you can see, there are many issues present when determining whether and how to transfer title to a home. Unfortunately, many people fail to properly transfer title resulting in tax and other problems that could have been avoided with proper professional advice.

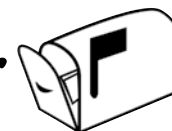

Attention All Glen Cove Residents It's Time To Stop The Overdevelopment Of Glen Cove

To The Editor,

The overdevelopment of Glen Cove is taking place right now but few residents are aware of the process. It is imperative that the public now becomes informed, vocal, and assumes an active participation, to ascertain whether or not each specific project will be an asset or a detriment to the community at large. The will of the people should be paramount and not disregarded. We did not choose to live in a suburb by the Long Island Sound, only to have it become transformed into a copy of Queens, because of the misguided vision of a few City officials in past administrations. The current administration will now have the opportunity to rectify this situation, thereby taking responsibility for its own actions. This is a disaster in the making. Those, who proclaim that Glen Cove needs more available housing to improve its finances, are ill-advised. For example, both Avalons and The Glen Arms, always advertise apartment vacancies. They have not positively affected our economy. The City grants developers and selective businesses, PILOTS (Payments in Lieu of Taxes), for a variable period of years, which are much lower than their normal local taxes. The shortfall must be absorbed into the property taxes paid by the City's homeowners, each year, for the duration of the PILOT. The Regency just had its PILOT extended for a period of 40 years, despite the fact that they have defaulted on their bonds that were used to finance it. Therefore, the Glen Cove taxpayer is subsidizing businesses, even though they are performing poorly. All legislation passed by the City of Glen Cove must be filed with the Secretary of State, by law. It has recently been discovered by watchdog residents that Glen Cove, over a period of years, neglected to follow that procedure. As a result, all legislation passed by Glen Cove during that time frame, which was not filed with the Secretary of State, is null and void. The City has been informed that the Master Plan and the zoning changes specified in Section 280 of the Zoning Amendments to the City Code, fall into that category. Therefore, the City cannot continue to allow these projects to be

built, based on laws that do not exist! It is a flawed concept to even discuss, no less vote, on projects that have no legal basis. However, the City is continuing to move forward to do exactly that. The Villa Project is scheduled to be voted upon, on Sept.30th, at City Hall. The Planning Board and the City Council will hold a joint meeting, at that time, which is open to the general public. The Villa project is to be located on Glen Cove Ave., on one of our only 2 corridors, proposes 194 units, and will be capable of housing approximately 776 occupants within a 2 block, narrow, curving strip of land, on a dangerously steep hill. The amended zoning law applicable to that location, (which is null and void), is called the RIO-GCA (Re-development Incentive Overlay - Glen Cove Avenue). Please attend this meeting. Your presence is essential and is an important show of force.

The totality of all the following projects would increase our population by at least 25%: The Villa (194 units), The Village Square Piazza (110 units), Carney St. Apts. (50 units), The Mews (72 Units), Garvies Point Waterfront Project (860 - 1110 units), North Manor Estates (Glen Cove Mansion - 46 units), and Sea Isle (8 units). There are also projects pending, under discussion: The Triangle (STAPLES), and the Konica Imaging and Photocircuit sites.

We need your help. It is up to all of us, - we the people - , to save our City. We must immediately take all necessary action to protect the value of our homes and quality of life, and to preserve Glen Cove as a suburban, waterfront community, with a country atmosphere. Do not allow it to be transformed into a huge mass of high density Queens style apartment complexes, with their associated problems, making our City unrecognizable. YOU can prevent that from happening, by contacting us to obtain additional information as soon as possible, to discuss the ways you may contribute to our mutual cause. Please refer to the contact information shown below. Time is of the essence. This week's celebrity, born in Los Angeles on Jan. 10, 1891, was an actress who appeared in 70 films and TV movies between 1928 and 1976. She attended Hickman Dramatic School in Washington, D.C. and once appeared with legend Will Rogers in a stage production of "Ah, Wilderness" at the Hollywood Playhouse. She was a character actress of the 1930s and '40s stage and film who played everybody's benevolent mom at one time or another. She was "Mother Adams" to Katherine Hepburn in "Alice Adams" (1935) with Fred MacMurray and "Ma" to Cary Grant's character in "My Favorite Wife" (1940) with Irene Dunne. Last week's celebrity was Miss Peggy Lee. She sang with Benny Goodman's band for two years, but in 1943, she married Dave Barbour, a guitarist in Goodman's band. According to her 2002 autobiography, she said, "David joined Benny's band and there was a ruling that no one should fraternize with the girl singer. But I fell in love with David the first time I heard him play and so I married him. Benny fired David, so I quit, too. Benny and I made up, although David didn't play with him anymore. Benny stuck to his rule. I think that's not too bad a rule, but you can't help falling in love with somebody". After a small "retirement" to take care of her newborn daughter, she drifted back to songwriting

an Academy Award nomination for Best Supporting Actress. In 1955, she was the voices for four characters in Disney's "Lady and the Tramp", the human "Darling", and the dog "Peg" and the two Siamese cats "Si" and "Am". She also wrote the "Cat Song" for that movie. Remember....purringly...."I am Siamese, if you please...." ding-ding? That was Miss Peggy's!

Lee continued to perform into the 1990s, sometimes in a wheelchair. After years of poor health, Lee died of complications from diabetes and had a heart attack on Jan. 21, 2002, at the age of 81. On her tombstone, the inscription read: "Music is my Life's Breath". In all their pomp and circumstance, in 2002, The Academy of Motion Pictures and Performing Arts neglected to add her face and name to the long list of celebrity

memorials at the Academy Awards that year. When the Academy was questioned by her family and fans, the answer was her film contributions were not lengthy enough to give tribute in that manner.... go figure.....ding-ding!

I read an interesting autobiographical novel a few weeks ago that has remained with me: *FLYING SHOES* by Lisa Horworth. The story opens as Mary Byrd Thornton is listening to an NPR newscast in her Oxford, Mississippi home as she waits for her children to come from school. The phone rings – the caller is a detective who has been studying cold cases and has just discovered who had

killed Mary's nine- year old brother over thirty years ago. Mary must appear in Virginia with other family members, but he will not reveal the killer's identity until they are all present. Mary has a paralyzing fear of flying so she embarks on a road trip to Richmond with a colorful array of friends. The novel takes place over one week and we soon realize this is not a murder mystery but a more a study of how people's lives are shaped by tragedy.
