Senior Moments

This column features a life-altering event that has had a great impact on a senior citizen's life, molding that person into who he or she is today. The people interviewed are all members of the Glen Cove Senior Center.

There are very few events in the history of the United States of which we, as a people and as a nation, should be ashamed. The era of slavery and its ensuing period of racism and segregation are the darkest events in the course of our development as a democracy.

It is impossible to imagine what young men and women, some mere children, had to endure. Wrenched from their families by bands of strangers; placed in leg irons and chains; packed into the dark, rat-infested bowels of ships; and fed ill-tasting gruel for days or weeks. Some survived the ocean crossing, some did not. Those who survived were placed on the auction block, their muscles, teeth and hair examined by perspective owners much as one would examine a prize bull or horse prior to purchase.

To understand Miss Jean, you must understand this horrendous period in our nation's history because she is the granddaughter of a slave. Miss Jean's grandfather unwillingly came to America to become the property of a land-owning Southerner. As other Southern slaves, he toiled in the fields from sunup to sundown. The work was back-breaking and the days were long and hot. On many plantations a whipping post was placed next to the weighing scales. If a slave did not pick his or her quota, he or she would be whipped. More often than not, slaves were mistreated for no reason at all. Slavery was abolished in 1865 with the ratification of the 13th Amendment. Like his father and siblings, her father, John Henry, worked the land many grueling hours every day despite being born a free man. Later her father worked for a construction company and her mother worked in the police department. Together her parents had eight children. Miss Jean is the second oldest child; having six sisters and one brother.

Miss Jean attended an integrated southern school. However, racism existed all around her. She was called names, spit at and had stones thrown at her. African-American children were taught from an early age to ignore the incessant taunts, to avert their eyes, and not to look directly at a white child or adult. Her nephew, Tilman, said that he did not experience racism or segregation. The only hateful incident he remembers is when the family moved into their new house someone burned a cross on their front lawn. Miss Jean dropped out of school in the ninth grade and, as so many people of color, worked the cotton fields from age fourteen to age eighteen. Picking cotton had to be done by hand and was labor-intensive. The cotton-pickers would drag burlap bags behind them in which to place

the cotton. The pickers were constantly stooping to reach the tufts of cotton. The plants were dry and often the edges of the pods holding the cotton balls would cut the pickers' hands. Later Miss Jean worked in a shirt factory which was not so labor-intensive. Miss Jean's experiences with racism and bigotry made her a strong, feisty and independent woman. Miss Jean married at 35 and moved Glen Cove. She worked at Pall Corporation for 12 years. She had eight children: two girls and six boys. Miss Jean is the matriarch of her family consisting of her eight children, 28 grandchildren; 46 great-grandchildren and 14 great-great-grandchildren. Her husband died

5 years ago. She has family here and in North Carolina but prefers to live in Glen Cove. Most days she can be found at the Glen Cove Senior Center. She is a moral woman who attends church regularly where she is an active volunteer.

Sharecropping was a system of agriculture instituted in the South during the Reconstruction era which followed the Civil War. Landowners had vast tracts of land but couldn't afford to hire farm workers. Millions of emancipated slaves knew only farm work and although they desired to become independent land-owning farmers, they had no money to purchase land, equipment nor seed. Plantation owners subdivided their land into smaller farms which were worked by former slaves who became sharecroppers. The landowner supplied the sharecropper with a cabin, seeds, tools and other necessary materials, even a mule. The cost for these items would be deducted from any monies the sharecropper earned.

At harvest time, the landowner sold the crop and deducted living expenses, the cost of the seed and other supplies. The remaining proceeds were split between the landowner and the sharecropper. After expenses the sharecropper earned little if anything. When the harvest was meager, the sharecropper fell into debt. Thus sharecroppers fell into a hole filled with debts from which they couldn't recover and were doomed to a life of pov-

erty.

Miss Juliette was raised in Florence, South Carolina, not far from Myrtle Beach. Her father was a sharecropper and her mother worked for the white women, cooking, cleaning and caring for their children. Her mother and father had 17 children in their blended family. They lived in the landowner's housing. It was a modest cabin with four bedrooms, a living room and a kitchen. The toilet was in a shed outside. On pleasant days the family ate in the yard under a big, old shade tree. Although several of her brothers and sisters were married and no longer living in the family house, Miss Juliette had to share a bed with two of

her brothers.

When Miss Juliette was two, the family moved to town where they rented a house. Her father had quit farming and got a job in a factory and her mother did housekeeping and, also, waitressed in a black restaurant. She attended school in a 3-room schoolhouse where grades were mixed together. "Separate but equal," more often than not, was separate but unequal. She remembers, vividly, going to segregated stores. Blacks were not allowed to eat in white restaurants. They could order food from these establishments, but had to go around to the back to pick up their purchases which they would eat at home. Many establishments had four bathrooms: two for the black males and females and two for the white customers. There were two water fountains: one for the whites and one for the "colored" folks. Little girls would admire the pretty dolls in the glass

showcases, but the young black children could not touch the dolls until after they were purchased.

Hospitals had two entrances: one in front for the whites and the other in the rear of the building for colored people. Within the hospital there were separate wards and ER rooms for the races. Black nurses could only treat black patients, never white patients unless there was a dire emergency. Miss Juliette could not understand why there would be two Baptist churches almost across the street from one another when one church should be enough.

The white children would be bused to their local high school while the black children had to walk quite a distance to their school. Many black children quit school, worked on farms and got married. Miss Juliette is exceptional in that she paid for and attended business school in Williamsburg. For two years she worked afternoons for three lawyers as part of the curriculum. After business school Miss Juliette worked for the State in the Department of Mental Hygiene for ten years.

She met and married a young man from Baltimore and together they moved to Elmont in 1974. They had four sons, two of whom are now deceased. Moving to the integrated North did not help the family escape racism. Her sons were victims of taunts and bigotry and illegal discrimination in housing. In the South racism was overt and evident; in the North racism was subtle and covert. In 1978 she got a job with the Town of Hempstead's Department of Parks and Recreation where she continued to work for 29 years. The Deputy Commissioner, who was her boss, was also a referee for professional boxing matches. Through him and Hempstead's boxing program, she met Sonny Liston and Mohammed Ali.

Miss Juliette moved to Glen Cove in 2009. Her rental agent told her about the Senior Center which she joined in 2010. She can be found at the center five days a week enjoying various activities, socializing and eating lunch with friends. She enjoys the challenges of the fitness computer and activities with the Brain Booster Club. She is a member of the Happy Hour Club and the Centre Club, participating in their many trips. On Tuesdays and Wednesdays one can find her engrossed in the Bingo games. To find her, just look for a happy woman with an engaging smile.

Opening Day Staff Convocation in Glen Cove

Glen Cove Superintendent of Schools Maria Rianna warmly welcomed faculty and staff back to school at the district's Opening Day Staff Convocation, which was held at Glen Cove High School, prior to the first day of school.

During the ceremony, Rianna reflected on her comments from last year's Superintendent's Day Conference, the first for her at the district's helm.

"Last year I said I was honored to be your superintendent, but I was never more honored than I am this morning," she said. "You are dedicated to this community and to the children in this community. You're amazing."

The superintendent also shared her personal focus for the upcoming school year.

"My focus is our children," Rianna stated. "What can we do to enhance their success? The answer is simple — continue to work together to ensure that every student is provided with a program that meets their needs and goals. And how do we do that? What makes the difference? You sitting before me, you are there each day with our children working hard to deliver the instruction that makes learning occur."

A highlight and annual tradition of the event was the recognition of faculty and staff with years of dedicated service to the school community. The most senior personnel honored were Edna Barr, a senior account clerk at the Thayer House, with 40 years of service; and Rosemary Tripp, a computer monitor at Connolly School, with 45 years of service. Tripp received a standing ovation from her colleagues.

original Broadway production of "The Skin of Our Teeth". Later, in 1943, a Warners Bros. producer, Hal B. Wallis, discovered our celebrity at her 21st birthday party held at the Stork Club in NYC. Wallis scheduled an interview with our celebrity the following day, but she cancelled it when a telegram asked her to replace Miriam Hopkins at the Boston production of "The Skin of Our Teeth". Through several more misguided decisions, she eventually signed with Paramount. She appeared in 21 films between 1945 and 1957, though she was loaned out for half of her films to United Artists, RKO, and Columbia. Her first film was "You Came Along" (1945) with Robert Cummings, as her leading man. The role was originally intended for Barbara Stanwyck. Despite her difficulties with Director John Farrow, who lobbied for Teresa Wright, the film remains one of our celebrity's favorites. In our celebrity's second film and despite the fact the two female leads had only one brief scene together, Stanwyck protested the use of our celebrity by Wallis in "The Strange Love of Martha Ivers". Our gal ended up in third place at the top behind Stanwyck, Van Heflin, with Kirk Douglas, in his film debut, billed below the three stars. The director, Lewis Milestone, swore he would never work with Wallis again, who wanted to re-shoot all of our celebrity's scenes, which Wallis had to do personally. Despite all the conflict, the film had four Oscar nominations for music, costume, art direction and screenplay.

This week's celebrity was born in Scranton, Pa. and will celebrate her 92nd birthday on Sept. 29th. She is one of the few silver screen actresses still with us. She attended Marywood Seminary and the Alviene School of Theater in NYC, where she adopted her stage name. After doing a national tour of "Hellzapoppin", she was discovered by Broadway producer Michael Myerberg, who, at the time, owned the Mansfield Theatre, from 1945 to 1974, at 256 West 47th St., now known as the Brooks Atkinson Theatre. By the way, the Chanins brothers built the theater in 1926 and it had mostly been in the dark, until they lost the venue to foreclosure in 1933 and Myerberg purchased it. He leased it to CBS-TV until 1960 and it played host to the long running panel games shows "I've Got A Secret" and "What's My Line?". When Myerberg died in 1974, the venue returned to theatrical use and renamed after NY Times theatrical critic, Brooks Atkinson. Myerberg used our celebrity as the understudy for Tallulah Bankhead in the

Sea Cliff's own Kristen Henderson and Nini Camps and the rest of the band gave an unforgettable performance at Sea Cliff Beach and I do have a great book for you to read while waiting for Silly Shakespeare to begin: THE LIAR'S WIFE by Mary Gordon. This- her latest work- is a collection of four novellas each about seventy pages long, all connected by a search for truth.

In "The Liar's Wife" an older, affluent woman meets her ex-husband after fifty years and learns about the person she has become; in "Simone Weil in New York" a young mother meets her teacher, the legendary mystic, and questions her earlier devotion to the woman. In "Thomas Mann in Gary, Indiana" a ninety year-old man looks back on the finest day of his life- the day in 1939 he was chosen to introduce the famed writer Mann to his high school class- the day in which he began to question the truths his family and community lived by. In the final piece "Fine Arts" a young woman travels to Europe to study the artist Civatali's sculpture and discovers the depth of her passion for truth. A poignant commemorative 9/11 Dedication Ceremony honoring September 11, 2001 was held at North Shore High School in memory of those who lost their lives and all the heroes of that tragic day thirteen years ago. To begin the ceremony, P.O. Joe Paolillo lowered the flag to half-mast in honor of his brother John, a firefighter who perished on 9/11, as well as all the brave men and women who will forever be in our hearts. Superintendent Dr. Edward Melnick, Board of Education Vice President, Antoinette Labbate, and SC Principal, Chris Zublionis, reflected on the significance of 9/11, explained how the nation came together, and reminded everyone to continue to educate our students since so many of them were

so young at the time of this tragedy.

Dr. Gerver then highlighted the steps that he took to receive the artifact and how proud he was that his students, fellow teachers, and community members came together and collaborated to complete this special project. He also spoke about his love of history and how this "twisted piece of metal signified strength." He communicated that it represented a significant piece of history for our students to admire and reflect upon now and in a century from now.

Many students and residents participated in the heart-felt ceremony including Emma Haley who beautifully performed the National Anthem and Paulina Calcaterra, SGO Co-President, who rang the school house bell 13 times. Kevin Lynch and Nicholas Harman played a beautiful version of Taps to conclude the ceremony.
