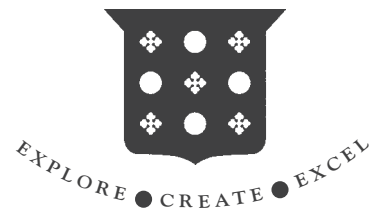

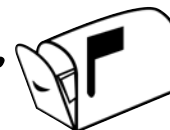

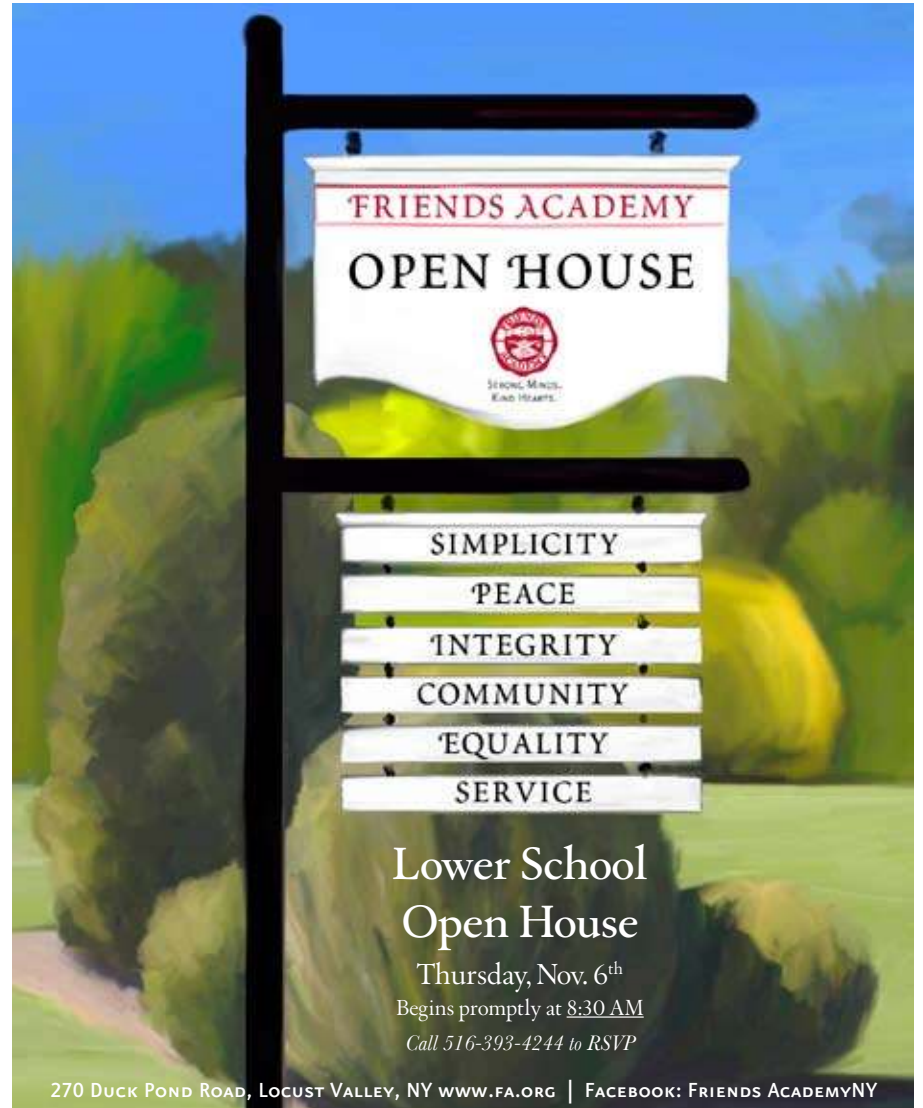

Name the Celebrity



her difficulties in establishing a career as a leading actress were often attributed to a long-standing feud that our celebrity had with powerful, studio-feared, gossip columnist, Louella Parsons. Our celebrity's husband, Tom Wood, a journalist and author of "The Lighter Side of Billy Wilder" once wrote a magazine article which was very critical of Parsons. M-E-O-W!

She did have some supporting roles along the way, but not until the 1941 John Huston film "Maltese Falcon" did she receive her well-deserved attention. She appeared as "Effie Perine", the loyal and quick thinking secretary of Humphrey Bogart's "Sam Spade". This was our celebrity's most enduring film characterizations.

This week's celebrity was born on Nov. 22, 1901 in New York City. She began acting on Broadway in 1924 and for more than a decade, was constantly employed. She established herself as a popular actress and appeared in the original 1929 production of "June Moon" by George S. Kaufman and Ring Lardner. She reprised the role in the 1933 revival. In 1937, she performed in the original Edna Ferber and George S. Kaufman play "Stage Door". She was recruited by RKO to reprise her role in the film version. The film was adapted by Morrie Ryskind and Anthony Veiller but the play's storyline and the characters' names were almost completely changed for the movie. This eventually led to our celebrity's part to be rewritten and split from a single character into two characters which were played by Katharine Hepburn and Ginger Rogers. Kaufman joked the film should be also changed from "Stage Door" to "Screen Door". The reason RKO gave for the dropping her role was that since she had made her first film in 1929, she had not appeared in a single film. RKO was reluctant to cast an unknown actress for a film which they were beginning to realize had great potential. Her disappointments continued when she was considered and then rejected for the lead role in "Stella Dallas" (1937) in favor of Barbara Stanwyck. Sounding like radio personality, Paul Harvey, "the rest of the story" was that

Last week's celebrity was Sue Ane (correct spelling) Langdon. After her film debut with Tony Curtis in "The Great Imposter" (1961), she went on to have leading roles in films such as "The Rounders" (1965) with Glenn Ford and Henry Fonda, "A Guide for the Married Man" (1961) with Walter Matthau and Inger Stevens, and "A Man Called Dagger" (1967). She was the third actress to play "Alice Kramden" in Jackie Gleason's "The Honeymooners" sketches and shows, preceded by Pert Kelton and Audrey Meadows and followed by Sheila MacCrea and then Meadows again. She appeared as "Kitty Marsh" during the NBC portion of "Bachelor Father" show with John Forsythe. Other TV shows she appeared in were: "Bonanza", "The Andy Griffith Show", "Perry Mason", "Gunsmoke", "Room for One More", "McHale's Navy", "Ironside", "Banacek", "The Wild Wild West", "The Dick Van Dyke Show", "Three's Company", and "Happy Days", to name a few. Sue Ane, 78, was married to motion picture, stage and TV director, Jack Emrek, from 1959 until his death on April 27, 2010.

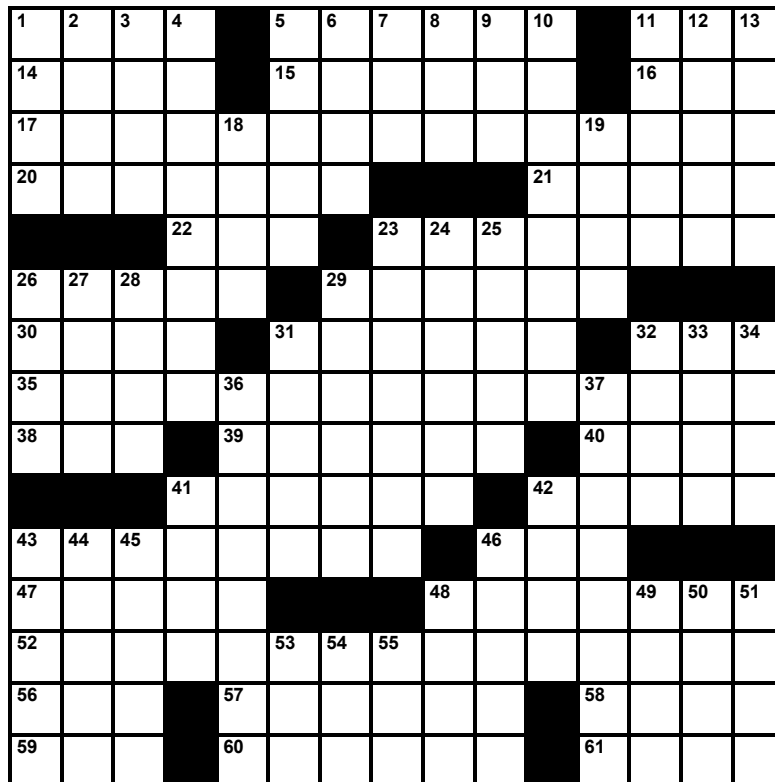
