# Mayor's Column

**From the Desk of Mayor Reginald A. Spinello**

The 2015 Proposed Budget— The 2015 proposed budget is a fair and reasonable budget which allows us to make good use of what little the city has in revenue while highlighting the benefits of prudent expense management. The tax levy is increasing by 1.64 percent. In this instance that translates to a property tax increase of \$38 for a home with an assessed value of \$500,000. Commercial property taxes are going DOWN \$80 for every \$500,000 of assessed value. Residents who qualified for the STAR program will get the refund sometime next fall. Some highlights of the proposed 2015 budget: we budgeted \$200,000 for tax certs and termination pay but it only

represents a portion of what's needed for the 2015 year. Our revenues reflect a budget that does not over-state the revenue or under estimate the expenses. We are able in 2015 to use revenue from the proposed sale of land on East Island as well as from the settlement of outstanding court cases. In addition to helping us on the revenue side, it gives us an opportunity to lower our legal cost projections because cases that were active for years and carried great legal expenses will no longer exist. Additionally, with the help of the Controller we were able to identify almost \$300,000 in "left over" capital funds and apply that money toward reducing the our debt service requirement. A savings of 1% tax increase was realized by this transaction. (Every \$290,000 in expenses increases the tax levy by 1 percent). Salary and overtime this year are projected to end the year at or below budget. Our cash flow was managed well, resulting in no need for short term borrowing which will result in a reduction in our stress level by the State Comptroller next year. Our Voluntary Separation Incentive Package created job opportunities, promotions and will reduce the payroll costs in 3 departments for the 2015 year. We achieved all of these things without cutting services and without layoffs. In fact, most residents have commented that our services

have improved. We still have a long way to go, but I am confident that we can get to a much better place financially if we continue to manage our expenses, grow our revenue base, and better utilize our under-performing assets. The City Council will be voting on the budget Tuesday, Oct. 28.

**Illegal Housing**— The City continues to aggressively and successfully combat illegal housing. Thanks to the public's response to our request for information, and the combined efforts of the Department of Code Enforcement, our special investigator and the City Attorney's office, we have commenced a record 8 prosecutions this past week! These prosecutions involve violations including overcrowding, use of the property inconsistent with the applicable zoning regulations, and basement apartments. Those prosecuted include homeowners who live in one part of the home while renting out other portions, tenants involved in subletting, and absentee landlords. In addition, to combat illegal housing which decimate our neighborhoods and jeopardize safety, we adopted new policies which include the following: mandatory prosecution in the instance of cellar and/or attic habitation; removing the discretion on housing matters from code enforcement officials and placing the decision on whether or not to prosecute with the City Attorney; an addition to the City Code called "presumptions" which address possible illegal housing conditions based upon sightings from the exterior of a home. We have also implemented a stipulation that desk appearance tickets may be issued to the occupants of illegal housing. There will be no plea bargains unless and until there is proof of compliance with city code--all pleas are conditional and require that compliance be maintained. The City presently has five pending prosecutions against one single (corporate) landlord that owns approximately 20 properties throughout Glen Cove. **CPU Implemented**—Our Police Department's Crime Prevention Unit (CPU) was recently appointed. It is an undercover, anti-crime unit staffed with two

members of our department. CPU is comprised of one detective and one officer, both of whom were chosen based on their proven track record of activity and resourcefulness. To accomplish their goals, both overt and covert methods of investigation will be implemented with a specific focus on people who choose to sell or use drugs in our community.

**Trick or Treat this Weekend**—On October 25, the Business Improvement District is once again sponsoring a Children's Halloween Parade on School Street. At noon there will be a Scary Story Hour at The Regency Assisted Living, 94 School Street. Parade registration is from noon until 1 p.m. The parade will step off at 1 p.m. from the corner of School Street and Highland Road. Children are encouraged to wear their costume and may trick or treat after the parade at Downtown BID stores displaying a participation poster. After the parade in Village Square, from 1 p.m. until 3 p.m. everyone can enjoy a special appearance by The Maniac Pumpkin Carvers; the Fun Bus; a costume contest sponsored by Christina Mercurio, DDS; a pie-eating contest sponsored by the Downtown Café; cocoa by Starbucks and pie bake-off contest. 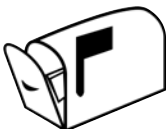

# From Dream To Reality

## Grand Opening Of The North Shore Schools Victorian Communications Center

Almost a decade ago, the dream of building the Victorian Communications Center at the North Shore School District began when Superintendent Dr. Edward Melnick approached Technology teacher Bruce Fichtman with an innovative idea of renovating an existing classroom at the high school into a student operated communications studio. Mr. Fichtman said, "I countered Dr. Melnick's proposal with the vision of designing a Victorian-style building from scratch with my students in the LI Studies (LIS) Program that would be located on school grounds." He continued, "The Victorian house construction tied in perfectly with our Long Island Studies curriculum, in which high school seniors study in-depth local history and literature and then take on the multi-year task of building a usable structure that represents our rich North Shore history."

On September 18, 2014, the dream became a reality as the Viking Foundation joyously celebrated the grand opening along with past and present Board of Education members, administrators, faculty, staff, students, and numerous North Shore community members. Dr. Melnick welcomed everyone in attendance and whole-heartedly thanked the many people involved. He stated, "This was a wonderful, collaborative effort made possible by the generous financial support of the Viking Foundation along with Bruce Fichtman and local citizens who shared their craft and expertise with our students and faculty." He proudly added, "It truly exemplifies project-based learning at its best – the kind of learning that our students will remember forever."

Dr. Melnick summarized that this beautiful communications center located at the front entrance of the North Shore High School campus will provide a rich and authentic interdisciplinary experience in multimedia for our students now and in the future. The curriculum will include the following: the study of broadcast journalism, pre/post production of digital video editing, camera, lighting, and composition, the development of screenplays and storyboards, student produced documentaries, short films and newscasts, in-house interviews with selected guests, the broadcast of sporting and theater events via the internet, student operated internet radio station, and the development of music videos."

Mr. Fichtman said, "My students and I were so lucky and thankful to have the opportunity to work alongside numerous local community members for the

past seven years. Masters of their trade, these volunteers acted as both mentors and teachers to our students, providing authentic learning experiences that are not found in any standard textbook."

He proudly proclaimed, "Today, I congratulate all 325 students in the LIS program who worked so hard over the past ten years on this project. You should feel very proud of your accomplishment. It is with great pride that I look at this studio, knowing that it was built by student hands. The structure and everything it encompasses is a testimony to the value of a progressive, rigorous, interdisciplinary program in the North Shore School District."

At the ceremony, other speakers in-

cluded Viking Foundation Board Member, Mr. Phil Como, President and CEO of Bethpage Federal Credit Union (a major contributor), Mr. Kirk Kordelski, and North Shore High School Principal, Albert Cousins. Mr. Como discussed the involvement of the Viking Foundation and passionately reminded everyone of the numerous community members and alumni that came forward to donate to this project. He stated that, "It is a strong indication of what type of education the North Shore School District represents." He added, "The North Shore Schools is one of the best school districts in the state and across the nation. More than 175 students entered kindergarten this year and will have access to ample resources along with the dedication and commitment of our entire faculty and staff. 13 years from now these children will be better prepared to embark on their next step in life."

Shore Schools and looks forward to the production of a new TV commercial for his company in the near future!



In what ways is dance class beneficial

for children with special needs? Carol Greenstein, parent of Hannah, age 6, Down syndrome: Dance class is beneficial because it is social, fun, and gives children a way to express themselves. Hannah loves to move to music, it makes her happy.

Michael O'Donnell, father of Kiera, age 6: Dance aids with body awareness or a comfort with/understanding of one's abilities. Dance also helps with confidence and social skills. ### Last Week's Celebrity

Last week's celebrity was Lee Patrick. The same year, after her success in "The Maltese Falcon" (1941), Warner Brothers tried to market her in a murder mystery series, as a crime-solving nurse, which was a popular studio action based on the past successes of series winners such as "The Thin Man", "The Saint", "The Whistler", and Edna Mae Oliver's "The Miss Hildegard Martha Withers" series. Unfortunately, it didn't catch the public's attention. She had already appeared in films such as "The Sisters" (1938) with Bette Davis and worked with her again in "Now, Voyager" (1942). She also did "Mrs. Parkington" (1944) with Greer Garson, "Mildred Pierce" (1945) with Joan Crawford and "Vertigo" (1958) with Jimmy Stewart. As TV came into popularity, she appeared in Ida Lupino's "Mr. Adams and Eve", and Walter Brennan's "The Real McCoys". She is probably best remembered as the flighty "Mrs. Cosmo Topper" with Leo G. Carroll, Anne Jeffreys and Robert Sterling on CBS TV's "Topper" based on Thorne Smith's book, which was made into the 1937 film, of the same title, with Cary Grant, Constance Bennett and Billie Burke as "Mrs. Topper." Patrick died suddenly of cardiac arrest four days after her 81st birthday on Nov. 26, 1982.

What a great show and I just heard it will be performed again in November. Daniel DiPietro recommended *A REPLACEMENT LIFE* by Boris Fishman last month and I enjoyed it immensely. It is the slyly humorous and moving story of young Slava Gelman, an undervalued junior editor for a New York magazine who is convinced by his grandfather to

write a restitution request for World War II reparations from the German government. Huge problem- the old man has no basis for the claim, so Slava must use details from his deceased grandmother's horrific wartime experiences. Soon he finds himself writing dozens of these life stories for neighbors and friends. The lines between truth and fiction cross while Slava struggles to reconcile loyalty to family, aversion to fraud, fear of deportation, and a growing pride in his writing. Colorful characters and love interests abound but the novel's greatest attraction for me lay in its portrayal of South Brooklyn's Soviet émigré community. Highly recommended!
