Mayor Spinello Visits with Pre-K Children at SLCD



Mayor Reginald Spinello accepted an invitation to visit with the Pre-K children at the School for Language and Communication Development in Glen Cove. The school recently received grant funding from the State and is able to provide free Pre-K classes to our community's children.

Guns and drugs seized during search warrant

On November 6th the Glen Cove Police Department executed a search warrant at 23 Ravine Ave in the City of Glen Cove. At that time 22 year old Josue Escobar was arrested while he was leaving his residence. According to Det. Lt. John Nagle, The defendant was arrested and charged with three counts of Sale of a Controlled Substance 3rd degree, one count of Criminal Possession of a Controlled Substance 4th degree, and four counts of Possession of a Controlled Substance 3rd degree. During the subsequent search of the house, Glen Cove Detectives recovered a loaded 45 caliber pistol, 48 grams of cocaine, 73 grams of MDMA, digital scales, and materials commonly used to package drugs. Detectives also

recovered over \$42,000 in cash. After the completion of the search warrant the defendant was also charged with Criminal Possession of a Controlled Substance 2nd degree, Criminal Possession of a Weapon 3rd degree, and Criminal Possession of a Weapon 2nd degree. The defendant currently resides at 23 Ravine Ave with his parents, his wife, and their 15 month old son. According to Detective Lieutenant John Nagle, "the newly re-manned Crime prevention Unit consisting of Detective Brain Glennon and Officer Eddy Linares targeted the residence after getting information that illicit drug sales were taking place out of the residence there". The defendant will be arraigned in First District Court on November 7th.

Ballet In Our Backyard

Almost every ballet school performs a Nutcracker. "This is a tradition for ballet, like the Super Bowl is for football," says Irina Lebedeva, the artistic director of the Long Island Ballet Academy & Dance in Sea Cliff. Lebedeva's dancers will preview "the Party Scene" from this year's production at Sea Cliff's Christmas Tree Lighting on December 7 at 5 p.m.

Russian ballet is in itself a Sea Cliff tradition. Lebedeva is the third Russian director of the studio, which is on Glen Avenue. Kaleria Fedicheva, a prima ballerina and three-time gold medalist, opened the studio after moving from Russia to the United States in 1975 with her son Ivan. "When my mother came to America she naturally wanted to open up a school," explains Ivan, "and because Sea Cliff has such a high Russian population it was just a natural place to be." Fedicheva bought the property, which Ivan says then included "a basketball court that was all overgrown," from St. Boniface. "The floor is a professional ballet floor that is easy on the joints," says Ivan. "You don't hurt your back when you're doing jumps." Fedi-

cheva taught every day except Sunday, and a lot of her students went on to be very well known. "She was a true, honest, loyal friend to the ballet," says Ivan. "More than anything else, I want her to be known as someone who did it for the art and never for the money."

After Fedicheva died in 1994, Lebedeva continued in her tradition, reopening the studio in 2006. Like Fedicheva, Lebedeva trains students in the Vaganova method of classical ballet. Ballet stars trained in this leading method include Mikhail Baryshnikov. Lebedeva was a

principal dancer at Ballet Festival Moscow, and since defecting to the U.S. in 1990, has performed and taught with the Eglevsky Ballet and has led seminars and classes in 28 states. "I think [my mother] would be happy and proud that the tradition still lives in Sea Cliff," says Ivan.

Tobacco Kills Too Many Vulnerable New York Youth

Great American Smokeout Spotlights Pressing Need to Help Change the Odds

The Great American Smokeout is an annual reminder that quitting smoking is critical for good health. Sadly, the most at-risk populations in New York haven't been able to quit on this day or any other. The use of Tobacco is still the leading cause of preventable disease and death killing nearly 24,000 New Yorkers every year and afflicting nearly 600,000 New Yorkers with serious disease directly attributable to their smoking. Tobacco is not an equal opportunity killer – there has been no reduction in smoking rates among low-income adults, adults with poor mental health, and those with less than a high school education.

The School Committee of SAFE Inc.'s PRIDE Project Coalition will continue their partnership with the Tobacco Action Coalition of Long Island to address these concerns on Thursday, November 20, 2014 in celebration of G.A.S.O at the Glen Cove High School with students by bringing their attention to reducing their exposure to Tobacco Marketing. The Coalition is Co-Chaired by Anthony Gallo, GC HS Health Education Teacher and the School Committee is chaired Denise Kiernan-GC SD Director of Health, Phys Ed & Athletics.

Executive Director-Dr. Sharon Harris said, "SAFE's goal is early intervention and prevention education." Dr. Harris continued, "According to the 2014 Bach Harrison Prevention Needs Assessment Survey, Glen Cove's youth showed a rise in lifetime and 30-day Tobacco Use.

Lifetime cigarette use continues to rise into the 10th grade (18.8%) and 12th grade (39.3%)."

The American Cancer Society, sponsor of the annual Great American Smokeout, estimates that 30 percent of cancers could be avoided if people stopped using tobacco. Quitting smoking is the single most important step you can take to reduce your risk of cancer and improve your health.

Per Carol Meschkow-TACLI Nassau Project Coordinator, "For our youth, reducing initiation is the greatest weapon in the effort to prevent addiction. The New York State Tobacco Control Program continues to focus their efforts on youth for a very clear reason. 90% of smokers smoke their first cigarette by the age of 18. It is during these formative years that our youth are most vulnerable to Tobacco Marketing especially at the Point-of-Sale and we are grateful to partner with SAFE and their Coalition Members to prevent the next generation of smokers." SAFE's Board and Executive Dr. Harris do an incredible job of bringing together all of the community stakeholders on behalf of their local youth".

Tuscany Press Announces 2014 Short Story Winners

Winners Include Sea Cliff Author

Sea Cliff author Margaret Gay Malone is one of 11 authors whose short stories have been selected for publication in the Tuscany Press Anthology in 2015. The story centers around a boy whose generosity and selflessness put him in danger on a brutally cold and snowy day.

Margie, as she is known, is the author of nine children's books and a romance novel. She is currently working on another novel.

According to Tuscany Press, with a 40% increase in submissions, this year's Tuscany Prize short story winners number eleven, which represents an increase over the number of stories that was published last year. The age and background of the Catholic authors are as diverse as the stories themselves.

"We are amazed with the depth and breadth of these wonderful short stories," said Peter Mongeau, founder of Tuscany Press, which offers the Tuscany Prize. "It's inspiring to think that we may very well be on the cusp of a great Catholic literary revival."

The authors will receive cash prizes totaling over \$3,500 with the top story winning \$1,000, double the amount of last year's prize. 4 boiled chestnuts, chopped (split, baked 15 minutes and removed from shell)
1 lb. chopped meat (beef or turkey or sausage)

1 medium raw grated sweet potato
1 medium chopped onion
1 apple peeled and chopped

Use your favorite pie crust recipe for 1 pie

5 large sweet potatoes peeled and cut into big cubes
Water to cover sweet potatoes, not extra
At least 1 tsp salt in water
1/4 cup honey or sugar added to water and potatoes
1/2 cup heavy Cream
1 cup sugar or more to taste
2 tsp vanilla
1/2 tsp nutmeg
1/2 tsp salt
3 large eggs

Boil till very soft. Mash and measure out 2 cups, more is ok too. Add sugar and keep on mashing till no lumps, add heavy cream, seasonings keep mashing. Add eggs one at a time and mash in. Don't over mix, the pie will be too puffy if you over mix eggs. Pour into your prepared pie crust and bake at 375 degrees till puffed and firm. About 30-35 minutes. Cool.

Don't Blame The Guy Who Got Stuck

To The Editor,

It's a fact of political life that a newly elected public official inherits the history of his or her predecessor. If the predecessor is an incumbent who is removed from office in an election, it's almost always the case that he or she got tossed out for a reason. In the broadest sense it's generally because voters finally came to the conclusion that the predecessor did a lousy job. The election of Reggie Spinello to replace Ralph Suozzi is just such a case. Had the voters believed that Mr. Suozzi was doing a decent job as their mayor, he should have easily been reelected after four terms in office. But he wasn't, and now Mr. Spinello has inherited Mr. Suozzi's mistakes.

One such mistake with which Mr. Spinello is now stuck is an amendment to the City Charter enacted in August, 2010 while Mr. Suozzi was running the store and before Mr. Spinello was elected to the City Council. Specifically, the amendment is Section 280-73.3 entitled "Glen Cove Avenue Redevelopment Incentive Overlay (RIO-GCA) District." It's commonly known as the "Villa Project" over which so many neighbors are now up in arms in their opposition to its development.

Stated simply, on its face, the enactment of the RIO-GCA District does not pass the "smile test." It's a bizarre piece of legislation passed by Mr. Suozzi and his City Council which looks more like the product of a contract negotiation with a developer that was turned into law. Every interested resident of Glen Cove should take the time to read it.

The RIO-GCA legislation permits a developer to have density bonuses (i.e., the right to build extra housing units over the amount otherwise permitted by law) by adding structured parking (parking inside the building), streetscape improvements (who knows what that really means?) and on-site recreational amenities (like a pool for the residents of the project).

Aside from the fact that these requirements just don't make sense as a basis for increasing the number of potential residential units from less than 100 to more than 200, Mr. Suozzi and his City Council built in to the zoning law a highly unusual, and therefore highly suspect, exception to the requirement that the developer actually build these extra amenities in order to get the right to build extra residential units. The Suozzi & Co. law actually provides that in lieu of creating these amenities, a developer can simply pay cash to the City as an alternative to get the right to double the number of units that can be built.

So, let's suppose a developer wants to build an extra 100 units. And let's also suppose that the developer can make a profit of \$100,000 per unit. That's \$10 million dollars of additional profit. Let's

suppose further that it would cost \$5 million dollars to build all of the amenities, but the developer could just pony up, say for example, \$3 million in cash to the City to get the right to construct the additional 100 units. Under those circumstances, why in heaven's name would any developer spend \$5 million when a cash payment \$2 million lower would give the developer the same right to build excess units?

Here's the kicker. The ordinance provides that it's the City Council which determines how much the developer has to pay in cash to get a waiver on the density of the project. It could be \$10 million or it could be a dollar. The problem is that if the City Council makes the price too high, it's almost a guarantee that the City will wind up in court over the issue and some judge may decide how much Glen Cove is going to get paid for allowing excess residential units to be built.

The bottom line is that Mr. Spinello is now stuck with Mr. Suozzi's crazy zoning ordinance and he's got to figure out how best to keep Glen Cove from getting hurt once the current developer starts beating the City over the head with the zoning club given to him by Ralph Suozzi and his City Council.

Public Hearing 11/5/14

To The Editor,

Many of us remember with sadness and outrage when the Grandfather Trees in front of the Library were torn down. That change to the street, done in the name of "development" has made it difficult and dangerous for us to use our Post Office. Our current Mayor and Council would be well advised to remember that the removal of the trees were a big factor in why Mary Anne Holzcamp lost the election. As a result of this, the City of Glen Cove Tree Ordinance was passed. According to the Tree Ordinance, shown on the City of Glen Cove website, it is required that a meeting be held with the Tree Commissioner and a member of the Planning Board and a written report be made showing all the trees planned to be torn down. A fee of \$1,000 per tree of a certain size is to be paid and a fine of \$50,000 can be levied for non-compliance. One of the big issues with the proposed Villas development is the the plan to tear down very many trees. Many people know that trees hold the hillsides. The applicant is asking for a waiver of the Hillside ordinance. I would urge the Council, the Mayor and the Planning Board to deny this waiver. I would also ask our Mayor, has there been a meeting with the Tree Commissioner and the Planning Board, and if so, the report, which is required under the Tree Ordinance, should be made public. If this has not been done, I would like to ask our Mayor, is it going to be done, and if so, when? If this is not done, I agree with one of the speakers at the meeting

of 11/5/14, the sign at the entrance to town "Glen Cove is a Tree City" should be removed, and the City should decline membership in the organization which designates a City as a "Tree City".

The applicant has also requested a waiver of the City's requirement to include affordable housing. I would urge that the Council, the Mayor and Planning Board to pay attention to the many speakers who spoke for the need for affordable housing and not agree to the requested waiver. I agree with Reverend Williams, "This is a moral issue."

The other matter being voted on is density. The issues of overcrowding and Queensification are very upsetting to those of us who have invested in Glen Cove and who always pay their taxes on time. In order to invest in Glen Cove, we had to pass a credit check. One of the speakers presented the fact that the applicant has poor credit and poor business references. The applicant claims that he has not paid the \$300,000 he owes in City taxes because he is in process of grieving his taxes. A taxpayer is not permitted to hold back on paying because he is grieving his taxes. Until he pays the taxes he owes, the City should not

grant him any consideration in the form of waivers. At the same time he is asking for a favor to be granted to him, Mr. Livingston actually said that many of the people who spoke in disagreement with his plan were "irrational". I do not see how the Council, the Mayor and the Planning Board can allow that gigantically insulting remark to stand.

We are concerned that the additional density will require us to pay for a full-time paid Fire Department and EMS. It is clear that the proposed stacked garages are a fire hazard to all of us living near this proposed development. Will we need to pay for yet another new well? The City of Glen Cove has consistently allowed high density development without making the slightest improvement to our roads. We do not have the highway infrastructure to support all these extra cars.

I would urge the Council, Mayor and Planning Board to pay attention and listen to the people who took the trouble to come out and speak against this proposed development. We can vote in Glen Cove, Mr. Livingston cannot.

Last Week's Celebrity

Last week's celebrity was Martin Balsam. He made his professional debut in August 1941 in a production of "The Play's the Thing" in Locust Valley. His entertainment career was interrupted by his service in the U.S. Army Air Force during WWII. In early 1948, he was selected by Elia Kazan to be a member in the recently formed Actors Studio. Among his other films, he was in "Breakfast at Tiffany's (1961) with Audrey Hepburn, "The Carpetbaggers" (1964) with George Peppard, "Tora, Tora, tora!" (1970) with Joseph Cotton, "The Taking of Pelham One, Two Three" (1974) with Walter Matthau, "All the President's Men" (1976) with Robert Redford and Dustin Hoffman, and "Murder on the Orient Express" (1974) with Bette Davis and Angela Lansbury. He was also in the original 1960 "Cape Fear" with Robert Mitchum and Gregory Peck and Martin Scorsese's 1991 remake. In 1965, he won an Academy Award for Best Supporting Actor for his role as "Arnold Burns" in "A Thousand Clowns". In 1968, he won a Tony Award for his appearance in the 1967 Broadway production of "You Know I Can't Hear You When the Water's Running". On the big screen he will probably be best remembered in the role of "Detective Milton Arbogast" on the stairs of the Bates Motel in Hitchcock's "Psycho". On TV, he fit right in with Carroll O'Connor in his role as "Archie Bunker's" business partner, Murray Klein, on the "All in the Family" spin-off, "Archie Bunker's Place." He passed away at age 76, on Feb. 13, 1996, from a stroke, in Rome, Italy.

This week's celebrity was born on June 30, 1898 in Waukegan, Illinois. After high school, he first joined the military and served during WWI. Upon completing his service, he went to study at the University of Illinois. During his college years, he performed as a violinist with a jazz band to help support him financially. He worked in vaudeville and by 1928 he broke into the film industry. Some of his early roles were in two-reel comedies such as "The Fatal Glass of Beer" (1933) with W.C. Fields and graduated into more substantial films such as "Libeled Lady" (1936) with Jean Harlow, Myrna Loy, and Spencer Tracy, Fritz's Lange's "Fury" (1936) again with Spencer Tracy, "Roxie Hart" (1942) with Ginger Rogers, Director Paul Henreid's murder thriller, "Dead Ringer" (1964) with Bette Davis and Karl Malden and "Every Which Way but Loose" (1978) with Clint Eastwood. He had numerous guest appearances on TV shows such as "Gunsmoke", "Laredo", "The Lone Ranger", "Ironside", "Bonanza", "Twilight Zone" and "Wagon Train", which added up to over 400 film and TV performances for him. He was elected to the Board of Directors of the Screen Actors' Guild in 1946 and was named to fill Ronald Reagan unexpired term as President of the Guild when Mr. Reagan left the
