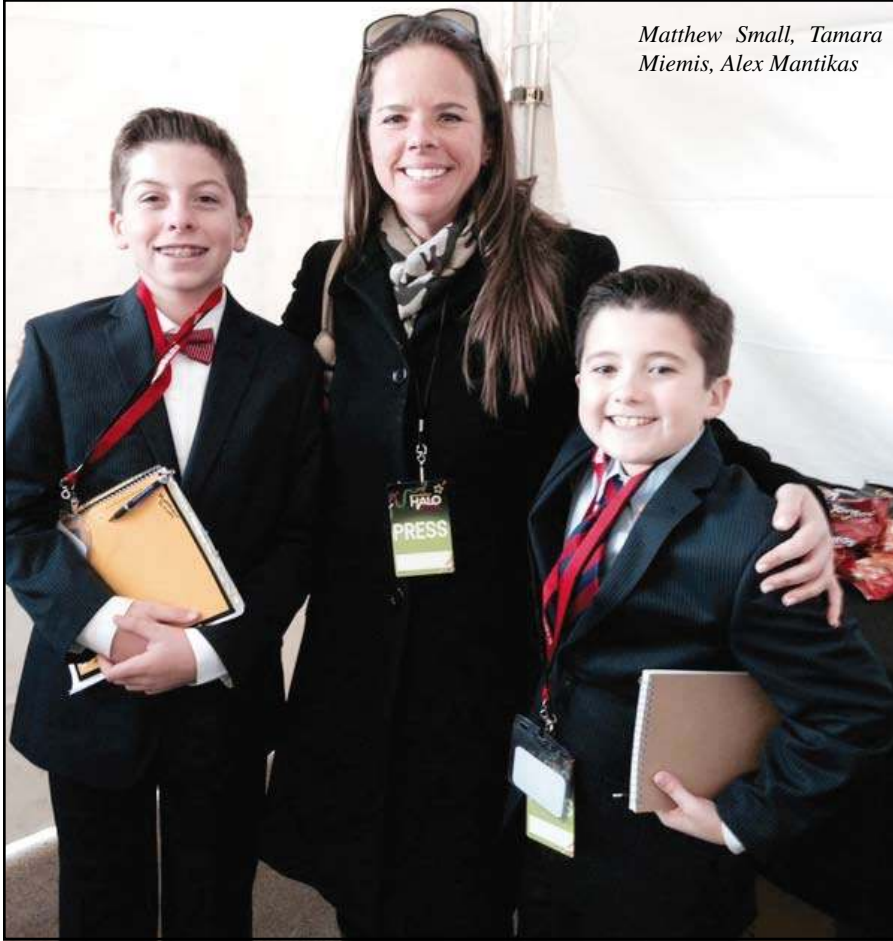

# "The Sip"

with Michael Amendola from The Village Wine Merchant

Thanksgiving has many unique qualities to consider when selecting wines. It's usually an afternoon affair, typically a long meal with a lot of different dishes on the table. Rather than trying to match specific dishes, it's better to put wines on the table that are flexible and will drink well with a wide variety of foods. As such, we look for wines that are light to medium bodied, with a nice fresh acidity, staying away from full bodied wines that have higher alcohol and are fatiguing to the palate over the course of the meal.

For a starter, sparkling wines are a good choice and you don't have to break the bank with authentic Champagne. Try a "Champagne Method" wine or a Crémant from France. The crisp acidity will go with all your appetizers and it's fine form to offer your guests a glass of bubbles as they arrive. Concurrently, know that dry rosé is a not just for summer. It's a super choice for a first wine, matches all types of foods very well and Thanksgiving is a fantastic opportunity to serve one.

As you settle into the meal, a grape that really excels is Gamay, so a Cru Beaujolais or Beaujolais-Villages is a premier choice. A quick mention of Beaujolais Nouveau. 2014 Nouveau will appear on shelves before Thanksgiving and while I love the joyous, direct simplicity of Nouveau from a quality grower, I'd serve it as a starter and not with the main meal

because it doesn't offer enough complexities to consider when selecting wines. For other red wines, the same attributes apply and style can be more important than grape variety. Look to Pinot Noir, Cabernet Franc, Merlot, and even Cabernet Sauvignon as long as you find a lighter style with good acidity and not one encumbered by oakiness. Along these lines, a small Chateau Bordeaux aged in stainless steel works well as do cool climate reds. Interesting choices include Italian reds such as a Schiava, Grignolino or a French wine like Plousard.

Let's not forget the whites, Turkey is a bird after all and white wine is a classic with poultry. We look for whites in a rounder style that still have the freshness to be versatile. I like Pinot Blanc, especially from Alsace, Italian wines like Soave and Friulano, and Pinot Gris from the west coast. If you prefer Italian Pinot Grigio, try a bigger, richer style from Collio, Trentino, and Alto Adige. Conversely, for Chardonnay, we like an unoaked version with broader fruit flavors in the apple/pear spectrum.

## Naturalists Engage 1st Graders in Hands-On Learning Opportunities in Science

North Shore Schools, Glen Head, NY - Ann Coney and Kathy Frost, the naturalists from BOCES Outdoor Education Program, recently visited Glenwood Landing leading students in many hands-on learning opportunities pertaining to science and weather. Mrs. Marcantonio said, "The two naturalists involved students in lessons including temperature, cloud formations, tornados, and the stages of water just to name a few! They asked thought-provoking questions which all tied in beautifully to the science curriculum and Next Generation Science Standards."

The young Glenwood students eagerly listened and interacted with the naturalists as they sat outside on a beautiful sunny day in the outdoor classroom. The first graders watched as a big thermometer was used to demonstrate the changing degrees of temperature. The naturalists then blew into an anemometer to measure the miles per hour of the wind. But, that's not all! The students were able to experience the different stages of water by touching ice, watching ice turn to water, and being squirted by water vapor which they all happily enjoyed! Additionally, the naturalists created tornados, formed clouds in a bottle, discussed various formations of clouds (e.g., cumulus, stratus, and cirrus), and encouraged the

children to act out wind blowing through trees during the various stages on the Beaufort scale!

wide Enrichment teacher, and Dr. Carol Smyth, Elementary Director of Science and Math, for bringing this wonderful, interactive science experience to the students at Glenwood Landing School.

## Tobacco Kills Too Many Vulnerable New York Youth

**Great American Smokeout Spotlights Pressing Need to Help Change the Odds**

The Great American Smokeout is an annual reminder that quitting smoking is critical for good health. Sadly, the most at-risk populations in New York haven't been able to quit on this day or any other. The use of Tobacco is still the leading cause of preventable disease and death killing nearly 24,000 New Yorkers every year and afflicting nearly 600,000 New Yorkers with serious disease directly attributable to their smoking. Tobacco is not an equal opportunity killer – there has been no reduction in smoking rates among low-income adults, adults with poor mental health, and those with less than a high school education.

The School Committee of SAFE Inc.'s PRIDE Project Coalition will continue their partnership with the Tobacco Action Coalition of Long Island to address these concerns on Thursday, November 20, 2014 in celebration of G.A.S.O at the Glen Cove High School with students by bringing their attention to reducing their exposure to Tobacco Marketing. The Coalition is Co-Chaired by Anthony Gallo, GC HS Health Education Teacher and the School Committee is chaired Denise Kiernan-GC SD Director of Health, Phys Ed & Athletics.

Executive Director-Dr. Sharon Harris said, "SAFE's goal is early intervention and prevention education." Dr. Harris continued, "According to the 2014 Bach Harrison Prevention Needs Assessment Survey, Glen Cove's youth showed a rise in lifetime and 30-day Tobacco Use.

### Mapping Out A Winning Strategy For Glen Cove

The PRIDE Project Coalition members held a Sustainability Planning session to learn the results of the Coalition self-assessment (KAIZEN) taken in may and conducted by Sergeant David You and Sergeant First Class Jairo Aquino from the National Guard Counterdrug Task Force (NGCTF). The KAIZEN is designed to help Coalitions become more effective in their work. Coalition Committee Chairs, SAFE Board of Directors and Staff reviewed the results of the Kaizen together and brainstormed ideas for the coalition's areas of improvement. Overall, the Coalition is functioning well. Areas to focus on are raising participation and delegation of responsibilities. For example, members need to be more engaged, some feel they may need a more active role.

To that end, a newly designed Coalition Orientation Packet with Volunteer Skills Checklist was created to assist with attracting new Coalition members with a clear understanding of the

The American Cancer Society, sponsor of the annual Great American Smokeout, estimates that 30 percent of cancers could be avoided if people stopped using tobacco. Quitting smoking is the single most important step you can take to reduce your risk of cancer and improve your health.

Per Carol Meschkow-TACLI Nassau Project Coordinator, "For our youth, reducing initiation is the greatest weapon in the effort to prevent addiction. The New York State Tobacco Control Program continues to focus their efforts on youth for a very clear reason. 90% of smokers smoke their first cigarette by the age of 18. It is during these formative years that our youth are most vulnerable to Tobacco Marketing especially at the Point-of-Sale and we are grateful to partner with SAFE and their Coalition Members to prevent the next generation of smokers." SAFE's Board and Executive Dr. Harris do an incredible job of bringing together all of the community stakeholders on behalf of their local youth".

The results of the Bach-Harrison Prevention Needs Assessment Survey are in! The survey administered biannually at the Glen Cove School District to students in grades 6th through 12th were shared with the public by SAFE, Inc. at Town Hall on Tuesday, Sept. 16. The survey assessed the current use of alcohol, marijuana, tobacco and other drugs by Glen Cove youth, and also offered longitude historical data from prior surveys to compare and contrast.

"Every community has drug and alcohol use," said Georgie Connett, SAFE Board Chair and Strategic Planner for the Coalition charged with analyzing the needs assessment data. "Ten years ago we applied for a drug free community grant to change societal norms about alcohol and substance abuse through a sustainable Coalition. We have accomplished that task as you will see here this evening. Additionally, a Foundation has been formed, entitled the Glen Cove Community PRIDE Foundation, Inc. to continue the Coalition's efforts and support other community based organizations who believe in early prevention and healthy lifestyles".

The survey is one avenue SAFE, Inc. utilizes to support the efforts of the PRIDE Project Coalition to eliminate drug and alcohol abuse among Glen Cove youth. Funded by a Drug-Free Communities Act ("DFC") federal grant, the survey is used to gauge the effectiveness of the Coalition's efforts and to remain cognizant of the areas that need to be addressed.

"SAFE is a tremendous organization," said Glen Cove Mayor Spinello. "I'm very proud we passed a ban on hookah bars. This administration cares about the youth of Glen Cove."

The Coalition, in partnership with Carol Meschkow-Nassau Project Coordinator of the Tobacco Action Coalition of Long Island initiated this sweeping legislative action. Ms Meschkow appreciates the opportunity to support the community in our ongoing efforts to remain pro-active on behalf of the local youth.

Dr. Bernard S. Gorman, independent Grant Evaluator and Research

Psychologist, shared the information from the survey in a PowerPoint presentation. He said that the survey grants people more information than whether or not young people have used drugs. "We want to know at what age, do they perceive the risk, do the parents disapprove," he added.

Survey Highlights--usage from

graders remained at 0%. As for prescription lifetime drug use, it has decreased between eighth and twelfth graders. Sixth graders' use remains the same at 0%. Tenth graders lifetime use has increased from 2.6% in 2012 to 4.3% in 2014. Sixth grade cigarette use slightly increased. By the time students reach the eighth grade 9.8% have tried smoking

Following the survey results, representatives of the Coalition's four Committees, all serving our local Glen Cove youth, addressed the audience providing information about the respective committees and their immediate action plan to incorporate this latest data in their future action plans to address this matter.

Coalition School Committee Chair Denise Kiernan, who is also the Director of Health, Physical Education & Athletics for the District spoke about the HS SALT (Student Athlete Leadership Team) program. The members of SALT, are trained to do peer to peer training with the district's middle school students. "The SALT members have worked hard to teach good decision making," Kiernan said, adding that she was proud of their efforts.

Coalition Co-Chair and Community Committee Chair Tony Gallo continued "We are continuing our efforts to create a SAFE Rides card Smartphone app in



6th to 12th grade mirrored National norms for substances abuse across the board whether it be alcohol, drugs or tobacco with the alarming exception of the fact that in Glen Cove our 8th graders binge drinking is above the National average. We are getting the message across as we are for the most part on a par with our peers communities, but clearly the challenges are great, and there is more work to be done.

The survey shows that most sixth graders haven't used alcohol yet. The lifelong use of alcohol among sixth graders has decreased by 1.9% since the last time the survey was administered, which was in 2012. Lifetime use between tenth and twelfth graders has also decreased, but eighth grade lifetime use has increased by 2.1%. Binge drinking was also surveyed. It has decreased among sixth and tenth grades but increased among eighth and twelfth graders. And eighth grade binge drinking in Glen Cove is higher than the national average. Since the 2012 survey lifetime use of marijuana has decreased in grades eight, ten and twelve. Lifetime use among sixth

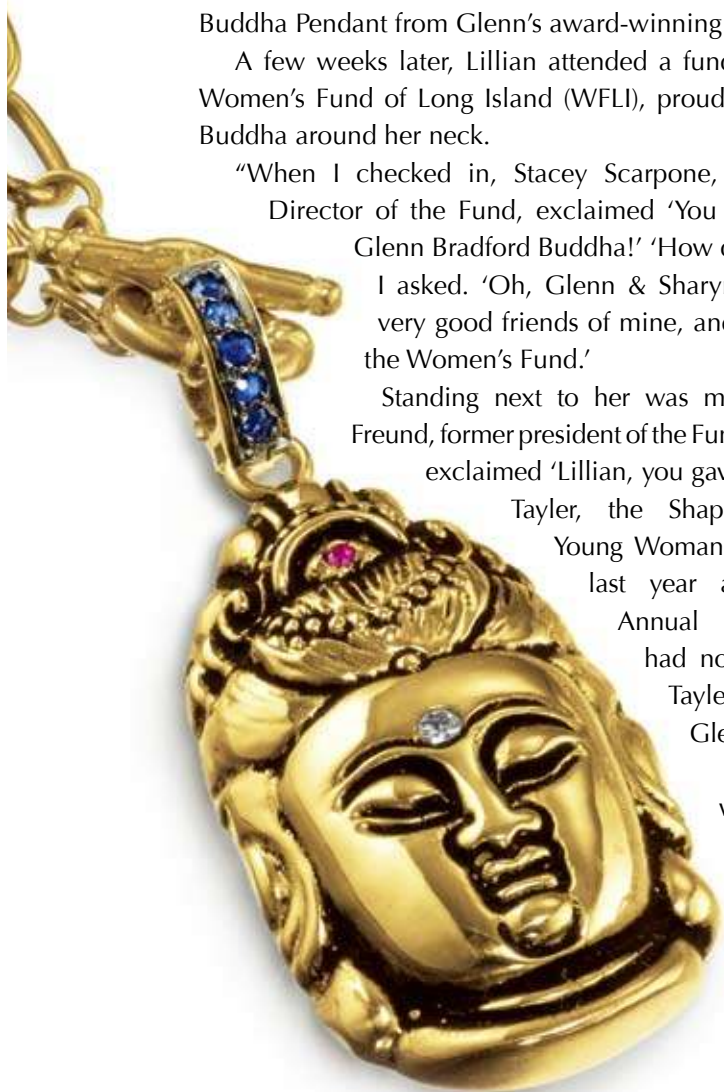

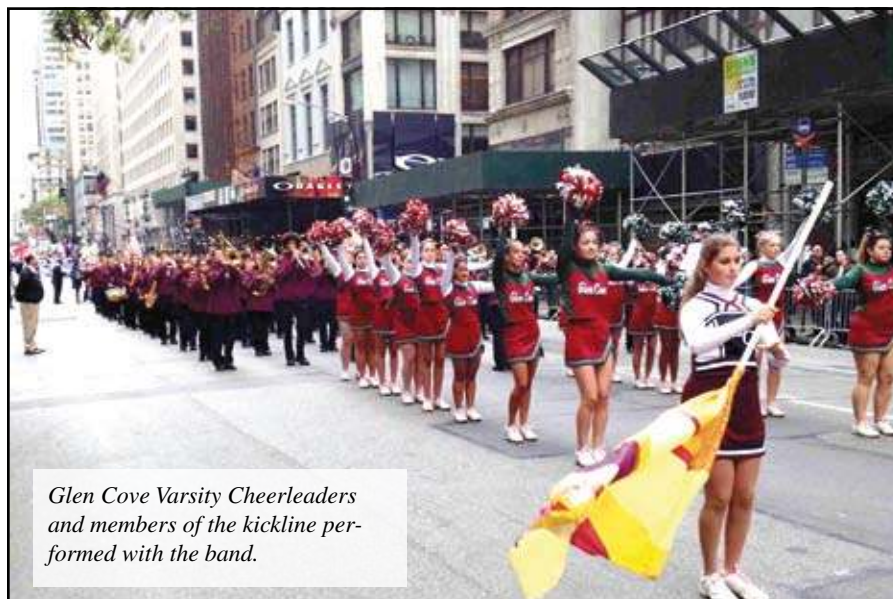
# Glen Cove Marching Band places 5th at Columbus Day Parade

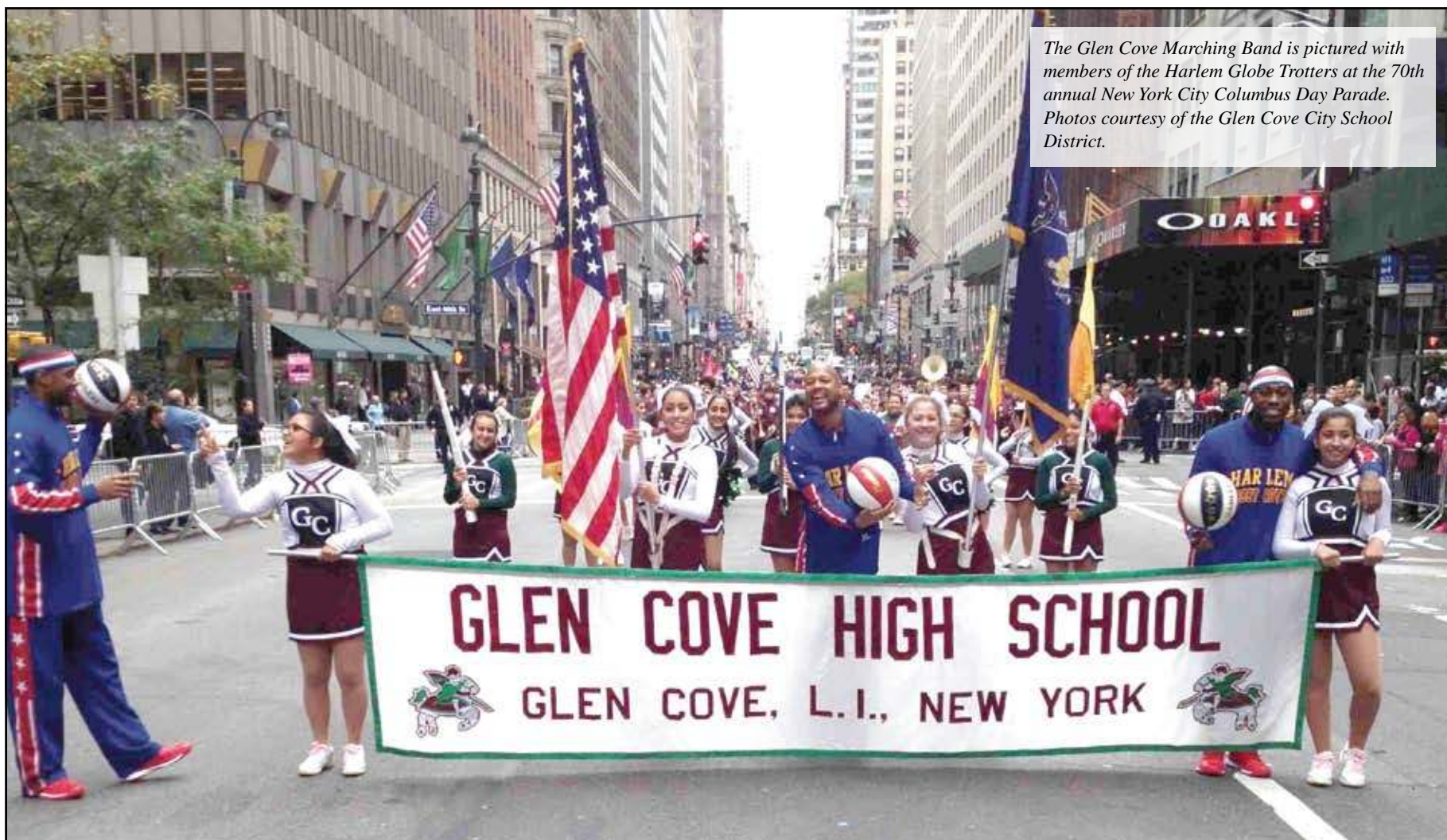
Student conductor Samantha Smith led the 92-member marching band during the competition. In addition, 16 kickline members and 18 varsity cheerleaders performed.

## No Bonus Densities For The Villa!

To The Editor,

Of particular concern is the recent Glen Cove Planning Board's recommendation to the City Council regarding bonus densities. Our Planning Board totally disregarded the letter from the Nassau County Planning Commission dated November 16, 2010, stating that the incentive bonuses and the waivers appear to be tailor made to fit the needs of The Villa's developer and do not provide for the public good. How could our Planning Board recently make contradictory recommendations to the City Council, ignoring The NCP's statements and analysis? The City also appears to have disregarded the NCP's request for additional information and a Findings Report.

The waiver of the Hillside Protection provision is a disaster in the making. Livingston's intent to remove hundreds of old-growth trees will compromise the stability and integrity of the steep hill. This act is equivalent to waiving the requirement to stop at a red light. The public's safety and protection must come first, above all else.

Additionally, both New York State and Federal guidelines require that any incentive zoning be given only when it benefits the public. Our Glen Cove officials must follow these guidelines and must deny all the bonus densities and waivers which have been requested.

The maximum number of units allowable, already built into the RIO - GCA, is 20 units per acre before taking off for the steep hillside, which would result in a maximum of approx. 50 total units for the entire project. For full and accurate information, it is necessary to have a topographical survey, clearly identifying the amount of actual useable net acreage, as opposed to the very misleading perimeter survey; thereby clearly indicating and documenting the amount of limited flat useable land rather than the misrepresentation which has thus far been provided, which includes the non-buildable vertical land.

To summarize, since Glen Cove Avenue is a County Road, and since the Nassau County Planning Commission has analyzed and made their position on the Villa project very clear in their letter of November 16, 2010, that no incentive bonuses meet the requirement of benefiting the public. In accordance thereof, you, the members of the City Council and the Planning Board, have not only the authority, but also the moral, and ethical duty, to deny all the bonus densities and all the requested waivers.

Some of his film credits included, "Hans Christian Anderson" with Danny Kaye, "The Apple Dumpling Gang" with Tim Conway and Don Knotts and "Meet Me at the Fair" with Dan Dailey. On TV, he had many guest appearances on shows such as "Wagon Train, but probably would be best remembered as "Uncle Petrie Martin" in the 1958-59 season of the CBS Sunday night "Lassie" TV series. After Tommy Rettig, who played "Timmy Miller" and his TV Mom, Jan Clayton decided to leave the "Lassie" show, youngster Jon Provost joined the series along with actress, Cloris Leachman, as his TV Mom. 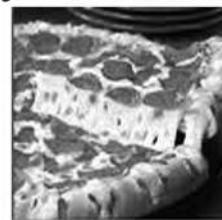
