# Over 100 Firefighters Tackle Sea Cliff Blaze

A fire alarm came in to Sea Cliff at 12:30 in the afternoon on December 18 for a fire in a large home at 88 Prospect Avenue that overlooks the harbor. It appeared that the fire initially was started from heat guns being used by workmen who were working on the renovation of the building.

Over 100 firefighters responded from 11 different fire departments to fight the blaze that was further driven by winds coming off the water that blew smoke into the direction of the firemen and fanned the flames from the rear of the building. In fact, there was enough fire damage in the rear of the building that the roof collapsed. The first engine was Sea Cliff's #572 that stretched hose line to the building's second floor to extinguish the fire. The ladder truck #574 followed and did searches and roof operation checking for extended fire, said Sea Cliff Chief Ernie Longobucco.

Together Sea Cliff and Glen Cove started the roof work with their aerial ladders and Glen Cove's #528 stretched hoses inside the building.

Fortunately the workers were all out

# Glen Cove Teen Court

On the afternoons of December 8th and 9th, Glen Cove Teen Court was back in session. Since September, students at Glen Cove High School have been working on preparing two cases for trial. The students were enrolled in elective class – Teen Court – which represents a partnership between Glen Cove City Court Judge Richard J. McCord and the Glen Cove School District to bring the student participants a real-life lesson in the workings of the criminal justice system and the consequences of poor choices made by their peers. Kristina S. Heuser, Glen Cove Deputy City Attorney, serves as the coordinator of the program. Ms. Heuser also serves as a member of the Nassau County Youth Board.

Two cases on Judge McCord's criminal



calendar were selected by the Judge and referred to Teen Court for adjudication. One of the cases involved a domestic dispute between two young sisters that resulted in one sister destroying the property of the other and being charged

with Criminal Mischief. The other case involved a young man charged with a violation of the NYS Vehicle and Traffic Law for possessing an Open Container of Alcohol in a Motor Vehicle, which was discovered after a serious accident that occurred down the road from Glen Cove High School in June. In addition to benefitting the student participants, the program also benefits the defendants whose cases are referred to the program, and the community-at-large. The youthful offenders have a very meaningful experience with the criminal

justice system though Teen Court, and receive appropriate and uniquely educational penalties without suffering the lasting impact of a criminal record.

The students in the Teen Court program served as defense attorneys, prosecutors, judge, and jury. The police officers involved in the respective cases testified at the trial, and even came to the Teen Court class during the course of the semester to meet and speak with the students. The trials were held in

of the building, said the chief. The Fire Marshall confirmed that the fire was started by stripping paint in the rear of the house with the heat guns. The fire originally started in the eaves between the 2nd floor and the attic and with the wind blowing across the house it escalated the blaze.

In the course of the fire three firefighters received minor injuries and were transported to the hospital.

Both Chief Ernie Longobucco and 1st Assistant Chief Mark Vitale were first to arrive followed shortly by 2nd Assistant Chief Michael Hallquest. Other fire departments called to assist were Glen Cove, Glenwood, Roslyn Rescue and Roslyn Highlands, East Norwich, Oyster Bay Co. #1 and Oyster Bay Atlantic, Bayville, Locust Valley and Syosset. Port Washington and Hicksville covered at Sea Cliff Fire Department.

The Sea Cliff chiefs extend their appreciation to all the fire departments that assisted in fighting the fire.

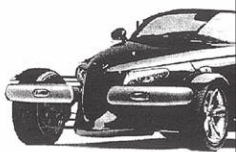

## North Shore Historical Museum Lecture 1/21/15



Join us at the Museum on Wednesday, 21 January 2015 at 7 pm for a Special Presentation by local resident Robert Pemberton, Sr. on the military career of Glen Cove's Marine hero, Sergeant Major Dan Daly, USMC. Light refreshments will be served following the presentation.

Born in Glen Cove in 1873, Daniel Joseph Daly enlisted in the Marine Corps in 1899. He is one of only 19 men (7 of them marines) who was awarded the Medal of Honor twice. He fought in the Boxer Rebellion in China (1900), receiving the first Medal of Honor for gallantry, and the second Medal of Honor was awarded for his conduct in helping to put down a rebellion in Haiti in 1915. Sergeant Major Daly fought in the

Battle of Belleau Wood during WWI, for which action he received the Navy Cross. Sergeant Major Dan Daly retired from the Marine Corps in 1929 and died in 1937. This past year he was honored in Glen Cove by the U.S. Marines with a parade and monument rededication, and by the City of Glen Cove with the renaming of the Arterial Highway in his honor.

## Hanukkah Happening at Sea Cliff Firehouse

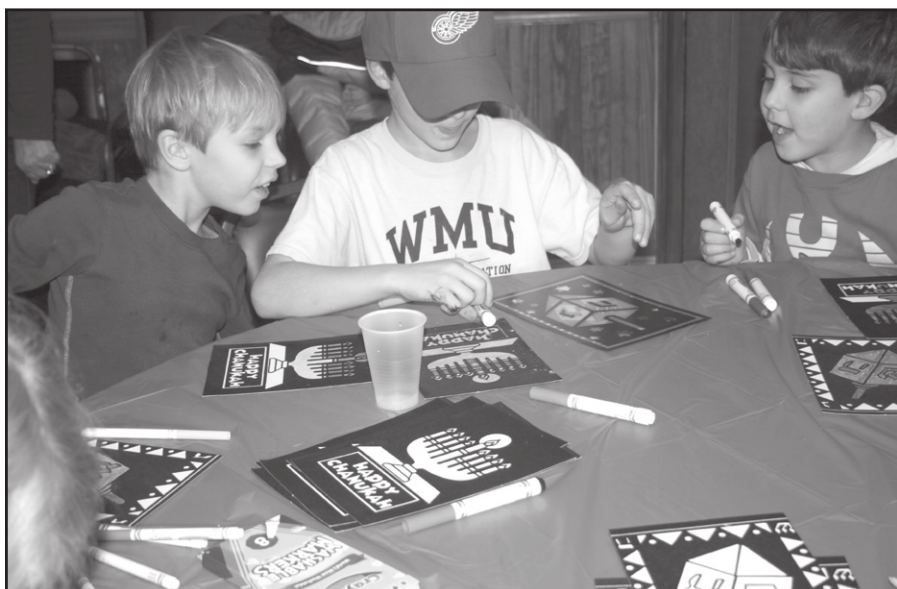

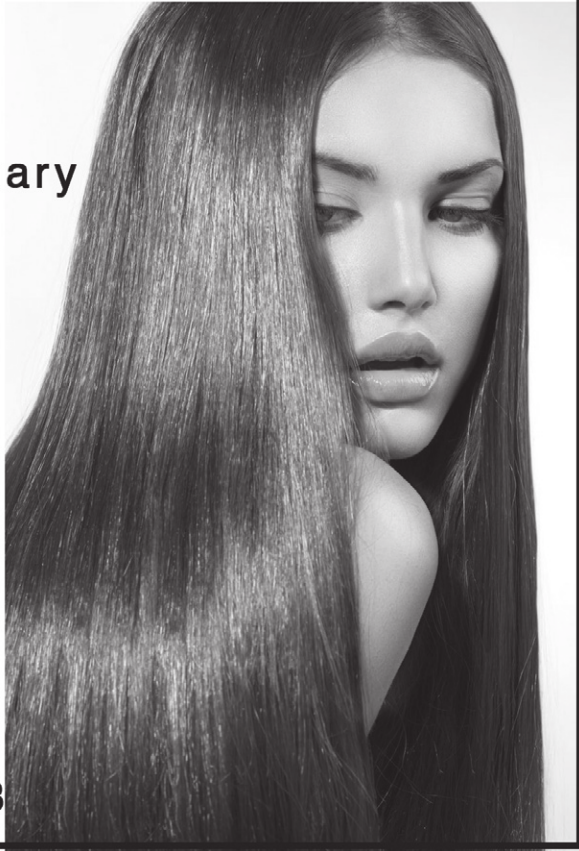

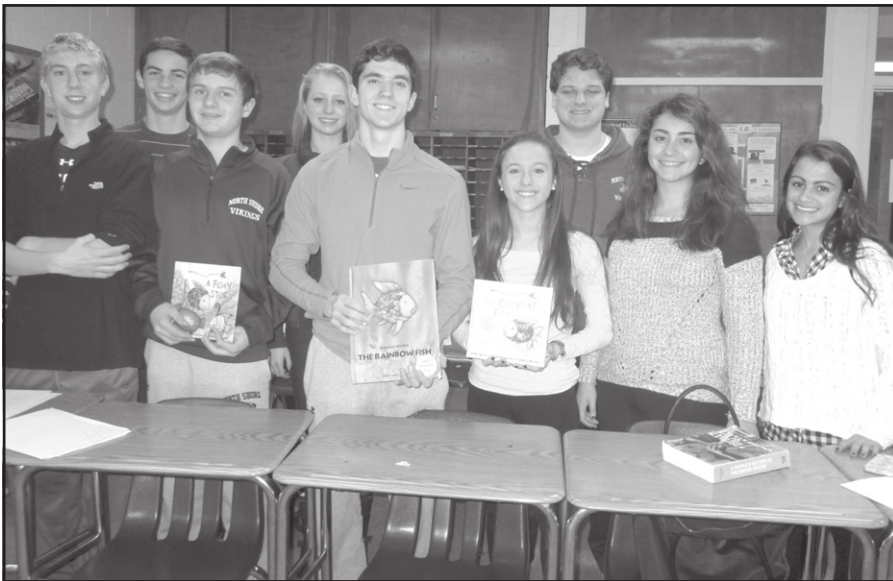

### Animal Lovers . . . Really?

#### To The Editor,

Kudos to Glen Cove Mayor Reggie Spinello for stepping up and paying appropriate attention to the conditions down at the city animal shelter that's been run by the group calling itself the Animal Lovers League of Glen Cove.

It appears that for years there has been a steady stream of complaints about how the shelter was being run. Stories seem to abound about what appeared to be an odd resistance to actually putting animals out for adoption, one of the main purposes of the place. It looked more like a hoarding operation.

Rumors abound that dogs would be picked up as strays and then refused to be returned to their owners who came down to reclaim them. People attempting to volunteer to walk dogs were either turned away or ignored. Worst of all, there are stories of employees closing the shelter at 4:00 p.m. and then not returning until 7:00 a.m. the next morning, 15 hours

later. How in heaven's name could any animal be trained sufficiently for adoption if it was being left to fend for itself in a cage for 15 hours?

And now, in what can only be described as a typically unfortunate article about the Spinello administration that ran in Newsday on December 10th, Long Island's daily made it appear that Mayor Spinello and City of Glen Cove were not being fair to the alleged Animal Lovers by replacing them with another not-for-profit group that may, in fact, turn out to love the animals a little more than the last crowd.

Finally, the word is that the Animal Lovers League is flush with several hundred thousand dollars in their bank account. So the question is, if they love animals as much as they claim, are they going to leave the dogs, cats and money behind when they depart, or just the dogs and cats?

He has dedicated his life to preserving, promoting, and enlightening the world about the Papa Miguel Manteo Marionettes and the origin and legacy of the acclaimed Papa Manteo Sicilian Marrisonette Theater, which was established on Catherine Street in Manhattan's Little Italy in 1918.

# Name the Celebrity



You may have seen her face a thousand times. She was never a star, but applauded for her professionalism and hard work. She appeared in 500 motion pictures and over 1,000 TV show appearances over an eight decade career. This week's celebrity was born in Amarillo, Texas on July 28, 1911. She was the daughter of silent film actress Carrie Barnett and began appearing in silent films at the age of 4, under a variety of stage names so her father's disapproving family wouldn't know. She was for example, as she once described herself, "one of the knobby-kneed little pages" in the Douglas Fairbanks Sr. version of "Robin Hood" (1922). After high school and college, she appeared as a girl in a swimming pool in "The Night Life of the Gods" (1935). This movie was about a scientist named "Hunter Hawk" played by Alan Mowbray when he wasn't a butler, who invents a device that can turn flesh into stone. While celebrating his discovery, he becomes involved with a half-naked leprechaun, "Meg." On a trip to NYC, "Hunter" and "Meg" decide to go to the Metropolitan Museum of Art and turn all of the statues of Greek gods into people. What follows is a drunken romp around NYC with Medusa's severed head still in Perseus' hand. HmMMM, sounds familiar!

Hellooooo, Ben Stiller! Who says Hollywood can't come up with new ideas!?!? Although our celebrity was billed only once in a leading role as "Jean" opposite actor Charles Starrett, in the 1939 "Rio Grande", she never once groused about playing second fiddle or even thirty-second. She was the snappy newspaper office worker in Cary Grant's "His Girl Friday" (1940) and "Maria", the nursemaid in Bette Davis' and Claude Rains' "Mr. Skeffington" (1944) However, she may be best remembered as James Dean's mother in the legendary actor's signature movie "Rebel Without a Cause" (1955).

### Last Week's Celebrity

Last week's celebrity was Sara Allgood. She was the sister of well-known Irish actress, Marie O'Neill and they both considered Irish poet, William Butler Yeats, a very close family friend. Besides, her role in "How Green Was My Valley", she also had memorable roles in the 1941 retelling of "Dr. Jekyll and Mr. Hyde" with Spencer Tracy, "Jane Eyre" (1943) with Joan Fontaine, "Keys of the Kingdom" (1944) with Gregory Peck, "Roxie Hart" (1942) with Ginger Rogers, "That Hamilton Woman" (1941) with Vivian Leigh and "One Touch of Venus" (1950) with Robert Walker Sr. and Ava Gardner. She was married for a short time to British stage actor Gerald Henson. Tragically, both Henson and their newborn daughter died of influenza in the outbreak of 1918. Sara never remarried. She took her oath as an American citizen in 1945. On Set. 13, 1950, shortly after finishing her final movie, "Sierra" with Audie Murphy and Burl Ives, she passed away, at the age of 70, from a coronary. 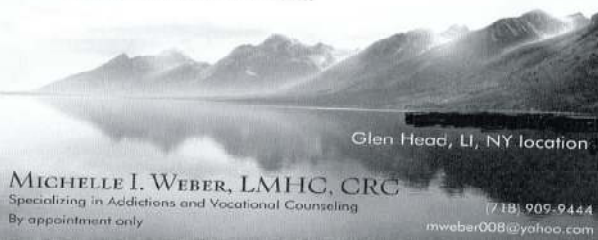
