Maybe They Just Needed a Jolt!

On June 22nd an unknown subject walked into King Kullen Supermarket at 77 Forest Ave and proceeded to leave the store with over \$600.00 of Red Bull Energy drinks without paying for the merchandise, according to Glen Cove Police.

On June 26th the same subject entered the King Kullen Supermarket and loaded his shopping cart with over \$400.00 worth of the Red Bull energy drinks and proceeded to leave the store without paying for the items. The stores surveillance cameras picked up the theft and the Glen Cove Police began their investigation.

On Wednesday July 29th an alert King Kullen security officer observed the vehicle that was involved in the prior larcenies at King Kullen in front of the Stop and Shop Supermarket at 177 Forest Ave in Glen Cove. The Security officer then observed the suspect walk out of the entrance door of the supermarket with a shopping carriage full of Red Bull energy drinks as well as baby formula. The security officer notified the Glen Cove Police and Glen Cove Officer Matt

Exuberant songs encouraging acceptance and positivity may seem out of place among the swag and glamour we hear in much of today's pop music, but those messages – accompanied by pure musical talent and undeniable charisma – has been drawing fans and critical response to acoustic pop duo, The Brady Brothers.

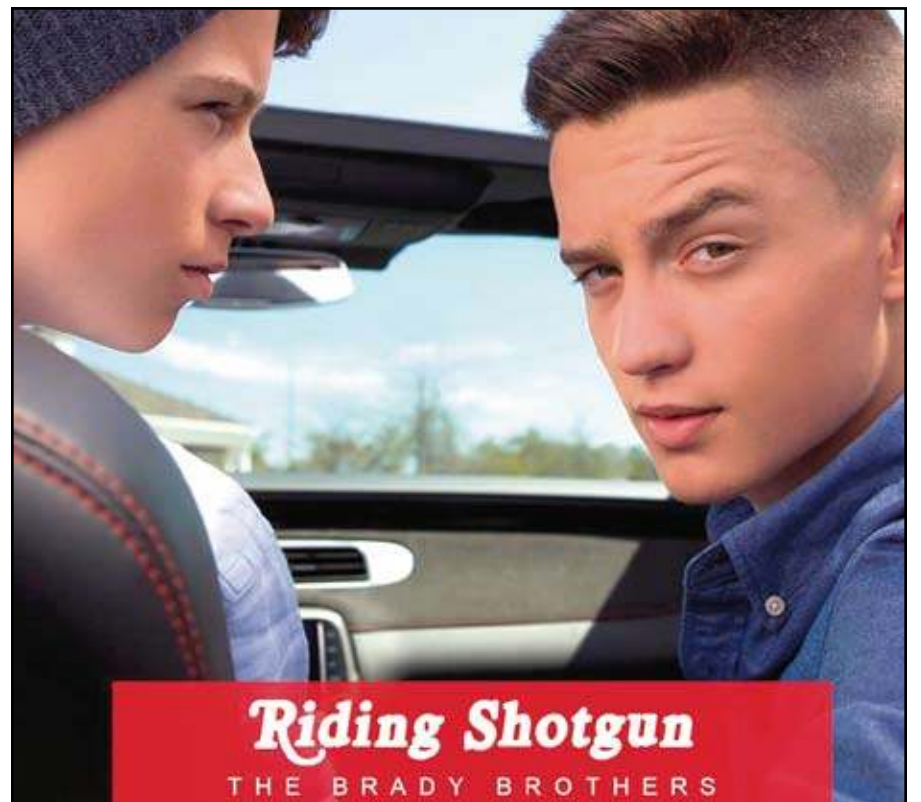
Sixteen year-old Sea Cliff twins, Dylan and Cody Brady, make up The Brady Brothers. Their debut album, *Riding Shotgun*, is an energetic ride, capturing the fun, anticipation and excitement that comes from growing up, starting to make your own choices and taking part in new experiences.

The album is the culmination of an incredible year. Their debut EP, *You + Me*, was released in September of

2014. The EP immediately cracked the top 100 pop album sales on iTunes, and their first single, 'Feet in the Sand', was featured on Radio Disney's First Time Play. The Brady Brothers supported the release by headlining an East Coast Tour in Boston, New York City, Long Island and New Jersey, as well as opening for Meghan Trainor in front of more than 1,200 fans.

The Brady Brothers have also used their music as a vehicle to teach and inform, not just entertain. From September of 2014, Dylan and The Brady Brothers have been showcased on the Disney Channel's Make Your Mark for Dylan's work in spreading a message of tolerance and understanding

Gillespie and Michael Napoli pulled the suspect's vehicle over on Brewster Street in Glen Cove.

At the time of the police stop the vehicle was loaded with over \$1000.00 of the stolen proceeds from Stop and Shop. The stolen items were recovered by the Glen Cove Police and the two suspects were arrested. The first suspect, 56 year old Michael Haynes of the Bronx was charged with one count of grand larceny in the 4th degree a class "E" felony. The second suspect, 48 year old John Walston, was charged with grand larceny

4th degree and for the two prior larcenies that had occurred at King Kullen. Both suspects have lengthy criminal records, and both were arraigned in District Court on Thursday July 30th. Defendant Walston is being held on \$4500.00 cash bail and Haynes is being held on \$2500.00 cash bail.

Detective Lieutenant John Nagle said, "We don't know why these defendant's selected Glen Cove as a location for their crimes, maybe they thought it was an easy target? I guess they figured wrong!"

City of Glen Cove Issues Water Conservation Alert Reminds Residents of Outdoor Water Guidelines

With the extended weather forecast indicating consistent days of temperatures above 90 degrees, Glen Cove Mayor Reggie Spinello has issued a water conservation alert today to maintain the City's water supply.

Pursuant to the City water ordinance, all outdoor watering activities are limited to the hours of 5:00 a.m. to 9:00 a.m. and from 4:00 p.m. to 12 midnight on specified watering days. A resident's watering day reflects their street address number – even street address numbers can

water on even days and odd numbered street addresses can water on odd days. If you do not have a street address number, you are considered an even day. Outdoor watering activities are not permitted on the 31st of any month.

Glen Cove's Code Enforcement and Water Department teams will be monitoring neighborhoods to ensure compliance with the current water restrictions.

The Glen Cove Youth Bureau, in cooperation with the Friends of the Glen Cove Youth Board is teaming up with local citizens, organizations and businesses to provide back to school supplies to disadvantaged youth in our community. A backpack filled with supplies is presented to children who otherwise would not have what they need to succeed in their studies. Last year, 254 children in grades K – 12 received back to school supplies as a result of this effort.

Given the cost of getting ready for school, the need is greater than ever this year. For example, on average it costs \$78.00 to purchase all of the supplies on the school list for a 1st grader in the Glen Cove School District and \$83.00 to supply a 4th grader. This cost simply covers school supplies. It does not cover back to school clothing, shoes, coats, etc. For families living on a fixed income, especially those with more than one child, these expenses are often impossible to absorb. When the family forgoes purchasing school supplies, it is the student who suffers.

Glen Cove Debate On Or Off? To The Editor,

Glen Cove's mayoral debate is now being debated.

City councilman and challenger Anthony Gallo Jr. readily accepted incumbent mayor Reginald Spinello's invitation to debate. The exchange came during the city council meeting July 28. Twenty-four hours later, however, Gallo e-mailed Spinello that the debate should take place on or about Sept. 28, more than two weeks after the Republican Party primary between the two.

Spinello called Gallo's idea of a debate date "ridiculous", suggesting that the event would be a moot point unless it is held before the scheduled Sept. 10 primary. Score one for Spinello. Gallo in turn insisted that both candidates should know in advance what topics will be addressed at the debate. The chairman of the Glen Cove Republican Committee, a Spinello supporter, retorted, "Then it ceases to be a debate and becomes a play that's to be rehearsed. A person who's running for office should have a grasp of all the issues." True, but a list of possible topics ought to be given to each candidate in order to give the debate substance, so score one for Gallo.

That's it then, a debate held earlier than Sept. 10. Possible topics will be recognized and agreed upon. An off-the-cuff portion will take place if agreed upon. Gentlemen, start your engines.

Debate Before?

To The Editor,

It would seem that any "debate"

between Councilman Gallo and Mayor Spinello related to any governing differences that currently exist between them concerning the future of our city should occur before, and I repeat, before the September Primaries. For Mr. Gallo to know in advance the issues to be discussed would not be a "debate." It would merely be a platform for him to make a prepared "speech" of some sort.

Mr. Gallo is known to be a popular physical education teacher and coach in our public schools system. These roles are admirable. They are key parts of our educational system. However Mr. Gallo is not a department head in the school system. Because of this deficiency, your readers might want to know precisely to what extent Mr. Gallo has honed the public sector management and/or leadership skills he alleges are needed for Glen Cove?

By comparison or contrast, Mayor Spinello has a documented history of being a successful private sector entrepreneur and CEO. During his past two year tenure as Mayor and CEO of our city he has clearly demonstrated the expected effective and efficient public

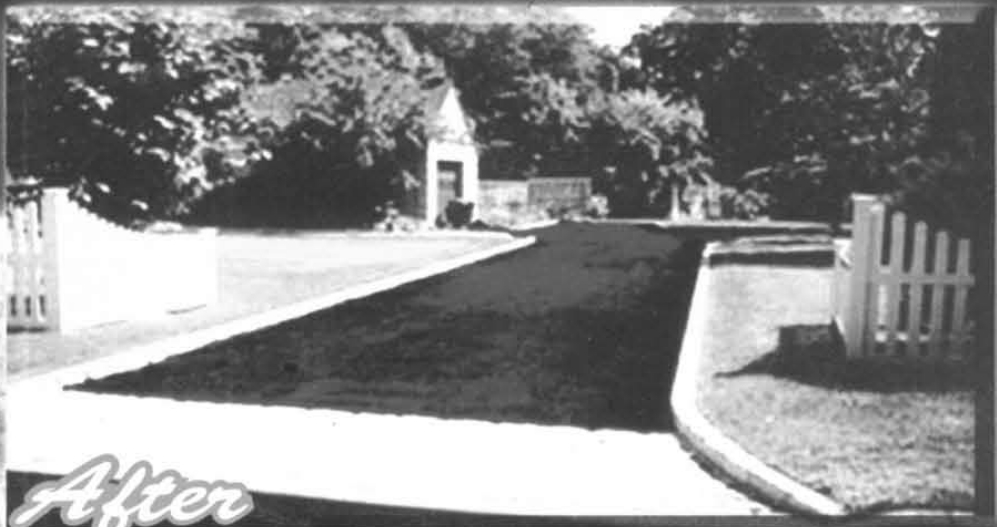

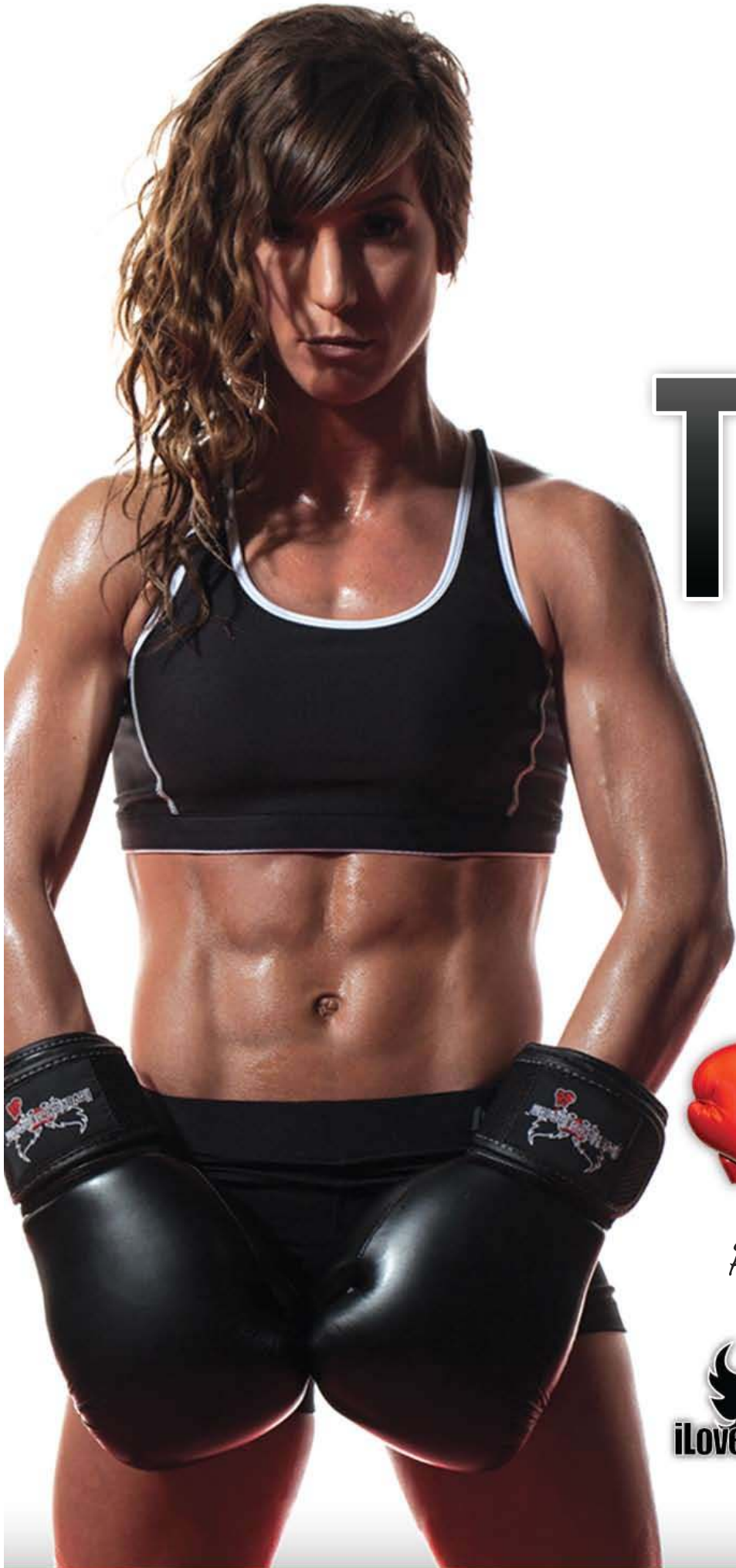

SAFE Glen Cove Coalition Continues to Address Alcohol and Substance Use

The SAFE Glen Cove Coalition held their Sustainability Planning meeting on May 20th to review their work from the previous year and strategically plan to set goals for the 2015/16. The mission of the Coalition is to eliminate alcohol and substance abuse in Glen Cove. The Coalition is overseen by SAFE's Board of Directors and Co-Chaired by Councilman Tony Gallo and SAFE Executive Director, Dr. Sharon Harris.

The Coalition's four established committees (Community, School, Youth and Parent) each have their own charge based on alcohol and substance abuse use surveys administered to students every two years at the Middle and High School to identify trends and prevent future use.

The Community Committee, Chaired by Councilman Tony Gallo, serves as a think tank to examine needs assessment data and make recommendations; Implement media campaigns regarding underage binge drinking, enforcement of underage drinking laws and social host law; Implement "SAFE Homes", a pledge adults take not to social host and "SAFE Glen Cove", a commitment made by local business to not sell alcohol or tobacco to minors.

The School Committee, Chaired by Denise Kiernan, Director of Health and Physical Education for the Glen Cove School District, utilizes the needs assessment data to identify, to provide Alcohol, Tobacco & Other Drugs (ATOD) prevention activities, and programs for youth; Expand and enhance Health Education curriculum to address needs assessment data; Enforce District's Tobacco Policy and drug-free school zones; Utilize Teens-As-Teachers/SALT programs to facilitate and implement coalition prevention activities throughout the district; Collaborate with the Youth Committee on shared coalition initiatives to ensure full community participation; Participate in assessing and analyzing root causes of substance abuse problems

in the community;

The Youth Committee, Chaired by Arlene O'Dell, Executive Director of the Glen Cove Youth Bureau, utilize needs assessment data to identify and provide prevention activities and programs for youth and participate in planning activities for youth that help to reduce youth drug and alcohol use.

The Parent Committee, Chaired by Laurent Caballero, SAFE's bi-lingual Life Skills Program facilitator, act as a bi-lingual parent resource for prevention, education, intervention, and research on alcohol and drug abuse; Serves as Liaison with the PTA Council; Participates in assessing and analyzing root causes of substance abuse problems in the community; Help develop, attend and promote the following Coalition activities and events: Annual Health and Fitness Fair, Town Hall, Parent University; Red Ribbon Week, SAFE Rides, SAFE Homes.

The four committees will continue with their respective initiatives in 2015/16 and will work with Sergeant David You and Sergeant Ohiro Aquino of the National Guard Counter Drug task Force to implement prevention education workshops for youth and will also continue to work with Carol Meschow of the Tobacco Action Coalition of Long Island to identify and address no-smoking areas in Glen Cove to promote a healthy and safe environment for youth and adults.

"The Coalition is in its twelfth year and continues to meet its goals and objectives due to the commitment of its membership. As SAFE's Board Chair and Strategic Planner for the Coalition, I am extremely proud of its accomplishments" said Georgie Connert.

Name the Celebrity



Born on Feb. 18, 1903 in Omaha, Nebraska, this week's celebrity was a dapper character actor and radio personality. After attending Chicago University, he entered show business as a comedian with the Ziegfeld Follies. His particular forte was mimicking a variety of ethnic dialects. Performing in vaudeville and in nightclubs, he scored an immediate hit with his comic creation, the "Greek Ambassador of Good Will", an English-fracturing Greek immigrant. He took his character with him to radio, where he worked for some time on the Jimmy Durante Show. His continuing popularity led to appearances in two-reel comedies and feature films. A couple of his first features were "Hollywood Party" (1934) with Stan Laurel, Oliver Hardy and Jimmy Durante and in "Riffraff" (1936) with Jean Harlow, Spencer Tracy and Una Merkel. In "Riffraff", he played "Markis, the attorney" who carried on verbal battle of mixed-up words and convoluted dialects with Joseph Calleia, who played "Nick Lewis, the cannery boss." Recent column celebrity Frances Marion and Anita Loos wrote the screenplay. George S. Kaufman was an un-credited contributor to the dialogue.

Last Week's Celebrity

Our celebrity last week was no other than Martin Balsam who was born on Nov. 4, 1919 in the Bronx, NYC. He caught the acting bug in high school where he participated in the drama club. After high

school, he continued his interest in acting by attending Manhattan's progressive New School. When WWII broke out, he was called to service in his early twenties. After the war, he was lucky to secure a position as an usher at Radio City Music Hall in NYC. By 1947, he was honing his craft at the Actors Studio in NYC, which allowed him training in the famous Stanislavsky method. In later years, he continued to periodically return to "The Studio".

Despite his excellent training, he had to prove himself, just like any up and coming young actor. He began on Broadway in the late 1940s, but it wasn't until 1951 that he experienced real success in Tennessee Williams' "The Rose Tattoo". After his Broadway success, he had a few minor TV roles before his big break came when he joined the cast of Marlon Brando's "On the Waterfront" (1954). He had recurring roles on popular TV shows such as "The United States Steel Hour", "The Philco-Goodyear TV Playhouse" and "Studio One in Hollywood". In 1957, he was able to prove himself on the big screen once again, with a prominent role in "12 Angry Men" (1957), directed by Sidney Lumet and starring Henry Fonda.

If our celebrity was alive today, he would probably be found telling a great story, which would go something like this: "I was once married to the actress, Patricia Van Patten, and our daughter, Talia, was once married to the actor, George Clooney. That was in 1989 before he got "big" and they got divorced in 1993. After their divorce, George swore he would never marry again. In fact, Michele Pfeiffer and Nicole Kidman bet him \$10,000 that he would have children by age 40, and sent him a check shortly after his birthday. Clooney returned the funds and bet double or nothing he wouldn't have children by age 50. Now, there's a guy with a goal!"

Dear Great Book Guru,
Last week you wrote about a family touring Ireland and we too will be vacationing there, beginning next week. With all your recommendations, I don't need any more books on Ireland, but I am interested in the controversial newly released Harper Lee novel. What did you think of it and should I download it to bring on our journey?
Curious Reader

Dear Curious Reader,
I feel similarly about GO SET A WATCHMAN by Harper Lee and Woody Allen's latest film IRRATIONAL MAN. Both were so roundly dismissed by critics, I had very low expectations and was happily surprised to find them quite wonderful. Written before TO KILL A MOCKINGBIRD, this novel is set almost 20 years into the future with Scout returning to Maycomb as a visiting 26 year-old New Yorker. While Jean Louise is no longer known as Scout, much

of her earlier robust, colorful character remains. However, she no longer sees her town, her home, and especially her father through the magical prism of childhood. Instead she finds racism and sexism all around her. The 1950's South is an uncomfortable place for Jean Louise, and much of the book- while at times offering a nostalgic description of small town life- deals with her horror of discovering things were perhaps never as she remembered. The title refers to the biblical quote that calls out for someone to rise up and become a moral compass; here it is Scout not Atticus who serves as that compass. Recommended!

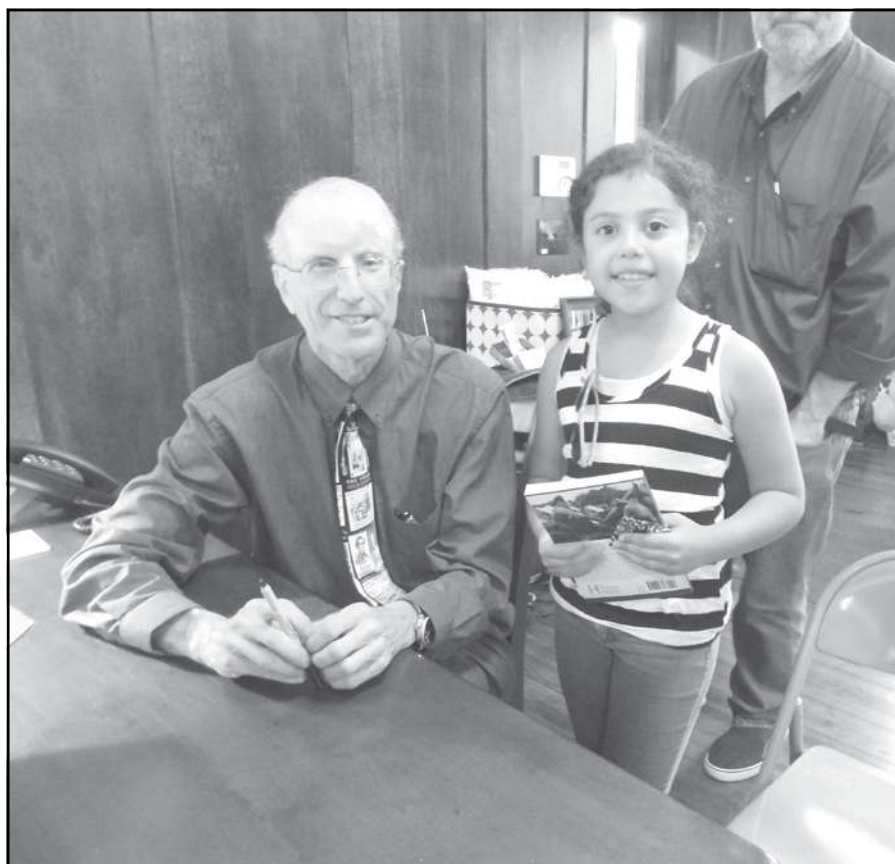


Civil War Presentation by Bill Bleyer at NSHM

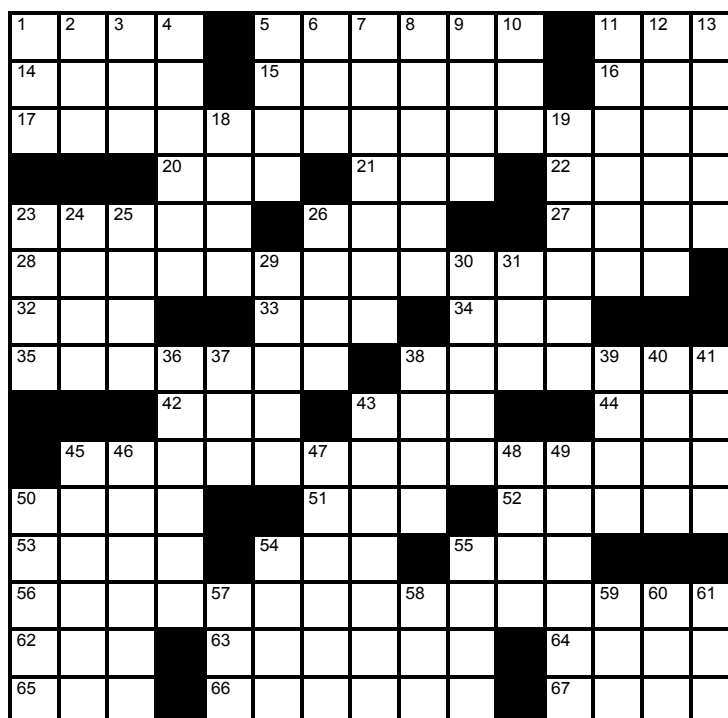
Civil War history buffs. Young student and future historian, Sophia Chavez, was among many attending the presentation, who were thrilled to have their books signed by Bill Bleyer.
