Democratic Legislator Delia DeRiggi-Whitton: Ban No-Bid Contracts

Democratic Legislator Delia DeRiggi-Whitton (District 11) announced today that she will propose a charter revision to ban the loophole that allows personal service contracts under \$25,000 to automatically pass without going before the legislature. A recent Newsday expose showed that, from January to July 2011, Nassau County Republicans have awarded \$9.5 million in 384 contracts ranging between \$24,000 and \$25,000 with no legal legislative oversight. In the same period, there were only \$500,000 in contracts between \$25,000 and \$26,000 that did receive legislative review and oversight.

DeRiggi-Whitton said, "The people of Nassau County have every right to question why millions of taxpayer dollars are being spent on political insiders,

rather than services that Long Islanders need. It is time to ban these no-bid, no-review contracts going to politically-connected insiders and companies at the expense of those that live, work and pay taxes in our community. I propose a charter revision to ban contracts under \$25,000 from going through with no review and will fight for a referendum to ensure it passes. This is just one urgent reform needed among many, including eliminating automatically adopted contracts if they are not reviewed within 45 days. We need to take immediate steps to ensure taxpayer dollars are not being spent without legislative oversight. Taxpayers deserve better. Any loopholes enable waste and abuse, and need to be closed."

To recognize Howard's efforts, Mayor Reggie Spinello presented him with the City of Glen Cove flag and acknowledged the charitable work of Howard and his wife, Karla with a special citation.

"As you take on the most important fight of your life, we extend to you our love and respect and present you with the City of Glen Cove flag," said Mayor Spinello. "In the 1976 Olympics you were wrapped in the flag of our country and that represented the gratitude of our great nation for your remarkable victory. Today it is our turn as a community to support your battle against cancer and wrap you with a reminder that we never forget our own and you are always in our thoughts and prayers." "I'm deeply humbled and honored to

receive such recognition from my state and hometown. The success I have been blessed with over the years would not have been possible without the support and foundation I was given by family and friends of Glen Cove. I may call

Florida home now, but Glen Cove will always have my heart and will always be my hometown," said Howard Davis Jr. As part of his visit to Glen Cove, Howard Davis Jr. went back to his old neighborhood on Mason Drive – where an honorary street sign was dedicated in 2009 to in tribute to Howard and his father, Howard Davis Sr. Howard shared hugs with old acquaintances, met with his former trainers and sparring partners and talked about preparing for the Olympics by running up and down all of the hills in Glen Cove.

"Howard was very happy to be back at the Glen Cove Housing Authority where he grew up," said Eric Wingate, executive director of the Glen Cove Housing Authority.

GLEN COVE NEIGHBORHOOD ASSOCIATION RESPONSE

As Directors of the Glen Cove Neighborhood Association (the "NA") which owns the land upon which the YMCA at Glen Cove presently operates, we are compelled to once again respond to the continued misleading and misstatements of fact that have been disseminated throughout the community with respect to the future operation of our Glen Cove facility. It is obvious that these rumors and misinformation are being circulated by individuals who are motivated by their own personal agendas having nothing to do with the best interests of this facility and are negatively affecting our ability to negotiate with the YMCA of Long Island for the extension of its lease of the property.

1. We are proud to report that since January we have added three new important members to our Board of Directors: Nicholas Martone, Craig Treiber and Philip Catapano, Esq. For many years, these gentlemen have volunteered their time, talents and money to both the YMCA of Long Island and the facility at Glen Cove. Both President Nicholas Martone and Director Craig Treiber, and their families have a long history of substantial financial support for the Glen Cove facility. Their financial support enabled the YMCA to expand the facility to provide additional programs and activities for the members of the community and the construction of the Martone Center Preschool and Child Care facility and the Treiber Center outdoor pool complex. Philip Catapano, Esq. has served for over 30 years on the Board of Managers of the YMCA at Glen Cove in numerous capacities. John Chase and Beverly Bell, both attorneys in the area, have served together for over 20 years on our Board and bring their continued commitment to our mission. Mr. Chase also served for over 30 years on the Board of Managers of the YMCA at Glen Cove. These stakeholders and individuals collectively comprise the stewards of this property who are motivated only to assure the continued operation of the Glen Cove facility for the betterment of the residents of Glen Cove and surrounding communities.

2. The Neighborhood Association first offered to extend the current lease with the YMCA back in January 2015, to allow the newly constituted Board the much needed additional time to resolve our issues with the YMCA before the current lease expires. Since that time, we have offered several other extensions, and negotiations on the latest extension offer are ongoing. Contrary to recent allegations, since this time we have negotiated only with the YMCA of Long Island. We have never met with, communicated with nor entertained any offers from any other person or entity to lease and operate our Glen Cove facility. Nor will we allow any person or entity to interfere with our negotiations or decision-making process with respect to the nature of this facility. We have not and will not at this time entertain any offers from the City of Glen Cove to lease or operate the Glen Cove facility or allow the City or anyone else to interfere with our negotiations or decision making process with respect to the future use of this facility. The City of Glen Cove is not a party to the current negotiations, and it has no interest, influence or role in the lease negotiation process with the YMCA of Long Island.

3. The land upon which the YMCA at Glen Cove is located was originally acquired from the Pratt family to be used for the recreational and beneficial use of the people of the City of Glen Cove and the surrounding communities to fulfill the mission of the NA as set forth in its certificate of incorporation. As such, the mission of the Neighborhood Association is simply to ensure that the operator of the facility does so with the best interests of the Glen Cove community and its environs in mind. We will continue to fulfill that mission by ensuring that the Glen Cove facility is operated only in the best interests of the community and unaffected by the rumors and misinformation being circulated by individuals having other personal agendas.

Morgan Park Summer Music Festival announces its first FolkFest. Talented local musicians Don Bikoff and Matt Grabowski will perform from 6:00 pm to 7:30 pm. A Band Called Honalee performs from 7:00 pm to 9:00 pm. Bring a picnic and settle in for an evening of favorite folk tunes from the 60s and the 70s.

Opening FolkFest is Glen Cove's own acoustic guitar artist, Don Bikoff. Don, who has performed at Port Washington's Landmark on Main Street, Manhattan's The Living Room and Riverhead's Vail-Leavitt Music Hall, takes to the stage at 6:00 to perform popular folk songs

of the 60s and 70s. At only 19 years old, Bikoff released his first recording, *Celestial Explosion*, a collection of finger-picking acoustic guitar solos heavily influenced by Delta blues, American folk and Eastern classical music. Last year this album was reissued as a result of several of its tracks being included in WFMU's playlist. The re-release of *Celestial Explosion* launched a major revival of Bikoff's musical career, one he had almost abandoned 40 years ago. His second album, *Hallowed Ground*, has just been released.

Also performing at FolkFest is Glen Cove singer-songwriter Matt Grabowski. Matt can be heard at a number of local venues including Stangos, The View, The Oak Room and Downtown Sounds as well as at venues in New York City. Grabowski's repertoire ranges from Paul Simon to Harry Chapin to his own folk-rock originals. Grabowski's appreciation for folk music came from

his parents who would play music by The Beatles; Crosby Stills, Nash & Young; Mary Chapin Carpenter; Poco and other country/folk artists while Matt was growing up.

A Band Called Honalee, a modern-day folk trio inspired by the legacy of Peter, Paul and Mary, performs at 7:30 pm. The band also draws on other unforgettable musicians of the era – The Mamas & the Papas, Simon & Garfunkel, The Beatles, Bob Dylan and other giants of folk-rock. Like Peter, Paul and Mary, A Band Called Honalee got its start in Greenwich Village. Since its founding in 2009, the group has actively toured the country and this year released its debut album. Committed to the melodies and messages of the 60s, the band's members believe that the music of that era is just as relevant today.

The folk festival is underwritten by Glen Cove's Rising Tide.

Come on down to Morgan Park and

enjoy a wonderful evening of family entertainment under the stars. Bring a blanket or chairs and picnic if you wish. Children are welcome. Morgan Park is located on Germaine Street at the end of Landing Road in Glen Cove. In the event of rain, the concert will be held in St. Patrick's Parish Hall, Pearsall Avenue, Glen Cove. 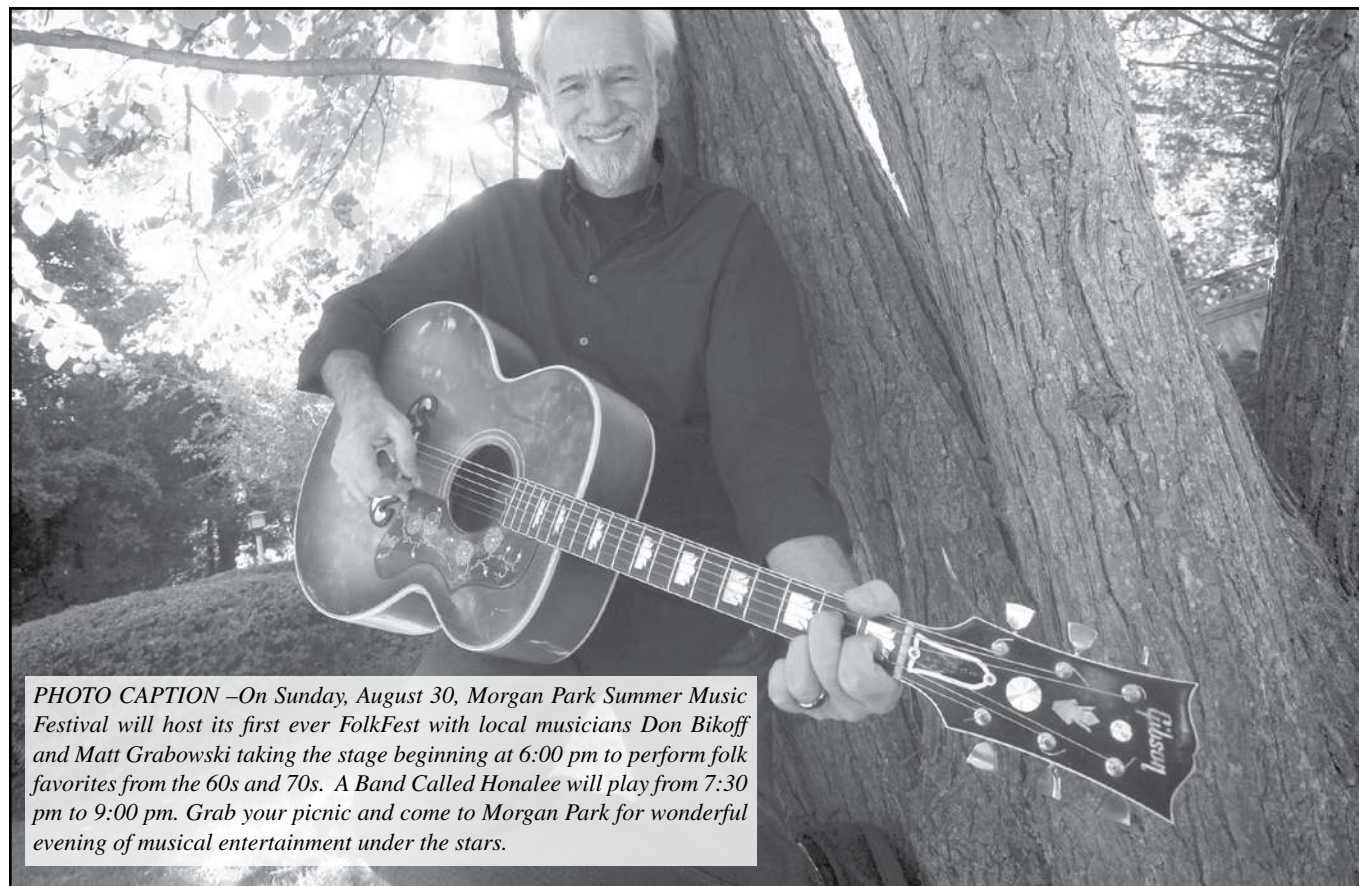

The City of Glen Cove Introduces New Single Stream Recycling Video Content Features "How To" Tutorial on City's new Sanitation Program

Reporting on the encouraging response of Glen Cove's launch of Single Stream Recycling, Mayor Reggie Spinello said, "City residents have demonstrated great enthusiasm for this program and our Sanitation team has seen notable increases in the number of recyclables being picked up in just a few weeks." To maintain the momentum for the adoption of Single Stream Recycling by residents, The City of Glen Cove has created a Single Stream Recycling video tutorial which is now available on the City's web site, www.glen Cove-li.us. The new video features an overview of the new recycling program and shows what can and cannot be recycled.

The Single Stream Recycling program features an "All In, One Bin" approach which allows residents to deposit paper, newspapers, magazines, cereal boxes, cardboard, metal and aluminum cans, junk mail, glass jars and bottles, plastics and plastic containers all in the same recycling bin. Residents may choose to continue to use their blue Glen Cove recycling bins or for those looking to recycle more, free Single Stream Recycling stickers are available at the Department of Public Works office (9

Glen Street; 3rd floor) to designate a larger traditional garbage can as their exclusive recycling receptacle.

As part of their marketing efforts, Glen Cove Department of Sanitation Supervisor Doug Poncet and Recycling Coordinator Stephanie Soter have attended several City events including Downtown Sounds, National Night Out, and the Morgan Park Summer Music Festival to promote the new program, distribute Single Stream Recycling Stickers and answer resident's questions. Community members continued to be surprised to learn that with Single Stream Recycling you can recycle books, magazines, most plastic toys, plastic coat hangers, rinsed glass bottles, and metals like a toaster oven – all in, one blue recycling bin. They were also reminded that some items like

Solo drinking cups, plastic blinds, juice boxes and metal coat hangers cannot be recycled with this program and should be put in with regular trash. Plastic grocery bags are not recyclable and should be returned to your grocery store or thrown out with your regular trash.

An Open Letter to Councilman Anthony Gallo Sent for publication...

Your plan for fiscal prudence calls for a 10% reduction in expenses over a two year period. Please be specific as to where those expense reductions are coming from. Since personnel costs make up the bulk of the city's expenses, the voters would like to know which hard working city employees you intend to put on the unemployment line. Your proposed 10% reduction in expenses would absolutely have to include layoffs thus resulting also in a reduction of some vital services.

"Push" has now come to "shove." You have to be more "transparent" with the voters. Your political platform identifies such issues as tax reduction, creating government efficiencies, overdevelopment, balancing the budget, reducing debt, creating enhanced recreation, protecting city assets, and implementing business-friendly atmospheres.

Sir, a lot of us are good at identifying perceived rather than real problems, but don't have a clue as to how to solve either of them except with empty rhetoric. Are you possibly in that same category as so many of the rest of us are? The voters have heard nothing from you as to how you plan to actually solve any of the alleged problems you have identified.

Perhaps the voters will recognize that Mayor Spinello has been educated in the private sector as to what it takes to be highly successful in planning, organizing, administering, directing, overseeing, establishing spans of control, and evaluating the activities and operations of corporate business. He has applied these successful concepts as the Mayor of the City of Glen Cove in the venues of public safety, community development, administrative services, operations and maintenance, parks, recreation, facilities, and administration. Mr. Gallo you are not even a department head in the school system so how can the voters intelligently determine what qualifies you in any way at present to be our mayor?

Mr. Gallo, will you describe to the voters as to exactly how you plan to facilitate the development and implementation of long and short range plans, policies, goals, objectives, programs and time lines to provide the City with technical and administrative direction in meeting and maintaining City service's standards better than Mayor Spinello has been doing? Perhaps you should recognize that to do any of the above is more of a science than it is an art, neither of which you are sufficiently prepared for.

Mr. Gallo, also, please tell the voters precisely how you will create government efficiencies. Are you implying in any way that our co-terminus police, fire, EMS and/or public works departments are inefficient. They are our professionals. What do you know as a physical education

teacher and coach for instance about any of the management, leadership qualities and duties mandated for police / fire / EMS or public works departments that the Mayor Spinello and/or the current heads of those departments don't know? If you are identifying perceived problems with state and federal governments, what are your solutions concerning lines of communication, coordination and cooperation without interfering with established protocols?

You are a good teacher and coach, but in summary, there doesn't seem to be any data in your academic or professional vitae that the voters can possibly equate with you becoming the mayor or the CEO of a city such as Glen Cove any more than my own academic and professional credentials would qualify me for being a mayor.

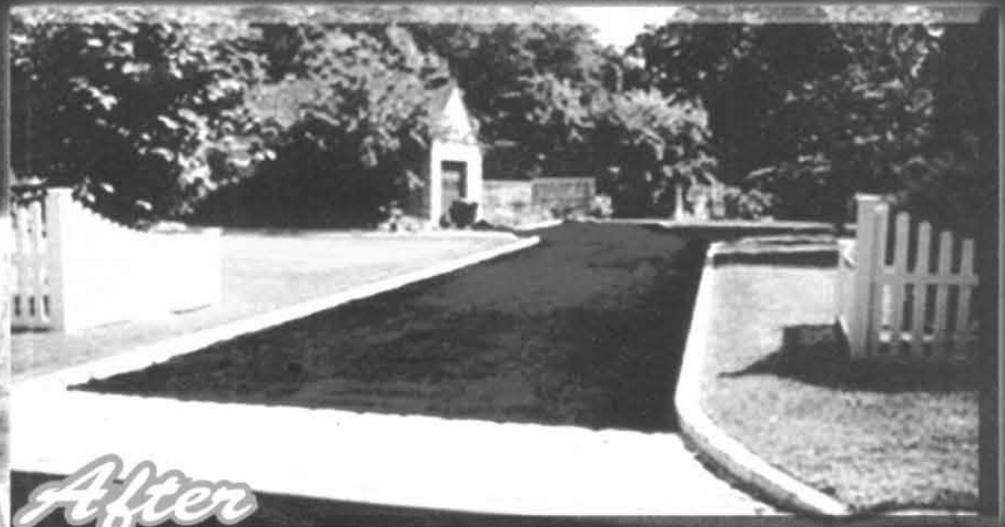

Assemblyman Lavine Delivers Bullet Aid to "Friends of Glen Cove Youth Bureau"

In the last legislative session Assemblyman Charles Lavine allocated \$25,000 in state funds to the Friends of the Glen Cove Youth Bureau.

The Friends of the Glen Cove Youth Board is a not-for-profit 501(c)(3) organization that was formed for the purpose of supporting and augmenting many of the programs that are offered by the Glen Cove Youth Bureau. The Glen Cove Youth Bureau, established in 1981, is a program dedicated to providing a safe and welcoming environment so that all youth can reach their full potential. The Youth Bureau provides several different programs for youth such as summer camp, youth employment, mentoring, and their premier program; Glen Cove after 3. Glen Cove After 3 is a free program, 3 hours a day, 5 days a week, that is offered to all Glen Cove residents in grades 3-8. At the elementary schools the focus is on an integrated arts and literary program with academic support and healthy physical development activities. At the middle school the program includes college and career centers along with integrated academic support and healthy lifestyles.

"The children of our community will live with the decisions that we make long after we are gone," said Assemblyman Lavine. "I am happy that we have decided to invest in the education of our youth, so that they can grow up to positively impact our society."

In addition to the aid delivered to The Friends of the Glen Cove Youth Bureau, Assemblyman Lavine also allocated funds to the Espoir Youth Program, the Nassau County Arts Museum and the Henry Viscardi School.

Safe Honored For Keeping Glen Cove Safe



On April 28th, Glen Cove Patch featured an article recognizing Glen Cove as one of the safest cities in America. Safewise, a community-focused security organization that researches community safety, placed Glen Cove in the top 100 because: "Relatively diverse, Glen Cove takes the health and safety of its residents seriously. Glen Cove supports "S.A.F.E." (Substance Abuse Free Environment), a community organization that works with other nonprofits, city government, and local businesses to eliminate alcohol and substance abuse."

Using 2013 crime data, Glen Cove was ranked number 76. With a population of 27,134, Glen Cove received these rankings based on low statistics of violent crimes and property crimes per 1,000 people. 0.62% of Violent Crimes per 1,000 and 5.41% of Property Crimes per 1,000 were yielded.

At the July 28th City Council Meeting, SAFE, Inc was honored by the Mayor & City Council for this national recognition.

Accepting the citation on behalf SAFE, Board Chair and Coalition Strategic Planner, Georgie Connett stated "it is greatly rewarding to be acknowledged by the Safewise organization and the Mayor and City Council who are tremendously supportive of SAFE and its mission".

Substance Abuse Free Environment (SAFE, Inc.) formed a community based Coalition in 2003 to change societal norms about alcohol and substance abuse and to address the risk factors that contribute to them. The Coalition is overseen by SAFE's Board of Directors and Co-Chaired by SAFE Executive Director, Dr. Sharon Harris and City Councilman Tony Gallo. It is composed of twelve sectors of the community: Youth (an individual 18 or under), Parents/Youth Caregivers, Business Community, Media, School, Youth-serving Organization, Law Enforcement, Religious Organizations, Civic Organizations, Healthcare Professionals, and Local Agencies with Expertise in the

Field of Substance Abuse and associated issues.

For the last twelve years, the Coalition has dedicated itself to its mission of eliminating alcohol and substance abuse through strategic planning using local prevention needs assessment data. Coalition members were in attendance and represent a cross section of the Glen Cove Community. Members actively participate on one of four established Coalition Committees, each with its own charge. The Community Committee, Chaired by Councilman Anthony Gallo, serves as a think tank to examine needs assessment data and make recommendations regarding underage binge drinking, enforcement of underage drinking laws and social host laws.

The School Committee, Chaired by Denise Kiernan, Director of Health and Physical Education for the Glen Cove School District, utilize prevention needs assessment data to identify and provide Alcohol, Tobacco & Other

Drugs (ATOD) prevention activities, and programs for youth.

The Parent Committee, Chaired by Laurent Caballero, acts as a bi-lingual parent resource for prevention, education, intervention, and research on alcohol and drug abuse.

The Youth Committee, Co-Chaired by Arlene O'Dell, Executive Director of the Glen Cove Youth Bureau and Melissa Rhodes, Executive Director of the Glen Cove Boys and Girls Club utilize needs assessment data to identify and provide prevention activities and programs for youth and participate in all planning activities regarding youth that help to reduce youth drug and alcohol use.

City of Glen Cove Mid-Year 2015 Budget Update

Mayor Spinello Reports Finances on Target with Potential Upside at Year's End

August 12, 2015...Glen Cove Mayor Reggie Spinello reported today that a mid-year budget evaluation showed strong year-to-date improvements and that his initiatives to find cost savings, manage expenses and find new revenue streams for the City are on track to deliver a balanced budget. And, if current trends continue, the city could generate an operating surplus at the close of the 2015 fiscal year.

Mayor Spinello attributes this important news to a number of sound financial decisions and business imperatives that have benefited the City of Glen Cove. Here are some topline highlights from the 2015 mid-term budget review:

- The Voluntary Separation Incentive Plan offered to employees will save over

\$400,000 in annual payroll costs and benefits, this year alone.

- The aggressive settlement of lawsuits on behalf of the City has resulted in \$1mm in budget revenues for 2015 of which 75% has already been collected. Additionally, illegal housing and code violations have yielded \$105,525 in fines through July, 2015. This is \$20,000 more than was previously budgeted for the entire 2015 year.

- A mutual agreement was reached with Safavieh whereby they would not renew their PILOT (Payment in Lieu of Taxes). The PILOT, which began in 2005, provided cost savings to assist them in the first several years of

operations. Beginning in January, 2015 the company is paying full taxes to the City of Glen Cove and the Glen Cove School District.

- Improved controls and procedures have saved the City \$120,000 in police overtime.

"Glen Cove's total 2015 budget is approximately \$50 million dollars and to effectively manage a budget of that magnitude, one needs to leverage their business acumen and management experience to have a deep understanding of where we can save money, where there are long-standing challenges that need to

be fixed, where we can find an upside through creating new revenue streams and where we can make things easier for our residents," said Mayor Spinello.

"In fact, our comptroller has been meeting with banks and credit card processors since March to create more convenient ways for City residents to pay for various program registrations and fees." By October Glen Cove residents will be able to pay their water bills online with a credit card.

Glen Cove's 2015 budget was the first budget created by Mayor Spinello and his leadership team.

Gold Coast Public Library Building Initiative Update

At the Gold Coast Public Library's monthly Board of Trustees meeting on Wednesday, August 19, Russell Davidson of KG&D Architects presented three preliminary designs for the library's proposed new building. The library has entered into a contract to purchase the Halm Industries property, 180 Glen Head Road, where the new building would be located if the public votes to approve the project.

To gather community feedback on the proposed designs, the library will hold a series of focus groups beginning on Thursday, September 10th. More sessions will be added to garner greater community feedback.

Prior registration is needed because only 50 residents can participate at each session due to the space limits of the Library Annex. Sign up in person, online at www.thenewgoldcoastpubliclibrary.org, or by calling the Library at 516-759-8300.

Given the proximity of the proposed site to surrounding neighborhoods, the board reiterated that it will continue to consult with those residents and the entire community regarding the future of the land not used for the new building. If the library moves to sell any of the remaining land, that sale and subsequent use would be subject to public approval.

In July, The Library and Halm Industries signed a contract with a

purchase price of \$5.7M for the 5.3 acre parcel contingent upon voter approval of the total project-building/land purchase and the design and construction of a new library building--through a public referendum to be held in late fall or early winter. Preliminary design estimates remain within the range of original rough calculations made at the outset based on generally known costs. At present, the completed project appears somewhere in the \$17 - \$19 million range, subject to a considerable amount of refinement yet to occur as a result of ongoing public input.

While residents of the different incorporated villages, the Town of Oyster Bay and a small number within the Town of North Hempstead have slightly different tax rates, all pay between 0.8% and 1.1% of their real estate taxes for library. The library's building initiative website will soon have available a tax calculator to help district residents see the projected share of cost for their properties.
