## All Saints Catholic Celebrates Two Historic Milestones

This coming school year will be a very exciting one for our local Catholic School, All Saints Regional Catholic School. This month marks not only ASR's 25th Anniversary, but also begins the 100th year of Catholic school education on the Gold Coast.

St. Patrick School was dedicated on September 6, 1915 in the same landmark building now occupied by All Saints. Three more Catholic schools opened in surrounding communities during the early to mid-20th Century: St. Boniface, Sea Cliff, St. Hyacinth, Glen Head and St. Mary, Roslyn.

These schools were founded to provide a high-quality faith based education to the families of this part of Long Island, including the children of the many Catholic immigrants who have always come to this area.

The four original parish schools joined together in 1990 to form All Saints Regional Catholic School. The school is supported by those four parishes, joined by St. Rocco's in Glen Cove, and by generous benefactors who support the school's mission.

To mark these two major anniversaries, All Saints is planning a number of celebratory events during school year 2015-16, starting in October with an historic reenactment of the original

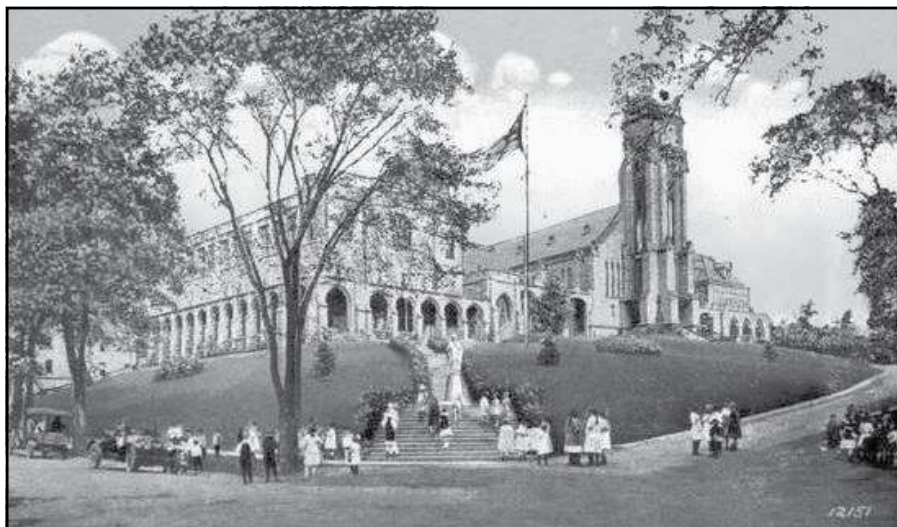

**Dear Great Book Guru,**  
*School has opened and we are looking at Labor Day weekend- last chance for breakfast at Sea Cliff Beach Café- a favorite activity of so many of us. I wonder if you have a really compelling book for me to read as the sun sets on another beautiful Sea Cliff summer? Labor Day Beach Lounger*

Dear Labor Day Beach Lounger,  
I have spent the last days of August reading a fascinating book: THE BROTHERS by Stephen Kinzer. He asks the question "Why is America so hated in so many parts of the world?" and he answers "The Dulles Brothers." John Foster Dulles and Allen Dulles were major players on the world stage throughout most of the twentieth century culminating in the 1950's when John Foster served as U.S. Secretary of State and Allen was head of the newly formed Central Intelligence Agency. The brothers plotted assassinations, overthrew governments, and saw themselves as

singlehandedly fighting the Cold War. Cuba, Vietnam, Indonesia, Guatemala, Korea, most of Africa, and Eastern Europe are just some of the places that felt their wrath -a wrath that at times took on biblical proportions becoming for them truly a battle between good and evil. Presidents Eisenhower, Kennedy, and Johnson, Winston Churchill, Nikita Khrushchev, Patrice Lumumba and Fidel Castro all come in for deft scrutiny and vivid characterization. Interestingly, his concluding chapter tempers all that came before by placing some of the blame on the American ethos- that the story of the Dulles brothers is really the story of the American people. Highly recommended!

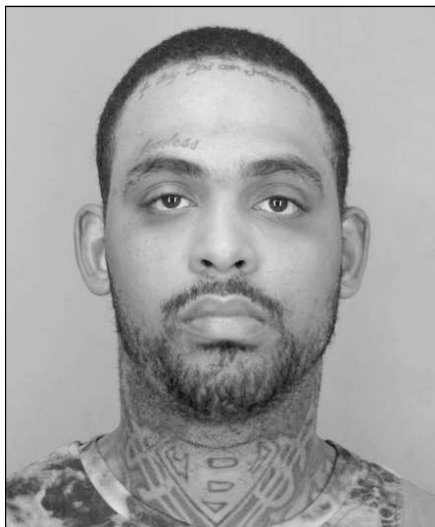

## Hempstead Man Caught In Glen Cove



On August 20th Glen Cove detectives Brian Glennon and Eddy Linares Pulled over a vehicle on The Place in Glen Cove on August 20th and inside the vehicle was 32 year old Kashawn Jackson of Hempstead, who the detective's knew was wanted for a violation of federal

Probation and a pending domestic violence charge from the New York City Police Department.

At the time of his arrest the detectives found a loaded 9 mm handgun wrapped in a Halloween mask inside the vehicle. The defendant was charged with Criminal Possession of a Weapon 2nd degree, Criminal Possession of a Weapon 3rd degree, Criminal Possession of a Firearm, Criminal Possession of a Weapon 4th degree, and Violation of Probation. The defendant will be arraigned this date at First District Court in Hempstead. Detective Lieutenant John Nagle of the Glen Cove Police praised the joint efforts of the NYPD, Federal Probation, and the entire Glen Cove detective Division in making this arrest. "We all worked together sharing information which was used by the Glen Cove detective division to make this arrest and to take another illegal handgun off the streets of Glen Cove."

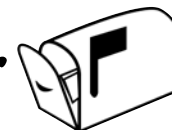

**International Beach Cleanup**  
**Coordinated Locally at Tappen Beach**

On Saturday, September 26, 9:30 to 11:30 AM, the Coalition to Save Hempstead Harbor will be coordinating the efforts of local volunteers to cover parts of the eastern shore of Hempstead Harbor as part of the Annual International Coastal Cleanup, sponsored by the Ocean Conservancy and the American Littoral Society. The weekends in September are dedicated to this program, and communities worldwide will be hitting the beaches to clean up debris from as many miles of shoreline as the number of volunteers will allow.

The cleanup is intended as much more than a one-shot attempt at getting rid of the garbage that washes up on our beaches. Instead, the volunteers who participate in the cleanup will be contributing to a massive data-collection effort. They will record and weigh the various types of debris found on the shore. The information is then sent to Ocean Conservancy, entered into a database, and analyzed to see whether there are changes in the amounts or types of debris that had been found in previous years. In the past, the data collected from the beach cleanup had been used to approach manufacturers to change the types of materials that frequently end up as floatable debris.

In 2014, the New York State Beach Cleanup included 6,800 volunteers who removed 92,677 pounds of debris from over 245 miles of shoreline! Here are the numbers for the items that made it to the top of the list in New York State: cigarette butts (49,773), plastic pieces (35,766), plastic bottle caps (35,766), food wrappers (candy, chips, etc.) (25,139), foam pieces (21,563), plastic beverage bottles (16,711), glass pieces (16,008), straws and stirrers (15,487), metal bottle caps (8,858), beverage cans (8,037), glass beverage bottles (7,777), plastic bags other than grocery (7,646).

On September 26, 9:30-11:30 AM, volunteers will work in teams to make the process of picking up and documenting material easier. All are invited to participate--students, seniors, families, and members of community organizations. Bring work gloves. All other supplies (bags, pencils, data cards, etc.) will be distributed to volunteers who will meet at the entrances of Tappen Beach. This is a great opportunity to do something meaningful for the environment--a perfect way to think globally but act locally.

## **Shamefully trying to thwart freedom of speech, again**

We listened to Mayor Spinello read the latest statement from the Glen Cove Neighborhood Association (the landlord for the YMCA) at the Council meeting on 8/25 and are very concerned that it tries to stifle freedom of speech again, as was attempted by the Mayor in his letter to local publications in April by labeling those who speak up as agitators or troublemakers.

Mayor Spinello wrote in April "By doing what they're doing, they've accomplished nothing except to make it even more difficult for the parties involved to reach an agreement (on the Y lease renewal)."

The latest release from the GCNA this week states "It is obvious that these rumors and misinformation are being circulated by individuals who are motivated by their own personal agendas having nothing to do with the best interests of this facility and are negatively affecting our ability to negotiate with the YMCA of Long Island for the extension of its lease of the property".

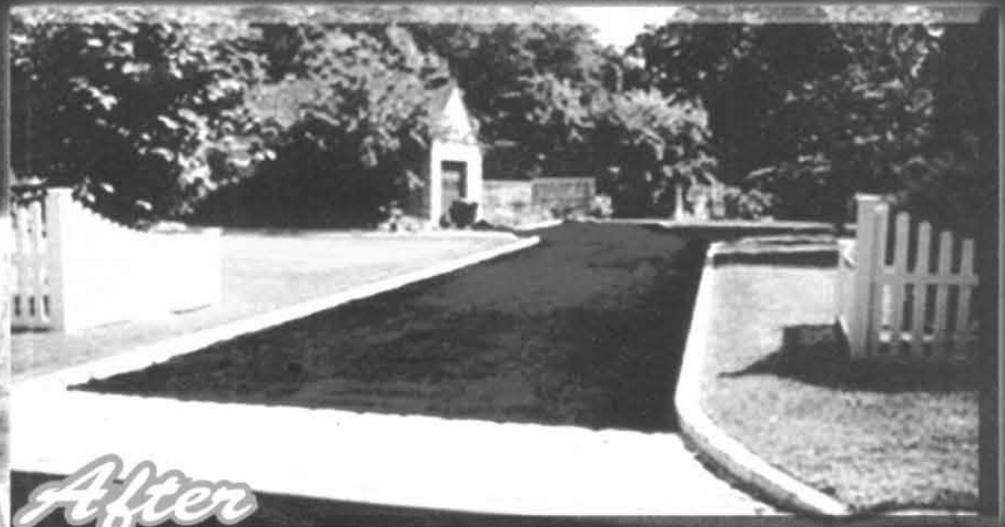

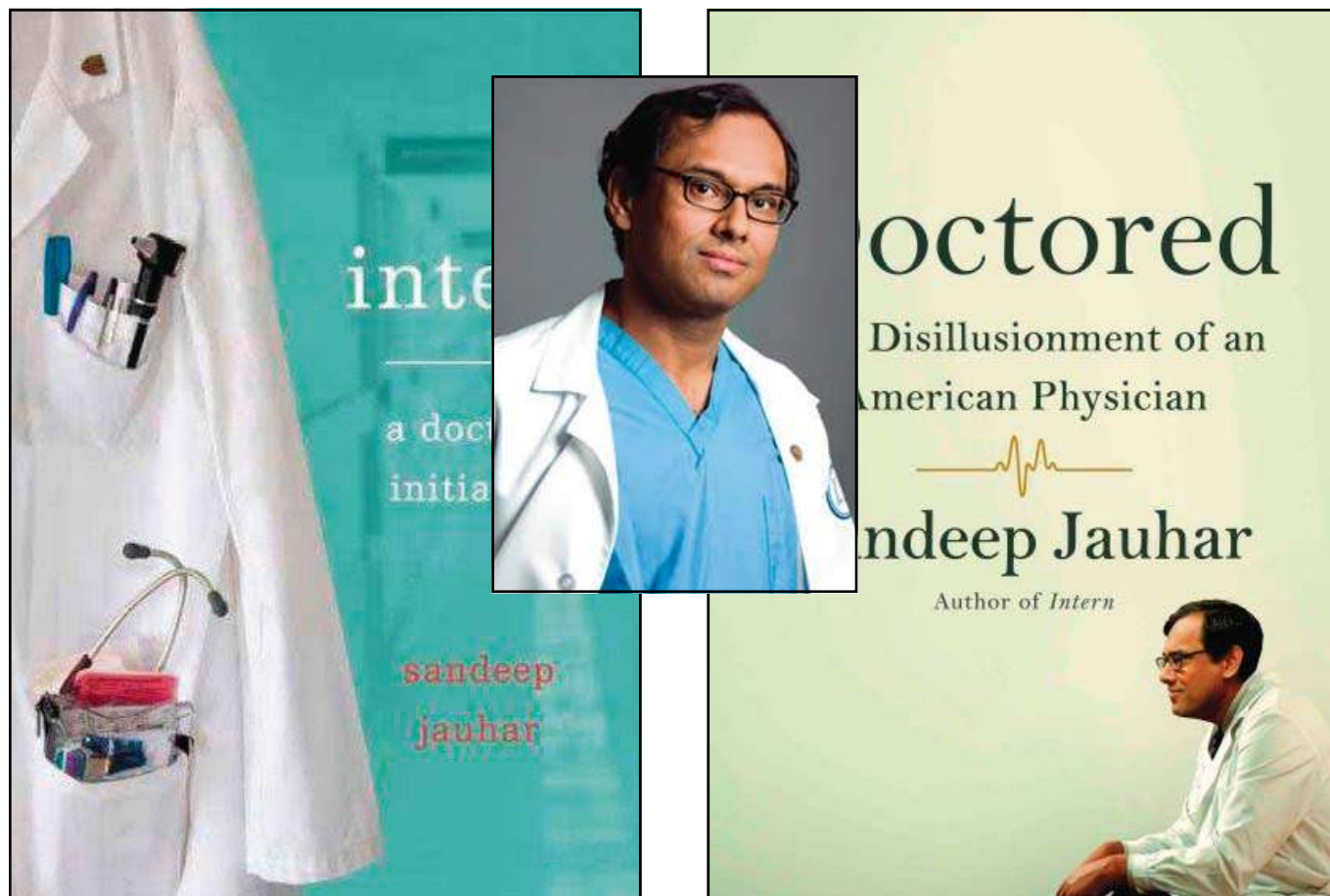
## Cardiologist and Author Sandeep Jauhar to Visit the Gold Coast Public Library

## Local Historian Bill Finlayson Shares Family Stories at NSHM

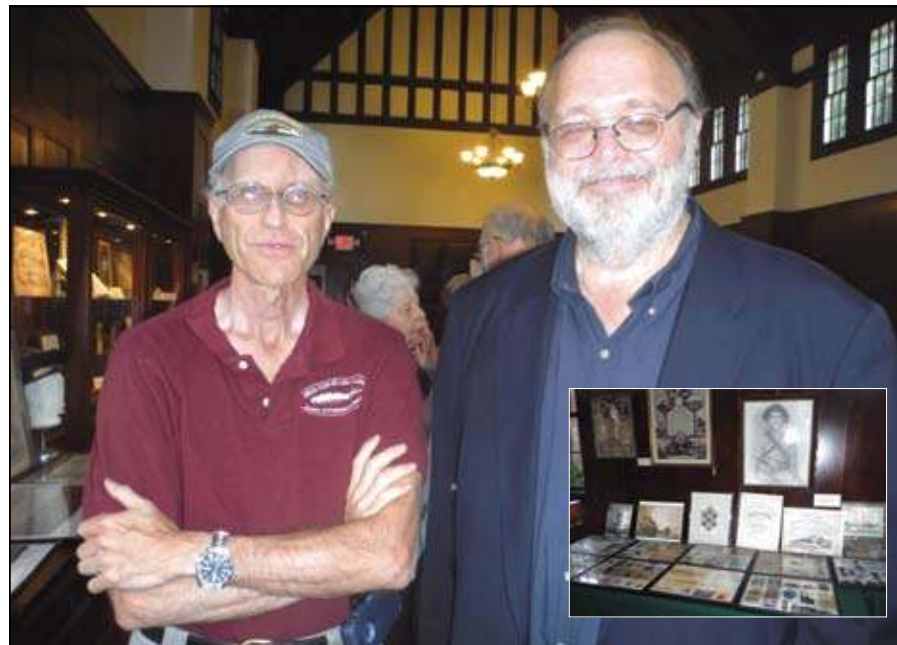

# Name the Celebrity



This week's celebrity was born on June 6, 1875 in Waterbury, Connecticut. He appeared as an actor in over 325 movies over a 41 year career from 1911 to 1951, and directed forty-four silent films from 1912 to 1917. Early in his career, he was a singer in minstrel shows, and toured the U.S. extensively for two years with stage productions. He made his first silent film in 1911, a dramatic short entitled "The Scarlet Letter" made by Carl Laemmle's Independent Moving Pictures Company (IMP), the forerunner of Universal Pictures. He continued to act in numerous films each year from that time on, and by 1912 he was directing them, as well.

The first film he directed was "The Worth of a Man", another dramatic short, again for IMP, and he was to direct 43 more films until his last in 1917, "Over the Fence", when he co-directed with Harold Lloyd. Our celebrity had crossed paths with Lloyd several years earlier, when Lloyd was an extra and our celebrity had given him much-needed work. He did the same thing for Hal Roach, both of whom appeared in small roles in "The Patchwork Girl of Oz", which our celebrity directed in 1914 and produced by L. Frank Baum's The Oz Film Manufacturing Company. When Roach set up his own studio, with Lloyd as his principal attraction, he hired our celebrity to direct. In 1918, our celebrity, who became one of the most beloved character men in Hollywood, had given up

directing and was acting full time. With a voice that matches his personality, he made the transition to sound films easily. A highlight of this period was his performance as the hobo, "Mr. Tramp", in "Our Little Girl" (1935) with Shirley Temple. In Frank Capra's "It's a Wonderful Life" (1946) with Jimmy Stewart, he played the owner of the tree damaged by "George Bailey" with his car.

### Last Week's Celebrity

Last week's celebrity was born Bowen Charlton Tufts III, but we know him professionally as Sonny Tufts. He was born into a prominent banking family. The Tufts family patriarch, Peter Tufts, sailed to America from Wilby, Norfolk, England in 1638. His great uncle was businessman and philanthropist Charles Tufts, for whom Tufts University is named.

After making his first film, "So Proudly We Hail" (1943), he received over 1700 fan letters a week and was named "The Find of 1943." The following year, he was cast opposite Olivia de Havilland in the comedy "Government Girl." That same year, he was voted the number one "Star of Tomorrow" by exhibitors. The next film after that was "I Love a Soldier" (1944), again with Paulette Goddard. During WWII, his popularity continued to rise principally because due to an old college football injury, he was one of the few male actors not serving overseas in the war. By the early 1950s, his popularity began to wane and he was cast opposite Barbara Payton in a low budget comedy film, "Run for the Hills."

His career briefly rebounded when he was cast in a small role in the comedy "The Seven Year Itch" (1955), starring Tom Ewell and Marilyn Monroe. Tufts career decline was compounded by his alcoholism and his off-screen antics. On June 4, 1970, he died of pneumonia at age 58.

I believe I could help bring fiscal responsibility and transparency to the Library Board.

## International Beach Cleanup Coordinated Locally at Tappen Beach

On Saturday, September 26, 9:30 to 11:30 AM, the Coalition to Save Hempstead Harbor will be coordinating the efforts of local volunteers to cover parts of the eastern shore of Hempstead Harbor as part of the Annual International Coastal Cleanup, sponsored by the Ocean Conservancy and the American Littoral Society. The weekends in September are dedicated to this program, and communities worldwide will be hitting the beaches to clean up debris from as many miles of shoreline as the number of volunteers will allow.

The cleanup is intended as much more than a one-shot attempt at getting rid of the garbage that washes up on our beaches. Instead, the volunteers who participate in the cleanup will be contributing to a massive data-collection effort. They will record and weigh the various types of debris found on the shore. The information is then sent to Ocean Conservancy, entered into a database, and analyzed to see whether there are changes in the amounts or types of debris that had been found in previous years. In the past, the data collected from the beach cleanup had been used to approach manufacturers to change the types of materials that frequently end up as floatable debris.

In 2014, the New York State Beach Cleanup included 6,800 volunteers who removed 92,677 pounds of debris from over 245 miles of shoreline! Here are the numbers for the items that made it to the top of the list in New York State: cigarette butts (49,773), plastic pieces (35,766), plastic bottle caps (35,766), food wrappers (candy, chips, etc.) (25,139), foam pieces (21,563), plastic beverage bottles (16,711), glass pieces (16,008), straws and stirrers (15,487), metal bottle caps (8,858), beverage cans (8,037), glass beverage bottles (7,777), plastic bags other than grocery (7,646).

On September 26, 9:30-11:30 AM, volunteers will work in teams to make the process of picking up and documenting material easier. All are invited to participate--students, seniors, families, and members of community organizations. Bring work gloves. All other supplies (bags, pencils, data cards, etc.) will be distributed to volunteers who will meet at the entrances of Tappen Beach. This is a great opportunity to do something meaningful for the environment--a perfect way to think globally but act locally.

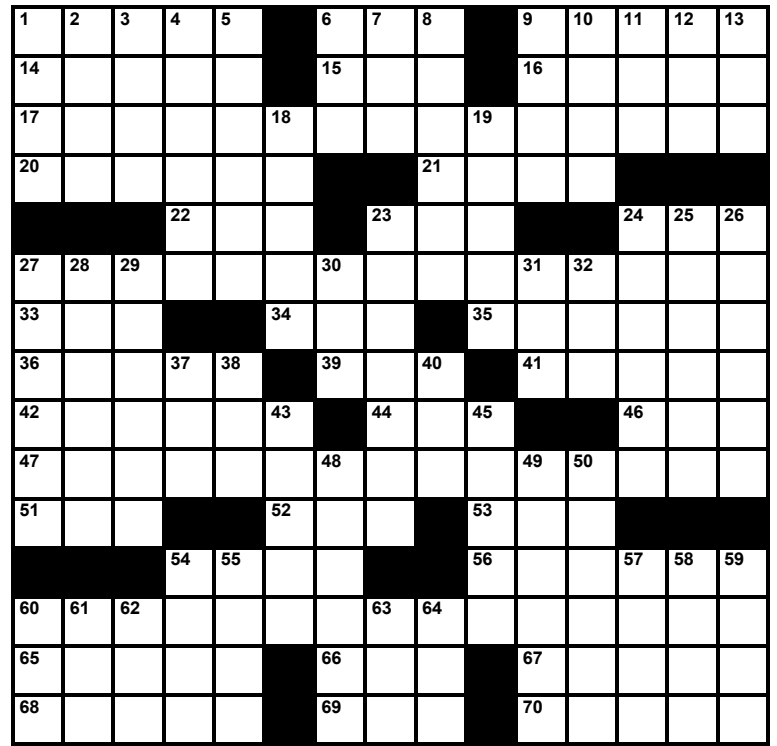
