Important Information about the Gold Coast Public Library Budget and Building Proposal

Dear Gold Coast Library District Resident,

We're writing to remind you that the vote on the Library's 2016 budget is right around the corner —Wednesday, September 9. We also want to correct unsubstantiated assertions being circulated around the community.

The Library 2016 Budget Vote and Trustee Election are the ONLY items on the ballot.

A new building proposal is under development but is NOT part of the September 9 vote. No final decisions have been established on the new building proposal. Ample community dialogue will continue on this important concept.

The Library board presents a budget each year for the public to approve.

The proposed 2016 budget increase of \$11,890 over 2015, at 0.74%, is below the State Tax Cap.

The Library accounts for between 0.8% and 1.16% of your total property tax, depending on your address. For example, if your taxes total \$12,000 before any deductions, you pay between \$96 and \$139 annually to support the library.

The Library District created by referendum in 2001 became a real place ten years ago. The budget for the first full year of operation was \$1,044,604. The budget has increased in response to resident desires for programs and services, as approved in every annual budget that has been presented.

10 years later the proposed 2016 budget is \$1,616,845. This represents a 54% increase in a decade. When the Library opened, it was closed on Wednesdays and Sundays. There was no Annex building to provide regular programming to the community. In the 10 years since opening, Library circulation has nearly doubled, from 63,931 in 2006 to 112,323 in 2014. Offerings and attendance in programming have increased from 195 programs with 2,667 attendees in 2006 to 591 programs with 8,729 attendees in 2014. Programs take place one at a time in our Annex, which has a space limit of 50 people, costs the Library \$60,000 each year to rent, and is being sold to investors. The Library's lease expires in May of 2016.

We value our employees. They provide you with library programs and services.

The chart below shows that salaries and benefits for our staff have increased by an average of about 2% each of the past several years, 10.2% total, not by the 50% asserted by unsubstantiated claim.

The Board of Trustees oversees the Library's finances. An independent CPA conducts an annual audit.

One claim circulating is that the reserves are hidden from the public. Perhaps this arises from a misunderstanding of proper reporting procedure. Generally accepted accounting principles place any reserve or fund balance on the organization's balance sheet and financial statement. A budget is a compilation of anticipated expenditures. The \$1.5M reserve reflects conservative, mindful budgeting and cost savings over a period of several years. It is also the result of prudent investments and the realization of the payments in lieu of taxes (PILOT) from LIPA. The Library will continue to receive these PILOT payments through 2027. The Library now allocates a portion of these funds annually as reflected in our budget.

Over the years, we have generally used reserves to reduce taxes and for capital improvements to the building. This year, we had to use \$100,000 for a new elevator. The Board has set aside \$200,000 for future repairs of our HVAC system and for roof repairs if they are needed. These decisions were made so that we wouldn't need to ask the voters for additional funding. \$1.2M of the reserve will be used for the new building project, if voters approve the referendum, or toward other capital expenditure for future expansion.

The impact of LIPA is uncertain, but we monitor it carefully.

The contention that the impending loss of LIPA would have a sudden significant impact on the community's tax base remains undetermined. Simply put, nobody knows what is going to happen and it could be years before the outcome in known. We communicate with local legislators and elected officials. No one has been able to provide a definitive answer. The best guess right now, based on interpretation of existing law, is that the impact of losing LIPA will be 1% a year. We, along with the rest of the community, are interested in the outcome of pending lawsuits and legislative initiatives to offset LIPA's closing of its local power plant.

to public libraries and the term "library" is not a one-size-fits-all description. Public libraries are community meeting places, cultural centers, creative venues, information hot spots and, most importantly, places for lifelong learning in all the ways that can happen — ink on paper, digital information, events, programs, etc.

The type of project proposed for Gold Coast is happening throughout Long Island, across New York and the nation. Libraries here and elsewhere have had to re-invent, re-task and add space to meet the evolving role they play in the communities they serve.

The notion that we don't need libraries anymore — because we have the internet, or that libraries are solely about reading — simply does not acknowledge that these transformative and vibrant community assets are not just buildings with books. Public libraries on Long Island are at least as well known for what goes on inside their buildings as the buildings alone.

Developing opportunities is part of responsible stewardship of the community's resources.

The trustees have the responsibility to keep the Library vital and viable. Statistical analysis of surveys and focus groups held in 2010, plus ongoing experience, continue to point to lack of

The Library board looked at a variety of options before selecting the Halm Property for public consideration. In the proposed location, the Library would support all the activity in the area, including the ball fields. Adjacent, complementary parking creates efficiency of space, curtails costs and supports present and future use. Our present location has four 15-minute parking spots in a shared lot with LIRR commuters.

Staffing

The claim that the proposed building would double the Library's personnel expense is incorrect, but it does help show an important part of our quandary — the structural inefficiency that we cannot address in our current configuration. We presently have to staff two locations and more than one floor. A new building on one floor would require no additional staff other than a custodian.

Library v. Developer

To be absolutely clear, the Library did not outbid any investor interested in the property. The owners of the Halm property made the decision to work with the Library and accepted a lower offer than those proposed by other interested parties. The notion that a private developer would add noticeably to the tax base is not supported. Based on what had been proposed by a developer, the offset to the area's tax base would be about 0.3% —not enough to substantially lower anyone's real property taxes.

The proposed estimates of between \$14 and \$18 million dollars for a new building are just that, estimates. Designs remain the subject of a series of community input sessions currently scheduled. It should be noted that the board entered the process with the intention that any project add less than \$100 to the financial obligation of the majority of homes. Our independent financial consultant estimates the maximum increase in your overall tax at 0.6% — that's 6/10s of 1%. We do intend to sell the present building



so that it is put back on the tax rolls. The Library has a tax calculator available to you at www. thenewgoldcoastpubliclibrary.org where you can see what the impact of the funding for a new building will be to

A Very Foolish Proposal To The Editor,

At the Glen Cove City Council meeting of August 25th, a proposal on the agenda was put forth by Mayor Spinello, to install a stop sign on the corners of Oak Lane and Dosoris Way, to try to prevent speeding and accidents. I think that this proposal is very misguided. According to a few residents of Oak Lane, there have been accidents on that intersection. I do not believe that there were as many as one resident suggested.

I have had my business on the corner of Dosoris Way and School Street for 38 years, and though I am two streets away from the Oak Lane intersection, I travel the full length of Dosoris Way several times every day of the week, for all the years I have been here. Although there may have been accidents at times, as there are occasionally on virtually every intersection of every street in every

community over enough years, I can not recall seeing or hearing of any accidents along that road, except for the two which involved my truck, which was parked in my lot, during the past year.

I have studied that intersection since the meeting, at all hours of the day and night, and I observed, from the Oak Lane intersection, that oncoming traffic is easily visible coming in either direction along Dosoris Way. When there are cars parked on Dosoris, it is more difficult to see oncoming traffic, especially coming from Walnut Road because of a slight rise in the pavement at that point, but from the left, there is clear visability all the way to Stuart Drive if there are just a few, or no cars parked on Dosoris Way.

Though I am not in favor of speeding, I have observed countless police and emergency vehicles traveling at speeds well above the speed limit on Dosoris Way. A stop sign would seriously impede these emergency vehicles which routinely use Dosoris as the fastest way to get to the hospital when even seconds count. It is possible that these vehicles might not fully stop at a stop sign, if installed, which could cause, rather than prevent, very serious accidents for drivers entering from Oak Lane, since the expectation is that everyone would be stopping at a sign.

The obvious and only solution to the potential problem is to eliminate permitted parking on the one side of Dosoris Way within 100 feet of the Oak Lane intersection. With that visibility in both directions, it would eliminate any danger whatsoever, and still allow for unimpeded traffic flow. Since speed bumps can be dangerous, and stop signs do not slow drivers down before they get to them anyway, speeding could be easily controlled by the use of police periodically using radar.

Families, School and Civic Groups Invited to Help Cleanup Morgan Park and Pryibil Beaches

September 14, 2015...With Labor Day signifying the closing of Glen Cove's beach season, Saturday, September 19 marks the date where Glen Cove families and groups come together to participate in the annual New York State Beach Cleanup Day. This event raises environmental awareness and underscores how people can take action to improve New York's conservation efforts. Volunteers are asked to meet at 9:00 a.m. at one of two Glen Cove cleanup sites: Morgan Memorial Park on the playground side or at Pryibil Beach. All supplies will be provided for the beach cleanup.

Held in conjunction with the Northeast Chapter of the American Littoral Society, a group dedicated to the study and conservation of marine life and habitat, this New York State Beach Cleanup Day is unique as volunteers will complete data cards to document the items that have been cleaned up. This information will then be sent to The Ocean Conservancy for analysis and past research from the program has been used to create strategies to combat marine pollution.

In 2014, over 6800 volunteers removed and collected data on 46 tons of debris from 245 miles of shorelines across New York State as part of the New York State Beach Cleanup event. "Glen Cove is fortunate to have miles of beautiful beaches and shorelines; in turn, we need to clean and protect our beaches to ensure the viability of our waterscapes and marine life," said Mayor Reggie Spinello. "Through participation in initiatives like the New York State Beach Cleanup which is part of the International Coastal Cleanup program, our community is taking proactive steps for environmental conservation."





Name the Celebrity



This week's celebrity, born in Astoria, Queens on Sept. 16, 1927, was a film and television actor. He made his film debut, in an uncredited role, in the 1939 biopic feature film, "The Story of Alexander Graham Bell" opposite Don Ameche and Loretta Young. He played the young "Matt Clay" in another biopic "Young Mr. Lincoln" (1939) starring Henry Fonda. In 2003, "Young Mr. Lincoln", directed by John Ford and produced by Darryl F. Zanuck, was selected for preservation in the U.S. National Film Registry by the Library f Congress as being "culturally, historically, or aesthetically significant". He was the drunk on the train in "Holiday Affair", a B/W 1949 light comedy with Robert Mitchum and Janet Leigh. He again played opposite Robert Mitchum in the 1950 film noir thriller "Where Danger Lives", directed by John Farrow and also starring Claude Rains and Faith Domergue, Howard Hughes' latest protégé, at the time. He played one of the outspoken students in the class of "Dr. Noah Praetorius", played by Cary Grant, in "People Will Talk" (1951) with Jeanne Crain. From 1969 to 1971, our

celebrity hosted the NBC daytime game show "Sale of the Century".

Last week's celebrity was born James Ellison Smith, but professionally known as James Ellison. Despite the success of Cecil B. DeMille's film "The Plainsman" in which Ellison played "Buffalo" Bill Cody, our celebrity spent the remainder of his career shuffling between cowboy pictures and more varied roles, primarily in B movies with titles like "Mr. District Attorney in the Carter Case" and "The Undying Monster". He had a supporting role in 1941's "Charley's Aunt" starring Jack Benny. He played the romantic lead in 1943's "The Gang's All Here", a Twenty Century-Fox musical in which he seemed somewhat lost among the vivid antics of Carmen Miranda, Charlotte Greenwood and Edward Everett Horton, and was the only principal not to sing a note. He landed another romantic lead as "Jerry Gibson" in the musical film, "Lady, Let's Dance" (1944), which starred the ice-skating sensation, Belita. She was the British 1935 Winter Olympic skater who placed 16th in the Ladies' Singles competition and like fellow Olympian skater Sonia Henie, turned to films.

In the 1950s, Ellison moved from acting to real estate. Joining fellow veteran Jackie Coogan, Ellison returned to the screen only once to play "Axel 'Longhorn' Gates", in a picture called "When the Girls Take Over" (1962). Ellison died at the age of 83, after suffering a broken neck, as a result of a fall.

Long Island Teen Travels to Italy and Volunteers with African Boat Refugees

Roselle Cacio is a Long Island high-schooler. This summer she took advantage of a trip to visit relatives in Italy to follow her aspiration to be a social worker, by visiting the African boat refugees' first response center of Reggio Calabria, Italy. Roselle wanted to volunteer as a translator. Once there, she listened to the stories of the refugees.

The center is located in the gymnasium building of the Santa Maria del Lume church parish, where some of the refugees are hosted. Most are just waiting for the chance to move on to other locations in Europe, to join friends and relatives. Work opportunities are scarce even for the locals in Southern Italy.


Among the boat refugees that have been rescued by the Italian Coast Guard, the port of Reggio Calabria has received thousands of Africans during the last months. Access to the refugees is restricted, by the Carabinieri (military police) and the Guardia di Finanza (finance police) stationed at the center. Although initial inquiries made to Caritas, the religious organization in charge of the hospitality, went unanswered, Roselle had acquired permission through the Parish reverend, Antonino Sgro, through one of her cousins, so she was initially able to visit the inside of the center. Subsequently she was limited to visit only from the outside, under the supervision of the police.

Particularly sad was the story of a girl from Badagry, Nigeria, about Roselle's age, escaped, leaving all the rest of her family behind, after her brother was killed in a church bombing on Christmas Eve. The followers of Islamic terrorist group Boko Haram have been targeting Christians in Nigeria for months. The girl, who remains unnamed, fled to bordering Libya only to found more chaos and lawlessness, a situation that leaves Nigerians particularly unwanted and target of crimes. After having been raped and beat up badly by the brother of a woman who took her in her house, the girl saw no other way to safety than embarking for the perilous voyage across the Mediterranean Sea on a boat overflowing with Sub Saharan people escaping similar situations.

In spite, or right because of the fact that those people were survivors, Roselle found hope and optimism in the center. The refugees speak no Italian, but most took some English in school. For them it was a welcomed moment when they could have their feelings heard by the people who help them. Reverend Sgro was also pleasantly surprised at the visit, as the locals shun the center because they are wary of the surge of newcomers. The boat refugees rescue by the Italians is very controversial in the rest of Europe because, once in Italy, there are no borders to the rest of Europe. To counteract this, Europe is giving Italy funds to help with the expense of hospitality and keep the immigrants in Italy.

Dear Great Book Guru,



Topics covered throughout the day will include medical, research, audiology, neuropsychological and rehabilitation implications related cochlear implant technology. The program's aim is to provide a comprehensive overview of the changing paradigm in cochlear implantation.

A cochlear implant is a device providing stimulation directly to the auditory nerve. It bypasses damaged hair cells in the cochlea that prevent sound from reaching the nerve. An implant does not restore hearing but allows a person to perceive sounds. Cochlear implants for adults were first approved by the U.S.





Amanda Sobhy Makes History at Pan American Games

Amanda Sobhy added golden luster to her achievements as the USA's best squash player when she made sports history in July by becoming the first squash player to win three gold medals at the Pan American Games. Making her Pan Am Games debut in Toronto, the reigning and two-time national champion started her gold medal campaign by defeating teammate Olivia Blatchford in the singles final and followed up by capturing the doubles title with partner Natalie Grainger. Sobhy closed out her golden sweep, which required her to play 11 matches in six days, by leading the US to victory in the team event as she and Blatchford notched victories to defeat host team Canada.

Playing at Toronto's Exhibition Centre in front of vociferous, sold –out crowds, loudest when her opponent was Canadian, did not daunt the Pan Am Champion. The finals of the team event were especially raucous. "I love that team energy," said Sobhy whose unflappable focus, commanding strength and competitive drive were on full display during the competition. "The rowdier and louder the crowd is, the more I want to get into the match and play."

The 22-year-old Sea Cliff native has competed in the sport's biggest tournaments – including the World Open, the J.P. Morgan Tournament of Champions in NYC's Grand Central Terminal, the Hong Kong Open and the British Open – but representing the US in one of the world's largest international multi-sport competitions was a special thrill. "It was just incredible to be in the athlete village with all these amazing athletes," Sobhy said. "It was fascinating to see all the body shapes of athletes from different sports, and to compare notes on training and competition."

As for marching in the Opening Ceremonies with more than 6,000 athletes, representing 36 sports, from North, Central and South America,

Sobhy grins widely. "I felt like a kid in a candy shop. There was so much to see everywhere you looked – all the athletes, 50,000 spectators and Cirque du Soleil performing. It was such a grand stage – I was in awe!"

Standing on the gold medal podium was incomparable. "I just had the biggest grin and when the national anthem played, I got goose bumps," recalls Sobhy. "I was filled with pride and patriotism. The best was the team podium because there was so much more riding on those matches, when you are not just playing for yourself."

Immediately after the Games, Sobhy spent time with family and friends in Sea Cliff, where she loves going to the beach and paddle boarding. The US squash star, who graduated in May from Harvard University where she majored in social anthropology and was undefeated in four years of intercollegiate squash play, won't be resting on her laurels. She is fully committed now to her new career as a touring professional squash player. Sobhy's love of travel will certainly be fulfilled as she competes on the women's international Professional Squash Association tour. In the upcoming five months, she will play tournaments in China, San Francisco, Philadelphia, Monte Carlo, Hong Kong, Qatar and Malaysia before returning to New York City in January for the J.P. Morgan Tournament of Champions in Grand Central Terminal.

"I want to be world no. 1 and win the World Open," Sobhy declares. "I also want to make an impact on the sport – especially to help grow it in the US. " As the highest-ranking American ever, world No. 10, in the Professional Squash Association rankings, and with three Pan Am gold medals around her neck, Sobhy is well on her way.
