Local Resident Prays With Pope

Glen Cove resident and Presbyterian Minister Eric Hall participated in a ceremony with Pope Francis last week. The event was, "A Witness to Peace: A Multi-Religious Gathering with Pope Francis, At the National September 11th Memorial and Museum on September

Hall, as Chief Executive Officer of the HealthCare Chaplaincy Network located in NYC has relationships with most religious and spiritual leaders. "Cardinal Dolan was kind enough to extend an invitation."

Hall was there representing the Presbyterian Church as Presbyterian Minister as well as representing healthcare chaplains (HealthCare Chaplaincy Network is the national leader in research, education and clinical care integrating spiritual care into the nation's health care system).

Hall said he traveled by car from Glen Cove, early in the morning. Reaching the Battery Tunnel parking garage was not an issue. "I waited in line for about an hour before going through numerous check points and a significant security search point which allowed me then

Glen Cove Shooting- Suspect Sought

On Tuesday September 29th at approximately 2:45pm the Glen Cove Police Department received a call regarding a shooting on Eldridge Place in Glen Cove. The Glen Cove Police responded to the call and discovered the 22 year old victim on Colonial Gate (a short distance from Eldridge Place). According to Glen Cove Police, the victim was suffering from a gunshot wound to his chest. It was determined that the shooting occurred inside One Eldridge Place in Glen Cove. After being shot inside the residence the victim ran from the home and collapsed a short distance away where police discovered him. Two suspects were observed running from the house after the shooting. The victim was transported to the hospital where he underwent emergency surgery and is currently in critical condition.

Glen Cove Detective Lieutenant John Nagle said, "We are considering this incident a home invasion situation where we believe the victim and shooter are known to each other." to enter the museum which was the site of the Interfaith service. To say there was security present is a gross understatement."

Hall said, "I have had the honor of being in Giants Stadium when Pope John Paul II celebrated liturgy. There was an energy around his presence and his words. This Pope was rather deceiving. His presence and his speaking disarmed you and I believe attributes to his aura."

Below is Hall's first hand account of the experience...

It started with the line outside the 9-11 memorial museum. A couple hundred people waiting to go through security. Next to me, a family who had lost a loved one; a fire fighter (they carried his helmet with love and respect); and clergy behind and in front of me. The conversation? This extraordinary event they had (we had) all been invited to. Each had an excitement in their voice as well as nervousness. This meeting was taking place in no ordinary venue. The fire fighter helmet reminded all of us that this was sacred space - lives sacrificed, lives taken on September 11, 2001.

There were two authentic moments for me. As I sat in the sixth row in front of the stage the Pope entered on the left. As a person who is well over 6 feet tall I get a pretty good view of things but the Pope was tough to spot at first. Then I caught the white of his robes, my eyes followed him as he warmly welcomes the group on both sides of the aisle with his eyes.

He only shook the hands of the interfaith representatives seated with him. He was not there for any of us. This was not an event as all the others in New York. He was there to pay his respects - his face noticeable disturbed by the event that had drawn him to this place.

Moving was the moment when he began to pray. He encouraged love, spoke of tolerance and reminded us of the senseless deaths and the families, friends and city that still grieve. The Pope then asked us to pray. Here representations of practically every faith tradition were assembled and at the Pope's invitation not a sound was heard. Not a picture was taken. Each of us accepted the invitation. You could feel all that is sacred and holy in this space - there in the belly of the site of Ground Zero assembled some 200 ft under ground, you could feel it, God was present.

As a Presbyterian Minister I could not help but see there was a lesson here. No matter where we are. No matter how deep in pain and suffering, doubt and despair when we cannot see the daylight God is present if we dare accept the invitation to pray. And by the way, if you take a moment to look to your left and to your right most often you will find there are others who are just like you and who have accepted the invitation as well.

The Pope left the space and the gathering lingered. We formed a line for the escalader and waited until it would bring all of us back to the light of day. I am grateful for the invitation from Cardinal Dolan to be present. It is an experience I will not soon forget.



The Pope who Visited Glen Cove

Residents of Glen Cove were no different from those of the rest of the nation, and, indeed, of the world, this past week as they sat glued to media watching, or even made personal pilgrimages to witness firsthand, the unforgettable trip by Pope Francis to our shores. The only part of Long Island visited by Francis during his short visit to New York was John F. Kennedy Airport International Airport. Forgotten by or unknown to many local people, however, was the interesting fact that Glen Cove itself and, specifically, our local Catholic school, once enjoyed a visit by an earlier Pope. That event took place nearly 80 years ago.

Cardinal Eugenio Pacelli, Secretary of State for the Vatican under Pope Pius XI, made a trip to New York in 1936. He was, to that date, the highest ranking Vatican official to ever visit the United States. The purported purpose of his trip was a vacation on Long Island, at the invitation of Genevieve Brady to visit her Manhasset estate, "Inis Fada" (Irish for "Long Island"), but the Cardinal was also whisked away on various items of business while here. One such item was to meet with President Franklin D. Roosevelt at Hyde Park to discussed plans to establish U.S. diplomatic relations with the Holy See. Another was to silence a demagogic and anti-Semitic radio personality, Fr. Charles Coughlin.

When he returned to Long Island, Cardinal Pacelli was brought to visit St. Patrick's School in Glen Cove. The school was located the building, dedicated 100 years ago this month, where All Saints Catholic School now operates. Among the people who greeted the Cardinal there was Sister Mary Brunonis, who had been among the original group of religious Sisters to open the school in September, 1915.

Sister Brunonis spent a remarkable career of nearly seven decades teaching at St. Patrick's. In a book published in 1957, she spoke as follows of the Cardinal, who became Pope Pius XII three years after visiting the school: "The late Pope Pius XII was no stranger to St. Patrick's...and there are people living within the parish whose lives will be forever blessed for having heard the sound of his voice and the touch of his hand."

Cardinal Pacelli, soon to be Pope, put into motion while visiting Glen Cove, the

beginnings of one more accomplishment still gratefully enjoyed by local residents. The City's Italian Catholics had long been petitioning for the establishment of an Italian national parish in the area, only to be rebuffed by church authorities who were of the opinion that the then sparsely populated city could not support a third Catholic parish, in addition to St. Patrick's, founded in 1856 after an influx of Irish migrants, and St. Hyacinth, founded to serve Polish Catholics.

Local Italians took advantage of their famous countryman's visit to Glen Cove to urge Cardinal Pacelli, upon his return to Rome, to ask Pope Pius XI to encourage the Bishop of the Diocese of Brooklyn, who then had jurisdiction over all of Long Island, to grant their request for the establishment of an Italian national parish. The fact that the construction of the Church of St. Rocco was underway just a year later is not likely to have been just a coincidence.

In 2015, the beautiful school building which set a stage for the historic first visit of a future Pope to America still stands as one of Glen Cove's most beloved historic landmarks. Catholic school education still thrives there, in the form of All Saints Catholic School, formed 25 years ago with the amalgamation of the area's four local parish schools. Students of the school, their families, alumni of All Saints and of the original schools, along with parishioners of the five local parishes and friends of education and history are taking the opportunity of the All Saints' 25th Anniversary and of the 100th Anniversary of Catholic school education on the Gold Coast to host commemorations and celebrations during school year 2015 – 16. They have also launched a financial appeal, the "Second Century Appeal" to help restore the building and to launch Catholic school education in the area into its Second Century of service to the children of the North Shore. Glen Cove Mayor Criticized By State Comptroller To The Editor,

The Glen Cove election campaign took a 180-degree turn in favor of City Councilman Anthony Gallo Jr. last week when Mayor Reginald Spinello was criticized in a report by State Comptroller Thomas DiNapoli about the city's operating budget, lack of a so-called "rainy day fund" and a high percentage of debt compared with revenues. "Obviously, it paints a very ominous fiscal picture for the City of Glen Cove," Gallo said in a story published by Newsday ("Negative fiscal report puts heat on Spinello", Our Towns, Sept. 25).

Glen Cove incredibly was one of only three state municipalities out of 1,043 examined that moved into a "worse category of fiscal stress" in 2014, Spinello's only full year in office. "This is a timing issue, nothing more," Spinello said. "A report like this is based upon a picture of time." Or could it be a smoke-and-mirrors attempt by the current administration to appease the taxpayers?

Spinello claimed that during his tenure the city has not had to borrow money for cash-flow needs. But Philip Pidot, a councilman candidate on Gallo's slate, said, "That's exactly what they did on Monday" at a public meeting by approving the issuance of \$610,000 in bonds to pay for property tax refunds. Last year the comptroller's office called it "imprudent" for Glen Cove to borrow money to pay for such "routine expenditures." The alleged mismanagement of money by Spinello and his council supporters puts a whole new spin on the mayoral campaign.

The pressure has led Spinello to challenge in court the petitions of the Gallo campaign that would give the challenger the right to run under the newly formed Glen Cove United Party in the Nov. 3 general election after losing to Spinello in the Republican Primary Oct. 10. It has become apparent that Mayor Spinello would rather not have to meet Councilman Gallo, who helped his former colleague to become elected mayor in 2013. Two years have gone by. Gallo has lost confidence and trust in Spinello as leader of the city. Gallo's candidacy gives Glen Cove voters a "choice" at the polls. And he believes he can bring Glen Cove out its fiscal slump.

Dear Pumpkin Patch Partner Sent for publication:

My name is Harry Descheene, I am the Human Resources Director for Pumpkin Patch Fundraisers. I've been with Pumpkin Patch, off & on for 22 years. I would like to thank you as Pumpkin Patch Partners for participating in the project and to let you know what your participation helps provide to Native Americans.

I am a Navajo, living on the reservation

all of my life (56 years). Pumpkin Patch has been employing Native Americans here on the Reservation for over 20 years. Our staff here in New Mexico is 100% Navajo, including all management. During the harvest we also hire Pueblo, both Zuni & Hopi tribes (300 workers). Unemployment on the Navajo Reservation is 42%.

My experience as an employee and manager is that Pumpkin Patch goes above and beyond what any organizations of the Reservation do to take care of their employees.

Pumpkin Patch pays for the transportation of their employees from all of the different Reservations, some as far as 4 hours away. Pumpkin Patch also provides residential facilities (dorms), laundry facilities, recreational facilities, a upscale kitchen with a chef and kitchen staff, a huge dining hall, extensive safety orientation before workers actually begin field work. Transportation was also provided to and from the fields. After completion of the harvest season all workers are provided with transportation back to their communities.

For many of our workers, it's the only opportunity to provide for their families and themselves. The approximately 1.3 million dollars in harvest labor makes a significant difference in the quality of the lives of my people. Opportunities like this are very scarce on our reservations.

I grew up tending livestock on the Reservation, went to boarding school and worked in local government as an elected official in the capacity of chapter president for 12 years. My salary and benefits with Pumpkin Patch are substantially above what I might receive from other private enterprises in the Farmington area. I have found that the owners of Pumpkin Patch are extremely concerned with the welfare of all of their employees both full and part time.

Another important aspect of Pumpkin Patch is the donations that the make to local organizations. Thousands of school children, senior citizen centers, special education & handicapped facilities, behavioral health facilities, church organizations, government services, correctional youth services and civic groups receive free pumpkins for their causes.

Again let me say that I cannot understate the value of the service and work provided to the Navajo people by Pumpkin Patch Fundraisers and its nonprofit partners.

Proposed Development at Garvies Point

To The Editor,

The proposed Glen Cove waterfront redevelopment, because of its tremendous density, is not just a Glen Cove issue – it is a regional issue. Former Mayor Tom Suozzi envisioned and proposed a true mixed use development for Garvies Point, consisting of shops, restaurants,

office buildings, entertainment, and no more than 500 residential units. A planned hotel and conference center would draw visitors to Glen Cove, many via the proposed ferry. However, now the developer seeks to eliminate a substantial portion of the mixed use and dramatically increase the residential component to 1,110 units.

In 2000, Sea Cliff and Glen Cove were entangled in litigation over proposed plans to re-develop the Garvies Point waterfront. As part of a settlement, a memorandum of understanding was signed by then Mayors Tom Suozzi and Claudia Moyne. This agreement was signed to address the potential adverse impacts the overall development would have on all the North Shore communities. Among other things, this agreement that overall development stated (including the ferry terminal) would not exceed 700,000 square feet, that the proposed hotel/convention center would not exceed 250 rooms nor exceed the then current zoning height of 45 feet, and created safe-harbor hours when the ferry could not run. Most importantly, the agreement in recognizing the significant environmental impact this project would have on the regional communities called for the establishment of the Glen Cove Creek Redevelopment Commission. The objective of this six member Commission (chaired by the Mayors of Glen Cove and Sea Cliff) was to reach consensus and to render advice to the Glen Cove IDA regarding the scope of the environmental impact studies as it relates to the development of the waterfront. The parties are to share and respond to ideas and input regarding specific aspects of the development in order to promote harmonious resolutions of any concerns that may arise.

I respectfully insist that Glen Cove and it's respective Boards not take further action until the Commission has had a chance to meet as it is not too late to correct the procedural misstep of ignoring the Commission.

The developer of the proposed project, RXR, has requested to modify their proposal in such a manner that could have dire consequences on the entire North Shore. They have requested the elimination of the hotel/convention center and the creation of a 1,110 unit residential skyscraper right at the mouth of Hempstead Harbor. The amended plan calls for a monstrous 125 foot tall 635,000 square foot building on our waterfront. This building is 30% larger in mass than the previous ghastly proposal. This proposed structure is larger than either of the RXR towers in Uniondale. Development of this nature is not conducive to the bucolic character of the North Shore.

All residents of the North Shore should insist that a Supplemental Environmental Impact Statement which can properly address the impact of the modification be mandatory. The effects of this substantial revision to the original plan is sure to have devastating effects on traffic in the area, the aesthetic beauty of the Harbor, water quality, sewage treatment capacity, damage to the newly

recovering ecosystem, strain on the school system, burden on local water supply, and overburdening the fire and police services.

It would cost nothing for the City to insist upon the submission of a SEIS from the developer but it could cost us all dearly if they don't. I urge all residents of the North Shore to write the Glen Cove Planning Board insisting that they require a SEIS prior to any vote on the proposal.

This week's celebrity was born Elizabeth Evans, in London, England, on April 26, 1887. She graduated from the Royal Academy of Arts in 1918 with honors. She attracted the attention of George Bernard Shaw and was the leading lady for actors George Arliss, Otis Skinner and William Faversham. She starred in films between 1913 and 1952. She had several roles in silent films which included "Florence Nightingale" (1915), "Esther" (1916) and "Mother" (1917). In Hollywood from 1935, she was usually seen as a cranky or narrow minded aunt or mother. One of her first talkies was "Crime and Punishment" (1935) with Peter Lorre, Edward Arnold and Gene Lockhart and directed by Josef von Sternberg. Other roles included "Mary Lynn" in "Theodora Goes Wild" (1936) with Irene Dunne and Melvyn Douglas and "Ma Cassidy" in "Mannequin" (1937) with Spencer Tracy and Joan Crawford. She also played Ida Lupino's character's "Ma" in "High Sierra" (1941) co-starring Humphrey Bogart.

Last Week's Celebrity

Last week's celebrity was born Harold Jacob Hochstein, but known professionally as Harold J. Stone. He had gone to college and medical school but the acting bug proved to be too strong. Although he went on to perform secondary roles in a number of films, he became a recognizable face to television viewers for his more than 150 guest appearances on numerous shows dating from the 1950s to the early 1980s including but not limited to "The Rifleman", "Gunsmoke", "Cimarron", "Sugarfoot", "The Virginian", "The Untouchables", "The Twilight", "Route 66", "Mannix" and "Gilligan's Island". In the 1960s and 1970s, he returned to the stage, directing several off-Broadway and Broadway productions, including "Ernest in Love" and "Charley's Aunt". On Nov. 18, 2005, at the age of 92, he died of natural causes in Woodland Hills, California.

The North Shore Key Club Begins the Year With a Splash




