Packing the Glen Cove City Council Chambers, Sea Cliff residents attended the Glen Cove Planning Board meeting of October 6, protesting the approval of the initial phase of the waterfront's development.

The Sea Cliff residents came to the meeting, in part, due to reading a letter to the editor printed in last week's Gazette from Sea Cliff Mayor Bruce Kennedy.

#### Glen Cove United Party Will Appear On November Ballot

In a court decision Mayoral candidate Tony Gallo and his slate of City Council candidates, Nancy Hawkins, John Perrone, Philip Pidot, Carlos Shimabukuro, Efraim Spagnoletti, and Roderick Watson, will all be candidates of the Glen Cove United Party. The party line petitions had been challenged by the Republican party.

"Democracy has prevailed," said Gallo. "Hundreds of Glen Cove citizens petitioned for ballot access on this new line, to ensure people would have a choice in an election that otherwise would have featured the current mayor on every line resulting in an unopposed mayoral election. Having overcome these attempts to silence the people's voice, we will proudly and firmly represent their interests in this campaign and in City Hall."

To win in November, Glen Cove United will make its appeal to voters of all political affiliations. On the new party's founding philosophy, Gallo stated, "My team and I recognize that the problems that plague Glen Cove are not solely the product of Republicans or Democrats. Instead of partisan bickering, we need common sense solutions to our major selfinflicted problems: overdevelopment, fiscal mismanagement, and a refusal to speak honestly about our financial crisis."



Available on the GlenIsle.com web site are renderings of the project. Above depicts the view from Sea Cliff's road, Cliff Way. Mayor Kennedy said, "I think it is incredibly out of character with the area. Additionally, since Cliff Way is considerably higher than the beach it minimizes the real appearance. Down on the beach and along the waterfront, the viewer will be looking UP at the building, and it will appear taller than the tree line - a lot taller." Kennedy said he requested a rendering from that vantage point but has not seen one to date.

"The developer of the proposed project, RXR, has requested to modify their proposal in such a manner that could have dire consequences on the entire North Shore," the Mayor wrote. "They have requested the elimination of the hotel/ convention center and the creation of a 1,110 unit residential skyscraper right at the mouth of Hempstead Harbor. The amended plan calls for a monstrous 125 foot tall 635,000 square foot building on our waterfront. This building is 30% larger in mass than the previous ghastly proposal. This proposed structure is larger than either of the RXR towers in

Uniondale. Development of this nature is not conducive to the bucolic character of the North Shore."

Noting the large crowd of residents, including Sea Cliff Mayor Bruce Kennedy, Planning Board Chairman Thomas Scott said, "This is not a public hearing," but in the interest of fairness, "I'll allow Mayor Kennedy a total of ten minutes to speak on the topic." He noted that public hearings had been held and publicized a number of times prior to this meeting.

Kennedy said, "The proposed Glen

Cove waterfront redevelopment, because of its tremendous density, is not just a Glen Cove issue – it is a regional issue. Former Mayor Tom Suozzi [in 2000] envisioned and proposed a true mixed use development for Garvies Point, consisting of shops, restaurants, office buildings, entertainment, and no more than 500 residential units. A planned hotel and conference center would draw visitors to Glen Cove, many via the proposed ferry. However, now the developer seeks to eliminate a substantial portion of the WATERFRONT continued on page 2

# **Community Mourns Herbert J. Schmidt Jr.**



A sailor's sailor has finished his last race. Herbert J. Schmidt Jr., 86, of Glen Head, NY, loving husband, father, businessman, and friend to all, passed away on August 16, 2015, from complications due to Parkinson's disease. He is survived by his beloved wife of 60 years, Barbara, their children Karen (Karen Pinell), Linda (Michael Patton), and Keith (Sheilah), and four grandchildren William, Andrew, Karl, and James. A memorial service was held on Sunday, August 23, 2015 at the Manhasset Bay Yacht Club (MBYC).

Herb was born in December 1928 in Cleveland, Ohio to the late Herbert J. Schmidt Sr. and Emily Clayton Schmidt. He graduated from the Illinois Institute of Technology in 1951 with a B.S. in Civil Engineering. He served as a Lieutenant in the U.S. Navy Civil Engineering Corps. He was a registered Professional Engineer in California, Massachusetts, and Rhode Island, and a Certified Corrosion Engineer.

An internationally recognized expert and author in the field of corrosion protection of metal products. He was a pioneer, innovator and leader in the plant application of extended life protective coatings on steel reinforcing bars, steel piling and structural steel. He founded three successful businesses. He developed the world's first automated centrifugal abrasive blast cleaning and fusion bonded coating production line for coating multiple steel reinforcing bars simultaneously. In 1977, he was issued a patent for the design of an automated multiple transfer, indexing and loading device for rebars and dowel bars. He was responsible for the formation of the Fusion Bonded Coaters Association, which merged into the Concrete Reinforcing Steel Institute (CRSI). For many years, continued on page 2

mixed use and dramatically increase the residential component to 1,110 units." Mayor Kennedy stated that Sea Cliff's two largest concerns were with the substantial increase in size of the largest building and the incremental increase in traffic by making it all residential.

"The visual impact from Sea Cliff will be dreadful and the increase in vehicular traffic through small Sea Cliff streets will create dangerous conditions." He made reference that, "F. Scott Fitzgerald would be rolling in his grave if he knew what was being proposed to be built at the site of the green light on Daisy's dock," referring to the book The Great Gatsby. He pointed out that the 635,000 square foot building, the structured proposed to be the closest to the Sea Cliff shore, would be one of the largest buildings in either Nassau or Suffolk Counties. Kennedy insisted that because of the multiple adverse environmental impacts that would result from the proposed amendment that an SEIS was beyond reasonable to be expected.

#### Broken Agreement?

After the meeting, outside, Kennedy told reporters and residents that he was considering all options including potential legal action against the city in part for a breach of a memorandum of understanding dated October 5, 2000 which was set by then Glen Cove Mayor Tom Suozzi and Sea Cliff Mayor Claudia Moyne along with the North Shore Environmental Alliance, Inc.

Kennedy said, "In 2000, Sea Cliff and Glen Cove were entangled in litigation over proposed plans to re-develop the Garvies Point waterfront... This agreement was signed to address the potential adverse impacts the overall development would have on all the North Shore communities. Among other things, this agreement stated that overall development (including the ferry terminal) would not exceed 700,000 square feet, that the proposed hotel/ convention center would not exceed 250 rooms nor exceed the then current zoning height of 45 feet, and created safe-harbor hours when the ferry could not run. Most importantly, the agreement in recognizing the significant environmental impact this project would have on the regional communities called for the establishment of the Glen Cove Creek Redevelopment Commission. The objective of this six member Commission (chaired by the Mayors of Glen Cove and Sea Cliff) was to reach consensus and to render advice to the Glen Cove IDA regarding the scope of the environmental impact studies as it relates to the development of the waterfront. The parties were to share and respond to ideas and input regarding specific aspects of the development in order to promote harmonious resolutions of any concerns that may arise.

"All residents of the North Shore should insist that a Supplemental Environmental Impact Statement, which can properly address the impact of the modification, be mandatory. The effects of this substantial revision to the original plan is sure to have devastating effects on traffic in the area, the aesthetic beauty of the Harbor, water quality, sewage treatment capacity, damage to the newly recovering ecosystem, strain on the school system, burden on local water supply, and overburdening the fire and police services." Kennedy added, "Most importantly, there is an agreement in place – a legally binding contract – between two adjoining municipalities. This is one of the reasons people don't trust government anymore, because of broken promises and broken agreements. This development is bad for Sea Cliff and all surrounding communities and I think it will ultimately cause financial ruin for the people of Glen Cove."

#### Impact Most

Given ten minutes to speak on behalf of the residents Mayor Kennedy gave a few of his minutes to Sea Cliff resident and attorney Amy Marion who said, "The west side of this development project is what will impact Sea Cliff the most. Although the gross square footage of the private development is less, from 2,225,680 to 1,719,932 the west side building is larger under the amended master plan as compared to block A under the prior approved plan claiming that consolidating the density into just

Price per copy is 75 cents two development blocks on the west side has numerous design advantages for the city and public. The plan proposes to split block A into two separate towers, allegedly to break up the massing when viewed from the harbor; and that the Planning Board finds that the heights of the proposed buildings on Blocks A1/A2 and B2 would be comparable to the heights of the buildings previously approved under the 2011 PUD Master Development Plan, including the 12story buildings on the prior Blocks A and C; and the height of the buildings on Block A1/A2 can be as tall as the treetop elevation of the ridgeline of Garvies Point Preserve."

Marion also noted that additionally the restaurant will be relocated to the western point of the project site, "and other retail space and casual eateries along with 123 restaurant parking spaces, creating light pollution along with all sorts of other pollution."

After letting Kennedy speak the Planning Board voted to approve the revision to the project as the packed audience shouted, "No, no." All but one of the board members voted in favor.

#### Recent History

The proposed waterfront project has been a vision for the City of Glen Cove since Tom Suozzi as Mayor first considered it in the 1990's. Most recently on September 16 at a public hearing, certain changes in the physical layout of the proposed redevelopment of only the west side of the Property as a result of eliminating the hotel changing the project to 1,110 residential units according to Marion.

Before the second public hearing began on September 16, 2015, Mayor Kennedy hand delivered to the Planning Board a three page letter from the Village's Attorney, together with the Memorandum of Understanding from 2000.

The Planning Board notes that the Village participated in the prior SEQRA review of the approved 2011 PUD Master Development Plan- which contained a 12-story building on Block A at the Project's westernmost end, and an up to 12-story hotel on block C also on the west side- including by submitting a comment letter to the board dated July 17, 2009, signed by the same Village Mayor, which raised, among other things, certain transportation and other aesthetic concerns, all of which were fully studied and addressed during the prior SEQRA review. Mayor Kennedy disputes that the Village's specific objections were properly addressed in the EIS, in fact he states that many of the Village's concerns were ignored.

#### Call For Balloons

In a letter writing campaign residents of Sea Cliff were encouraged to present letters to the City of Glen Cove reading, "I am writing this letter to let you know that I oppose the Amended Planned Unit Development application in connection with the Garvies Point Waterfront Redevelopment project.

"Although alternative plans to the original conceptual site plan were included in the Final Environmental Impact Statement, including market conditions and technical construction challenges which may have resulted in reconsideration of the original plan, I take exception with the relatively short notice given to the public to evaluate the impact of some significant changes.

"There was no outreach conducted to inform or get feedback from the public interest groups and other stakeholders before the announcement in June.

"The massive size of the consolidated 11/12 story structure and its impact on the surrounding landscape are difficult to imagine and unprecedented for Hempstead Harbor shoreline development.

"A site tour with balloon markers to define the buildings' mass must be offered to the public before the Glen Cove Planning Board/ City Council makes a final decision.

"In addition, this new plan raises concerns regarding increased nitrogen run off, impact to the water supply system, traffic, and post-Sandy sea level rise and flooding."

#### More than 3.5 Million

Before the Planning Board meeting the Glen Cove City Council along with Mayor Reginald Spinello held their precouncil meeting in which the Mayor rolled out his draft of the city's budget. In it is a line item expecting the sale of the waterfront property of 3.5 million dollars to be used in the budget's general fund with the final sale of the property expected to be before the end of 2015. The city also budgeted for an additional million dollars included in building permits, etc.

Residents who also attended the meeting were surprised at the figure, thinking the total sale was 3.5 million.

The Mayor later explained that the actual contractual sale was in excess of 15 million, agreed to by prior administrations. Of the 15 million prior loans are due for the city's portion of the cleanup of the property, a requirement of the sale. "The city has paid out millions and now we're going to start seeing that money come back." He noted that the Federal Government, as part of the Brownfield Cleanup agreement, "paid close to \$100 million as well."

Spinello noted the push back from the neighboring community but said that the proposed amendment would be better for the area then the prior proposal. He also noted that the property will include 29 parks, open spaces, restaurants, boat ramps, retail space, etc. Excited he said the city is very happy with its relationship with the developer. "This will get rid of a blighted area of our city... It will turn Glen Cove around."




unique and took time to make a historical connection.

# Listening to the Needs of the Glen Cove Residents

Autumn is in the air. With crisp days, roaring crowds cheering for Glen Cove High School's football team and our residents picking the final fruits and vegetables of the season, fall brings a renewed energy for finishing the year's to do lists and planning for the year ahead. Listening to what's top of mind for Glen Cove residents, here are a series of updates on our key initiatives for the City.

#### Taxes

My 2016 budget presentation to the City Council and public will take place in October. As always my number one priority will be to keep our taxes stable. Real estate taxes are the main revenue source municipalities use to offset the continued rising costs of goods and essential services needed to run the City. With the New York State property tax cap set at .73%, I continue to search for new revenue streams so tax payers don't have to bear the burden of meeting our annual financial obligations. When I took office in 2014 we held the line on taxes and even decreased taxes for commercial businesses. This continues to be a challenging task as with each new fiscal year, the City's expenses increase. Those increases are due to contractual obligations, the rising cost of everything from rock salt to replacing outdated equipment and dealing with whatever Mother Nature sends our way. To cover that financial gap, new revenue generating opportunities are pursued. For Glen Cove, those revenue opportunities may include new developments, new businesses, new programs like Single Stream Recycling and the sale of underperforming assets.

#### Reducing the Need for Speed

At a recent City Council meeting one Glen Cove resident referred to a road by their home as a "raceway." Each week the Glen Cove Police Department receives many calls on this very topic - speeding on neighborhood streets. But lead foot drivers beware as Chief William Whitton and Deputy Chief Chris Ortiz of the Glen Cove Police Department has pinpointed speeding as one of Glen Cove's top safety concerns. A new program will be introduced later this month that will focus on education and enforcement to encourage drivers to watch their need for speed and drive within the speed limit on various roadways that are connector streets that pass through thickly settled residential areas.



#### Quality of Life

Glen Cove's Code Enforcement team and City Attorney's office are the unsung heroes of our City's effort to reduce illegal housing and enhance the quality of life in Glen Cove's neighborhoods. Working in partnership with Code Enforcement, our City Attorney Charles McQuair and his team have prosecuted over 70 cases and issued over \$250,000 in fines under my administration.

#### Making Inroads on Glen Cove Road Repairs

Please note that road repair is scheduled for the following streets with work to begin the first week of October: Garden Place, Glengariff Drive, Lincoln Place, Cleveland Place, McKinley Place, Milford Lane, Preston Ct., Norman Ct., Scott Ct., The Outlook, Center Street, Marietta Rd., Highfield Road, Pratt Blvd., Frost Pond Road, Comp Lane and Putnam Avenue. Also, Nassau County has advised us that repairs of the 13 roads they maintain in Glen Cove are in their 2015 capital resurfacing budget. Sections of the roads targeted for repairs include parts of Forest Ave., Dosoris Lane, Cottage Row, Town Path, Shore Road, Highland Road, Glen Cove Ave., Elwood St. and others.

# Water Department Now Accepting Online Payments

Beginning this month, Glen Cove Water bills can now be paid online at glencove. ezonlinepayments.com. As we look ahead to 2016 we are hoping to have this online feature available for property and school tax payments.

#### Seniors

Membership at the Glen Cove Senior Center does have its privileges as Carol Waldman, executive director of the Center and her team does an outstanding job in offering programs and services that enrich the lives of our senior community members. With the Center's membership expanding, we recently announced that there is now additional parking available at Coles School with free shuttle bus service to the Senior Center. I am also proud of Glen Cove's participation in the Virtual Senior Center program. Homebound seniors have the opportunity to join classes five days a week from their home. Program participants are provided with a free Touch Screen computer and training so that they may enjoy being a part of the Senior Center's activities, virtually.

## Recovery Month And Substance Abuse Trends

Every September, the Substance Abuse and Mental Health Services Administration (SAMHSA) sponsors Recovery Month to increase awareness and understanding of mental and substance use issues and celebrate the people who recover. Recovery Month spreads the positive message that behavioral health is essential to overall health, that prevention works, treatment is effective and people can and do recover.

According to SAMHSA, in 2014, an estimated 66.9 million people aged 12 or older were current tobacco users.

SAFE Inc. is the only prevention agency in Glen Cove dedicated to the elimination of alcohol and substance abuse in Glen Cove. The agency continues to work to change societal norms about alcohol and substance abuse through ongoing prevention, intervention and education activities and events. Through the SAFE Glen Cove Coalition, local substance abuse trends are identified and addressed to maintain an ongoing prevention effort.

Executive Director-Dr. Sharon Harris said, "SAFE's goal is early intervention and prevention education." Dr. Harris continued, "According to the 2014 Bach Harrison Prevention Needs Assessment Survey, administered to students in the 6th, 8th, 10th and 12th grades, Glen Cove's youth showed a rise in lifetime and 30-day Tobacco Use. Lifetime cigarette use continues to rise into the 10th grade (18.8%) and 12th grade (39.3%)."

According to Carol Meschkow, Coalition member and Nassau Project Coordinator for the Tobacco Action Coalition of Long Island, "For our youth, reducing initiation is the greatest weapon in the effort to prevent addiction. The New York State Tobacco Control Program continues to focus their efforts on youth for a very clear reason. 90% of smokers smoke their first cigarette by the age of 18. It is during these formative years that our youth are most vulnerable to Tobacco Marketing especially at the Point-of-Sale and we are grateful to partner with SAFE and their Coalition Members to prevent the next generation of smokers.'

Each Spring the City of Glen Cove welcomes the blooming of thousands of pink tulips thanks to the annual pink tulip bulb planting and fall clean-up sponsored by the Glen Cove Beautification Commission and Glen Cove C.A.R.E.S. (Cancer Awareness Resource Education Source). Held annually during National Breast Cancer Awareness Month in October, the program was created by the late Terry Petikas, the founder of Glen Cove C.A.R.E.S. Volunteers plant pink tulips each year to raise awareness of the importance of early cancer detection techniques.

he was an active member of numerous technical committees for the American Society for Testing and Materials (ASTM) that developed the standards for epoxy coated steel reinforcing bars. He pioneered the commercial development of epoxy fusion bonded coating materials in conjunction with the Federal Highway Administration's National Experimental and Evaluation Program (NEEP) for Extended Life Concrete Bridge Decks.

Several years ago, WindCheck magazine interviewed Herb for their monthly 'SoundPeople' column, which said this about Herb, "Every once in awhile a man comes along who, in his own quiet way, makes a big difference to those of us who escape the bustle of everyday life by going sailing. We are not talking about a difference in a national or world arena, but at the community level, where it is so important to spread the word of the joys of sailing. Herb Schmidt does just that; he gathers young and old, those new to sailing or the totally uninitiated and gets them out on the water. He single-handedly developed Sonar Fleet #11 in Manhasset Bay." In 2008, the inaugural Sonar Long Island Sound Series Award was named the Herbert J. Schmidt, Jr. Perpetual Trophy. The award was created in recognition of

the foresight, inspiration, leadership, and dedication of Fleet Founder and Captain Herbert Schmidt. Herb was the founder of the Sonar Fleet at MBYC and had been the Fleet Captain for 27 years.

Herb was very active in his local community. He served as both President and Vice President of the North Shore School Board, Chairman of the Community Scholarship Fund, and President of the Hill Terrace Civic Association (for many years playing Santa Claus to the local children as well as at the Glen Garden Club's annual winter luncheon). He served St. Luke's Episcopal Church, Sea Cliff, as a Vestryman and Chairman of the Design and Construction Committee for the rebuilding of the Rectory. He was a former member of the Matinecock Rod and Gun Club, Masonic Lodge, and the Kismet Temple of the Shrine, and the Rotary Club (Paul Harris Fellow). He was Secretary and Trustee of the Manhasset Bay Yacht Club and former President of the New York Metropolitan Alumni Association of the Illinois Institute of Technology. # IAC Learns about Mental Health Services provided by Melillo Center

The Glen Cove IAC recently held its monthly meeting at St. Rocco's Church in Glen Cove. Members were warmly welcomed by Coleen Spinello and enjoyed a delicious breakfast prepared by volunteers at the Church.

The guest speaker was Nicole Del Guidice of the Melillo Center. She spoke about various services that are available at the Melillo Center. Approximately two years ago, the chemical dependency program transitioned from Glen Hospital to the Melillo Center. At the beginning, there were approximately 40 patients and a handful of therapists. Today, the program has grown to 20 staff members serving 170 clients.

The Center runs two chemical dependency programs for women: intensive and non-intensive. Both are outpatient programs. Women in the intensive program meet for three hours a day, Monday through Friday. Childcare is provided. The women receive individual and group therapy, attend workshops and participate in yoga classes. Seventy five percent of the women in the intensive program are also on a psychotropic medication to treat a mental condition. Women in the non-intensive program meet less frequently. Depending upon their need, they receive from 1 group/1 individual meeting per week to up to 3 group/2 individual meetings per week.

The Melillo Center also works with the court system. Legally mandated patients receive a special evaluation. They are referred to Melillo Center for DWI and other offenses. There is a specific curriculum for DWI cases. Other programs offered by the Melillo Center include a co-occuring disorders program, adolescent program and significant other program. The majority of patients have

Medicaid; however, the Melillo Center takes most insurance plans and will not turn anyone away for lack of funds. The Center also treats approximately 65 patients in the field who are unable to come to the Center.

The Melillo Center also has three group homes on the North Shore, a forensic home for those who were in jail and a respite home for short term stays to give family members a break. The Center also rents over 100 apartments in Nassau County, four of which are for families with children.

This week's celebrity was born in Altoona, Pennsylvania, as Martha Lafferty, on April 25, 1921. This vivacious, honey-haired performer was singing with Hal Kempe's band at the Coconut Grove in Los Angeles in 1941 when she was spotted by a talent scout from Columbia Pictures. She signed with them and made her debut in Three Girls on the Town" (1941) with Joan Blondell and Binnie Barnes. She gave one of her best performances as the title character, a slightly vacuous, man-attracting beauty opposite "plane-jane" sister, Rosalind Russell in the lively "My Sister Eileen", a romantic comedy of two sisters who move from Ohio to NYC's Greenwich Village. She was Rita Hayworth's best friend in "Tonight and Every Night" (1945). During WWII, she appeared as the pin-up girl

in the March 1944 issue of Yank magazine. After the swashbuckler, "The Black Arrow", with Louis Hayward, Columbia dropped her and she moved to the theater and to television.

#### Last Week's Celebrity


Last week's celebrity was Elisabeth Risdon. Often playing stern, autocratic elders, her composure and customary dignity were distinctly ruffled when she was literally spanked on her bottom by a grizzly George "Gabby" Hayes in the John Wayne 1944 mystery-western, "Tall in the Saddle". Elisabeth was "Aunt Clarissa" in "The Howards of Virginia" (1940) with Cary Grant and Martha Scott. She was "Mrs. Polverdine" in "The Canterville Ghost" (1944) with Charles Laughton and Robert Young. She played Claudette Colbert's mother in "The Egg and I" (1947), based on Betty MacDonald's novel, and also starring Fred Mac-Murray. This movie also debuted Marjorie Main and Percy Kilbride as "Ma & Pa Kettle". Her last film was in 1952 with Stewart Granger, Eleanor Parker and Janet Leigh in "Scaramouche." On Dec. 20, 1958, she suffered a stroke and died, at the age of 71. Her body was donated to medical science.

It appears that Tony Gallo has again put his foot in his mouth in his efforts to disparage Mayor Spinello. The recent statements made in Newsday by Mr.Gallo and his cohort, Phillip Pidot are deceptive and misleading at best.

Using the recently released State Comptroller's report as the backdrop, Mr.Gallo attempts to sway the voters into believing that the criticism of this report is the result of Mayor Spinello's fiscal mismanagement, yet Mr.Gallo fails to mention the role he played in the adoption of the inherited 2014 budget from the prior administration.

During the proposed budget process for 2014, both Mayor Spinello, at the time a sitting councilman, and Mr. Gallo voted no for its adoption.

Mr. Gallo then wavered during the lame duck period prior to Mayor-Elect Spinello taking office and voted yes with the prior administration to add additional jobs to an already imperfect 2014 budget. This yes vote by Mr. Gallo further burdened the City's taxpayers by adding approximately \$300,000 in additional costs to the 2014 budget inherited by Reggie Spinello on his first day as Mayor.

It is clear that the fiscal crisis the State Comptroller's office references in its criticism of 2014 began long before Mayor Spinello took office.

If Mr.Gallo has been so concerned with the City's fiscal health, then why has it taken him 3 <sup>1</sup>/<sub>2</sub> years to voice his concerns? His continual wavering on city issues along with his reckless, misleading, irresponsible statements in the hopes of garnering votes should be of the utmost concern to every voter in the City of Glen Cove.

I am certainly looking forward to Friday night's Museum reception and I do have a fast moving, topical novel to recommend: A WINDOW OPENS by Elisabeth Egan. Alice Pearse is happily living in an affluent suburban community, her husband is on the partner track at a prestigious New York law firm, she works a few days a week as a magazine book reviewer while helping her best friend run a local bookstore, her three young children are well adjusted, her devoted parents live nearby, and she has Jessie, the perfect babysitter. Shortly

into the book, everything changes and there is one major villain (other than the vagaries of life): Scroll-her new employer- a fictional combination of Amazon, Google, Facebook, and Apple. Scroll is developing plans "to reinvent reading as Starbucks reinvented coffee" with lounges featuring leather chairs, e-reader terminals, foot massages, plastic-encased first editions, and artisanal refreshments. Midway through the story, the company decides to shift its focus from books to video games, but meanwhile Alice finds herself caught in a nightmarish trap of electronic servitude reminiscent of Dave Eggers's THE CIRCLE. This book, while predictable in many ways, was surprisingly poignant in its depiction of family and work relationships. Recommended!


