Spinello Secures Second Term

Glen Cove Mayor Reginald A. Spinello who ran on both the Republican and Democratic line defeated challenger Anthony Gallo Jr. securing a second two year term of office. In his victory speech he noted that through his administration,

illegal housing has decreased, business has increased, taxes and spending have stabilized, "and the waterfront will move forward!"

Spinello received a total of 55% of the votes at 2,843 beating his challenger's 2,276 votes.

For Council the following candidates were elected:

- Efaim Spagnoletti with 2,334 votes
- Roderick Wilson with 2,159 votes
- Pamela D. Panzenbeck with 2,091 votes
- Joesph Capobianco with 2,026 votes
- Nick DiLeo with 1,987 votes
- And Tim J. Tenke with 1,930 votes

Gallo said, "I'd like to congratulate Reggie Spinello on his victory and I wish him good luck with his next term. In addition, kudos to the city council victors... I'd like to thank my Glen Cove United running mates, supporters and volunteers.

"Our Glen Cove United movement has a future which is to truly represent people and not political parties. I have put my best foot forward, but finished short.

Glen Cove English Language Arts High School Teacher Surprised with \$25,000 Milken Educator Award

When Lauren Jensen's honors classes had T-shirts created that said, "I survived Ms. Jensen's class," it was both tongue-in-cheek and a source of pride. Her students leave her classroom ready for college. Now they will need to get T-Shirts that say, "My teacher Ms. Jensen is a Milken Educator AND she's \$25,000 richer!"

Glen Cove High School Language Arts teacher Lauren Jensen walked into a schoolwide assembly at her school this morning and was surprised with the prestigious Milken Educator Award and presented with a \$25,000 check.

In front of her entire hometown,

including the school principal, colleagues, students, staff and distinguished community members, Jensen was given the surprise of her life when she was handed the distinct navy blue envelope by Milken Family Foundation Co-Founder Michael Milken.

"I'm completely shocked," Jensen said. "I've only been teaching in the district for three years, I'm mostly overwhelmed that in that short time I could have made such an impact."

For the next six months, in up to 40 schools around the U.S., outstanding

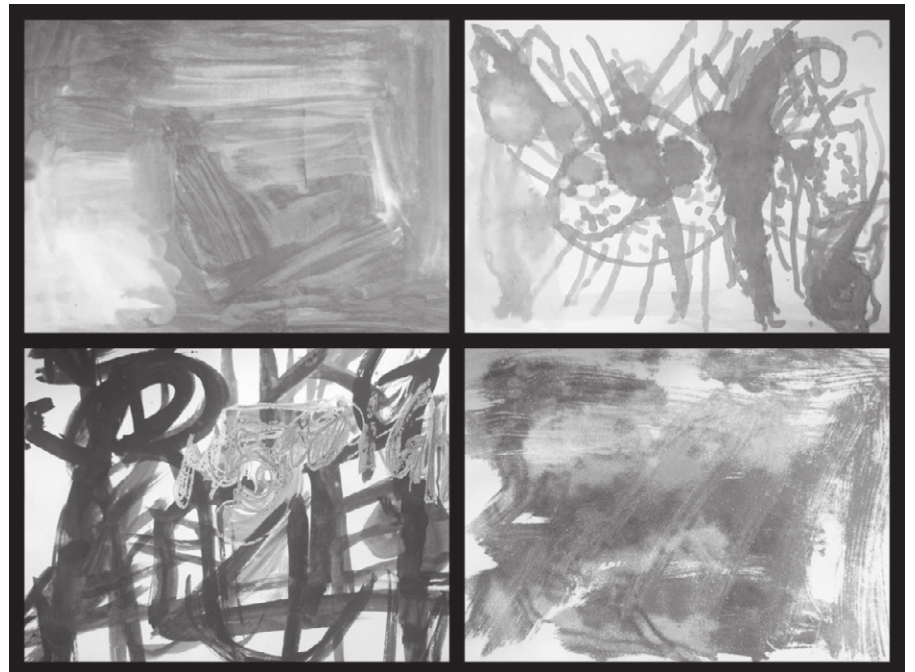


SCO art at SC Librar

We are writing today to formally inform the district of our decision to refuse to allow our child, _____, to participate in:

- _____ any local/benchmark assessment used in the New York State teacher evaluation system administered in the fall, winter, and spring (may include STAR, AIMSweb, MAP/SWEA, SLO's) in the 2015-16 school year (grades K-12) (excluding spring 2016 middle school local assessments being used as a final grade)*
- _____ the 2016 grade 4 New York State science assessment
- _____ the 2016 grade 8 New York State science assessment

Our refusal should in no way reflect on the teachers, administration, or school board. This was not an easy decision for us, but we feel that we have no other choice. We simply see these tests as harmful, expensive, and a waste of time and valuable resources.

We refuse to allow any data to be used for the purposes other than the individual teacher's own formative or cumulative assessment. We are opposed to assessments whose data is used to determine school ranking, teacher effectiveness, or any other purpose other than for the individual classroom teacher's own use to improve his or her instruction.

We believe in and trust our highly qualified and dedicated teachers and administrators. We believe in the high quality of teaching and learning that occur in our child's school. We hope our efforts will be understood in the context in which they are intended: to support the quality of instruction promoted by the school, and to advocate for what is best for all children. Our schools will not suffer when these tests are finally gone, they will flourish.

We do apologize in advance for the inconvenience or scrutiny that this decision may cause the administration, the school, and the staff.

middle and high school educators will receive the Milken Educator Award and an unrestricted cash prize of \$25,000.

Milken said Jensen, who hails from Glen Cove, was on a full research fellowship at NYU working towards her doctorate in education when she decided her heart was in the classroom – as well as her hometown – after nine years of teaching in Virginia.

“Lauren is a lifelong learner committed to improving the way English is taught and learned,” said Milken. “She challenges her students to think more analytically and express themselves in writing more clearly and persuasively – core skills that endure for a lifetime. Always the consummate professional, she believes every student can achieve if he or she is truly engaged. That belief is felt by all who work with her. We’re happy to welcome her to the Milken Educator family.”

“Ms. Jensen’s students are fortunate to have a teacher who challenges them to think deeper, write clearer, and ask tougher questions. These skills will serve them well in college, in the workforce, and as citizens,” New York State Education Commissioner MaryEllen Elia said. “Ms. Jensen’s colleagues in her building—and across the State—are also fortunate to work with her. She has demonstrated a commitment to sharing best practices and to strengthening professional development opportunities for the teachers in her district. Thank you to the Milken

Family Foundation for recognizing such an outstanding educator, and congratulations to Ms. Jensen on all of her accomplishments.”

As a 10th and 12th English Language Arts teacher at Glen Cove High School, Jensen’s passion for education and high standards motivates students to aim higher. Her no-nonsense, student-centered instruction considers various learning styles and is grounded in exploring larger themes that encourage students to ask and discuss the “big question.” Jensen’s desire to see her students succeed fosters a sense of community in the classroom. Students feel safe enough to take risks and trust each other for feedback.

Self-assessment is an important part of Jensen’s unique teaching method, too. She believes students should take some responsibility in monitoring their own academic improvements. Utilizing individual portfolios, students keep track of writing assignments, including

written feedback from Jensen, peers and themselves. Her students have come to believe that no project or writing piece is truly “finished,” and as a result are always looking for ways to improve. At the end of the school year, each student revises a self-selected piece to demonstrate their growth as a writer.

Jensen is fully committed to her students’ active engagement in their education. She motivates them to draw connections between texts and the real

Jensen graduated magna cum laude from Wake Forest University in 2002 and earned her master of arts in The Teaching of English from Columbia University Teachers College in 2008.

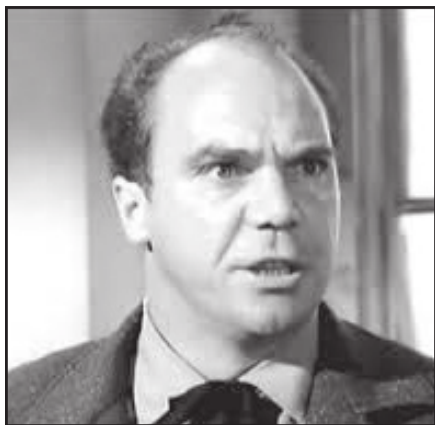

Last Week's Celebrity

Last week's celebrity was Vinton Hayworth. He was one of the founders of AFRA, which later became AFTRA, the American Federation of Television & Radio Artists, the union representing radio and TV artists, of which he was also the president from 1951-54. He was married to actress Jean Owens. Owens' sister was Lela Owens, mother of actress Ginger Rogers. Hayworth's elder sister was Volga Hayworth, mother of screen star, Rita Hayworth, making Vinton uncle to both Rita Hayworth and Ginger Rogers. After years in big screen films, Vinton began appearing on TV in the 1950s. He appeared in "Alfred Hitchcock Presents", "Gunsmoke", "Perry Mason", "Dennis, the Menace", "Ripcord", "Hazel", "The Munsters" "Green Acres" (1965) and "Dick Tracy" (1967). His final role was as "General Winfield Schaeffer" on "I Dream of Jeannie" between 1969 and 1970, with Barbara Eden and Larry Hagman. Hayworth replaced Barton MacLean, who had played "General Martin Peterson" until his death in 1969. Shortly after completing his recurring role of "Gen. Schaeffer", Hayworth died of a heart attack on May 21, 1970. Both Hayworth and MacLean died before the final episodes that they appeared in were aired. The show ended in it's fifth season in 1970.

This week's celebrity was born on Jan. 21, 1921 in Brocton, Plymouth County, Massachusetts and was an American film character actor. He was a balding, husky man remembered for playing mob muscle and western bad guys in movies. He appeared in some 260 movies and television programs, with about 60 early, uncredited roles. He progressed to dramatic roles including a small part as an architect in "The Fountainhead" (1949) with Gary Cooper and Patricia Neal. In the 1970 epic "Patton" with George C. Scott and Lee Marvin, he played 3rd Infantry Division Commander Maj. Gen. Lucian K. Truscott. His other notable performance included a part in Stanley Kramer's "High Noon" (1952) with Grace Kelly and Gary Cooper. As a side note, "High Noon" has been selected for preservation in the U.S. National Film Registry by the Library of Congress. Our celebrity also appeared in "The Robe" (1953) with Richard Burton and Jean Simmons, in "Sierra" (1950) with Audie Murphy, a re-make of "Forbidden Valley" (1938) and in the mega-budget film "Cleopatra" (1963) with Elizabeth Taylor and Richard Burton. Glen Cove's own Delia DeRiggi-Whitton (Dem) was returned as the incumbent to the seat of the Nassau County Legislator - 11th District beating

Students Study “As Scientists” in the Glenwood Landing Outdoor Classroom

During the gorgeous autumn season, Glenwood Landing K-5 students went outside to study in the beautiful GWL Outdoor Classroom & Garden. Numerous learning stations were created to assist each of the children in their pursuit as “scientists and critical thinkers” as they rotated among various learning stations to seek answers to some important questions. The stations included the following:

- Science Tables,
- Garden Beds
- Water Tables
- Music & Art Center
- Composting Bins

GWLEnrichment teacher, Mrs. Marcantonio said, “After students spent time at each of the stations utilizing scientific tools including magnifying glasses, balancing scales, measuring devices, and funnels they came back together to consider some important questions posed by their teachers.” Some of the questions asked of the kindergarten classes included:

- “What did you observe as scientists?”
- “What did you notice?”
- “What did you wonder?”

As part of the discussion, students had to utilize their four senses (e.g., sight, hearing, touch, and smell) to defend their stance on what they learned. Examples of some answers included, “I noticed that the peas were very green in the garden,” “I noticed that the rock weighs more than the twig,” “I wonder why when I hit the drum it makes that sound,” “I wonder why that broccoli had that smell?,” and “I wonder why the leaf floats than sinks to the bottom?”

Mrs. Marcantonio concluded by saying, “From this collaborative study, the students of Glenwood Landing had the opportunity to engage in hands-on learning and critical thinking to reach important conclusions and understandings.”

Chilling Out in Sea Cliff

Dear Chilling Out,
I recently read a fascinating biography: ONE MAN AGAINST THE WORLD -The Tragedy of Richard Nixon- by Tim Weiner. Weiner has written award winning histories of the FBI and the CIA, and this is another well documented, well written story of paranoia, deception, and loyalty gone awry. Using recently declassified information, Weiner paints a portrait of a man riddled with insecurities and abated by a cadre of sycophants who undermined our country in a myriad of ways. The sabotaging of peace talks to defame Lyndon Johnson and prevent Hubert Humphrey's election, the bombing of

civilians in Hanoi, the attacks on neutral Cambodia, the sale of ambassadorships, and his original claims that the CIA had masterminded the Watergate break-ins are all described in compelling detail and substantiated by oral recordings from the State Department, journalists, memoirists, and- most damningly- Nixon himself. For many, Nixon is seen as a complicated, tragic figure whose greatest crime was the botched Watergate break-in. Weiner refutes this by showing us a man whose crimes were far, far worse than imagined. The lives ruined, the lives lost, the lasting damage to our democracy are presented here, and the lasting tragedy as it turns out is not Nixon's but ours.



Master Sergeant Christina M. Noon Named as Glen Cove's 2015 Veterans Day Honoree U.S. Air Force Veteran to be recognized at November 11 Ceremony

Mayor Reggie Spinello and Commander Joseph Lavery of the VFW James Donohue Post 347 announced that Glen Cove will honor Master Sergeant Christina M. Noon at its annual Veterans Day Memorial Service on Wednesday, November 11. "It is a privilege to recognize Master Sergeant Noon as she is the first female to be honored during the City's annual event that pays homage to our City's military veterans," said Mayor Reggie Spinello. "Master Sergeant Noon is a born leader, she has served in the military for over 18 years and is the first female member of the Glen Cove VFW James Donohue Post 347," said Commander Lavery.

Master Sergeant Noon enlisted in the Army National Guard in February, 1998. She graduated from the Avionic Mechanic Course at Fort Eustis, Virginia, in March 1999, went on to the Air National Guard in February, 2002 and then attended the Security Forces Academy in Texas. Graduating in 2002, Sergeant Noon's assignments have included the Civil Engineering Squadron, Knowledge Operations Manager and a deployment to Afghanistan in support of Operation Enduring Freedom. She is currently a First Sergeant, 106th OG in Westhampton Beach, New York.

Her contributions to the military have been recognized with many awards and commendations including
