### Village of Sea Cliff Files Lawsuit to Oppose Glen Cove Waterfront

The Incorporated Village of Sea Cliff filed a lawsuit on November 5, 2015 in the Supreme Court of the State of New York (Nassau County). The lawsuit seeks relief under Article 78 of the CPLR, Declaratory Judgment Action Pursuant to Section 3001 of the CPLR, Injunctive Relief Request and a Breach of Contract action against numerous parties including the Planning Board of the City of Glen Cove, Glen Cove City Council, City of Glen Cove Industrial Development Agency, City of Glen Cove Community Development Agency, the current project redeveloper Rexcorp-Glen Isle Partners LLC, and other parties with various interests in the proposed Garvies Point development on Glen Cove Creek.

The Petitioners-Plaintiffs are the Incorporated Village of Sea Cliff, Board of Trustees of the Village of Sea Cliff and Bruce Kennedy, individually and as Mayor of the Incorporated Village of Sea Cliff. The Plaintiffs are represented by their attorney Brian S. Stolar of the law firm Meyer, Suozzi, English & Klein, P.C.

This legal action arises from the October 6, 2015, decision of the Planning Board of the City of Glen Cove granting the application for an Amended PUD Master Development Plan and Subdivision Application for the project known as the Garvies Point Waterfront Development Project. The proposed Waterfront Development Plan would significantly alter forever the character of the community and transform Hempstead Harbor, which is currently a bucolic waterfront, environmentally sensitive land into a gigantic, sprawling, and superdensely-packed subdivision with one thousand one hundred residential units, including a single structure that is 125 feet tall with a mass of 635,000 square feet.

# Slime, Goo, and Ooze!

Glenwood Landing's School-Wide Enrichment Services under the direction of Audra Marcantonio conducted an exciting science program for all second graders called Slime, Goo, and Ooze hosted by the Long Island Science Museum.

Ms. Marcantonio said, "Children in second grade participated in a series of hands-on science investigations designed to deepen and extend the second grade science unit, States of Matter = Changes." She added, "We were fortunate to have a representative from the Long Island Science Museum lead our students in various investigations with plastic that utilized their senses, were fun and interactive, and explored properties of matter including solids and liquids."

In one investigation, students made "Gak" by mixing a liquid plastic (glue) with water and green food coloring. They watched it turn from a liquid to a green solid when they added a powder (Borax) and stirred with a stick. Different

## Village of Sea Cliff Files Lawsuit to Oppose Glen Cove Waterfront

The suit alleges several distinct areas of violation including breach of contract for failure to abide by a 2000 agreement between the Village and the City which sets forth parameters of the development plan. As the result of a breach of this Agreement, the Village is seeking a declaratory judgment, injunctive relief, and related relief related to the breach of contract. Other allegations of the suit include:

- Failure to comply with SEQRA (State Environmental Quality Review Act)
  - Failure to take a hard look at the impact on view corridors and scenic vistas
  - Failure to take a hard look at the impact from additional window and light exposure
  - Failure to take a hard look at the impact from additional noise exposure
  - Failure to take a hard look at the impact of the 2000 agreement
  - Failure to take a hard look at cumulative impacts and changes occurring after the 2011 SEQRA analysis
  - Failure to provide interested agencies with notice of the amendment application and its potential environmental impact
- This is one of two Article 78 filings

against the City of Glen Cove in regard to the Garvies Point Project in the past week. A separate lawsuit was filed by attorney Amy Marion on behalf of 41 private residents of the City of Glen Cove, the Village of Sea Cliff, and the Hamlet of Glen Head.

Sea Cliff Mayor Bruce Kennedy stated, "Because of its scope and size, the Garvies Point development is more than a Glen Cove issue; it is a regional issue. We will fight to keep this disproportionate and inappropriate development from changing our community's character and destroying our environment. Hempstead Harbor, Glen Cove Creek and its surrounding communities constitute an environmentally sensitive area and we will not allow the City of Glen Cove to make mistakes that will cause irreparable harm and a permanent transformation of our community. We will not accept the adverse environmental impacts that this project will assuredly bring without having voice in how this land is developed."

Mayor Kennedy and the Sea Cliff Board of Trustees welcomes a meeting with Glen Cove Mayor Spinello and the City Council to attempt to reach consensus on how this regional development plan should proceed. Kennedy said he would welcome the Mayors of the surrounding North Shore villages to participate in any discussions.

observations made by the students included: it was wet, cold, sticky, green, and moved slowly. Students got to roll the "Gak" and even bounce it on the floor!

In another investigation, the second graders made "Flubber" by mixing a liquid plastic with melted plastic then adding a powder (Borax) and mixing with a stick. Students drew conclusions including: it had a brownish-yellow color, had a bad odor, moved quickly, was cold, and very slippery. Students were able to totally stretch the "Flubber" with their hands or sticks!

Students were fascinated in the process of making the "Flubber" and "Gak." At first, they were complaining of how sticky the substance was. After

stirring and creating a more solid matter, students were able to play with their "goo or slime." This hands-on experience allowed for a greater understanding of the different states of matter and their properties. Students were able to bring a small ball of this "Flubber" or "Gak" home in a plastic bag. Not only was this a fun and engaging science investigation, but it allowed for questioning and observation.

It was clear by the excitement in the room, that all the students thoroughly enjoyed the various science investigations. Many thanks to Audra Marcantonio and the LI Science Museum for bringing this fun and educational learning experience to the students of Glenwood Landing.

## HIDDEN GEM: Whitting wraps up big senior season

One thing is apparent about Jake Whitting. Once on the football field, the young man is a quick study.

Whitting completed his football career at St. John's Military School this past weekend, wrapping up a record-setting season as a receiver for the Muleskinners. The numbers put up were impressive enough. They become almost remarkable when coupled with the fact that this was Whitting's first full season at the position.

"From my position, I call him raw," St. John's head coach Mike Reid said. "We have been very fortunate to have a diamond in the rough."

Whitting's football skills were certainly raw when he arrived for his first practice at St. John's Military prior to the 2012 season. It didn't take long for the coaches to find a place for the inexperienced freshman.

"I never really played organized football until I came to St. John's and played my freshman year," Whitting said. "I used to swim and play baseball, but when I came to St. John's they didn't have either of those so I decided to switch to football. "I picked it up pretty quickly. I was starting on offense and defense my freshman year and played about three games, but then I broke my ankle." After playing tight end and outside linebacker as a freshman, Whitting made position switches on both sides of the ball — to quarterback and safety — his sophomore year.

"There was really no one else to (play quarterback) so I kind of stepped in," Whitting said. "I liked playing quarterback, but I always loved playing receiver and catching the ball."

His junior season was cut short by a shoulder injury, and surgery on that shoulder has limited his participation on defense this season. Whitting still finished the 2014 season with 69 carries for 308 yards but also got some time at receiver in four games, making 10 catches for 263 yards and six receiving touchdowns.

When Reid took over the team prior to the 2015 season, he found some depth at quarterback with junior Joshua Smith and senior Tyler Adams, at times using a dual quarterback system. That freed up Whitting to do what he does best and enjoys most.

"I give them all the credit for throwing up some beautiful passes," Whitting said of Smith and Adams. "And for being able to stand back there and take the hits. "But I love playing receiver. Just going up and catching the ball and scoring that touchdown. My favorite part is the deep ball. I'm working on my short routes, but I love going long and can break a few tackles."

Whitting broke more than a few tackles during the course of his senior season. He finished with 86 catches for 1,332 yards and 19 receiving touchdowns over 11 games. He also added 336 yards rushing on 38 carries, and for good measure, completed 6 of 8 passes for 121 yards and two touchdowns in last week's playoff win over St. Mary's Academy.

"All season he has been double teamed and triple teamed, and it is still amazing how many yards he's put up," Reid said. "He definitely has good hands, and if it is in the area, he will lay out and go after it."

"The speed is going to come. He hasn't had any formal athletic training in that area."

At 6-foot-2, 190 pounds, Whitting has the size necessary to play at the collegiate level next fall. As Reid referenced, improving Whitting's speed could also improve his chances of getting more offers from four-year schools.

"My dream is hopefully playing college ball," Whitting said. "I'm not going to play basketball in the offseason. I'll be training and trying to get a scholarship. I have coach Reid and (assistant coach) Joe Risher helping me get my name out there."

"Hopefully, I will be able to train with (assistant coach) David Leonard at Sharp Performance, hit the weight room to get my 40 time down and my bench press up."

"He has to work on his speed a little bit, and he has got to get bigger, strong and faster," Reid said. "But I've coached many kids, and he has what it takes."

"He's got guys around him preparing him for the next level. He just needs an opportunity, and he has got to have someone come down the pike and give it to him."

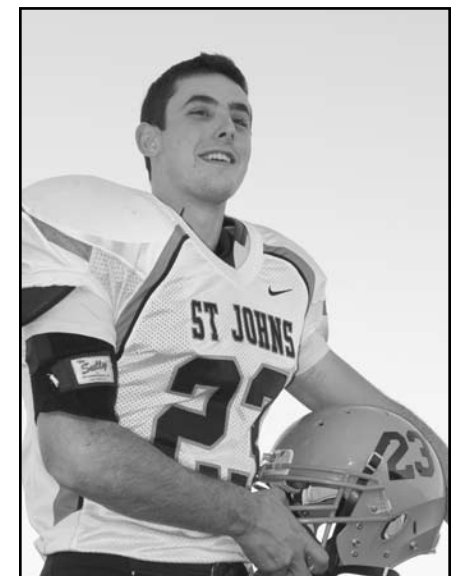
Whitting recognizes that the St. John's coaching staff has done and continues to do all it can to help him find a spot

next season. He also would like to use the opportunity to show student-athletes from St. John's can contribute at the next level.

"It's very satisfying to go out there and play the game I love," Whitting said. "Just to be able to go out there and, even though it is a small school, kind of put St. John's on the map."

"I want to thank everyone for their support. I have to thank my teammates, coach Reid, coach Risher and David Leonard for their support."

"The boys that come to St. John's are here for a variety of reasons," Reid said. "Jake has had some ups and downs with injuries and personally growing to be a young man. This year he found his niche."

## Mayor Spinello Delivers State of the City Update to IAC



The Glen Cove Interagency Council (IAC) recently held its monthly meeting at Glen Cove City Hall. After installing IAC officers for the coming year, Mayor Reggie Spinello provided IAC members with an update on various projects around Glen Cove.

The Mayor said that things are moving well in Glen Cove. He has been working with the Senior Center on a number of projects of interest to the senior community. These include a new program called Senior Outreach for Safety – “SOS”. This program provides seniors with information on how they might be scammed. An officer has been assigned to meet with the seniors every couple of weeks. He updates them on what is going on in the community and receives feedback. The City also secured a grant from the Community Development Agency, the proceeds of which were used to install automatic doors at the Senior Center. Parking is

always an issue at the Senior Center. In an effort to alleviate the situation, the Mayor directed the Public Works Department to dedicate 20 parking spaces at the Coles School to seniors who go to the Senior Center. One of the Senior Center buses will provide shuttle service between Coles School and the Center.

The Mayor said the “Open for Business” campaign is going well. It is overseen by Deputy Mayor Barbara Peebles. Since its inception, Glen Cove has attracted 30 new businesses that have brought in 250 new jobs. In addition, the campaign has resulted in many businesses remaining in Glen Cove. One new business is Panera Bread. Doherty Enterprises (Panera franchisee) said Glen Cove was one of its most successful openings.

The waterfront project is moving forward. The City has approval for construction of the road and has received

a \$10 million grant to go toward planning and construction costs. The City hopes to close on Phase I by the end of the year and to have the shovel in the ground by mid-2016. Completion of the waterfront project will make Glen Cove a destination location and should help increase property values. It is a question of balance – Glen Cove needs the demographics (i.e.: more people) to bring in more businesses.

In terms of quality of life, the Mayor said that illegal housing prosecutions are up. There have been over 60 prosecutions that have resulted in over \$200,000 in fines. The police force is at full strength. The CPU targets hotspots. The Mayor accompanied the unit one evening in early September. The unit made three arrests in two hours.

The Glen Cove IAC includes community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen

Cove’s rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis. 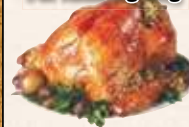

## TALKING TURKEY



Thanksgiving holds different meanings to different people. Some feel it is a day for being generous or giving thanks through unselfish deeds. Others feel it is a time to sit around with family sharing stories of the year. Still many others simply look forward to the day for football. No matter how you view Thanksgiving, one thing is for sure, filling up on turkey is an integral part of the holiday.

Here's a refresher on dealing the all-important gobbler.

### How much turkey should be purchased?

Allow 1 pound of uncooked turkey per person from an 8 to 12 pound turkey. Larger birds have a larger proportion of meat to bones, so 3/4 pound per person should be sufficient with leftovers for the beloved turkey sandwich or soup.

By purchasing a larger turkey than needed for the holiday feast, you can transform holiday extras into timesaving meals. Freeze the extra cooked turkey and you'll have your

own "ready-to-prepare" healthy food for quick and easy post-holiday meals.

### How should the turkey be thawed?

Frozen turkey, like all protein foods, should be thawed in the refrigerator, never at room temperature. When foods are thawed at room temperature, surface bacteria can rapidly multiply to dangerous levels at temperatures of 40° F and above.

For safety and superior quality, leave turkey in the original packaging and place in a shallow pan. Thaw, in the refrigerator, using the simple formula: whole turkeys thaw at a rate of 4 to 5 pounds per 24 hours. Example: A 15-pound frozen bird will take 3 to 4 full days to thaw in the refrigerator.

Speed thawing: keep turkey in the original tightly sealed bag and place in a clean and sanitized sink or foodservice safe pan. Submerge in cold water and change the cold water every 30 minutes. The turkey will take about 30 minutes per

pound to thaw. Refrigerate (at 40° F or below) or cook the turkey when it is thawed. Do not refreeze uncooked, defrosted turkey.

### What are the key pointers for stuffing a turkey?

Stuffing should be prepared and stuffed into the turkey immediately before it is placed in the oven for roasting. If preparing the stuffing ahead-of-time, wet and dry ingredients should be refrigerated separately and combined right before stuffing the turkey.

Stuff the turkey loosely, about 3/4 cup of stuffing per pound of turkey. Test the internal temperature of the stuffing as well as the turkey. The internal temperature in the center of the stuffing should register 160 to 165 F.

### When is the turkey done?

Since turkey is low in fat and high in protein, the meat is sensitive to extreme heat and prolonged cooking. Loosely place an aluminum foil tent over the turkey

breast during the first 1 to 1 1/2 hours of roasting, then remove to allow the turkey to brown.

A turkey should be cooked just until it is done. The best way to determine the level of doneness is with a food thermometer. Use these tests to determine doneness and to keep the turkey juicy.

For whole turkey, place the food thermometer in the deepest part of the thigh, but not touching the bone. The internal temperature of the turkey should measure 180° F in the thigh and 170° F in the breast. Juices should run clear and the drumsticks should be soft and move easily at the joint. 🦃

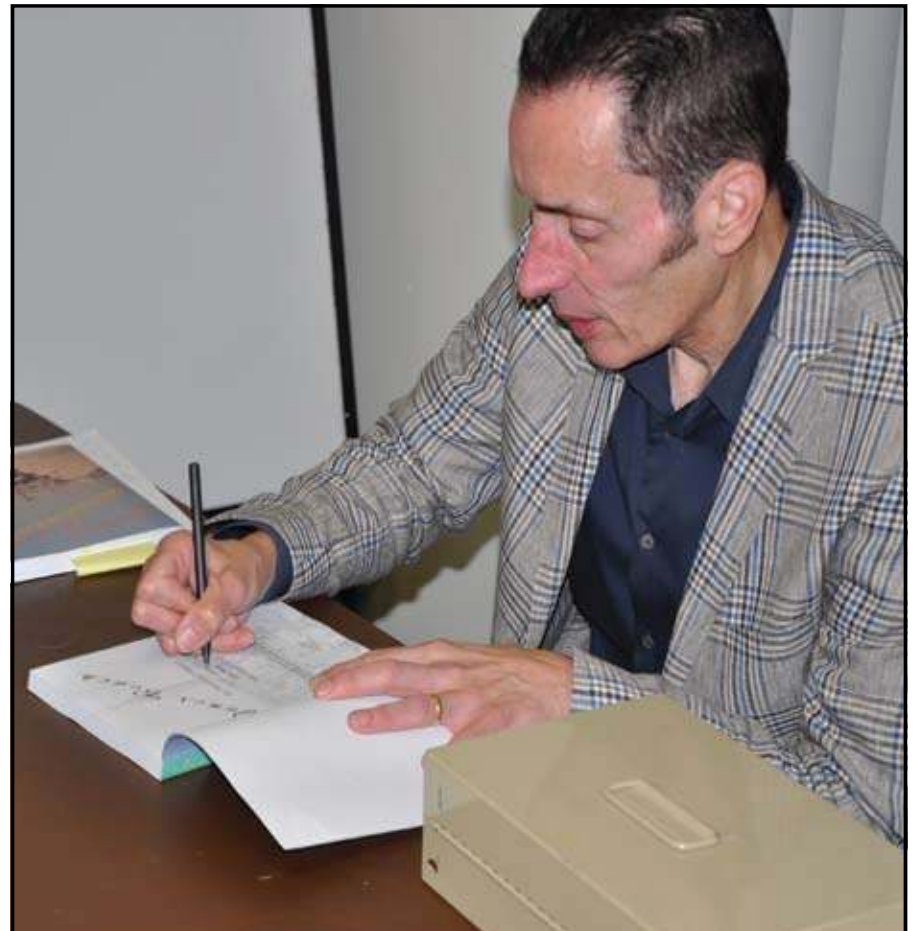


# Author John Hanc Presents The History of Jones Beach

## Last Week's Celebrity

Last week's celebrity was John Doucette. He was the "Sheriff" in John Wayne's "True Grit" (1969), "Uncle Ben McCandles" in "Nevada Smith" (1966) with Steve McQueen, and as "Sheriff Monte" in "One More Train to Rob" (1971) with George Peppard and Diana Muldaur. Many baby-boomers first saw him as the bad guy in several TV episodes of "The Lone Ranger" with Clayton Moore. This was a natural role for him considering his rough looks, commanding presence, and skill with a gun. He was considered, by many, to be one of the fastest draws in Hollywood. His roles, however, went well beyond that stereotype. He appeared on a variety of TV shows, including "The Fugitive", "The Roy Rogers Show", "Bonanza", "The Virginian", "Hogan's Heroes", "Sea Hunt", "The Adventures of Superman", "My Friend Flicka", "Sky King" among many more. Between 1959-61, he played "Lt. Weston" on the TV series "Lock Up" with MacDonald Carey. He twice played the Apache chief, Geronimo, on "Tombstone Territory" and "Death Valley Days". In 1961, he was cast as "Capt. Cardiff" in "The Americans", a 17 episode NBC series, starring Darryl Hickman, about how the American Civil War divided families. He passed away at the age of 73 on Aug. 16, 1994.

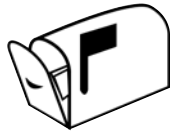
This week's celebrity was born in Walters, Oklahoma on Dec. 13, 1908. He was an American theater radio and film actor. He played mostly character parts over the course of his film career. He began his acting career on Broadway in the early 1930s before being signed to a contract by RKO Radio Pictures. He made his film debut in "A Woman Rebels" (1936), opposite Katharine Hepburn. He eventually was signed by Metro-Goldwyn-Mayer. They began to groom him as a leading man in B movies and provided him with supporting roles. They initially cast him in roles in films such as "Santa Trail" (1940) with Errol Flynn, Olivia de Havilland, Raymond Massey and Ronald Regan.

He began to hone his acting skills throughout the early 1940s. He provided a compelling characterization of the embattled President Andrew Johnson in "Tennessee Johnson" (1942). He played opposite Lionel Barrymore who, in the role of Congressman Thaddeus Stevens, failed to have Johnson convicted in an impeachment trial by the slimmest of margins. 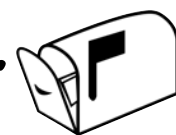

all the way to the next election. On Day 1, the new Councilman managed to declare complete and utter disloyalty to the man whose popularity and hard work had just gotten Spagnoletti elected.

For the next 22 months, Mr. Spagnoletti and his new political pal, Tony Gallo, devoted their energies to undermining the new Mayor's success in office whenever the opportunity arose. As a result of this infidelity, the Republican Party refused to endorse them for reelection. Mr. Gallo's response? He declared himself a candidate for Mayor, put together his own slate of City Council candidates, and then, together with Spagnoletti, forced a Republican primary which Gallo promptly proceeded to lose while Spagnoletti squeaked out a 5th place win to get himself on the Republican line.

With his name thus on the Republican line, Spagnoletti then stuck it to the Republicans again by joining Gallo in creating another party - the so-called Glen Cove United Party. What this meant, of course, was that in the general election, the hapless Mr. Gallo would only appear on one line, while Spagnoletti would be on two. It was, in effect, the perfect politically schizophrenic storm for Spagnoletti. By running with Mayor Spinello on the Republican line while simultaneously running with Tony Gallo on the opposition Glen Cove United line, Spagnoletti essentially declared that he was in favor of Mayor Spinello's initiatives while he was simultaneously against them. Put another way, by running on politically opposing lines, Spagnoletti established himself as a politician who stands for nothing but his own election.

On Election Day, Mr. Spagnoletti only received 61% of the insurgent Gallo Party votes. Had this been his only line, Spagnoletti would have handily lost his seat. But, in an odd twist of fate, he picked up enough votes on the Republican line to give him a victory. Intellectually, it was impossible for a voter to support both Reggie Spinello and Spagnoletti in the same election because they are politically polar opposites. But because so many voters

make the common mistake of voting a straight party line instead of principle, Spagnoletti once again picked up enough votes from Mayor Spinello's popularity to get himself back into office while his pal, Mr. Gallo, went down to defeat.

Obviously, what Mr. Gallo never realized was that while he never had any realistic chance of beating Mayor Spinello, Spagnoletti could cash in for himself if Gallo created an opposition party that could give Spagnoletti enough additional votes to get him over the finish line while his leader and pal could never reach it.

And that's exactly what happened. Gallo went down to defeat, as expected, while Spagnoletti, who'd encouraged Gallo to create the new Glen Cove United Party, parlayed his Republican primary win into a personal success. Had Mr. Gallo only known how it would all play out, the Glen Cove United Party might well have been named the Efraim Spagnoletti Re-election Party. When you think about it, if Tony Gallo had refused to buy in to the foolishness of trying to unseat a popular mayor and just run for re-election to his own Council seat, it would be Mr. Gallo, an otherwise popular fellow, who would be getting sworn in this coming January 1 while Mr. Spagnoletti would be out looking for a new job.

On January 1, 2016, Mr. Spagnoletti will raise his right hand to take the oath of office while Mr. Gallo will be using both hands to pull himself out from under the bus where he was thrown when someone told him that creating a new party to run a race he couldn't ever win was a good idea.

Friendship in politics, it seems, has no limits.
