



Glen Cove Waterfront Economic Redevelopment Project Will Not Be Derailed By Sea Cliff Lawsuits

The Garvies Point Waterfront Project, which will boost Glen Cove's economy, create new public amenities and activate the City's waterfront after decades of neglect, will continue to advance, despite the filing of two lawsuits last week in Nassau County Supreme Court, seeking to stop the Project just months before shovels are ready to enter the ground.

The Village of Sea Cliff filed a lawsuit seeking to overturn the Planning Board's October 6, 2015 approval of an Amended PUD Master Development Plan for the Project. The Village claims that the Amended Plan will worsen views from Sea Cliff of the westernmost building, and also that the development proposal violates a purported Memorandum of Understanding (MOU) from 2000. These claims are without merit, and the City is confident that the Court will reject the lawsuit.

Contrary to what Sea Cliff claims, the Amended Plan will improve the view sheds from Sea Cliff and Hempstead Harbor, as compared to the prior approved PUD Master Plan from 2011. The prior Plan approved a continuous row of buildings, with 12-story "bookends" on the west side of the Project.

Under the Amended Plan, the density on the west side would be significantly reduced by approximately 270,000 gross square feet, and consolidated into just two building blocks. This will completely open up the center of the Project's west side for a new Garvies Point Park and other public amenities. Garvies Point Park will be just one of several exciting spaces for the public to enjoy recreational and other activities. Mayor Spinello stated, "The changes to the west side will greatly improve visual corridors, and ensure that our waterfront will be an attractive and inviting destination for our residents and visitors."

The City also maintains that the 2000 MOU is legally unenforceable, and has never once been raised or mentioned by the Village during the past 15 years when the planning for the Waterfront Project advanced. Mayor Spinello stated, "My attorneys advise me that the Courts do not protect parties who sit on whatever rights they think they have, and suddenly appear years later, at the last minute trying to change things. There would be tremendous prejudice caused to the City and Redeveloper, who both continue to devote substantial resources to making this long-awaited economic redevelopment Project a reality. We have kept the Village of Sea Cliff fully informed about the Project, and will continue to do so in the future."

The separate lawsuit filed by a small group of residents mostly of Sea Cliff

and a few residents of Glen Cove, is also without merit. These residents challenge the Planning Board's approval on environmental grounds, claiming that there is "new" information that supposedly requires the Board to completely re-open the SEQRA process.

The information that these residents rely upon only confirms that the former industrial sites along the City's waterfront are at the goal line of being deemed clean and safe for the public's use and enjoyment after more than \$100 million dollars of remediation over the past two decades.

It is normal in brownfield redevelopment projects for certain residual contamination to be found in isolated spots as the site goes through its final reviews, cleanups and approvals. The Environmental Protection Agency (EPA) and Department of Environmental Conservation (DEC) have been fully involved in the Glen Cove Waterfront for close to 20 years, and will not grant final approvals until the site is safe and ready for re-use.

Additionally, the Glen Cove Planning Board exhaustively studied and is fully informed about the environmental conditions at the property. The law does not require a municipality to re-open the SEQRA process every time new tests are conducted and data is obtained as part of EPA's and DEC's final approval processes. Mayor Spinello said, "I applaud the efforts of EPA, DEC, the Redeveloper and the City in getting the property clean and ready for redevelopment. This effort has spanned multiple administrations across party lines and it is finally time to break ground, create jobs, and restore these sites to the City's tax rolls."

The SAFE Glen Cove Coalition held their Sustainability Planning meeting on October 27th to review their work from the previous year and strategically plan to recognize unmet community needs and the resources necessary to address them. The mission of the Coalition is to eliminate alcohol and substance abuse in Glen Cove. The Coalition is overseen by SAFE's Board of Directors and Co-Chaired by Councilman Tony Gallo and SAFE Executive Director, Dr. Sharon Harris.

The Coalition's four established committees (Community, School, Youth and Parents) each have their own charge based on alcohol and substance abuse use surveys administered to students every two years at the Middle and High School to identify trends and prevent future use.

The Coalition is aware of the community's needs through its ongoing collaborative efforts. It is composed of twelve sectors of the community which are: youth, youth serving organizations, parents, business community, media, school, law enforcement, faith based organizations, civic and volunteer groups, healthcare professionals, state, county

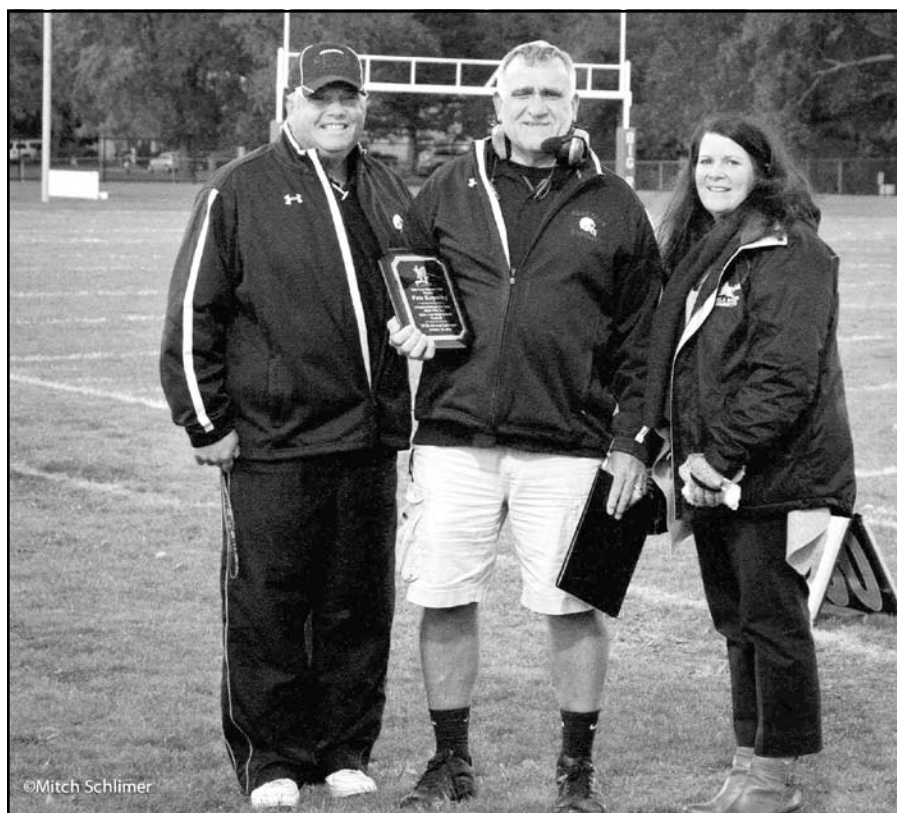

The Glen Cove Light and Power Company offered to wire the tree with lights and provide electricity for Christmas Week - it took a crew three days to wire the tree and when it was first lit on December 24th, the Glen Cove community gathered to listen to children singing Christmas carols.

Blind singer, drummer and motivational speaker, Vinny St Martin, gave a moving multi-media presentation on how his blindness allowed him to "see" people as they really are, not the color of their skin or the way they dress.

The Glen Cove Arts Council sponsored these presentations recently, at the Oyster Bay/East Norwich Boys & Girls Club, in Oyster Bay, and at the Grenville Baker Boys & Girls Club in Locust Valley.

Children, from first grade up through middle school age, listened attentively to the presentation as Vinny St. Martin spoke to the youth and told his story, along with some singing with band mate Elysa Sunshine, and a video filmed in Glen Cove. There was a short original song performed by Vinny and Elysa, and later a spontaneous rendition of a Ray Charles song, in which the children joined in with

clapping and singing.

This was followed by a question and answer period, and the children wanted to know how Vinny became blind, and what had happened to the boys who had befriended him in school. Many wanted photographs taken with him.

The Glen Cove Arts Council also

SC Fifth Graders Study Environmental Issues Collaborate with NS High Students on an Environmental Field Study at Tappen Beach

For the past several weeks, Sea Cliff fifth graders have been studying environmental issues associated with Long Island's waterways. During their time in enrichment class, students researched the effects of nitrogen on the Peconic River fish kill and met with members of Citizens Campaign to learn about protecting Long Island's aquifer system. Students conducted experiments, analyzed data and discovered that fertilizers and sewage can increase nitrogen levels in Long Island's waterways causing algal blooms, fish die offs, and contamination.

As an extension of this study, on Thursday, October 28th, the fifth graders joined 10th and 11th grade science students from North Shore High School to collaborate on an environmental field study at Tappen Beach. The day began at Sea Cliff School with an informative presentation by Eric Swenson of Hempstead Harbor Protection Coalition. Mr. Swenson shared his knowledge of Hempstead Harbor's rich history as well as the environmental issues affecting the Harbor and current solutions to improve water quality.

At Tappen Beach, North Shore's high school students skillfully organized a series of authentic, inquiry-based environmental investigations. They guided younger students on a nature walk to record the time of day, weather, and air and water temperatures.

Then, work began at Station 1 where students performed a test to compare the nitrogen levels of water from two different locations; Scudder's Pond and Hempstead Harbor. The fifth graders discovered that Scudder's Pond had a much higher nitrogen level than Hempstead Harbor and predicted it was due to the town's rainwater runoff.

At the next station, students took part in a quadrat observation to identify biotic and abiotic factors. Closer to the shoreline, students observed living organisms like mussels, seaweed, and horse-shoe crabs and further away they noticed non-living objects like rocks and plastic pollution. High school group leaders engaged the 5th graders through extensive questioning and encouraged more detailed and descriptive

observations. The day's investigations concluded with students collecting trash and debris in an effort to preserve and protect the Tappen Beach ecosystem.

Mr. Zublionis said, "The work at the beach was terrific. Not only did the high school students act as engaged teachers but our grade 5 students were actively engaged for the entire time."

This fantastic learning experience became a reality through the collaborative efforts of Mr. Menchel, Ms. Hogan, Ms. Pastuch and their 10th and 11th grade science students along with Mr. Zublionis, Ms. Smyth, Ms. Levy, Ms. Mishkin, Ms. Uanino and Mrs. Krupin. A special thank you to all faculty and staff that provided assistance to make the day's events even better for our 5th grade students!

Glen Cove's Tran Named Math Scholar



The Institute of Creative Problem Solving for Gifted and Talented Students at SUNY College at Old Westbury has named Glen Cove High School freshman Matthew Tran a Long Island Young Scholar of Mathematics and accepted by the institute to pursue mathematics and mathematical science applications.

Tran is one of 84 students who competed against approximately 600 of the top ranking students nominated from school districts on Long Island.

Selection by the institution implies Tran is among the top one-tenth of one percent in math of all students in his grade. Acceptances were based on five criteria: nomination, school transcript, teacher recommendation, a brief statement written by the students and a rigorous entrance exam.

Each student is expected to spend 60 hours in class over the course of 20 Saturday mornings, and on related topics. The curriculum covers mathematical topics from algebra, geometry, discrete math and number theory. Topics not included in the standard course of study, such as problem solving applied to probability, drawings of ocean bottom profiles, theory of finite differences, topics in science and mass point geometry will also be presented.

Tobacco Kills Too Many Vulnerable New York Youth

Great American Smokeout Spotlights Pressing Need to Help Change the Odds

The Great American Smokeout is an annual reminder that quitting smoking is critical for good health. Sadly, the most at-risk populations in New York haven't been able to quit on this day or any other. The use of Tobacco is still the leading cause of preventable disease and death killing nearly 24,000 New Yorkers every year and afflicting nearly 600,000 New Yorkers with serious disease directly attributable to their smoking. Tobacco is not an equal opportunity killer – there has been no reduction in smoking rates among low-income adults, adults with poor mental health, and those with less than a high school education.

The Coalition is Co-Chaired by Anthony Gallo, GC HS Health Education Teacher and the School Committee is chaired Denise Kiernan-GC SD Director of Health, Phys Ed & Athletics.

The American Cancer Society, sponsor of the annual Great American Smokeout, estimates that 30 percent of cancers could be avoided if people stopped using tobacco. Quitting smoking is the single most important step you can take to reduce your risk of cancer and improve your health.

Per Carol Meschkow-TACLI Nassau Project Coordinator, "For our youth, reducing initiation is the greatest weapon in the effort to prevent addiction. The New York State Tobacco Control Program continues to focus their efforts on youth for a very clear reason. 90% of smokers smoke their first cigarette by the age of 18. It is during these formative years that our youth are most vulnerable to Tobacco Marketing especially at the Point-of-Sale including exposure at pharmacies that are still selling tobacco products. "As a result of the youth's advocacy, we hope that they will be instrumental in encouraging their peers and those they care about that smoke, to take this day as a first step toward quitting like a champion" said Meschkow.

The SAFE Glen Cove Coalition annually partner's with the TACLI to impart prevention education as well as implement environmental strategies such as no-smoking signage throughout public and private city wide facilities. "This partnership had produced incredible results by bringing together all of the community stakeholders on behalf of the local youth. The Coalition is fortunate to have Ms. Meschkow as an instrumental member, helping to prevent the next generation of smokers" said Dr. Sharon Harris, SAFE Executive Director and Coalition Co-Chair. Name the Celebrity



This week's celebrity was born Eartha Loehr in New York City on July 5, 1926. Her father was an oil supply executive and her mother, a concert pianist. Our celebrity was considered a child prodigy. She began taking piano lessons at age 4, and by the age of 12 was playing with the Los Angeles Junior Symphony Orchestra. As "Dolores" Loehr, she made her film debut playing the piano in "They Shall Have Music" (1939) starring famed violinist Jascha Heifetz (as himself), Joel McCrea, Walter Brennan, and Majorie Main. She was once again back at the keyboard in "There's Magic in Music" (1941), with Allan Jones and Margret Lindsay, when it was decided that she had more potential than she had been allowed to show. Paramount Pictures changed her name and began casting her in films that allows her to show her personality and developed her skills as an actress. Her comedic scenes with Ginger Rogers in "The Major and the Minor" (1942) were well received and in 1944 she scored an outstanding success in Preston Sturges' "The Miracle of Morgan's Creek" with Eddie Brackan and Betty Hutton. Back in the late 1960s, if one was a patron of downtown Oyster Bay stores such as Bohack's, in the center of town, the A&P, presently Dodd's & Eder, Snouder's Drugstore, and the very nostalgic, Buckingham's 5 & 10, one had a great opportunity to bump into our celebrity, who had a summer home in Oyster Bay Cove.

Last Week's Celebrity

Last week's celebrity was the craggy-faced, dependable star, character actor Van Heflin. He never quite made the Hollywood A-list, but made up for what he lacked in appearance with hard work, charisma and solid acting performances. After his parents separated, he was farmed out to his grandmother in California. He was never quite settled and his restless spirit led him to ship out on a tramp steamer after graduating from school. After a year at sea, he studied for a law degree at the University of Oklahoma, but after two years he decided he had enough and went back to sailing the Pacific. When he returned, he decided to try his hand at acting and enrolled at the prestigious Yale School of Drama. His first foray into theatre was the comedy "Mister Moneypenny" (1928) credited as Evan Heflin. He had a string of disappointing plays for several years and actually returned to the sea for awhile. Thank goodness that adventure didn't last long. In between wartime service and two musicals, "Presenting Lily Mars" (1943) and the Jerome Kern biopic "Till the Clouds Roll By" (1946), he appeared in the excellent film noir "The Strange Loves of Martha Ivers" (1946) with Barbara Stanwyck and Kirk Douglas. Through the 1950s and '60s, he appeared in a variety of films and plays. One of his last performances was as the deranged bomber in "Airport" (1970) with George Kennedy, Burt Lancaster and Dean Martin. His final curtain call on stage was as "Robert Sloane" in "A Case of Libel" (1963-64) on Broadway. Unlike many of his peers, Van shunned the limelight and was never a part of the Hollywood glamour set. A well-liked, introspective and talented performer, he died of a heart attack on July 23, 1971, aged just 60

At its core this is an old fashioned novel of families: the wealthy Hamilton

Sweeneys, the Californian- Vietnamese transplant and her journalist neighbor, the East Village anarchist study group, a punk band, the heroin addicted artist and his young lover from rural Georgia, an aging police inspector and his wife, and finally, Samantha and Charlie, teenagers from Long Island who seek excitement and enlightenment in a city literally on fire. The story finds its focus early on when Samantha is found near death in Central Park. The thirty nine characters we meet are all connected in some way to her and to one another and to the City- which is the most colorful and important of this novel's characters. Recommended!
