### City's Grand Menorah

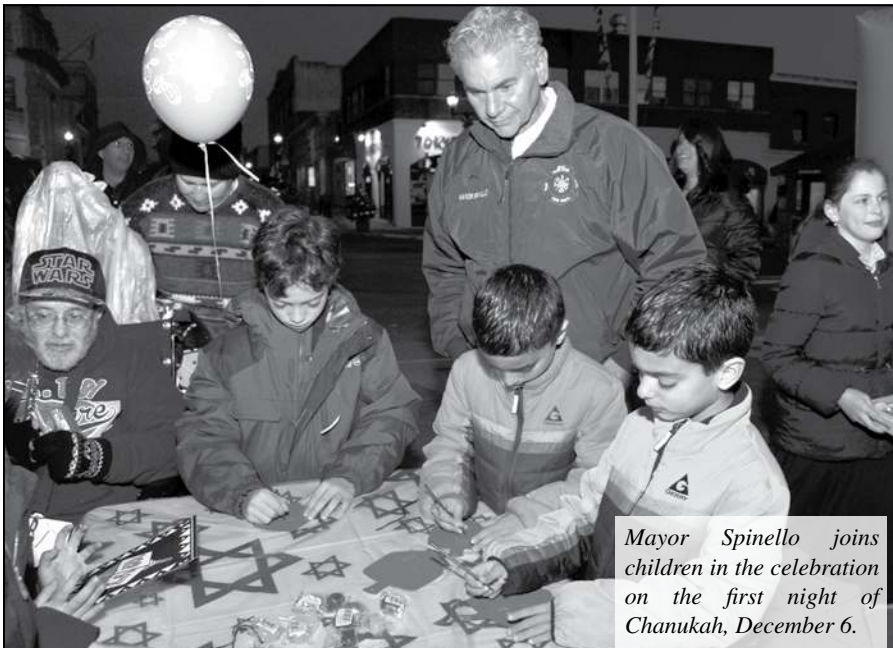

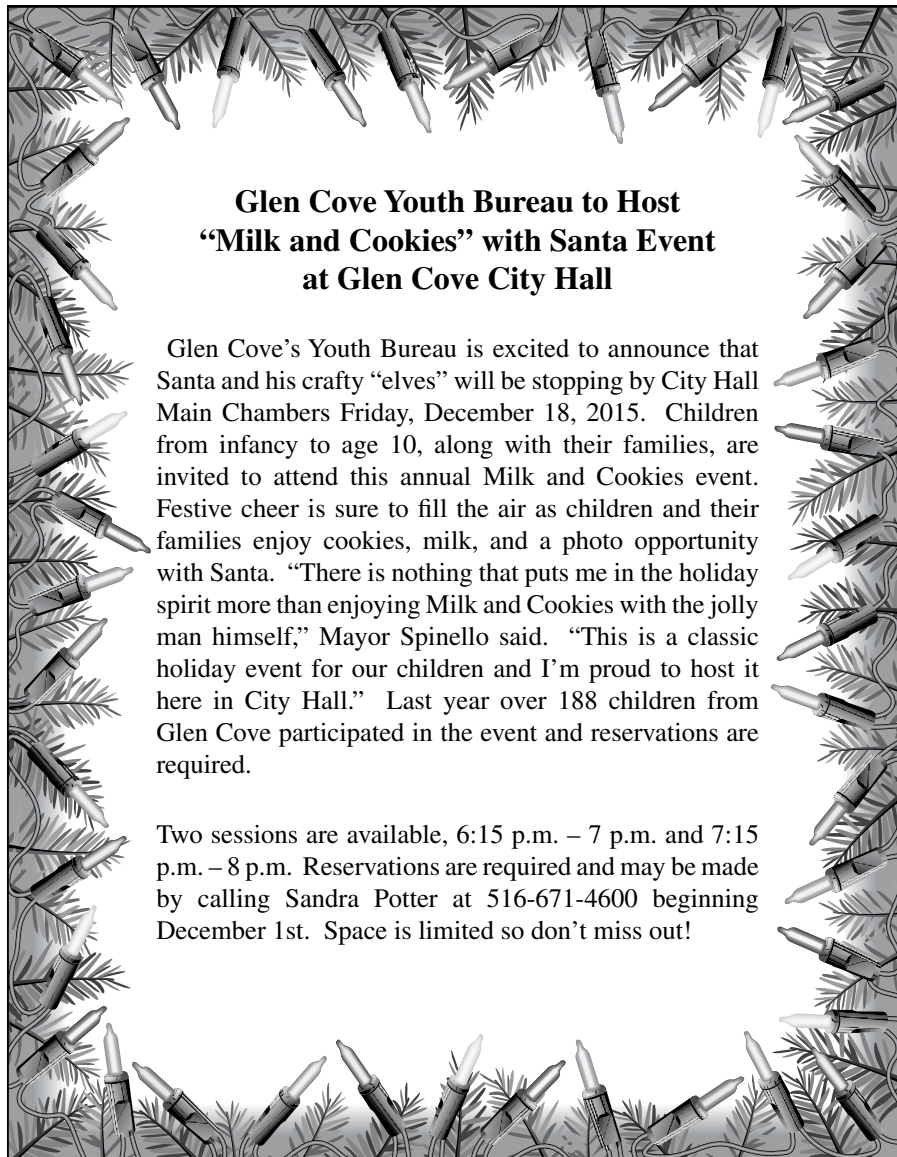

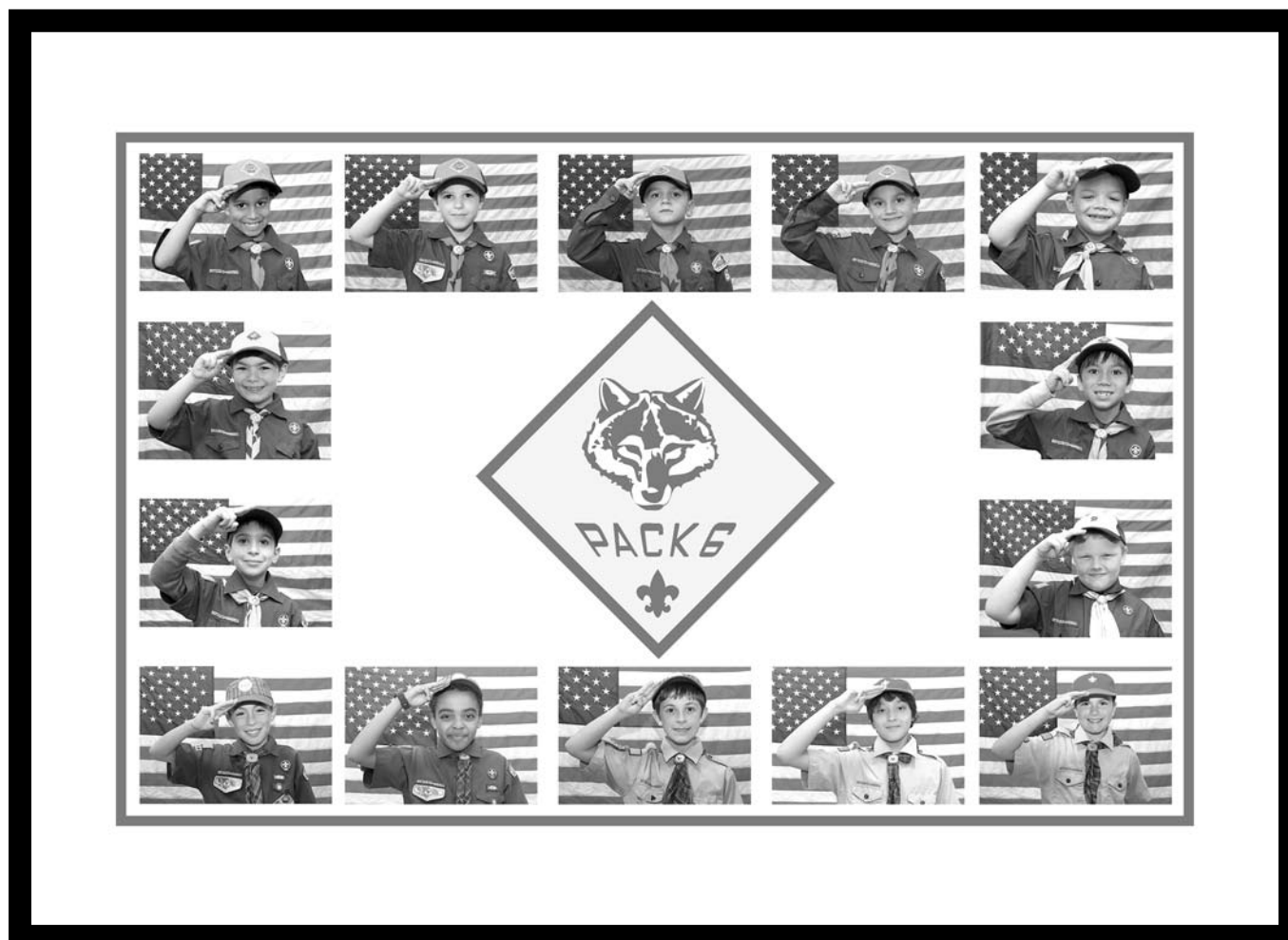

## A Memorandum Of Misunderstanding To The Editor,

We are talking about the irreversible future here. The City of Glen Cove has moved forward in a process that will leave the village of Sea Cliff looking at an 11-story tower, plus other buildings, that will cast a shadow over Hempstead Harbor and that part of the Long Island Sound which has always made the area postcard-perfect and accommodating to hundreds of residents, neighbors and visitors every year. Not to mention environmentally stable, but only if diligently nurtured by us and left to Mother Nature's healing powers.

All of this will go to pot if Glen Cove proceeds with its insensitive Waterfront Project by ignoring a Memorandum of Understanding which was supposed to maintain the mutual resources that both municipalities were blessed with. In the year 2000, mayors Tom Suozzi of Glen Cove and Claudia Moyne of Sea Cliff duly signed an agreement that

pledged a continuation of our symbiotic relationship so that future leaders of the two constituencies would respect and benefit from such a cooperative arrangement.

But now Glen Cove's newly reelected mayor, Reginald Spinello, has other ideas. He has watched his planning board grant a permit on Oct. 6 so that the city and latest interested developer can go ahead with an extravagantly more involved and lucrative plan. Mr. Spinello has gone on his own with the city council to include the millions of dollars in presumed revenue from the waterfront sale to balance their 2016 city budget. Talk about putting the cart before the horse. Additionally, attorney Michael Zarin of White Plains, Glen Cove's special advisor for this case, calls the Sea Cliff suit a last-minute "Hail Mary" by the plaintiff that was not unexpected.

Well, Sea Cliff mayor Bruce Kennedy has other ideas, too. He has filed a lawsuit in State Supreme Court to halt any further movement or motions before his tiny square-mile village goes head-to-head against the giant city, which happens to be the largest municipality on Long Island. This personal confrontation likely will take place sometime in January at the earliest.

Put it this way, we will be acknowledging the devoted mayors who had the presence of mind to safeguard our hometowns from the over-indulgence of capital-minded civil servants who would cast our properties and rights asunder. Those mayors are asked to join us if possible at any upcoming hearing so that their foresight does not dissolve into a Memorandum of Misunderstanding.

Pearl Harbor in Vivid Color  
To The Editor,

For the United States, World War II began with the Imperial Japanese attack on Pearl Harbor. My generation arrived over twenty years after the end of the war and most of us looked upon the black and white photos of sunken ships, raging oil fires and floating bodies with the detached indifference of a middle school Social Studies student two minutes before the bell. By the time my generation

matured to the age of comprehension, a new Japan had emerged from the ashes and had dominated American imports with cheap goods. In those days everything was "made in Japan." The faded black and white photos of Pearl Harbor, Gaudal Canal, Iwo Jima were replaced by shiny new televisions, electronic goods, automobiles complete with plastic accoutrements of every color of the rainbow. The world had simply moved on. Today post-WW 2-generations struggle with the notion of "remembering" an event, which took place before color film. An event, like all things black and white, pushed away and

shunned like an episode of "My Three Sons" or "Leave it to Beaver."

American service members who were present in Pearl Harbor, December 7, 1941, saw and experienced this event in excruciating color; the fires burned orange to blue-hot from the burning oil and ordinance and American blood spilled in dark crimson. No color could ever capture the grief and bereavement of the parents, spouses and children, brothers and sisters of the lost. The pain simply wasn't black and white it was something else. Something that was real, unimaginable and not quantifiable. The anger and resolve of a nation was in vivid color too. America quickly resigned and prepared itself for all out war.

As we go back in time and reflect on past American wars, less and less photographic images are available. Our study of pre-Civil war conflict is confined to oil paintings and literature. Never will the world gaze upon the photo of the young soldier who sacrificed his life in the War for American Independence. How will today's generation and future generations remember these great sacrifices, without the colorful drama played out on the likes of Youtube, Facebook or Gawker? Are these deaths less significant than a soldier that perishes in full vivid color splashed across the internet as "content"? The answer is; of course not, but how do we teach our children the significance of events that are in black and white or exist only in paintings and on pages? How do we preserve our freedoms when young people grow up ignorant of the sacrifices made to secure them? On December 7, 1941, 2403 Americans were killed and 1,178 wounded at Peal Harbor. Let us teach our children that freedom is not free and that sacrifices such as Peal

Harbor are as vivid, colorful and relevant today as they were in 1941.

## Garvies Point Development To The Editor,

My family and I moved to Sea Cliff in 2012. We love our beautiful town and especially our waterfront. We enjoy swimming at Sea Cliff Beach and watching the amazingly beautiful, ever changing light of the sun as it sets over Hempstead Harbor. We also enjoy the bucolic nature of life on the North Shore, even though getting in and out can be a challenge because of the traffic on the already crowded roadways.

In June we became aware of the Glen Isle/RXR plan to develop the land along Glen Cove Creek, directly across from Sea Cliff Beach and simply could not believe that a project of this scale had been approved by the City Of Glen Cove and its agencies (IDA, CDA, Planning

Board etc).

My wife and I got involved and started learning about the history of the site... the Superfund Status, the ever changing plans, and how the project morphed from a lovely "Mystic Seaport" type of destination to a massive 1110 unit residential development with 125' tall buildings!

We attended the GC Planning Board meetings and the City Council meetings where we heard public officials say in essence "where has the public been all these years? Why are you just coming out now to protest this?" Needless to say, I was troubled by this lack of involvement from the community and went back through the official documents including the Final Environmental Impact Statement (FEIS).

It didn't take long to figure out that there have been voices of protest against this project since at least 2007, right about the time that RXR got involved. These voices (private citizens, the Coalition to Save Hempstead Harbor, Public Officials) of protest where cogent, well informed, and intelligent responses to the out of scale proposals put forth by the Developer/Planning Board et. Al. It is very apparent that these voices were consistently ignored or sloughed off. As it was then, so it is now!

There is still serious opposition to the size and scope of this project but individual citizens have consistently been ignored and their comments brushed aside because the developers had a vision and they would not be deterred.

There are very few avenues available to residents who oppose this kind of development. Public comment periods are one and litigation is the other. Litigation is prohibitively expensive and is literally a David and Goliath scenario. The 7-Billion Dollar Development company has unlimited resources to throw at lawyers while citizens do not. So really, the Public Comment Period is the only recourse that residents have. When those comments are ignored completely it leaves no means for public input. That is the case here. In every instance public comments were disregarded completely or explained away. One of my favorite responses in the FEIS is to a comment of the height of the buildings... the answer is essentially "well, there are only two, 12 story towers..." "ONLY"? In my opinion one 12-story tower is too many.

I will close with a comment submitted in 2009 by over 100 Glen Cove Residents through the Landing Pride Civic Association whose president told me they did not have the money for litigation and that there comments were ignored. They are as relevant today as they were then.

"In closing, I believe it's fair to say that you cannot add 3,200 parking spaces and the cars that will fill them to an area, and not feel a significant change in traffic impacts. You cannot

build on a 50+ acre plot for seven or more years, and not have inconvenience and noise for many people for a very long time. You cannot add a few green roofs and LEED building principles, and expect them to erase the damage that all this new construction, traffic, pollution and noise will perpetrate on the environment, wildlife and the community. You cannot offer a few pocket parks in between tall buildings, a turning basin which serves no real purpose, and give us view corridors which take away views, and call this an improvement over what's there. Sure it will look better aesthetically, but what

will the trade-off be? The DEIS, while comprehensive and detailed in certain places, fails to tell the whole story of the real quality of life and other impacts that will be felt for many years to come, nor does it begin to make the case for the benefits of the project. Will the dubious benefits of this high-rise high-density project be worth the loss of quality of life that it will cause? A dramatically scaled-down version of this project is the only solution for the true benefit of the community and environment."

According to Ferrufino, "It is exciting to see youth step up and take initiative to end tobacco sales in pharmacies as a direct correlation to their education on avoiding destructive decisions".

"This year's GASO theme is "Quitting Like a Champion". To that end, it's very invigorating to see the students who we've watched grow over the last several years take the lead in educating their peers and adults about the dangers associated with this addiction. Pharmacies are Licensed health care facilities and unfortunately the sale of tobacco products send an incongruent message to our youth. It's imperative to reduce youth exposure to tobacco marketing at the point of sale and I am confident the Glen Cove youth

will continue to advocate for change" said Carol Meschkow, Nassau Project Coordinator of TACLI.

# Name the Celebrity



(1884-1950), who played with our celebrity in "Juliet", originated the role of "Dolly Levy" on Broadway in 1938, when "Dolly" was just a minor character in Thornton Wilder's original play "Merchant of Yonkers". Seventeen years later, Wilder reworked the play as "The Matchmaker" with "Mrs. Levy" as the main character and that became the source of the musical, "Hello, Dolly".

### Last Week's Celebrity

Last week's celebrity was Marvin Miller. He was probably best remembered for two of his roles, as "Michael Anthony", employee of "John Beresford Tipton", voiced by Paul Frees, on the series, "The Millionaire" and the voice of "Robby, the Robot", in the 1956 American sci-fi film, "Forbidden Planet", starring Walter Pidgeon, Anne Francis and Leslie Nielsen. From the 1950s to the 1970s, he did a great deal of voice work in American animation. His work stretched from the narration on the 1950 Academy Award winning United Productions of America cartoon "Gerald McBoing Boing" to the 1970 "The Ant and the Aardvark" cartoon "Scratch, the Tiger". He voiced "Aquaman" for the Filmation studio for their 1967 series "The Superman/Aquaman Hour of Adventure." He was also the voices of pilot/scientist Busby Birdwell" in the company's animated series "Fantastic Voyage" and the arrogant alien "Zarn" on the "Land of the Lost". He also lent his distinct voice to "The Pink Panther TV Show". He won Grammy Awards in 1965 and 1966 for his recording of "Dr. Seuss" stories. He also read "Horton Hatches the Egg. Miller had over two dozen hobbies including woodworking, collecting menus, book-binding, painting, photography, and collecting rare phonograph recordings. He also recorded the entire Holy Bible on record, the first time that had ever been done. It contained more than a million words, and took a week and a half to play. He died on Feb. 8, 1985, at the age of 71, from an acute coronary.

### Correct Callers

Rich Reynolds, Don Adams, Mario Moccia, Will and Babs Hutchins, Roberta Pezza

This week's celebrity was an American stage and film actress, born in Gloucester, Mass. on Nov. 5, 1864. She was a sailor's daughter, who first came to the stage at the age of 16, performing with a stock company in either Boston, Mass. or Providence, R.I.. Both places have been reported. The year was 1880, and it took her another 26 years to make her debut on the Great White Way in "The Kreutzer Sonata". Already a seasoned actress, she enjoyed third billing. Her screen career started with one and two reels, as early as 1915, but her proper entry into Hollywood did not come about until 1933.

For more than 20 years, our plump, down-to-earth celebrity made her reputation as a character actress on Broadway playing an assortment of nurses, maids and aunts. She was used in musicals by George M. Cohan and acted in Shakespearean roles from "Twelfth Night" to "Romeo and Juliet". She was the nurse to Jane Cowl's "Juliet" in the 1923 play which ran for an unprecedented 174 performances and co-starred Eva Le Gallienne and Katharine Cornell. Like other successful actresses of the stage, our celebrity was brought to Hollywood to reprise a Broadway hit role. In her case, it was her "Aunt Millie" role in "Child of Manhattan" (1933) with John Boles and Nancy Carroll, from the Preston Sturges play of the same name. She was also the definitive incarnation of the endearing nurse, "Peggotty" in "David Copperfield" (1935) with W.C. Fields, Freddie Bartholomew and Edna Mae Oliver. Dear Delighted,  
I just finished a fascinating and very disturbing book: THE DEVIL'S CHESSBOARD by David Talbot. It's subtitle is "Allen Dulles, the CIA, and the Rise of America's Secret Government." A few months ago I recommended THE BROTHERS by Stephen Kinzer - a biography that detailed the lives of Allen and John Foster Dulles, showing their nefarious roles in 20th century global politics. This book focuses on Allen Dulles and his impact on the United States government and national psyche. As the longest-serving head of the CIA, he skillfully manipulated Congress, the FBI, and all three Presidents he worked

for: Truman, Eisenhower, and Kennedy. Richard Nixon himself rose to power as a result of Dulles's coaching and financing. His role in the Cold War and in particular the dark days of the McCarthy scourge are highlighted. His involvement with Nazi war criminals and the Mafia is revealed as is terrifying evidence of his role in the Kennedy assassination. The book reads like a spy thriller, but it supported by extensive documentation. The 21st century world we live in now is in many the creation of Allen Dulles. Recommended!
