At the town meeting, the public will have the opportunity to ask questions regarding this topic or any others. Also, on the agenda will be an IB Update.

Over the next couple of months, Trustees will then begin diligently reviewing the school budget. They strongly encourage all of our residents to get involved early, attend Board meetings, learn the facts, and stay informed. It was standing room only at the January 1, 2016 Inaugural ceremony for Mayor Reginald Spinello and members of Glen Cove's City Council. Judge Paul Meli and Judge Joseph McCall administered the official oath of office to Mayor Reginald Spinello and City Council members Joseph Capobianco, Nicholas A. DiLeo Jr., Pamela Panzenbeck, Efraim Spagnoletti, Timothy J. Tenke and Roderick Watson. Special guest, New York Senator Charles Schumer, acknowledged Mayor Spinello's successes in the areas of economic growth, stabilizing taxes and taking a hard line on illegal housing for the City of Glen Cove and noted his work with the Mayor on the Glen Cove Waterfront project as part of his remarks.

In his inaugural address to Glen Cove residents, Mayor Spinello said, "My promise this year is that my administration will concentrate on smart growth in our community – from our waterfront redevelopment to the revitalization of our downtown, I expect 2016 to be a watershed moment in turning Glen Cove into the vibrant municipality that it should be. Our vision is simple – make Glen Cove a "go to" destination for commerce, recreation, entertainment, culture and waterfront living. We're intent on infusing our local economy with new jobs, expanded tax revenues from sources other than homeowners and residents, and bringing in young professionals, empty nesters and new families who will appreciate the benefits of an affordable suburban City with beautiful surroundings and easily-accessible beaches." The Mayor concluded his address with an invitation to the community, "Please join me in becoming part of a team that nurtures our land for safe, sensible and smart development, that plants seeds of innovation with new and creative programs like Single Stream Recycling

which will save money and benefit our planet, that aggressively tackles suburban weeds like illegal housing and that sees the potential of achieving Glen Cove's promise – making our City a center of commerce and culture and a place you can be proud to call your home."

The ceremony was hosted by David Zatlín, Chairman of the Glen Cove Republican Committee, and featured a Presentation of Colors by representatives of the Glen Cove Police Department, Harbor Patrol, Volunteer Fire Department, Emergency Medical Services, Auxiliary Police, United States Coast Guard Flotilla 1203, Glen Cove American Legion Post 76, Glen Cove American Legion Post 1765 and Veterans of Foreign Wars James E. Donohue Post 347. Michael Renga, a second grader at Glen Cove's Gribbon School led the audience in the Pledge of Allegiance while singers John Brakatselos and Millie Sullivan sang the National Anthem and God Bless America. North Shore Elementary Students Participate in the National Hour of Code

In celebration of Computer Science Education Week during December 7-13, 2015, North Shore students embarked on an exciting adventure participating in the National Hour of Code that is a global movement sweeping the globe, reaching tens of millions of students around the world in over 180 countries.

The goal of The Hour of Code was not to teach anybody to become an expert in computer science, but to demystify coding and in one hour help students of all ages and backgrounds learn that computer science is fun and creative. Like learning a foreign language, it is recommended to begin at a young age so that students will have a foundation for attaining success as they embark on their careers in the 21st century.

At Glenwood Landing under the direction of Dr. Carol Smyth (Elementary STEM Director), Mrs. Audra Marcantonio (GWL School-wide Enrichment teacher) and their teachers, students participated in the Hour of Code in the new STEAM (Science, Technology, Engineering, Art, Math) Lab. In addition, Library Media Specialist Mrs. Stephanie Smith, and teachers Ms. Jen Chaputian, and Mr. PJ Ciampi helped work with the students.

Mrs. Marcantonio said, "This was an exciting opportunity to expose students to coding in a fun way! Every K-5 grade participated in coding lessons utilizing iPads where the "E" for engineering was emphasized! The hope was to simply expose students to coding and then offer resources to parents and their children to use at home." The various grade level coding activities included:

- Students in K-2 were coding a program called Lightbot.
- 3rd & 4th graders were coding Flappy Birds
- 5th graders were programming a "robot" friend by telling the kids the actual steps in code how to build stacks of cups

At Sea Cliff School under the direction of Principal Zublionis and Dr. Carol Smyth students participated in the Hour of Code in the Computer Lab and school library. The children of various grades participated in coding lessons after school in the computer room and library. The various coding activities included learning coding programs called Lightbot and Flappy Birds.

Dr. Carol Smyth said, "Today, we are surrounded by technology; many students have their own tablets and phones. We are enthusiastic about asking students to begin to explore how these devices work. Simple computer science activities, like coding, not only stimulate

interest in computer programming but also help nurture creativity, critical thinking, and problem solving skills." She concluded by saying, "As we work to incorporate STEAM (e.g., Science, Technology, Engineering, Art, Math) in our schools, we are excited to bring

innovative opportunities like this to our students."

North Shore Schools Kindergarten Registration

In September 2016, your child will enter Kindergarten and the start of an exciting journey. The first step into school is one of the passages in life that marks the beginning of new experiences and relationships. It begins an educational experience that will serve as a foundation for their future.

During the Kindergarten Registration Week and Orientation Week, you will learn more about our Kindergarten program and about our schools. First you must complete a registration process that provides us assurance of your residency in the North Shore Schools and the necessary demographic information on your youngster. Parents enrolling their child in non-public (private and parochial) schools must also prove residency and meet eligibility requirements in order to qualify for transportation and textbooks.

The first step in this process is to complete a residency packet. You may obtain this packet in person at the main office at any of the three elementary schools. Upon completing the required documents, please call Mrs. Katherine Miller, Registrar for the North Shore Schools, at 277-7824 to schedule an appointment to review your completed documents. Appointments will be available beginning January 19, 2016. This meeting should take no more than ten or fifteen minutes. At this meeting you will receive a second packet of information pertaining to the second step in the process, which is to register your child at the appropriate elementary school.

Please note the following registration dates for the Elementary Schools:

Glenwood Landing	March 7th through March 10th
Sea Cliff	March 14th through March 17th
Glen Head	April 12th, April 19th, and April 20th

The third step in preparation for Kindergarten will be orientation. Your school will contact you with the dates and details regarding the orientation program during which you will have an opportunity to become better acquainted with the school, the principal and some of the people who your child will work with beginning in September.

Superintendent Dr. Edward Melnick and everyone at the North Shore School District warmly welcome you and your family to North Shore. The next thirteen years will be ones of fulfillment and growth.

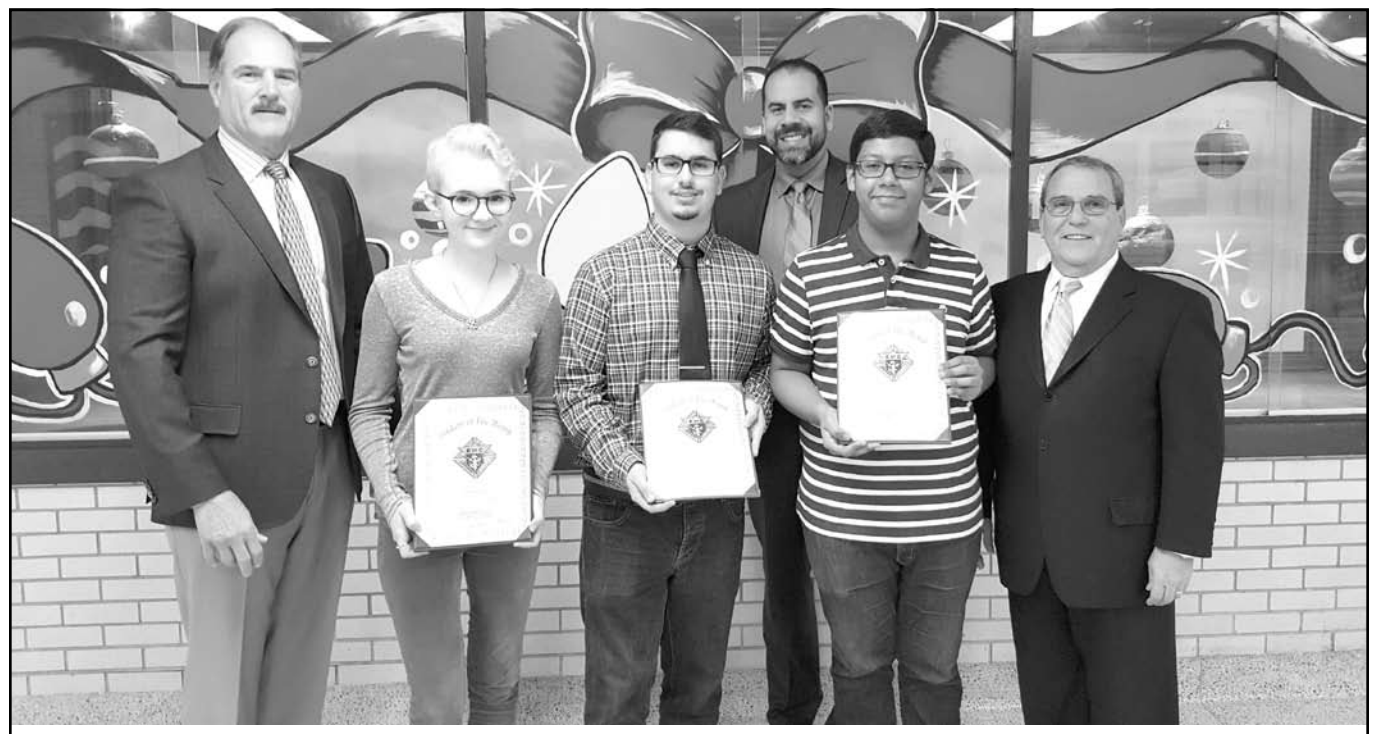

Bullying Prevention Education at Gribbin

Stand up comedian and former middle school teacher Mike Speirs delivered his anti-bullying presentation "Be an Upstander, Not a Bystander" to Gribbin School students as part of the school's observance of National Bullying Prevention Month.

During the fun and engaging, interactive presentation, Speirs used a variety of activities and multi-media resources to teach students what it means to be bullied. He also identified the different types of bullying, explained why bullying happens and provided strategies on how to stand up to a bully. Speirs explained the differences between reporting and tattling and gave examples to help students identify a "big problem" as opposed to a "small problem."

The presentation concluded with Speirs reminding students that when someone is mean it can hurt people. "If everyone in this room chose to be nice there would be no more bullying," Speirs said.

Students at Gribbin School also participated in STOMP Out Bullying's Blue Shirt Day World Day of Bullying Prevention. The "Be an Upstander, Not a Bystander" kicked off the school's Character Education program, which we will focus on respect and kindness.

Last Week’s Celebrity

Born Ernest Sharpe, last week’s celebrity was professionally known as Erik Rhodes. He was a capable baritone and stepped easily into musicals of the day, commonly playing the effete playboy that became his trademark. He portrayed a passionate Latin in “The Gay Divorcee” (1934) and again, just as passionate, as “Alberto Berdini”, in another Astaire-Rogers feature, “Top Hat” (1935) and from there moved into several secondary features of the day. He played “Leopold Jaynos” in “A Night at the Ritz” (1935) with William Gargan and Allen Jenkins and “Max Corday”, the sketch artist, in “Charlie Chan in Paris” (1935) with Warner Oland. He was “Archie Fisher” in “Chatterbox” (1936) with Anne Shirley and Lucille Ball and “Anton Spadissimo” in “Fight for Your Lady” (1937) with Ida Lupino, John Boles and Jack Oakie.

After serving in the Army Air Force Intelligence Service during WWII, as a language specialist, he did some early TV work most notably with Gloria Swanson in a variety show called “Wonder Boy”. Between 1947 and 1964, he was back on Broadway in “The Great Campaign”, “Dance Me A Song”, “Shinbone Alley”, “Jamaica” and “A Funny Thing Happened on the Way to the Forum”, to name a few shows. In the Cole Porter musical “Can-Can”, he appeared as a lecherous art critic and introduced the song, “Come Along With Me”.

He died of pneumonia on Feb.17,1990, at the age of 84. He was interred with his wife, who preceded him in death, in El Reno, Oklahoma.

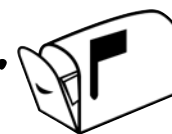
This week’s celebrity was born March 6, 1916 in Oklahoma City, OK and was an American film actress from the 1930s through the 1960s. She was a WAMPAS Baby Star in 1931. This was a promotional campaign sponsored by the United States Western Association of Motion Picture Advertisers, which honored 13 (15 in 1932) young actresses each year whom they believed to be on the threshold of movie stardom. The campaign ran from 1922 to 1934.

Our actress may be best remembered today for co-starring in “Wild Boys of the Road” (1933), a Pre-Code Depression era American film telling the story of several teens forced into becoming hobos. Directed by William Wellman, this film was selected in 2013, for preservation in the U.S. National Film Registry by the Library of Congress as being “culturally, historically, or aesthetically significant”. She also played “Cosette” in the 1935 film version of “Les Miserables” with Fredric March and Charles Laughton. She was Shirley Temple’s older sister, “Mary Blair” in “Curly Top” (1935), with John Boles and Natalie Wood’s mother in “Rebel Without a Cause” (1955), co-starring James Dean and Sal Mineo. She also played “Sally Glynn”, the fallen ingénue to whom Mae West imparts the immortal wisdom, “When

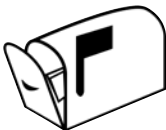

Jewelry Stolen From 96 Year Old Victim

On February 3rd 2015 a retired Glen Cove Couple was tricked by a group of men who posed as tree trimming crew who wanted to cut some trees in their backyard. According to Det. Lt. John Nagle, While the couple was distracted

another person entered their bedroom and removed a safe which contained the couples life savings, of over \$50,000 . The Glen Cove Police immediately began their investigation into the deception burglary. The Glen Cove Detective Division headed up the investigation and reached out to other jurisdictions who faced similar type burglaries. According to Nagle, The investigation into the burglary was assisted by the Suffolk County 4th Squad the NYPD Intelligence Unit, and the NY/NJ Fugitive Task Force (Marshals). Glen Cove Cove Detective Karl VanAllen was able to identify one of the suspects and a warrant was issued for his arrest. The detective was able to locate the wanted subject in New Jersey, and on December 18th the NY/NJ Fugitive Task Force apprehended Tommy Marion, also known as Nicky Anderson, in Cliffside Park N.J. The defendant waived his extradition and was brought back to Nassau County by the Nassau Police Fugitive Unit on January 4th. The 39 year old defendant will be arraigned on today’s date in County Court in Nassau for burglary 2nd degree and Grand larceny 3rd degree.

“The Glen Cove Detective Division spend a great amount of time investigating this deception style burglary. It caused a great amount of fear among the retired families living in Glen Cove and the surrounding areas,” Said Nagle.
