


Francesca and Antonia played violin for their grandmother two to three times a week while she was in the hospital in ICU, and then at the local rehab center. Mrs Cipriano responded miraculously to their very special treatments. Even when she was in a coma, she would tap her foot in rhythm to the music; while in recovery she would bounce her head and wave her hand. She survived another three years after the stroke, and it was felt that the sound of her grandchildren's music was a major factor in prolonging her life.

That was the impetus for The Gambino sisters to launch their "Giving Back Through Music" program, or "Strings For Healing". In addition to Glen Cove Hospital, Francesca and Antonia presently play at all of the nursing homes and rehab centers in the Glen Cove area, and also at the Regency Assisted Living Center. "We enjoy giving back, and watching the smiles on the residents, " says Francesca, now 16. "And it's a thrill when they sing along with our music." And while some in the audience may be physically unable to respond, 15-yearold Antonia is confident that the music is still working its magic. "As long as they can hear our music, I'm sure it helps them feel better".

Phyllis Coniglione can testify to that; she recalls how Strings For Healing raised her husband's spirits when he was at Glen Cove Hospital. "He was extremely ill at the time, and it was so wonderful to have these two lovely, talented young ladies bringing music into the room, and providing him with a joyous experience. It brought tears to my eye, and I thank them so much."

Expert opinions may vary about the medical benefits of music therapy, but the inspirational value of the "Strings for Healing" program cannot be denied, and Francesca and Antonia Gambino are committed to practicing their melodic medicine wherever they can. "Music makes us all feel good!"

Diagnosed in early 2015 with Stage 4 lung cancer, Howard Davis Jr. passed away on December 30, 2015 in Florida. Ever the athlete, the clean living Davis never smoked and fought hard till the end with his wife Karla and fiveyear-old daughter by his side. "Howard stands tall in the history of our City," said Mayor Reggie Spinello. "He will always be remembered as a champion, a gentleman, and the greatest amateur boxer." To celebrate the life of Howard Davis Jr., the tribute will feature guest speakers including family members, friends, representatives of the boxing community and local dignitaries. Light refreshments will be served. Following the tribute, a reception sponsored by the Glen Cove Housing Authority will be held from 1 p.m. to 3 p.m. at The View Grill, 111 Lattingtown Road, Glen Cove.



### Mill Neck Students Utilize Many Skills to Support Local Charity

Mill Neck Manor School for the Deaf students in Donna Argeroplos' Home and Careers Skills class wrapped up their month-long, campus-wide project for Long Island Cares on December 16. That day, they delivered the items they collected to the food pantry operated out of St. Gertrude's Church in neighboring Bayville, a collection site for Long Island Cares.

After choosing the project, the students presented it for approval to the school's principal and then immersed themselves in every aspect necessary to get it rolling. The sixth through eighth graders were responsible for everything from startto-finish; for tasks including research, strategy, marketing, distributing the collection boxes throughout the campus and packing up. Rather than have the items picked up by Long Island Cares, the students themselves delivered the items to the food pantry and also helped stock the shelves. Said Argeroplos, "We feel it's important to take the kids to the drop off location, rather than having the food picked up, to allow them to see where the food goes."

Argeroplos, who is also the school's librarian, described the significance of the Home and Careers class, saying it is organized around four process skills: communication, leadership, management and thinking. These skills are taught through ten content topics: community connections, career development, clothing management, consumer resource management, family/ parenting, financial management. human development, interpersonal relationships, nutrition and wellness and personal environment management. The skills and content topics align with the National Learning Standards for Family and Consumer Sciences. Carrying out a

community project is a natural extension of the course, as it is taught using a hands-on, experiential approach. "The use

of real-life relevant tasks, laboratories, simulations, and community involvement are integral parts of the course. So is the use of research, class discussions and group activities," said Argeroplos.

Collectively, the middle schoolers expressed great enthusiasm for the project and felt they learned many valuable lessons, from awareness of the particular charity they supported to working as a team. They all agreed, too, that it is important to spread awareness about hunger throughout the year, not just during the holidays. "I don't think it matters the time of year, people always need food," said 7th grader Amanda Parrott.




Corey Dinkins led the way with 33 points and six assists, while Khalil Zachary added 31 points and 14 rebounds to lead the team.

# Name the Celebrity



This week's celebrity was born on May 6, 1904 in San Francisco. Having survived the 1906 San Francisco Earthquake, he went on to be a Broadway, movie and television actor. When he was a teenager, he went to Hollywood to seek movie stardom. He found it was harder than he thought, however, and took a variety of short-term jobs. He worked for a time as a day laborer at a movie studio in the days of silent pictures, but was fired for sneaking into a mob scene, while it was being filmed. He also worked for a while as a stockbroker and a banker. Having no success getting any kind of movie roles, he went to NYC where he had no better success getting into the theatre. Eventually, he began working as a merchant seaman and sailed to various ports of the world, including China, Japan, the Philippines, and the Mediterranean. While docked in Hawaii, he worked on a pineapple plantation, the community theatre and sang on a local radio program.

In 1938, he decided to try Hollywood again. His luck changed for the better when he actually began getting some bits in movies. However, after the U.S. entered WWII, he again served in the U.S. Merchant Marine. When the war was over, he returned to Hollywood and eventually began getting character roles. His film roles include playing a member of the board on the comedy/romance "Sabrina" (1954) starring Humphrey Bogart, Audrey Hepburn and William Holden; Mr. Benson in the drama "Picnic" (1955) starring William Holden and Kim Novak; a doctor n Hitchcock's drama "Vertigo" (1958) starring Jim Stewart and Kim Novak; and the colonel in the comedy "No Time For Sergeants" (1958) starring Andy Griffith.

### Last Week's Celebrity

Last week's celebrity was Rochelle Hudson. She was the daughter of Ollie Lee Hudson, who worked for the State Employment Bureau in Oklahoma and was the direct descendent of famed explorer Henry Hudson, who in his ship, "The Half Moon", discovered the Hudson River and Hudson Bay. During her peak years in the 1930s, notable roles for Hudson included: Richard Cromwell's love interest in the Will Rogers showcase "Life Begins at Forty" (1935), the daughter of carnival barker, W.C. Fields, in "Poppy" (1936) and Claudette Colbert's adult daughter in "Imitation of Life" (1934) with Louise Beavers.


She married four times and was fluent in French and Spanish, which would eventually come in handy. There is little known about her first husband, Charles Brust. However, in 1939, she remarried and her second husband, Harold Thompson, was head of the Storyline Dept. at Disney Studios. She assisted Thompson, who was doing espionage work in Mexico as a civilian during WWII. They posed as a vacationing couple to various parts of Mexico, to detect if there was the German activity in these areas. One of their more successful vacations uncovered a supply of high test aviation gas hidden by German agents in Baja California.

In the 1954-55 TV season, she co-starred with Gil Stratton in the CBS sit-com "That's My Boy", based on a 1951 Jerry Lewis and Dean Martin film of the same name. She abandoned Hollywood for a time after playing Natalie Wood's mother in "Rebel Without a Cause" (1955) to run a 10,000 acre ranch in Arizona. She later moved to Tulsa, Oklahoma and work for a petroleum refinery. Missing California, she returned in 1963 and, briefly restarted her career, but left Hollywood for good in 1967. She moved to Palm Desert, where she found success in real estate.

On Jan. 17, 1972, at the age of 55, she was found dead in her home at the Palm Desert Country Club. A business associate, with whom she had been working in real estate, discovered her body sprawled on the bathroom floor. She died of a heart attack brought on by a liver ailment. Her only close survivor was her mother.



#### **Disrespect** Displayed

#### To The Editor,

I attended the Glen Cove City Council meeting on Tuesday night, Dec. 8. As a resident of Glen Cove, I was stupefied at the level of disrespect displayed by the Mayor and the City Attorney in response to questions about the Waterfront development and other projects from concerned citizens.

I am apprehensive because I keep hearing that the City has approved the development of a very big, very tall, and very out of character for the area, mixed use complex on top of what is still a toxic Superfund site.

Is it true that the City is also on the hook to build the road going in and out of this toxic area at an estimated cost of \$25,000,000?

How can the City sell land that has not passed inspection by the EPA?

How can the City propose that the money from the sale of this land be used to balance the City budget when the land cannot be sold until it has passed inspection?

Why is the City so hell bent on pushing this down our throats without providing transparency to the residents of Glen Cove and our surrounding neighbors?

I was afraid to stand and ask the

questions at the City Council meeting based on the way my neighbors comments were being shrugged off.

I am not opposed to development. I would love a destination full of vibrant stores and restaurants in Glen Cove. However, I do not want to risk our health and wellbeing unless answers about the toxicity, as well as other quality of life and economic issues are answered effectively, based on current information and unbiased testing.

I have not lived in Glen Cove for very long, only 3 years. I was unaware that this has been an outstanding conversation across several elected officials and many, many years. I am late to the game. But I would like to know the answers to the questions. I want to make sure that the development will not be further polluting the air and water, or condemning the City to more unsupportable debt. And worse, should people start getting sick during the proposed 10+ years of development, who is going to provide healthcare for those individuals?

I have watched with horror this week as our elected federal officials declined the renewal of the healthcare fund established for the first responders of 9/11. I don't want to see this happen in Glen Cove.

This weekend celebrates the birthday of Martin Luther King and I feel inspired to learn more about world events. The problem is that I have a short attention span and the world is so, so complicated. Can you think of a book that will help me understand it all...? Weary of Wondering

#### Dear Weary,

I just finished a very enlightening book with a bold title: PRISONERS OF GEOGRAPHY- Ten Maps That Explain Everything About the World- by Tim Marshall. Marshall carefully lays out his thesis that all past history and present politics can be explained by studying the geography of the world powers. Each chapter is preceded by a detailed map that shows how each of ten regions- Russia, China, the United States, Latin America, the Middle East, Africa, Western Europe, India and Pakistan, Japan and Korea, and the Arctic- is subject to the

vagaries of geography. For example, he strongly links Putin's annexation of Crimea to his lack of a warm water port, while the United States' coastal borders make it an impenetrable paradise . Mountain ranges and waterways are far more important in Marshall's view than leaders and ideologies when it comes to having a lasting effect on history. This is a short (265 pages), highly readable, very informative take on the world.... highly recommended!
