Glen Cove Senior Center and North Coast Subaru Support Free Medical Transport for Residents Volunteer Drivers Wanted

For almost ten years, the Glen Cove Senior Center and North Coast Subaru have partnered on a unique transportation initiative for Glen Cove residents. The Glen Cove Medical Transport program provides free transportation to all Glen Cove residents for doctor appointments, physical therapy sessions and any other non-emergency doctor, hospital, lab or medical center visits.

“Due to the popularity of this program, we are looking for more volunteer drivers – individuals with a valid driver’s license and a big heart,” said Carol Waldman, Executive Director of the Glen Cove Senior Center. “The program runs from 10:00 a.m. to 2:00 p.m. three days a week; with more volunteer drivers, we would like to expand the program from 9:00 a.m. to 5:00 p.m. Monday through Friday.”

While Glen Cove’s Medical Transport program began years earlier, in 2007 North Coast Subaru donated a vehicle to provide additional help to meet the community’s non-emergency transportation needs. As the program grew in popularity, a larger vehicle was required to help residents with wheelchairs and through program

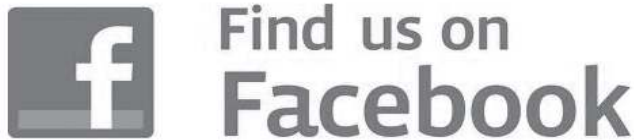

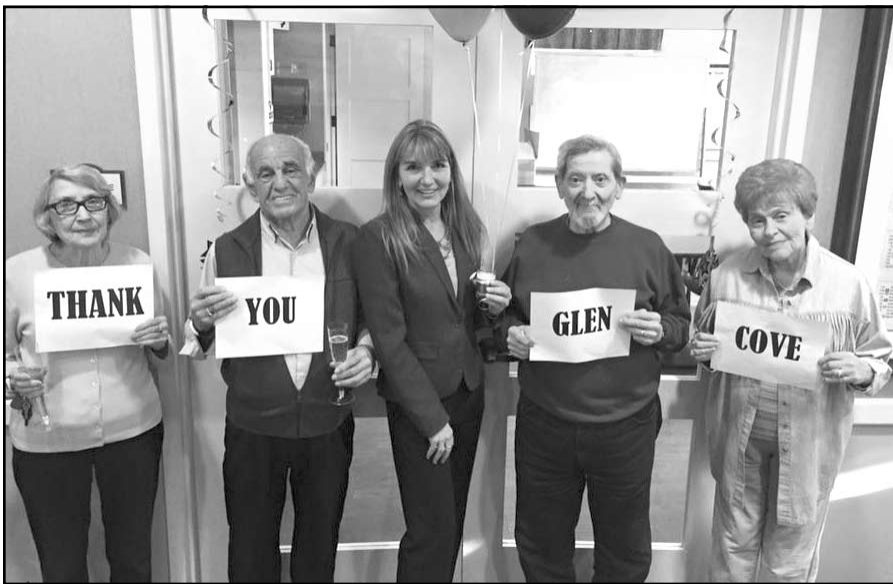

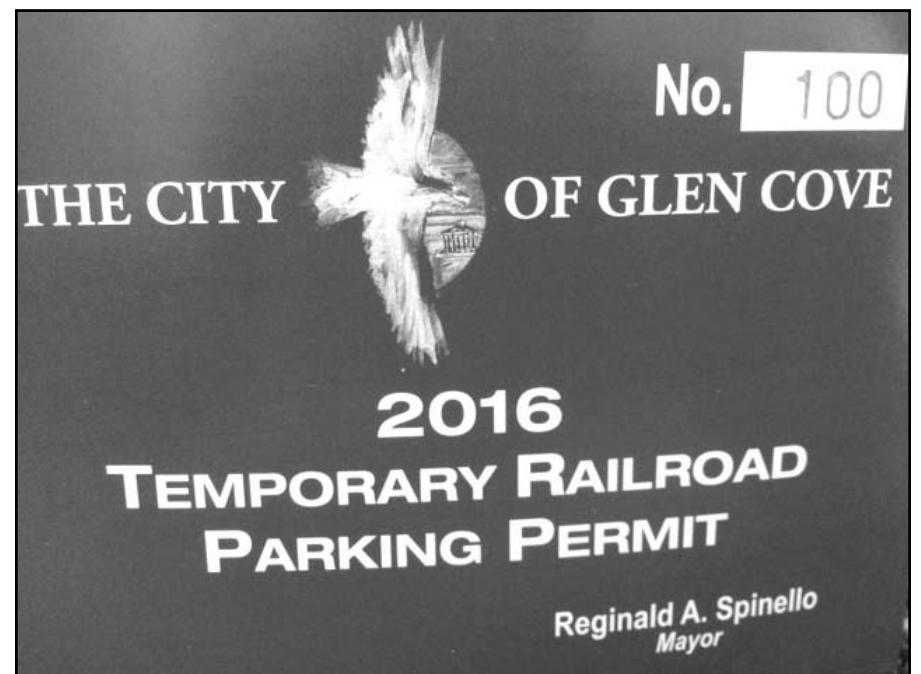
Glen Cove to Issue "Temporary Railroad Parking" Permit for Residents With Special Circumstances

Mayor Reggie Spinello's "Residents First" parking program that offers Glen Cove residents-only parking on the north side of the Glen Cove and Glen Street LIRR train stations, has received strong community support. If a resident's license and car registration have a Glen Cove address, no parking permit is necessary at this time. "However, in listening to the needs of a select group of Glen Cove residents, we have learned there are individuals who have a series of special circumstances that prevent them from meeting the criteria for parking in the North lots of our train stations," said Mayor Spinello. Those special circumstances for local residents include individuals who have recently moved to Glen Cove and their vehicle* is still registered in another state or a resident is driving a company car that is registered in another location.

For these unique situations, the City of Glen Cove will offer a special free

"Temporary Railroad Parking" Permit. To receive a temporary Glen Cove Railroad Parking permit, residents can bring their driver's license, a photo ID and two documents that show Glen Cove proof of residency (e.g., mortgage statement, deed, lease, phone, tax and utility bills) to the City of Glen Cove's City Clerk's office at 9 Glen Street (third floor) between the hours of 9:00 a.m. and 5:00 p.m. Monday through Friday. Or, for train commuters who are unable to come to the City Clerk's office during the week, there will be a special Saturday sign-ups on January 30 and February 6 from 10:00 a.m. to 1:00 p.m. in the Main Chambers of City Hall. For more information call the City Clerk's office at (516) 676-3345.

* According to Glen Cove Police Chief William Whitton and New York State law, residents who have moved to Glen Cove from another state have 30 days to re-register their vehicle in New York.

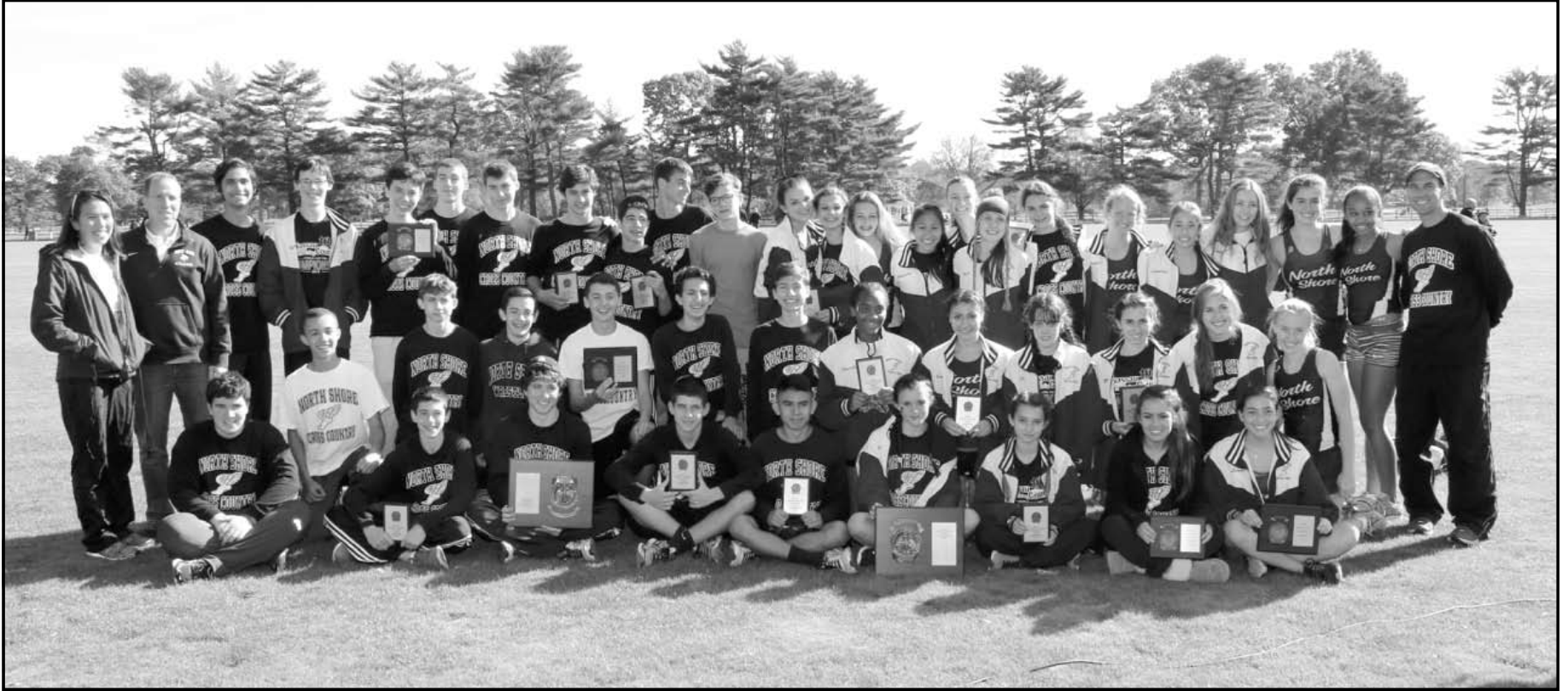

Congratulations to Diana Vizza, NEWS12 Scholar Athlete Award Winner



The North Shore School District is proud to announce that Diana Vizza, a high school senior, has been named a NEWS12 Scholar Athlete. For the past four years, Diana has been a part of the Women's Cross Country Team. Her speed, endurance, and mental toughness have earned her multiple "All County" honors. Recently, Diana won the New York State Class B Women's Cross Country Championship, was named the Long Island Cross Country runner of the year by Newsday, and on January 21st won the qualifying trial for the Millrose Games (for the high school women's mile). As a result, Diana will be competing in what is regarded as a signature event at one of the most prestigious indoor track and field competitions in the nation. She crossed the finish line in 4 minutes 54.34 seconds - a winning margin of 0.02 seconds. This was her fastest indoor mile ever by four seconds. Additionally, it was the best time by any high school female runner in New York State this year, and the second fastest nationally.

Neal Levy, Diana's track coach said, "Diana has been a role model for her work ethic and striving to reach one's potential. She has been wonderful in carrying on the tradition of excellence for the North Shore High School track program."

Additionally in school, Diana is a member of the National Honor Society,

the National Tri-M Music Honor Society, the National Foreign Language Honor Society, and the National Science Honor Society. Earlier this school year, she was named a National Merit Semifinalist. This incredible scholar-athlete also finds time to sing in the Concert Chorale and play the cello in the North Shore Chamber Orchestra. Next fall, Diana will be attending Dartmouth College where she will be studying Biomedical Science.

Diana stated, "While often it is difficult to balance academics, sports, and life... I run for my teammates." She added, "Even when you think you can't, try and keep going ... always run with confidence."

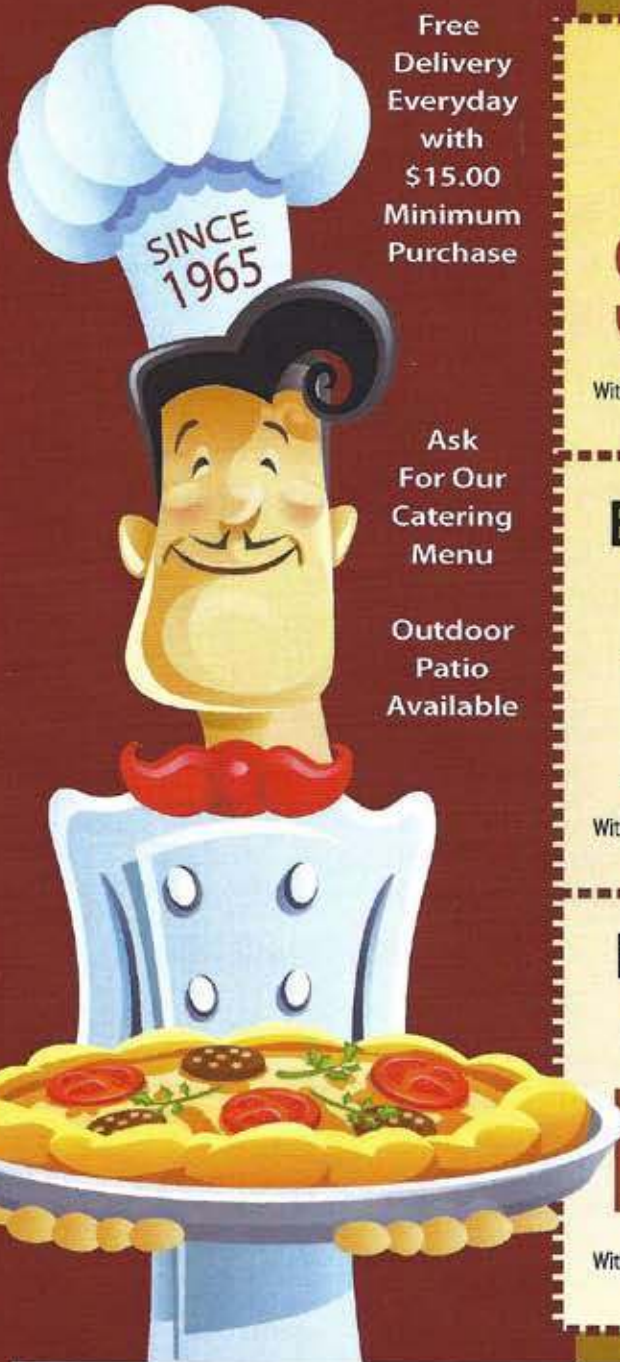

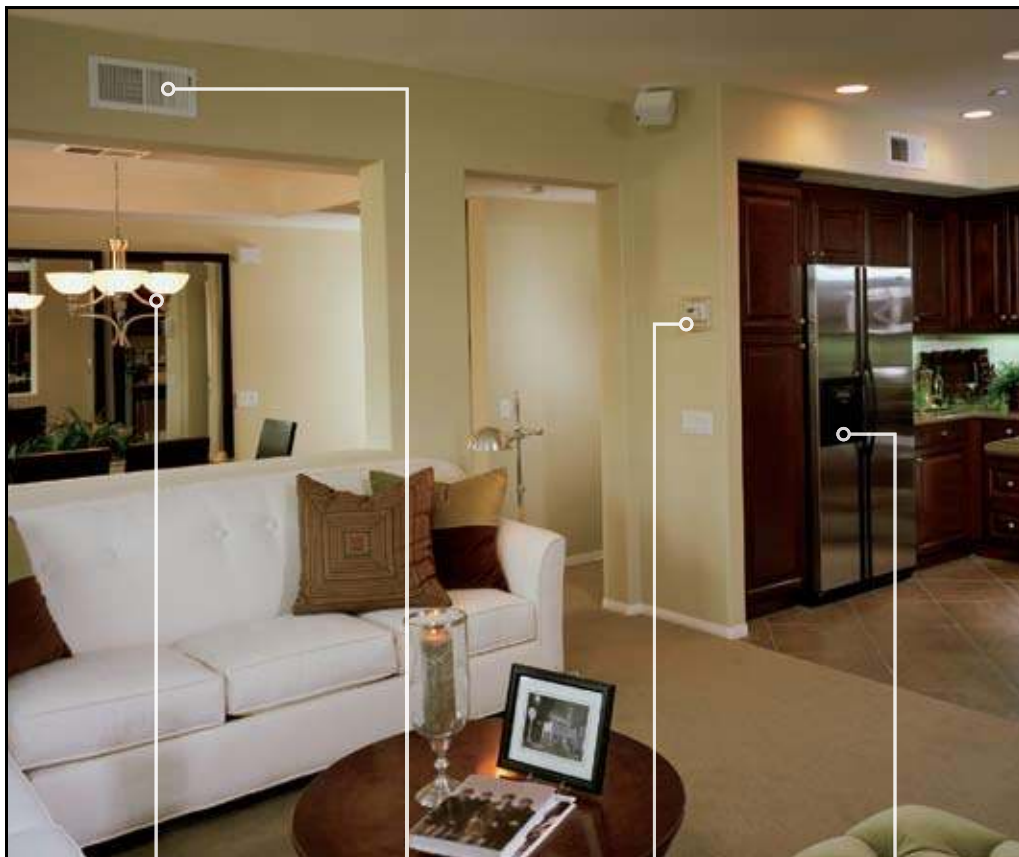
We Stand Together."

Rally Shows How Unpopular Waterfront Project Really Is

To The Editor,

If anything, an indoor rally of some 200 residents of Glen Cove and Sea Cliff Jan. 31 more than served its purpose. Make no mistake, the Sunday afternoon packed house showed just how unpopular the Waterfront Project being proposed by Mayor Reginald Spinello and his city council really is. The event was hosted by the Committee for a Sustainable Waterfront and supported by the Village of Sea Cliff and Coalition to Save Hempstead Harbor. If only members of the city administration could have witnessed the spirit and force of this fund-raising event held at the Metropolitan Bistro restaurant in Sea Cliff.

Cheers and jeers filled the room as organizers Roger Friedman, attorney Amy Marion and village mayor Bruce Kennedy in turn denounced the proposal as detrimental not only to the future of Glen Cove but to the permanent loss of a bucolic peninsula that used to be an integral part of "The Gold Coast" of Long Island.

Mayor Spinello obviously is convinced that his re-election in November was a public mandate to do whatever he wants with Glen Cove in the next two years. He wants to transform the city from a bedroom community into "a go-to destination" with resort-like amenities. Who knows, but his self-image might be that of a casino owner. But we must not panic because there was a level-headed presence among those leaders attending the rally.

They handed pamphlets to everyone who came through the door that contained the names and e-mail addresses of our political representatives, including U.S. Senator Charles Schumer, State Senator Carl Marcellino, State Assemblyman Chuck Lavine of Glen Cove, Nassau County Legislator Delia DeRiggi-Whitton of Glen Cove and County Executive Edward Mangano. Getting them involved would certainly open some eyes in city hall.

The symbiotic relationship between Glen Cove and Sea Cliff was supposedly sealed with a 2000 agreement signed by Glen Cove Mayor Thomas Suozzi and Sea Cliff Mayor Claudia Moyné, who was in attendance and acknowledged for her part in sustaining cooperation between our two communities. So the movement against the Waterfront Project has escalated nicely. We must thank our two weekly newspapers, the Record-Pilot and Gazette, for their important coverage.

Glen Cove Battle On Two Fronts Now

General George Patton, one of our WWII

heroes, had good advice for those citizens unsure about standing up for their rights: "Lead, Follow or Get Out of the Way".

That applies to us, dear readers, especially now that we are being forced to fight Glen Cove city hall on two fronts instead of one. We are talking, of course, about the Waterfront Project at Garvies Point and the Villa Condominium Complex on Glen Cove Avenue.

We must congratulate and thank both of our community newspapers, the Glen Cove Record-Pilot and the Gold Coast Gazette, for giving us weekly updates on the not-so-little war we have going here. Former City Councilman Steve Gonzalez gives us first-hand insight on the Waterfront in a letter titled "No Gains For Residents". He cites RXR Realty, its contractors and those highly-paid "consultants" from Westchester County. He says Mayor Reginald Spinello "has turned a blind eye" toward the project's imminent adverse impact on the city because he views his re-election as a mandate from the public to proceed however he wants. They call this carte blanche, also available at Uncle Dai's or American Cafe.

RXR chairman and CEO Scott Rechler hosted a New Year party for 120 believers at the Glen Cove Mansion. He told them in melodramatic terms that he considers Glen Cove his hometown because his mother grew up on Woolsey Avenue, he spent

childhood summers at his grandparents' house on Crescent Beach Road, collected shells at Prybil Beach and got ice cream at Henry's. Now he wants to surreptitiously make millions of dollars by changing Glen Cove forever and taking away such memories from future generations.

The developer across town, Daniel Livingston, wants to create housing for young couples and empty nesters that will displace 48 families from the site they call home. He also has similar plans in Hempstead and Huntington where housing for the poor would also be more appropriate. Yet this representative group of developers met under the auspices of an LI Regional Planning Board that amounted to nothing but a back-slapping session on who was doing what and where. No agenda because nobody else was invited to the chummy affair.

According to Mayor Spinello, the sale of the Waterfront Property will take place in the "second quarter" which means between April and June. The timetable on the Villa is unclear. The two lawsuits concerning the Waterfront are scheduled to be heard Feb. 8. Verify time, date and place by calling Glen Cove City Hall (676-2000) or Sea Cliff Village Hall (671-0080). There is nothing so convincing as a courtroom full of spectators to make judge and/or jury see how important this hearing is.

While I have loved all the books in the series: BLACK FRIDAYS, MORTAL BONDS, and LONG WAY DOWN, this latest is the best yet. Jason Stafford is a talented former Wall Street trader who was sent to prison for insider trading. After being released, he began a new, very lucrative career as a financial investigator. The novels all involve fiscal malfeasance of some sort with this latest focusing on a hostile takeover, but they are more than just financial thrillers. Sears has created a colorfully diverse

community of villains, friends, and relatives- with special focus on Stafford's young autistic son Jason(aka the Kid). Much of the storyline deals with the joys and challenges of parenting, and when Stafford and the Kid are placed in a witness protection program, these challenges multiply. Sears's writing is always dynamic and the plot, while intricate, is always believable. Highly recommended!

Name the Celebrity



This week's celebrity was born on Dec. 12, 1917 in Los Angeles. He was an American motion picture and TV actor. In his early years, he appeared mostly in westerns. He began his screen career in 1937 with a bit part in "Daughter of Shanghai" with Charles Bickford, Buster Crabbe and J. Carroll Naish. He continued in a variety of B pictures such as "Prison Farm" and "King of Alcatraz" (1938) with Gail Patrick, Lloyd Nolan and Harry Carey Sr., before appearing in two of Cecil B. DeMille's films "The Buccaneer" (1938) with Fredric March and Akim Tamiroff and "North West Mounted Police" (1940) with Gary Cooper and Madeleine Carroll. The latter film was DeMille's first film in Technicolor and received an

Academy Award for Best Film Editing. Our celebrity's acting career was interrupted when he was drafted into the U.S. Army in 1941. He rose to the rank of first sergeant in the Coast Artillery, eventually serving in the Philippines. Following military service, he worked frequently for film producer and director, Sam Katzman, known for his 15-part "Superman" serials and 1940s "Eastside Kids" films, and was given the lead in "Jack Armstrong" film serials. In 1957, he portrayed "Nat 'Hawkeye' Cutler" in the syndicated western series, "Hawkeye and the Last of the Mohicans", set in New York State in the 1750s. It was based loosely on the novels of James Fenimore Cooper.

Geoffrey Lewis, a talented and highly capable character with rustic and sometimes sour-faced looks, was last week's celebrity. He had a long association in films with Clint Eastwood and one of his scariest roles was as the local gravedigger, "Mike Ryeson" in Stephen King's 1979 film "Salem's Lot" with David Soul and James Mason. He was very creepy sitting rocking back and forth in that old rocker in the dark room! He was equally busy on the small

screen. He had guest-starred on dozens of episodes of high profile TV series such as "Law & Order: Criminal Intent", "In the Heat of the Night" and "My Name 'Earl'". He received a Golden Globe nomination for his performance in the "Alice" spin-off sitcom, "Flo" with Polly Holliday. Lewis was also a member of the rather unique musical/storytelling "Celestial Navigations", along with award-winning composer songwriter Geoff Levin. Their performance have received terrific reviews from some of Hollywood's top actors and noted musicians, including Chick Corea, who had a professional career of his own with Cab Calloway, trumpeter Blue Mitchell, flutist Herbie Mann and saxophonist Stan Getz. He died of natural causes on April 7, 2015 at the age of 79.
