## Tom Suozzi Holds Congressional Town Hall in Glen Cove Over 150 residents discuss range of issues

Former Glen Cove Mayor and Nassau County Executive Tom Suozzi, addressed a full house at a town hall meeting held on February 10 to discuss issues of importance to residents as he considers his bid to run in the 3rd congressional district. Last month, Suozzi announced that he filed paperwork with the Federal Election Commission (FEC) and would explore running for the seat being vacated by Rep. Steve Israel, who announced his retirement from Congress in January.

"I'm overwhelmed by the turnout

we received tonight," said Suozzi. "Everyone was very engaged and it was a great discussion on important issues. We have a lot of work to do, but tonight was a great start."

Suozzi kicked off the meeting by stating he wouldn't be considering this run if not for the surprise retirement of Israel and acknowledged the excellent work he has done in Congress; while he was a leader on national issues, he

always looked out for the best interests of his constituents.

Being in the private sector for the past six years has given Suozzi a new perspective and he said he shares the frustrations of many others by the lack of progress and cooperation in Washington and the general mistrust in government and politicians.

“Let’s face it, Washington is broken and needs to be shaken up,” said Suozzi.

Prior to the meeting Suozzi had asked residents to complete a survey that was mailed and also posted on his website, [suozzi2016.com](http://suozzi2016.com), and those questions

formed the basis of the evenings discussion. Among the issues raised were income inequality, the high cost of college education, and the struggles of middle class families and seniors.

Suozzi said that he is still not decided if he will run, but will continue to talk to residents of the district and consult again with his family and make a firm decision soon. Additional town halls will be held over the next few months throughout the district. These limited spaces are available for a \$90 annual fee and permits year round storage. Space is limited, and permits are issued on a first come first serve basis.

If approved, a permit sticker will be issued and your kayak can be conveniently stored on the City owned rack for one year. Owners are required to provide their own cable and lock to secure the kayak to the storage rack. ## More Waterfront Concerns

### To the Editor,

Late last month I attended the gathering in Sea Cliff sponsored by the Committee for a Sustainable Waterfront. It was quite an eye-opener not only because of the overflow crowd of supporters attending but even more so because of the more detailed renderings of just what is planned for the Garvies Point redevelopment. These depicted all the structures that are to be built including a significant number of smaller residential apartment buildings that appear to have been flying under the radar. Putting them together with the two eleven story monstrosities and their eleven hundred plus apartments, easily 5,000 or more people could someday be calling Glen Cove their home and very abruptly at that. That would be a good thing if you asked Reggie Spinello. It would not be a good thing if you asked anyone in Western Europe who is dealing with providing for the humanitarian needs of millions of desperate immigrants.

Immigration is a very contentious issue in the world today and in our country too. Now the people coming to the Glen Cove waterfront could never be considered as such but look at what they will encounter. They will be sequestered in a very small, isolated, fifty-five acre enclave surrounded on three sides by water in Glen Cove's hinterland, relegated to close quarter housing on a Superfund site as well with little chance of relatively rapid assimilation into the usual ebb and flow of the community. That certainly is what currently describes the plight of the many refugees and asylum seekers that are pouring into Europe from the battlefields of the Middle East and the deteriorating conditions and sense of hopelessness in many other countries. Certainly there are differences that are all too obvious and defy comparison. Unlike the European countries that have to provide for their sustenance and survival, we only have to cope with the loss of treasured landscapes and shorelines from insensitive and overzealous building for profit, increased traffic congestion, etc. You know the rest

There is something else that concerns me and I doubt anyone else. I grew up helping my Dad who was a plumber. I unloaded sewer pipe from barges on the creek imported from Italy in the fifties during the heyday of road and sewer construction on Long Island. I know sewers. They are indispensable and deserve our deepest appreciation but they do have limitations and at Garvies Point I am concerned about the number of toilets that will be crammed into that very confined fifty-five acre space, easily 1100 plus and possibly double that number. My fear is for a perfect storm, an astronomical number of residents flushing their toilets by chance at precisely the same instant unleashing a tsunami the likes of which all of us would

be loathe to contemplate. That might not be the end of it, though. The city could get wind of this and decide, likely or not, this can't be allowed to happen. One possible solution and I don't like mentioning it but knowing how the city decides things, might be alternating flush days. One half the residents flush one day, one half the next. Next, how do you prevent violations? I'm sure someone could come up with a modification for red-light cameras making them suitable for bathroom use. That would leave us with the unpleasant prospect of watching the build-up in our toilets on non-flush days while awaiting the arrival of the next authorized flush day, all this the result of the unrestrained overbuilding at Garvies Point. I don't think anyone could be faulted if their thoughts turned to the people responsible for this as they kept looking at this stuff.

## Where's Waldo?

### To The Editor,

"Where's Waldo" is a notable series of illustrated children's books by Martin Handford. Handford would conceal "Waldo," a character who wore a red and white striped shirt, in various amusing scenes. As finding Waldo has been a head-scratcher, so has been locating Glen Cove City Councilman Efraim Spagnoletti at times. Per a FOIL request, Spagnoletti missed three pre-council and two council meetings in 2015. In 2016, he skipped one council meeting thus far. What caused Spagnoletti's absence?

Days after former Councilman Tony Gallo announced his intent to run for mayor, Spagnoletti hid from the Mar. 10 council meeting. He was missing in action at the Apr. 21 pre-council. It was the same day that Mike Bruschini and I raised questions about "strange similarities" in the councilman's writings and an anonymous profile on the Internet. Spagnoletti seemed to place pizza over politics on Aug. 18. He was supposedly seen at a local pizzeria instead of the pre-council. As his council colleagues discussed the 2016 budget at the Oct. 6 pre-council, Spagnoletti was away. Perhaps his most mysterious

absence occurred on Nov. 24. Social media commentators speculated that he took a "selfie" at a Donald Trump rally held that day in Myrtle Beach, South Carolina. If true, why would he miss a council meeting for a political event in another state? Maybe a photoop trumped doing his duty.

In an ideal world, Spagnoletti would owe the taxpayer a portion of his councilman's salary for the curious absences; however, there is no legal requirement to attend a specified number of council or precouncil meetings under the Glen Cove City Charter. The charter states, "The City Council shall meet in Council chambers on the second and fourth Tuesday of each month except June, July, August and September when they shall meet on the fourth Tuesday" (Art. VII, § C79).

The council should adopt an attendance ordinance for its members lest it face a runaway representative as happened in the City of Bangor, Maine. In 2015, a Bangor City councilwoman moved to Florida but still owned a home in Bangor. She never officially resigned her seat and just stopped showing up to meetings. As a result, the council scrambled to establish attendance rules. Until there are rules on appearing at meetings, some will continue to ask, "Where's Spagnoletti?"

## Name the Celebrity



This week's celebrity was born Jonah Marcus Weidenfeld, in Buffalo, N.Y., on Jan. 3, 1917, and reared in Akron, Ohio. He made his first amateur appearance in local stage productions at the age of fifteen. Though aspiring to be an actor, he worked at many different jobs during the 1930s, including selling beauty products and lingerie. After moving to Cleveland, Ohio, he began a career in vaudeville and burlesque, traveling widely before landing a role on Broadway. In 1942, he made his Broadway debut "The Moon is Down", based on the John Steinbeck book of the same name, followed by a

successful performance in the role of a sanitarium orderly in the popular play about a larger than man, invisible leoprid, "Harvey." He would later reprise his role in the 1950 film version with Jimmy Stewart and the 1972 TV movie. In 1947, our celebrity made his film debut in a small part in the film noir "Kiss of Death" with Victor Mature and Brian Donlevy. The actor, Richard Widmark, also had his film debut in this movie as the sadistic killer who is remembered for strapping an elderly woman, "Mrs. Rizzo", into a wheel chair with an electrical cord and throwing her down a flight of steps. During the 1950s, our celebrity began landing roles on TV shows, including appearances in Danny Thomas' "Make Room for Daddy" and Peter Lawford's "Dear Phoebe". In 1954, he landed a semi-regular role as "Cagey Calhoun" on "Private Secretary" starring Ann Sothern and Don Porter. He also appeared in "Designing Woman" (1957) with Gregory Peck and Lauren Bacall and "Marjorie Morningstar" with Gene Kelly and Natalie Wood.


