Glen Cove CDA Installs New Handicap Accessible Doors in City Hall

February 24, 2016, Glen Cove, NY... Thanks to the efforts of the Glen Cove Community Development Agency (CDA), a set of new handicap accessible doors was installed in the rear entrance of City Hall. \$7,682 in United States Department of Housing and Urban Development Community Development Block Grant (CDBG) funds that are administered by the CDA provided the financing for the handicap door mechanisms and installation.

"The CDA has fulfilled a vital need for the Glen Cove community by allocating grant money that allows the City to expand its handicap accessibility at our municipal facilities," said Mayor Reggie Spinello. "Our effort began last year with the installation of new handicap accessible doors at the Glen Cove Senior Center and now we are pleased that the CDA was able to allocate CDBG monies to improve resident access to City Hall," said Myralee Machol, CDA Executive Director.

This latest work is a series of short chapters in which the narrator Lucy Barton recounts moments in her life from early childhood to late middle age with the longest section of the book focusing on a few weeks when, as a young mother and wife, she was

Over the weeks, she tells Lucy about friends and neighbors from their small rural town. Strangely, all these stories are about unhappy women and disastrous marriages. Name the Celebrity



This week's celebrity was born April 15, 1888 in San Antonio, Texas. She was a film and stage character actress who often played grande dame characters in supporting roles. She showed musical talent as a child, but a hand injury inhibited her from continuing her piano studies. In 1906, she graduated from the University of Texas at Austin with a degree in Mathematics, after which she taught school. In 1909, she met and married her first husband and gave up her career to raise her daughter. When that marriage ended in divorce, she began to study law and passed the bar examination in 1914, becoming at the age of 26, the first female lawyer in her home state. She practiced law for four years in San Antonio.

Now, for the sake of needed clues, this writer will continue her pre-film accomplishments for next week, as she was a very adventurous individual for the times.

In the mid-1930s, she auditioned for and won the roles of "Miss Bates" in a Pasadena Playhouse adaptation of Jane Austen's "Emma". When she decided to continue working with the theatre group, she changed her professional name. In 1939, she was introduced to Alfred Hitchcock, who cast her in her first major screen role, the vain dowager, "Mrs. Van Hopper", in "Rebecca" (1940) with Joan Fontaine and Laurence Olivier. She also played "Mrs. Manleigh", the overbearing boss-lady of Ann Sothorn's character in "Letter to Three Wives" (1949) also starring, Kirk Douglas, Paul Ford and Linda Darnell. This film won the Academy Awards for Best Director, Best Writing, and Screenplay, as well as, nominated for Best Picture.

Last week's celebrity was Marge Redmond. She may be best known as "Sister Jacqueline" in "The Flying Nun" with Sally Field, which aired on ABC from 1967-70. She was nominated for an Emmy for Outstanding Supporting Actress in a Comedy Series for her role as "Sr. Jacqueline" during the 1967-68 season. However, she lost to Marion Lorne, who won posthumously for her role as "Aunt Clara" on "Bewitched". Our celebrity made guest appearances on TV programs ranging from "Ben Casey" (1962) with Vince Edwards through "Law & Order" (1997). Other shows

that graced her appearance were "Perry Mason", "Matlock", "The Munsters", "Barnaby Jones", "Quincy M.E.", "The Rockford Files" and "Murphy Brown", to name a few.

Her first and only husband was actor Jack Weston. After they married in 1950, she developed her acting career with him at the Cleveland Play House. Their Hollywood years began in 1958, when they abruptly quit their parts in the hit Broadway musical, "Bells Are Ringing" and left for L.A., in a vintage Volkswagen, fully expecting to have to return to NYC. They stayed in L.A. together for 18 years after they attained success in TV. The reader may remember Jack as "Max Kellerman", the owner of the upstate NY summer camp in "Dirty Dancing" (1987). The couple eventually divorced and never had children. Marge never remarried and enjoys semi-retirement appearing occasionally on off-Broadway.
