# Glen Head School (GHS) First Annual Invention Convention

On February 25th, Glen Head School held its first annual GHS Invention Convention. Over 100 students in grades K-5 presented approximately 55 original inventions and games. Children, families and friends were invited to participate and play, then the students selected which ones would be considered for indoor play alternatives!

To help solve a problem that “indoor play was not fun”, Glen Head School (GHS) Principal Lori Nimmo challenged her entire student-body to develop new, different, or better ideas that could be considered for use during indoor playtime. As part of the educational S.T.E.A.M. (Science, Technology, Engineering, Art, Math) challenge, she asked her students whether they would commit to solving the “indoor play problem” as an inventor or innovator to help make a difference in the lives of others. Not surprisingly, her students were up to the challenge and showcased their inventions during the first GHS Invention Convention.

To help prepare her K-5 students for the S.T.E.A.M. challenge, Principal Nimmo explained that an inventor was someone who creates something new, while an innovator is someone who finds a better way of doing something. She asked them to make the following GHS Invention Convention commitment:

- Identify one specific problem with indoor play
- Work by yourself or with others to bring your idea to life
- Brainstorm a variety of ideas to possibly solve this problem
- Select one idea to plan, create, test out, and revise
- Build a prototype or model
- Test your prototype for the first time and make observations
- Make revisions to improve upon your idea (then conduct other tests)
- Create a finished product and make presentation
- Allow GHS to implement your ideas

To get started, the Glen Head students had to complete a registration packet and attend a design workshop on January 8th. Formal proposals needed to be submitted by January 22nd in preparation for the final GHS Invention Convention on February 25th. Students initially met with an adult coach as they began to select ideas to consider. Prior to final presentations, students met with a small group of students for peer feedback, in time to make last minute revisions. Some ideas and games submitted included Roll-A-Word, Rocket Toss, Mandarin Hopscotch, Marble Champ, Flick-It, Drawing off the Top of the Head, Wheel of Fun, Neon Drawing Board, Birthday

Bash Ball Tossing Game, Viking Mazeball PinBall Game, Magnet Run and Air Racers.

Principal Nimmo said, “I am very proud of the way they used interdisciplinary learning in all of the important areas of S.T.E.A.M. to create new, exciting, and fun indoor play ideas, games, and inventions. I have assisted them throughout the design process along with their peers as they initiated, built, and fine-tuned their presentations. It was an incredible night on February 25th as all of the wonderful inventions were exhibited and chosen as new indoor playtime alternatives for Glen Head

School. The following were selected as the most popular ones: Drawing off the Top of the Head, Wheel of Fun, and Neon Drawing Board. The other highly rated ones were Viking Mazeball, Rocket Toss, School Shot, Invasion of the Galaxy Game, and Flick It.”

Principal Nimmo concluded by saying, “This challenge not only exemplified my students’ knowledge and skills of S.T.E.A.M., but also demonstrated many aspects of our North Shore School District’s Shared Values Outcomes (SVO) initiative that goes beyond everyday testing and test prep. During the process, my students engaged in creativity,

brainstorming, effective communication, inquiry, critical thinking, independent learning, and collaboration. In addition, they demonstrated respect for each other’s ideas and differences, advocacy for their ideas and inventions, and a deeper, more meaningful understanding of the subject matter.”

## Glen Cove Youth Step Up and Call for a Reduction of Tobacco Marketing on Kick Butts Day 2016

Glen Cove High School students will take a stand on Kick Butts Day 2016 through awareness activities organized and chaired by the SAFE Glen Cove Coalition's School Committee. Kick Butts Day is a day of national activism sponsored by the Campaign for Tobacco Free Kids that empowers youth to stand out, speak up and seize control against Big Tobacco. The High School students will become educated on tobacco marketing techniques and will be encouraged to raise awareness with their peers and adult leaders of the problems of tobacco use in their community, and the misleading message associated with tobacco sales in local pharmacies.

The SAFE Glen Cove Coalition is pleased to once again be partnering with the Tobacco Action Coalition of LI, and their "Seen Enough Tobacco" campaign" to reduce our youth's exposure to tobacco marketing. "Our local youth have stressed that they feel CVS's decision to ban the sale of tobacco demonstrates the importance of this campaign in bringing awareness to the public and our elected officials of the need to reduce their exposure to tobacco marketing", per Ashley Ferrufino-SAFE Coalition Liaison. "Further tobacco marketing has been declared a youth epidemic by former Surgeon General Benjamin, so today we are encouraged

to see our next generation step up and call for a reduction in youth's exposure to tobacco marketing".

In New York, \$235 million a year, or nearly \$650,000 a day, is spent on marketing tobacco products and 280,000 kids under 18 today in NYS today will ultimately die prematurely due to smoking. In fact, if the current smoking rates continue 5.6 million Americans younger than 18 who are alive are projected to die prematurely from smoking related diseases.

"Tobacco sales in pharmacies is raising moral questions, as tobacco is the only consumer product that when used as intended, will kill at least one half of its long term users. Its displays in stores and trusted local pharmacies give youth the impression that tobacco products are easily accessible and tobacco use is acceptable. We are so proud of the activism of the teens at Glen Cove High School; and are grateful for our continued partnership with the SAFE Glen Cove Coalition as we have seen many teen leaders emerge over the years," said Carol Meschkow-Nassau Coordinator for the Tobacco Action Coalition of LI.

"Smoking is deadly, and we need to work together to protect our impressionable teens from the lure of this dangerous product; and that's why the physical education and athletic department for the

Glen Cove School district is particularly concerned. We strive to motivate, and stress that our teens take a stand and speak out for themselves. It is satisfying to see our students advocate for causes that they believe in such as challenging local pharmacies to re-consider the display of deceptive tobacco marketing promotions", said Anthony Gallo- GCHS Health Teacher.

According to Dr. Sharon Harris- Executive Director of the SAFE Glen Cove coalition, "a study recently released by the American Cancer Society found that smokers toll on health is worse than previously thought. The study found five additional diseases attributable to smoking and estimated that an additional 60,000 deaths each year in the US are due to tobacco use. This alarming statistic brings the total annual death toll to 540,000 people dying every year due to smoking related diseases. In NYS 108,500 High School students smoke cigarettes, and each year 135,000 kids initiate their addiction as daily smokers".

In New York State, 82 percent of retailers including pharmacies, convenience stores and gas stations occupy at least half of the space behind counters to openly display tobacco products for all to purview. The Glen Cove High School student leaders have

seen enough tobacco marketing and are banding together with the same message, "we want to be the first generation to be tobacco free!"

## Moving Forward To The Editor,

I want to congratulate Myralee Machol, Executive Director of Glen Cove's Community Development Agency for the accomplishment of securing \$7,682 in funds from the United States Department of Housing and Urban Development Community Development Block Grant, which allowed the CDA to provide financing to install automatic door openers at the rear entrance of Glen Cove's City Hall. This will not only assist so many people who may have the slightest mobility impairment, but parents who may be carrying small children, as well. I am very proud to have been a very, very small part of this accomplishment. She deserves all the credit!

As per her request of me, I am listing some additional suggestions, that from my personal vantage point in a wheelchair, might add to the quality of life of all citizens of Glen Cove.

- 1) The first parking spot in front of City Hall, at the Glen Street entrance, should be designated as a handicapped parking spot.
- 2) When facing the front of City Hall, at the Glen Street entrance, to the left of the actual building, there is an alley-way with an apron that comes to street level. This apron is not graded properly, with a huge lip, creating a very serious tripping hazard, even for an able-bodied person.
- 3) Signage should be placed outside the Glen Street entrance of City Hall,

One other suggestion, which could only add to a more welcoming atmosphere of downtown Glen Cove (a project which could be taken on by either the CDA, the Chamber of Commerce, the Beautification Committee, the BID – or even be sponsored by local organizations or merchants) – would be to add benches on the sidewalk areas, along both Glen and School Streets. This could allow citizens carrying packages, to rest briefly, before moving on to their next destination.

Again, these suggestions are not only being made from my vantage point, but have been suggested to me by many of our local citizens with minor mobility impairments. I would like to see the City of Glen Cove continue to have an "Access for All" philosophy.

We demand that the arts in education and librarians be brought back into our schools at the level children deserve. Students should not be test performers. They need and deserve to experience a well-rounded, stimulating, hands on education. We need to foster a love for learning in our classrooms, not be forced to over focus on scores. I call on this community to do all we can to have this insane law repealed.

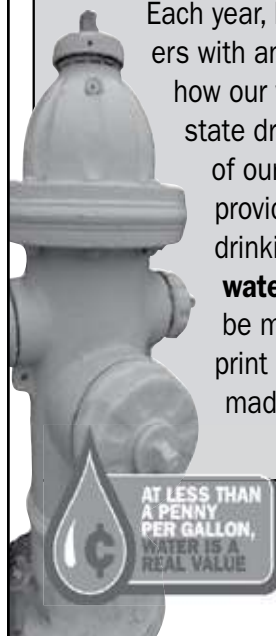

Glen Cove High School sophomore Spyro Markoulis was selected by the Nassau County Hockey League to play in the All-Star game vs. Suffolk County on April 2.

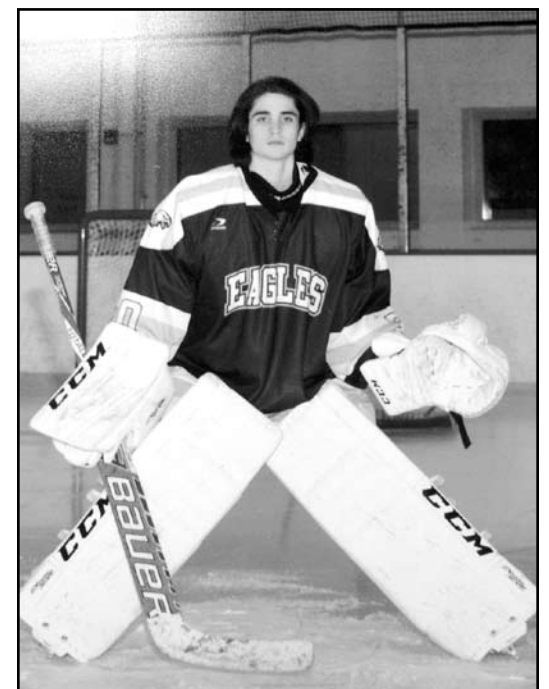

This weekend I will be attending my first ceildh- a celebration of Irish songs and poetry with acclaimed minstrel Joe Hughes leading the festivities. I would like to do some reading ahead of time to get in the spirit of things. Do you have any suggestions? Lover of All Things Irish

Dear Lover of All Things Irish, This time of year I always take out my copy of James Joyce's THE DUBLINERS, a collection of fifteen short stories set in early twentieth century Ireland. All are linked by a common theme: the spiritual and economic paralysis of Ireland brought on by English rule. The stories are divided into the three stages of life: childhood, adolescence, and adulthood with the concluding piece entitled "The Dead." Each of the characters in each of the stories faces a moment of decision but is unable to act because of

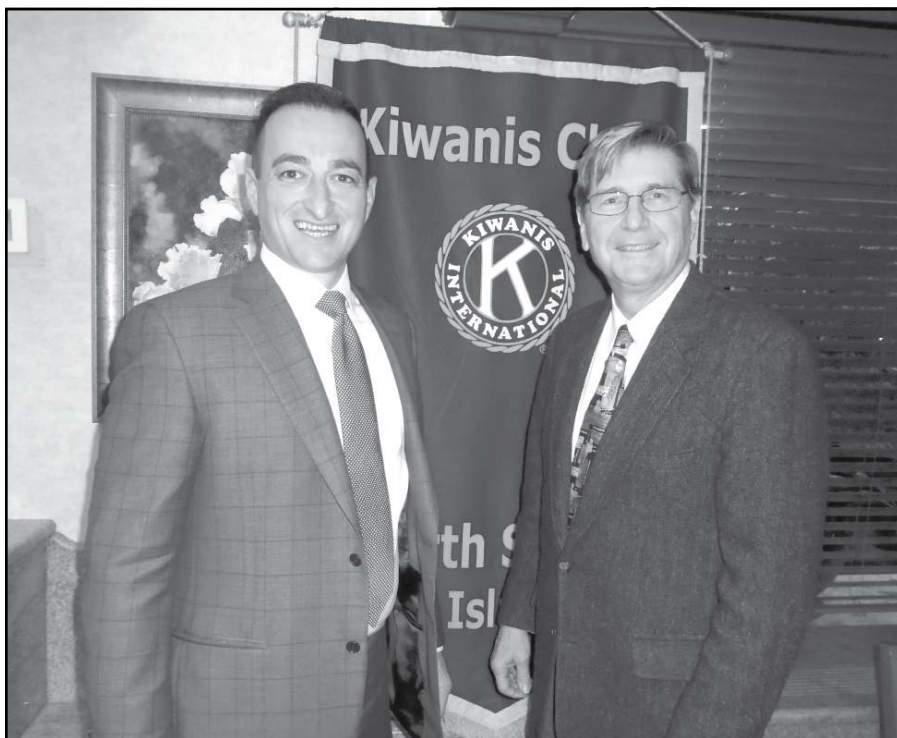
fear. Pitilessly, Joyce judges Ireland and the Irish people and finds them guilty because of their failure to throw off the domination of England and its agent-the Church. In each story, a character is allowed a moment of revelation – an epiphany. That they cannot act on their epiphanies only furthers the tragedy that Joyce sees as Ireland. The songs and poems at your ceildh will seem to bear little resemblance to these stories, but listen closely and you will hear Joyce's angry, soulful message. Highly, highly recommended !

# Name the Celebrity



This week's celebrity was born in NYC on Oct. 5, 1922 to Welsh immigrants. He was orphaned as a teenager and lived in abject poverty during the Depression era. He fought at the Battle of the Bulge during WWII and was wounded and captured by the Germans. It was those experiences that helped set up many of the tough eccentric characters he played. He brought a quirky charisma to every role he played from shopkeepers to space-age simians. He acted almost entirely on Broadway or regional stage in the late 1940s and '50s. His noted turn as the unbalanced in former in Broadway's "Advise and Consent" (1961) set the standard for his offbeat, conspiratorial persona in dozens of TV and movie appearances into the 1980s. In the 1960s, he turned to TV and film, when fantasy and spy shows relied heavily on distinctive guest players. He appeared five times on "The Man From U.N.C.L.E.", more than any other guest star, except Jill Ireland, who also appeared five times.

In 1962, he played the part of "George Pickson" in "Perry Mason-- The Case of the Bogus Books". In 1967, he appeared as "Brock" in the sci-fi TV show "Voyage to the Bottom of the Sea". He is often remembered as "one of TV's greatest slimeball villains". He later appeared in "The Money Changers", based on Arthur Hailey's book, with Kirk Douglas and Christopher Plummer. He also appeared in the 1979 NBC mini-series "Backstairs at the White House", which was nominated for eleven Emmy Awards, winning one. The series was noted for its all-star cast, Leslie Uggams, Cloris Leachman, Leslie Nielsen and Lou Gossett, Jr.. He had a few big A-movie parts, including his role as one of the wretched prisoners in "Papillon" (1973) with Steve McQueen and Dustin Hoffman and in "Dirty Harry" (1971) with Clint Eastwood.

### Last Week's Celebrity

Last week's celebrity was Jeanne Eagels. She was born Eugenia Eagles, but later changed the spelling of her surname to "Eagels". During the peak of her success, she began abusing drugs

and alcohol and eventually developed an addiction. She went to several sanitariums in an effort to kick her dependency. By the mid-1920s, she began using heroin. In 1928, after failing to appear for a stage performance in Milwaukee, Wisconsin, she was banned by Actors Equity from appearing on stage for 18 months. The ban did not stop Eagels from working in film and she made two "talkies" for Paramount Pictures: "The Letter" and "Jealousy", both released in 1929.

In September 1929, Eagels underwent eye surgery at St. Luke's Hospital in NYC. At the time, she was also suffering from breathing problems and neuritis. After a ten-day stay, she returned to her apartment on Park Avenue. On Oct. 3, 1929, Eagels and her secretary walked to St. Luke's where Eagels had an appointment. While talking to her doctor, she began having convulsions and died shortly after. The assistant chief medical examiner, who performed her autopsy, concluded that she died of "alcoholic psychosis". The M.E. stated that while Eagels had not consumed alcohol in the two days preceding her death, she began "acting strangely" and "suffering from hallucinations" three or four days before she died. Toxicology reports revealed that Eagels still had alcohol in her organs when she died, in addition to heroin and chloral hydrate. Her death was attributed to an overdose of the chlorate hydrate.

She was posthumously nominated for the second annual Academy Award for Best Actress for her role in "The Letter". She lost to Mary Pickford for the film "Coquette". The award has been described as an early example of cronyism in the Academy, as early meetings of the Academy were held at Pickfair, Mary Pickford and Douglas Fairbanks Sr's. home. Many believed the award should have gone to Eagels. Seems like the Academy had problems all the way back then, too.

In 1957, a mostly fictionalized film biography titled "Jeanne Eagels", was made by Columbia Pictures, starring Kim Novak, as Eagels.

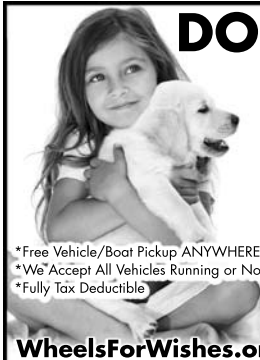

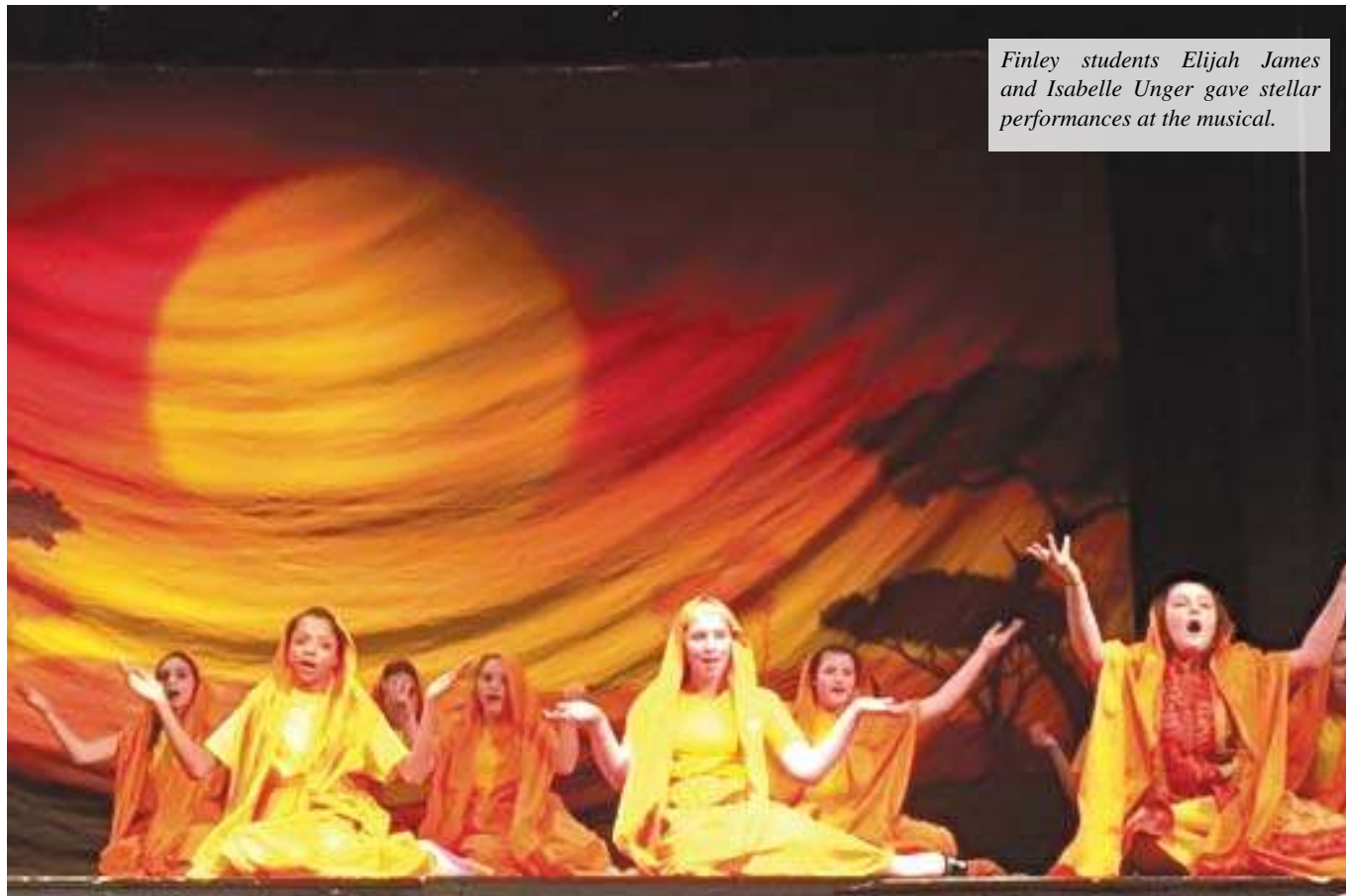
