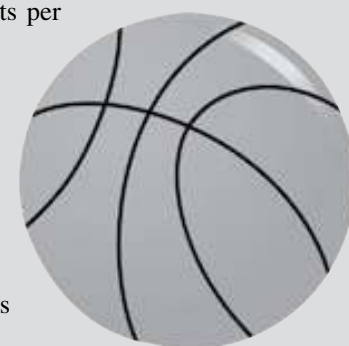
North Shore Women's Varsity Basketball Player Selected for the Newsday All-LI Basketball First Team

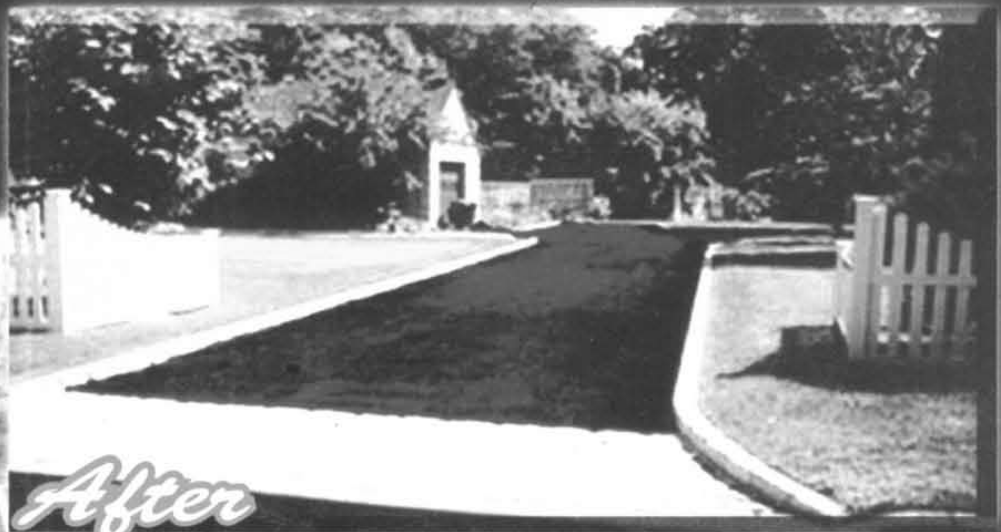

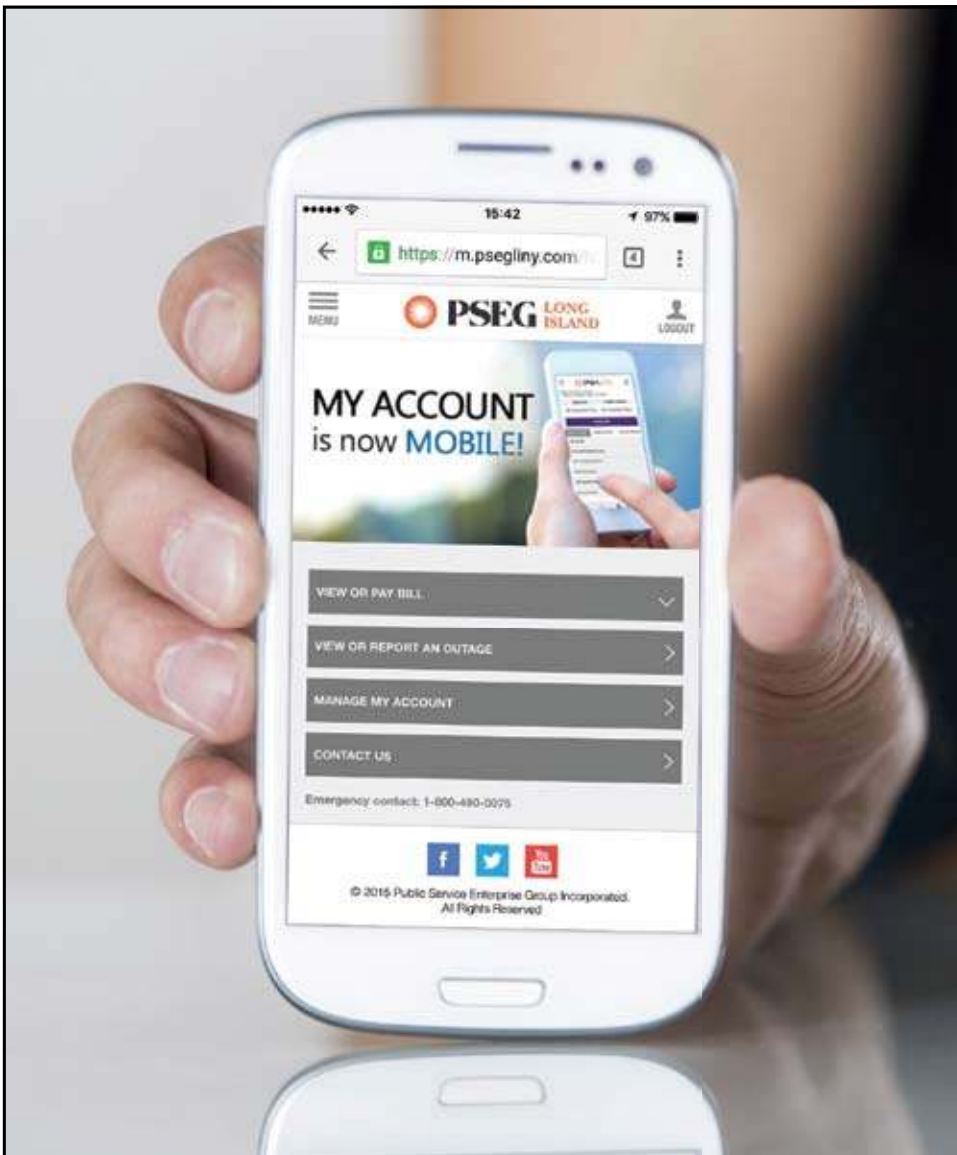


Bailey Arboretum Photography Contest Rules

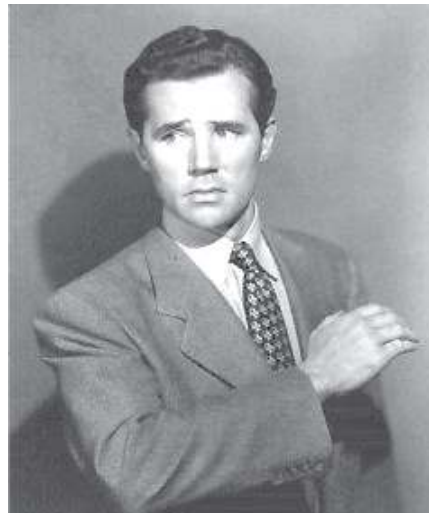

This week's celebrity was born in Charleston (now Bremerton), Washington, on Nov. 24, 1913. He graduated in 1932 from Roosevelt High School in Seattle, where he began acting in school plays after he was cut from the school basketball team. He worked locally in the theater in Seattle until he entered the U.S. Army Air Corps. He was assigned to the USAAC radio service. He announced re-broadcasts prepared for Armed Forces Radio Service (AFRS). In this role, he served as the announcer for "Suspense" dated March 16, 1943. His greatest radio role was when he played Dashiell Hammett's private eye "Sam Spade" from 1946 to 1950, starring in "The Adventures of Sam Spade" on three different networks, ABC, CBS and NBC.

After the war, his career improved and quickly procured his first film role as an inmate in "Brute Force" (1947) with Burt Lancaster and Hume Cronyn. He was also in "The Naked City" (1948) with Barry Fitzgerald, "All My Sons" (1948) with Edward G. Robinson and Burt Lancaster and "A Wedding" (1978) and Carol Burnett and Mia Farrow, "Red Canyon" (1949) with Ann Blyth and a "Woman in Hiding" (1950) with his future wife, Ida Lupino. In 1951, our celebrity married Ms. Lupino already a well-established star at Warner Bros., who was coming into her own as a director.

Last Week's Celebrity

Last week's celebrity was Estelle Winwood. She was very good friends with actress Tallulah Bankhead, who died in 1968. Bankhead, actresses Eva LeGalliene and Blyth Daly and Estelle were dubbed "The Four Riders at the Algonquin" in the early silent film days, because of their appearances together at the "Algonquin Round Table". Winwood appeared as a character in "Answered Prayers", Truman Capote's final unfinished, thinly veiled "roman a clef". In the novel, which uses her real name, she attends a drunken dinner party with Bankhead, Dorothy Parker, Montgomery Clift and the novel's narrator P.B. Jones. Some of her other film credits were "Darby O'Gill and the Little People" (1959), "The Misfits" (1961) with Clark Gable and Marilyn Monroe, "The Magic Sword" (1962), "The Notorious Landlady" (1962) with Jack Lemmon, Kim Novak and Fred Astaire, "Camelot" (1967), "The Producers" (1968) and "Dead Ringer" as the older family member who insists on praying the rosary with Bette Davis' character. Some of her TV work included guest roles in "Dennis the Menace", "The Twilight Zone" "Dr. Kildare", "The Man from U.N.C.L.E.", "Bewitched", "Batman", "Police Story" and in an excellent showcasing, the last episode of "Perry Mason" entitled "The Final Fading". She plays a fading actress who ends up as a second defendant. Winwood's final film appearance, at age 92. in "Murder By Death" (1976) was as Elsa Lanchester's ancient nursemaid. At the time, when she took her final major TV role in a 1979 episode of "Quincy M.E.", she officially became, at age 96, the oldest actor working in the U.S. narrowly beating out fellow British actress, Ethel Griffies, who played the elderly ornithologist "Mrs. Bundy" in Alfred Hitchcock's "The Birds" (1963). She continued making appearances until she was 100 years old. When she died, on June 20, 1984, 101 years of age, she was the oldest member in the history of the Screen Actors Guild.
