# NS Board of Education To Hold Town Meeting/Budget Hearing, Thursday, May 5, HS Library, 7:30 PM



There will be a BOE/Town Meeting on Thursday, May 5, at 7:30 pm in the North Shore High School Library which will include a public reading of the budget (Proposition 1). Also, on the North Shore Schools ballot this year will be Proposition 2. The district is asking for permission to establish a Capital Reserve Fund for a period of 10 years that will be funded up to a maximum of \$8.5 million dollars. If approved, the reserve will include the following building projects:

- Glen Head School: Replacement of 1995 boilers and 1950 septic tanks; renovation to the nurse's office; air conditioning in the library and cafeteria
- Glenwood Landing School: Replacement of 1950 septic tanks, exterior doors, and interior ceramic tiles; air conditioning in the library and auditorium
- Sea Cliff School: Replace windows on

the second floor, exhaust fans in the halls and stairways; new flooring in the 1st and 2nd floor classrooms on the east side of the building; walk-in refrigerator and freezer; air conditioning in the cafeteria

- Middle School: Renovate boys and girls locker room; air conditioning in the cafeteria
  - High School: Replace entire cafeteria ceiling/install LED lighting; replace sidewalks in the rear of the buildings and around the courtyard; air conditioning in the gymnasium
  - Central Office: Re-pipe existing hot water heating system; excavate and waterproof entire perimeter of the building and foundation; install new generator to power building; level floors
- The Capital Reserve is a fund set aside to use for specific projects that are related to school buildings and grounds. Instead of incorporating the costs for these capital projects into future budgets which likely increases property taxes, a Capital Reserve Fund enables the completion of these projects without increasing the annual budget.

The Town Meeting format provides all district residents with the opportunity to engage in direct dialog with Trustees related to any issues pertaining to our schools. The Trustees encourage all interested community members to attend this meeting. Also on the agenda for May 5th is the Guidance Review Action Plan

## Cove Animal Rescue Presents A "Cause For Paws" Spring Gala

Topping off a banner year of accomplishment, Cove Animal Rescue (CAR) will hold its second annual spring gala Thursday, May 12th at Bayville's Crescent Beach Club (333 Bayville Ave.) with its gorgeous views of Long Island Sound. Enjoy an evening of entertainment with an open-bar cocktail hour, from 6pm to 7pm, followed by dinner, a silent auction and dancing to a nine-piece band.

Proceeds from the gala directly support Cove Animal Rescue's mission of providing a healthy, safe environment for homeless cats and dogs and placing them in suitable adoptive homes. CAR strives for a cage-free environment to help eliminate the fear and stresses that can make an animal difficult to present for adoption. To this end, private benefactors have made it possible to expand the shelter by 1,800 sq. ft. to create a cage-free colony-like wing for the cats that includes windows, sky lights and cat doors opening to secure open-air enclosures. In addition, a spacious specially-fabricated green-turf outdoor play area has been constructed for the benefit of the dogs.

A ribbon-cutting ceremony, held Sunday, April 10th, inaugurated the new additions. Presiding in front of the shelter, Glen Cove mayor, Reggie Spinello, addressed a crowd of supporters. He acknowledged the CAR staff and volunteers for their contributions to the efficient functioning of the shelter. He cited Deputy Mayor

Barbara Peebles for her dedicated support of Cove Animal Rescue. And the mayor lauded CAR's board members for their stewardship. Now, just 13 months after taking over management, the facility has been expanded and the day-to-day environment the animals experience has been greatly improved. Since taking charge March 1, 2015, more than 80 dogs have been brought to the shelter as lost or surrendered by their owners. Nearly that same number have left due to placement in new homes or return to their owners. Similarly, the number of senior cats given up by owners and then adopted is near parity. Currently, nearly 100 animals are receiving medical care, food and the loving attention of staff members and volunteers. And, off campus, Cove Animal Rescue is continuing to work with local trappers to reduce the feral cat population with a trap-neuter-release program.

Cove Animal Rescue's "Cause For Paws" Spring Gala at the Crescent Beach Club is the non-profit organization's flagship fundraiser of the season. Why not set aside the evening of May 12th for an evening of fun while benefiting the shelter's cats and dogs? It is an uncontested election with three seats available. Meet the Candidates Night will take place on Wednesday, April 20, in the North Shore High School Cafeteria, at 8 PM.

Community members will have an opportunity to vote on the North Shore Schools Proposition 1 (2016-17 School Budget Proposal), Proposition 2 (Permission to Establish a Capital Reserve Fund), and the Election of Trustees on Tuesday, May 17, 2016, from 7:00 AM to 10:00 PM in the North High School Gymnasium.

**Bios from the Candidates:**

**Sara Jones**



Occupation: For 16 years, I have been the owner and CEO of a successful, national catalog-based company now serving 100,000 customers. I have consistently increased sales and market-share through strong financial and strategic planning, pro-active budgeting, complex supply chain management, and creative problem-solving. Previously, I worked as a director of fundraising for the public-private partnership Citymeals-on-Wheels raising several million dollars in donations annually and gaining an understanding of the role of private fundraising for public institutions.

Qualifications: I am a current Trustee for North Shore's Board of Education and have greatly enjoyed serving our community for the past three years. During that time, I also co-founded the volunteer-run, nonprofit Sea Cliff MAKEshop which provides coding, science and engineering opportunities for district students. Previously, I served as Treasurer for the Friends of the Sea Cliff Library; I have also been deeply involved in our schools through the Sea Cliff PCA where I was former webmaster, created the book swap and chaired the nutrition committee; I also served on North Shore's district-wide nutrition committee. I graduated in 1989 from Princeton University, A.B. cum laude.

Personal: I am a sixteen-year resident of Sea Cliff. I have a son at Sea Cliff School and a

daughter at North Shore Middle and am a former Roslyn Trinity Co-op parent. Both kids have taken advantage of the terrific opportunities our district has in the arts and athletics, and it has been a great opportunity to meet so many of our neighbors in our auditoriums and on our playing fields. We are the proud companions of a dog we adopted from a shelter last fall, two cats, and a frog raised from tadpolehood in our daughter's kindergarten class.

Statement: "I am a strong advocate for public schools generally and our district in particular. Through my experiences as a member of the North Shore Board of Education over the last three years, I have gained a great deal of insight about the workings of public education both on a local and national scale. I believe this experience makes me an even stronger candidate now than I was three years ago, and I look forward to having the opportunity to put my knowledge and skills to work for the North Shore community for another term.

During my tenure on the Board of Education, I have advocated for a curriculum that focuses on creating life-long learners and

engaged citizens. As such, I authored the board's Resolution on High Stakes Testing which argued for limiting the impact of government mandated testing on our high performing schools. My work on the Board has also focused on promoting and protecting the overall well-being of our students. I am a Board representative to the Wellness and Health & Safety Committees and initiated a review of our student data privacy policies. I also serve on the District's Construction Steering committee which is deeply involved in the long term planning used to provide the facilities needed for the kind of well-rounded experience we want for our students.

As a CEO and business owner, I am very conscious of the duty of a school district to be fiscally responsible. Our community currently enjoys high quality schools and our district has worked hard to create a full range of arts, athletics and other extra-curricular activities to engage all children. My skills in long-term planning, budgeting and creative problem solving are crucial in this environment, and I look

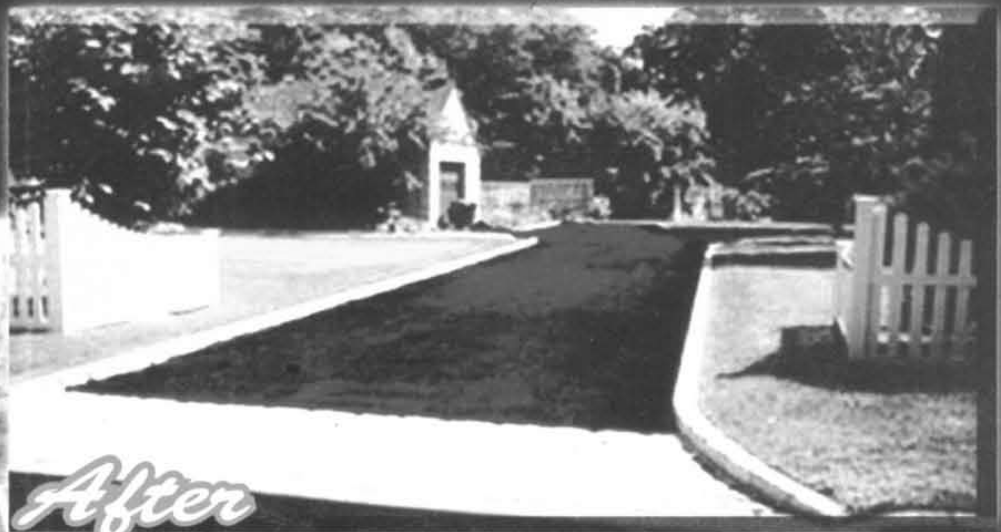
and attended the fundraiser the Keystone Club teens fulfilled their goal in helping Make-A-Wish, an organization the teens chose because of the great work they also do for children.

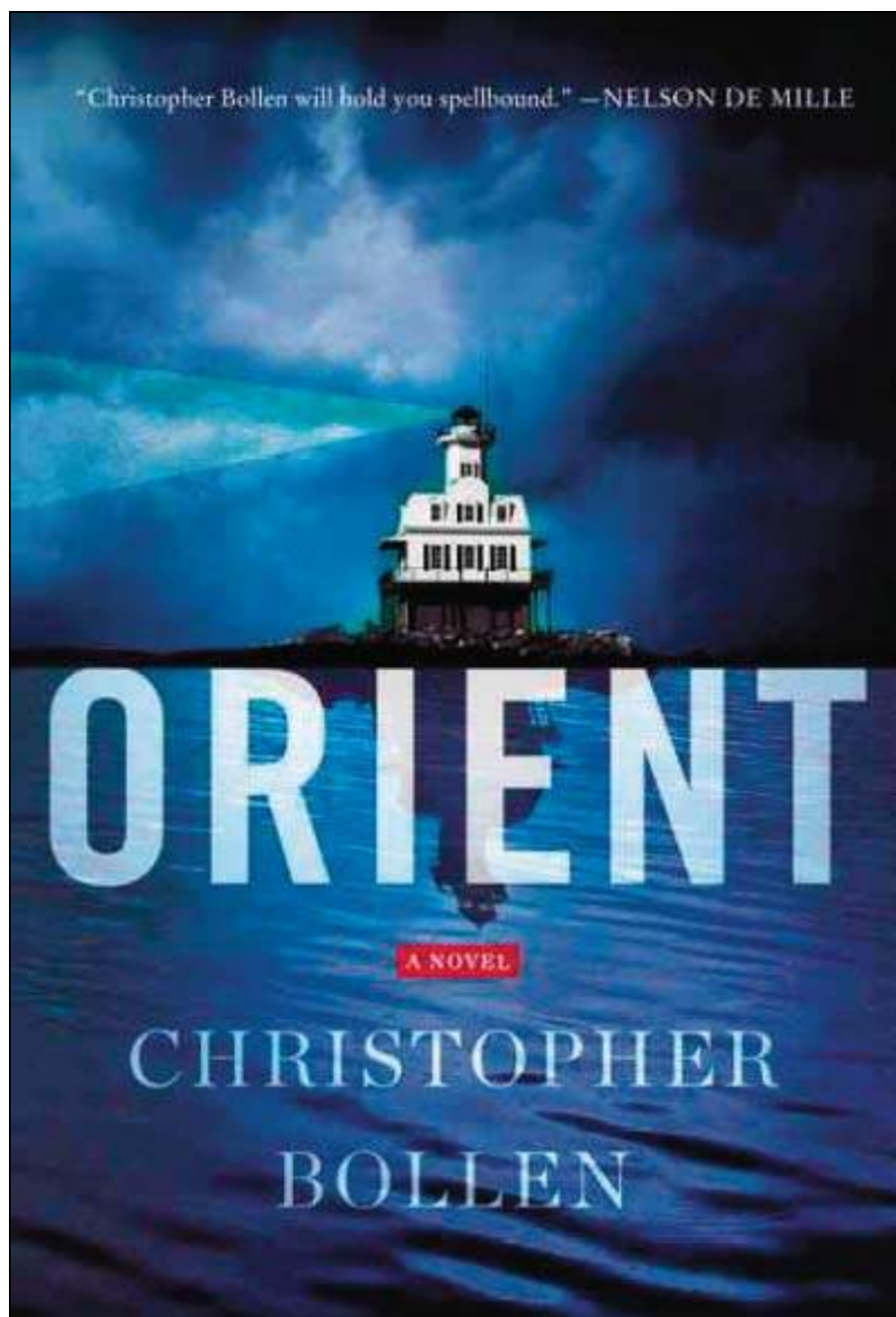

Author Christopher Bollen will visit the Gold Coast Public Library on Tuesday, May 24 at 7pm to discuss his thriller *Orient*.

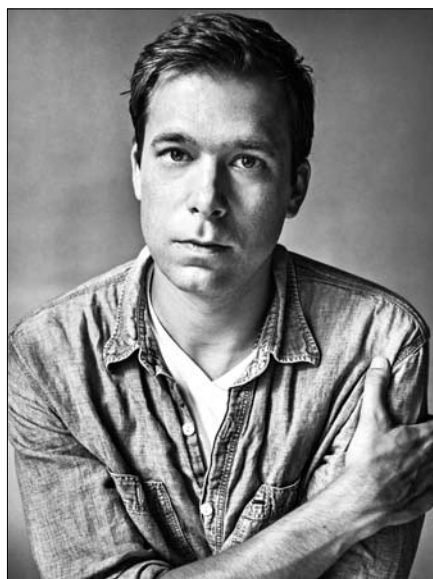

## The BioBus Stops By Glenwood Landing School

Students had a special treat when the BioBus recently rolled into the parking lot of Glenwood Landing School. The BioBus is a high-tech science lab on wheels filled with research-grade equipment! As students boarded the bus, they were told that they were “scientists” who were able to immediately explore the microscopic world around them in an inquiry-based setting that is supervised by Ph.D. level scientists.

With fluorescence stereo zoom microscopes and digital cameras, Glenwood Landing students were excited to explore first-hand the internal workings of a micro-crustacean organism called a *Daphnia*, more commonly known as a water flea. In addition, the young Glenwood scientists were able to ask many questions and learn about its physical and behavioral characteristics.

The BioBus has been on the road since 2008 giving 115,000 people at more than 420 schools and communities the opportunity to work side-by-side. It is operated by Cell Motion Laboratories, Incorporated, an educational non-profit organization based in New York. On their website, it states “Cell Motion Laboratories works towards a future in which all people have experienced the power and beauty of making a scientific discovery. Cove Animal Rescue believes an animal shelter is a great place for humans as well as animals and is working toward completing changes to make the shelter an inviting, healthy environment, while providing the opportunity for visitors to expand their interest in, and consider the benefit of, pet companionship. Now, North Coast Subaru and Subaru of America are bringing the shelter closer to its goals.

The Subaru Love Promise is a pledge to do right by the community by partnering with national and local nonprofit organizations. This past holiday season, Subaru hosted their 8th Annual Share the Love Event. With its track record of increased adoptions, increased neutering of feral cats and increased outreach with community organizations, Subaru America recognized that Cove Animal Rescue was a prime example of the Share the Love Philosophy; communities that adopt a healthy, active lifestyle also recognize the connection to responsible pet ownership.

## Animal Services to the Community-

### --Dogs

By the end of 2015, just 10 months after beginning the management of the shelter, 74 dogs had sought shelter from Cove Animal Rescue and 73 had found new homes or been returned to their owner.

This was accomplished by prompt cooperation with the Police Department and the City Dog Control Officer; with Cove Animal Rescue providing 24/7 staffing to have the facility open and prepared for a "delivery" of a dog into a safe, and warm shelter with the ability to "chip scan" for identification as well as immediate FaceBook notification of our newest guest.

### --Cats

Working with local trappers and colony

feeders, Cove Animal Rescue assisted with the trapping, and paid for the neutering of 165 feral cats in just the first 6 months of being open. Of those, 104 kittens came into the shelter, and 98 have been adopted out. Additionally 21 adult/senior cats entered the shelter (primarily surrendered by their owners who were residents of Glen Cove); but 23 senior cats were adopted out.

## Programs for the Community-

### --Children

Cove Animal Rescue created a weekly program for the Boys and Girls Club of Glen Cove during the summer of 2015. The children were able to observe the following: a dog agility course demonstration (setup by our trainer; a competitor in dog agility training); a very large, unique breed of dog that is a certified companion dog and the subject of a book; a demonstration by our Vet Technician that included a physical examination, acquisition of a sample, preparation of, and viewing of, a slide on the microscope. Additional animal care instruction was provided.

### --Teens

Cove Animal Rescue teen volunteers learn animal care. If school, or volunteer, credits are needed, the course requirements must be reviewed and accepted.

### --Adults

Cove Animal Rescue receives frequent visits from persons in programs for the mentally and physically challenged.

Construction projects completed and

underway-

In addition to caring for the animals and reaching out to the community, Cove Animal Rescue has accomplished the following:

In furtherance of our conviction that caging of an animal is cruel, and counterproductive to creating an adoptable pet, Cove Animal Rescue has neared completion of an extension providing a cage-free environment for our cats with access to a screened-in "cattery."

Having successfully trapped, and funded the subsequent neutering, of 170 feral cats, we have now commenced replenishment of needed surgical equipment for our

on-site operating room; fostering a more effective TNR program.

3-Completed construction of outdoor dog interactive play areas with "doggie astroturf" surfaces built over a constructed, layered, natural drainage system.

The \$21,000 from North Coast Subaru and Subaru of America will contribute to cover the costs of the ongoing internal structural improvements including new pre- and post- op room, isolation room, surgical area and equipment, "meet-and-greet" space and reception area.

The upcoming event will be held at the historic Mill Neck Manor House, a circa

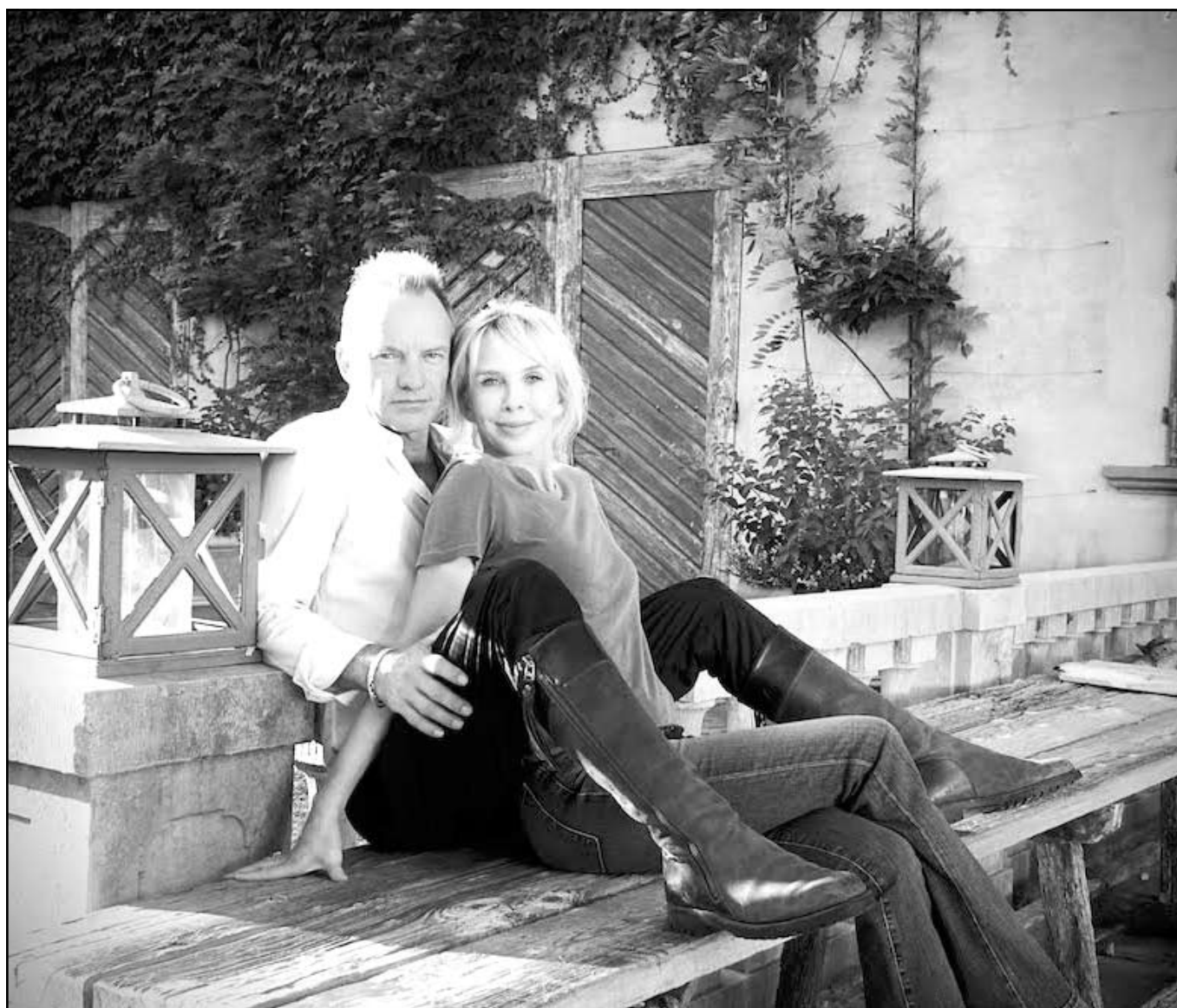

"There is a magical quality to Alec's mark-making. Up close, it's more difficult to make out the image in his paintings, but from a distance the squares come together to create the whole picture. At the same time the color and value differences in the squares kind of "buzz" against each other, creating an exciting energy and tension." - Art Teacher, Elissa Theiss

"Alec was in my Studio Art class since his first year at North Shore High School and I have been working with him during all of his years at the high school," said Ms. Theiss. "One of the beginning exercises in this class was learning how to draw using a grid. Instead of looking at a picture of a person and seeing eyes, nose, mouth, etc., the grid helps a person look at a section of abstract information that the brain doesn't have a pre-existing memorized space shape for, which allows the artist to more accurately observe and record what they are seeing and to do it in a more manageable way. The gridded drawing opened up new possibilities for Alec. When he used the grid, he was able to focus on what he was seeing in front of him. It helped slow down his process and allowed him

to take in smaller bits of information at one time. This helped him to record what he was observing more accurately and with greater detail. "Apples" is one of my favorite Alec paintings and I have a signed and numbered print of it, a gift from the artist, hanging in my living room. The original painting is hanging in this gallery."

This year, our goal has been to help Alec paint more independently, continued Ms. Theiss. The grid process and routine allow Alec to do this. "The "Violin and Guitar" painting is one of my favorite pieces that he has created this year!"

I see Alec at his happiest when he is painting. He loves when he finishes a painting and gets to sign it. It's a joy to watch. Working with Alec has been such an incredible opportunity for me - I have learned so much and it has been an amazing experience to watch him develop into the artist he is today. # GWL Kindergarteners Practice STEAM Inquiry through Nursery Rhymes

GWL kindergarteners put their heads and hearts together allowing nursery rhymes to become the inspiration for weeks and weeks of engaging learning. As young readers, the children enjoyed learning to read and recite dozens of rhymes, but the process of scientific inquiry, scientific practices, and investigations had the kindergarteners truly living their lives as young scientists.

Some examples of how the kindergarteners practiced scientific inquiry and engineering challenges included:

“Humpty Dumpty” - created a boxcar that transported humpty safely through their tour of Glenwood Landing School  
“Rub-A-Dub-Dub Three Men in a Tub” - challenged students to design and build tinfoil tubs that needed to support varying amounts of weight. Students collected data by tallying the number of dominoes their tubs supported.

“London Bridge” - had the children working with their collaboration partners to co-design blueprints and build bridges with a variety of resources. The building process inspired a lot of scientific talk surrounding structure and design.

“Jack and Jill” - led the way to comparisons of weight by filling buckets with different materials. It also inspired the exploration and sorting of rolling objects.

“Little Miss Muffet” - had collaborative partners building spider traps to place in our outdoor classroom. Our designs were so varied that it was fun looking and celebrating all the possibilities for novel designs.

“The Crooked Man and His Crooked Mouse” - had the kindergarteners using sticks, straws, and playdough to build Crooked Houses. They mastered the art of crooked designs!

“Jack Be Nimble” - put everyone in the jumping mood! Students created jumping strips and collected data on how far they can jump. They were left wondering.... Do people who are older jump farther? Does jumping distance depend on ones' age or size?

Teacher Kelly Bierwiler stated, “Bravo to all the kindergarteners for bringing their voices together to treat us to such a lovely culmination. Their singing was inspiring and so was their scientific thinking and their passion for learning.”

Gasper Buffa passed away peacefully on January 19, 2016 at the age of 96 in Port Charlotte, Florida. Beloved husband to Rose (nee Suozzi). Proud parent to Carol Williams (Silas), Linda Emmi (Thomas), Angela Buffa Tortorici, Gasper Buffa Jr. (Theresa), and Dominick Buffa (Liz). Grandfather to Cynthia Genova, Brian Robert Pascucci (Jennifer), Gasper Buffa III (Jennifer), Matthew Ernest Pascucci (Dawn), David Gasper Buffa (Nicole), Lauren Benedict (Christopher), and Paul Bradley Buffa. Great grandfather to Liam Pascucci, Luke Pascucci, Daniel Buffa, Jay Gasper Buffa and Silas Benedict. He is also survived by his sister Sarah Pachiarotti and many nieces and nephews.

After Midway he was sent to Guadalcanal earning the rank of Master Sargent and Crew Chief while serving with the Marine Aircraft Wing. He finished his service with an assignment in

China. His commendations include: The Presidential Unit Citation with 2 Stars, Navy Unit Commendation medal, Good Conduct Medal with 2 Stars, American Defense Medal, Navy Campaign Medal with 1 Star, Asiatic Pacific Campaign Medal with 3 Bronze Stars, World War II Victory Medal, China Service Medal and the Occupation Service Medal.

He wrote poetry during the war and has been published in Leatherneck magazine. When he left the service he started a building business on Long Island and became a well-known and accomplished general contractor and developer. Above all, Gasper loved his wife, Rose, who passed away in 2008, after 65 years of marriage. They were both involved in the community organization in the City of Glen Cove, New York, where he served in leadership positions in the Glen Cove Lions Club, Rotary Club, Glen Cove VFW, the Dan Daly Glen Cove Globe and Anchor, and Glen Cove Post 76 of the American Legion. He had a remarkable life. He will be missed every day.

Dear Great Book Guru,  
Last weekend I was at opening day of Sea Cliff Baseball rooting for my favorite team "The Artful Dodgers" when I overheard a heated discussion of a new book about widespread injustices in America. I would love to learn more but didn't catch the title. Any idea? Fan of "The Artful Dodgers"

Dear Fan,  
Yes, I was part of that discussion and the book is EVICTED by Matthew Desmond. Desmond, a young sociologist, writes about eight families living in Milwaukee's poorest neighborhood. We learn in exquisite detail the struggles these families endure as they face seemingly insurmountable odds. The cumulative effect for the reader is shame and horror. We read of a single mother paying 80% of her \$628 income in rent, and failing to pay this rent, she is evicted during a brutal Wisconsin winter. A father struggling to care for his young children is evicted after three 911 calls

trigger "a nuisance citation" and, yes, the calls were because of his son's asthma attacks. The book focuses on two points: that growing numbers of low income families are paying astonishing shares of their income for rent and secondly, evictions aren't a result of poverty but a cause, resulting in job losses, school absences, illness... To lose one's home, the author discovers is often to lose everything- your possessions, your job, your children, your future. These evicted families enter into Dante's inferno- "abandon all hope, you who enter here." Highly recommended!

This week's celebrity was born Oct. 25, 1928 in NYC. In 1948, he joined the Cherry Lane Theatre Group off Broadway, at the same time as actress Bea Arthur. He followed that with roles in several major films, including "A Face in the Crowd" (1957) with Andy Griffith and Patricia Neal, "The Naked Maja"

(1958) with Ava Gardner, "The Long Hot Summer" (1958) with Paul Newman and Orson Welles, "Career" (1959) with Dean Martin and Shirley MacLaine, "Period of Adjustment" (1962) with Jane Fonda, "The Pleasure Seekers" with Ann-Margaret and Carol Lynley, "Fathom" (1967) with Raquel Welch and "The Drowning Pool" (1975) with Paul Newman and Joanne Woodward.

### Last Week's Celebrity

Last week's celebrity was Nita Talbot. She was a leading lady who spent the first decade or so of her career playing "slick chicks" and sharp witted career girls, but perhaps best known for her role as "Marya", the White Russian spy in the 1960s sitcom "Hogan's Heroes", as well as, "Sheila Fine" in the sitcom "Soap". She received an Emmy Award nomination for Best Supporting Actress in a Comedy Series for the 1967-68 season of "Hogan's Heroes". 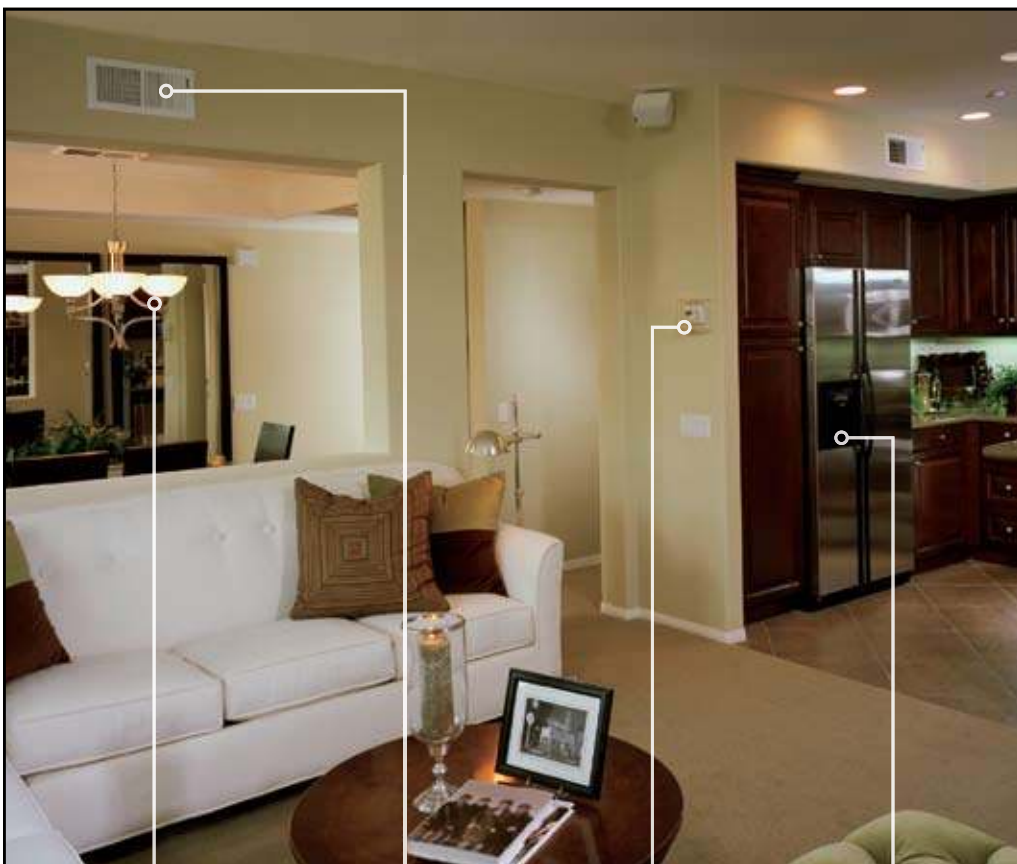
