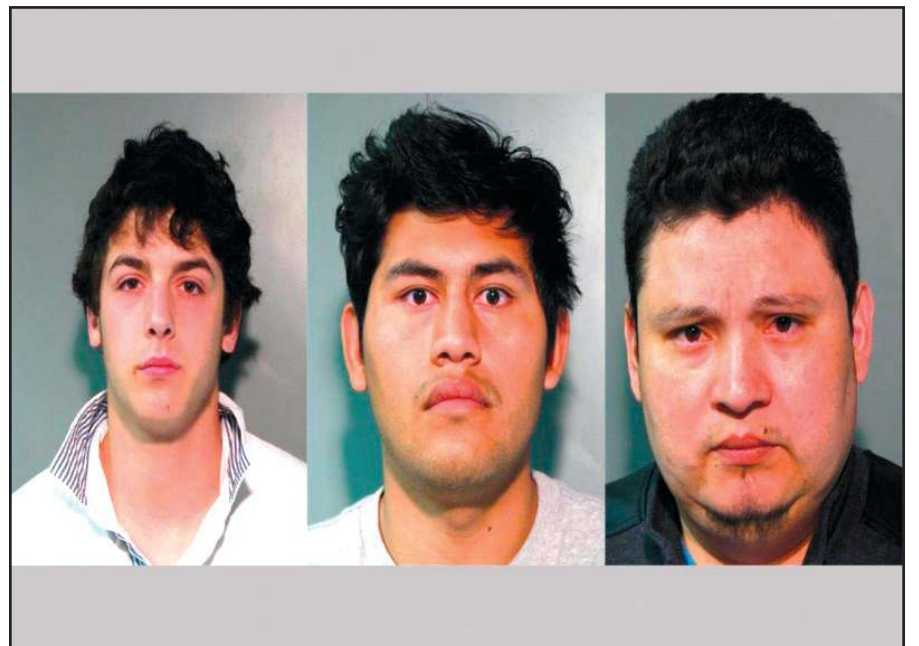


# Safe From Sands Point Dropped In Glen Cove

On April 27th members the Glen Cove Crime Prevention Unit observed a large safe lying on the ground at 131 Glen Cove Ave in Glen Cove. According to Det. Lt. John Nagle, the officers observed that the safe had been broken open and the contents were removed. The officers, Glen Cove Detective Brian Glennon, Police officers Steven Grella and Peter Michaleas investigated the incident further and were able to arrest three men at the scene.

According to Nagle, the subsequent investigation determined that the safe was removed from a residence in Sands Point NY and was transported to Glen Cove by the men. The officers arrested Benjamin Hayt, 18, of Port Washington, Elmer

Mendez, 19, of Port Washington, and Jose Chevez, 36, of Glen Cove. The defendant Benjamin Hayt was charged with two counts of Burglary 3rd degree, one count of Criminal possession of Stolen Property 2nd degree, and Criminal Mischief 2nd degree. Elmer Mendez was charged with one count of Burglary 3rd degree, Criminal Possession of Stolen Property 2nd degree, and Criminal Mischief 2nd degree. Jose Chevez was charged with Criminal Possession of Stolen Property 2nd degree, and Criminal Mischief 2nd degree. The Nassau Police, 3rd squad detectives assisted with the case when it was determined that the original crime took place in Sands point.

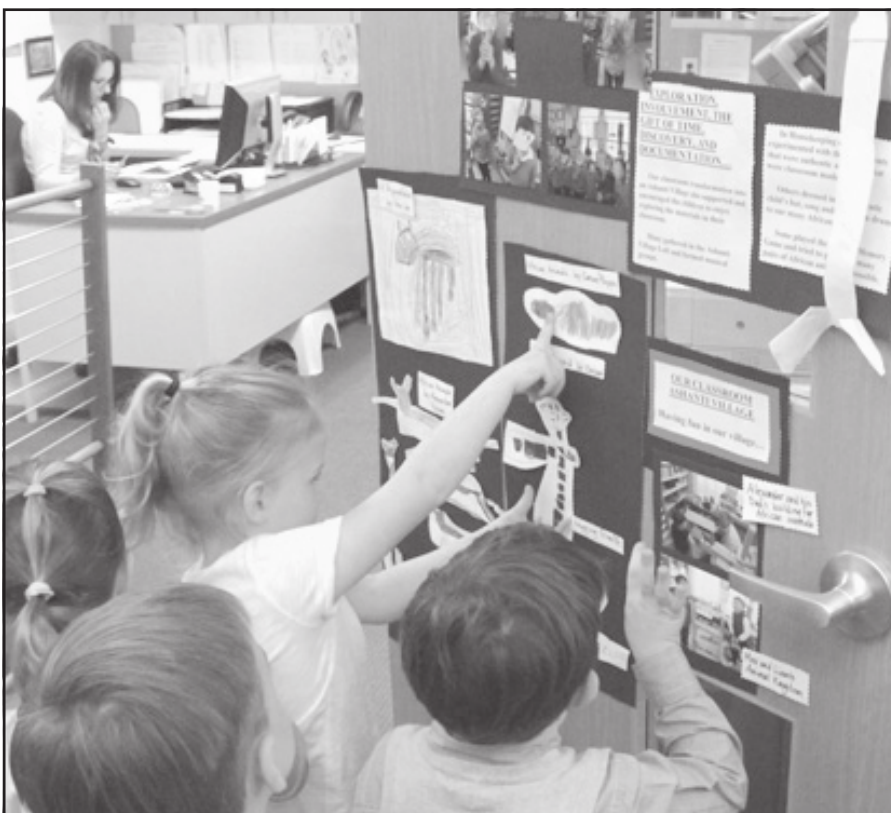

Throughout the month of April, Joanne Pappas' and Kimberly Lynch's Pre-Kindergarten class showcased several African museum exhibits in the lobby of the Early Childhood building on campus. Student creations ranged from Kofi's weaving hut and African shakers, crowns and clay pottery. The students also made animal paintings of their favorite animals, including lions, cheetahs and crocodiles.

"The Pre-K II classroom is steeped in the Reggio Emilia experience as the 'tipping off' point to all that transpires in our learning environment," Mrs. Pappas said. "Keeping in mind that the experiences are generated from the interests of the children and that the 'life of the project' is created by the children's

curiosity and exploration. Why the continent of Africa? When I first began my teaching career we were coached to work from rote/traditional curriculum based ideas. When I was 'bitten' by the value of the Reggio Emilia experience, the classroom became the laboratory where exploration, observation, discovery and documentation took the main stage. The idea to explore this continent rich in history, culture, traditions, animals, different terrain and language provokes a child to expand on their previous experiences and knowledge gathered as well as become completely immersed in the many offerings Africa has to offer through their discoveries -- both observing and challenging children to question and create."



# GV Voices Sing National Anthem at CitiField

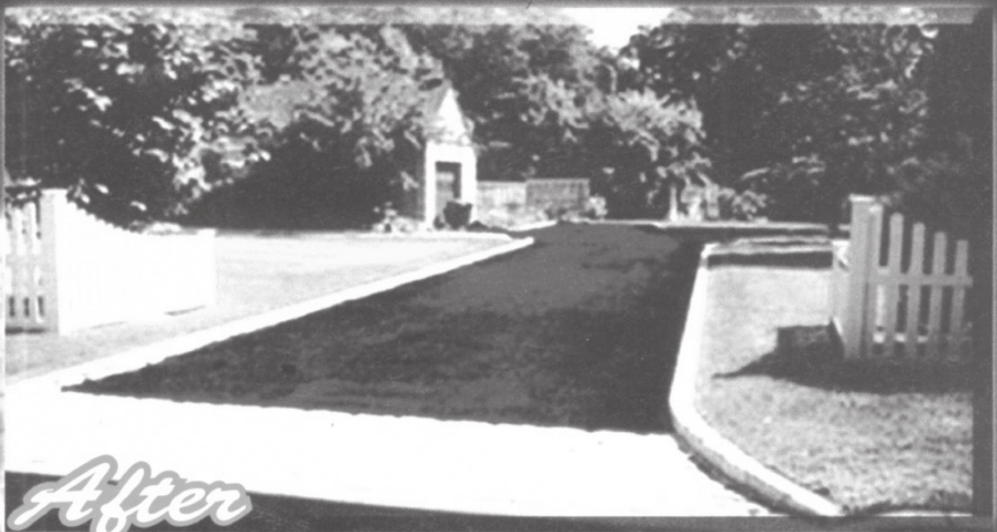

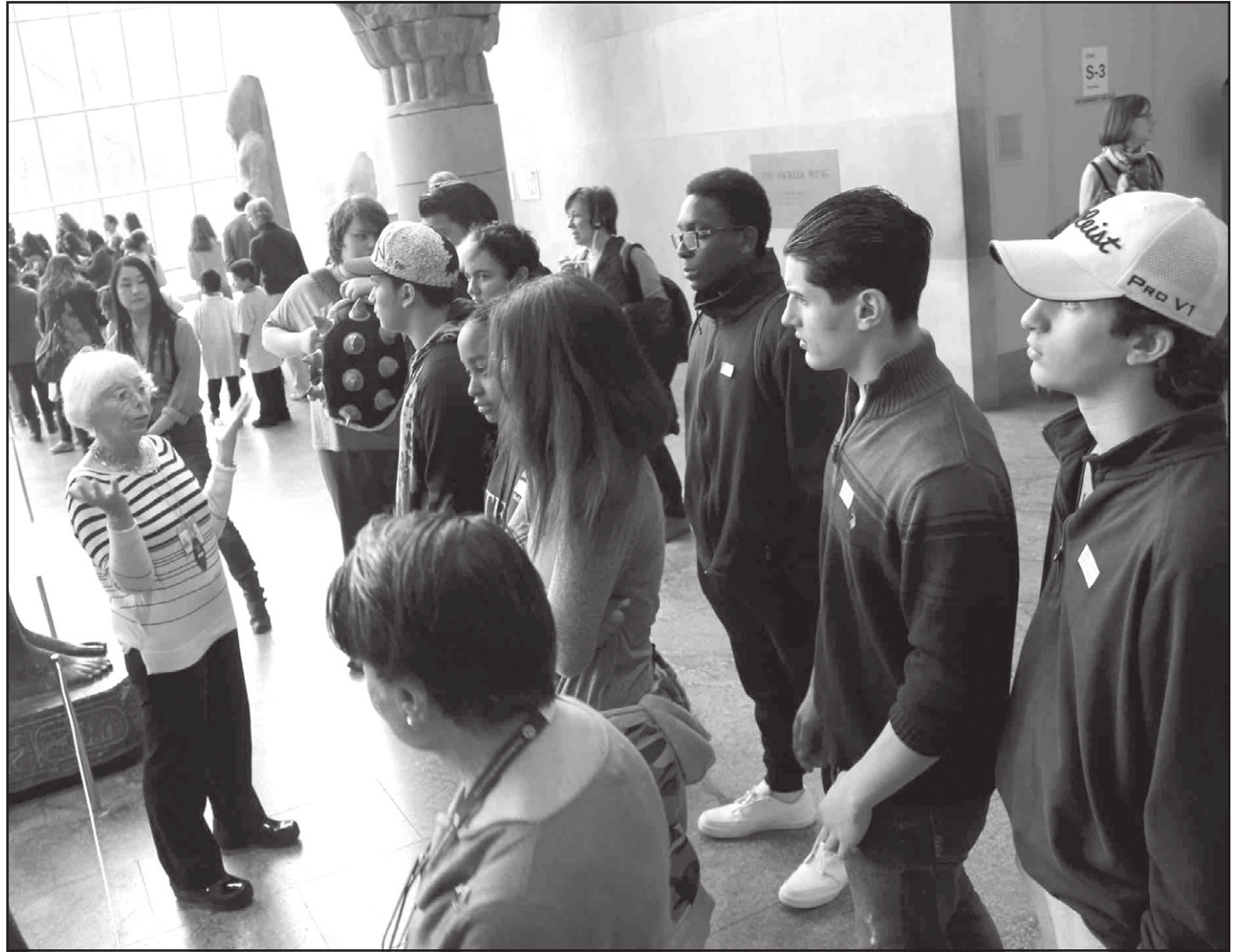

## Lutheran Friends of the Deaf Launches a Free Vacation Bible School on Long Island

"Gospel Hands" Vacation Bible School (VBS) is an exciting 4-day program being offered this summer by Lutheran Friends of the Deaf. Free of charge to Deaf children and their siblings (ages 6-12), this unique VBS will be held at the Lutheran Church of the Resurrection in Garden City on August 16-19, 2016.

Since 1947, Lutheran Friends of the Deaf (LFD), the founding member of the Mill Neck Family of Organizations has made it their mission to serve the spiritual needs of those who are Deaf, locally, nationally and around the world. And while they serve Deaf individuals as far away as Ethiopia, LFD's first and foremost priority is to serve individuals right in their backyard of Long Island.

With a generous grant from the Lutheran Church Missouri Synod (LCMS), LFD was able to develop and launch this special program. LFD also teamed up with the Lutheran Women's Missionary League (LWML), who awarded a grant that funded the development of "Bible Story Books"—a series of 12 written and ASL Bible Stories for children. Using the Bible Story Books as the basis of the VBS curriculum, LFD will

bring the Gospel into the lives of children by combining American Sign Language, expressive artwork, the written word and video.

Language and cultural barriers have often left the Deaf population in isolation, especially when it comes to learning the Gospel. Christian Deaf ministries estimate that only 1 percent of Deaf adults will attend a Christian church. Through "Gospel Hands" VBS, as well as other programs and social events, LFD aims to reach hundreds of Deaf individuals on Long Island, greatly increasing the

# Name the Celebrity



This week's celebrity was born Harold Herman Brix on May 19, 1906 in Tacoma, Washington. His first career was as an athlete. At the University of Washington, he played football in the 1926 Rose Bole, for the Huskies, as a tackle, and was a track-and-field star. Two years later, he won the Silver Medal for the shot put in the 1928 Olympic Games in Amsterdam. He moved to Los Angeles in 1929, after being invited to compete for the Los Angeles Athletic Club and befriended actor Douglas Fairbanks Jr., who arranged a screen test

for him at Paramount. In 1931, MGM, adapting author Edgar Rice Burrough's popular "Tarzan" adventures for the screen, selected Herman Brix to play the title role. The film was begun on location in Guatemala, under rugged conditions of disease and money shortages. Brix did all his own stunts including dives off rocky peaks. The finished film, "The New Adventures of Tarzan" was released in 1935 and offered to theaters as a 12-chapter serial. The Washington Post quoted Gabe Essoe's passage from his book "Tarzan of the Movies": "Brix's portrayal was the only time between the silent and the 1960s that "Tarzan" was accurately depicted in films. He was mannered, cultured, soft-spoken, a well-educated English lord who spoke several languages, and didn't grunt."

Unfortunately, during the filming of "Touchdown" (1931), with Richard Arlen and Jack Oakie, Brix broke his shoulder. It cost him the role in future "Tarzan" films. The role went to Olympic swimmer Johnny Weismuller. The injury also caused Brix to fail to qualify for the 1932 Olympic trials while holding the world record in shot put.

## Last Week's Celebrity

Last week's celebrity was born Anthony Papaleo, but was professionally known

as Tony Franciosa. His parents divorced shortly after his birth, and he never really knew his father. After graduating high school, he happened to be on his way to take a free dance lesson at a YMCA and he came across an audition for a play. Curious, he auditioned and was offered a part. He began acting professionally, taking his mother's name, and had his breakthrough in Calder Willingham's play "End as a Man" (1955), which opened off-Broadway at the Theatre de Lys on Sept.15, 1953 and transferred to Broadway on Oct.14, 1953, after 32 performances. It was directed by Jack Garfen and co-starred Ben Gazzara, who remained a life-long friend of our celebrity.

Aside from his many movies, in 1968, Franciosa was cast as one of three alternating leads in the TV series "The Name of the Game", a spin-off from the 1966 TV movie "Fame is the Name of the Game" (1966). This was the first TV movie ever made as a pilot for a TV series that was subsequently picked up as a series. Although the show was popular with audiences, he was fired after appearing in the first two seasons. The NBC network justified giving him the sack by saying Franciosa's mercurial temper was causing too many problems

on the set. Looking back at his career in a 1996 interview, Franciosa said that he was too young in the late 1950s, too inexperienced to handle sudden stardom. "It was an incredible amount of attention, and I wasn't quite mature enough psychologically and emotionally for it".

He continued to act in supporting roles in large screen movies and in starring roles in TV movies and series until he retired in 1996. He appeared in one last project, "Manifest Mysteries: Coronation" (2006), shortly before his death from a stroke, on January 19, 2006, at the age of 77.
