Coalition To Save Hempstead Harbor Celebrates 30 Years *Carol DiPaolo Is Honored For Her Deep Commitment*

A sell-out crowd of community supporters gathered to celebrate the Coalition to Save Hempstead Harbor's 30th anniversary at the Sea Cliff Manor on Friday night, May 6. "We've come a long way since those early days in the mid-1980s when Hempstead Harbor had the most toxic waste sites of any area on Long Island," said Karen Papasergiou, President of the Coalition. "Who would have thought 30 years ago, that Hempstead Harbor would produce the second largest shellfish harvest on Long Island in 2015?" she continued.

In large part, the remarkable success of the Coalition's efforts was sustained

and guided by its Community Programs Director, Carol DiPaolo, who was--unbeknownst to her--the secret honoree of the night. In 1991 Ms. DiPaolo created the Coalition's award-winning citizens water-monitoring program which tracks a variety of water quality indicators and she has been instrumental in helping other communities set up their own programs. But beyond her expertise, "She is the one who 'saved' the Coalition itself over the years, when board members suffered burn-out," board member Kay Bromberg said. Former Executive Director Lynda

Schroeder added, "Quite simply, Carol is the heart and soul of the Coalition!"

Several public officials attended the dinner and presented proclamations in honor of Ms. DiPaolo including Nassau County Legislator Delia DeRiggi-Whitton, Eric Swenson, Executive Director of the Hempstead Harbor Protection Committee and also representing Town of Oyster Bay, and Sea Cliff Village Trustee Ed Lieberman. North Hempstead Town Supervisor Judi Bosworth also presented a proclamation, but was unable to attend in person. Former Nassau County Executive Tom Suozzi praised the Coalition for staying the course for 30 years and credited it with improving the environment and the quality of life for all the harbor communities and residents.

To commemorate the occasion, Coalition board member Charlie Weinstein created a slide video showing some of the original toxic waste sites and the decrepit state of the harbor 30 years ago. In flashback photos, the video covered the incinerator battles in North Hempstead and Glen Cove, cleanup of Glen Cove Creek, and the gradual progress made through the positive efforts of the water-monitoring program, beach cleanups, and hundreds of volunteers who have contributed time and energy to restoring Hempstead Harbor. The efforts have paid off beyond expectation with the return of whales to the harbor last year and sightings already in April this year.

Well, this summer let's make the effort to jump on the train or hop in the car and hit a play. A must see, "School of Rock The Musical," playing at the Wnter Garden Theatre. My son Kacey is a huge fan of the 2003 movie starring Jack Black. He was apprehensive about seeing the musical based on the hit movie, fearing it wouldn't live up to it... but it did live up to it, and exceeded it with flying colors.

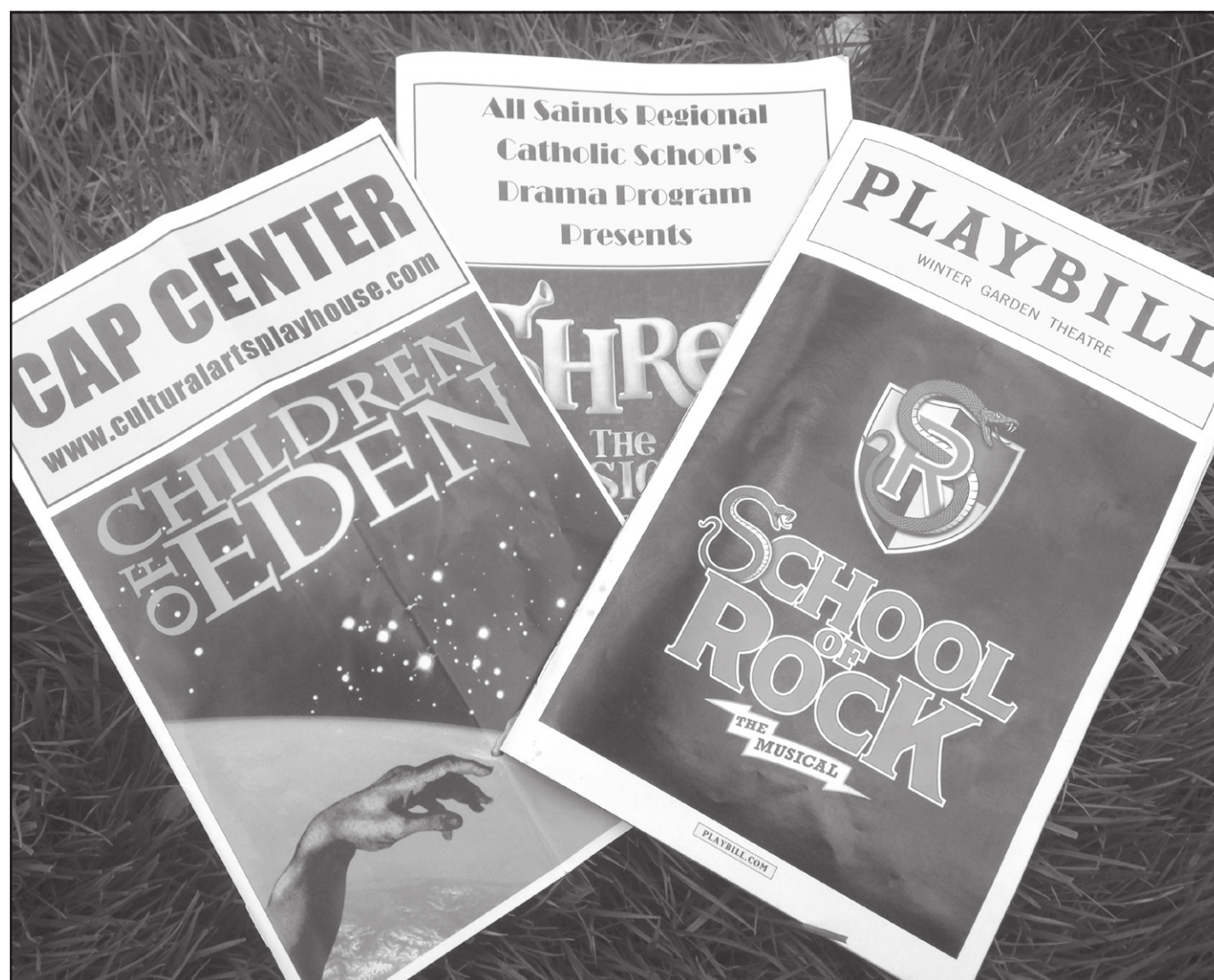

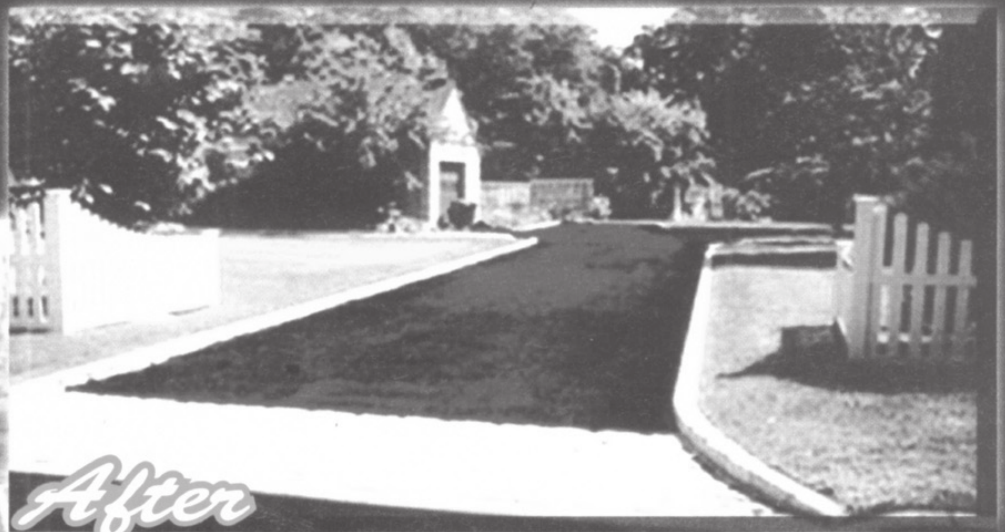

Glen Cove Public Safety Agencies and S.A.F.E. Team Up to Host “Shed the Meds” Collection

May 21st Event Asks Glen Cove Residents to Drop-Off Expired/Unused Medications and Supplies

The challenge of managing drug abuse on Long Island is top-of-mind each day as news headlines share the sad stories of people losing family members to substance abuse. As part of an important line of defense in a community’s war on drugs, the City of Glen Cove, S.A.F.E. (Substance Abuse Free Environment), Glen Cove Police Department, EMS and the Downtown B.I.D. (Business Industrial District) will host their spring “Shed the Meds” event on Saturday, May 21 from 10:00 a.m. to 1:00 p.m. at the Glen Cove Police Department parking lot, 1 Bridge Street.

“Last year we collected well over 500 pounds of prescription drugs (unused, unwanted or expired), medical sharps and waste,” said Mayor Reggie Spinello. “This program like banning hookah bars within our City is about promoting wellness in Glen Cove.” “Prescription and illegal drugs continue to take a devastating toll on many Long Island communities,” said Dr. Sharon Harris, S.A.F.E. Executive Director. “Our bi-annual ‘Shed the Meds’ drug reclamation program helps residents properly dispose of RX medications and medical supplies that are no long needed or have expired and is one of the many tactics we use to tackle drug abuse in our City.” The safe disposal of unused and expired drugs supports the need to eliminate the risk of these drugs getting into the hands of children. This is of critical importance to S.A.F.E., added Dr. Harris. At the event, Glen Cove residents can also learn about the new pharmacy take back laws.

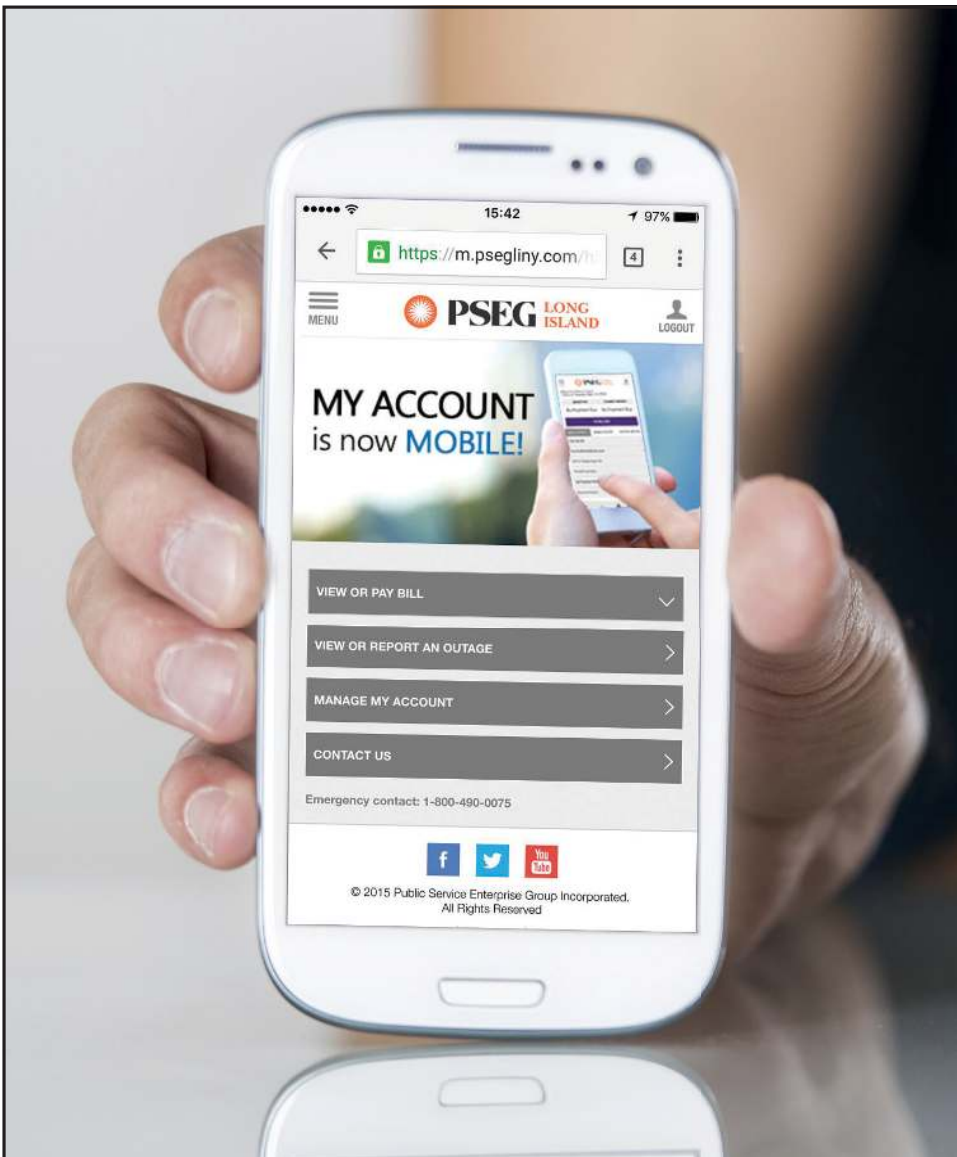

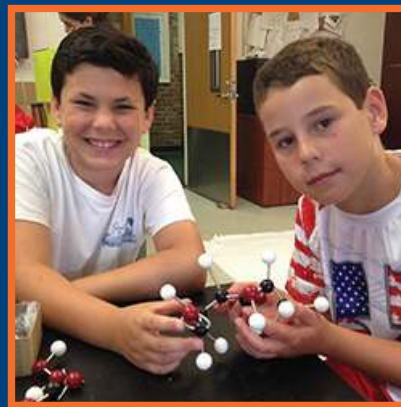

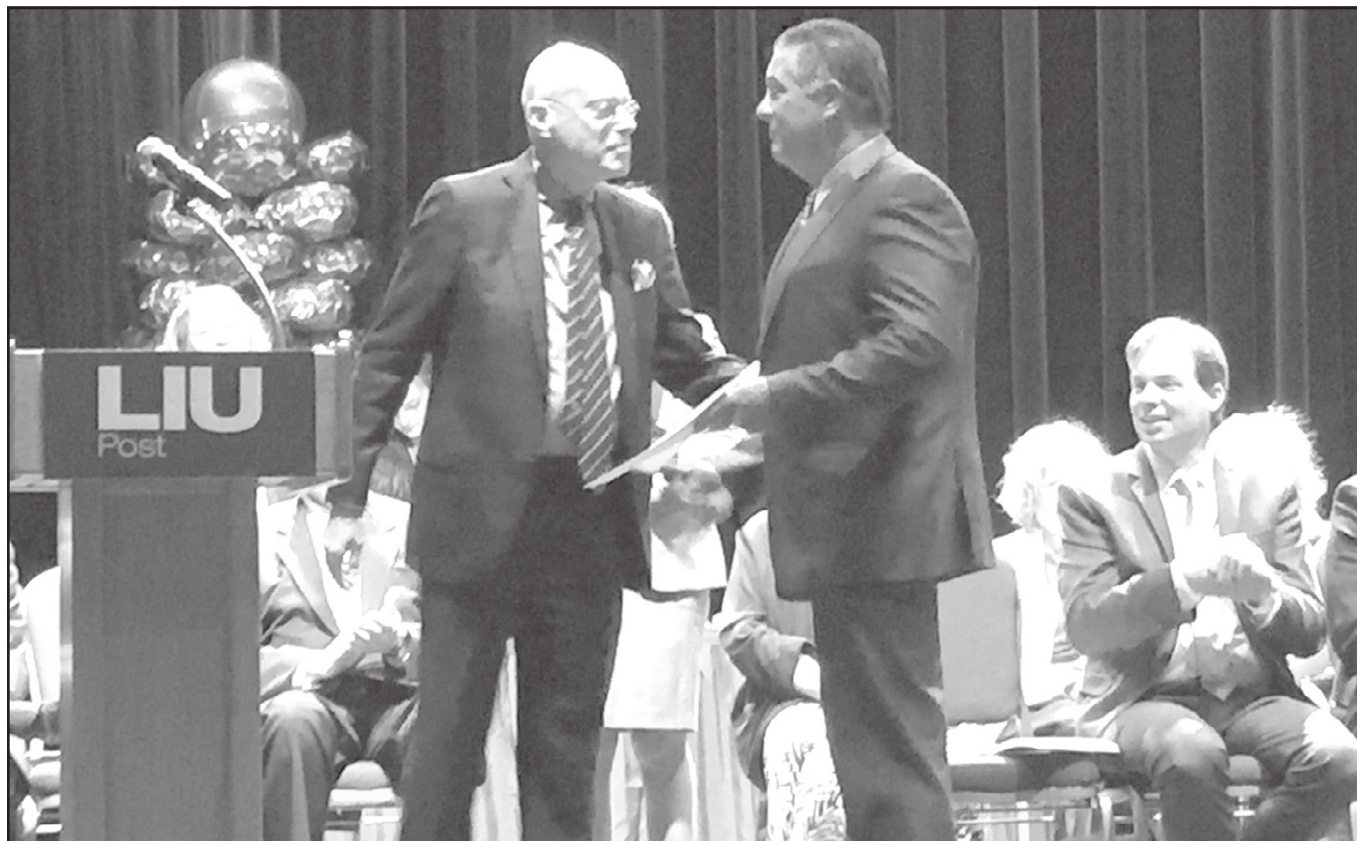

Name the Celebrity



This week's celebrity was born in Los Angeles on Nov. 28, 1923. Early in her high school days, she dropped out to pursue acting. She was signed to a contract with MGM Studios under her professional name after Louis B. Mayer saw her performing on Broadway. She made her film debut in "Blonde Fever" (1944) with Mary Astor and Philip Dorn and then scored one of her most widely praised roles as the promiscuous "Violet" saved from disgrace by "George Baily", played by James Stewart, in "It's a Wonderful Life" (1946). MGM was not able to develop her potential as a star and her contract was sold to RKO Studio in 1947. She was often featured in film noir pictures as a tarnished beauty with an irresistible sexual allure. During this time, she made films for several Hollywood studios. She received an Oscar nomination for Best Supporting Actress for "Crossfire" (1947), the theme of anti-Semitism, as did that year's Academy Award for Best Picture winner, "Gentleman's Agreement". She starred with Humphrey Bogart in the film, "In a Lonely Place" (1950), a performance for which she gained praise. Though today it is considered among her finest performances, it wasn't a box-office hit and Howard Hughes, owner of RKO Studios, admitted that he never saw it. When she asked to be loaned out for roles in "Born Yesterday" and "A Place in the Sun", Hughes refused and instead made her do a supporting role in "Macao" (1952) with Robert Mitchum and Jane Russell. Despite only appearing for a little over nine minutes

on screen, she won the Academy Award for Best Supporting Actress in MGM's "The Bad and the Beautiful" (1952). This was a record at the time for the shortest performance on screen to win an acting Oscar, which was held for 27 years before Beatrice Straight broke it in 1977 for her role as "Louise Schmacher" in "Network" (1976) with Peter Finch.

Last Week's Celebrity

Last week's celebrity was Bruce Bennett. He used his birth name Herman Brix during the filming of "Tarzan". Even though his shoulder injury, which occurred during the filming of "Touchdown" (1930), prevented him from starring in future "Tarzan" movies and replaced by fellow Olympian Johnny Weissmuller, he continued starring in Republic Pictures' serial "Hawk of the Wilderness" and other action films until 1939. Finding himself type cast as "Tarzan" in the minds of movie producers, Brix changed his name to Bruce Bennett, and became a member of Columbia Pictures' stock company. During the next few years, he would be seen playing minor roles in many Columbia films, from expensive dramas to "B" mysteries to "Three Stooges" short subjects, including "How High Is Up?". His screen career was interrupted by WWII, when he served in the U.S. Navy.

Bennett appeared in many films in the 1940s and early 1950s, including "Sahara" (1943) with Humphrey Bogart, "Mildred Pierce" (1945) with Joan Crawford, "Nora Prentiss" (1947) with Ann Sheridan, "Dark Passage" (1947) with Bogart and Lauren Bacall, "Treasure of Sierra Madre" (1948) with Bogart and Walter Huston, "Mystery Street" (1950) with Ricardo Montalban, "Sudden Fear" (1952) with Joan Crawford and Gloria Grahame and "Strategic Air Command" (1955) with James Stewart.

He had five guest appearances on TV's "Perry Mason" and became a very successful businessman in the 1960s. A lifelong parasailer and skydiver, he last went skydiving, from an altitude of 10,000 feet, over Lake Tahoe, at the age of 96. Bennett turned 100 on May 19, 2006, and died less than a year later on Feb. 24, 2007 of complications from a broken hip.

day, Mr. Contorno teaches a Trial and Debate after-school course in order to prepare students for the Mock-Trial Team he advises. He is also the adviser for the high school's Model United Nations club.

Mr. Contorno will receive his award at the Long Island Council for the Social Studies Award Ceremony on June 2 at the Upsky Hotel in Hauppauge.

Superintendent of School Maria Rianna congratulated Mr. Contorno on this tremendous honor, describing him as a "committed educator and wonderful person."

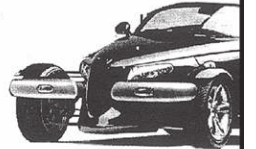

Drastic Departure from Plan **To The Editor,**

On April 26, 2016 the Glen Cove CDA (Community Development Agency) and the IDA (Industrial Development Agency) met in a special joint session. One of the subjects at hand was the "RXR Garvies Point Infrastructure Discussion", item

7B under new business. But in reality this discussion had to do with upcoming LDA (Land Development Agreement) amendments and the acceptance by the Boards of a provider for Tax Incremental Financing (TIF). Chairman Spinello and special counsel Mike Zarin proposed that financing by Citigroup be approved for infrastructure construction such as esplanade, bulkheads and parks. They also stated that there was consideration, to not convey some of the acreage (28 acres) to RXR but to retain ownership of those lands and the amenities to be built by the TIF funds.

The original LDA was signed by Mayor Mary Ann Holzkamp on May 14, 2003, there was one amendment by her administration signed in 2005. There were three amendments to that contract under the Suozzi administration between 2008 and 2012; and there have been four amendments by the current Spinello administration between 2014 and 2015. The Spinello administration is currently defending two lawsuits against the Boards' recent approvals to site plan changes. Further amendments or changes may exacerbate those costs.

Since its inception, the LDA has required the developer to bear all costs, including construction and maintenance for the public amenities and infrastructure, to the proposed redevelopment of 56 acres known now as the Garvies Point Project (previously Glen Isle). They are responsible for all taxes on the same. Should the CDA/IDA retain ownership of these 28 acres, no taxes would be

realized by the City on those lands. Why in the world would the administration and boards amend the contract and offer to take on these expenses, liabilities and reduction in tax revenue to the City when it has always been the intent of the City to get all these lands back on the tax rolls?

City Zoning law allows for a PUD (Planned Unit Development) in the MW3 Waterfront District (280-73.2C3). A PUD is required to have 25 contiguous acres and may include parcels on the north side of Garvies Point Rd at the discretion of the Planning Board. However, with the non-conveyance of approximately 28 acres, the properties are broken up, are no longer contiguous and, at best, add up to 28 acres ultimately owned by the developer. The PUD Zoning allows for 20 units per acre. Should the Planning Board decide that the project is still considered contiguous, does this mean the developer is reducing the density from 1110 units to 480 in consideration of the reduction in acreage?

In addition to the recent site plan amendments and approvals, the new proposal changes the ownership of lands, reduces acreage and subsequently reduces tax revenue from what had been previously presented in the DEIS (Draft Environmental Impact Statement) & FEIS (Final Environmental Impact Statement) during SEQRA review. I have been a supporter of this project for many years but these changes are a drastic departure and more than sufficient for the Planning Board to require a new application and SEQRA review. Otherwise we, the residents are all going to suffer by further subsidizing this project.

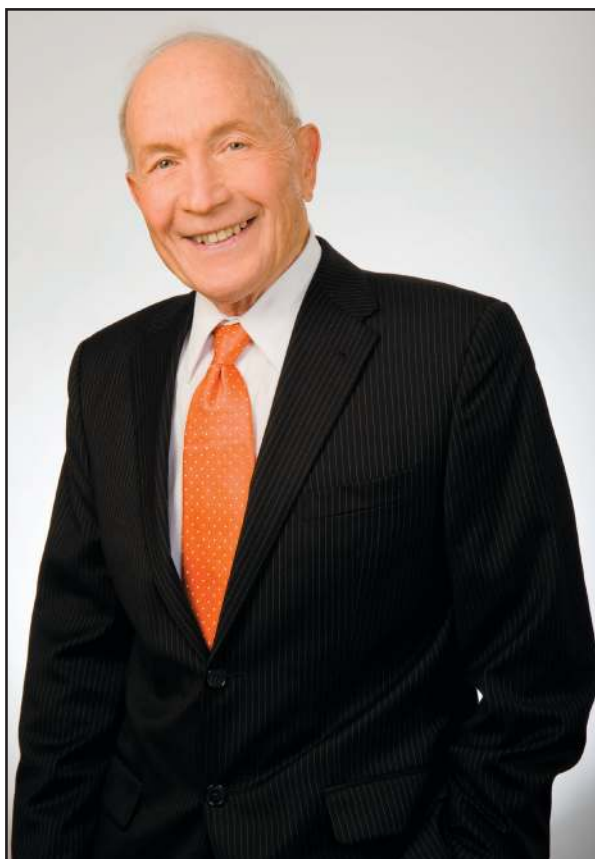
