# Opposition to Garvies Point Development Gains Momentum

Area residents gathered on two separate occasions in the past two weeks to protest the development of the Glen Cove Waterfront as proposed. With two separate cases filed in New York State Supreme Court against the City of Glen Cove, the Glen Cove Planning Board, and the Glen Cove IDA/CDA still undecided; the opposition over the 1.8 million square feet of new development at the waterfront continues to grow. The current plan for the waterfront includes 1,110 residential units which will make up for 1.725 million square feet of the project plus another 75,000 square feet of combined commercial and retail space.

Two rallies organized by the Committee for a Sustainable Waterfront against the development plan have been held in the past two weeks. On Sunday May 15th over 200 people carrying signs and wearing T-shirts condemning "overdevelopment" marched from Memorial Park in Sea Cliff to the beach to protest RXR's plans for the North Shore. At the beginning of the rally Amy Marion, a Sea Cliff resident and attorney for the private plaintiff litigants made a

## Sea Cliff Yacht Club takes on Sailing Goliaths

Sea Cliff Yacht Club, nestled on the shore of Hempstead Harbor, is going head to head against some of the biggest and most preeminent Yacht Clubs in America. This fall a team of Sea Cliff YC members will compete in the New York Yacht Club's prestigious Resolute Cup, a Corinthian Championship for

US Yacht Clubs, to be held in Newport R.I. Sea Cliff is one of only 30 yacht Clubs invited to enter this year's regatta. Our local area sailors will be going up against world renown Clubs such as Southern Yacht Club (New Orleans), St. Francis YC (San Francisco), San Diego YC, Eastern YC (Marblehead, Mass), the Chicago YC and New York Yacht Club to name a few.

The Resolute Cup fleet will compete in fleet racing in one design keel boats, Sonars and Melges 20s. Racing is Sept 12th through Sept 17th in Narragansett Bay, off of Newport. The Sea Cliff Yacht Club team is led by team captain Doug Wefer, a 4-time collegiate All-American sailor. Sea Cliff knows it will be up against some stiff competition. Doug Wefer says,

"The Resolute Cup will be a great test for our team. The talent in the regatta will be deep and the format will make racing very close with no room for error. It will be a lot like college sailing but in a fleet of 30."

Planning to prepare for this challenge has already begun. A special committee entitled TEAM SEA CLIFF has organized the campaign. Practice boats are being secured; training sessions underway and Club members have assumed duties to support this effort so this "family friendly" Club can hold its

own against these sailing giants.

SCYC Commodore Jim Arnemann states "Sea Cliff has long been involved in sailing competition. We have a lively Junior Sailing program, Club races and team races against neighborhood Clubs, and we have our signature event, the Around Long Island Regatta. The Resolute Cup lets us step up and go against some of the best sailors in the country. This is quite an honor for our small Club."

The Resolute Cup will test sailing skills. It will take a mastery of tactics, boat speed and team work to show well in Newport. The Sea Cliff Yacht Club believes they are up to the challenge. # Opposition to Garvies Point Development Gains Momentum

speech deriding Glen Cove officials for having consistently ignored residents' concerns. "They have repeatedly lied to the people. They have misled the public in their studies, statements, and promotion of this outrageous plan. We are not against competent development, but we do not support what is sure to be the destruction of our quality of life," Marion said. Following Marion's speech a peaceful procession began down Prospect Avenue and Cliff Way to the beach, a stone's throw from the Garvies Point site.

As the hundreds of people walked they chanted "High Density – High Traffic," "Suburban Not Urban" and "Don't Wreck It Rechler" (referring to RXR Chairman Scott Rechler). At Sea Cliff Beach the marchers formed a human chain along the waterfront and were greeted by a speech by Roger Friedman, one of 105 resident plaintiffs in the lawsuit. "The wrong things are happening at Garvies Point. This isn't smart development, this is overdevelopment; this is simply a bad idea. The alleged financial benefits have consistently been misrepresented with Mayor Spinello misstating the city's published studies. Recent reports by the EPA and DEC state that the ground they are planning to build on is still poisonous. These government agencies are putting too much trust in the City and RXR. You're relying on people who stand to make a lot of money on the development," Friedman said. "I moved from Brooklyn to escape city living.... Now Spinello wants to make the North Shore look and feel like Flushing."

Sea Cliff Mayor Bruce Kennedy took the microphone and thanked the crowd for coming out to speak their minds on

the RXR plan. He said, "This is your community and you deserve a voice, you deserve to be heard. Reggie Spinello has called you all NIMBY's and nay-sayers, I say you are stakeholders. This is your community and you should never let government step on you or ignore you." Kennedy concluded by telling the crowd that Glen Cove money didn't fund the considerable cleanup that has occurred since 1999, the vast majority was Federal and State tax dollars, "It was your tax dollars that funded the cleanup efforts so you have already paid to have a place at the table."

The second rally was held in front of the RXR welcome center on May 18th. In what had been promoted as a "Wine & Cheese Ribbon Cutting Ceremony," turned out to be a large protest outside the RXR welcome center on Herb Hill Road. Over 50 people standing in the light rain held signs opposing the development

plan greeting individuals who arrived in Mercedes and Maserati's. When Glen Cove Mayor Spinello arrived he was met with the mantra of "Hey hey ho ho, Reggie Spinello has got to go." Glen Cove resident and historian Joan Harrison said, "I'd like to see the City respect its history, this is a complete betrayal." Glen Cove resident Maureen Tracy called the plan "gross overdevelopment" and Glen Cove resident Amy Peters declared that, "This is not the type of development that Long Island needs in fact it is unprecedented and unsustainable."

Representatives of Vision Long Island, a pro-development organization whose printed mission is to support smart growth communities, had representatives at the gathering. Glen Cove resident Jon Lauter suggested the organization should be renamed, "Lack of Vision Long Island." How can you call this smart growth? It is nowhere near public transportation, it is

far outside downtown, it has virtually no retail or mixed use, and the whole process ignored input from local stakeholders." Sea Cliff Mayor Bruce Kennedy attended the protest and said, "I am bewildered by what is going on here. It is the epitome of arrogance that Reggie Spinello is holding a ribbon cutting ceremony when there are currently two lawsuits seeking to overturn the decision of the Glen Cove Planning Board. I urge Mayor Spinello and Scott Rechler to honor our 16 year old contract that limits the overall development to 700,000 square feet with building heights limited to 65 feet. This agreement is actually one of the terms in the land sale contract between Glen Cove and RXR."

Plaintiff's attorney Amy Marion stated emphatically, "This is a water issue, it is an environmental issue, it is a traffic issue; it is an utter disaster for the North Shore of Long Island. This is not over and we will not be silenced."

## Mayor's Column

*Mayor's Column

After months of weekly 2-page advertisements by RXR promoting their plans for Garvies Point, I am compelled to address its ambiguities. Every one of these ads show lots of open space, trees, boats, kayaks, and people enjoying the natural environment. What the artist's renderings do not show is buildings; huge buildings that will be the focal point of this project. They also do not depict the traffic backup that will start at the Hempstead Harbor Club and will continue for over 5 miles to Northern Boulevard in three different directions through Glen Cove, Sea Cliff, Glen Head, Brookville, Locust Valley and Brookville. They don't depict the intolerable amount of air, water, noise and light pollution that will result from the RXR plan.

The Village of Sea Cliff does not oppose re-development of the waterfront but we are simply asking it be done in a sensitive way that doesn't threaten to destroy all that we love about our community. Over the years, Sea Cliff has repeatedly expressed concerns for the potential of the Garvies Point development plan to negatively alter the collective character of our communities and adversely affect the environment of the residents living near Hempstead Harbor. Unfortunately, the recent actions of the Glen Cove Planning Board seem to indicate that our concerns and the concerns of many Glen Cove residents are irrelevant.

All that Sea Cliff is asking is that Mayor Reginald Spinello honors a 16-year old agreement with our village and that RXR honor its land sale agreement with Glen Cove. Back in 2000, as the result of a different lawsuit in regard to the development of this same property, Sea Cliff and Glen Cove reached a

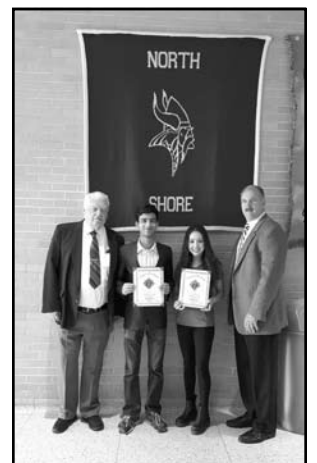
settlement in the form of a written and signed agreement. The purpose of the Memorandum of Understanding was to establish a framework for the Village and City to work together in a spirit of cooperation to achieve the most beneficial outcome for Glen Cove and the entire North Shore community. Parameters included limiting the total density of the development to 700,000 square feet and the maximum height of the buildings to 65 feet. Furthermore, the City committed to give the Village due notice of any public meetings scheduled with regard to development in the Waterfront Revitalization Area. This Memorandum is stipulated on page 17 of in the contract of sale from the City to the developer, so it is disingenuous to say this agreement is a surprise to any of the parties.

The City attorney and RXR's attorney have both acknowledged the signed agreement but claim that it is unenforceable. I beg to differ with their assessment which is a portion of the ongoing lawsuits. It is the opinion of the Village that this agreement was entered into in good conscience after months of fair dealings between the parties. This was an agreement that all parties established was equitable and I still believe is reasonable. Mayor Spinello has stated repeatedly that he believes that opponents to this plan will eventually come around to his way of thinking but he is mistaken. This current plan is bad for Sea Cliff, Glen Cove and our surrounding communities. That land is currently an open canvass that could be something terrific for future generations if some vision and imagination were exercised. Jobs could be created, revenues could be generated and the environment could be respected all at the same time.

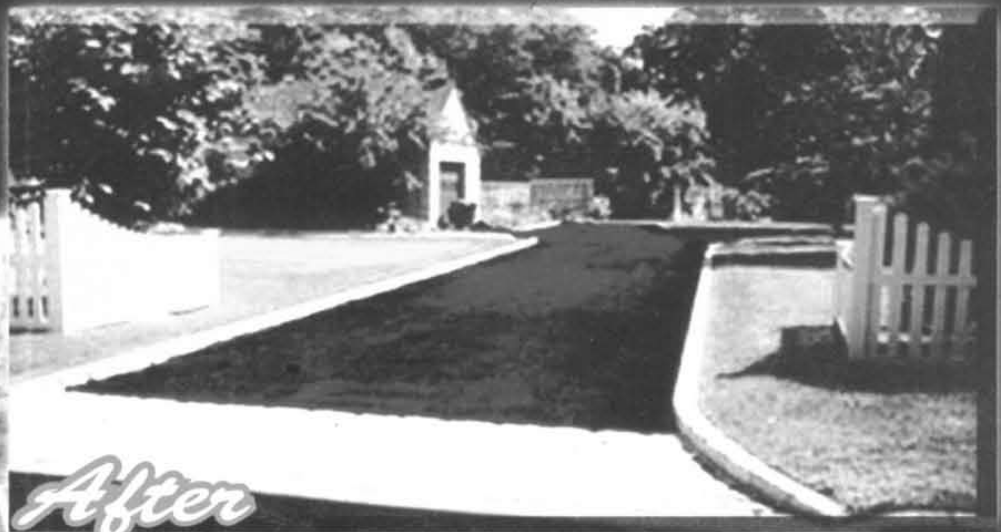

said Makaela.

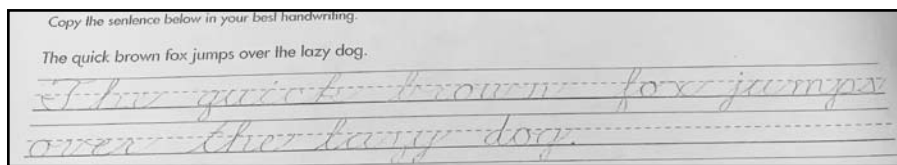

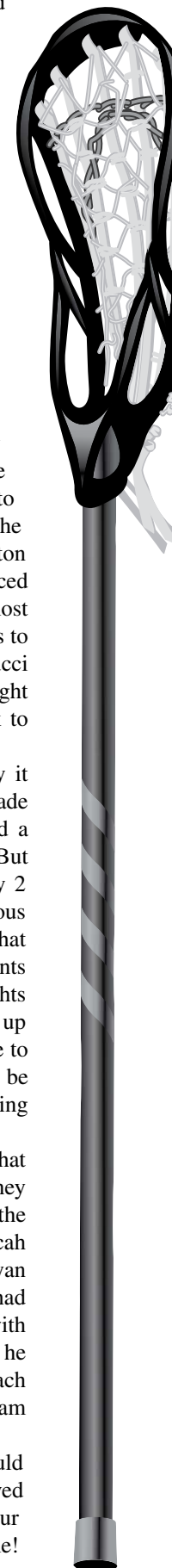

# Name the Celebrity



This week's celebrity was an American film actor who was born on June 17, 1908 in St. Louis, Missouri. His beefy, square jawed features usually cast as a heavy or villain throughout his career. He started his career as a comedian in vaudeville and appeared on Broadway from the late 1920s. His film career included "Captains Courageous" (1937) with Spencer Tracy, Lionel Barrymore and Freddie Bartholomew, "The Fighting 69th" (1940) with James Cagney and Pat O'Brien, "Yankee Doodle Dandy" (1942) again with Cagney, and "The More the Merrier" (1943) with Jean Arthur, Joel McCrea and Charles Coburn. This film was remade as "Walk, Don't Run" (1966) with Cary Grant, Samantha Eggar and Jim Hutton, which was Grant's last film. Our celebrity also did four films with the Three Stooges: "Pardon My Backfire" (1953), "Fling in the Ring" (1955), "Guns a Poppin'" (1957) and a "A Merry Mix-Up" (1957). In the last film, "A Merry Mix-Up", the Stooges played 9 brothers, who were all WWII veterans, who live in the city but have lost track of each other. Our celebrity played the nightclub waiter who walks in and sees all nine brothers simultaneously withing minutes of the wives of the married brothers show-up, thinking their husbands are cheating on them. The

film was especially remembered for the major oversight Columbia Pictures made when posters and displays were featured nation-wide in advertising the film's release. Columbia listed the Stooges as "Shemp", Larry and Joe (Besser), omitting Moe entirely. Shemp had died two years earlier.

Last week's celebrity was born Roy Barnes Jones but was professionally known as Roy Roberts. His early career was on the Broadway stage gracing such plays as "Old Man Murphy" (1931), "Twentieth Century" (1932), "The Body Beautiful" (1935) and "My Sister Eileen" (1942). In 1943, he made successful switch to films debuting as a Marine officer in "Guadalcanal Diary" (1943). He was usually billed around the tenth in the credits. He played a reliable succession of stalwart roles including captains, generals, politicians, sheriffs, and judges. When Roberts made the move to TV, he began to include more work in comedies. The 1950s and the 1960s would prove him to be a most capable foil to a number of prime sitcoms with Gale Storm, in "Oh, Suzannah!" as the Captain, with Zasu Pitts and "The Lucille Ball Show". His patented gruff and exasperated executives often displayed their prestige by the mere use of initials such as "W.W." and "E.J." way before "J.R." was "J.R.". While he never landed the one role on film or TV that could have led to top character stardom, he nevertheless remained a solid and enjoyable presence, a character player who added stature no matter how far down the credits list. He had gained a considerable amount of weight in the 1970s and he died of a heart attack on May 28, 1975 at the age of 69.

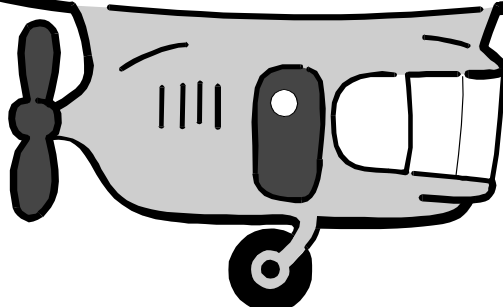

# GVS Students Shine During A "Knight" of Science

On May 10, the Green Vale School celebrated A "Knight" of Science, an all-star exhibit where students from 1st to 8th grade showcased various projects for faculty, family and friends. This was the fourth straight year Green Vale and its community hosted a school-wide STEM event. Green Vale, whose official school mascot is a knight, continues to be at the forefront of students' study of science, technology, engineering and math with its strong partnerships with the Brookhaven National Laboratory and the Cold Spring Harbor Laboratory.

"A 'Knight' of Science is a celebration of our students' excellent work in the fields of science, technology, engineering and math," Science Department Chair Dr. George Pasquale said. "It's an opportunity for our students to demonstrate creative ways of applying concepts they've learned to real world situations. # 2015 drinking water quality report

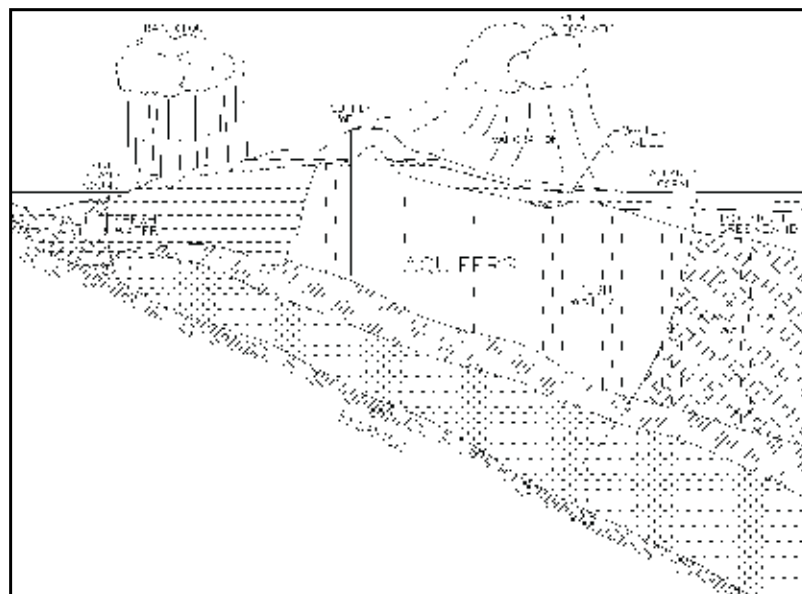

## SOURCE OF OUR WATER

The source of water for the City is groundwater pumped from four (4) wells located throughout the community that are drilled into the aquifers beneath Long Island, as shown on the adjacent figure. Generally, the water quality of the aquifers is good to excellent.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants.

In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.



THE LONG ISLAND AQUIFER SYSTEM

The population served by the City of Glen Cove during 2015 was 28,000. The total amount of water pumped by the City in 2015 was 1.53 billion gallons, of which approximately 90 percent was billed directly to consumers.

The remaining un-metered water is from uses such as municipal and public school facilities, fire fighting, hydrant flushing, main breaks and undetected service line and water main leaks.

## WATER TREATMENT

The Water Department treats the water supply before it enters the distribution system. A small amount of chlorine is added to assure the water maintains its bacteria-free quality. Our water is also treated with sodium hydroxide to increase its pH to reduce its corrosivity before it enters the distribution system. This treatment reduces the leaching of copper and lead from household plumbing. Source water from the Kelly Street well is treated by air stripping to remove various volatile organic chemicals. Source water from the two (2) Duck Pond Road wells are treated by granular activated carbon filters to remove various organic chemicals and pesticides. All treatment is approved by and in strict accordance with Nassau County Department of Health standards.

## WATER CONSERVATION MEASURES

The underground water system of Long Island has more than enough water for present water demands. However, saving water will ensure that our future generations will always have a safe and abundant water supply.

In 2015, the City of Glen Cove continued to implement a water conservation program in order to minimize any unnecessary water use. The pumpage for 2015 was approximately 6% greater than the pumpage for 2014.

Water supply management has long been a practice in Glen Cove. Over the last 20 years, the city has initiated numerous programs geared to reducing water usage. Obviously, continued water conservation efforts will be required to maintain ample supplies.

Some of the major water conservation measures implemented by the City are:

Water Conservation Ordinances – local ordinances have long been in effect to restrict non-potable water use during periods of peak demand, such as Summer periods and fire emergencies. In 1987, the City, in an effort to promote conservation, amended its municipal ordinances and adopted stricter regulations related to:

- Water sprinkling (odd/even) hours are 5:00 a.m. to 9:00 a.m. and then again from 4:00 p.m. to midnight. There is NO watering permitted on the 31st of any month. Sprinkler systems must be equipped with a backflow device and rain sensor.
- Car washing – only self closing shut off valved hose permitted for use.
- Water saving plumbing fittings and fixtures are required on all new residential and commercial construction and in certain alterations and additions to existing construction.

## SOURCE WATER ASSESSMENT

The NYSDOH, with assistance from the local health department, has completed a source water assessment for this system, based on available information. Possible and actual threats to this drinking water source were evaluated. The source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how rapidly contaminants can move through the subsurface to the wells. The susceptibility of a water supply well to contamination is dependent upon both the presence of potential sources of contamination within the well's contributing area and the likelihood that the contaminant can travel through the environment to reach the well. The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become contaminated. See Section entitled "Water Quality" for a list of the contaminants that have been detected. The source water assessments provide resource managers with additional information for protecting source waters into the future.

Drinking water is derived from four (4) wells (Duck Pond (2), Nancy Court and Kelly Street). The source water assessment has rated all of the wells as having a low susceptibility to potential sources of contamination. However, due to the highly sensitive characteristics of the aquifer, continued vigilance in compliance with water quality protection and pollution prevention programs as well as continued monitoring and enforcement will help to continue to protect groundwater quality.

A copy of the assessment, including a map of the assessment area, can be obtained by contacting the City Water Dept.

## WATER QUALITY

In accordance with State regulations, the City of Glen Cove routinely monitors your drinking water for numerous parameters. We test your drinking water for coliform bacteria, turbidity, inorganic contaminants, lead and copper, nitrate, volatile organic contaminants, total trihalomethanes and synthetic organic contaminants. Over 135 separate parameters are tested for in each of our wells numerous times per year. Over 5,000 tests are taken each year from the distribution system and supply wells. The table presented on page 3 depicts which parameters or contaminants were detected in your drinking water. It should be noted that many of these parameters are naturally found in all Long Island drinking water and do not pose any adverse health affects.

## COST OF WATER

Our residential rate structure for each 3 month period is as follows: \$2.36 per 1,000 for the first 45,000 gallons, \$2.66 per 1,000 gallons for the next 45,000 gallons, and \$2.95 per 1,000 gallons for usage over 90,000 gallons.

The City of Glen Cove Water Department conducts over 5,000 water quality tests throughout the year, testing for over 130 different contaminants which have been undetected in our water supply including:

**Definitions:**

**Maximum Contaminant Level (MCL)** - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.

**Maximum Contaminant Level Goal (MCLG)** - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Action Level (AL)** - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow. **Milligrams per liter (mg/l)** - Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).

**Micrograms per liter (ug/l)** - Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).

**Non-Detects (ND)** - Laboratory analysis indicates that the constituent is not present.

**pCi/L** - pico Curies per Liter is a measure of radioactivity in water.

<sup>(1)</sup> - During 2014, we collected and analyzed 30 samples for lead and copper. The 90th percentile level is presented in the table. The action levels for both lead and copper were not exceeded at any site tested. Resampling is scheduled for 2017. 90th Percentile Value: The values reported for lead and copper represent the 90th percentile. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the lead and copper values detected at your water system.

<sup>(2)</sup> - Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask advice from your health care provider.

<sup>(3)</sup> - The Food and Nutrition Board of the National Research Council determined an estimated safe and adequate daily dietary intake of manganese to be 2,000-5,000 micrograms for adults. However, many peoples diets lead them to consume even higher amounts of manganese, especially those who consume high amounts of vegetables or are vegetarians. The infant population is of the greatest concern. It would be better if the drinking water were not used to make infant formula since it already contains iron and manganese. Excess manganese produces a brownish color in laundered goods and impairs the taste of tea, coffee and other beverages. Concentrations may cause a dark brown or black stain on porcelain plumbing fixtures. As with iron, manganese may form a coating on distribution pipes. These may slough off, causing brown blotches on laundered clothing or black particles in the water.

<sup>(4)</sup> - No MCL has been established for sodium. However, 20 mg/l is a recommended guideline for people on high restricted sodium diets and 270 mg/l for those on moderate sodium diets.

<sup>(5)</sup> - Perchlorate is an unregulated contaminant. However, the State Health Dept. has established an action level of 18 ug/l.

<sup>(6)</sup> - MCL is for combined Radium 226 and Radium 228.

<sup>(7)</sup> - UCMR3 - Unregulated Contaminant Monitoring Rule 3 is a Federal water quality sampling program where water suppliers sample and test their source water for 1 year. Results will be used by the USEPA to determine if the contaminants need to be regulated in the future.

The City of Glen Cove routinely monitors for different parameters and contaminants in your drinking water as required by Federal and State laws. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk. For more information on contamination and potential health risks, please contact the USEPA Safe Drinking Water Hotline at 1-800-426-4791.

During 2014, the District collected 30 samples for lead and copper. The next round of samples will occur in 2017. If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. The City of Glen Cove is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline (1-800-426-4791) or at <http://www.epa.gov/safewater/lead>.

Some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. With this in mind, the Department of Public Works had undertaken an internal audit of all water department facilities, mechanical systems and delivery infrastructure. Immediate needs for operational and mechanical improvements have been determined and the City will be performing major improvement projects for the 2016 period. Improvement projects will include upgrading the City's transmission main to provide service to the waterfront redevelopment project area.

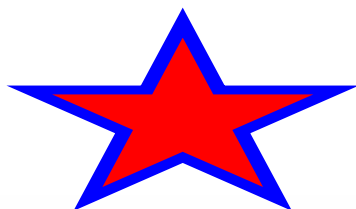

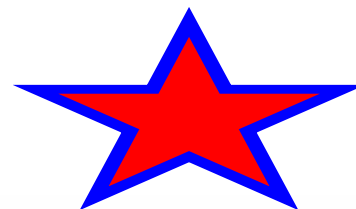
