Despite Rain, Village Honors Veterans

The threat of a tropical storm may have caused the cancellation of Sea Cliff's annual Memorial Day Parade but didn't dampen the spirit of the Day of Remembrance. At 12 noon a crowd, led by James F. Brengel American Legion Post Commander Phil Como, formed in Memorial Park to ensure the real meaning of the day was observed.

The service began with Reverend Kirtland Watkins, minister of the United Methodist Church of Sea Cliff, offering a moving benediction where he put familiar faces on the fallen soldiers that died in service of our country. At the conclusion of the Reverend's remarks, resident and professional singer Catherine Virgillio

sang a heartfelt acapella version of America the Beautiful.

Mayor Bruce Kennedy then stood before the decorated monument with the names of Sea Cliff residents who died in WWII, the Korean and Vietnam wars. He paid honor and respect to the men and women who made the ultimate sacrifice and gave their lives defending our nation. He picked up on the personal nature of the service that was initiated by Reverend Watkins stating "the fallen soldiers we honor today were children of fathers and mothers, they were brothers and sisters and some had spouses and

children of their own". He asked that we, as a people, had the duty to work to repair the nation these soldiers died for. Phil Como then shared the story of James F. Bregel (1883-1918); a Sea Cliff resident and son of an American Civil War veteran. Bregel served as Chief of the Sea Cliff Fire Department and worked for NY Telephone Company before joining the American Expeditionary Force. He was posted in France where he perished leaving behind a widow and infant son, his namesake, whom he never had the opportunity to meet. James F. Bregel Jr. was raised by his mother in Sea Cliff where he attended school and followed

in his father's footsteps by joining the Fire Department. He attended St. Johns University and became an accountant before joining the US Army in 1943. He was posted in Southern France where he gave his life for his country on October 22, 1944. Commander Como concluded his statements with a reading of the poem Flanders Field. The solemn ceremony concluded with two middle school students playing Taps and Catherine Virgillio leading the observers in the singing of God Bless America.

Glen Cove Teen Earns Photography Scholarship

Joseph Stoppel, a 13-year-old eighth grader from Glen Cove, was awarded a scholarship to the Center for Railroad Photography And Art's annual conference, "Conversations 2016", on the basis of his photographic work and his enthusiasm for the field of rail photography. Joe served as a docent at the conference, which was held at Lake Forest College in Illinois, just north of Chicago, on the weekend of April 8-10, and was attended by many distinguished railroad photographers and historians, including Ron Hill, Steve Patterson and Emily Moser.

Joe, a student at Iris Wolfson School in Greenvale, has been photographing trains and railscapes for years. Last fall he took a class at the New York Transit Museum called "Art on the Tracks", in which he and other teens visited abandoned subway and train lines and documented their visions on camera. A subsequent exhibition of their work, including Joe's "Freight Line on the Hudson", is now on display at the museum in Brooklyn through September.

It was the teacher of that class, John Sanderson, who encouraged Joe to apply for the conference scholarship. A nationally-known rail photographer, Sanderson was a featured speaker at the conference, presenting the keynote talk "Railroad Landscapes", which explored the evolving dialectic of the railroad and the natural landscape. Mr. Sanderson will

be running another "Art on the Tracks" class this May.

As one of three docents chosen for the scholarship (the others were Ryan Gaynor of Toronto and Aviva Gellman of Madison, Wisconsin) Joe received free

registration, lodging and travel expenses, and the chance to absorb and appreciate the talent and wisdom of professional photographers who share his passion. The experience is one he will always treasure. "I had a wonderful time in

Chicago. It was a great opportunity to get the perspective of other artists from across the country. I feel inspired to continue my photography with a new outlook on the art."

Possessing a strong work ethic, dedication, and a creative mind, Kate Weseley-Jones has excelled as a member of North Shore Middle School's Science Research Club. Kate has dedicated a great amount of time and effort to her science research project, entitled A Graph is Worth 1,000 (Misleading?) Words, and it has paid off. Kate's research project entailed several surveys in which she presented graphs to viewers focusing on how truncation of the y-axis on a graph affected how viewers interpreted the results of the graph. This phenomenon is seen often in the media where the aim is to mislead the viewer by misrepresenting the data or statistic being shown. Kate's goal was to study how falsely advertising data or statistics could affect viewer interpretation of results.

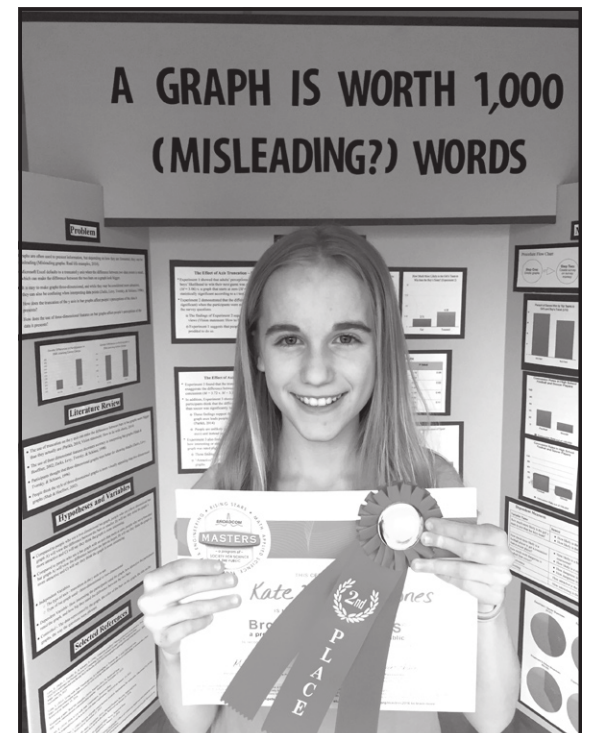
Kate has participated in both the prestigious Long Island Science and Engineering Fair (LISEF) and the Long Island Science Congress (LISC). In order to participate in the science competitions Kate spent numerous hours both in and out of school planning and conducting her research, composing a research paper, running statistical analyses to determine the significance of her results, and creating a presentation for the competition's judges. At the

competitions, Kate had the opportunity to present her research to each of three judges.

Kate earned second place at the Long Island Science and Engineering Fair and is still awaiting the results from the Long Island Science Congress. Kate's second place triumph allowed her the opportunity to apply to present her research at the Broadcom MASTERS (Math, Applied Science, Technology and Engineering Rising Stars) national competition. Only the top 10% of 6th, 7th, and 8th grade participants are nominated to enter the prestigious national competition. Teacher Leader for Math & Science, Ms. DiMeola said, "Kate has been a pleasure to work with throughout the research process and I look forward to all that lies ahead for her."

Speed Cameras Gone? Not So Fast.

To The Editor,

It might be recalled that Nassau County residents (especially the ones who vote) rose up in arms over the surreptitious installation of speed cameras around schools in the County that were put up under the guise of a non-existent safety program to protect our kids. Everyone knew it was a phony play on their part. The politicians didn't have the guts to cut spending or raise taxes, so they did what they always do when they want to cover their financial ineptitude – they found a way to screw the public without calling it a tax raise. They put up speed cameras, having learned that they could increase revenues by \$30 million dollars off the backs of unsuspecting motorists.

This sort of revenue raising ploy is among the worst kind of abuse in which politicians regularly engage. The people it affects the most are those among us who can afford it the least. The guy who makes \$25,000 a year pays the same fine (essentially a tax) as the guy who makes \$250,000. That's called a “regressive” tax. Most everyone is familiar with the concept where the more you make, the more income tax you pay and the higher the rate as your income increases. That's a “progressive” tax. We may not like paying taxes, but at least the concept is fair.

Over the past 10 or 15 years, politicians have discovered how to raise money by raising every kind of fee you can imagine. The mother of all increases

may have been the 1,000% increase that Tom Suozzi stuck gun owners with when he was first elected as County Executive and promptly raised the pistol permit fee from \$20 to \$200.

Not long ago, our esteemed County Legislature invented a new document mysteriously called a Tax Map Verification Certificate which is required to be purchased in order to record all real estate documents filed with the County Clerk. The fee for this bogus document was originally \$75. Now, the Legislature has raised that fee 300% to \$225, and if you record more than one document, you have to pay it for each document that gets recorded. In addition, the Nassau County Legislature has doubled the fee for recording a mortgage from \$150 to \$300. As a result, fees on the sale of a home have gone up hundreds, and for some homeowners thousands, of dollars. Just to sell your house!

You see, the way it works is this. Most people who vote are not going to be selling a home. So, instead of hitting all the voters who will object, why not stick it to just a few, but do it big time. It's estimated that this latest money grab will raise about \$36.5 million and most people won't even know their Legislator did it until they try to sell a home.

When the invidious speed cameras came in, everyone was affected in some way because just about everyone knew that they had to slam on their brakes to instantly drop their speed from 40 or 45 mph to 25 mph if you came upon a school zone. If you woke up to late – bam! - \$80 ticket. The public went wild. There wasn't a Legislator anywhere who could go to the supermarket without being accosted by an angry constituent. So what did they do? Yep, they repealed the law because they knew they couldn't get re-elected if it stayed on the books. Now, of course, they've replaced it by moving the problem to people selling real estate.

The important thing is, however, that if you've been driving around the County as of late, you may have noticed that while the school speed trap law has been repealed, the cameras haven't been removed. Wonder why? Simple. Our Legislators are just waiting until the climate is right before they once again impose the speed trap cameras on us. A public that doesn't pay attention is a sitting duck for these people.

I think it would be perfectly reasonable for residents of this area to ask our Legislators Donald MacKenzie and Delia DeRiggi Whitton to spend more time figuring out how to stop wasting taxpayer money and covering that waste with these incessant fee increases. If they want voters to believe they're serious, the first thing they can do is to get rid of those school speed trap cameras. Otherwise, it's just a matter of time until they slip them back on line.

I, for one, will not vote again for my Legislator if this trend continues. I may

vote for him if I see those cameras taken down. I wholeheartedly recommend to my fellow voters that they do the same. I don't know why we keep sending these people back time after time when it's so clear that they're working for themselves, not for us.

Water Quality Issues?

To The Editor,

Last week, the New York State Department of Environmental Conservation issued a “Notice of Cleanup Decisions” regarding Captain's Cove which is a parcel of land that is a part of the Garvies Point proposed land development.

According to the DEC's decision, the remedy will be “an enhancement of the excavation conducted earlier to reach site-specific soil cleanup levels necessary to achieve groundwater standards, and to revise soil cover requirements to allow restricted residential use for the site. Under this remedy, isolated hot spots of arsenic and lead soil contamination will be removed and disposed of properly.”

This exact quote from the DEC's decision, unequivocally demonstrates, proves, and supports the arguments in the lawsuit filed by over 100 residents which claim that the site was not cleaned up to “site-specific cleanup levels”, the soil was not suitable for restricted residential use as claimed by the City of Glen Cove, and “hot spots” exist which contain contaminants which need to be removed – these facts have been continuously denied by the City of Glen Cove.

Furthermore, on May 16, 2016, the Town of Oyster Bay sent a letter to the City of Glen Cove which equally supports the arguments in the residents' law suit and confirms the very reason for the filing of the Article 78 petition in the first place – a Supplemental Environmental Impact Statement (SEIS) is required.

As stated by the Town of Oyster Bay, “It does not appear that the impacts of the project amendments on water quality have been adequately addressed, in terms of stormwater management, including imperviousness bordering ecologically sensitive tidal wetlands, and measures to mitigate same.” The Town, through its expert consultants, states that “We do not believe that this project should be held to the lowest possible standard for stormwater management given the size of the development and associated magnitude of stormwater runoff volume, and the site's location adjoining critical coastal resources.” Thus, the Town maintains that the impacts of the project amendments on water quality have not been adequately addressed and that stormwater management plan for this project is not competent – these are the very reasons that SEQRA (State Environmental Quality Review Act) requires a SEIS.

Additionally, the Town of Oyster Bay states that “it would be beneficial if elaboration were provided to demonstrate that the project will achieve the necessary levels of remediation to prevent public exposure and environmental impacts due to site contaminants.” Once again, these

statements of the Town establish the residents' claims that SEQRA requires a SEIS when it has not been demonstrated that “the project will achieve the necessary levels of remediation to prevent public exposure and environmental impacts due to site contaminants.”

Finally, the Town of Oyster Bay notes that during the SEQRA process for the original application, the Town “asked about project-related impacts at the intersection of Northern Boulevard (NYS Route 25A) and Glen Cove Road. The response in the Final Environmental Impact Statement (FEIS) indicated that adequate mitigation was not practicable to address project-related impacts, and that the project would contribute to deteriorated operating conditions at this location.” The Town states that it “would be helpful to know whether this conclusion may have been altered in the intervening years – e.g., by new data, changes in background conditions circumstances, etc. – either in a positive or negative direction” thus, once again proving that an SEIS is required. Disturbingly, the Town of Oyster Bay was provided with comments regarding a recent SEQRA review of a proposed expansion of the New York Institute of Technology's Campus which specifically addresses impacts to and studies regarding this very intersection. Shamefully, the Town did not even address this in their letter to the City of Glen Cove.

It is important that the public understand that the City of Glen Cove has not provided residents with accurate information. Once again, the City has just recently announced that the Developer will not be taking ownership of the entire acreage as originally stated, instead claiming now it will only buy approximately half that amount. Leaving the City to manage and pay for the property as well as denying the City of the revenues it planned on receiving and it used to balance its current budget, even after being cautioned not to do so by the State Comptroller. The City is heading for another disaster as it has already demonstrated with the Piazza, which has now become another eye sore. This administration cannot be counted on, history continues to repeat itself. The people of this area must inform themselves and must understand that this is not fiscally responsible, but a disaster.

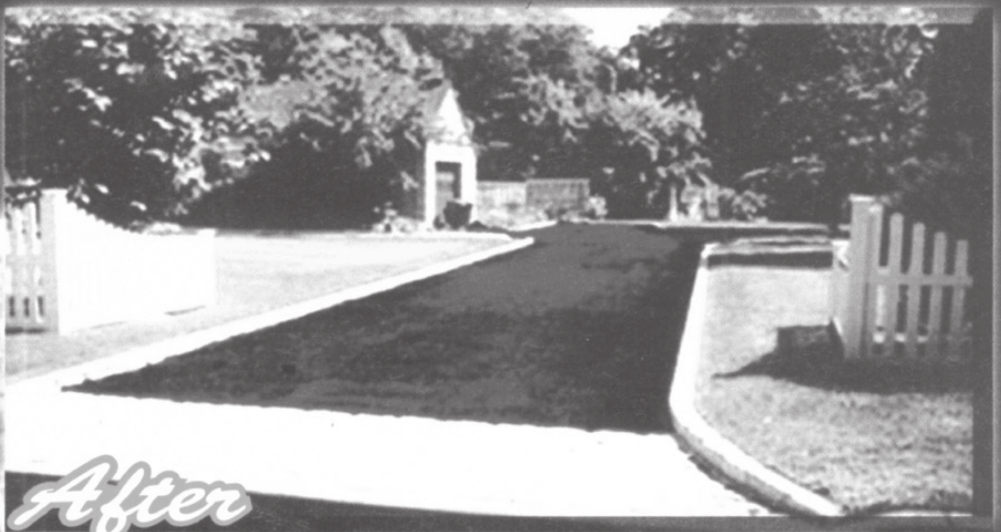

Mayor's Column

OUR WATERFRONT: Progress and Common Sense vs. the Cost of Nonsense

Over two decades ago, long before I was Mayor, the City of Glen Cove had the good sense to put in place an ambitious multi-million dollar plan to restore the toxic dump of the Superfund Site known as Garvies Point – our waterfront – to a habitable and productive use. After more than 20 years of effort, at a cost of \$100 million, Garvies Point is ready to be restored to our tax rolls as a world-class residential, commercial and parkland area 56 acres in size, more than 27 acres of which will be for public use and enjoyment. It's been a remarkable and highly successful journey to bring this former contaminated area back to life!

From the very beginning, the vision – as shared by four Mayors and embraced by thousands of residents – was the restoration of the Garvies Point property to drive new tax revenues, jobs and recreational activities for the City of Glen Cove.

An Ambitious Vision for the Reclamation of Garvies Point

At the onset of the Garvies Point project it was crystal clear, the City of Glen Cove had zero financial ability to spend or borrow enough money to make even a dent in the toxic waste cleanup, nor could it ever find a developer to build a non-income producing park for residents at a cost of hundreds of millions of dollars.

Prior city administrations elected to make a commitment to move forward to redevelop Garvies Point in a manner best thought to serve the needs of our community and improve our quality of life, not just at the waterfront, but for all of the City's residents. The objective has always been to use a significant piece of the space for outdoor activities that everyone in Glen Cove and our surrounding communities can enjoy. Making Good Sense of the Financial Opportunities and Public Amenities Ahead for Glen Cove

It is this Administration's goal to meet our City's longstanding obligation to finish what has been started, and finishing it in the best, most community and business-friendly way we can. As we near a critical milestone for the Garvies Point project and a successful outcome for the City, here's what can be expected:

- Glen Cove will receive \$15 million dollars immediately when the property is

turned over to the developer.

- \$7 million dollars of the sale price will be used to discharge the City's obligations to Nassau County.

- 466 construction jobs will be created, generating \$36 million in earning annually, and 545 jobs post-construction will be created, resulting in a total earning potential of \$22 million.

- Over the next 40 years the City, School, County and Library (affected tax jurisdictions) will receive an estimated \$500 million in tax and other revenue.

- Glen Cove will receive an additional lump sum payment at Closing of more than \$10 million dollars as a fee for providing financial assistance in connection with the waterfront redevelopment.

- The financial benefits gained from this project will stabilize property taxes in Glen Cove, improve the City's credit rating, lower the cost of borrowing and eliminate the need for persistent short-term cash borrowing to run the City's operations.

- Home values will increase and Glen Cove businesses will expand.

- Glen Cove will be transformed, but not in a way that the naysayers claim. It will become a center of commerce over the next ten years and its economy will expand dramatically – a win, win, win result for the City and all of its residents.

No Development = Millions of Dollars in Paybacks/Penalties, No Progress and Substantial Tax Increases

The newly vocal opponents of the Garvies Point Project are costing our tax payers substantial amounts of wasted money and time. They have launched at least two lawsuits against the City - suits that will cost hundreds of thousands of dollars to defend.

Without the development the City of Glen Cove and its tax payers will be on the hook for millions of dollars and that would definitely impact the quality of all of our lives. Here are some of scenarios should the project not move forward.

- If the project is prevented from going forward, 20 years of time invested and

more than \$20 million in funds spent by the City will be lost.

- Glen Cove will immediately be obligated to pay back \$7 million in outstanding loans to the County which were used to clean up the toxic chemicals.

- The City's 2016 budget will immediately have a deficit of between \$4 and \$5 million dollars.

- These loan repayment obligations, coupled with the 2016 budget deficit, will require a reduction in City services in 2017 and a need to either borrow \$12 million dollars or raise property taxes by 40%.

- Additionally, the federal and state governments may likely seek reimbursements for some of the millions of dollars they invested in helping to clean up Garvies Point.

- Over the next 40 years, the affected

tax jurisdictions will lose \$500 million in tax and other revenues that are now projected to be received from the waterfront.

- Finally, the redeveloper would seek to recover from the City up to \$40 million dollars in funds it invested in good faith with the City since the 2003 Land Development Agreement with the City in the redevelopment of the Waterfront

Those are just a few of the adverse effects of stopping the project at this point.

We all know that progress may have a few challenges along the way, but think of all of the good that will come from the 20-year effort that it has taken to bring this waterfront redevelopment project to the cusp of final success. I heartily applaud every Mayor and their City Council members who came before me and helped bring about this day. I, along with all of our City's residents, will be the beneficiary of their hard work, perseverance and forward thinking.

Mayor's Column

Sea Cliff Mayor Bruce Kennedy

Many people in Sea Cliff, Glen Cove, Glen Head, Glenwood Landing, Roslyn Harbor and the Brookville's have reached out to me in the past week in regard to my column last week. The vast majority just said thank you for being one of their sentinels in regard to the proposed Garvies Point development plan. Many people were confused because they were under the impression that the mega development was a fait accompli and were unaware that it was in a judge's hands at this point.

The most common question that area residents are asking me is in regard to the stances of all our other elected officials. This is not simply a Glen Cove issue; it is a regional issue due to the scope and scale of this 1.8 million square foot development that could bring in another 4,000 residents to the area. There are countless issues within the two Article 78 proceedings that have been filed and the people are unsure of where our town, county, state and federal elected representatives stand on these concerns.

Nobody disagrees that many hearings were held over the years on assorted development plans for Garvies Point but the significant matters relating to the potential for adverse environmental impacts were not sufficiently addressed; and in many cases these subjects were not addressed at all. New information has been brought forth, specifically the reports of both the EPA and DEC, yet these reports have been largely ignored. The current plan that threatens to bring the single most massive building ever built on Long Island to the waterfront of the Gold Coast was only discussed by the City in two or possibly three publicly noticed hearings with no effort to reach out to the surrounding communities. The issue of the City and developer trying to

unilaterally break the settlement of a 2000 lawsuit regarding future redevelopment plans is very poignant and explains why so many people feel that the current plan completely disregards the rights of the stakeholders. Therefore, the people want to know where their elected officials stand on this current proposal and the process by which an approval was obtained.

The people know that the current plan is bad for the entire region. Virtually all high density residential development at the end of an environmentally sensitive peninsula that is nowhere near public transportation cannot possibly be a good idea. There was once a vision of Garvies Point becoming a Seaport Centre that would attract visitors from all over. That plan proposed a premier waterfront marketplace complete with cultural dining, retail, spas, and a conference center / banquet hall. That was a plan that would create up to 1,000 jobs, generate revenues for the City far beyond residential development, significantly reduce the demand on public services – and do it all on half the footprint. Maybe this isn't the dream of RXR but it is of the people in the area. RXR signed a Land Disposition Agreement with the City in 2003 that acknowledged they couldn't develop more than 700,000 square feet and building heights could not exceed 65 feet, so the allegation that RXR may have a claim against the City is untrue.

At this point the question is whether to run blindly ahead at the command of a multi-billion dollar corporate bully or sit back for a moment and contemplate the future of the area. This is not a time to be penny wise and pound foolish when our quality of life, property values and environment are at risk.

film noir, which also featured Robert Mitchum. In regards to the contract, Hughes claimed that an oral agreement with Rank precluded her from being loaned out to any other studio, so she sued RKO. Last Week's Celebrity

This week's celebrity was born on Jan. 31, 1929 in Lower Holloway, London, England. Her father was a bronze medalist in gymnastics at the 1912 Summer Olympics. During WWII, she and her family were evacuated out of London. Upon their return, she would become one of the "well-spoken young starlets" of J. Arthur Rank, who was one of the original owners of Pinewood Film Studios, England's rival to Hollywood. She was spotted by director Val Guest, who cast her in a Margaret Lockwood vehicle, playing her younger sister, in "Give Us the Moon" (1944). Before moving to Hollywood, she played several other roles including a young "Estella" in David Lean's version of "Great Expectations" (1946), "Ophelia" in Laurence Olivier's "Hamlet" (1948), for which she received her first Oscar nomination, and a Indian girl in the Powell-Pressburger film "Black Narcissus" (1947) with Flora Robson and Deborah Kerr. In 1949, she starred with Stewart Granger in "Adam and Evelyn". He would become her first husband, in 1950, and they would both become American citizens in 1956.

In America from the early 1950s, she found out that RKO head, Howard Hughes had purchased the remaining six months of her Rank Studio contract. She made four films for Hughes including Otto Preminger's "Angel Face", a B&W

Last week's celebrity was born Francis Thomas Sullivan and simply remembered as Frank Sully. He made his feature film debut in "Murder of the Vanities" (1934) and appeared in over 240 film between 1934 and 1968. Along with previously mentioned films, he may be remembered as one of the "Joad" family members, "Noah Joad" whose family treks across country for a new life, in the 1940 John Ford classic film, "Grapes of Wrath" with Henry Fonda. He also played "Sgt. Matthews", the dim-witted assistant to "Inspector Farraday" played by Richard Lane in two "Boston Blackie" films with Chester Morris: "Boston Blackie Booked on Suspicion" (1945) and "Boston Blackie and the Law" (1946), "Northern Patrol" with Gloria Talbot, "Gun Smugglers" (1948) with Tim Holt and Martha Hyer, and his last two films, "Bye-Bye Birdie" (1963) with Dick Van Dyke and Ann-Margaret and "Funny Girl" with Barbra Streisand, to name a few.

In addition to his film work, he also had bit parts in several TV credits including "Maverick", "The Alfred Hitchcock Hour", "Leave it to Beaver", "I Love Lucy", "The Beverly Hillbillies", and as the character, "Charley", on "Topper" with Leo G. Carroll. He also had a recurring role as "Danny" on "The Virginian". He died Dec. 17, 1975 at the age of 67.

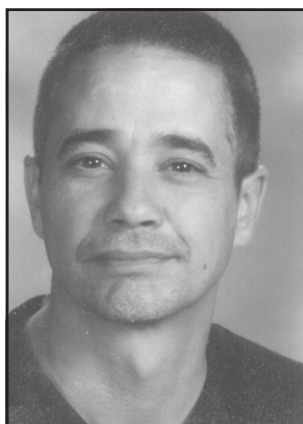
