# Community Joins In Mourning a<mark>nd Prayers</mark>

The Gold Coast community joined the nation in grief upon learning of the mass shooting which took place on Sunday, June 12, in the "Pulse" nightclub in Orlando FL.

The grief was further compounded when it was learned that Glen Cove resident Marissa Delgardo was among the injured. Delgardo, a graduate of Glen Cove High School, had recently moved to Orlando and was at the Pulse nightclub when the gunman entered the building early Sunday morning, shooting and killing 49 people and injuring many.

The mass shooting is the deadliest in U.S. history.

Marissa's mother, Lisa Delgardo, posted on Facebook that her daughter had been shot as many as 12 times and asked for prayers for her recovery.

As a sign of unity and solidarity, the City of Glen Cove, like other communities, has lowered its American flags to half-staff. at his town's Memorial Day ceremony, Steven Behnke secured funding to construct an ensemble and his efforts were well received from the start. "We had Veterans telling us how much it meant to them to have live music," recalls Steven. "That feeling was amazing!" # Gold Coast Public Library District Election Set for September 7, 2016

On September 7, 2016, residents of the Gold Coast Public Library District (GCPLD) located in Glen Head, NY, who are eligible to vote in a general election will vote for as many as three candidates to fill three open seats on the Board of Trustees and to establish the Library budget for 2017. There are (3) three year seats. Balloting will take place at the Gold Coast Public Library Annex, 40 Railroad Avenue, Glen Head, between the hours of 9:00 am and 9:00 pm. Please note the change of location of the Trustee election.

Persons wishing to vote who are not registered, who are US citizens, have resided within that portion of the North Shore School District not including Sea Cliff, and will be at least 18 years of age on or before September 7, 2016, must register by August 12, 2016 with the Nassau County Board of Elections. Petitions must be directed to the Chair of the Election Committee of the Gold Coast Public Library District at the Gold Coast Public Library and filed in the Office of the Chair of the Election Committee, located at the Circulation Desk, not later than 5 pm on Thursday, August 25, 2016.





First, despite the writer's insinuation to the contrary, no one in their right mind opposes sensible child safety laws. To even suggest otherwise is bizarre.

Second, where is there a shred of evidence that school zone speed cameras have prevented a single accident? Indeed, where is there any evidence that speeding in school zones has ever been a problem to begin with?

Third, if, as the writer suggests, kids are being "knocked down" in front of schools, then why in heaven's name did the Legislature ever repeal the law and end the speed camera revenue raising tactic? Do they really care more about preserving their jobs than the safety of children?

The letter writer's implication that

speed cameras were installed because child safety is the issue misses the point entirely. Child safety is not the issue, nor has it ever been. It's exactly that kind of flawed logic which produced the speed cameras in the first place. If you ask most people whether they think it's a good idea to turn those cameras back on, the vast majority will oppose it because they know child safety claims were a convenient excuse, not a legitimate reason, for installing them. The public promptly called out their Legislators over their obviously false claim of child safety as the basis for needing a speed camera program, and in response, the Legislature almost immediately ended it even while their hands were still in the taxpayers' cookie jar.

The speed camera program is yet one more classic illustration of a solution in search of a problem. It always makes you wonder why folks so easily buy into the solution in order to support their belief in a non-existent problem.

#### *Learning The Difference* To The Editor,

I would like to share some thoughts I have had since recently becoming the Chairperson of the City of Glen Cove's Democratic Committee. Today, I am aware of the horrific pain my country is in regarding the events in Orlando, Florida. It is my goal here to expand upon a statement made by my wife, Janice, "We must speak about our differences, in order to understand and accept our differences, in order to HEAL our differences".

I have learned a lot in these past six months. I have learned a little about election law and politics, but definitely not enough to call myself an expert. My personal interest is in discussing the difference between being a politician and that of a public servant. I view my role as someone who cares about my community, and who works FOR the people in my community

As the Chairperson for the City of Glen Cove Democratic Committee one of my responsibilities will be to recommend (along with a group of experience quality and qualified individuals) Democratic party candidates for the 2017 City of Glen Cove election. I am often given feedback from the general public on which "kind" of person I should be looking for -a female candidate; a candidate of color - either Black or Hispanic or Oriental; a candidate of a specific religion; a member of the LGBT community; a mixture of all the aboveor even "that guy in the wheelchair" (and that's me). I am dismayed that we continue to define ourselves with these Unfortunately people within labels. our communities are not willing to be involved in their home towns. They often will not attend, on a regular basis, local government meetings which would give them an upfront and personal opportunity

on how their local government works and the pertinent issues that their elected officials are required to make decisions upon. Recently in Glen Cove, only 1044 people voted in the School Board election (the year 2014 population of Glen Cove = 27,000) and yet I am sure that many citizens will be up in arms when decisions are made that they do not approve of.

Is it the focusing upon our differences which creates the apathy within our communities?

Over the three days of the Memorial Day weekend, myself and some friends went to two public locations in Glen Cove to offer assistance in registering voters – not to ask them to change their party affiliations but to REGISTER TO VOTE. We were amazed at the amount of people we encountered who were NOT registered voters (and were successful in registering them). Voting is a privilege. It is how we become involved, and we HAVE TO make a difference via our vote. We have to use our rights as a United States citizen to vote, something that my parents came to this county for.

I read a recent article published on May 18, 2016 by the Long Island Herald written by Nassau County Legislator Laura Curran (Democrat, 5th district) in which she states,

""If you want true accountability, spend less time on Facebook and more at board meetings, in legislative chambers — and in the voting booth. Heck, why don't you consider running for office? It's too easy to complain. In the end, true accountability is up to you".

Bravo Legislator Curran! I echo your feelings. Please let's NOT define ourselves by our differences. #### Alternate Reality? To The Editor,

The many statements made by Mayor Spinello regarding the Waterfront plan are either blatantly false or grossly misleading. It seems that the Mayor is living in an alternate reality, but residents of Glen Cove deserve the truth. Despite multiple public warnings, Spinello proposed and passed a speculative budget that relied on revenue streams from deals he knew he couldn't close and now he blames others for his shortfall.

The Mayor states: "Despite the lawsuits, the waterfront project is moving forward as planned." The Mayor cannot know if this project will move forward as the courts have not yet ruled. The developer's CEO himself states in an affidavit that "These lawsuits . . . severely threaten our ability to secure financing for the Project...if there is any degree of uncertainty regarding our approvals and ability to build." This is hardly a statement of "moving forward as planned."

"Public hearings will be held over the next few months, so people will have a chance to ask questions and voice concerns." The public record (FEIS) contains 15 years worth of questions and concerns that have been ignored. Why should anyone believe that his or her concerns and questions would now be addressed? The concerns today are the same as they've been in the past... the density, the traffic, the strain on services and the questionable finances.

"A TIF is non-recourse to the city and the city has no liability to repay it." This is dangerous equivocation. It's Glen Cove's debt, so it's Glen Cove's liability (the terms are synonymous). Glen Cove is indeed responsible to make both the interest and principal payments. What the Mayor seems to mean is that if the project fails the debt is secured by the property itself. But Glen Cove still needs to repay this financing.

While the city is paying for the infrastructure costs up front, the property owner will pay the taxes" What is the meaning of this sentence? "The City is paying for the infrastructure costs up front" i.e. you are taking out a loan to pay for these costs NOW. "the property owner will pay the taxes" i.e. Some day in the future, when and IF the project is starting to sell or rent apartments, there will be taxes that will cover the cost of the loan payments. But using The City's own figures, the math doesn't add up to profit, it adds up to more debt. The annual net profit after expenses cited in the FEIS is \$1.7 million. This has oddly been revised upward to \$3.2 million with the new plan, but this does not take into account any debt service for infrastructure TIF's. The interest on 75 million in borrowing is substantially more than 3.2 million. This project could leave a shortfall of millions in the City's budget year after year where they will have not choice but to RAISE YOUR TAXES.

"The project is expected to generate at least 1,000 construction and permanent jobs and to bring in \$50 million per year to the city". The jobs figure is a gross overstatement, and the statement regarding \$50 million per year is an outright misinterpretation of the City's own estimate. Here are the facts directly from the City's own documentation:

In 2011, total on-site employment was estimated at 585 full-time equivalent jobs; more than half of that number of jobs was attributable to a hotel/spa. So the Mayor's jobs estimate is quoted from an item that is no longer part of the project! The new estimates are: 226 onsite jobs (123 of these are attributable to office space yet to be rented and 296 due to assumed increased economic activity. In addition, far fewer than 1,000 construction jobs are expected, with the total now estimated at 466.

As for "\$50 million per year to the City," This too is a misrepresentation. The Estimated Retail Spending from new residents is expected to be 9.8 million,

and that's for all of Nassau County! These figures come from a report by The Eisen Group, consultants on the project and contained in the FEIS(Final Environmental Impact Statement).

"At full build out of the site, the project will generate \$50.9 million in total tax revenues during the construction period." According to the FEIS this 50.9 million will not accrue to the benefit of Glen Cove. This money will go to the state and the county for taxes on wages, material purchases and miscellaneous purchases during construction. Not much of this money, if any, will go to the City of Glen Cove. The numbers in the FIES are broken out: 24.5 million in sales tax (state and county) due to material purchases. State income tax accounts

Nassau County mortgage recording tax is estimated at 5 million. This equals 50.1 million that the City does not receive! The magnitude of the Mayor's misunderstanding of this figure is stunning.

"This is once in a lifetime found money and it is the right thing for Glen Cove... In the long term, the revenue growth will be substantial and will offset the increase in expenses." Everyone knows that there is no such thing as "found money." Everything comes with a cost. Where is this purported revenue growth to come from? There are no figures in the record. This is yet another statement with nothing to back it up.

"The buildings should be completed in 18 to 24 months. The entire project is expected to take five to six years to complete." Here's what the FEIS actually says: "Given the scale of the proposed project, the site's development is anticipated to be phased over the course of an estimated time period of up to 10 years." This is more than twice the amount of time stated by the Mayor.

The people of Glen Cove and our North Shore community deserve the truth from their trusted public officials. It appears however that the Mayor doesn't have time to bother with facts. I invite Mayor Spinello to come back to reality and actually read the Final Environmental Impact Statement on the Waterfront. It is posted on our website for his convenience. www.sustainablewaterfront.org

# Name the Celebrity



This week's celebrity was born in London, England on Nov. 16, 1942. After WWII, she and her family moved to Canada and then to the U.S.. At the Neighborhood Playhouse, she got her start on Broadway in such plays as "Take Her, She's Mine", "The Chinese Prime Minister" and "Poor Richard" with Alan Bates and Gene Hackman. She was then discovered by director Sidney Lumet, for his 1966 adaptation of Mary McCarthy's novel "The Group", which also starred Candace Bergen, Joan Hackett and Jessica Walter. The success of that film launched a film career that included roles in "The Night of the Generals" (1967), as "Mata Bond" in the "James Bond" spoof, "Casino Royale" (1967), in Peter Yates' "Robbery" (1967) with Stanley Baker, "Blue" (1968) with Terence Stamp and the Victorian period comedy "The Best House in London" (1969).

In the 1970s and '80s, her feature film appearances became sporadic and included roles in the cult horror films and over a dozen made-for-TV movies including "Cry of the Innocent" (1980) with Rod Taylor. She was often mistaken for actress Sharon Tate. Ironically, in 1969, our celebrity had lunch at Tate's home on the afternoon before Tate's murder, in that same home.

## Last Week's Celebrity

Last week's celebrity was Jean Simmons. After a court settlement concerning her contract with RKO's Howard Hughes, Simmons began to be loaned out to other studios and thus began her association with the 1950s costume films. First, there was "Androcles and the Lion" (1952), then as a young Elizabeth I in "Young Bess" (1953), with then-husband, Stewart Granger, Deborah Kerr and Charles Laughton and as a young Ruth Gordon in George Cukor's "The Actress" (1953), with Spencer Tracy and Teresa Wright. She felt she worked especially well with Spencer Tracy, who received a Golden Globe for his performance in "The Actress". She thought so highly of him that she named her first daughter, Tracy Granger, after him. Her second daughter, by #2 husband Director Richard Brooks,

was named Kate Brooks, after Katherine Hepburn, another close friend.

By 1960, her marriage to Granger had fallen apart and she married Richard Brooks. He immediately raised her horizons by casting her as the evangelist opposite Burt Lancaster in "Elmer Gantry" (1960). Lancaster and Shirley Jones both won Oscars for the film, but Simmons wasn't even nominated. She then sportingly played the female lead in "Spartacus" (1960) with Kirk Douglas, which would prove to be her last big picture. She did less stellar roles and more or less by the 1970s, she seemed to retire. Her marriage to Brooks came to an end in 1977. There were stories that she was drinking too much and in the early 1980s, she checked herself into the Betty Ford Clinic and spoke publicly about her addiction. She started to work in TV which included Richard Chamberlain's and Barbara Stanwyck's "The Thorn Birds" (1983) and as an admiral in "Star Trek: The Next Generation (1991). On Jan. 22, 2010, a week before her 81st birthday, Jean Merilyn Simmons died of lung cancer.

She loved to play the piano and attend concerts at Planting Fields or the library. She played bridge with Bob and other couples, and later, in local bridge groups. She was also an avid reader, attending the Casual Book club and Great Books book club at the Locust Valley Library for many years. Helen's mother lived with Helen and Bob at the end of her life. They were avid scrabble players, and they both had a repertoire of memorized poems that they recited at appropriate times. Helen was filled with
