Assault with knife in Glen Cove

John Nagle said, "Upon police arrival a 26 year old victim was discovered in the driveway suffering from stab wounds to both arms, chest and abdomen. The victim was transported to the hospital for his injuries and police arrested 24 year old Pantro Reyes of Glen Cove at the scene and charged him with Assault 1st degree and Criminal Possession of a Weapon. The victim was admitted to the hospital in critical condition and is undergoing surgery for his injuries. The defendant will be arraigned on June 25th in First District Court in Hempstead."

The Sidemen Featuring The Legendary Uptown Horns To Play In Glen Cove July 8th

A host of well-respected, sought-after musicians will take the stage when The Sidemen and The Uptown Horns perform on week two of the 2016 Downtown Sounds Concert Series at the Village Square Plaza in Glen Cove on July 8 at 7:30 pm. This musical all-star group is an 11-piece band comprising New York musicians who have played in the studio and on stage with some of the biggest rock performers in the world.

You never know who will take the stage when The Sidemen play, but it's a sure bet Andy Aledort will be front and center. Over the years, Andy has played with a who's who of rock musicians including Dickey Betts and Double Trouble. He has also performed for the Jimi Hendrix Tribute Tour. Musicians who will be joining Andy at DTS include Paul Nelson and Mike DiMeo. Nelson is a Grammy-winning guitarist who has played with Johnny Winter while DiMeo has accompanied Deep Purple and Tommy James. J.P. Patrick, Craig Privett and Richard Rosch will contribute on vocals, bass and drums, respectively, while Jim Keller of Tommy Tutone and



"867-5309" fame will be playing guitar.

Playing with The Sidemen at DTS will be Uptown Horn members including Arno Hecht, Crispin Cioe, Bob Funk and Larry Etkin. These Ray-Ban wearing musicians have played with such luminaries as The Rolling Stones, B.B. King, Bruce Springsteen, Robert Plant, Aretha Franklin, REM and the B-52s. What is more, their horn riffs can be heard on historical chart toppers including James Brown's "Living in America," The B52s' "Love Shack, and

"Buster Poindexter's" "Hot, Hot, Hot" and Joe Cocker's "Unchain My Heart."

When The Sidemen and Uptown Horns take the stage at DTS, their set list will pay homage to the legendary musicians they have accompanied and admired. For example, they will feature a plethora of the greatest classic rock, soul, blues, funk and R&B tunes of all time. "We play evergreen artists who appeal to people anywhere from 30 to 65 years of age," explains Aledort, a Sea Cliff resident who rocked DTS with his other

group, The Groove Kings, in 2013. "And we love when our musician friends show up and join the fun!"

Not Anti-Development, but this ain't smart!

To The Editor,

In regards to the Waterfront Development one major point that's being missed is that the opposition is not anti-development.

We are for cleaning up the site, we are for the development of the site. We applaud the EPA and the DEC for their work to date and, as we've stated at the public meetings, we hope they will continue to remediate until it is completely cleaned up and there is absolutely no danger to human health. We would also applaud the smart, responsible development of the site, but the current plan is neither responsible nor smart.

This project is being called "Smart Growth" but it violates virtually all Smart Growth Principles. The closest LIRR station, a staple requirement of the regional smart growth movement, is anywhere from one mile to 1.6 miles

away - or in practical terms, about a half hour walk. The nearest supermarket is 1.2 miles away, up a giant hill (North Shore Farms). Urban planning standards cite true walkability as anything reachable on foot within a quarter mile radius. Using City Hall as an anchor of the downtown area, the eastern portion of the Garvies Point site is roughly a .6 mile walk, more than double the walkability standard used by urban planners.

Furthermore, it is not mixed use, it is 96% residential; it offers limited transportation options; it does not blend in with the existing surroundings or architecture; it does not strengthen existing communities; it is not practical, fair or cost effective; it disregards stakeholder input. It is out of scale with the surrounding area and it is simply too dense.

RXR has stated that the company "...has been and continues to be at the forefront of downtown revitalization and redevelopment. In addition to real estate endeavors, our efforts also focus on improving communities as a whole, including economic development, education and public safety..." that all sounds very nice and yet this is not "downtown", it will not "improve our communities" it will destroy them, and they have no desire to work with people who actually live here to create something we can all live with. RXR is trying to create a precedent for their "Urban-Suburban" model, and, if unchecked, they will shove it down our throats whether we like it or not! We must not let that happen.

As stated at the outset we are not anti-development. There have been other plans put forward in the past that we would support wholeheartedly, and that would still bring new residents and business and spur much needed economic activity. In fact, a real mixed use development with some residential, shops and other local businesses would most likely spur more economic development for Glen Cove than the current plan.

Mayor Spinello calls the opposition a "small number of naysayers". He also says that the City has a contract that needs to be honored. That is a convenient dismissal of the issues we have brought to the forefront. Indeed, it is a tactic of the powerful to frame the debate in a narrow way - "it's either all or nothing" - "if we don't get the TIF financing we can't do the project", "there has been too much invested in this plan to change it at this point", "we have a contract"... It's nonsense. The contract has already been renegotiated no less than 7 TIMES!

The debate needs to be re-framed - what works for ALL of the stakeholders in the community? If not this plan than what is possible? That's a discussion we, and most in the community, would support and welcome wholeheartedly.

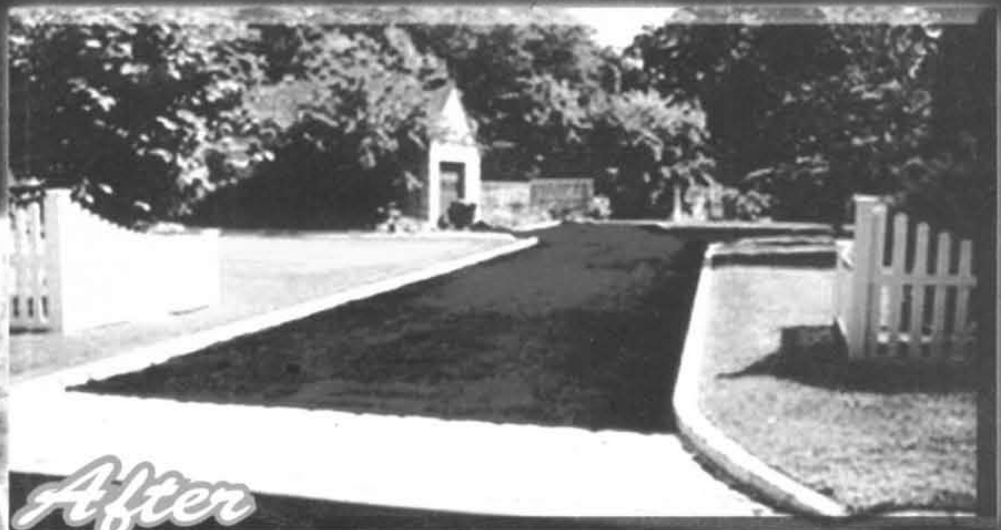

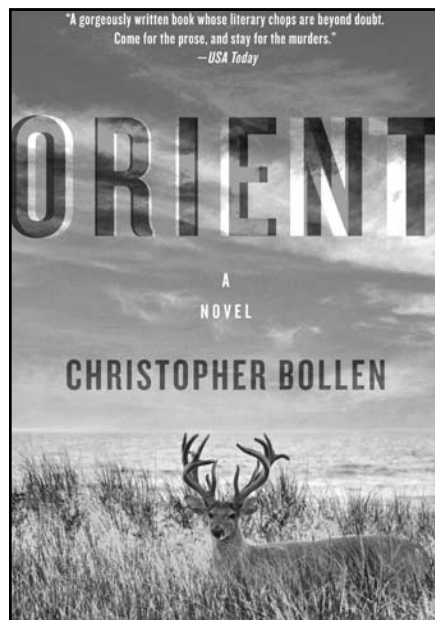
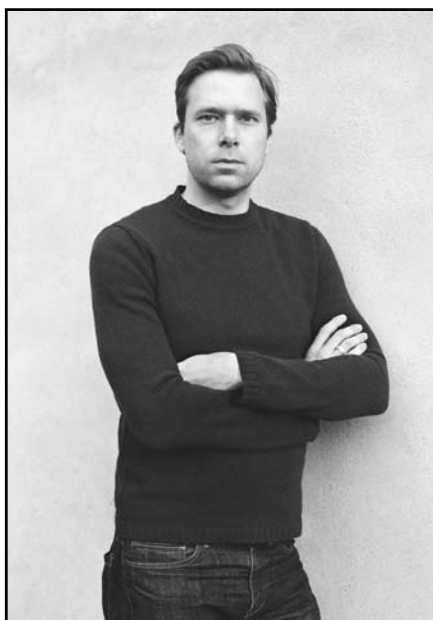

Sumi-e is the traditional brush painting of East Asia. Sumi-e is the Japanese word for Black Ink Painting. This style of painting and calligraphy developed in Ancient China where emphasis is placed on each individual brushstroke. The Chinese often speak of Sumi-e as "writing a painting" or "painting a poem." A great painting is judged on the ability of the brushstrokes on paper to capture the spirit (Ch'i) of nature rather than a photographic likeness.

The Asian Artists Association of New York is a relatively new chapter of the international organization Asia Artists Association of USA, whose international membership exceeds 2000 renowned artists and professionals. The mission of Asian Artists Association of New York and its parent organization is to foster communication and the interchange of the arts throughout the

Name the Celebrity



This week's celebrity is an American actor, producer and director with a career spanning nine decades. Born on Nov. 8, 1914 in Jersey City, N.J., he grew up in Brooklyn. He has worked in every major facet of the industry including radio, theater, TV and film dating back to the Great Depression, and at 101 years of age, is the oldest working Hollywood actor. He graduated from high school when he was 15 and began studies at N.Y. University, but left at the end of his sophomore year. "All around me I could see the way the Depression was affecting everyone: for my family, for people in business, like my father, it was a terrible time. I just wasn't going to stay in college, paying tuition to get a degree to be a lawyer, when I could see lawyers that had become taxi drivers." His father, a salesman and proprietor of a furniture store, died in 1945, at 55 years of age, "broken by the world that he was living in."

In 1932, at age 17, our celebrity auditioned and became the youngest of the apprentices under the direction of May Sarton at Eva LeGallienne's Civic Repertory Theatre in NYC. He was involved in several theatre productions which eventually led him to the Federal Theatre Project where he would meet Orson Welles and John Houseman. They left to form their own independent repertory theatre company, the Mercury Theatre. Our celebrity was invited to become a charter member. In the late summer of 1939, our celebrity was invited to Hollywood to join Welles and other Mercury players in the first film being prepared for RKO Pictures, "Heart of Darkness". Given a six week guaranteed salary of \$500 a week, he took part in a reading for the film, which was to be presented entirely through a first-person camera. After elaborate pre-production, the project never reached production because Welles was unable to trim \$50,000 from his project, something RKO insisted upon, as revenue was declining sharply in Europe by autumn 1939. The winds of war were beginning. Welles asked the actors to stay for a few more weeks, as he put together another film project, but our celebrity impulsively returned to NYC's Broadway. "Those who stayed did 'Citizen Kane' and I have always regretted it" he remembers. He later

returned to Hollywood to play a Nazi spy in Alfred Hitchcock's "Saboteur" (1942) also starring Joel McCrea, starting a long friendship and professional association with Mr. Hitchcock.

Last Week's Celebrity

John Rummel Hamilton was last week's celebrity. Throughout his career, he appeared in an incredible 225 films, from earlier films "The Man Who Cried Wolf" (1937) with Lewis Stone, to when he played the recruiting officer, who inspired George M. Cohan, played by James Cagney, to compose "Over There" in "Yankee Doodle Dandy" (1942). He continued to play small roles in films including the "Magnificent Doll" (1946) with Ginger Rogers, "That's My Gal" (1947) with Lynn Roberts and "Walk a Crooked Mile (1948) with Louis Hayward. In 1950, he appeared as "Justice White" in "The Magnificent Yankee" with Ann Harding and Louis Calhern and as "Col. Pollard" in "Davy Crockett, Indian Scout" starring George Montgomery.

Interestingly, in the mid-1930s, as a hint of things to come, he appeared in a 10-min. commercial for the new 1936 Dodge auto called "Fire at the Mine". In that short film, the amazing Dodge "Super-car" out-ran a speeding train, climbed tall mountains without the use of a road, and rescued people, with the help of a capable driver, from a burning coal mine. It was only appropriate that John Hamilton star in a commercial for a "Super-Car". After completing "The Great Caruso" in 1951, he was cast as "Perry White", the grumpy, but lovable, editor-in-chief of the "Metropolis Daily Planet" and continued in the role for all 104 episodes of the TV series, "Superman", starring George Reeves. This was Hamilton's largest and longest running role, and the one for which he was best remembered.

Noel Neill, who played "Lois Lane" in both TV and films, felt Hamilton played a stronger "Perry White" than Pierre Watkins, who had the role in the film serials. It was because Hamilton was so irascible and so unpredictable, that no one ever knew what he would say. Later on, during the series, he would often get flustered and miss lines. Tommy Carr, producer of the TV series, placed the script among the papers on his Hamilton's stage desk. He did it so well, no one knew he was reading his lines. Take him away from his desk, they were gambling.

After the show got canceled in 1957, Hamilton unofficially retired, although he did appear in a number of advertisements for an eyeglass firm to supplement his income. His last film was "Outcasts of the City" (1958). At 72 years of age, on Oct. 15, 1958, Mr. Hamilton passed away, due to a heart attack. Great Caesar's Ghost!

P.S. The answer to last week's teaser was Walter Huston played "Capt. Jacobi", the ship's captain who fell, mortally wounded, into "Sam Spade's" office, in his son, John Huston's "The Maltese Falcon" (1941).

Notwithstanding the provisions of the New York State Constitution, Article VIII, Section 10, the amount to be raised by tax on real estate in any fiscal year, in addition to providing for the interest on and the principal of all indebtedness, shall not exceed an amount equal to 1.75% of the five-year average full valuation of taxable real estate in the city, less the amount to be raised by tax on real estate in such year for the payment of the interest on and redemption of certificates or other evidence of indebtedness described in paragraphs A and D of Section 5 of Article VIII of the New York State Constitution, or renewals thereof.

D. Contracts for public lighting and public water utilities shall not be made for a longer period than five years

§ C3-3. Contracts exceeding \$20,000; bidding required; emergency repairs for the acquisition of goods and services.

A. The purchase of all goods and services for the City shall be executed in accordance with the provisions of the General Municipal Law and the City of Glen Cove's Purchasing Policy. No contract for public works exceeding \$20,000 shall be made without a published notice inviting bids according to plans and specifications on file in the office of the department having the matter in charge. All bids shall be accompanied by the names of two sureties or a surety company. All such contracts shall be let to the lowest responsible bidder who furnishes a satisfactory surety bond, unless all bids are rejected.

§C3-4. Transfers of surplus funds.

The City Council may transfer the surplus not needed in any other fund, excepting the funds for library purposes, which may not be transferred.

§C3-5. Deposits of city funds.

The funds of the city shall be deposited in the local a commercial bank. Such depositories shall secure said deposits in excess of FDIC limits by furnishing satisfactory corporate surety bonds, or by pledging with the city approved bonds, or securities therefor, for which the receipt of the Controller shall be given sufficient collateral in accordance with the provisions of General Municipal Law.

§C3-6. Payment of claims against city; itemizing, approval, audit required.

A. No demand against the city for money shall be paid, unless itemized in writing. Invoices or other written demands may be paid only when validated by at least two signatures. One signature shall be that of the City Controller upon audit of such invoice or demand for payment Purchasing Agent or other applicable officer who shall indicate the receipt of material and/or services in good order. The second signature shall be that of the department head to whom the material and/or services are furnished. The department head's signature shall indicate that the expenditure was properly authorized and in keeping with approved procedure and that the material or service has been received.

B. For the purposes of this section, a department head shall be any person reporting directly to the Mayor. All approved demands shall be submitted to the Controller for audit, review and payment as shall be directed by the Controller. ~~This procedure shall not apply to money for library purposes, which shall be paid according to the provisions of § C6-5 of this Charter.~~

Article IV. Courts and Legal Matters

§ C4-1. City Attorney; deputies.

A. A court of civil and criminal jurisdiction known as the "City Court of the City of Glen Cove," with a City Judge, is established in and for the city, with the same jurisdiction and powers, and with the same procedures, including appeals therefrom, as set forth under the provisions of the Uniform City Court Act of the State of New York, except that the civil jurisdiction shall be limited to and including \$5,000 in accordance with the Uniform Court Act. The court shall have the power to send its process and other mandates in an action or special proceeding of which it has jurisdiction to any part of the county, and without the county where empowered, under the Uniform City Court Act of the State of New York, for service or execution and to enforce obedience thereto.

C. The City Judge shall be elected as provided in this Charter, shall hold office for a term of six years and shall receive a salary to be determined by the New York State Office of Court Administration. ~~Should a vacancy occur in the office of elected City Judge, the Mayor, with the approval of the City Council, shall appoint a person with the same qualifications to fill said vacancy who shall hold office until the election and qualification of a person to be nominated and elected at the next municipal election. The elected City Judge shall also serve as the Supervising Judge of the City Court.~~

E. The City Judge shall appoint a Chief Clerk, Deputy Clerk, Assistant Deputy Clerk, Traffic Bureau Clerk and such personnel as may be necessary, at a compensation to be fixed by the New York State Office of Court Administration. The Chief Clerk and Deputy Clerk shall have the power to issue summonses, subpoenas, executions, transcriptions to administer oaths and take acknowledgments, to take depositions and informations and to issue warrants thereon, adjourn proceedings and act as official court stenographer and the minutes of such stenographer shall be the official minutes of the court and all proceedings. Notwithstanding the provisions of the Criminal Procedure Law or the provisions of any general or special act, the Chief Clerk or Deputy Clerk of the City Court of Glen Cove shall have the power to issue subpoenas in criminal cases, to sign and make executions, commitments to jail and other penal institutions, orders of discharge and certificates of conviction and to certify and sign copies thereof for the execution of any judgment rendered in said Court.

E.F. The City Judge City Council shall appoint City Marshal(s) at a compensation to be fixed by the New York State Office of Court Administration City Council, who shall have the same powers and duties and shall be subject to the same liabilities as sheriffs in courts of record and shall have within their territorial jurisdiction and subject to any limitations imposed by the Uniform City Court Act of the State of New York or by other provision of law, such power to serve and execute the process and mandates of the court as sheriff has with regard to the process and mandates of the Supreme Court. Marshal(s) shall, before entering upon the discharge of their duties, file with the City Court of the City of Glen Cove a bond in the form required of sheriffs of the county

FG. The court shall be open on each business day from 9:00 a.m. until 5:00 p.m. and in addition thereto at such times as may be required by the Administrative Board of Judges of the Judicial Conference of the State of New York. The same fees shall be charged as provided for in the Uniform City Court Act and under the Civil Practice Laws and Rules. The person against whom costs are awarded shall be entitled to the disbursements and fees as set forth in the Uniform City Court Act.

GH. An Associate City Judge shall be appointed by the Mayor with the approval of the City Council, which person shall have the same qualifications as the elected City Judge to act in his or her temporary absence or disqualification or to hold a separate part of said Court for the

disposition of such business as the City Judge may from time to time assign to him or her, and the said City Judge and Associate City Judge may hold their courts at the same time and in separate quarters with the same jurisdiction. The person so designated shall receive a salary as designated by the New York State Office of Court Administration. ~~The Associate City Judge shall hold office for a term of six years.~~

Should a vacancy occur in the office of elected City Judge, the Mayor, with the approval of the City Council, shall appoint a person with the same qualifications to fill said vacancy who shall hold office until the election and qualification of a person to be nominated and elected at the next municipal election.~~

J. The term of office of the City Judge shall be six years.

§ C5-1. Police force: organized, powers

A. Ranks and grades; distribution.

(2) Notwithstanding the foregoing, the present any personnel holding ranks or grades that do not conform to C5-1.A.(1) shall continue until reduced by normal attrition.

C. Members of the police force shall possess all the powers of a police officer as established in the New York State Criminal Procedure Law, except for the service of civil process.

§ C5-2. Special duty: appointment of Police force; auxiliary police: payment

A. There shall be within the Police Department, an Auxiliary Police Department whose members are proposed by the Chief of Police or his designee, subject to approval by the City Council. Said Auxiliary Police Department shall be supervised by the Chief of Police or his designee, and shall be staffed with volunteers and part-time employees holding no police powers. It shall be the duty of the Auxiliary Police to assist with traffic control, special events, and security.

B. There shall be within the Police Department a Division of Crossing Guards whose members are proposed by the Chief of Police or his designee, subject to approval by the City Council. Said Division of Crossing Guards shall be supervised by the Chief of Police or his designee, and shall be staffed with part-time employees holding no police powers. It shall be the duty of the Division of Crossing Guards to assist with traffic control and pedestrian safety at school crossings, church crossings, camp crossings, and other special events.

C. On the application of a corporation or person showing the necessity therefore, the Chief of Police may detail a regular member of the police force, or appoint and swear any additional number of auxiliary police for the special duty within the city, for which service the applicant shall pay may be charged by the City of Glen Cove, such sum as will reimburse the city for all costs and expenses. The auxiliary police so appointed shall be subject to the rules and directions of the police force.

If no bid shall be received for a tax lien offered for sale, the Controller for and on behalf of the city shall bid in the tax lien and upon such bid no deposit or payment in cash shall be required from the city. When the city has bid in any tax lien a certificate of the tax lien to the city shall be executed by the Controller in the form and matter prescribed for other notice thereof to the holder of such certificate of tax lien by mail, addressed to such address as may have been furnished to the Controller. Upon receiving the surrender of the certificate of tax lien, the Controller shall pay to the holder the amount thus deposited. 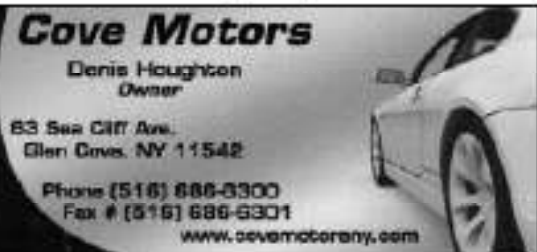
