July 4th Children’s Bike Parade Attracts Hundreds of Riders

A Glen Cove tradition for over 20 years, the Annual Children’s bike parade took place on the morning of July 4 attracting hundreds of residents dresses on decorated bikes to celebrate America’s Independence.

It all began when two Glen Cove residents, Cheryl Carmody and Patti Pilla, organized a small informal neighborhood parade with the children who lived in the area of the president’s streets. As it grew in popularity it was quickly moved to the downtown area.

It was the perfect day for a bike ride through downtown Glen Cove with several hundred children and their families participating in the City’s annual event. Led by a costumed City Eagle with music by D.J. John Yee, bikes decorated in red, white and blue with kids wearing patriotic tee shirts, bandanas and sparkly accessories, made this traditional bike parade a spectacular vision to see. At the completion of the ride, Mayor Reggie Spinello invited children to join him on stage to sing a melody of patriotic songs while bike parade volunteers and

Local Heroin Dealer Off the Streets

Glen Cove Police along with Nassau Narcotics, ATF and Suffolk Police arrested a major heroin dealer who was supplying heroin to Glen Cove and the surrounding area on June 28. The defendant was arrested in Brooklyn after an extensive investigation which was originated after the Glen Cove Crime Prevention Unit discovered that the dealer was supplying large amounts of heroin to Glen Cove and the surrounding areas.

Glen Cove Det. Lieutenant John Nagle “ This arrest resulted after an intensive investigation which was originated by the Glen Cove Crime Prevention Unit. This particular dealer was bringing out this deadly drug to our community and

the entire North Shore area. The joint efforts of the Glen Cove Police, the Nassau County Police Narcotics Unit, ATF, and Suffolk PD, resulted in this arrest which will reduce the amount of this poison entering our communities.”

The dealer, along with another co-defendant was arrested on Wednesday by the combined task force after the vehicle they were driving in was pulled over on Decatur Street in Brooklyn. At the time of her arrest the defendant possessed

598 bags of heroin, and approximately \$3,900 in cash. During the car stop the defendant's 12 year old sibling was also in the vehicle. The suspected dealer, 22 year old Damaris Lee Santana of Brooklyn was charged with Criminal Sale of a Controlled Substance in the 2nd degree, five counts of Criminal Sale of a Controlled Substance in the 3rd degree, six counts of Criminal Possession of a Controlled Substance 3rd degree. Jessica Cales, age 35 of Brooklyn was charged with Criminal Sale of a Controlled Substance 2nd degree and Criminal Possession of a Controlled Substance 3rd degree. Both defendants were arraigned in First District Court on Wednesday June 29. Defendant Santana was held on \$150,000 cash bail and defendant Cales was held on \$100,000 cash bail. Glen Cove Police Chief William Whitton

said, "I Am thoroughly and totally disgusted with the people who choose to deal this deadly drug to our youth, it's causing tremendous damage to family's throughout the country, I promise as Chief of Police to do everything within our power to root out the dealers wherever they may be that bring heroin and other illegal substances to our community."

Glen Cove Mayor Reginald Spinello said, "This is a critical arrest and I am thankful for the outstanding collaboration among law and drug enforcement officers from Glen Cove, Nassau and Suffolk Counties to aggressively pursue heroin drug dealers," said Mayor Reggie Spinello. "For the safety of our community and its young people, the efforts to stop drug trafficking is a priority for our police department and it's a critical one as each arrest can save the lives of many."

Glen Cove Mural Restoration Begins

Arterial Highway Temporary Lane Closure from 10 a.m. to 3 p.m. Weekdays for Up To Four Weeks

Glen Cove's welcome mural on the Arterial Highway/Route 107 is getting a makeover this summer. Manhattan artist Sean Sullivan has been commissioned by the City of Glen Cove and the Glen Cove Beautification Commission to paint a new design to update the decades old mural on the Rt. 107 southbound retaining wall. For the safety of the artist and project workers, the new mural project requires the right lane of Rt. 107's southbound traffic to be partially closed for five hours each day throughout the duration of the project. "We appreciate the Glen Cove community's support of this project and it is our hope to limit any inconveniences to our residents by closing only one lane during off-peak travel hours," said Darcy Belyea, Glen Cove Parks & Recreation Director,

who also oversees the Beautification Commission.

Starting the week of July 4th and extending up to four weeks (weather permitting) from 10 a.m. to 3 p.m. Monday through Friday the right lane of the Arterial Highway (Rt. 107) from Town Path to the railroad trestle will be closed as the artist and community volunteers complete the mural restoration project. The new mural design will spell out the City's name, "Glen Cove", replacing the seascape scene which currently adorns the wall. The Glen Cove Youth Bureau's Summer Youth Employment Program participants and Beautification Commission Volunteers will also work alongside the artist during the project.

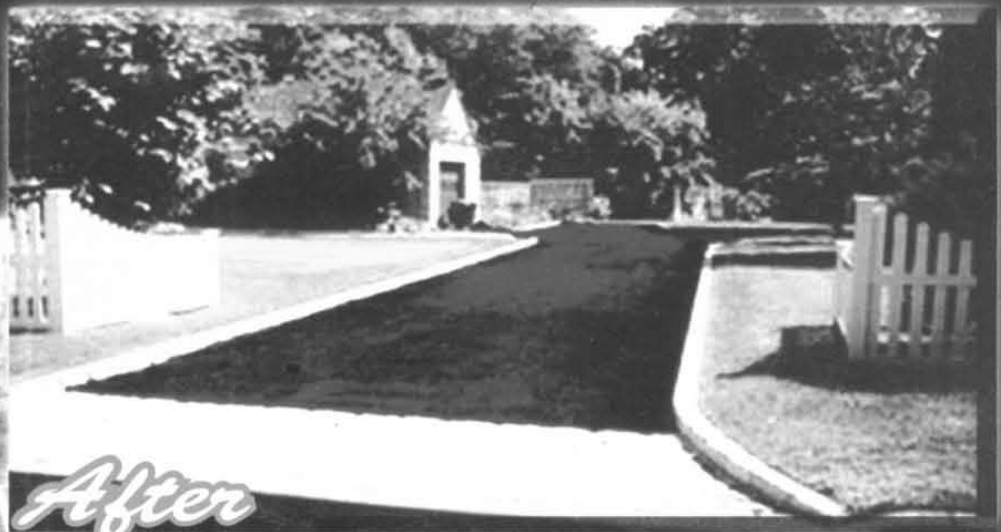

Desert Highway Performs the Greatest Hits of the Eagles at Glen Cove Village Square

The chart-topping hits of the Eagles will be featured when Desert Highway Band performs on week three of the 2016 Downtown Sounds Concert Series at the Village Square Plaza in Glen Cove on July 15 at 7:30 pm. The critically-acclaimed performances of Desert Highway provide a non-stop journey that celebrates one of the world's all-time best-selling bands.

Desert Highway is a group of six talented musicians who join forces to pay homage to the Eagles, an American rock band formed in Los Angeles in 1971. As such, Desert Highway performs the rich vocal harmonies and intricate guitar styles that were staples of the world-renowned group. The authenticity is undeniable as their show is presented without the aid of prerecorded instruments or vocals.

With five number-one singles, six Grammy Awards, five American Music Awards and six number-one albums, the Eagles were one of the most successful musical acts of the 1970s. 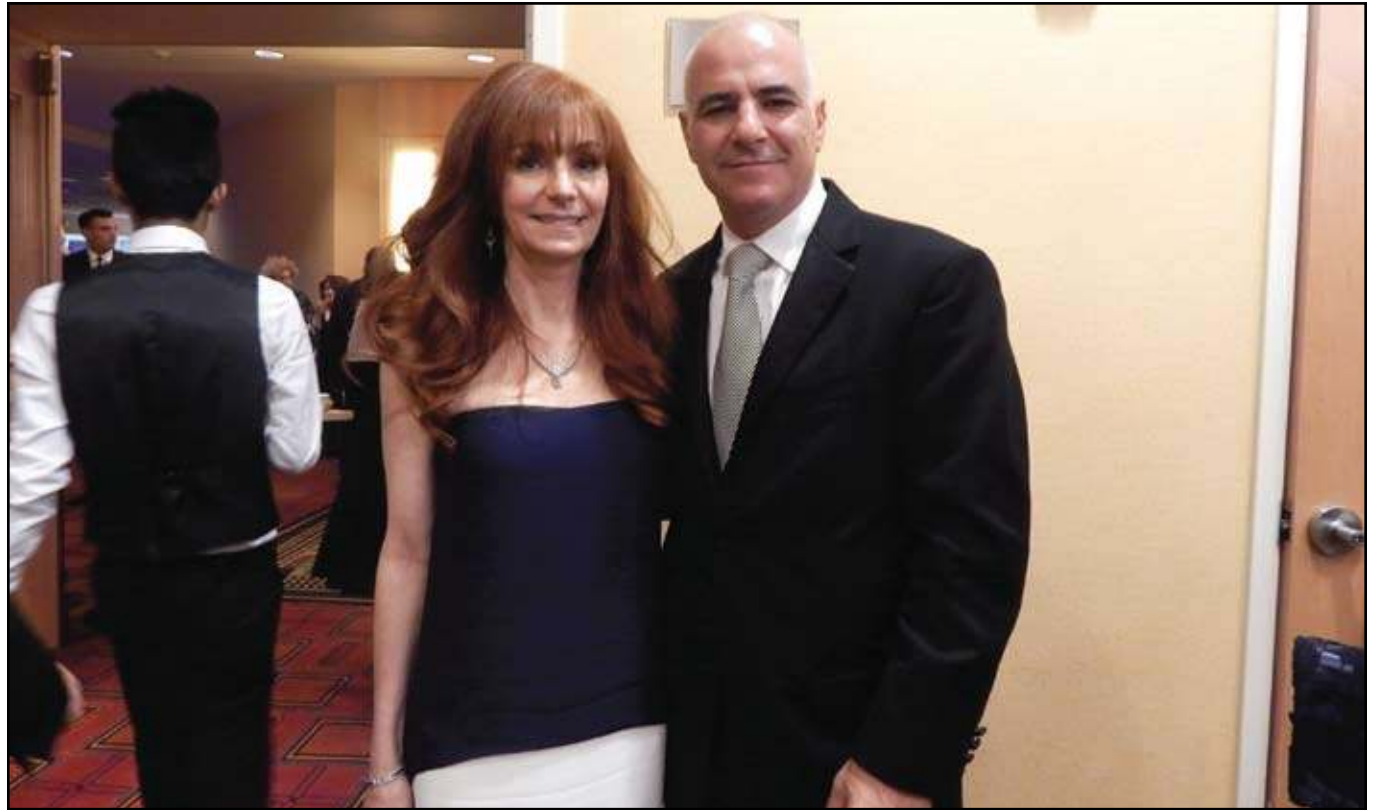

One of my favorite authors – Stewart O'Nan- just came out with a new novel: CITY OF SECRETS and it's quite wonderful. Jossie Jorgensen is a recreated man- his name, his passport, his taxi, his address are all forged- gifts of the Jewish Defence Organization- a group organized to protect Jewish immigrants from Arab assault and the harshly restrictive British Mandate following World War II. Jossie had survived the Holocaust, but his young wife, his siblings, and

his parents were not so lucky. Arriving from a Latvian concentration camp to polyglot Jerusalem, he finds himself morally and emotionally shattered. He chauffeurs American tourists to Christian sites during the day while aiding the underground at night. When he becomes part of a terrorist plot to overthrow the British, he is forced to examine his place in a brutally, seemingly senseless world, while the reader is left to question the moral and ethical implications. An absorbing look into a period of history which eerily foreshadows our present time....recommended!

sister "Carmen" in the film noir classic "The Big Sleep" (1946) also starring Humphrey Bogart. She played the teenage nymphet "bad girl" for all it was worth.

Last Week's Celebrity

Last week's celebrity was born Norman Perlmutter but was better known as Norman Lloyd. His long professional association with Alfred Hitchcock began with his memorable performance as a Nazi agent in the 1942 film "Saboteur". He also appeared in "Spellbound" (1945) with Ingrid Bergman, Gregory Peck and Leo G. Carroll. A marginal victim of the blacklist, he was rescued professionally by Hitchcock and hired as an associate producer and director of his long-running anthology TV series "Alfred Hitchcock Presents" in 1958. Previously, he directed the sponsored film "A Word to the Wives" (1955) with Marsha Hunt and Darren McGavin. He took an unusual role in Rod Serling's TV series "Night Gallery" episode "A Feast of Blood" as the bearer of a cursed brooch, which he inflicts upon a hapless woman, played by Sondra Locke, who had spurned his romantic advances.

This week's celebrity was born in Ann Arbor, Michigan on May 28, 1925. After attending schools in various states, Florida, Texas and California, she and her family settled on the West Coast. A raving beauty, she broke into the entertainment field as a model for still photographer William Mortenson. This attracted the interest of David O. Selznick and she signed a starlet contract with him, but nothing came of it. Universal Pictures took over her contract where she was groomed in inauspicious bit parts such as her corpse/victim in "Frankenstein Meets the Wolfman" (1943) with Lionel Atwill and Bela Lugosi and in such low-level entries as "Captive Wild Woman" (1943) with Milburn Stone and John Carradine and in "The Mummy's Ghost" (1944) with Lon Chaney Jr. and again with John Carradine. In between assignments, our celebrity earned WWII pin-up exposure in such magazines as "Yank: The Army Weekly".

RKO gave her some higher-level billing chances with "Marine Raiders" (1944) with Pat O'Brien and Robert Ryan and "The Falcon in Mexico" (1944) with Tom Conway. However, it was Warner Bros. that put her officially on the map. She generated some real heat as Lauren Bacall's wild thumb-sucking

In the 1980s, he played "Dr. Auschlander" in the TV drama "St. Elsewhere", over its six-season run (1982-88). In 1989, he made his first film role in nearly a decade, playing "Mr. Nolan", the authoritative headmaster of Welton Academy in "Dead Poets Society" with Robin Williams. He had numerous TV guest star appearances including "The Joseph Cotton Show", a former colleague of the Mercury Theater, "Murder She Wrote", "The Twilight Zone", "Wiseguy", "Star Trek: The Next Generation", "Wings", "The Practice" and "Civil Wars". In 2010, he guest starred in the episode of ABC's "Modern Family". Following the death of Olaf Pooley, on July 14, 2015, he became the oldest living actor to have appeared in "Star Trek". At present, he is the oldest working actor, in Hollywood, to hold a Screen Actors' Guild card.

Centennial celebration at St John's of Lattingtown

On June 11, 1916, St John's of Lattingtown was consecrated as an Episcopal Church by the Episcopal Bishop of Long Island the Rt. Rev. Dr. Frederick Burgess, and in celebration of this anniversary a dinner dance was held at the Piping Rock Club in Locust Valley. A cocktail reception was held both indoors and out, followed by dinner in a tent, which was decorated with lights and pink cherry blossoms.

On a large screen a photograph of the children from St. John's who had been confirmed by Bishop Lawrence Provenzano earlier that day, at the Cathedral of the Incarnation in Garden City. Later a short video was shown on the screen about the church history.

Rev. Mark Fitzhugh, who recently celebrated his first year at St John's as the eighth Rector, welcomed guests to the 100th anniversary celebration as did the church wardens. Bishop GERALYN Wolfe, Assistant to Bishop Provenzano, gave the invocation before the dinner.

Also in attendance was Dean of the Cathedral of The Incarnation in Garden City, Rev. Michael Sniffen, a former assistant priest to Rev. Simon Foster at St John's of Lattingtown.

A live auction followed which featured more than a dozen fine wines and outings to a variety of sporting events.

The very first place of worship built on the property built in 1859, was called the Union Chapel on what was a road called Pudding Lane, now Lattingtown Road. The Episcopal Church was founded by Henry Davison, William Guthrie and J.P. Morgan, who had left the Episcopal Church in Glen Cove following a reputed disagreement.

Many expansions to the church building have been added over the one hundred years.

Rev Fitzhugh outlined three areas of importance for the future; outreach, music and education. The funds raised at the centennial anniversary dinner will help the church towards fulfilling those goals. For further information visit stjlat.org.
