Mayor Spinello Recognizes Musician Richie Cannata Honorary Street Dedication

Glen Cove’s Piazza Project: City Takes Next Steps for Eminent Domain as Progress Stalls

Long the topic of conversation among Glen Cove residents and downtown business owners, over the past year progress on the City’s Piazza development has been stagnant. While phase one of the Piazza project got off to a start with opening of Panera Bread last summer, the development has not moved forward with its promised plans for continued demolition and the start of construction. “This developer has held the City hostage for far too long and the property is an eye sore,” said Reggie Spinello, Glen Cove Mayor and Chairman of the Industrial Development Agency (IDA). “The Piazza is a vital component of the future development of Glen Cove and to say we are disappointed with their lack of progress is an understatement.”

To address this situation, the IDA has

Glen Cove's Piazza Project: City Takes Next Steps for Eminent Domain as Progress Stalls

embarked on a path towards eminent domain as the ongoing delays, notices of violations and lack of developer action to address the project's issues are placing an unfair burden on Glen Cove residents and businesses. "It's been one broken promise after another - and enough is enough," said Deputy Mayor and IDA Executive Director, Barbara Peebles. This is private property and not a public/private partnership, therefore we are left with limited options. "At this point and in the best interests of our residents and local businesses we had no choice than to start the process for eminent domain." Eminent domain authorizes the government and certain quasi-governmental bodies to acquire property for a public use, benefit or purpose. In this case the Glen Cove IDA has the power to seek condemnation of the property, identify a developer that would purchase the property and deliver on the project. According to Peebles and in accordance with the eminent domain procedures on April 26, 2016 the IDA voted to approve the release of RFP to appraise the property and selected the appraiser on May 24, 2016. On June 24, 2016 the IDA released its "Expression of Interest" to potential developers. A requirement was included that provides for an open public space to benefit the community as well as encouraging the consideration of an entertainment component.

"Via a written correspondence I have notified the developer, Michael Puntillo, that we are working on a parallel path and if he makes good on the promises

he's made to the City, we will stop these proceedings," said Peebles.

In addition we have notified the owners of two other parcels within the Village Square boundaries that their property will also be subject to the eminent domain process.

Glen Cove's Village Square is a prime location that attracts many potential businesses and is the backdrop to countless community and cultural activities, parades, musical events, and celebrations. "We look forward to moving the process along in a productive and mutually beneficial manner," said Mayor Spinello.

About the Glen Cove Piazza

Jobco Realty's Glen Cove's Piazza project was approved by the Glen Cove Planning Board in 2011 and is slated to re-develop a blighted area of Glen Cove's downtown community. According to the development's web site, the beautifully designed mixed use development will feature a 12,000 square foot decorative brick plaza, 110 rental units (10% will be affordable housing), and 25,000 square feet of new retail shops, restaurants, and services. A key component of the revitalization will be linking downtown Glen Cove to the waterfront. Demolition of the pre-existing buildings began in 2014 and residents got their first taste of what the Piazza will offer with the opening of Panera Bread Restaurant in May, 2015. Since that time, the project has not moved forward due to various circumstances including the developer's legal and potential financial challenges.

Four from Sea Cliff Receive Whitecaps

The Sea Cliff Bistro was abuzz with residents as four deserving candidates were presented with Whitecap Awards for their extensive volunteer work given to Sea Cliff, over the years. The first presenter was Jack Pierce who gave a history of 92 year old John Di Stefano born in the Village. John resided in Sea Cliff on Glen Avenue, graduated from St. Boniface School and Sea Cliff High School. At age 18 he joined the Sea Cliff Fire Department on November 15, 1941, weeks before the beginning of WWII.

During the war, John joined the Air Force and was an engineer/gunner on a B17. After his time in the service he came back to Sea Cliff, married and raised a family on Downing Avenue. In 1946 he went into business with his brother Gene, together they had a service station on Glen Cove and Ransom Avenues. Over the course of 30 years they sponsored Little League teams with the name of Sea Shell Service. John supported many organizations in town and was a member of the Sea Cliff Civic Association.

John was recently honored for serving 75 years of active duty to the Sea Cliff Fire Department in which he was motor chief. Jack asked everyone to join him in honoring John DiStefano as he was presented with a Whitecap Award.

John Reali stepped up to the mic and noted that his nominee was born in Sea Cliff on October 2, 1928. He said in his youth this candidate resided at 325 Sea Cliff Avenue. He attended Sea Cliff School, the high school and graduated in 1946 with a regents diploma. His mother opened a candy store at that location when he was young. During WWII Ernie served as a messenger that would relay information from a civil defense person that was stationed on the roof of the Sea Cliff firehouse. His mother used to tell him while he was up there, "to watch for the bombs."

Eventually, the candy store changed to the Pine Tree Bar and Grill, affectionately, known as Longo's or Mom's (today it's K.C. Gallagher's). John said the family

asked that I mention that all service members were fed well at no charge. This candidate and his brother ran the business for 50 years.

In his life with his wife they raised four children. The three boys followed in their father's footsteps and joined the Sea Cliff Fire Department. The candidate joined the fire department at the age of 16 on November 7, 1945 during WWII. He was recently honored for his 70 years of service to the fire department.

"Community service and being ready to lend a helping hand is part of this third candidate's character and why he is being presented with a White Cap Award tonight said Gwynne Lennon with Mike Lennon. "Sometimes in the spotlight, often behind the scenes, we have seen him serve the community for over 25 years. Kids have benefitted from this man's patience and kindness and learned to fish. Many members of the community were helped by his pro bono legal work." This man has helped his wife in "umptime" times being a de facto member of Sea Cliff's Beautification Committee, weeding and clearing and helping in many memorable events. In his office at the edge of town, where alongside the restored façade are attractive plantings. He welcomes AHRC visitors to have lunch and to annual events. His legal work has been an asset to the Sea Cliff Yacht Club as counsel for over a decade.

This candidate joined Boy Scout Troop 43 when his sons were scouts. With his guidance and fellowship the troop made it through many weekends in early spring late winter trekking through show, ice and mud and climbing Mt. Washington. During the same era, he would attire in velveteen as a member of the Silly Shakespeare productions.

This gentleman is always cordial and ready to engage in meaningful dialogue, even when he may strongly disagree with someone, eager to understand and work for the common good, he is involved in vetting people from Sea Cliff's huge reserve on involved citizens to govern. He continues to perform the

tedious task of getting signatures, open for residents to voice their opinions and listen even though he may have a different perspective.

From 2000 to 2014 he served as a member as well as President of the Architectural Review Board. His commitment to ARB involved long hours, tough and sometimes unpopular decisions. When his tenure was up he joined the Sea Cliff Fire Department. Before closing, Gwynne almost forgot how that Don started and ran the Sea Cliff Farmers Market for five years.

With all that said, Gwynne was happy to call up none other than Don Kavanagh to a hardy round of applause to receive his Whitecap Award.

Last, but hardly the least presenter was Carol Vogt. She explained how in 1999 a couple moved to Sea Cliff and purchased a home with a history. The couple began fixing the house up with as much attention to the past as to the family's needs.

Even before it was all finished she opened her door and hosted events benefiting numerous local organizations. It continued to be open for shows, garden tours and holiday parties.

She joined the Sea Cliff Landmarks Association and took over and reinvigorated the biannual house tours.

Then after the tragic loss of Evie Haim, she stepped up as President of the Landmarks Association and continued to chair the house tours and took on other important projects like Sea Cliff's Secret Stairways project; she helped design and manage the restoration of the Central Avenue steps. About that time she was appointed to the Landmarks Preservation Commission and recently became its chair.

In addition, she is an active member of the PTA, a volunteer with the Sea Cliff Beautification Committee, as associate member of the Good of the Village Association and founding member of the Viking Foundation. In her spare time, she volunteers as a mentor to North Shore High School Senior intern.

Of late, she was the driving force behind the recent restoration of the children's library. She worked on the design and with contractors, donated countless hours, professional and financial resources and organized fundraisers.

She is a volunteer whose focus is always on the work. She is hands on, using her extensive and diverse skills to get the job done.

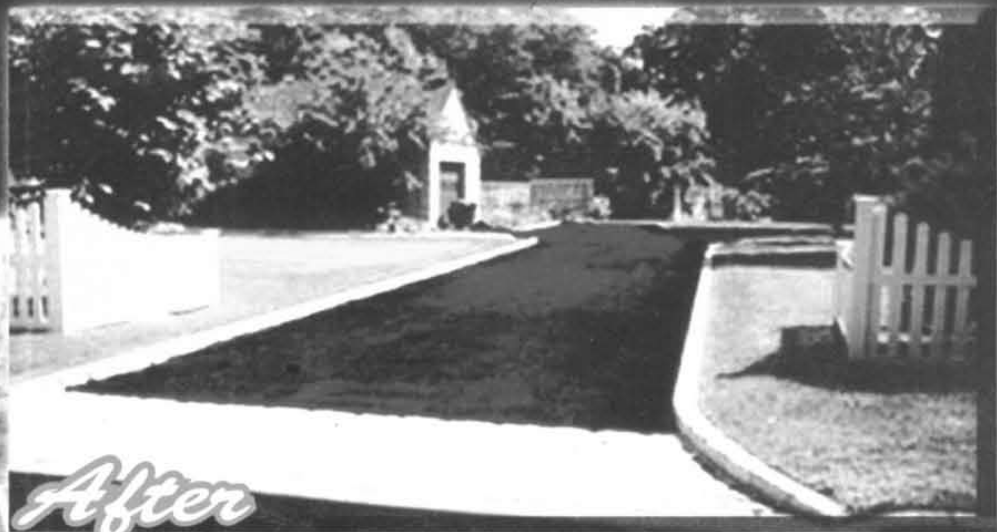

The Glen Cove Youth Bureau, in cooperation with the Friends of the Glen Cove Youth Board is teaming up with local citizens, organizations and businesses to provide back to school supplies to disadvantaged youth in our community. A backpack filled with supplies is presented to children who otherwise would not have what they need to succeed in their studies. Last year, 266 children in grades K – 12 received back to school supplies as a result of this effort.

Given the cost of getting ready for school, the need is greater than ever this year. For example, on average it costs \$78.00 to purchase all of the supplies on the school list for a 1st grader in the Glen Cove School District and \$83.00 to supply a 4th grader. This cost simply covers school supplies. It does not cover back to school clothing, shoes, coats, etc. For families living on a fixed income, especially those with more than one child, these expenses are often impossible to absorb. When the family forgoes purchasing school supplies, it is the student who suffers.

Senior Center South Bay Paddle Wheel Cruise

Wednesday, July 6 was a beautiful, warm and sunny day. At 9:30 a.m. a group of seniors from the Glen Cove Senior Center set out by bus for the marina at Bay Shore. At the dock stood the Lauren Kristy, an old but lovely restored rear paddle wheel boat. The seniors boarded the boat, climbed the stairs to the upper deck, and Captain Mike weighed anchor at 11 a.m. Off we cruised, at a gentle pace, around the waters of the Great South Bay.

As we pulled out of the marina we could see several Fire Island Ferries taking summer vacationers to their weekend retreats. We passed Brightwaters where we could see the Brightwaters Canal cutting a path through the land on its journey to Montauk Highway. We glided under the Robert Moses Causeway and Bridge, formerly the Captree Bridge, built in 1954. We passed by Oak and Captree Islands, viewing several species of water birds, including two Osprey nests filled with baby chicks. We saw people digging for Oysters in the middle of the bay since the bay's depth is only between 6 and 15 feet.

Captain's mates, Owen, Patrick, Trish and Robin, served lunch and refreshments, ensuring that we were well-fed and well-hydrated throughout the cruise. On the starboard side we could see the Jones Beach Water Tower and the outdoor theater. Captain Mike

navigated along the State Boat Chanel on our way to the Fire Island Lighthouse. The lighthouse was built in 1852 on the western end of the island. Over the decades, the west side of the island was built up, adding an additional 5 miles to the Fire Island shoreline. The Captain informed us that tours of the lighthouse are given every day of the year except Christmas Day. Visitors can climb the 182 steps to the observation deck, but not the additional 10 steps to the beacon. The original Fresnel lamp is housed in a building on the lighthouse grounds.

As we turned back to port, we passed Saltaire and Kismet, the westernmost villages on Fire Island. Both villages were badly damaged by the hurricane of 1938. In Saltaire 150 houses were destroyed or severely damaged. The hurricane struck on September 21st. Four caretakers lost their lives. Had it struck on a weekend the death toll would have been much greater. All too soon we were docking at the Bayshore Marinara once more.

We boarded our bus with Tilman, our capable driver getting us safely back at the Senior Center by 3 p.m. Thanks to Jenny, our Activities Director, and her assistant Gina, we had a wonderful time and can't wait for our next excursion. Name the Celebrity



This week's celebrity is going to allow this writer to wade into the early history of television and pass on a few little events that happened, that would not seem like a big deal to talk about today, but back at its conception, it was news. Our celebrity was born August 24, 1917 in Jersey City, New Jersey. He was the first person on television to host a telethon (raising over \$700 million for United Cerebral Palsy throughout his career), the first to appear on a TV commercial, the first to emcee a variety show and the first to appear on video tape. He started his game show hosting career with the first network game show, "Cash and Carry" on the Dumont Network, NY's Channel 5, from 1946 to 1947. He had several other game show jobs, as well as, live commercial spokesman positions on various networks. It was in January 1961, that our celebrity was to be the live commercial spokesman for the CBS network, for one of their sponsors, Kellogg's Cereal. CBS was soon going to find out that they were going to have the worst year in TV history since the first TV turned on, in the 1940s. Part of the reason for that was the premiere of a new game show called "You're in the Picture" that aired for only one episode on Friday, Jan. 20, 1961 at 9:30 pm, on the evening of the Inauguration of President John F. Kennedy. The show created by Don Lipp and Bob Synes, was an attempt by its host and star, Jackie Gleason, to "demonstrate versatility" after his success within variety shows and "The Honeymooners". Gleason was joined by Johnny Olson, later to be teamed with Monty Hall on the original "Let's Make a Deal", and our celebrity doing live commercials for Kellogg's cereals. There were four panelists: Pat Harrington, Jr. (later on "One Day at a Time"), Pat Carroll (from Danny Thomas' "Make Room for Daddy"), Hollywood actress Jan Sterling and multi-talented Arthur Treacher, soon to be Merv Griffin's sidekick on Griffin's WNEW evening show. Technically, the show could be said to have run for two episodes, since the following Friday, Gleason appeared at

the same time, but in a studio stripped to the brick walls" and giving what "Time" magazine called "an inspiring post-mortem", asking rhetorically, "how is it possible for a group of trained people to put on so big a flop...laid, without a doubt, the biggest bomb in history... would make the H-bomb look like a two-inch salute". Gleason said he would finish out his series commitment, by promising to return the following Friday saying to the audience, "tune in next week and you may find the biggest soapless opera in history!" Gleason came back and the show was re-named "The Jackie Gleason Show" and it remained to the end of the contract and was then picked up by CBS for another four years, moved to Saturday nights and re-named "American Scene Magazine" with Gleason, Johnny Olson, musical director Sammy Kahn, the June Taylor Dancers and many new Gleason characters, such as, "The Poor Soul", "Reginald Van Gleason III" and "Joe, The Bartender".

Our celebrity was the CBC spokesman for Kellogg's, sponsor of "You're in the Picture" and would have retained the position with the re-named show, except for a moment during Gleason's TV apology. Gleason hinted that the coffee cup he was sipping from wasn't really filled with "coffee" but what he called "Chock Full O'Booze". Kellogg's pulled out of the series a week later and publicly claimed "This show isn't the show we bought". They reportedly told CBS executives they were offended by the coffee cup reference and wanted no further association with Gleason or the show after that. Too bad they didn't understand the idea was as truthful as Dean Martin's glass of gin in his hand during broadcasts. The supposedly "spiked" cup of coffee was a running gag Gleason often used as part of the monologue. It was all part of the act..."How sweet it is!!!!" Our celebrity missed out, but Ligett & Myers (L&M and Chesterfield cigarettes), the show's alternate sponsor, continued with the series until it ended in 1966. Not to worry, our celebrity, with future gigs, would go on to be known as the "Dean of Game Show Hosts".

Last Week's Celebrity

Last week's celebrity was born Martha MacVicar, but was better known professionally as Martha Vickers. Her "bad girl" role in "The Big Sleep" with Humphrey Bogart and Lauren Bacall, led to other "B" roles and not necessarily all "bad girl" parts. Highly appealing as the second femme lead in the pleasant musical "The Time, the Place and the Girl" (1946) with Dennis Morgan and Jack Carson, Martha looked radiant but was overlooked for bigger things. She continued on and disrupted the proceedings again in the atmospheric

film noir "The Man I Love" (1947) with Ida Lupino and finally earned leading lady status in "That Way with Women" (1947) opposite Dane Clark.

Very much part of the Hollywood dating scene, which included actor Jimmy Stewart and director Fred DeCordova, best known for his Johnny Carson "Tonight Shows, Martha married producer A.C Lyles in March of 1948, but the marriage was over within a couple of months. Post-war films include "Love and Learn" (1947) with Jack Carson, another film noir piece "Ruthless" (1948) with Zachary Scott and Diana Lynn, and the melodrama "Bad Boy" (1949) which was Audie Murphy's first starring role. She ended the decade top-lining "Poverty-Row" drama "Alimony" (1949) with Hillary Brooke. Surprisingly, her high-

profiled second marriage in 1949 to film star Mickey Rooney (she was his third wife), did not advance her career. In fact, she was not seen at all in films during this period. Despite the couple having a son, Teddy Rooney, Rooney had already hit the nadir of his career and had turned excessively to the bottle. Her marriage to Rooney would be short lived, as well. Their son Teddy, recently died on July 2nd, this year, at the age of 66.

In 1960, Martha did her last filming with the western "Four Fast Guns" with Edgar Buchanan and after guest-starring on a couple of episodes of the TV series "The Rebel", she ended her career. Not much was heard from this sultry beauty until her death from cancer in 1971, at age 46, in Hollywood.

There are the expected moments of deep grief yet there are also bits of humor as the family struggles to adjust, but the most astonishing thing about this book is the role of Crow- the voice that embodies their collective grief. 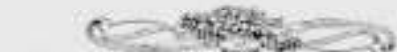
