Students Learn the Letter of the Law at Glen Cove's Teen Court

Since City Court Judge Richard J. McCord founded the Glen Cove Teen Court Program in 2002, the program has garnered local and statewide attention for its innovative approach to educating high school students about the justice system. In this popular for-credit, elective class, students are trained to actively participate in real trials of cases involving teenaged offenders.

The Glen Cove Teen Court is a State program established under the auspices of the Department of Criminal Justice Services of New York State and operates with the approval and support of Nassau County Administrative Judge Thomas Adams and Nassau County D.A. Madeline Singas, Glen Cove Superintendent of

Schools, Maria L. Rianna and the Glen Cove Police Department. Recently revived in the 2014-2015 school year through the dedication of the Hon. Richard J. McCord and all the court staff, the program is directly supervised by Judge McCord and Program Coordinator Glen Cove Deputy City Attorney Kristina Heuser.

Classes are supervised by Glen Cove High School teacher Christopher Contorno with featured presentations by other members of our community who are active in the criminal justice system, including Glen Cove City Police Officers, District Court Judges, and members of the Nassau County Bar Association.

Mayor's Column

Matters of Fact

With the upcoming sale of the waterfront property and our efforts to issue bonds for public improvement at no liability to our taxpayers, Glen Cove could be in its strongest financial position in over a decade. Our priority continues to be ensuring our taxpayers receive the high quality services they deserve without the burden of tax increases.

I am certain that with the sale of the Waterfront property we will be headed in the right financial direction. And, it's equally important to understand that without this project and the new revenues it will bring, there will be an increase in taxes, a reduction in City services and potential layoffs.

Bond Buyer Validates Glen Cove's Financial Solution to Fund the Waterfront Infrastructure

A recent story in the Bond Buyer, a respected and independent newspaper that covers the municipal bond

market, validated the upside of Glen Cove's financial approach. The article highlights the financial benefits of the plan and quotes Moody's analyst Cristin Jacoby who said, "They are expected to get things right with fund balances if everything goes well with the waterfront development. Overall the long-term boom to their economy could be huge." Further in the article Jacoby added, "They have been moving positively toward balancing fund operations, but still have some challenges ahead. To the extent that the redevelopment project leads to new revenue and positive property values we would likely consider it to be a major credit strength."

Correcting Misinformation about the Glen Cove Waterfront

Every day we hear and see incorrect, fabricated or exaggerated information about the Waterfront project. Here are facts and the insights so our residents can draw their own conclusions.

The misinformed say: The City will incur \$115 million in new debt

Fact: The bond offering to build parks and other public amenities at the Waterfront will NOT be a City or IDA debt. The risk of repayment is exclusively the bond holders. At NO time would the residents and the City have any obligation to repay it. It will also NOT affect our bond rating.

The misinformed say: The Garvies Point waterfront site is not fit environmentally for redevelopment

Fact: The Environmental Protection Agency, New York State Department of Environmental Control, and other governmental agencies have spent \$120 million on the remediation of this Super Fund Site over the past 20 years. Final approval on the last parcel will be forthcoming in the next few weeks. Upon the issuance of the final approval, the property will be deemed ready for development and public use. After 20 years of remediation our Creek is cleaner than ever. Our Waterfront, which was once a toxic waste land, will finally be clean and ready to return to our tax roll. The City, DEC, EPA and other Agencies have been diligent in their oversight, and would not allow this property to be developed until it is absolutely safe for the public and future residents of the Project.

The misinformed say: Construction will last for 10 years

Fact: Under previous plan, that may have been the case. However, now with the reduction in the number and heights of several of the buildings, there will be an expedited construction schedule, lasting about 5-6 years. Important for the bonding and other City protections, during the first two years all of the Public amenities including parks, amphitheater, esplanade, dog park, playgrounds and more, totaling 28 acres of public recreational and open space, will be built first for all to enjoy.

The misinformed say: Buildings are too tall and will block the view of neighboring communities.

Fact: The building heights and plan for the redevelopment of the Waterfront have been reduced from the original concept of multiple 16 story buildings with few public amenities to its current footprint, which reduced the building footprint by 23% and increased the public amenities and park space to 28 acres. The western parcel (closest to the Harbor), which in 2011 was approved with two 12 story buildings and two four (4) story buildings, has been redesigned with one 11 story building with stepped back twin towers

to enhance view corridors, and one five (5) story building to allow for the addition of three (3) additional acres of park space.

The misinformed say: There will not be enough revenue to cover the cost of City and other public services resulting from the Project.

Fact: This could not be further from the truth. The City ensured during negotiations with the Redeveloper that each tax jurisdiction will receive tax and other revenue from the Project after payment of the Bond, which far exceeds their cost of services. This starts on the first day of the Project.

It is estimated that over the next 40 years the City will receive \$225 million with expenses of \$51 million. The School will receive a total of \$292 million with expenses of \$46 million. The County will receive \$96 million with expenses of \$6 million, and the Library will receive \$8 million with no additional expenses.

The misinformed say: 399 ferry trips weekly

Fact: The truth is that there would be about 8-10 ferry trips per day during the week and fewer on the weekend.

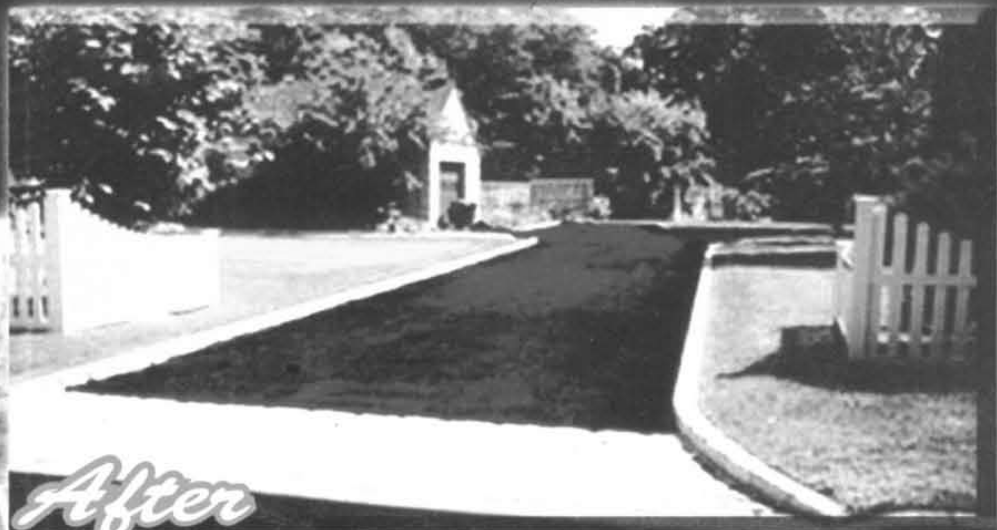

Wrong Path? To The Editor,

Mayor Spinello's crusade to urge the City Council to support hundreds of millions of dollars in tax breaks for the Garvies Point redevelopment plan will prove to be a detriment to the suburban way of life we have all come to expect and enjoy in Glen Cove.

Under the PILOTS (payments in lieu of taxes) program the \$960 million project would, as the city's consulting attorney Mr. Zarin, noted, significantly reduce RXR's property taxes by 40% for the first 20 years beginning next year and then 20% for the following 20 years. In other words, RXR will benefit from these tax abatements and pay reduced taxes for the next 40 years.

What make this head scratching plan more bizarre, is that the City of Glen Cove will not realize any income until after 2043 when the bonds are projected to be paid off, assuming that are paid off on time. Thus, the City will have to wait more than 25 years before reaping the "gains" the mayor claims this project will generate.

There are many more questions that need answers. What happens in terms of future revenues and/or PILOTS if the waterfront development plan doesn't get off the ground in a timely fashion? Why hasn't the exact dollar amount of the property tax breaks been made public?

Reggie disregards the fact that the two Avalon projects were also awarded substantial tax abatements. A review of the tax revenues of the past decade should reveal that the City didn't garner the revenue projections during that project's construction. So far it has been all smoke and mirrors.

Reggie, you state that you inherited this project with no prior input in its conception before your first mayoral term. Although this statement may be accurate it belies the fact that during your first mayoral run you campaigned vigorously against this project as the number of residential units were too high for this area. Ironically, the number of residential units which was not only approved under your administration, but with your blessing, is now approximately 27% higher than it was before.

You have an obligation to the City of Glen Cove and its residents to seek and facilitate a project that will emphasize both a strong business presence and supplemental residential development in Glen Cove without ruining the suburban nature of our city. This current construction plan lacks both elements.

Unfortunately, you do not seem to understand that you have chosen a path that will forever negatively impact Glen Cove and the neighboring Hempstead Harbor communities.

Eligibility Requirements for Free and Reduced Price Meals Glen Cove School District 2016-2017 School Year

The Glen Cove School District today announced a free and reduced price meal policy for Glen Cove School District area school children.

Local school officials have adopted the following family eligibility criteria to assist them in determining eligibility:

INCOME ELIGIBILITY GUIDELINES FOR FREE AND REDUCED PRICE MEALS OR FREE MILK
(Effective July 1, 2016 through June 30, 2017)

SNAP/TANF/FDPIR Households: Households which currently include children who receive SNAP but who are not found during the DCMP, or Temporary Assistance to Needy Families (TANF), or the Food Distribution Program on Indian Reservations (FDPIR) must complete an application listing the child's name, a SNAP, TANF, or FDPIR case number and the signature of an adult household member, or provide an Eligibility letter for free meals/milk from the New York State Education Department.

Other Households: Households with incomes the same or below the amount of money listed above for their family size may be eligible for and are urged to apply for free and/or reduced price meals (or free milk). They may do so by filling in the application forms sent home with

Name the Celebrity



This week's celebrity was born in Flagstaff, Arizona on Oct. 7, 1905. He attended St. Mary & St. Benedict's College and Northern Arizona State Teacher's College, now Northern Arizona University, and was a star football player at Santa Clara University. He also played semi-professional football under the pseudonym "Jerimiah Schwatz". His football experience led to his first sizable film role, in the 1931 "The Spirit of Notre Dame". He had acting ambitions, so, after college, he went to Hollywood, where he worked as a Venice Beach lifeguard within easy distance of the studios. He met his wife-to-be, Dorothy House, in 1933, while filming "Doctor Bull" at Fox Studios. They were married on Oct. 28, 1933, in Las Vegas, and remained married until his death 44 years later. Although it was first thought that his peculiar, wheezy voice would prevent him from moving to the talkies, instead it became his trademark. He claimed that his speech resulted from a childhood

accident. He had been running with a curtain rod in his mouth and when he fell, it pierced the roof of his mouth. When he was able to speak again, he had developed a labored, scratchy, duo-tone voice. A biographer, however, indicated that this was one of several stories the actor fabricated about his voice. The actor's son related in an Encore Western Channel interview that there had been an accident, but that he was uncertain if it resulted in his unique voice. When asked if he had strange nodes in his vocal cords, our celebrity replied, "I've got the same nodes as Bing Crosby, but his are in tune."

He appeared in more than 400 films and shared with Walter Brennan, another character actor, the rare ability to move with ease from "B" westerns to "A" pictures. His notable roles included ten films as sidekick "Cookie" to Roy Rogers, a role in "Romeo and Juliet" (1936), and "Danny" in "A Star is Born" (1937). He made several appearances in films with John Wayne, including "Stagecoach" (1939), "Island in the Sky" (1953) and as the frightened marshal in "The Man Who Shot Liberty Valance" (1967).

Last Week's Celebrity

Last week's celebrity was Selena Royle. Along with the many motherly roles she undertook, she was also the title character's mother opposite Ingrid Bergman as "Joan of Arc" (1948). She was in William Wyler's high-profile literary adaptation "The Heiress" (1949) with Olivia de Havilland and

Montgomery Clift and crime dramas such as "He Ran all the Way" (1951) with John Garfield and Shelley Winters. In 1951, however, her career came to a halt when Royle was denounced in the publication "Red Channels" as an alleged Communist sympathizer and subsequently refused to appear before Senator Joseph McCarthy's investigative committee. She was suddenly "wrong" for every role that she tested for and her screen career was effectively ended. She sued "Red Channels" and the American Legion, who published "Red Channels" list of supposed subversives, and mounted a publicity campaign that ended with Red baiters backing off. Royle had beaten the blacklist, but she only

made two more movies. Phil Tucker's ultra-low-budget "Robot Monster" (1953) with George Nader and Edgar G. Ulmer's independently made "Murder is My Beat" (1955) with Barbara Payton, neither of which was produced on a scale resembling the films of her earlier days. In 1954, seeing that she was no longer wanted or needed in Hollywood, Royle and her second husband, George Renavent, decided to leave the United States. They moved to Guadalajara, Mexico, where they lived happily until his death in 1968. During her final 20 years, Royle was a successful author of cook books and about Mexico. She died, after a short illness, on April 23, 1983., at the age of 78.
