International Coastal Cleanup Coordinated Locally at Tappen Beach

On Saturday, September 17, 9:30 to 11:30 AM, the Coalition to Save Hempstead Harbor will be coordinating the efforts of local volunteers to cover parts of the eastern shore of Hempstead Harbor as part of the Annual International Coastal Cleanup, sponsored by the Ocean Conservancy and the American Littoral Society. The weekends in September are dedicated to this program, and communities worldwide will be hitting the beaches to clean up debris from as many miles of shoreline as the number of volunteers will allow.

The cleanup is intended as much more than a one-shot attempt at getting rid of the garbage that washes up on our beaches. Instead, the volunteers who participate in the cleanup will be contributing to a massive data-collection effort. They will record and weigh the various types of debris found on the shore. The information is then sent to Ocean Conservancy, entered into a database, and analyzed to see whether there are changes in the amounts or types of debris that had been found in previous years. In the past, the data collected from the beach cleanup had been used to approach manufacturers to change the types of materials that frequently end up as floatable debris.

In 2015, the New York State Beach Cleanup included 7,723 volunteers (832 more than 2014!) who removed 125,544 pounds of debris from over 250 miles of shoreline! Here are the numbers for the items that made it to the top of the "Dirty Dozen" list in New York State: cigarette butts (54,226), plastic pieces (43,199), plastic bottle caps (28,673), food wrappers (candy, chips, etc.) (27,794), glass pieces (25, 120), and foam pieces (25, 039). Just at Tappen Beach the numbers for the top three were; cigarette butts (1,690), food wrappers (334), and plastic pieces (314).

On September 17, 9:30-11:30 AM, volunteers will work in teams to make the process of picking up and documenting material easier. All are invited to participate--students, seniors, families, and members of community organizations. Bring work gloves. All other supplies (bags, pencils, data cards, etc.) will be distributed to volunteers who will meet at the entrance of Tappen Beach. This is a great opportunity to do something meaningful for the environment--a perfect way to think globally but act locally.

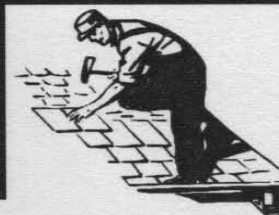

Lilli Scott Displays Botanical Paintings

The Glen Cove Senior Center is delighted to display the botanical paintings of Lilli Scott in the Golden Gallery during September and October.

Lilli has been a resident of Sea Cliff for more than fifty years. After enjoying several careers, Lilli has come full circle, back to her art, her first love. Following years of study at Pratt Institute, Lilli worked as a pen and ink illustrator. She went on to a career as a writer while still maintaining her passion for drawing, watercolor and pastels. Upon retirement, Lilli was able to return to her artistic endeavors.

Lilli maintains a perennial garden that provides her with her beautiful and colorful subjects. Her floral painting follows the strict canon of botanical art, while her pastels afford her more relaxed still life interpretations. Lilli's vibrant flowers, fruits and vegetables are depicted in the centuries old botanical painting genre. Engravings of all manner of vegetation from the 15th century were used by healers to identify medicinal substances. In the 18th century Marie Antoinette encouraged worldwide collection of exotic plants; renderings of these plants were considered to be works of art.

Botanical art, a descendent of medical illustration, has seen a resurgence in

the past thirty years. These paintings are accurate in every minute detail, and are devoid of backgrounds and shading, which would be a distraction. Botanical paintings and prints are widely collected by today's aficionados.

Lilli earned her Bachelor's degree from the City University of New York and a graduate degree from New York University. She served as Chairperson of the Nassau County Arts Decentralization of the New York State Council on the Arts while employed in advertising, public relations and a researcher/writer in the New York State Senate and the United States Congress.

Lilli is a member of the American Society of Botanical Artists and the Guild of Natural Scientific Illustrators. She is an active member of numerous organizations in the Village of Sea Cliff and sings tenor with the North Shore Community Chorus. Her paintings have been

widely collected over the decades and are admired by those who have had the privilege of seeing them on exhibit.

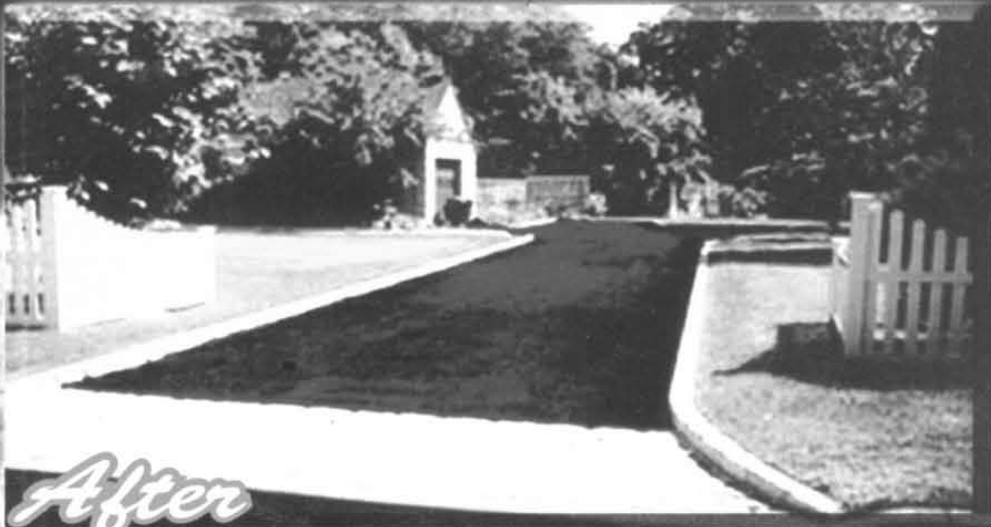

Name the Celebrity



Born in London on Dec. 23, 1887, this week's celebrity came out of college and started his working life as an insurance agent. However, while touring in Australia, he took an interest in the stage and theater. He gave up his insurance job and turned to acting after returning to England. With his elfish long, straight nose, squint-eyed demeanor and a crisp voice, he successfully began a career starring in many shows and revues, focusing on traditional British comedy. Encouraged further in 1923, he came to NY and was almost immediately using his London stage experience on Broadway. Though there were few dramatic parts, he inevitably played comic roles in musical comedies and revues regularly from 1923 to 1933. He would return once again some ten years later to take on multiple roles for Ziegfeld Follies of 1943. No stranger to film, as early as 1920, he had tried his hand in British cinema. In 1926, he did the silent U.S. version of "The Great Gatsby" (1926) that starred Warner Baxter. His familiar role as a head waiter began with his first Fred Astaire/Ginger Rogers film, "Flying Down to Rio" (1933). With a foot still on Broadway, in 1923, he played the waiter in the stage version of "The Gay Divorcee" and then was tapped to reprise the role in the film version with Fred and Ginger. Our celebrity had been perfecting his basic comic characters since his London days-- a leering English gentleman, brusque/wise-acre butler or waiter or other service provider with a lock-jawed British accent. These characters accompanied by his flawlessly timed delivery were thoroughly applicable and effective as he moved permanently to

Hollywood character acting. He played a fair spectrum of other roles, even in a few rare dramas, such as the adventure "The Soldier and the Lady" (1937) with Akim Tamiroff and "Island of the Lost Men" (1939) with J. Carrol Naish.

Last Week's Celebrity

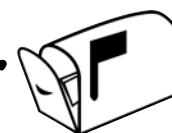
Last week's celebrity was Leon Ames. He had always wanted to be an actor and he did it the hard way, serving a long apprenticeship in touring amateur theater companies, even selling shoes for a while on 42nd Street in the 1920s. He appeared in his first movie, the somber, expressionistic "Murders in the Rue Morgue" (1932), an Edgar Allan Poe adaptation, in which Leon played the dependable love interest of Sidney Fox. For the next three years, he appeared under his birth name, Leon Waycoff, in a variety of B-movies for poverty-row studios like Mayfair, Showmen's Pictures, World-Wide Pictures, Empire and Majestic. His first film as Leon Ames, was "Stowaway" (1932), a Shirley Temple feature, also with Fay Wray. For the next few years, he served yet another apprenticeship, playing a variety of stalwart characters and the occasional bad guy in such cheerful potboilers, as the anemic "Murder in Greenwich Village" (1937), again with Fay Wray, the amusing, "Mysterious Mr. Moto" (1938) with Peter Lorre and the ever forgettable "Secrets of a Nurse" (1938) with Helen Mack and Dick Foran. He also appeared in Ernst Lubitsch's last film at Paramount, "Bluebeard's Eighth Wife" (1938) with Gary Cooper and Myrna Loy and as the leading man in "Cipher Bureau" (1938) an "Panama Patrol" (1939). Leon continued to work in films well until his later years and was last seen as Kathleen Turner's grandfather in "Peggy Sue Got Married" (1986). On TV, he had a popular run starring in "Life With Father" (1953) and "Father of the Bride" (1961), played by Spencer Tracy on the big screen. He joined the cast of "Mister Ed" (1963-66) as "Wilbur Post's" (Alan Young), retired "Col. Gordon Kirkwood", after the death of actor Larry Keating, who had played "Post's neighbor, "Roger Addison". Leon passed away at the age of 91, of natural causes, on Oct. 12, 1993.

Scam Prevented

On June of 2016 the Glen Cove Police Department reached out to the local businesses and the public regarding the uptick in phone scams using pre-paid cards. The outreach program was an effort to educate the public and local convenience stores about the increasing use of pre-paid cards being used in various telephone scams. Newsday covered the outreach program and printed an article regarding the program on July 11th. In addition to the press release, the outreach program included flyers sent out to local businesses on how these scams worked, and how the local businesses could help prevent some of these scams. Unfortunately many of these scams are specifically aimed at the elderly population. On August 23rd a Glen Cove resident was called by one of these scammers who told her that her grandson was arrested and being detained by the police. The scammer went on to tell the victim that he was her grandsons attorney and he needed \$1,500 to represent him. The victim was

told to purchase \$1500 worth of pre-paid cards and to give the scammer the pin numbers to the cards. The victim proceeded to the Glen Cove CVS located at 65 Forest Ave to purchase these cards. Fortunately the CVS employee working the register inquired about the amount of money the victim was spending and alerted the victim to the realization that she might be getting scammed. The alert CVS employee saved the victim from becoming another scam victim. There are a variety of these phone scams out there according to Glen Cove Detective Lieutenant John Nagle, "the one constant in almost all of these scams in the insistence upon the purchasing of these pre-paid credit cards. Once the pin is revealed to the criminal the money is quickly taken from the cards and used by the scammer. Our hope is that our outreach program will result in even more community members being alerted to these scams before becoming another victim."

Mayor Inaugurates New Glen Cove Christmas Tree Farm

August 25, 2016, Glen Cove, NY... It was Christmas in August as Mayor Spinello, Councilwoman Pamela Panzenbeck, Francine Koehler from the Glen Cove Business Improvement District (B.I.D.), Glen Cove Parks & Recreation Director Darcy Belyea, Santa (played by Mike DiLeo) and a Merry Tree (played by Megan Peet), unveiled the City's new Christmas Tree Farm at Dennis Brian Murphy Park on Leech Circle South. "The idea for Glen Cove's Christmas Tree Farm came from the B.I.D.'s Francine Koehler as each year she collaborates with the City to ask local residents to donate a 25 foot tree to be the centerpiece of the City's holiday celebration," said Mayor Spinello. "Glen Cove's new tree farm underscores our commitment to sustainability and we hope to harvest our first marquee Christmas tree in about 15 to 20 years." The five trees that were planted were from the City's 2015 Merry Tree Festival in 2015 where local businesses sponsored and decorated "living" Christmas trees and the City would like to plant five trees a year for the next five years.

"We had the perfect summer day to break ground on our City's new Christmas Tree Farm," said Mayor Spinello. "Our Parks & Recreation and Public Works staff members did an outstanding job in preparing our park for the tree planting and it was wonderful to have Santa; members of our Senior Center and Beautification Commission along with residents participate in the pre-holiday hoopla."

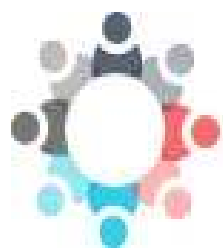

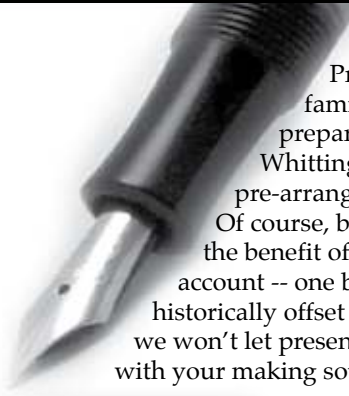

The Company, presented an application for financial assistance dated June 3, 2016 (the "Application") to the Agency and the Glen Cove Local Economic Assistance Corporation (the "Issuer") requesting, inter alia, the Agency undertake a mixed-use project (the "Project" or the "Garvies Point Project") consisting of the following: (A) the acquisition of fee title to the Land by the Company from the Agency and CDA with the Deed subject to the reservation of the Public Use Easement by the Agency (the Land is delineated as either Private Use Improvement Areas or Public Use Improvement Areas); (B) as part of a unified project to effectuate the purposes of the Urban Renewal Plan, the acquisition and construction on the Land by the Company or the Agency of a planned smart growth community of certain buildings and other improvements containing: (i) on the Public Use Easement Areas (and nearby public land) improvements consisting of, among other things, parks and playgrounds, Esplanade, bulkheads, marinas, utilities, roads, and other public improvements, infrastructure and amenities inclusive of funding certain off-site road and incinerator improvements (the "Public Use Improvements"); and (ii) on the private

improvement areas of the Land (the "Private Use Improvement Areas") which Private Use Improvement Areas are to be the subject of a lease from the Company to the Agency (the "Lease") with a related leaseback to the Agency to the Company (the "Leaseback"), improvements consisting of approximately 1,719,932 square-feet of space containing a total of up to approximately 486 rental residential units, 513 condominium units and 111 workforce housing units (55 for rent and 56 for sale) (collectively, "Residential Units"), and up to approximately 75,000 square feet of retail, restaurant, cultural and related space (collectively, the "Commercial Space", and together with the Residential Units, the "Private Use Improvements" and together with the Public Use Improvements, the "Improvements"); and (C) the acquisition and installation in and around the Improvements of certain items of machinery, personal property, fixtures and equipment (the "Equipment", and together with the Land and the Improvements, the "Facility"); and

The Issuer shall issue its Tax-Exempt and Taxable Revenue Bonds (Garvies Point Public Improvement Project), Series 2016 (the "Bonds" or "Public Improvement Bonds"), in one or more Series and Sub-series, in an aggregate principal amount currently estimated to be \$120,005,268, but not to exceed \$150,000,000, consisting of (i) Current Interest Bonds, (ii) Capital Appreciation Bonds, (iii) Convertible Capital Appreciation Bonds, and (iv) Current Interest Bonds (Taxable) all for the purpose of financing a portion of a certain public improvement project (the "Public Improvement Project") to be undertaken by the Agency consisting of: (A) the acquisition, construction and equipping on the Public Use Improvement Areas (and other nearby public land in the City) of the Public Use Improvements; and (B) the payment of all or a portion of the costs incidental to the issuance of the Public Improvement Bonds, including issuance costs of the Bonds, capitalized interest, if any, and the funding any reserve funds as may be necessary to secure the Public Improvement Bonds (the items (A) through (B) above being hereinafter collectively referred to as the "Costs of the Public Improvement Project" or "Public Improvement Project Costs"). Simultaneous with the execution and delivery of the Deed: (i) the LDA shall be terminated and the Company shall lease the private portion of the Facility to the Agency pursuant to the Lease, (ii) the Agency shall lease the private portion of the Facility back to the Company pursuant to the Leaseback, and (iii) the Agency and the Company shall enter into a certain Master Tax Agreement pursuant to which the Company shall make certain in-lieu of tax payments to the Agency for the benefit of the holders of the Bonds, Nassau County ("County"), the City, the Glen Cove City School District (the "School District") and the Glen Cove Public Library (the "Library" and collectively with the County, the City and the School District (the "Tax Jurisdictions"). The Tax Jurisdictions have consented to the use of revenues received by the Agency under the Master Tax Agreement to pay the Bonds and to a fixed allocation among the Tax Jurisdictions differing from the distributions and allocations that the Tax Jurisdictions might otherwise receive.

In order to induce the Company to acquire, renovate, construct, reconstruct and equip the Facility, and undertake the Project, the Agency is willing to take a leasehold interest in the Private Use Areas pursuant to the Lease to Agency, and thereafter the Agency will develop the (A) Public Use Improvements through the Company as agent of the Agency under the terms of the Public Use Easement and (B) Private Use Improvements through the Company as its agent and lease the Private Use Improvements and Private Use Areas

(collectively, the "Private Use Facility") back to the Company pursuant to the Leaseback Agreement (the Leaseback Agreement together with the Lease to Agency, the "Lease Agreements"). The Agency contemplates that it would provide financial assistance to the Company and/or its affiliates in the form of: (i) exemptions from sales and use taxes otherwise payable upon the purchase or lease of materials, furnishings, fixtures and equipment, and other taxable personal property and rentals related to the Private Use Facilities and Public Use Facilities and (ii) exemptions from mortgage recording taxes in connection with the acquisition financing, construction financing or permanent financing or any subsequent refinancing of the costs of the acquisition, renovation, reconstruction, refurbishing and equipping of the Public Use Facilities and Private Use Facilities; and (iii) increment financing issued by the Issuer to be funded from payments in lieu of real property taxes under a tax agreement between the Agency and the Company (the "Tax Agreement") that would involve a partial abatement of real property taxes. The Tax Agreement and related increment financing to fund the construction and installation of the Public Use Improvements would be a deviation from the Agency's Uniform Tax Exemption Policy. The deviation and use of revenues received by the Agency under the Tax Agreement has been consented to by each of the Tax Jurisdictions. It is contemplated that, among other things, the Tax Agreement will provide for payments to be utilized to pay debt service on public improvement bonds issued by the Issuer in the principal amount of approximately \$97,000,000 plus reserves, costs and capitalized interest, the net proceeds of which will be used to fund the Public Use Improvements. The payments under the Tax Agreement will also pay certain essential service payments and certain other amounts to all Tax Jurisdictions which will be affected by the Tax Agreement.

The Agency previously held a public hearing on this matter on June 22, 2016. A copy of the transcript of the June 22, 2016 hearing is
