When Frances is badly hurt, Charley worries about the coming spring, and how she will face it without her friend by her side. It's a heartwarming story about friendship and loyalty, and the simple joys of childhood.

The Year That Spring Didn't Come is the latest project of Sea Cliff native (and Charley's mom), Merry Spence.

The real Charley and Frances, when they aren't appearing in this book, are second grade students at Sea Cliff School. They met in preschool and have been friends ever since. On Easter Sunday, 2016, Frances was badly burned in an accident at her home. With her family and friends by her side and strength beyond her years, Frances' recovery was nothing short of incredible. When she was finally released from the hospital, she and Charley were reunited, and between them, nothing was changed.

This is the first book for Merry, whose other hats include carpenter, inventor, designer, artist, band roadie and lawyer.

The book is illustrated by Devin Kent. Devin, a 26 year old award winning artist,

# Virtual learning brings science to life at Finley

Finley Middle School eighth-graders recently took part in a three-dimensional science lesson as part of a unit study on contour mapping.

The lesson was made possible thanks to the district's new Virtual Sandbox, which allows students and teachers to manipulate sand that is augmented in real time with an elevation color map, topographic contour lines and simulated water.

According to science teacher Steve Kocienda, the cutting-edge technology gives students an opportunity to identify contour lines, which represent changes in elevation, in addition to manipulating climate. The students can also see how water flows from different points and add water to the sand to completely change the topography they are viewing. Finley science teachers learned about the virtual learning tool from the University of California, Davis, and it came to fruition at the district thanks in part to the leadership of Student Management Systems Administrator Gayle Tullo.

The Virtual Sandbox uses a standard projector and an Xbox Kinect to project colorful images onto the sand, which is held in a wooden structure. Stony Brook University student Nick Aversano downloaded the software while interning at the district over the summer. District carpenter Brian Kormoski created the wooden stand for the sandbox.

## Strategic Appointments and Programs Announced at Glen Cove City Court

Over the years, the objective of the Glen Cove City Court has been to ensure an ever-widening focus on the community as a whole and overall answerability to the residents of Glen Cove. In that regard, Nassau County District Attorney Madeline Singas has assigned a permanent District Attorney, Cindy Ayers, to appear in the Glen Cove City Court on all arraignments on the criminal calendar.

Ms. Ayers will be headquartered in the Glen Cove police department in conjunction with her assignment. She will assist the police with processing arrests and will work with the Court as a part of its ongoing objective to ensure that the rights of people in our community continue to be fairly adjudicated. Ms. Ayers has been an assistant district attorney since 1996 and has prosecuted cases in the district and county courts, including seven years prosecuting high level felony drug cases in the narcotics and gang bureau. Currently, she is assigned as Glen Cove City Court Prosecutor.

In other Glen Cove City Court news, Steven Martinez, Court summer intern for 2016, assisted Supervising Judge Richard J. McCord in part in the Adolescent Diversion (ADD) Program. This program is open to high school students and college students who are interested in pursuing a legal career and allows them to experience the justice system first hand in matters pending in

the Glen Cove City Court.

Supervising Judge Richard J. McCord is also very pleased to announce the continuation of the Teen Court Program for the coming school year. He will be working in conjunction with with Teen

Court Coordinator, Kristina Heuser, the Glen Cove High School, the Glen Cove Police Department and Nassau County Administrative Judge Thomas Adams and the District Attorney's Office, as part of the ADD Program. In this popular

and well-regarded program, students are trained to actively participate in real trials of low-level cases involving teenaged offenders

## Tipi Ted Teaches GWL about Native American Life on LI

"Tipi Ted," head of the Traveling Wilderness Museum and king of the longhouse, visited Glenwood Landing School in September 2016 to help teach students about Native American life on Long Island. This tradition is an introduction to the Native American unit of the fourth grade curriculum.

Thanks to Enrichment Teacher Audra Marcantonio, students had the opportunity to study inside a longhouse and examine various wildlife specimens including deer hides, animal bone tools, and shell rattles. Additionally, students engaged in hands-on activities including corn grinding, drumming, and wampum necklace making; and played Native American games such as "pick-up bones!"

"Tipi Ted" along with Chris Puleo, otherwise known as Two Feathers, has annually brought this enrichment program to all three North Shore Elementary Schools. The goal of the program is to help illustrate to the students in an educational and interactive way how Native American tribes lived, gathered food, and even enjoyed games many years ago on Long Island.

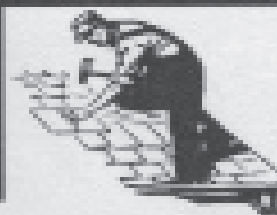
our part to encourage friends and loved ones to get frequent screenings for early detection."

## Vikings Football 9/11 Memorial Game

The Seaford & North Shore School Districts participated in a memorial home football game on Saturday, September 11th, commencing the 15th anniversary of the tragic events that took place in multiple cities around the nation in 2001. An announcement prior to the start of the game stated:

Today, we join our fellow Americans, around the world, in pausing to remember and honor those who lost their lives in the September 11 terrorist attacks. We continue to honor the heroism and bravery of the first responders, including firefighters, law enforcement officials and civilians who worked to save the lives of others. We are grateful for the countless American heroes who have, and continue to stand watch around the globe, protecting and defending our country from those who seek to destroy it. Today we are especially grateful for their selfless service. Freedom and unwavering liberty remain strong in our hearts and minds. We will always remember September 11, 2001.

To start the ceremony, the American Legion Glenwood Landing Post 336 marched onto the center of the field with flags held high. High School musicians, Ryan Faber and Peter Bennett, beautifully played an echoing version of taps on their trumpets.

In a tough fought game, the Vikings were defeated by the top seeded Seaford football team 42-33. Senior Quarterback Ryan Aughavin opened the scoring for North Shore when he took the first snap from center and dashed 73 yards for the touchdown. He would finish the day with 3 rushing touchdowns. Senior running back Brian Tilton also scored in the first quarter with a 4 yard plunge

in the end zone. Aughavin connected with senior John Magliocco on the 2-point conversion play that followed. In the fourth quarter, the Vikings came within one score of tying Seaford when Ryan Aughavin connected with Senior Hayden DiPalma with a 20 yard pass for a touchdown.

The defense was led by Nick Lounis who totaled 2 solo tackles and 9 assisted

tackles on the day. Jake Cirilla and Joe Magliocco each had a fumble recovery to keep North Shore in the game. In addition, Nick Lounis earned the honor of "Captain of the Game" for the Carle Place game.

# Name the Celebrity



This week's celebrity was a film and television actor and was born in Boston, Massachusetts on Feb. 22, 1910. He was a graduate of Northeastern University and the Leland Powers School of Elocution in Boston. He was also a certified public accountant. In his youth, he worked in summer stock and in radio. After serving with the U.S. Army in WWII, he broke into television. His wife, Ruth Moss, was a radio personality and Broadway actress. In his many TV appearances, he was cast as "Julian Tyler" in the 1957 episode "The Chess Player" of the CBS crime drama "Richard Diamond Private Detective" starring David Janssen. He also appeared in several episodes of CBS's "Twilight Zone", including the role of the salesman in the episode "I Sing the Body Electric". His film appearances include "Jailhouse Rock" (1957) as the attorney, "Mr. Shores", overseeing Elvis Presley's character's new record label and as "Deacon Davis" in "Cat on a Hot Tin Roof" (1958) with Elizabeth Taylor and Paul Newman.

In 1960, he appeared in Alfred Hitchcock's original "Psycho" as "Mr. Lowery", "Marion Crane's" (Janet Leigh) employer in a small real estate office. That same year, he starred in the movie about Admiral William F. Halsey (James Cagney), Commander of the 7th Fleet, in the WWII Pacific Theater, in "The Gallant Hours" (1960), as Commander Mike Pulaski, USN. The film was directed by Robert Montgomery, who also did non-credited narration and told the story of Adm. Halsey's efforts in fighting against Admiral Isoroku Yamamoto and the Imperial Japanese Navy in the Guadalcanal campaign. The film was produced by Montgomery and Cagney and it was the only film made by their joint production company.

*Last Week's Celebrity*

Last week's celebrity was Spring

Byington. For GM, she played "Midshipman Roger Byam's" (Franchot Tone) mother in "Mutiny on the Bounty" (1935), also starring Clark Gable and Charles Laughton. She became a household name during "The Jones Family" series of seventeen films, which were second feature family comedies produced by 20th Century-Fox between 1936 and 1940. MGM had "Andy Hardy" and 20th Century-Fox had "The Jones". Oddly enough, our celebrity played the first "Mrs. Hardy" in the 1937 pilot of the series along with Lionel Barrymore as "Judge Hardy". They were replaced by Lewis Stone and Fay Holden. Byington was nominated for the Academy Award for Best Supporting Actress for her role in Frank Capra's "You Can't Take It With You" (1938), again with Lionel Barrymore. She lost to Fay Bainter for "Jezebel" (1938) with Bette Davis. However, Byington had a role in that film, as well, as the antebellum, society matron, "Mrs. Kendrick".

During WWII, she worked in radio and decided to continue working in this medium as her film career began to decline after the war. In 1952, she joined CBS Radio to become the lead role as the widowed "Lily Ruskin", in the sitcom "December Bride." In 1954, the TV company Desilu Productions produced a pilot of the show for a sitcom, also starring Byington. The pilot was successful and the new hit sitcom aired in its first two seasons immediately following "I Love Lucy". "December Bride" broadcast 111 episodes through 1959. Harry Morgan, "M.A.S.H.'s" "Col. Potter", played her next-door neighbor in the show. She guest starred, as herself, in the CBS sitcom "Dennis the Menace" starring Jay North, in the episode titles "Dennis' Birthday". From 1961 to 1963, Byington was cast as the wise matronly housekeeper "Daisy Cooper", in the NBC western series "Laramie", starring John Smith and Robert Fuller. After "Laramie", Byington guest starred as "Mrs. Jolly" on Dennis Weaver's NBC sitcom "Kentucky Jones" and as wealthy "J. Pauline Spaghettti" in an episode of "Batman" in 1966. Her penultimate role, before her death from cancer was in 1967, was as Larry Hagman's mother on NBC's "I Dream of Jeannie". Her final role in 1968 was the convent's "Mother General" on ABC's "The Flying Nun" starring Sally Field. On Sept. 7, 1971, Byington died of cancer and at her request, her body was donated to medical research.

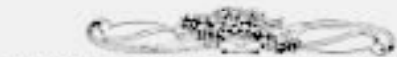
