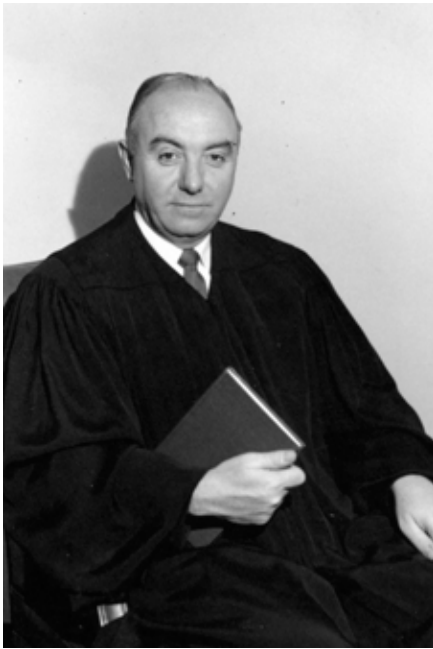

Community Mourning Joseph Suozzi



Joseph A. Suozzi, a former mayor of Glen Cove, who also served as a state Supreme Court justice and was appointed a New York State Appellate Justice, died peacefully at his home on Sunday night, October 16. Suozzi was 95.

Judge Suozzi was born on August 22, 1921, in Ruvo del Monte, located in the province Potenza, Italy. Along with his mother, Suozzi immigrated to the U.S. in 1925 to join his father Michele, who

had preceded his family to the United States, and served in the U.S. infantry during World War I. The Suozzi's moved to Glen Cove shortly after Suozzi arrived with his mother, when his father became a caretaker at the North Shore Mansion of Isabel Doge Sloane in Lattingtown, where he worked for 40 years until his retirement.

Suozzi attended St. Patrick's Grade School in Glen Cove and St. Dominic High School in Oyster Bay. Asked what his goal was for his high school year book, Suozzi responded that he wanted to be a "real American."

Suozzi attend Fordham University School of Education in the Woolworth Building in Downtown New York in 1939 and received a Bachelor of Science degree in Education in 1943. While at Fordham, he volunteered as an Aviation Air Cadet. Upon graduation, he joined the Air Force, during World War II, serving with distinction. Suozzi was a navigator for a B-24 of the 15th Air Force, based at Torretta Air Field

Local Residents/ Pastor At Washington Pilgrimage

Among those who traveled to the Basilica of the National Shrine of the Immaculate Conception were Father Kevin Dillon, Pastor of St. Boniface Martyr R. C. Church in Sea Cliff and parishioners Catherine Bailey and Margaret Evans.

The day's activities began at Noon, with a welcome from the Rector at the Basilica and continued through the afternoon with the Sacrament of Penance being offered, the Rosary being recited, and the Holy Sacrifice of the Mass being

in Cerignola, Italy, 50 miles from his birthplace. Between August 1944 and May 1945, he completed 35 bombing missions over Germany, Austria, Italy and Yugoslavia and was awarded the Distinguished Flying Cross and the Air Medal with three Oak Leaf Clusters.

After the war, Suozzi attended Harvard Law on the G.I. Bill and received a Doctorate of Law in January 1948. He was admitted to practice law in the State of New York in November 1948. Suozzi subsequently returned to Glen Cove to practice law with then Mayor Luke Mercadante at the firm Mercadante, Suozzi--, and Sordi. In 1949, Suozzi was elected to the bench of the City Court of Glen Cove, at the age of 28 making him the youngest elected or appointed judge in the United States. He was reelected in 1953, but resigned in 1955 to run for Mayor of Glen Cove.

Suozzi was elected Mayor of Glen Cove in 1956. As mayor, Suozzi helped lead the effort to build the city's library and was behind the city's purchase of 100 plus acres of beachfront property that became Pryibil Beach and the city

golf course.

In 1961, he was elected Justice of the Supreme Court for Nassau County to a 14-year term and was reelected in 1974 with bipartisan support. In 1976, Governor Hugh Cary appointed Suozzi Justice of the Appellate Division, Second Department. Suozzi left the bench in 1980 and joined the law firm Meyer, Suozzi, English & Klien, P.C. as a senior partner.

Judge Suozzi was the beloved husband of 63 years of Marguerite Suozzi, the two having wed on Valentine's Day in 1953. Loving father of Rosemary Mancini Lloyd, a Unitarian minister and assistant pastor of the First Church of Boston, Dr. William Suozzi, a doctor of internal medicine, Christopher Suozzi, an investment banker with Credit Suisse First Boston, Thomas R. Suozzi, who also served as Mayor of Glen Cove and former Nassau County Executive and the late Joseph M. Suozzi, an attorney and accountant. Suozzi was a devoted grandfather of 14 and great-grandfather of four. In lieu of flowers, the family requests donations to Catholic Charities of Rockville Centre, Momma's House, or New Ground.

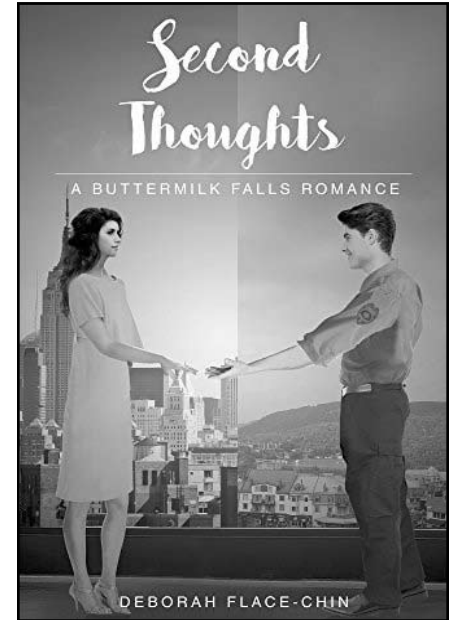
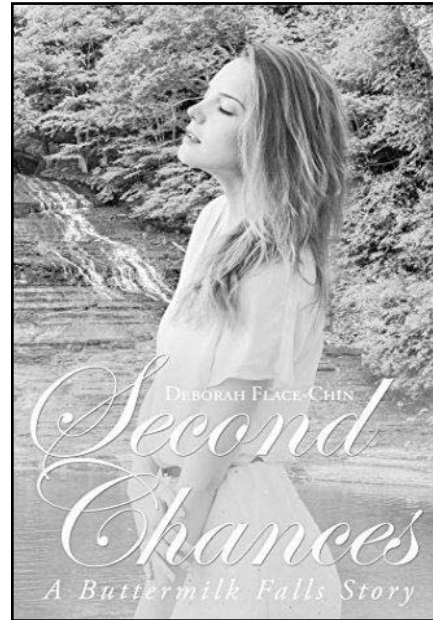

Congratulations North Shore Commended Students in the 2017 National Merit Scholarship Program

Principal, Albert Cousins of North Shore High School recently announced that Joseph Doyle, Jacqueline Thoet, and Sang Muk Yun were named National Merit Commended Students in the 2017 National Merit® Scholarship Program. They are being recognized for the exceptional academic promise demonstrated by their outstanding performance on the qualifying test used for entry. 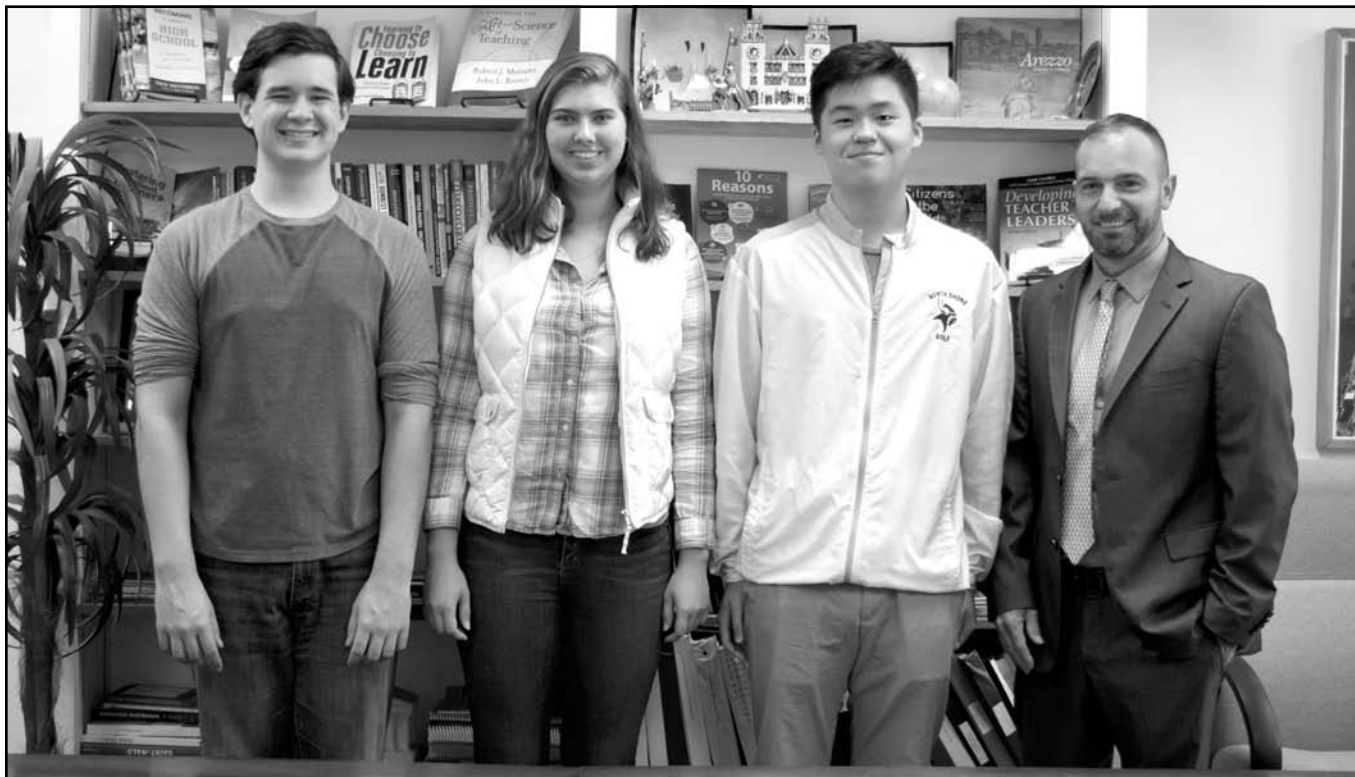

Election of 1912 Relived at Historical Museum Event

The North Shore Historical Museum held its annual fundraising event on October 8 at the Webb Institute. The theme of this year's event was the presidential election of 1912.

Woodrow Wilson won the Democratic primary and then sitting President William Howard Taft beat out ex-president Theodore Roosevelt (1901 - 1909) for the Republican primary nomination. Not the kind of person to give up without a fight, Roosevelt and his support group formed the Progressive or "Bull Moose" party. Since the Republican vote was split between Taft and Roosevelt, Wilson easily won the general election that year.

The fundraising event, which featured costumed characters representing Theodore and Edith Roosevelt, William Howard and Helen Taft and Woodrow and Edith Wilson, raised money to support ongoing programs and other expenses at the Historical Museum.

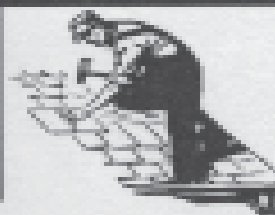
On Wednesday, October 26, the Historical Society will feature "The Election of 1924," presented by long-time Glen Cove resident and historian Dr. Millie DeRiggi. During that year's presidential campaign, Lattin town resident John W. Davis was nominated as the Democratic candidate on a record-breaking 103rd ballot. 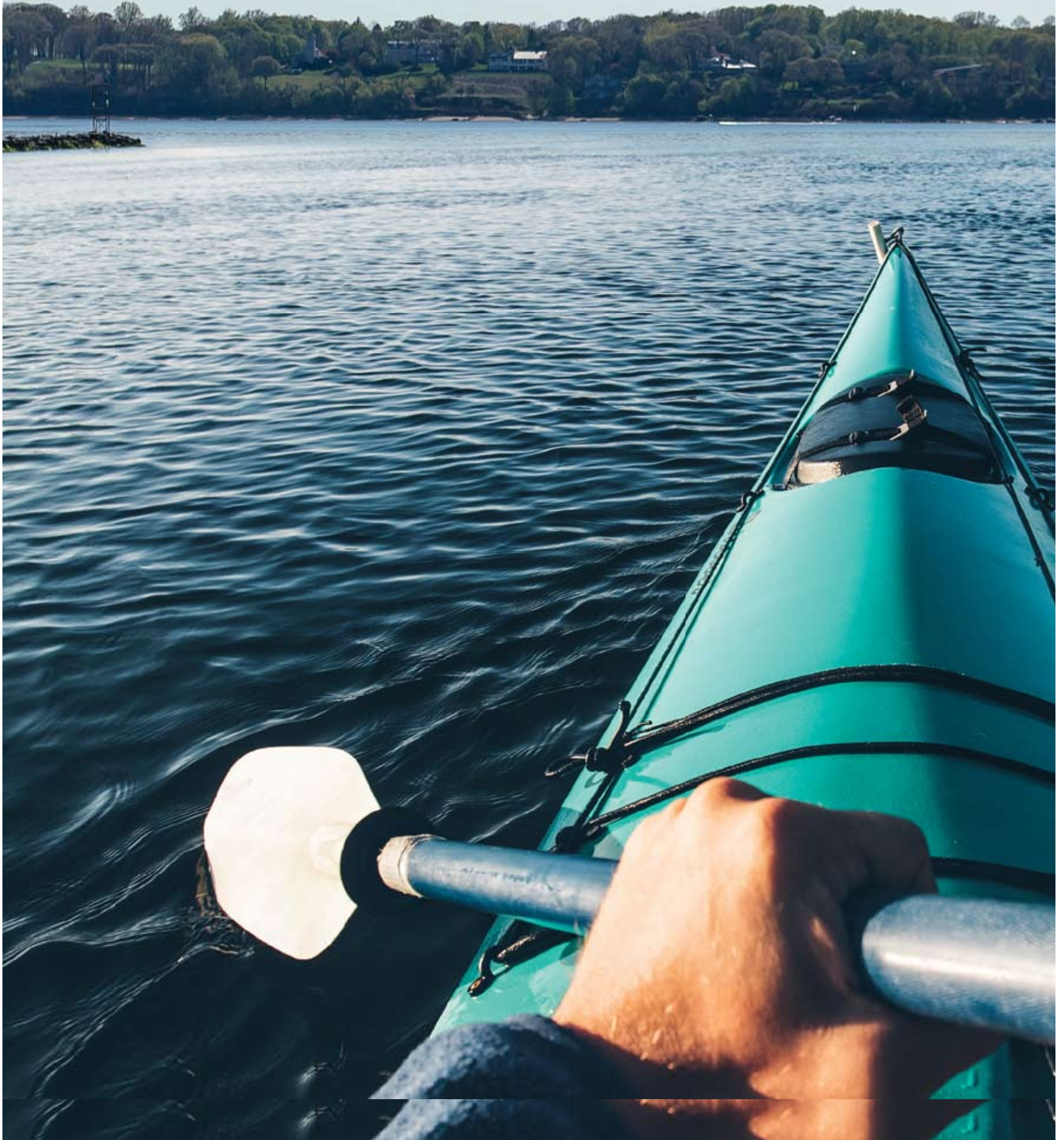

Great Book Guru

Dear Great Book Guru, Fall has arrived here in Sea Cliff and how lovely it is! One of my favorite autumn sights is the beautiful maple basking in full red bejeweled glory behind the Children's Library. Amidst all this beauty, I feel the need for some serious reading. Any recommendations? Lover of Sea Cliff Every Season of the Year

Dear Lover of Sea Cliff ..., I just finished a remarkable, very troubling historical novel: THE UNDERGROUND RAILROAD by Colson Whitehead. This award winning work is told from the perspective of Cora, a young woman who has been enslaved all her short life. Her grandmother had been kidnapped from an African village and eventually brought to the Randall plantation in Georgia where Cora was born. Her journey is told in harsh detail and serves as a prelude to her granddaughter's suffering and abuse.

Early in the book, Cora sees a way to escape the horrors of plantation life by taking "the underground railroad." Colson adds a level of magical realism here by making the railroad a subway of sorts- tracks deep underground on which actual trains ran emerging in various states, each location holding its own peculiar torments and terrors for the riders. Interspersed with Cora's story are short vignettes of historical and fictional characters she meets along her way. While set in pre- Civil War times, the novel underscores the brutal legacy of racism that lingers in the American psyche. A remarkable book and highly recommended!



City Announces New Dog Park Planning in Collaboration with Local Residents Dennis Brian Murray Park Selected as Dog Park Site

As an outcome of discussions at the October 13th City Council meeting, Glen Cove Mayor Reggie Spinello and the Glen Cove City Council approved a resolution to allow residents to walk their dogs at two city parks - Big Ralph Park on Kelly Street and Dennis Brian Murray Park on Leech Circle South. This resolution changes a past ordinance whereby dogs were not allowed in these two parks. Part and parcel of that discussion, Mayor Spinello also announced the construction of a community dog park at Murray Park due to the recent closing of Garvies Point due to preconstruction activities. "As a dog owner who completely understands the need for dogs to exercise and play, I began to think about an opportunity to build a new dog park to meet the needs of residents and their loyal companions," said Mayor Spinello.

"Through a series of conversations and correspondences, it was clear that there was a strong desire for a Dog Park in Glen Cove. In response to our resident's requests, our idea is to build an environment that allows park goers and pet owners to both enjoy our park's amenities with safety and security a priority," added Mayor Spinello. Working in partnership with the Department of Public Works, the Glen Cove Police Department, the Glen Cove Dog Control Officer and local residents who have established a Dog Committee,

Mayor Spinello is proposing a 150" x 150" fenced in Dog Park area in the back of Dennis Brian Murray Park on Leech Circle South.

The enclosure will feature a gated leash-off entry area with a 150" x 100" fenced in open space for large dogs and a separate 100" x 50" area for small dogs. Also, a new water fountain will be installed and the park's children's playground will be fenced in. While the Dog Park is in the early construction phase, the Dog Committee will be sharing additional ideas with Mayor Spinello and may sponsor fundraising drives to add new features and amenities to the Dog Park.

Mayor Spinello anticipates the new Dog Park will officially open within the next two to three weeks pending a City Council vote on October 25th. As a reminder, all dogs in Glen Cove must also be licensed and registration forms may be obtained at the City Clerk's office, 9 Glen Street, third floor, from 9:00 a.m. to 5:00 p.m. Monday through Friday. The cost of the dog license with the appropriate rabies vaccination documents is \$10. Dog owners are also responsible for picking up after their dogs and keeping their pets on leashes while in the open park space.

Name the Celebrity



For a couple of years, she got only bit parts, but she finally got 5th billing in the 1938 musical comedy "Sing, You Sinners", which also starred Bing Crosby and a 12 year old Donald O'Connor. It was at this point that she changed her name from Terry Ray to what she would thereafter be known to her public. One of her most notable films was "Christmas in July" (1940), directed by Preston Sturges and starred opposite Dick Powell.

Last Week's Celebrity

Last week's celebrity was Vaughan Taylor. In 1958, Taylor appeared in Steve McQueen's CBS western series, "Wanted Dead or Alive" as a doctor shot to death in the back by the brother, played by Nick Adams, of an outlaw, portrayed by Michael Landon, whom he treated. That same year, Taylor was cast on the ABC/Warner Bros. western series, "Cheyenne" as "Doc Johnson", an outlaw known as "The Ghost Cimarron", the title of the episode. He appeared three times in the 1960-61 season of the syndicated series "CORANDO 9" starring Rod Cameron. He guest starred on ABC's "The Real McCoys" with Walter Brennan. In 1961, he played a veterinarian in another ABC sitcom, "The Hathaways", starring Peggy Cass, Jack Weston and the Marquis Chimps. He guest starred as financier "Ashbury Harpending" in the 1965 episode "Raid on the San Francisco Mint" on "Death Valley Days", with series host Ronald W. Regan cast as "William Chapman Ralston, the founder of the Bank of California. Vaughan also appeared in episodes of "Perry Mason", "Petticoat Junction", "The Outer Limits" and "Get Smart". His last film appearance was in a comedy "The Gumball Rally", with Gary Busey, released in 1976. He passed away on April 26, 1983, at the age of 73.

This week's celebrity was born Esther Loretta Ray, on Nov. 23, 1914, in Kansas City, Missouri. She was the daughter of a barber and a housewife, who later moved to Chicago. The story of her discovery reads like a page out of a starlet's diary. As a teenager, she worked various jobs, as an accountant and salesgirl to help support her family. Along the way, her fresh faced good looks and high wattage smile earned her a couple of beauty pageant trophies. Shortly thereafter, she moved to Hollywood to try her luck in movies, but quickly realized that she was just one among thousands of young women with the same dream. She took a job as a waitress at C.C. Brown's, whose famed hot fudge sundaes drew a lot of celebrities to the Hollywood Blvd. shoppe. One of her customers was William Demarest, a character actor, later known for his role as "Uncle Charley" in the TV series "My Three Sons" with Fred MacMurray. He told the pretty brunette that she could be in pictures. In what seemed a somewhat typical Lana Turner fashion, she laughed at the classic Hollywood line, but eventually went for a screen test at Paramount, where she was put under contract for a minimum weekly salary.

Obituaries

Joseph Palumbo

PALUMBO, Joseph of Bayville, NY on Oct. 13, 2016 age 90. Husband of the late Louise. Father of Rosalinda, Joseph C. (Josephine), and Sergio (Dina). Brother of Pasquale (Carmela), Rosalia Contrino and the late Carmelo. Grandfather of Marisa L., Laura M., Christina D., Michael V., Veronica A., Joseph R., Sergio A. and James J. Great grandfather of Gianna and Nicholas. Also survived by nieces Susie and Rose and nephew Charlie.

He lived during the Depression and World War II ("WWII"), in a small apartment in Italy where his father worked for a utility company and his mother was a seamstress and a homemaker. As a young man during WWII he learned to do what was needed to survive. During an allied bombing raid he and his family would take cover in a bomb shelter. On a routine supply run to his house from the bunker, he came back to realize that there had been a direct hit on the location of the shelter. He helped pull out some of his family members, but unfortunately, he lost a brother, Carmelo, at an early age of 6 or 7 who suffered injuries due to the stampeding panicked crowd.

Going to school he became an accountant, who also happened to love to play soccer and fish. But he didn't fish with a normal rod and reel.

After WWII the Germans left behind land mines, so he and his friends used to take them apart and use them for fishing. They chummed the water and dropped the explosives to stun the fish. Then he and his friends would gather the fish and sell them to restaurants in exchange for cooked meals.

Years later he met his wife Louise and came to live in America. To provide for his family he started working in the garment business. He was a bad tailor but the owner wanted him to play on his Brooklyn soccer team so he made him a sleeve maker instead. He later went from selling replacement windows to selling life insurance to provide for his growing

family. While he was selling insurance he met someone who tried to sell a European facial steamer in America. He didn't have success, but my father did. He started a business (P-ryton) that continues with his children, Linda, Joseph and Sergio.

He was a sharp, intelligent man who put his family first above all else. A passionate, thoughtful man, he put all his efforts into whatever he had to do. He attended countless baptisms, confirmations, communions, graduations, high school musicals and concerts, birthdays, dance recitals, and even weddings and a "bring your loved ones to preschool" day! An avid traveler well into his old age, he traveled to China, Europe, Mexico, and everywhere in between. He spoke four languages! He even para-sailed and sky dived in his 80's.
