Richner Communications, Long Island's largest publisher of community media, has purchased the Gold Coast Gazette, the weekly community newspaper covering the legendary Gold Coast communities of the North Shore of Long Island. Established in 1991 by the mother-son team of Kevin and Patricia Horton (who passed away in April of '09), the Gold Coast Gazette has been a staple of the North Shore of Long Island.

"The Richner family is part of our family," said Kevin Horton, "They've been printing the Gold Coast Gazette since our first edition through their offset printing division, it's an honor to hand over the reigns to family."

"We are delighted to continue the legacy of the Gold Cost Gazette as an independent, family run newspaper covering the hometown news people have grown to love," said Stuart Richner, president of Richner Communications.

"The Gazette has become a staple in the community and we plan to continue the Hortons' commitment to journalistic integrity," said Publisher Cliff Richner.

The Gold Coast Gazette just celebrated 25 years of production having started in September of 1991. "We started the Gazette with the belief of hometown news with strong journalistic integrity. Our first issue featured a Glen Cove kindergarten class with the headline, 'A thousand mile journey.' It truly has been a thousand mile journey.... And I'm happy to pass the torch to my brothers in printing, Stuart and Clifford."

On October 19, 2016 at approximately 6:20PM the Glen Cove Harbor Patrol observed a vessel traveling without lights in Hempstead Harbor. According to Det. Lt. John Nagle, Moments later the wake of the boat capsized a crew boat being operated by the Manhasset High School girls rowing team. The Glen Cove Harbor patrol assisted at the scene with the rescue along with two chase vessels which were following the crew team. During the rescue there was a total of 12 people in the water. Glen Cove Harbor Patrol Officers, Phil Congero, and Carmine Montesano then notified firecom and ambulances were dispatched to check on the crew team. Fortunately for everyone involved there were no reported injuries.

Sgt. Sonny Bifone and PO Ted Karousos spoke to the students from grades K-8 about the risks of using drugs and the important role that decision making plays in maintaining a healthy lifestyle. Students listened intently while the officers provided real-life stories from their extensive policing experience and students were given the opportunity to ask the officers questions about drugs, alcohol, and tobacco.

As part of this weeklong celebration, members of the Glen Cove After 3 Program participated in a interactive youth presentation with members of the Army Nation Guard Counter Drug Task Force to teach kids about making healthy decisions and lifestyle choices. SSG Sean Cassidy spoke to students at Connolly Elementary School, Landing Elementary and Finley Middle School about the consequences of substance use and dangers associated with risk taking behaviors.

SAFE's Coalition holds an art contest each year and the winners are announced

at the Red Ribbon Week assembly by SAFE Board members and executive Director. The purpose of the art contest is to encourage children to commit to making good choices and to be aware of the dangers of drug and alcohol. Winning posters will appear on display in the Children's Room of the Glen Cove Public Library from October 25th- November 15th.

"Red Ribbon Week is an effective way to impart healthy choices to children through a celebration of wellness. It fosters communication between youth and adults about the dangers of substance abuse in a positive fashion" said Georgie Connett, SAFE Board Chair".

### Glen Cove Students Vote

Glen Cove High School sophomores in Valerie Stazzone's class had an opportunity to vote for the next United States president as part of a culminating activity to their unit study of non-fiction.

Prior to the election, the students read multiple articles that focused on education, national security, climate change and gender equality to get familiar with the issues and the views of presidential candidates Hillary Clinton and Donald Trump. They also read both candidates' platforms and watched the first two presidential debates. In class, the students discussed what they learned in a Socratic seminar. According to Stazzone, she initiated the unit by asking

students if they felt they had a voice in the community.

"It's important for the students to realize they have a voice," Stazzone said. "When we began this unit many students had preconceived opinions about each candidate. Through this process they were able to identify and focus on issues the students supported and match them with the candidate that best represented their beliefs."

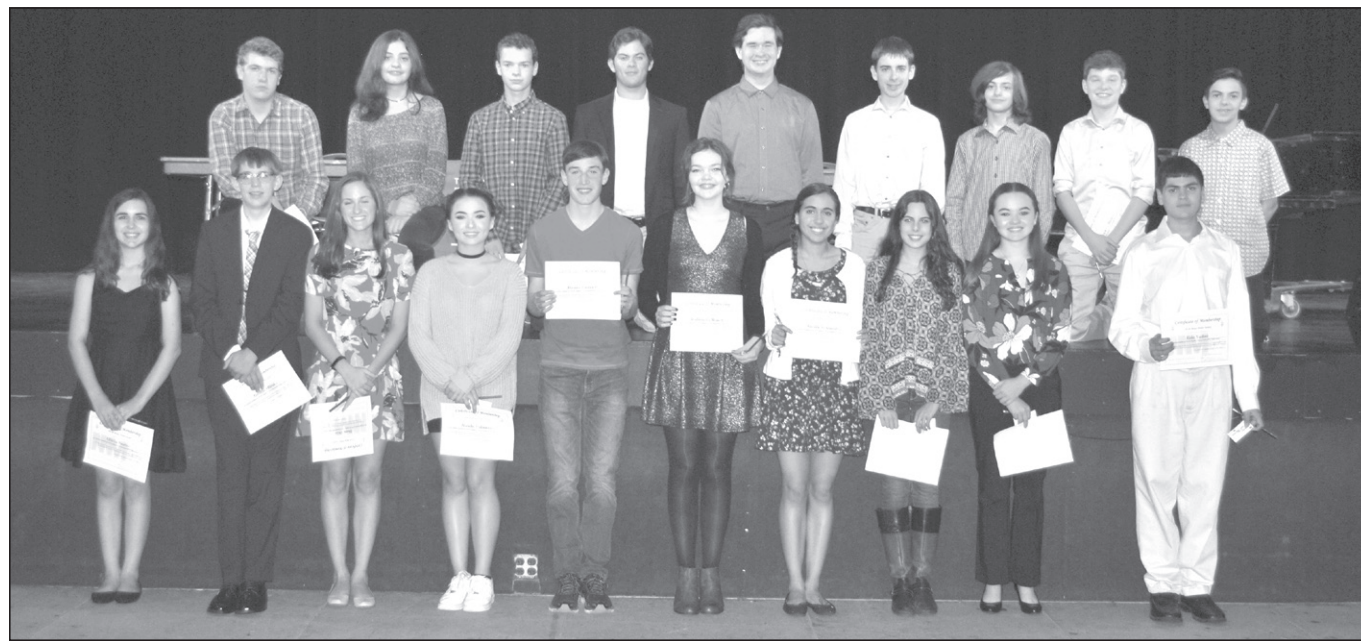

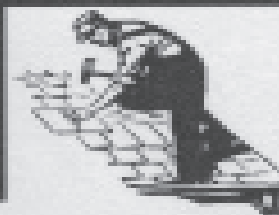

### Last Week's Celebrity

Last week's celebrity was Ellen Drew. She was a \$50-a-week contract actress at Paramount, who rose through the Hollywood ranks to star with such actors as Joel McCrea, Dick Powell and Rudy Vallee, during the 1940s and '50s. Among some of her films, was "If I Were King", which was scripted by Preston Sturges, who also did her 1940 notable film "Christmas in July". Her notices were outstanding for this "King" and over the next three years, she was Paramount's reigning dramatic ingenue. She received a tidal wave of publicity and was dubbed by the press as "The Girl from the Five & Ten", having worked at Grants, and the "Candy Store Cinderella", reflecting her humble beginnings. She was also in "Buck Benny Rides Again", in which she was the straight woman to Jack Benny and in William Wellman's "Reaching for the Sun" (1941), in which she starred with Joel McCrea and Eddie Bracken. Her last film was "Outlaw's Son" (1957).

Her career started to wane after she took an extended leave to fly to England to be with her military husband, who was stationed in England. Regardless of the reason, Paramount was not happy with this long leave and started to give plum roles to Veronica Lake, Betty Hutton, Dorothy Lamour and Marjorie Reynolds. When she returned to Hollywood, she found herself loaned out to Republic Pictures. She did not even receive billing in Paramount's all star "Star Spangled Rhythm", where her appearance was whittled down to about 3 seconds. As the years went by, she did less feature films and turned to television. She did guest shots on approximately 20 shows including "Ford Television Theatre", "Perry Mason", and "Schlitz Playhouse of Stars". In May of 1954, she appeared on Columbia's "Ford Theatre". The installment, titled "Keep It In the Family", was a homespun comedy and pilot for the TV show "Father Knows Best". She and Robert Young star as the Midwestern parents of three, two girls and a boy. Both Young and Columbia expected she would do the series, and she very much wanted to, but her husband, by now #3, made it clear that she should turn it down. She accedes to this, and Jane Wyatt replaces her in the mother role. The rest, as they say, is history. Ellen Drew died from a liver ailment on Dec. 3, 2003, at the age of 88.

This week's celebrity was born in Guangzhou, China on June 18, 1904, grew up in Seattle, Washington, and his family owned an art shop. Before becoming an actor, he was a local artist in his community and while attending high school, he contributed cartoons and illustrations to school publications. Later in Hollywood, he worked on several of the murals inside Grauman's Chinese Theater. He did some of the original artwork for the 1933 "King Kong" press book. He also painted the casino mural in "The Shanghai Gesture", a 1941 film noir starring Gene Tierney, Walter Huston and Victor Mature. He published a limited edition set of pen & ink drawings of "The Rubiyat of Omar Khayyam" in the 1950s. He also created illustrations for the books "The Unfinished Song of Achmed Mohammed" by Earle Liederman "The Blessed Mother Goose" by Frank Scully and an edition of "Messer. Marco Polo" by Brian Oswald Donn-Byrne. Other art work by our celebrity included the dust jackets for books published in the 1950s and 1960s. It was through his studio art work that he was recruited for his first movie roles.

Our celebrity made his film debut in "The Painted Veil" (1934) with Greta Garbo, Herbert Marshall and George Brent. The following year, he gained his first big role as "Charlie Chan's" eldest son in "Charlie Chan in Paris". He worked so well with Warner Oland, the actor playing "Chan" that "Number One Son" became a regular character in the series, alternately helping and distracting "Pop" Chan in each of his murder cases. Our celebrity appeared seven times opposite Oland's "Chan". He left the "Charlie Chan" series in 1938, shortly after Oland died. Their unfinished "Charlie Chan at the Ringside" was completed as "Mr. Motto's Gamble", with our celebrity


